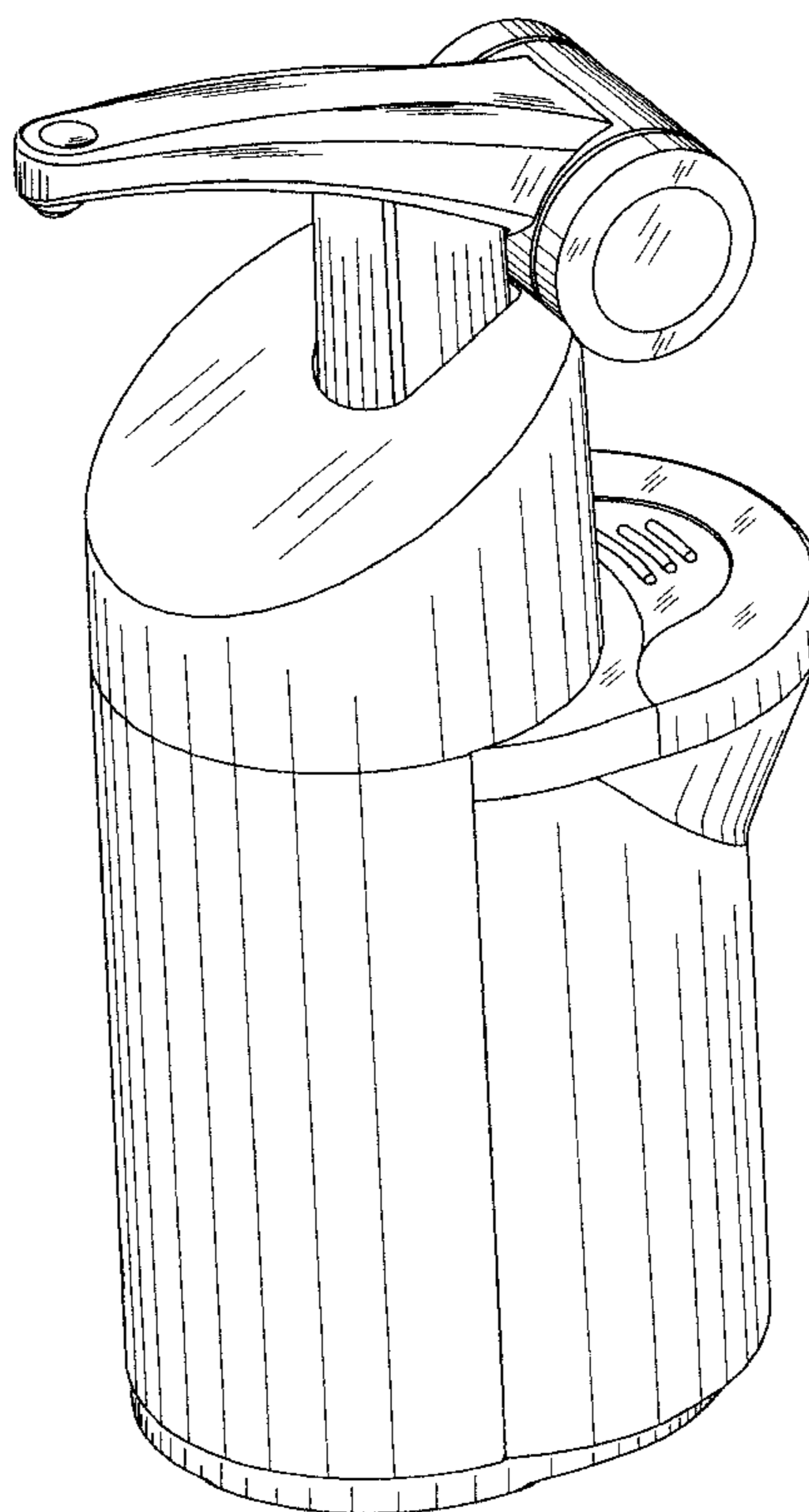
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of soap dispenser according to the present invention;  
 FIG. 2 is a top plan view of FIG. 1.  
 FIG. 3 is a rear plan view of FIG. 1.  
 FIG. 4 is a left side elevational view of FIG. 1; the right side elevational view being a mirror image thereof.  
 FIG. 5 is a front elevational view of FIG. 1.  
 FIG. 6 is a perspective view of a second embodiment of a soap dispenser according to the present invention.  
 FIG. 7 is a top plan view of FIG. 6.  
 FIG. 8 is a rear plan view of FIG. 6.  
 FIG. 9 is a left side elevational view of FIG. 6; the right side elevational view being a mirror image thereof; and,

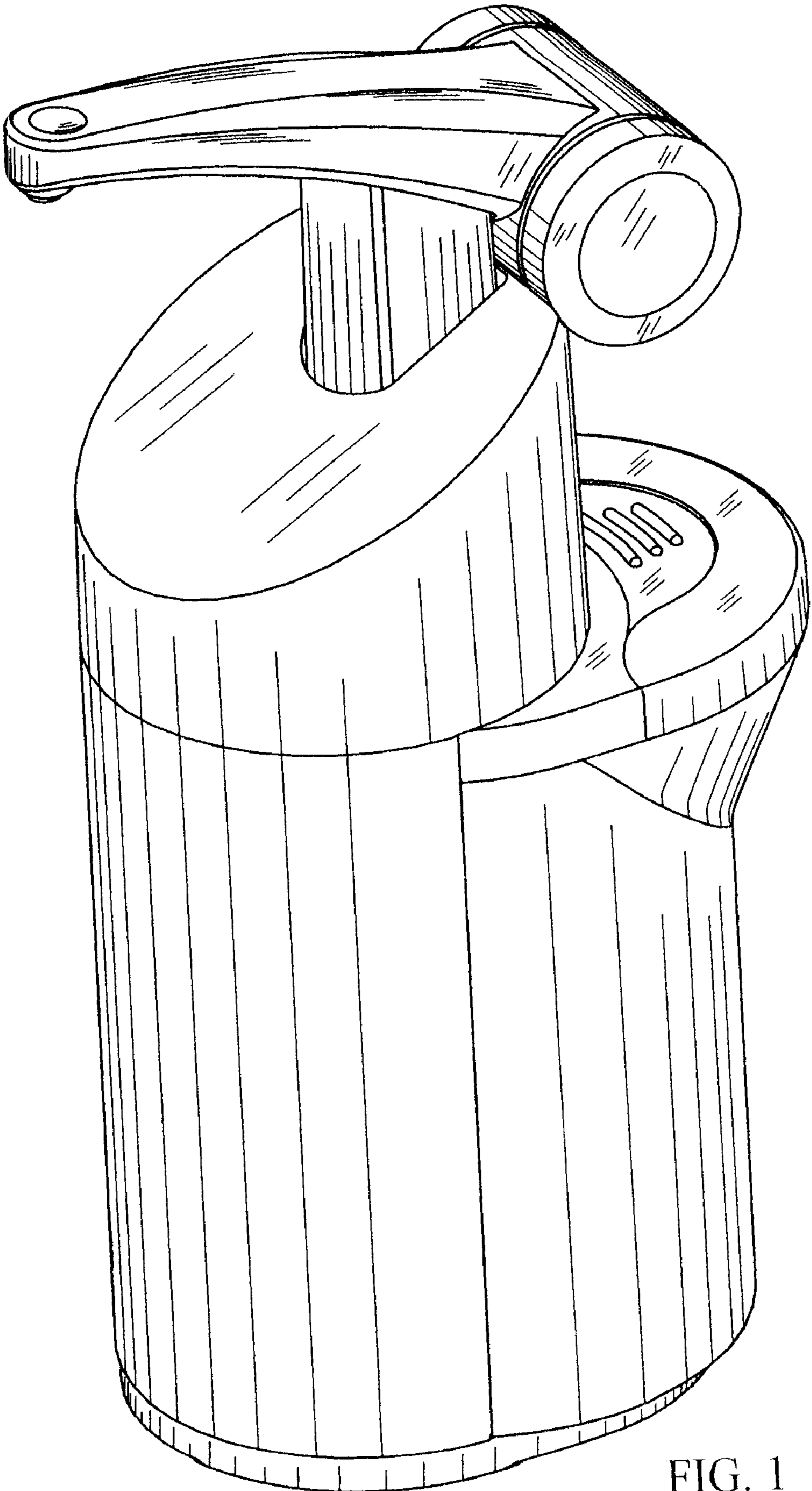

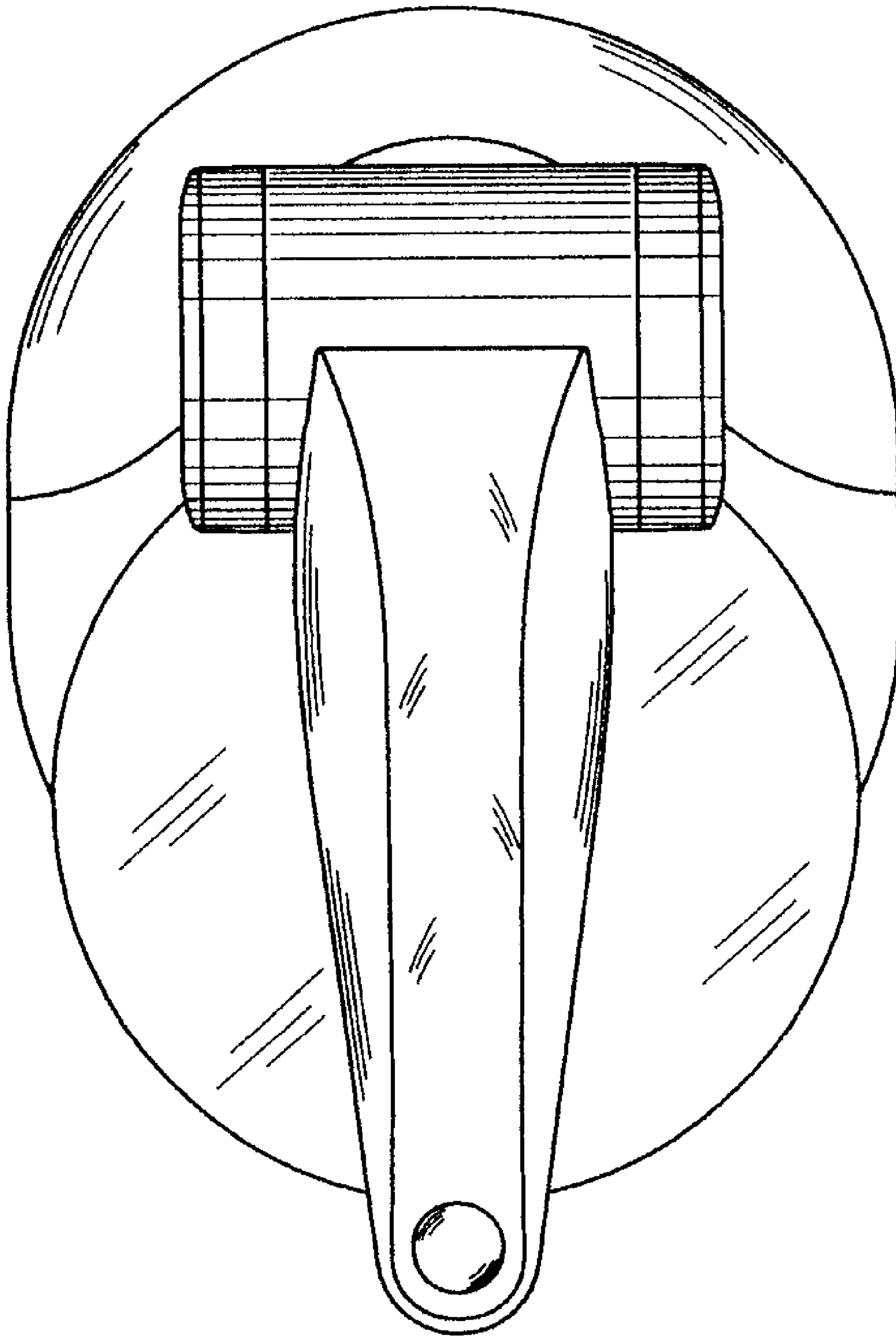

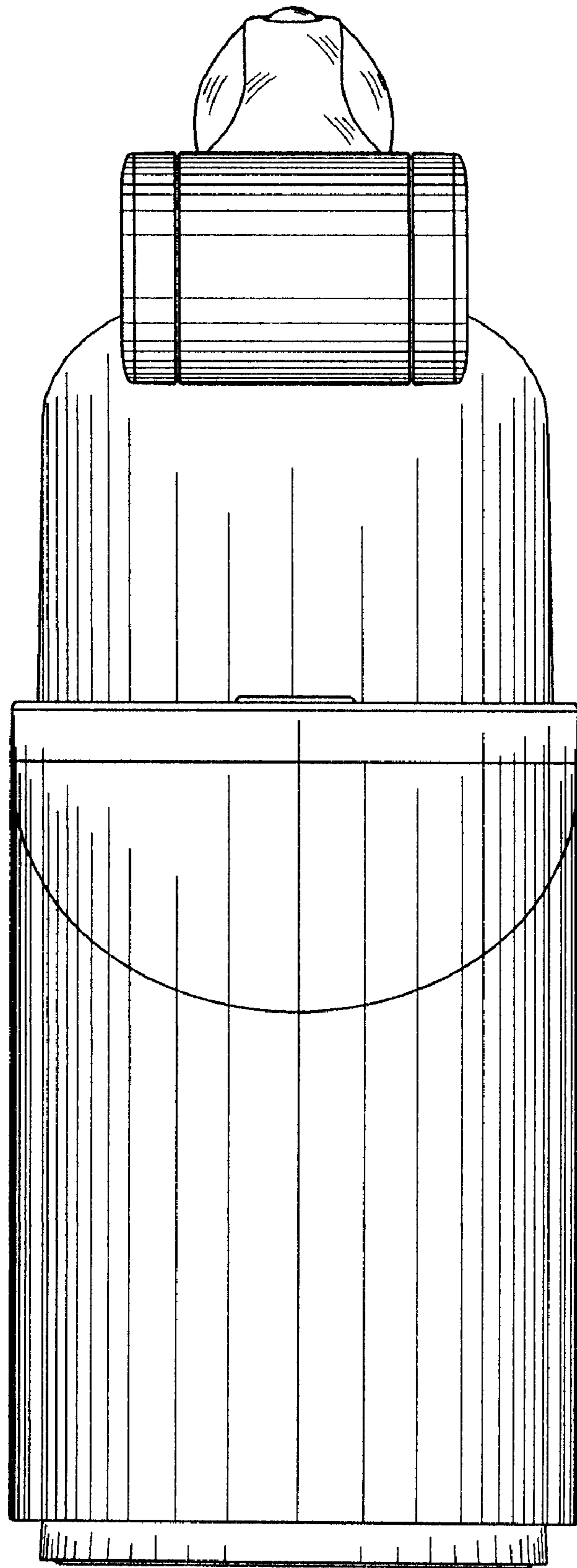

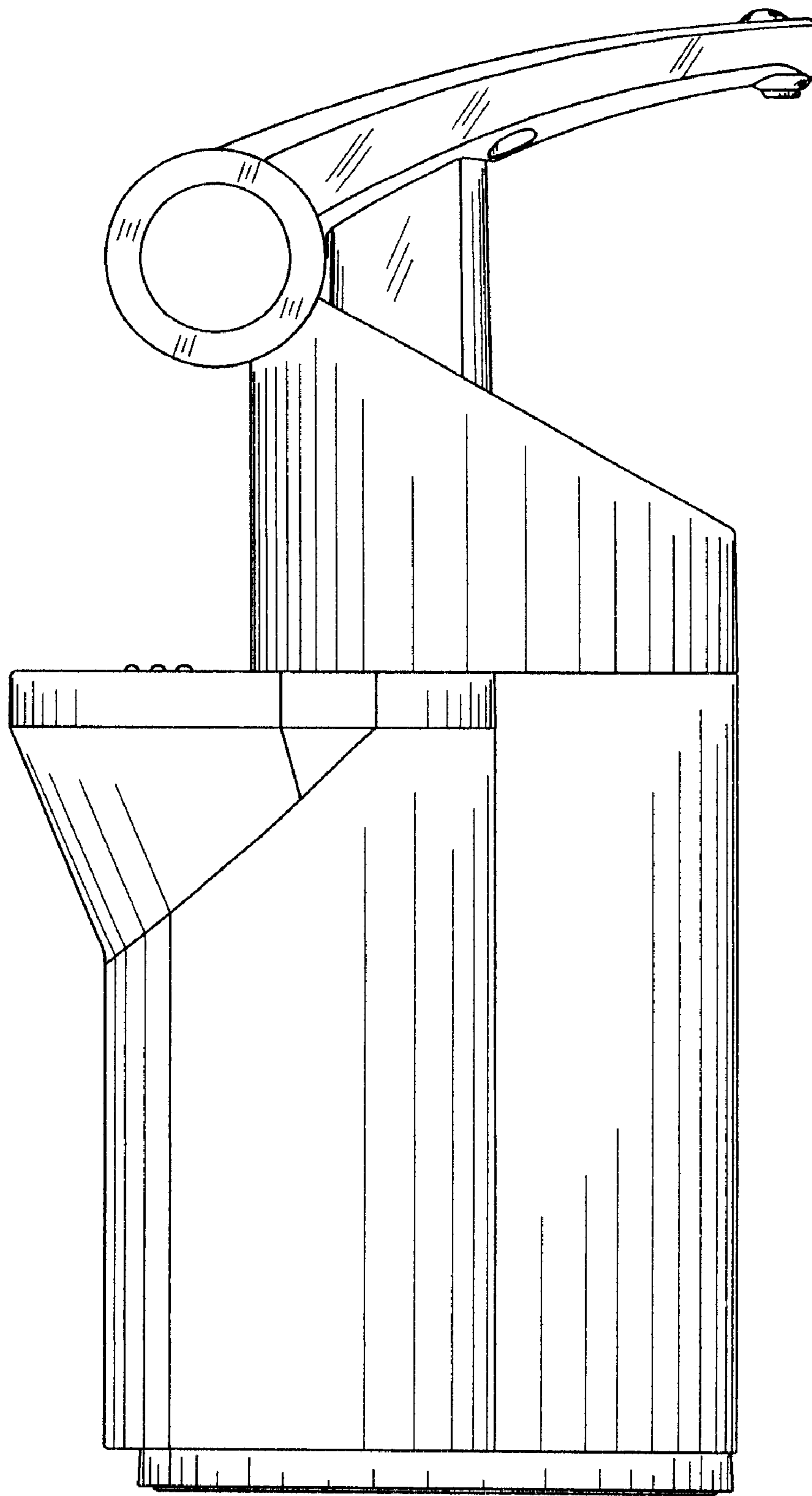

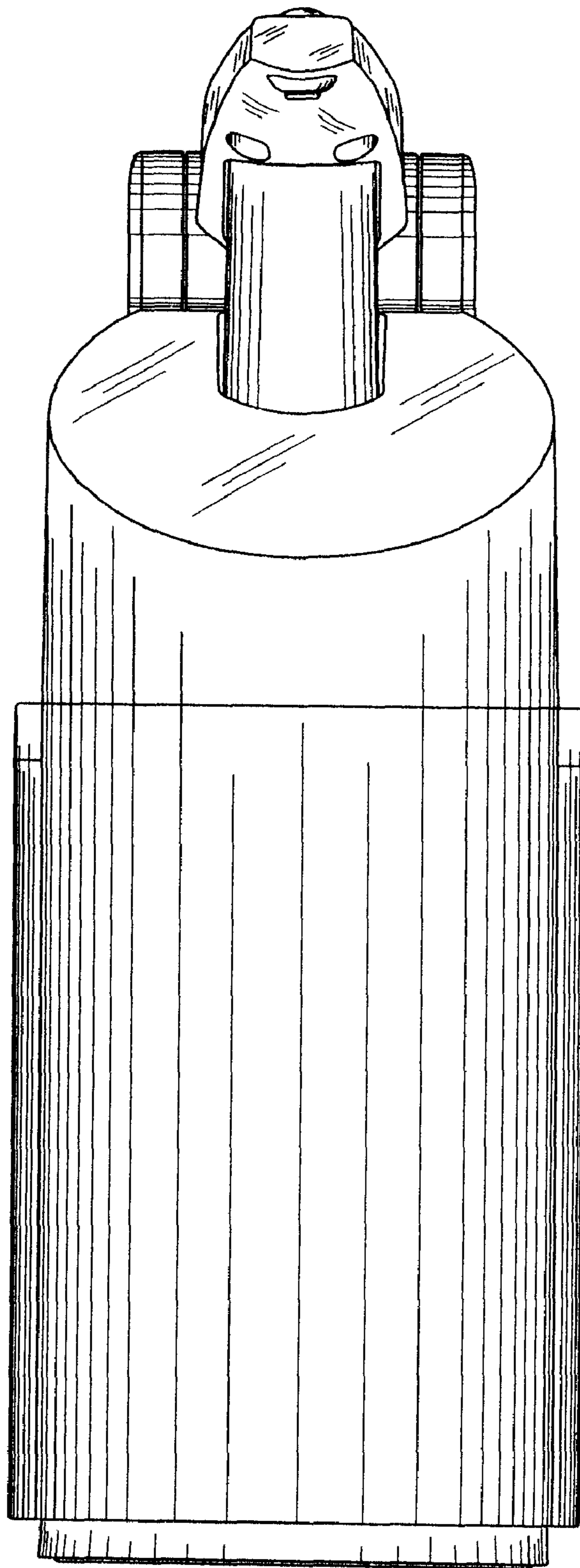

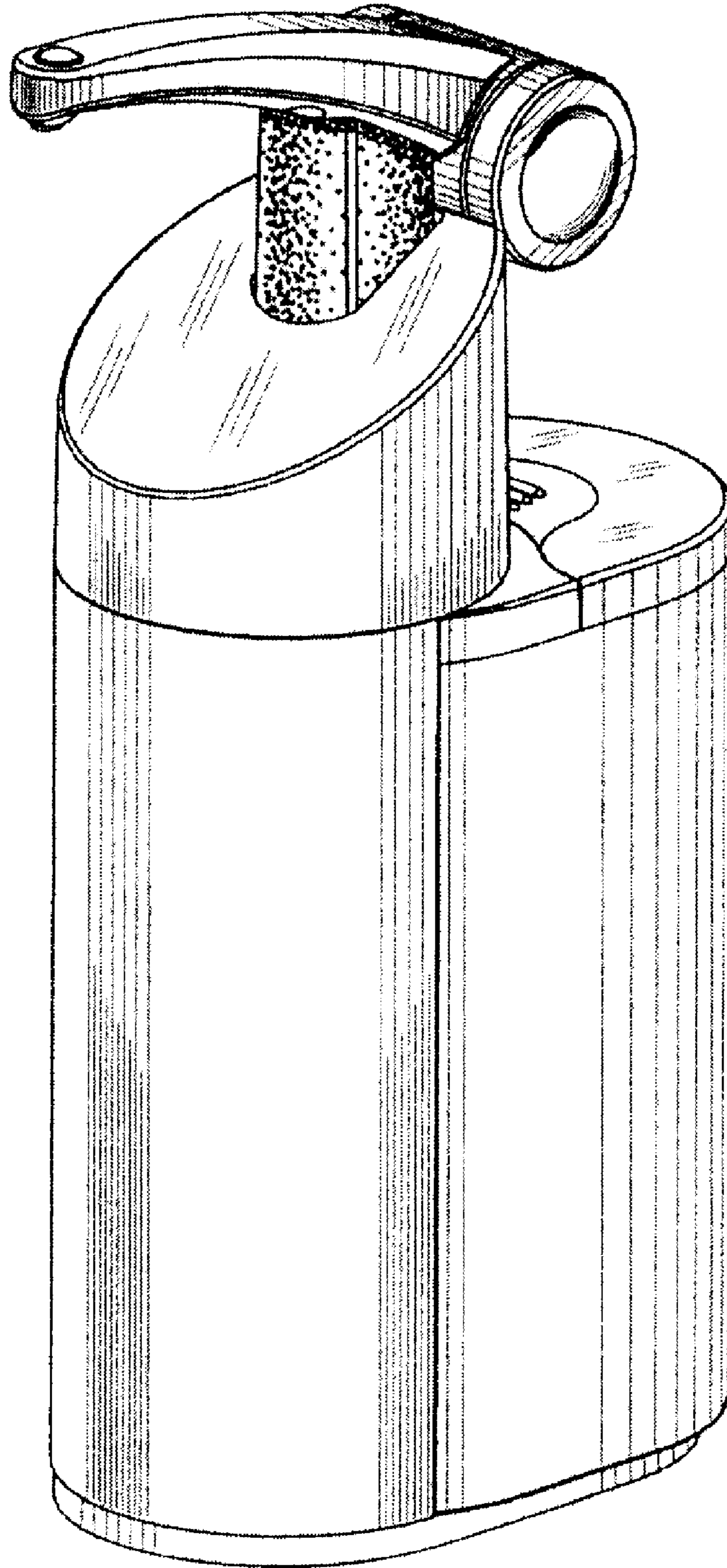

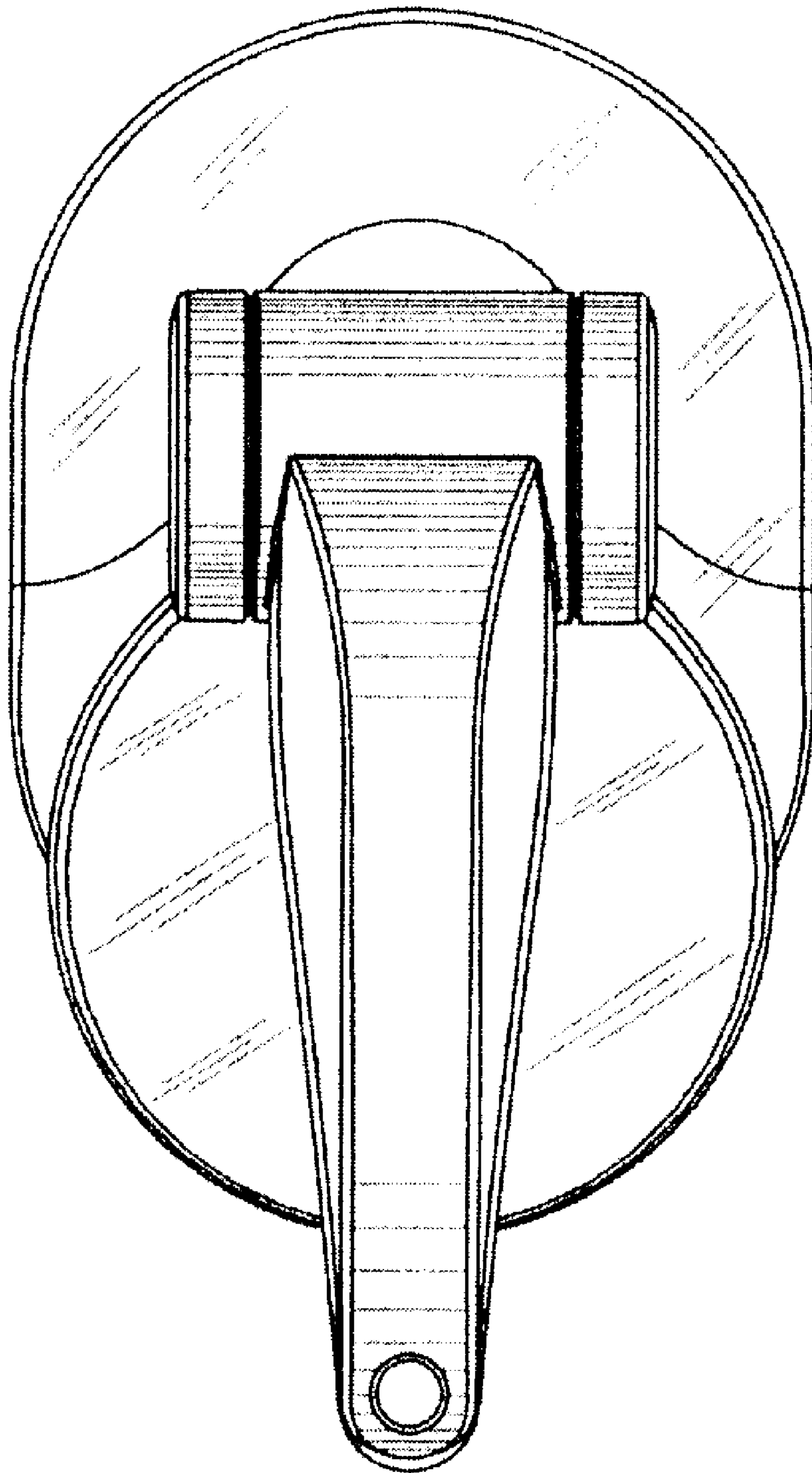

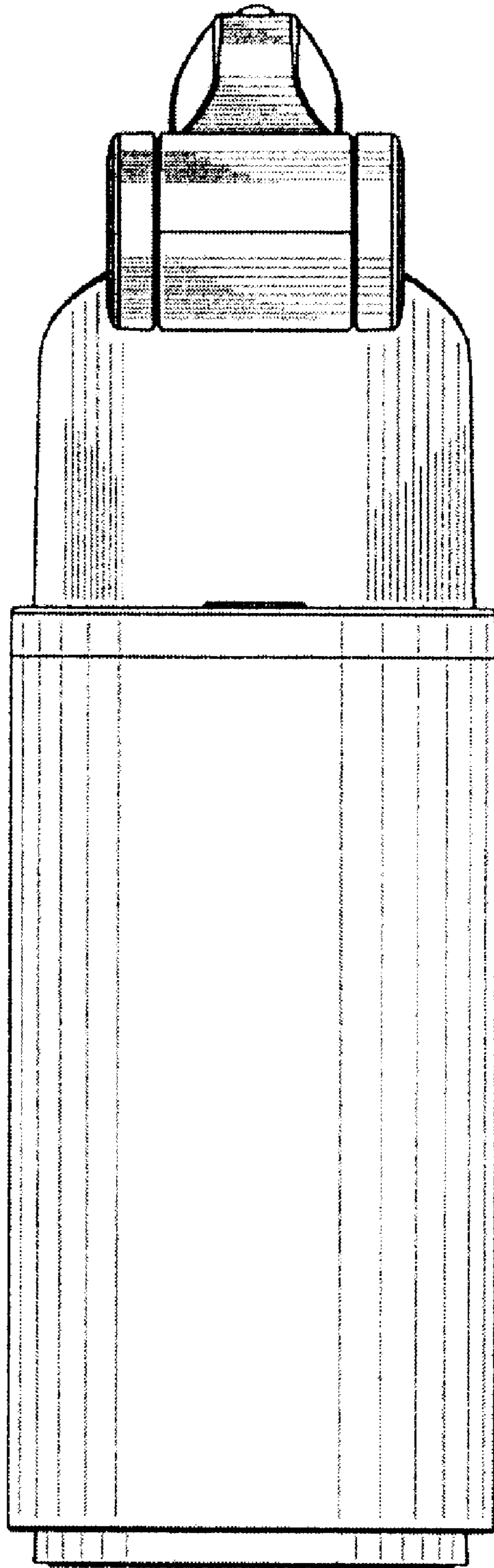

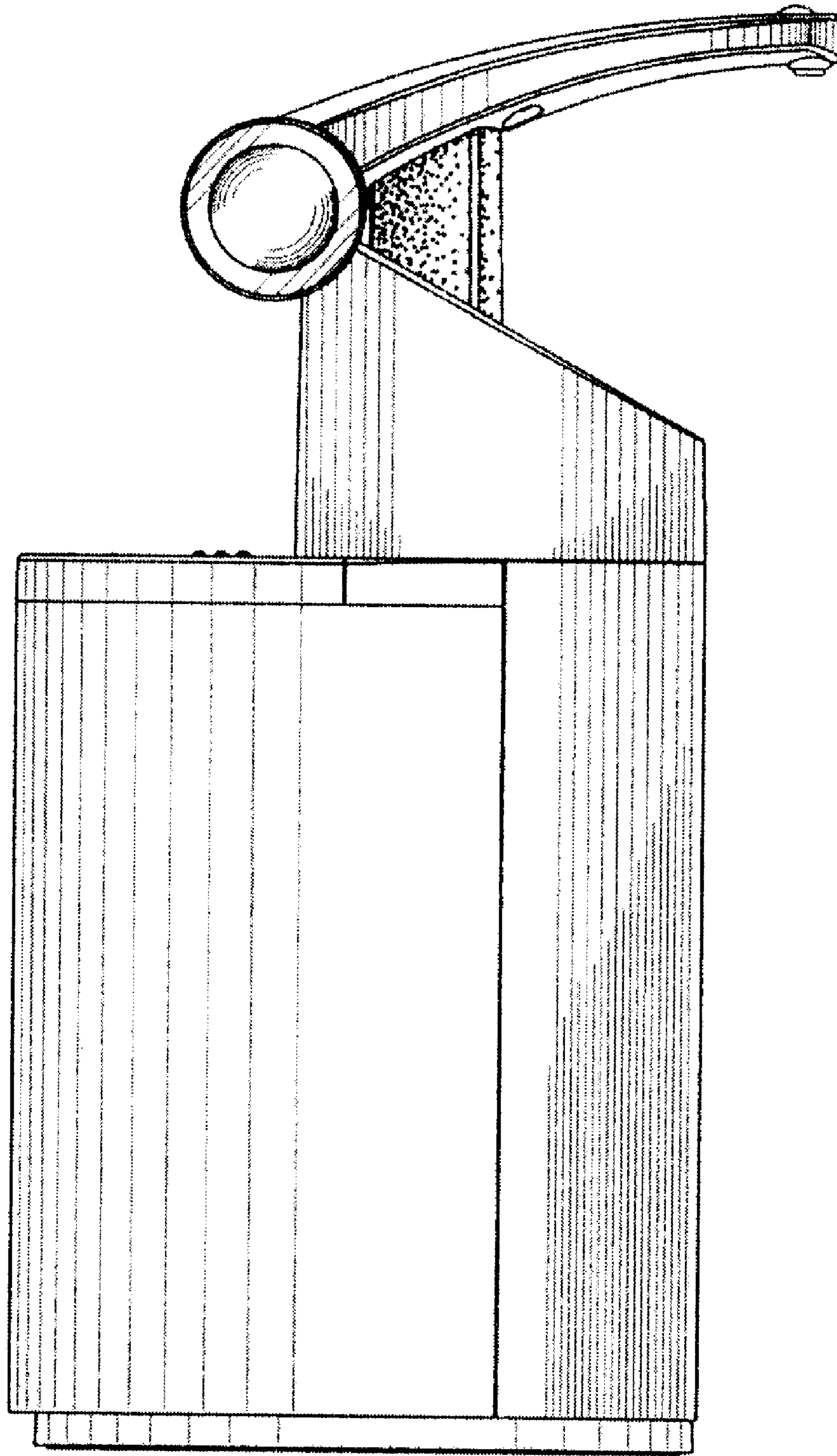

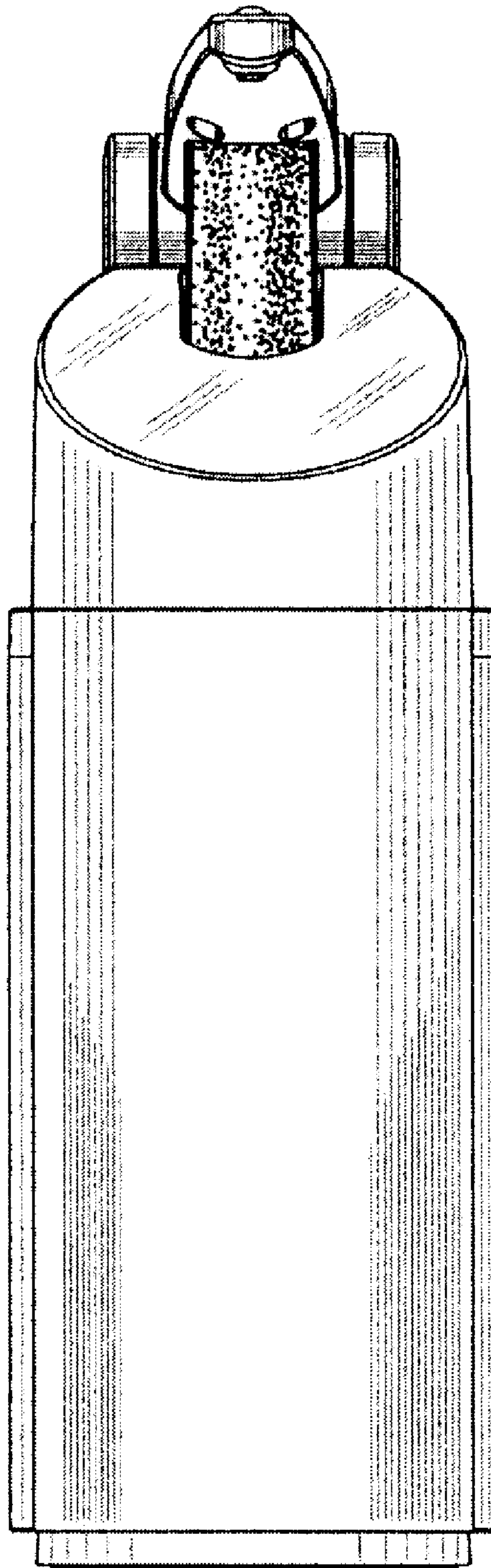
