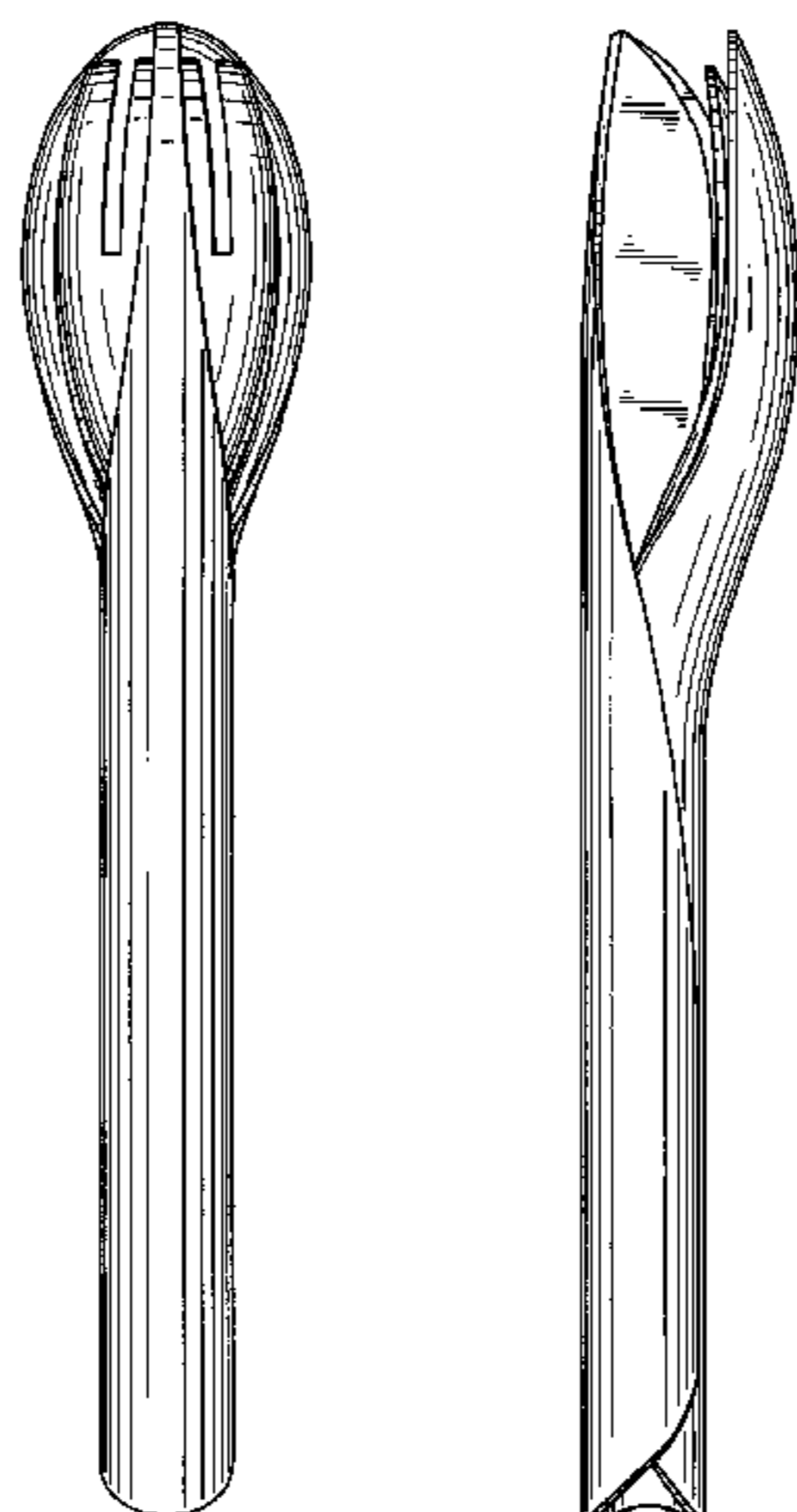
(57) **CLAIM**

The ornamental design for a cutlery set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of an assembled cutlery set incorporating my new design;  
 FIG. 2 is a bottom view of the cutlery set;  
 FIG. 3 is a side view of the cutlery set, the view from the other side being a mirror image;  
 FIG. 4 is a view of one end of the cutlery set;  
 FIG. 5 is a view from the other end of the cutlery set;  
 FIG. 6 is a perspective view of the spoon of the cutlery set shown in FIG. 1 shown separately for ease of illustration;  
 FIG. 7 is a top view of the spoon;  
 FIG. 8 is a bottom view of the spoon;  
 FIG. 9 is a side view of the spoon, the view from the other side being a mirror image;  
 FIG. 10 is a view from one end of the spoon;  
 FIG. 11 is a view from the other end of the spoon;  
 FIG. 12 is a perspective view of the fork of the cutlery set shown in FIG. 1 shown separately for ease of illustration;  
 FIG. 13 is a top view of the fork;  
 FIG. 14 is a bottom view of the fork;  
 FIG. 15 is a side view of the fork, the view from the other side being a mirror image;  
 FIG. 16 is a view from one end of the fork;  
 FIG. 17 is a view from the other end of the fork;  
 FIG. 18 is a perspective view of the knife of the cutlery set shown in FIG. 1 shown separately for ease of illustration;  
 FIG. 19 is a top view of the knife;  
 FIG. 20 is a bottom view of the knife; and,  
 FIG. 21 is a side view of the knife, the view from the other side being a mirror image.

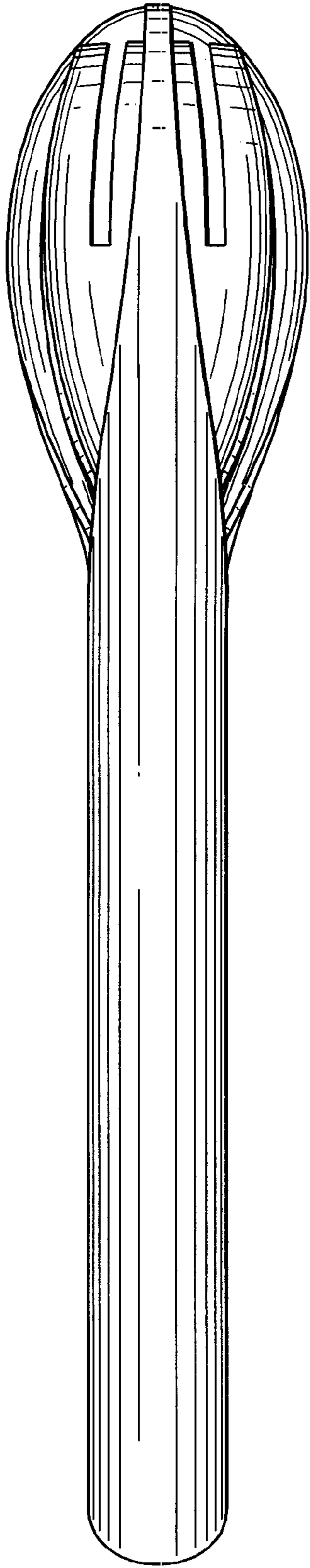

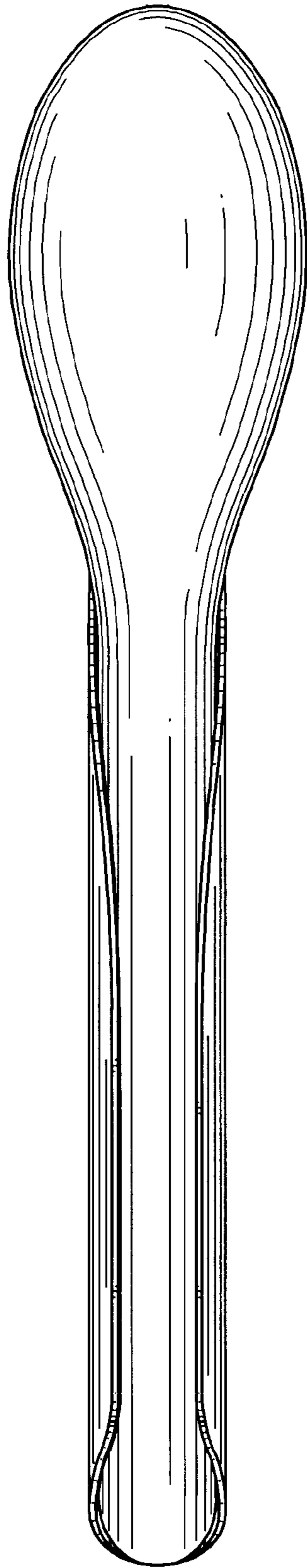

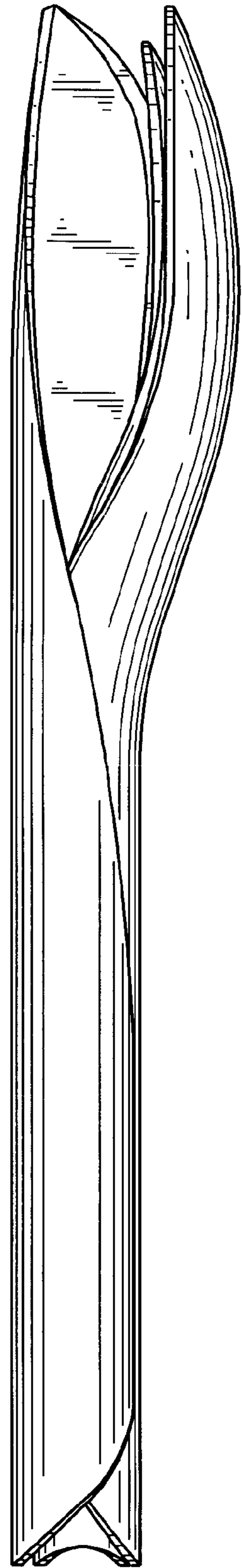

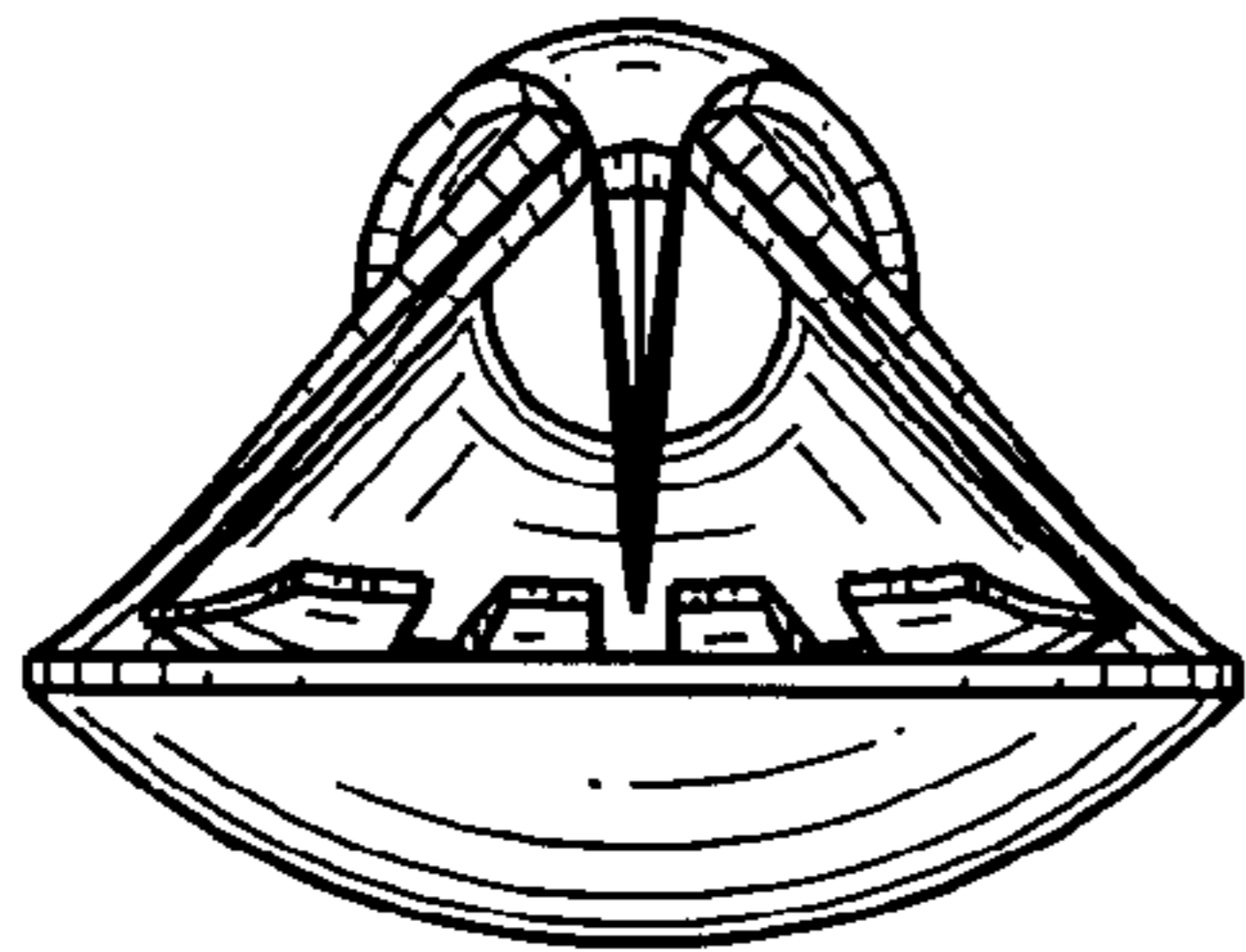

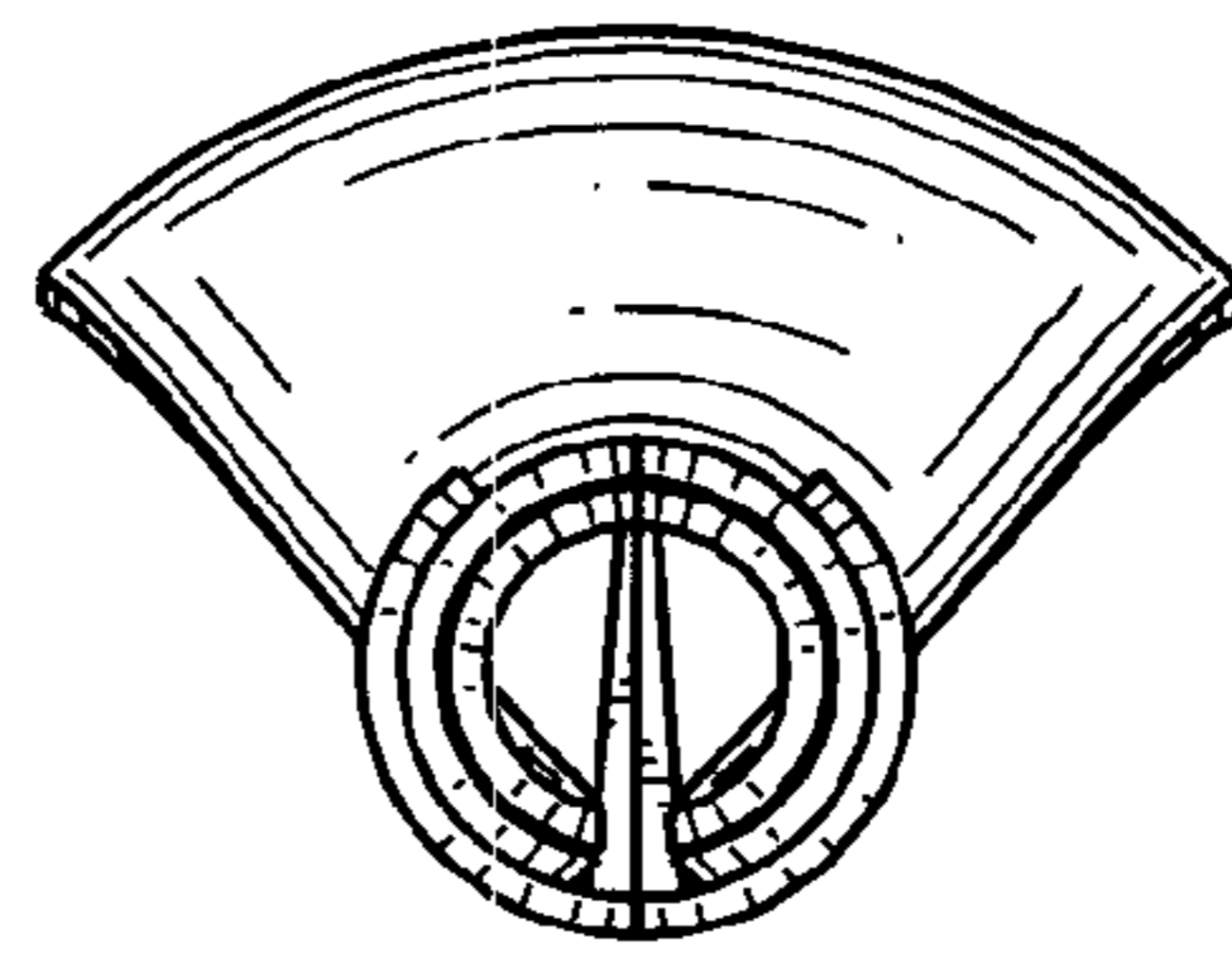

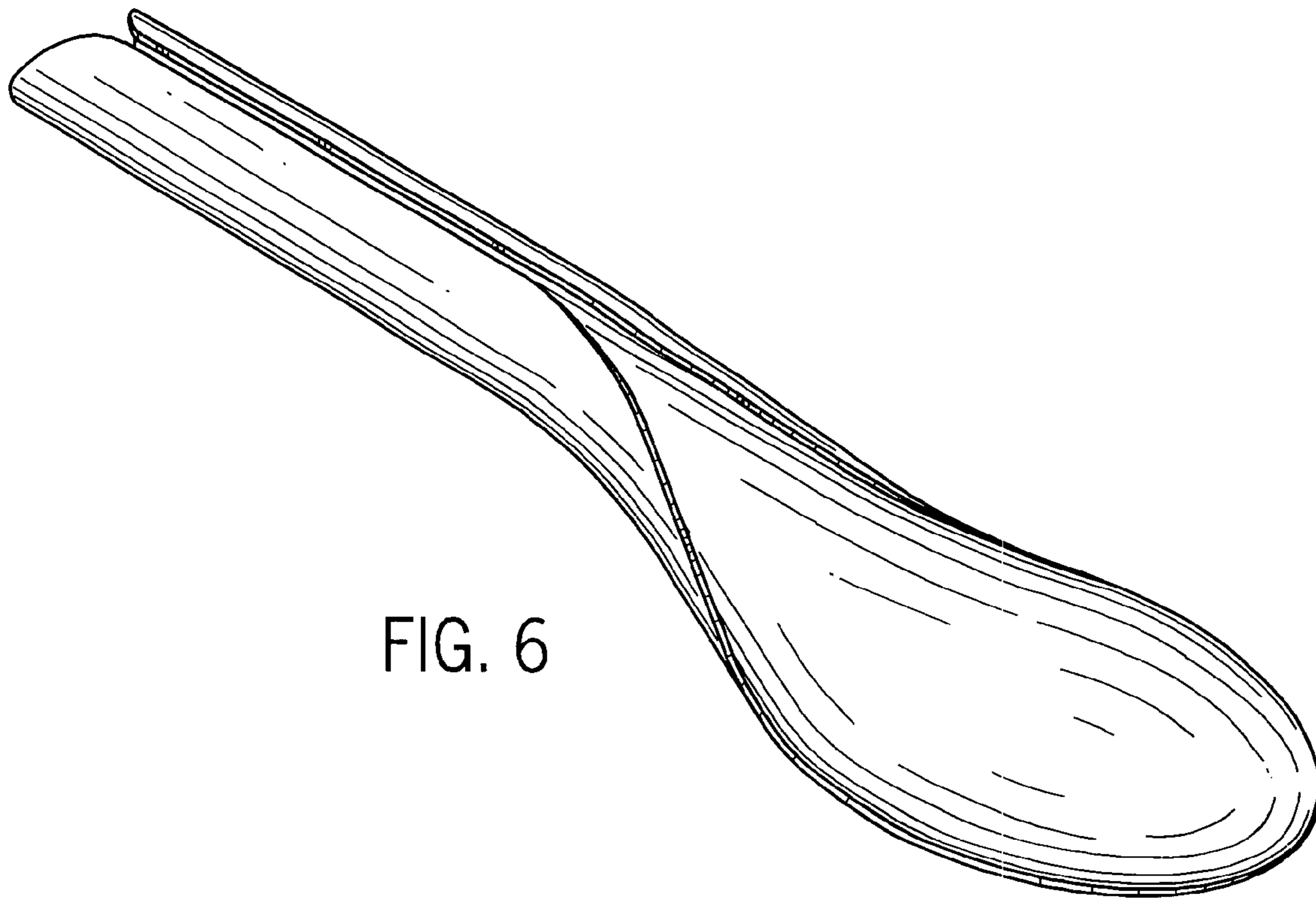

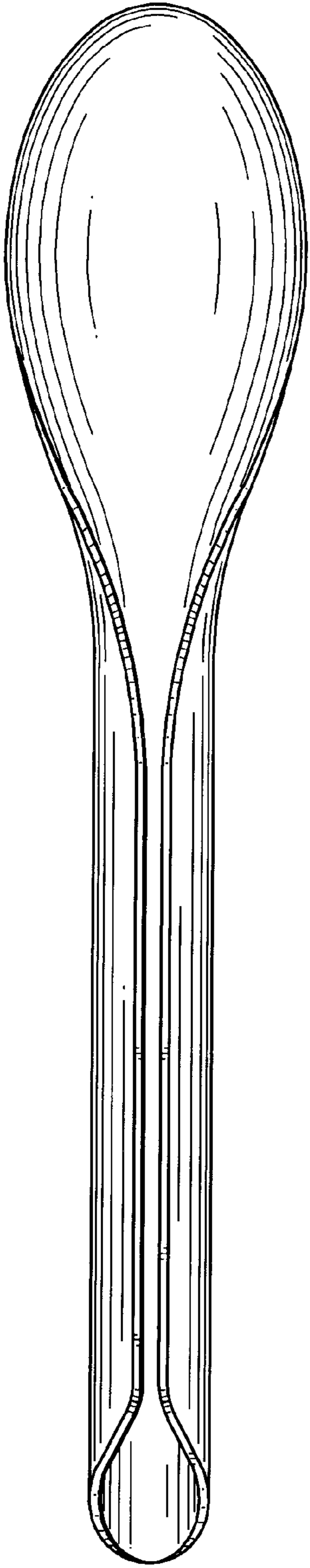

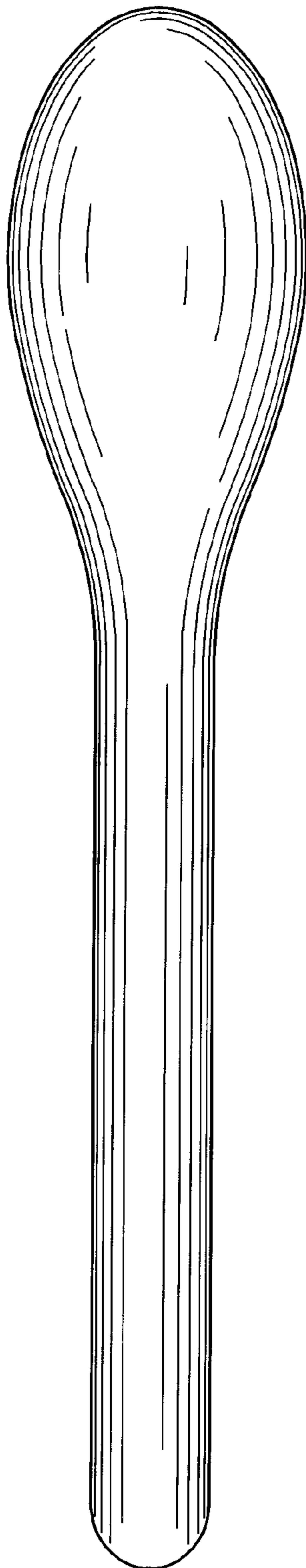

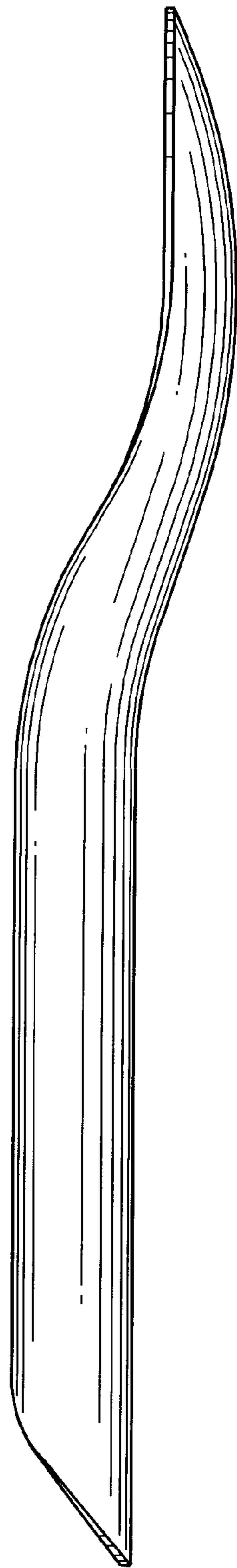

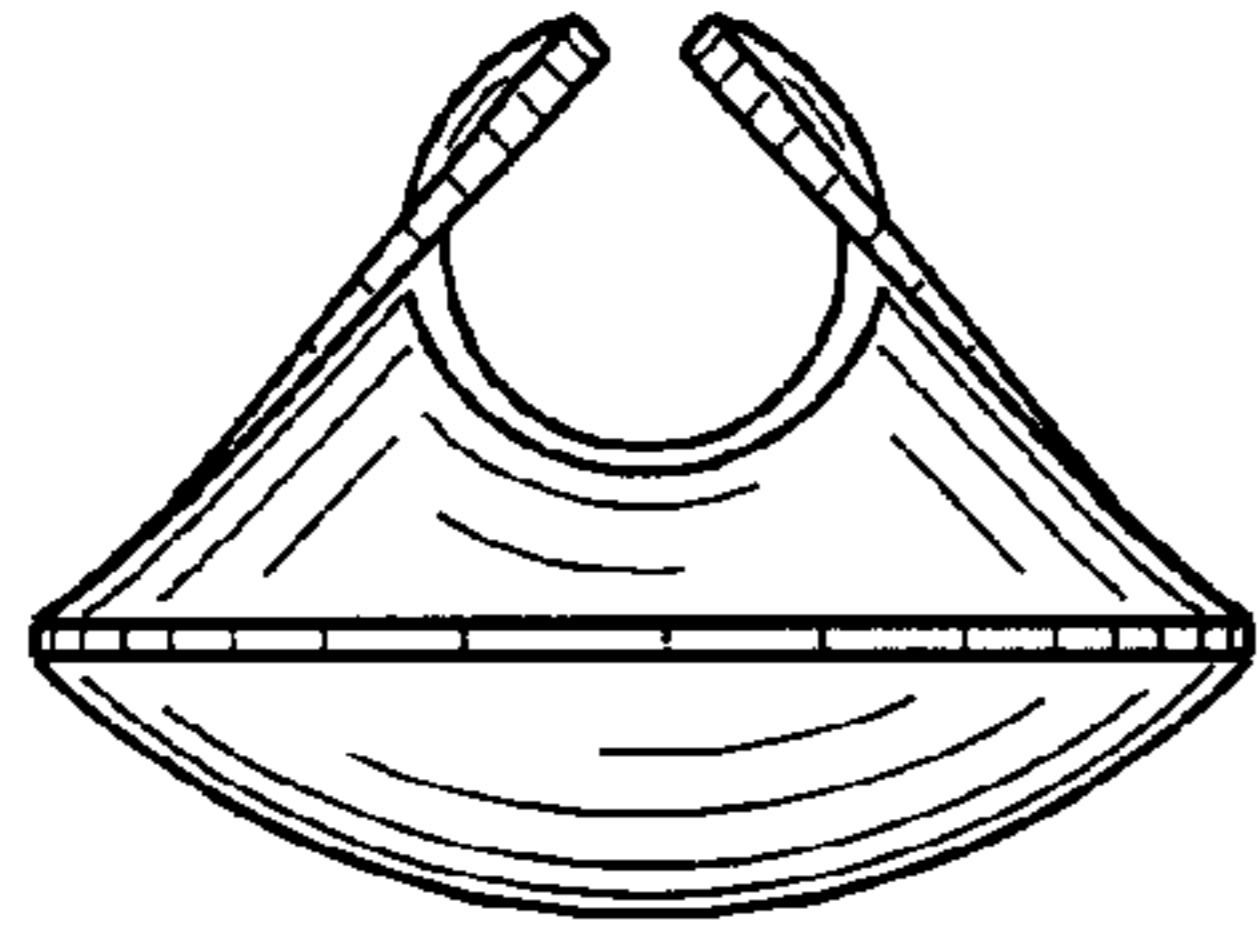

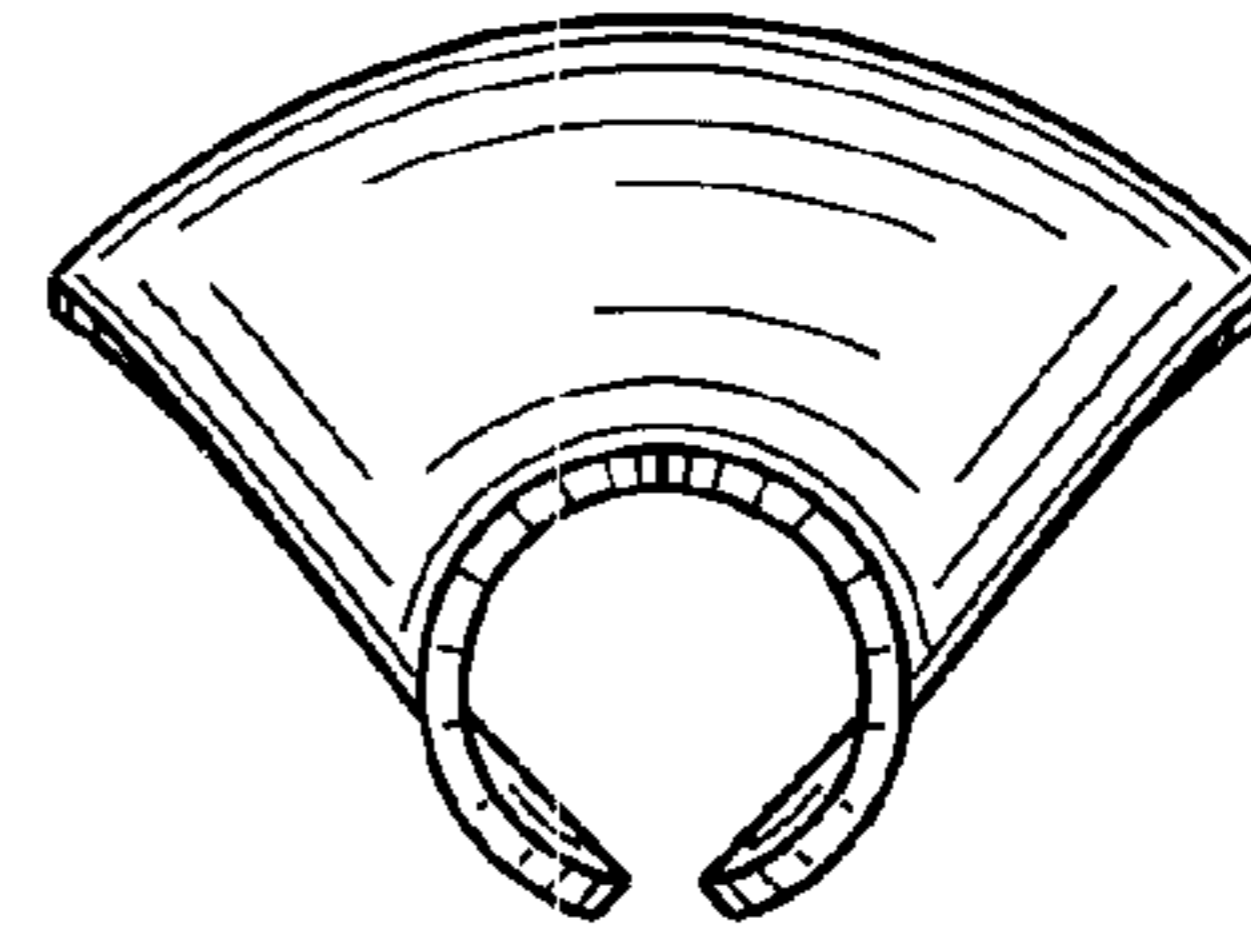

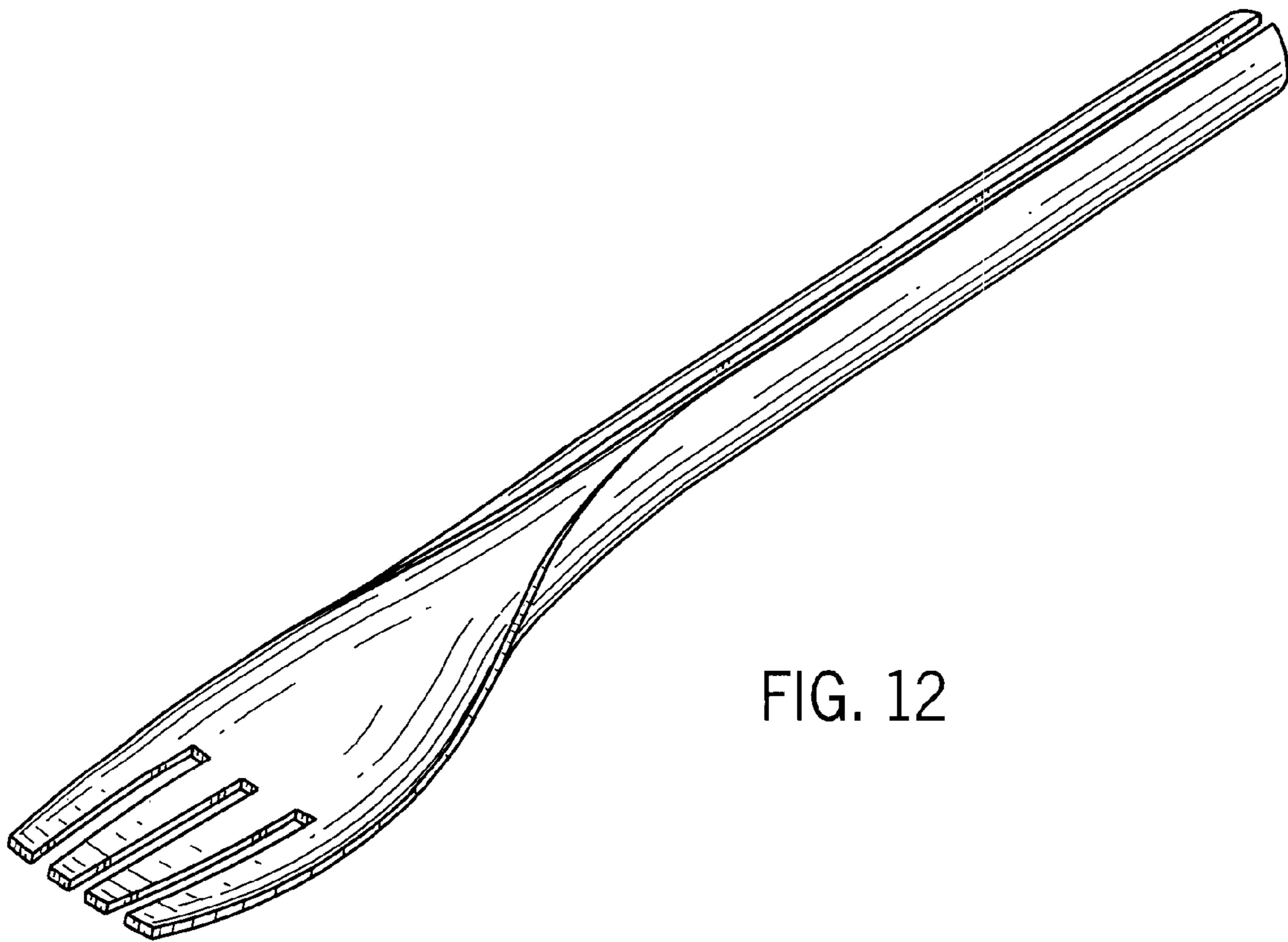

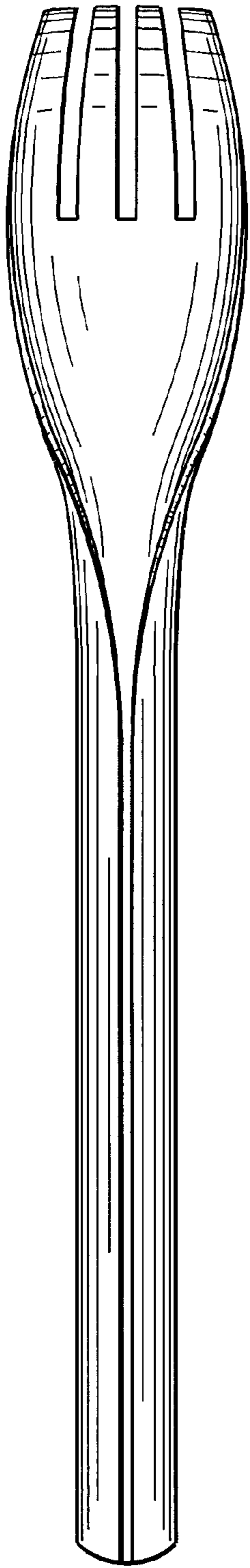

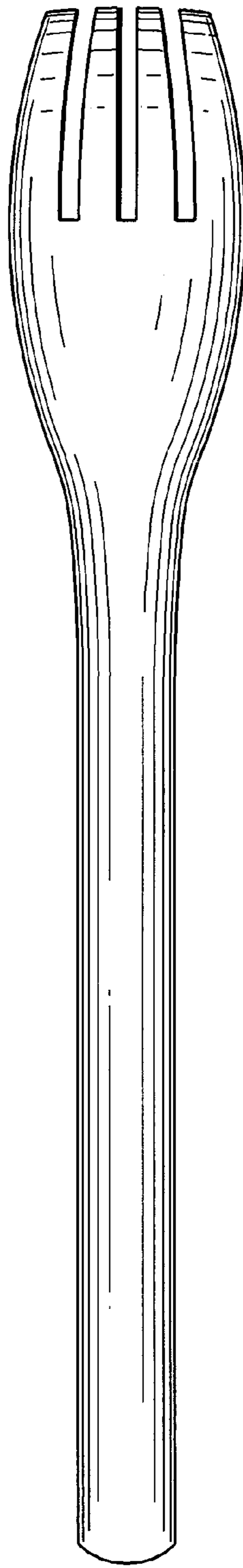

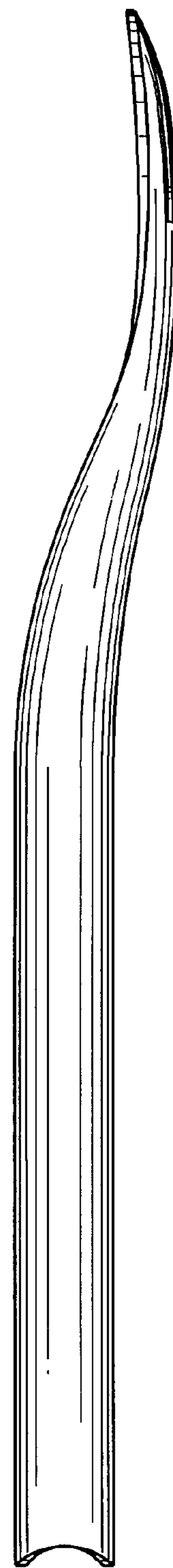

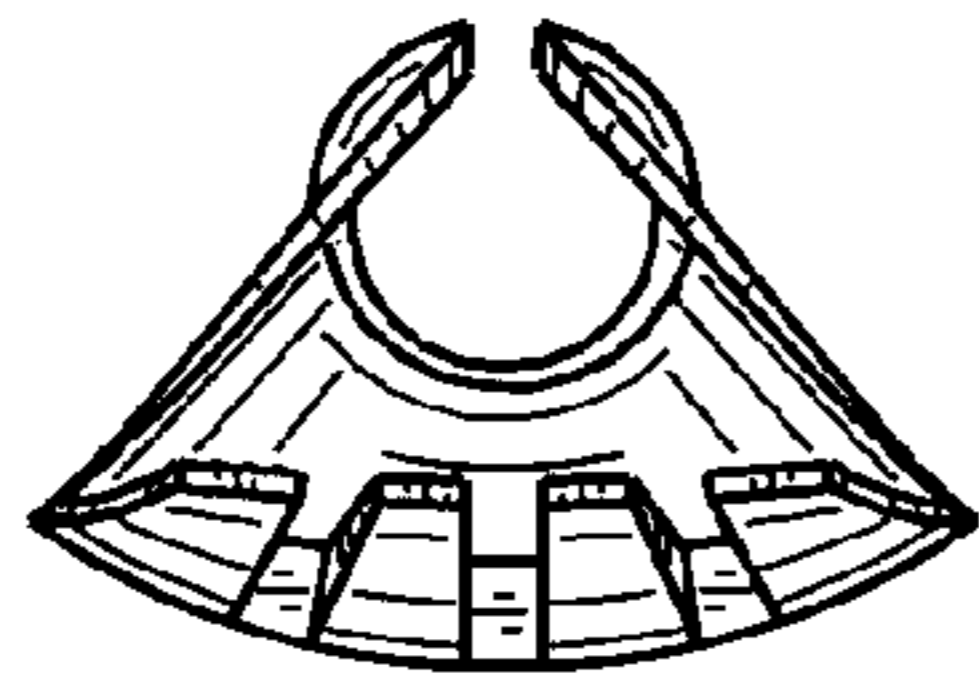

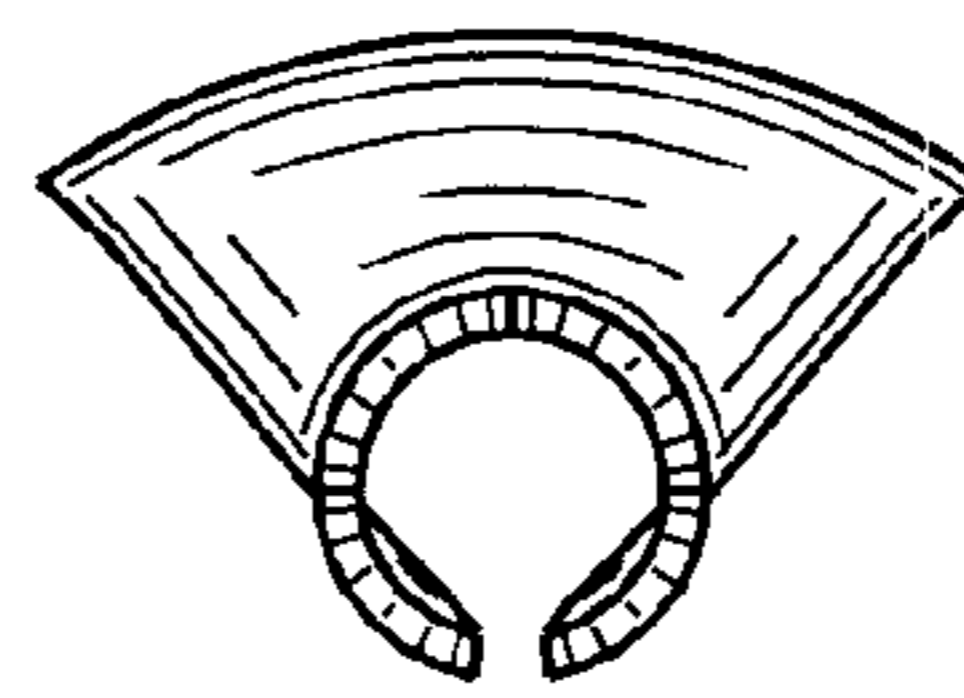

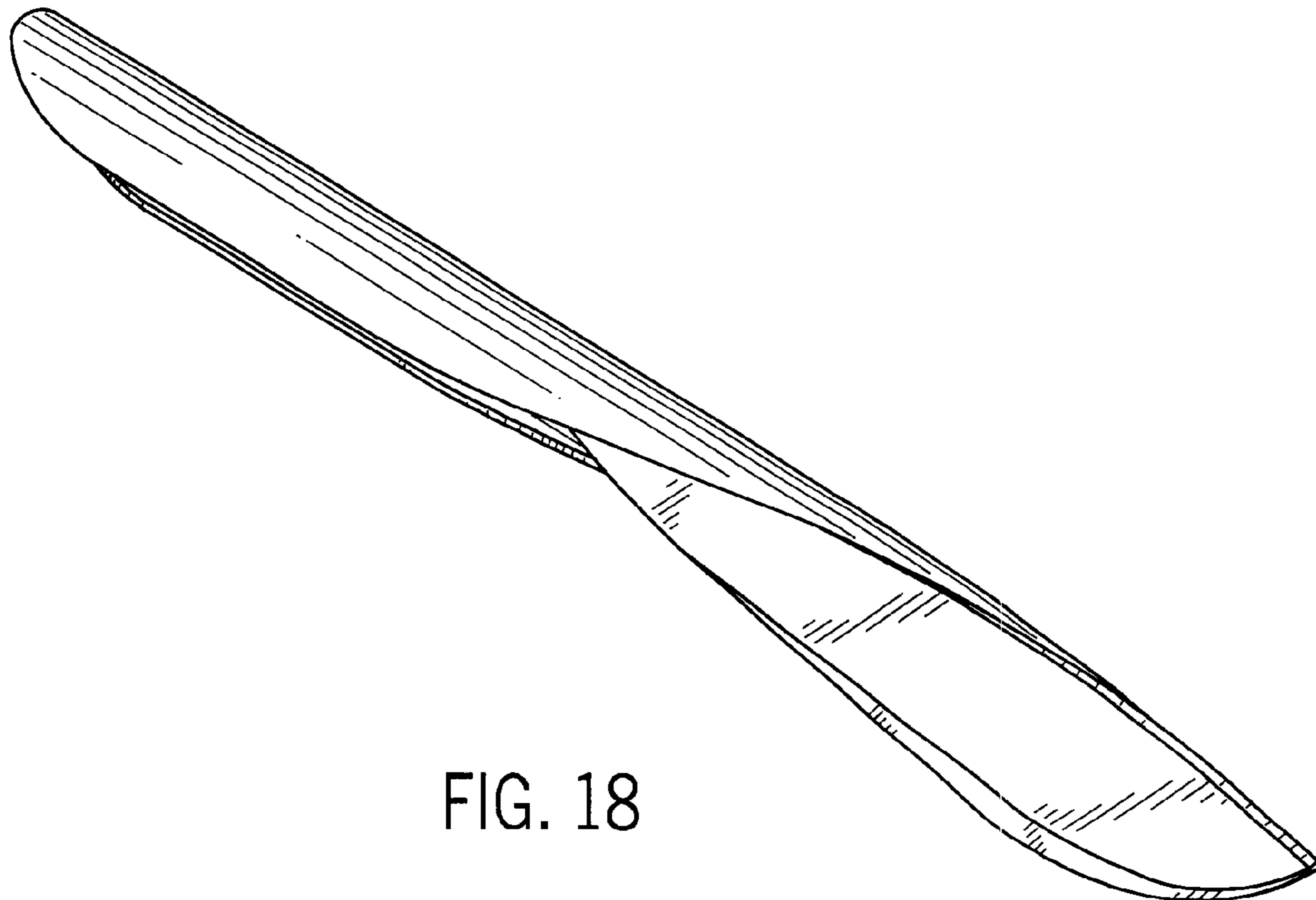

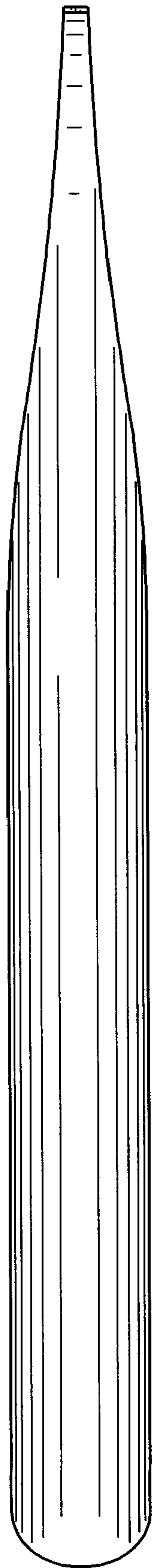

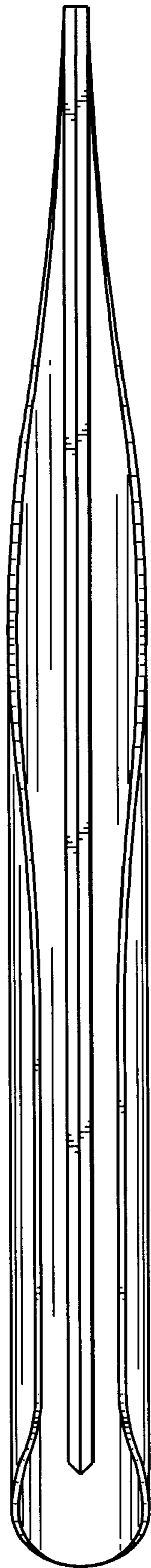

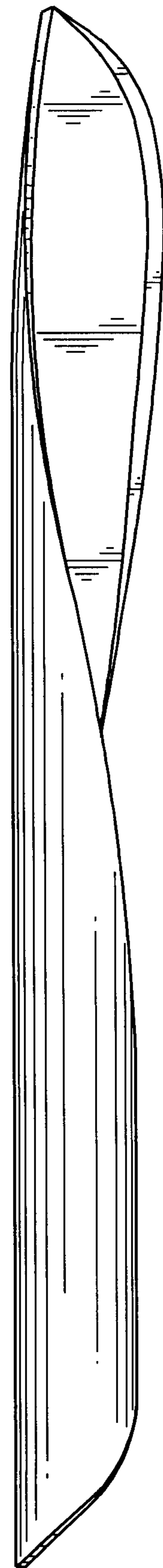
