(57) **CLAIM**

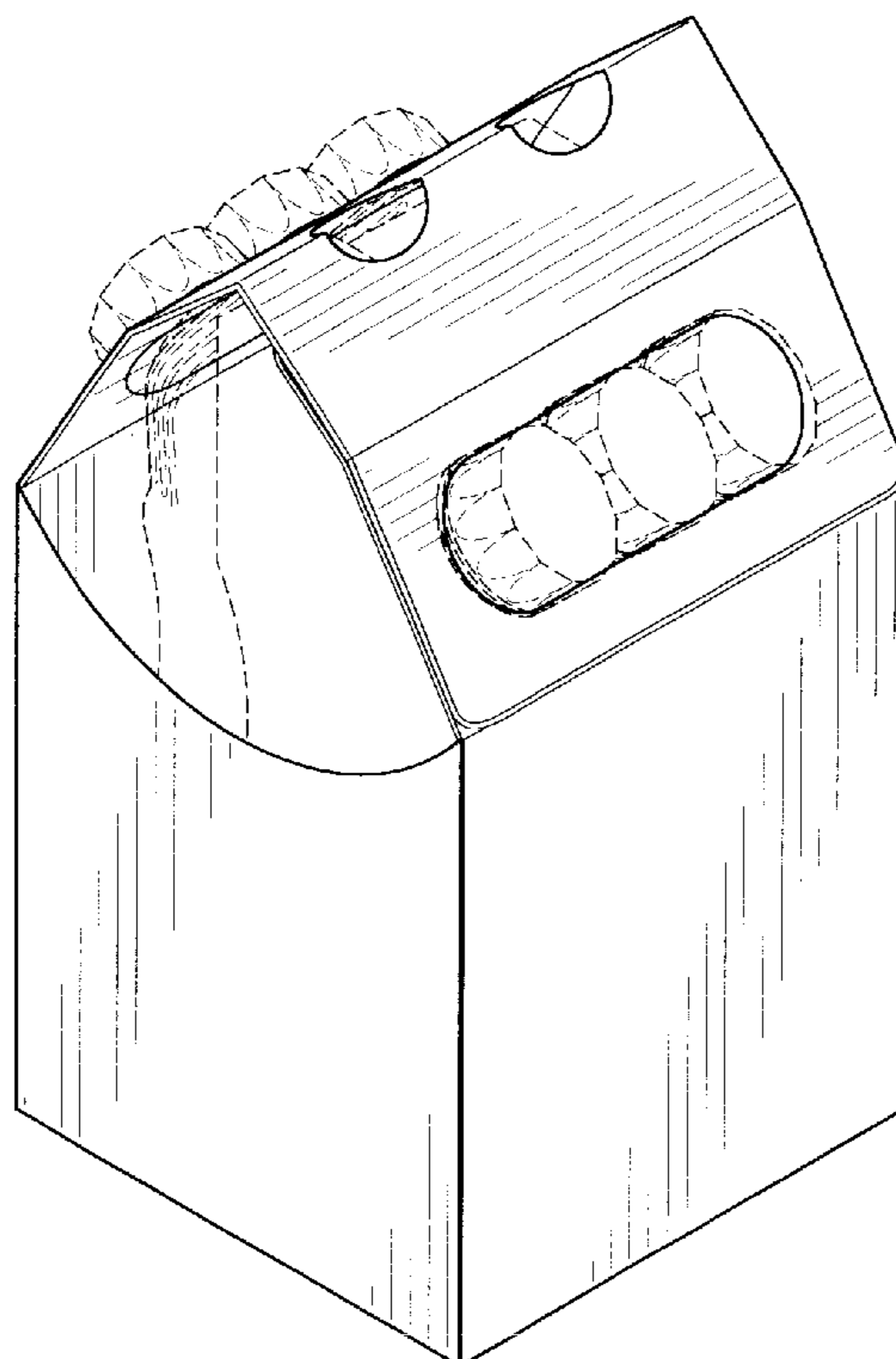
The ornamental design for a container for display, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the container for display showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;

FIG. 6 is a top plan view thereof;

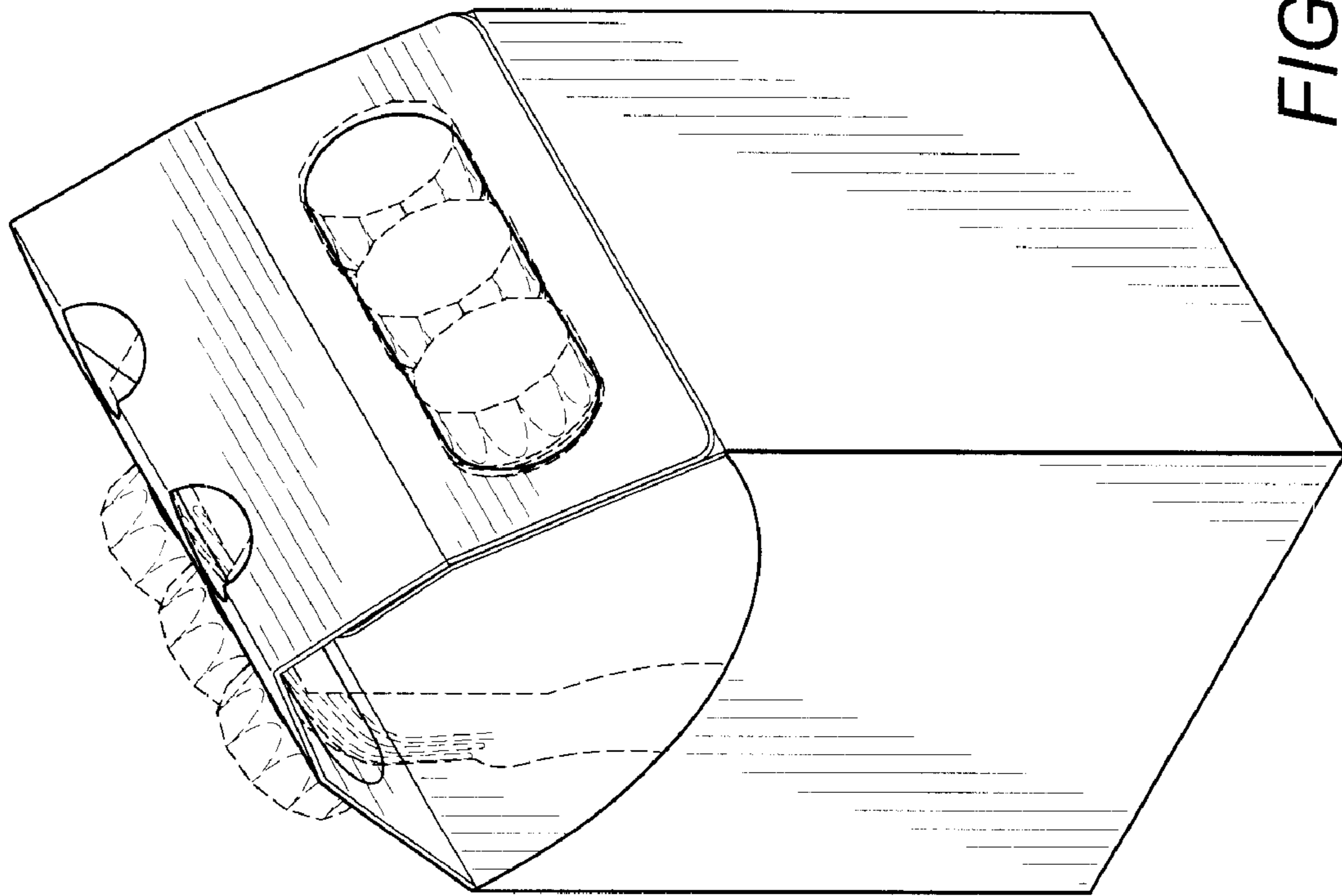

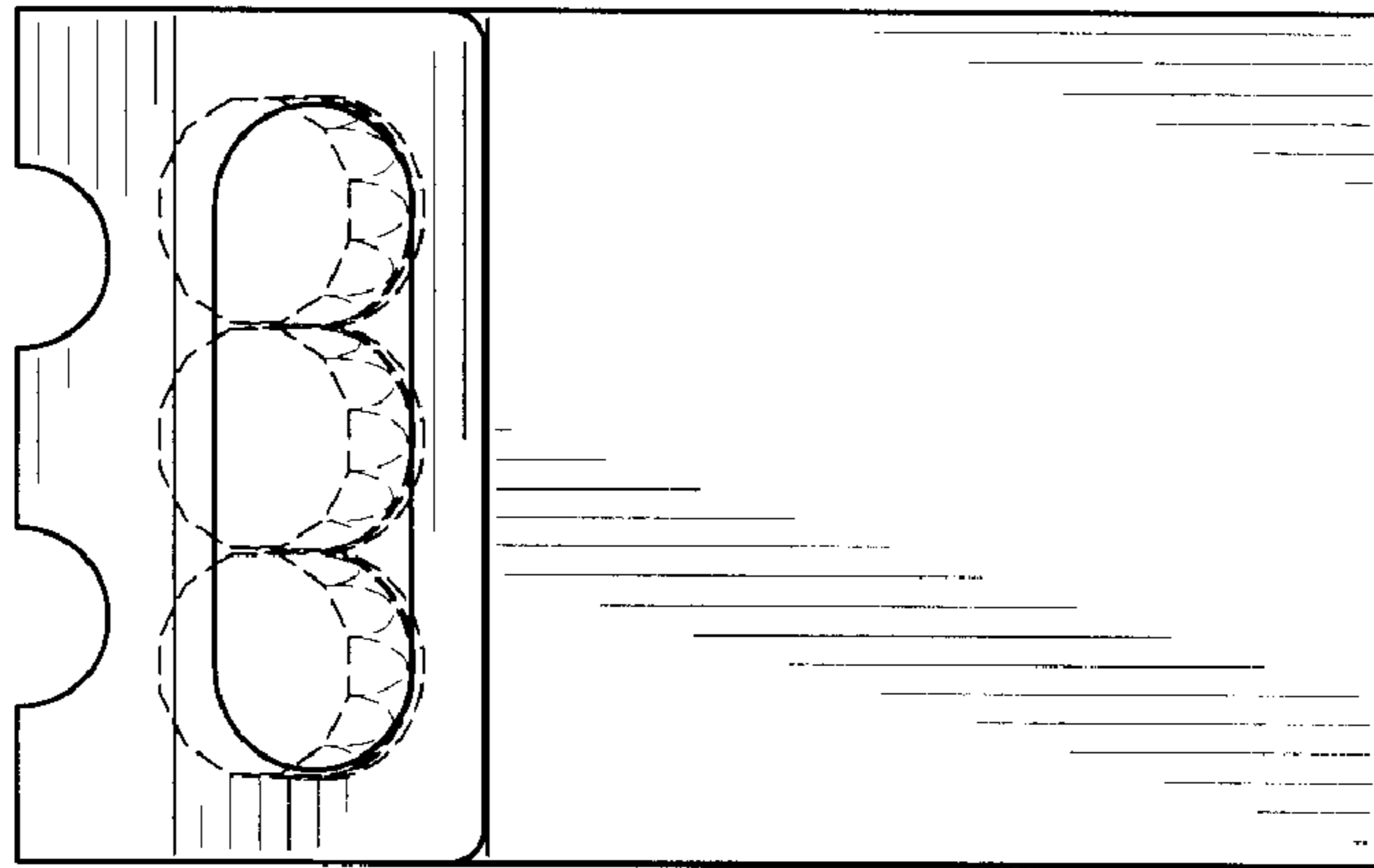

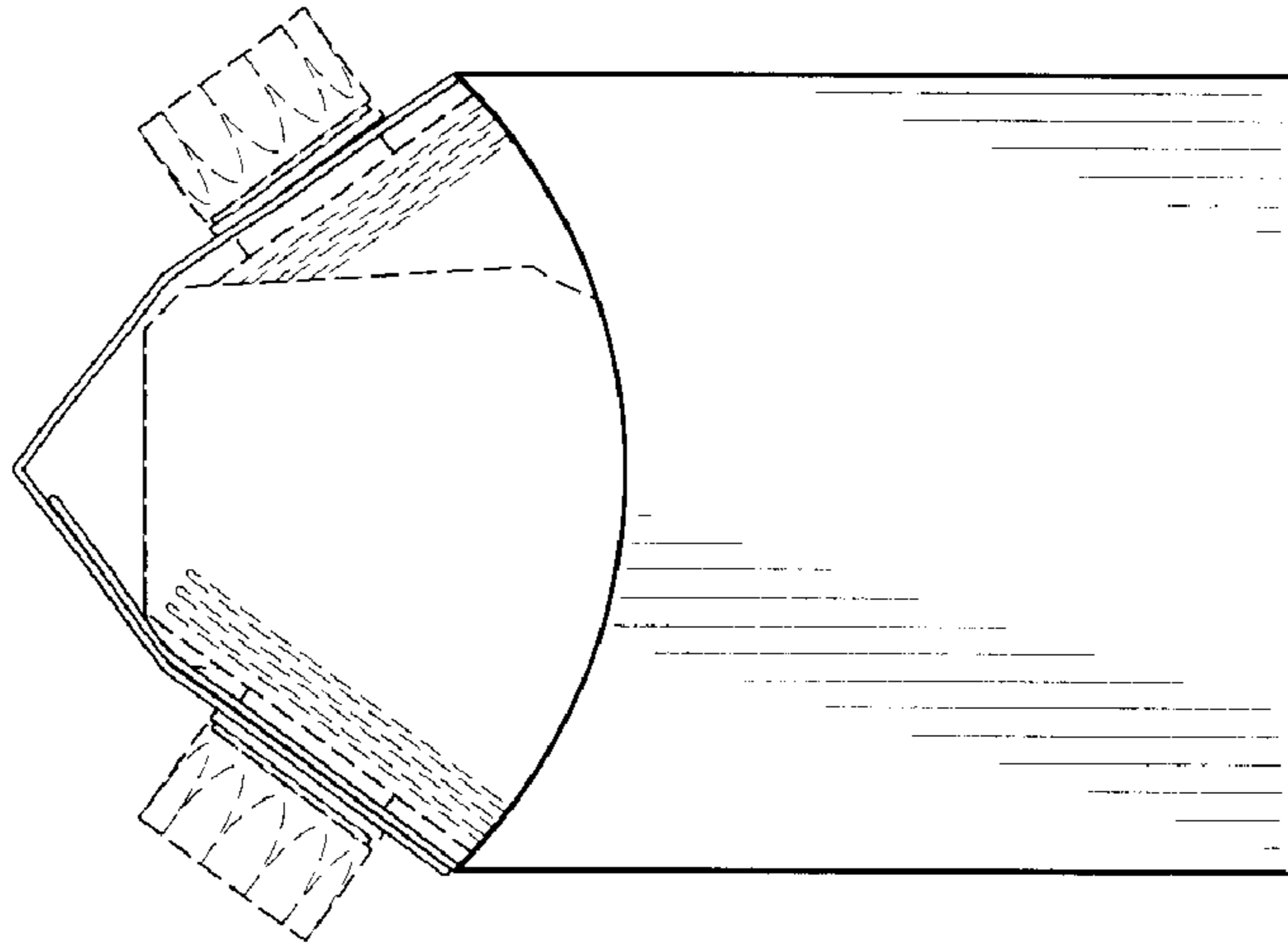

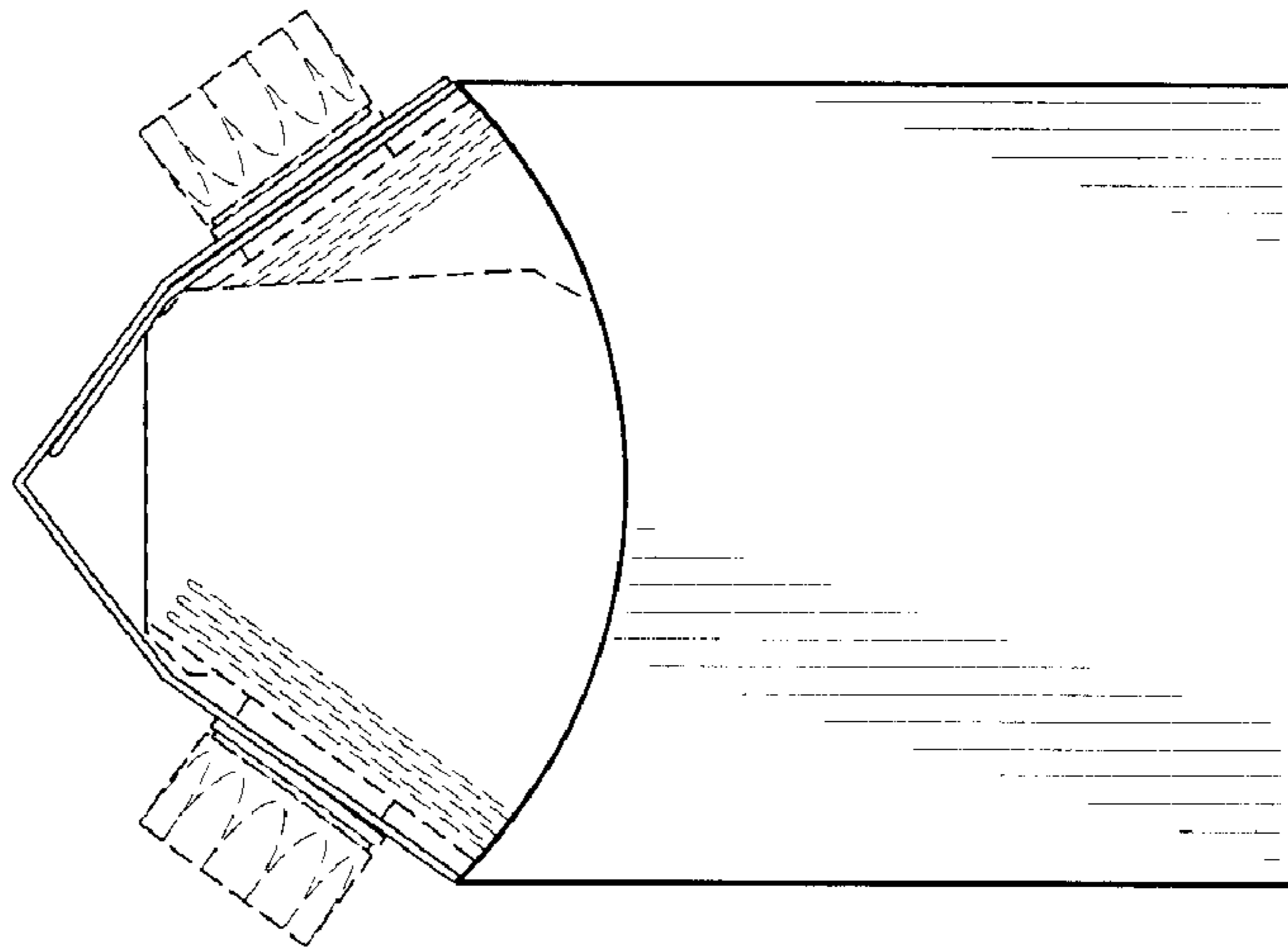

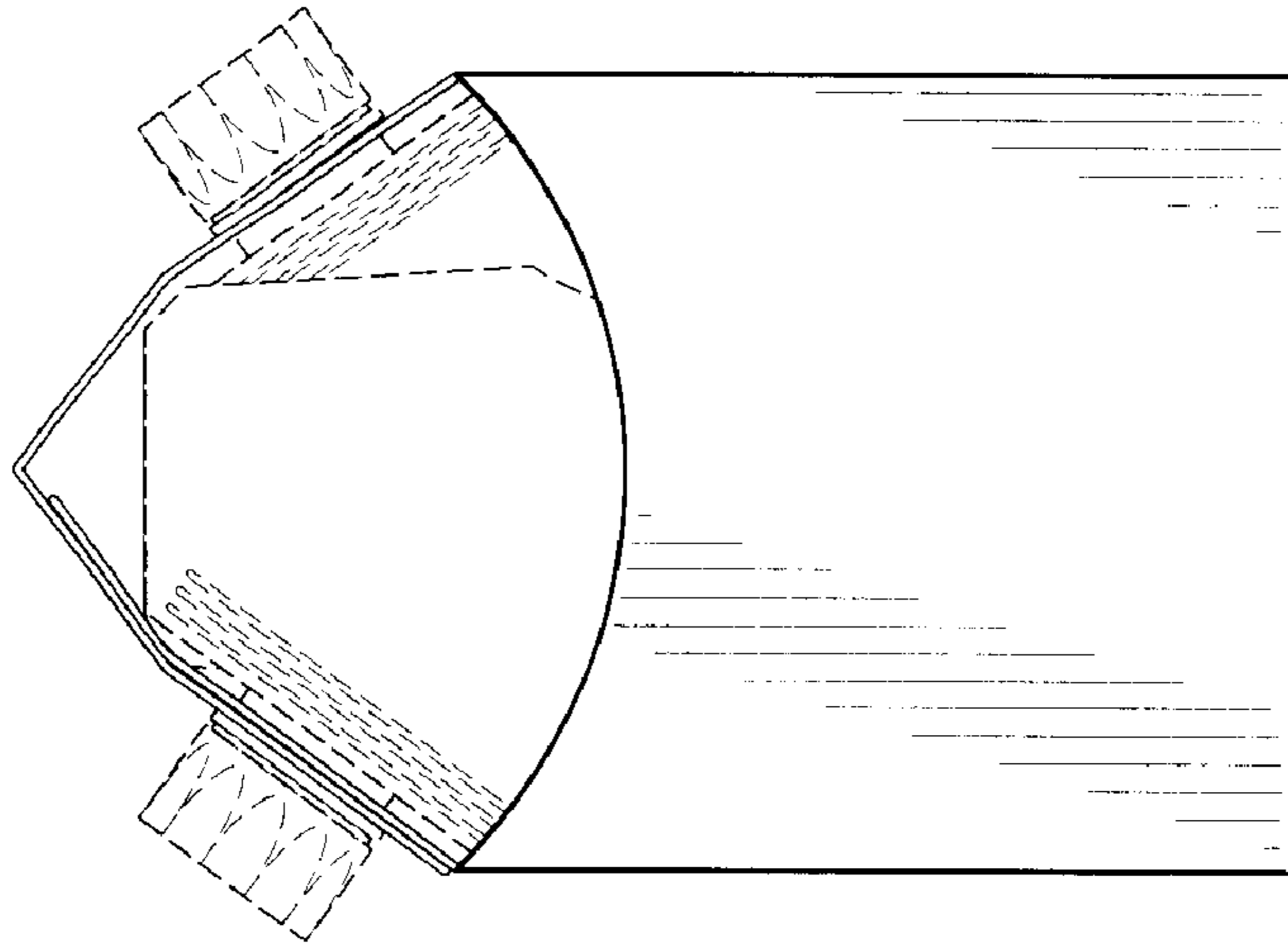

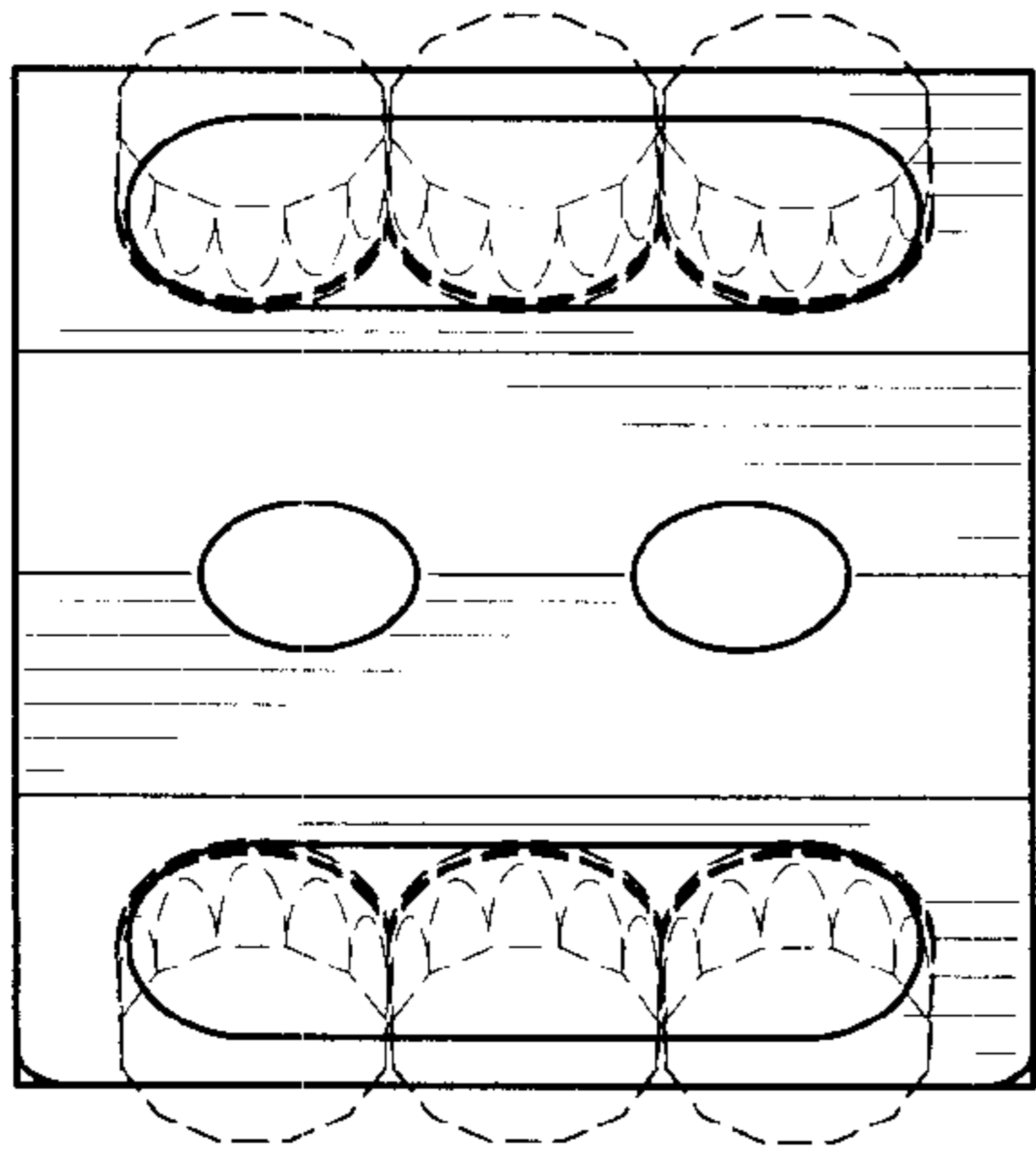

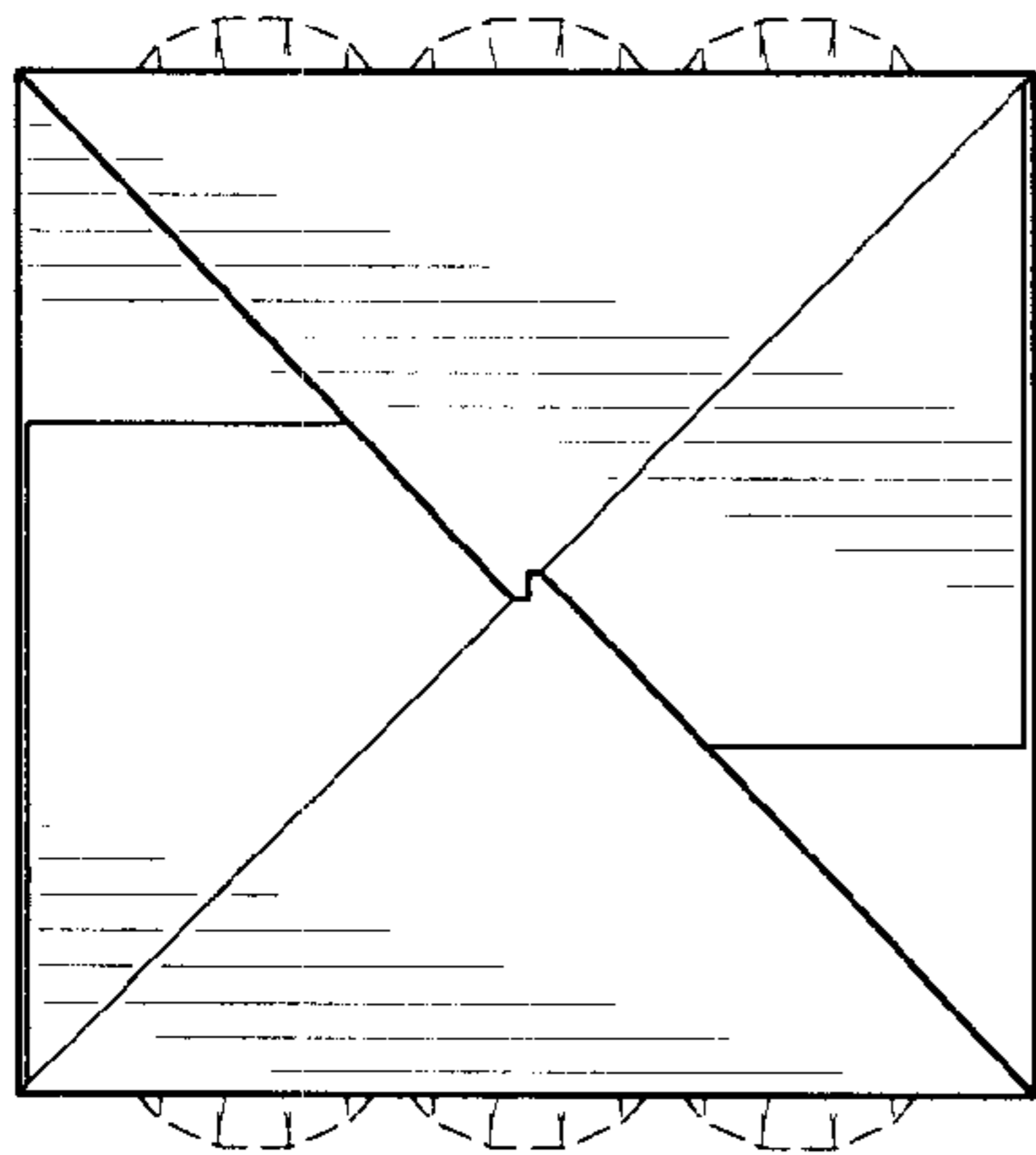

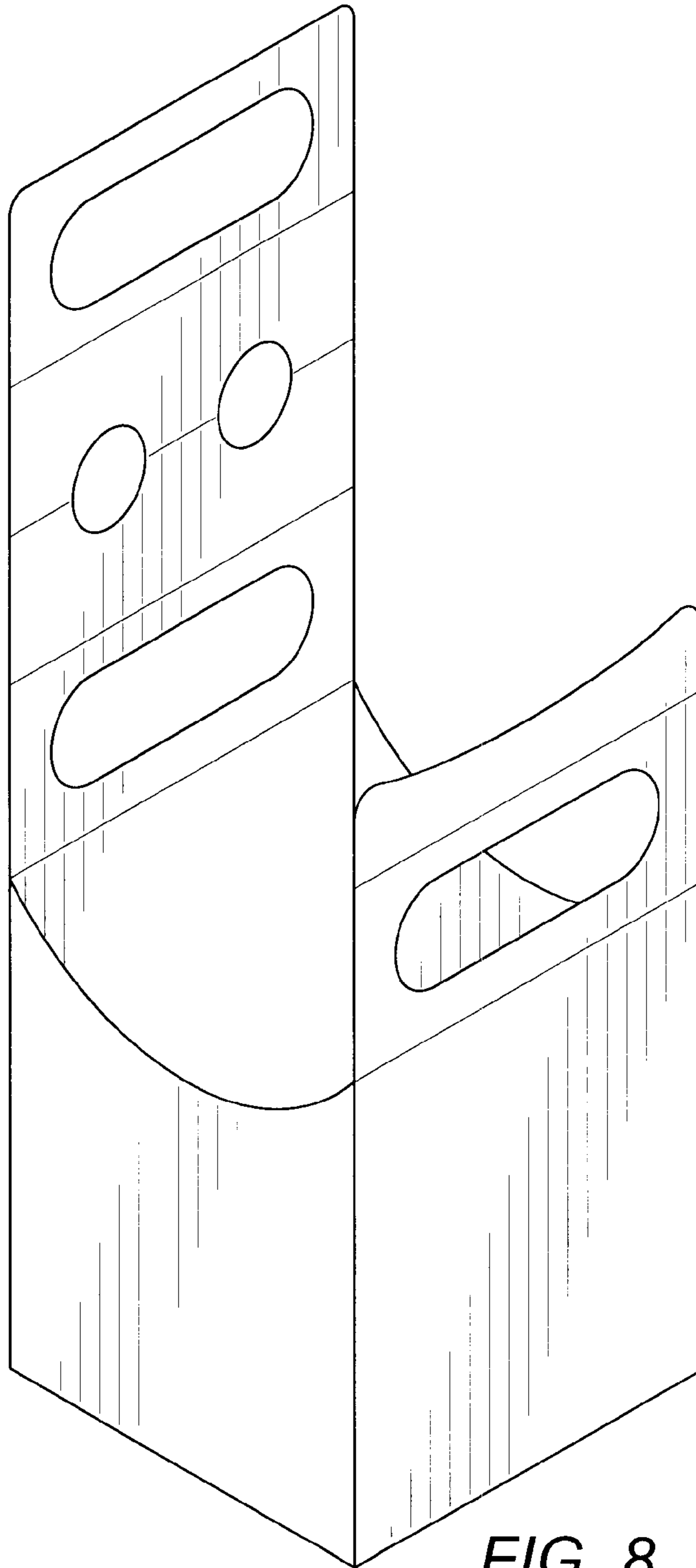
