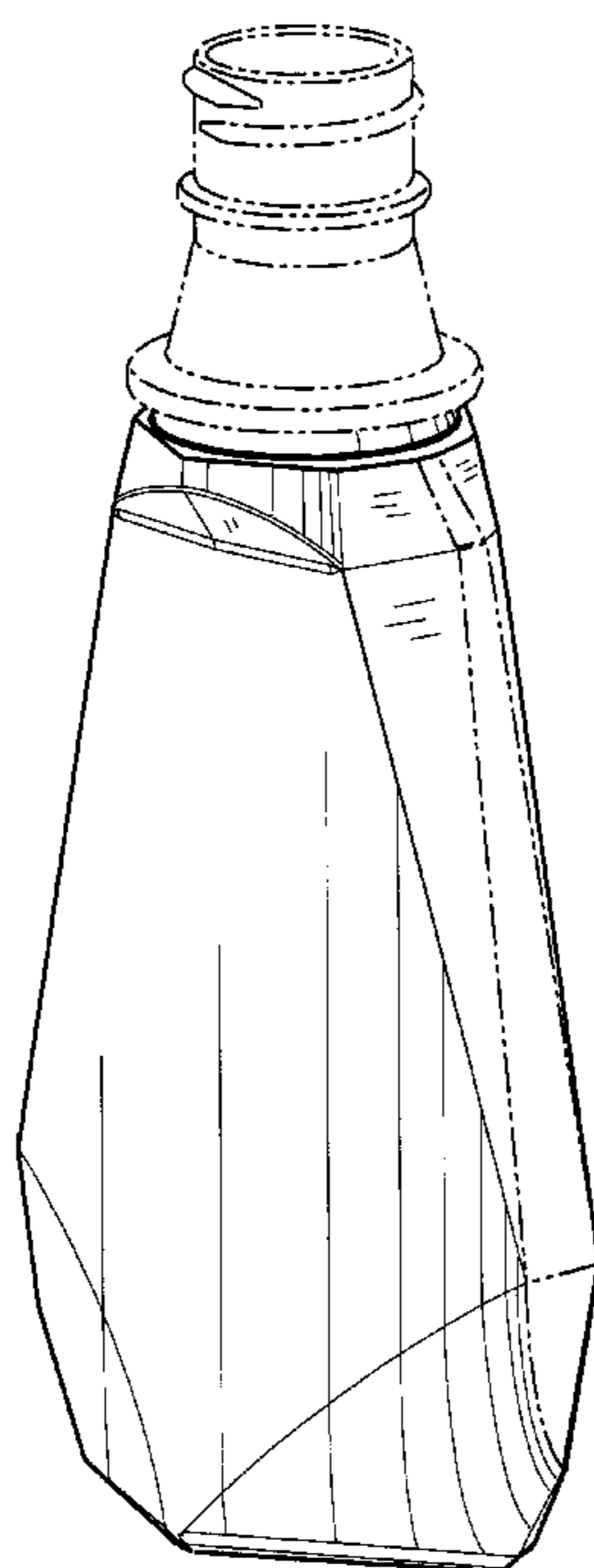
DESCRIPTION

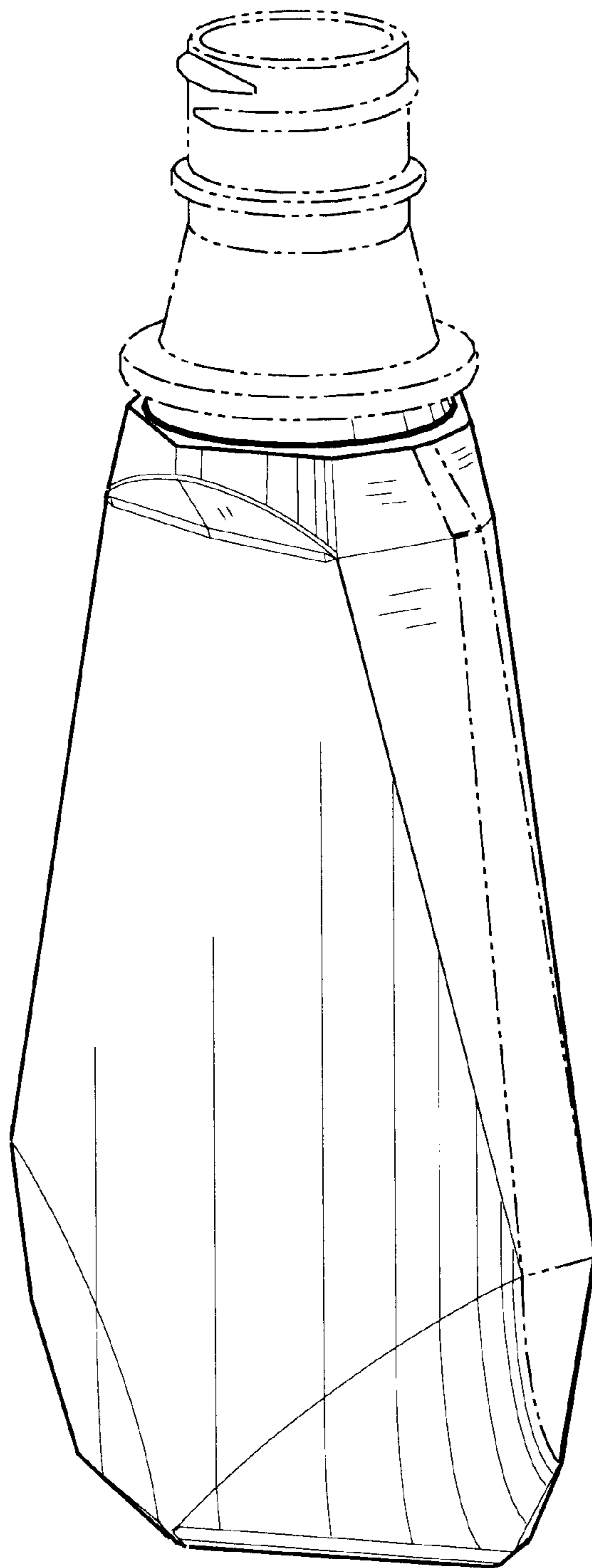

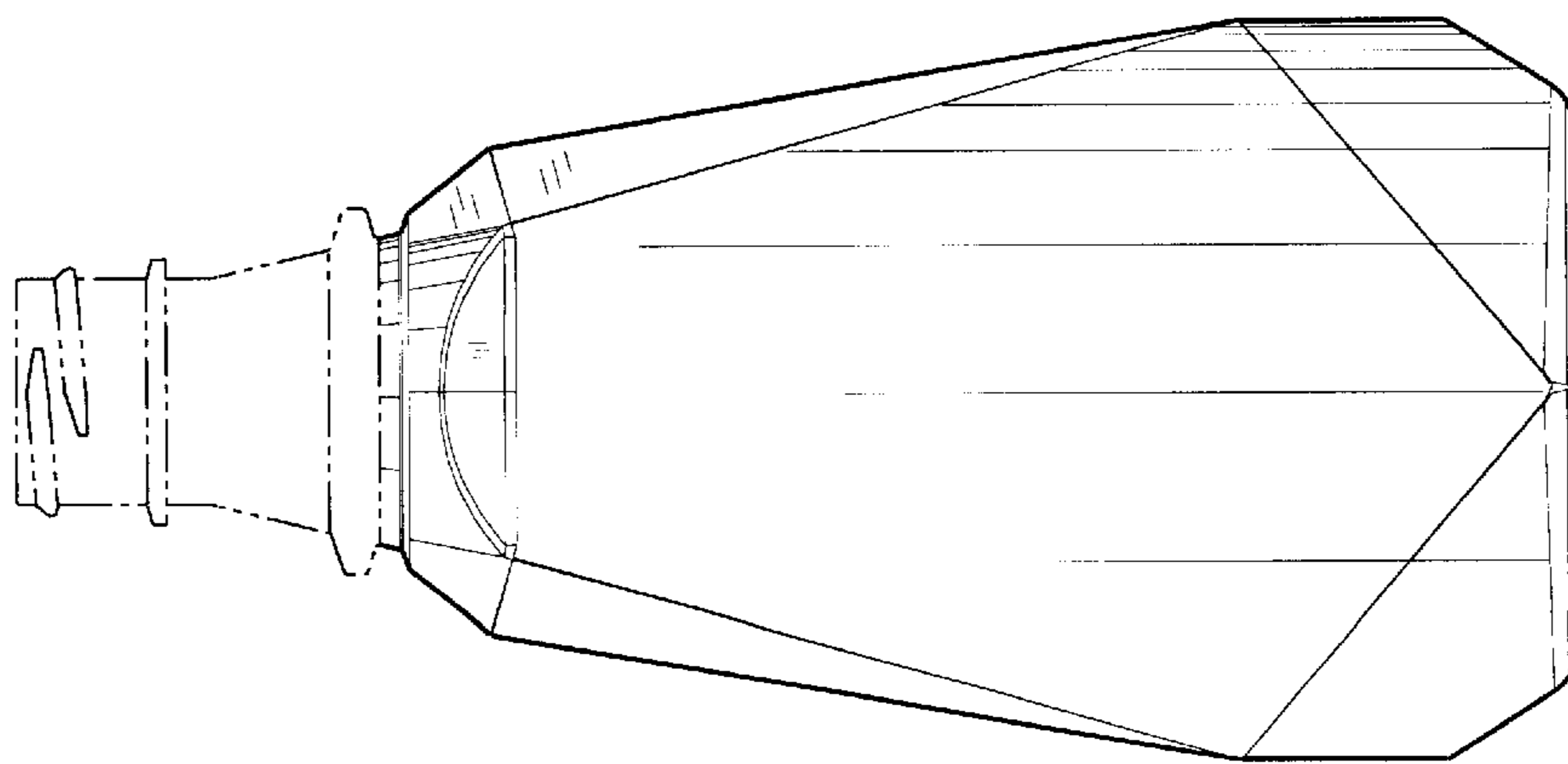

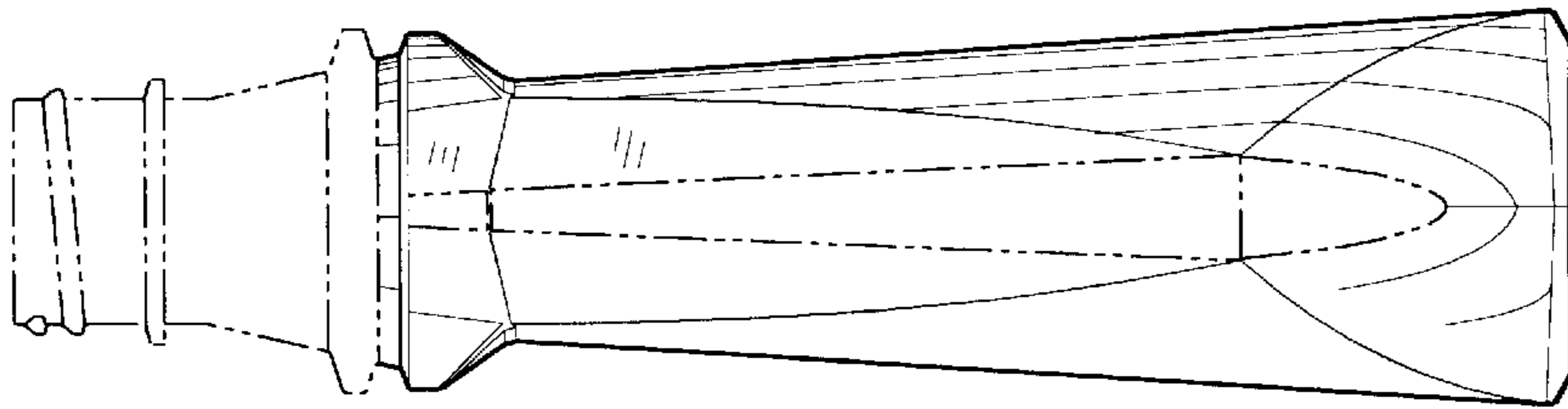

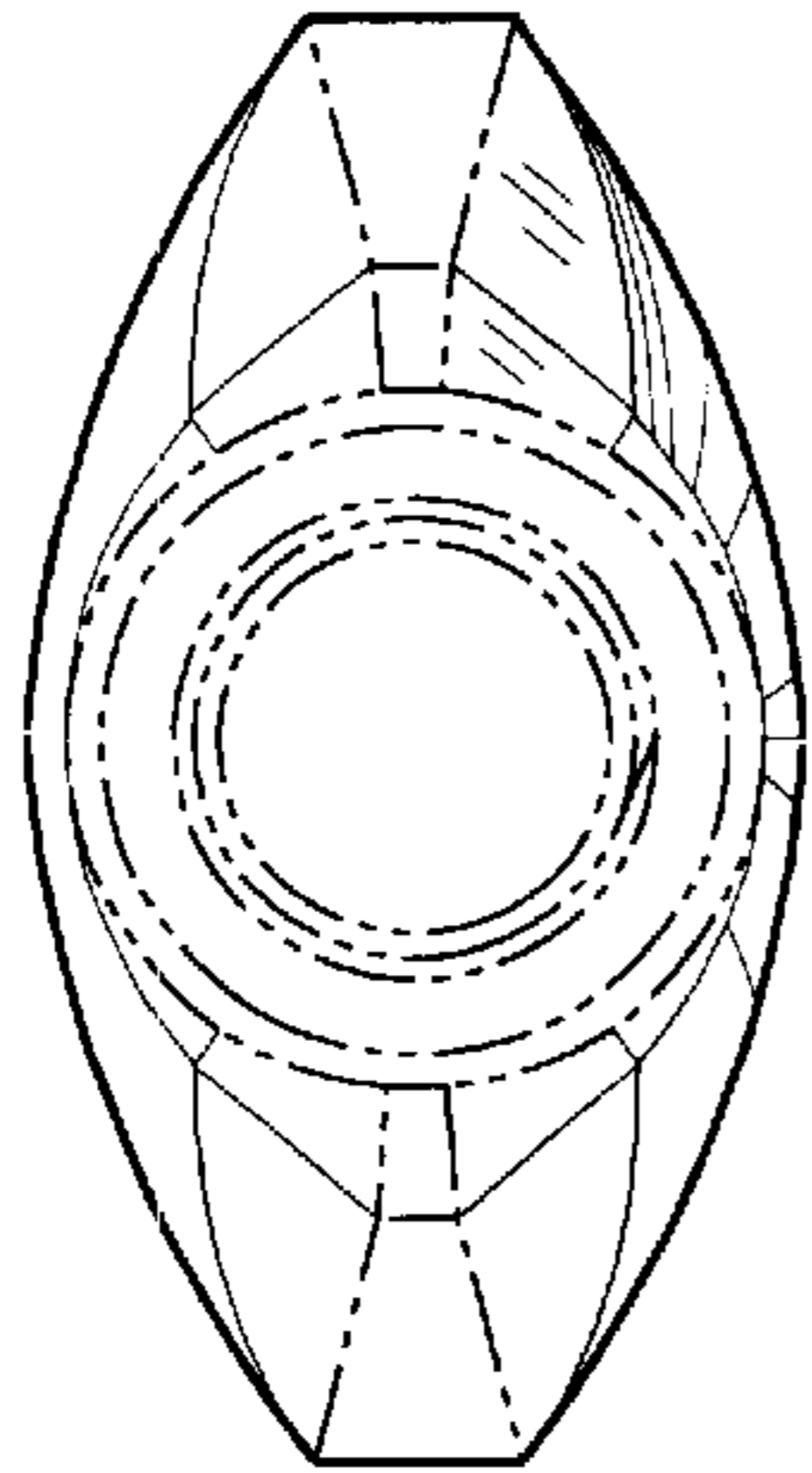
