(57) **CLAIM**

The ornamental design for a red wine bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the red wine bottle showing my new design;

FIG. 2 is a front elevational view thereof, with the cap being shown in phantom, which forms no part of the claimed design, the rear view being identical;

FIG. 3 is a top plan view thereof; and,

FIG. 4 is a bottom plan view thereof, the lines in phantom form no part of the claimed design.

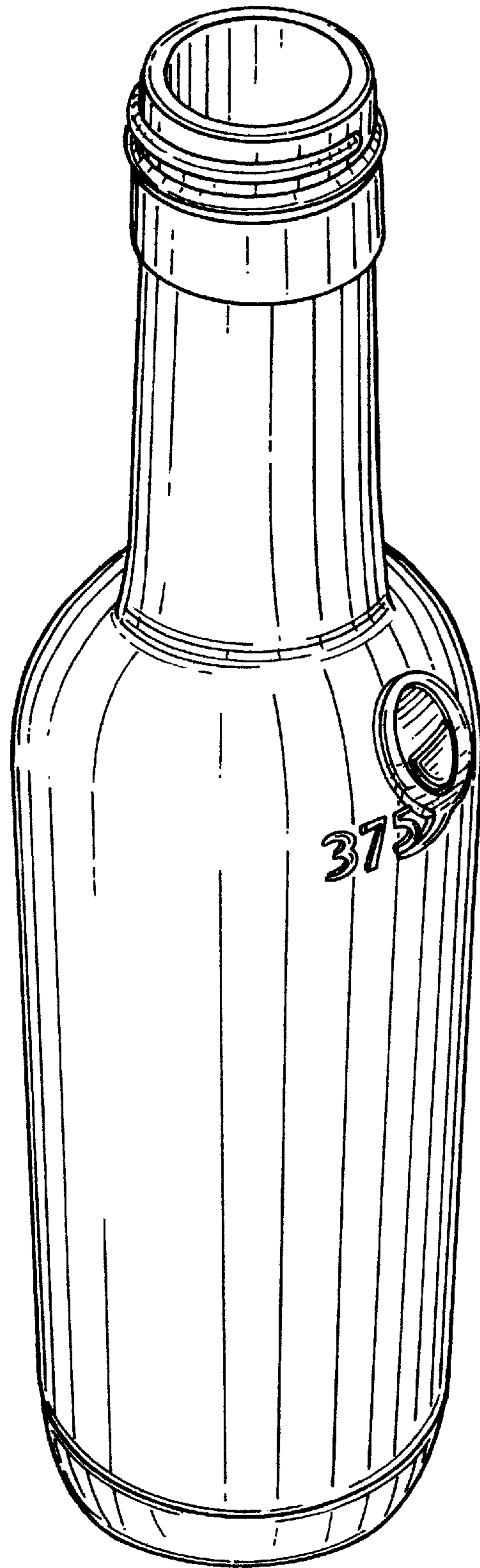

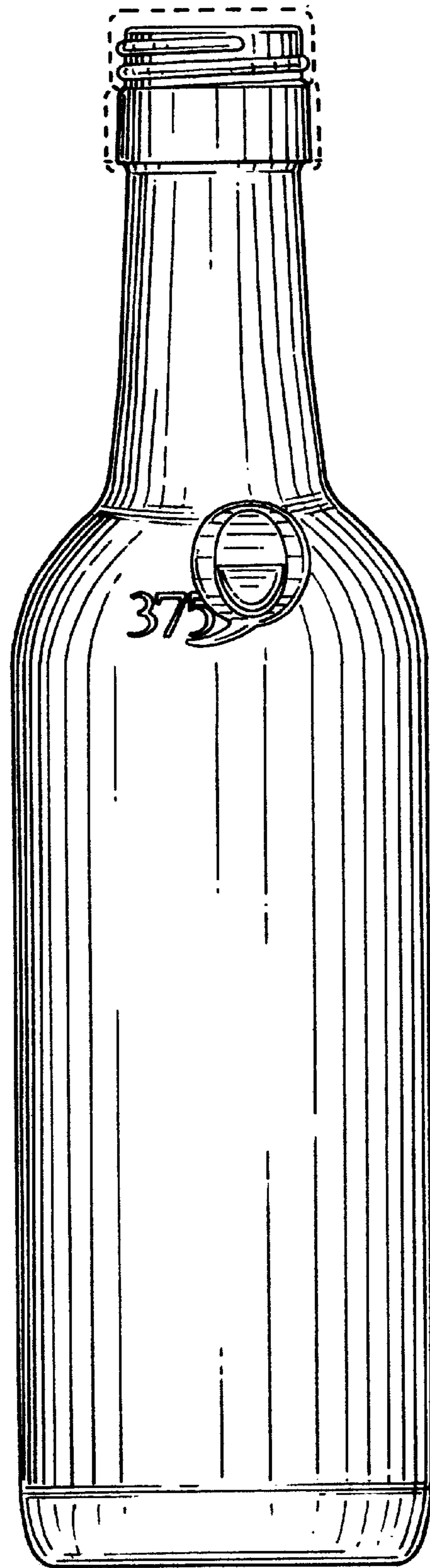

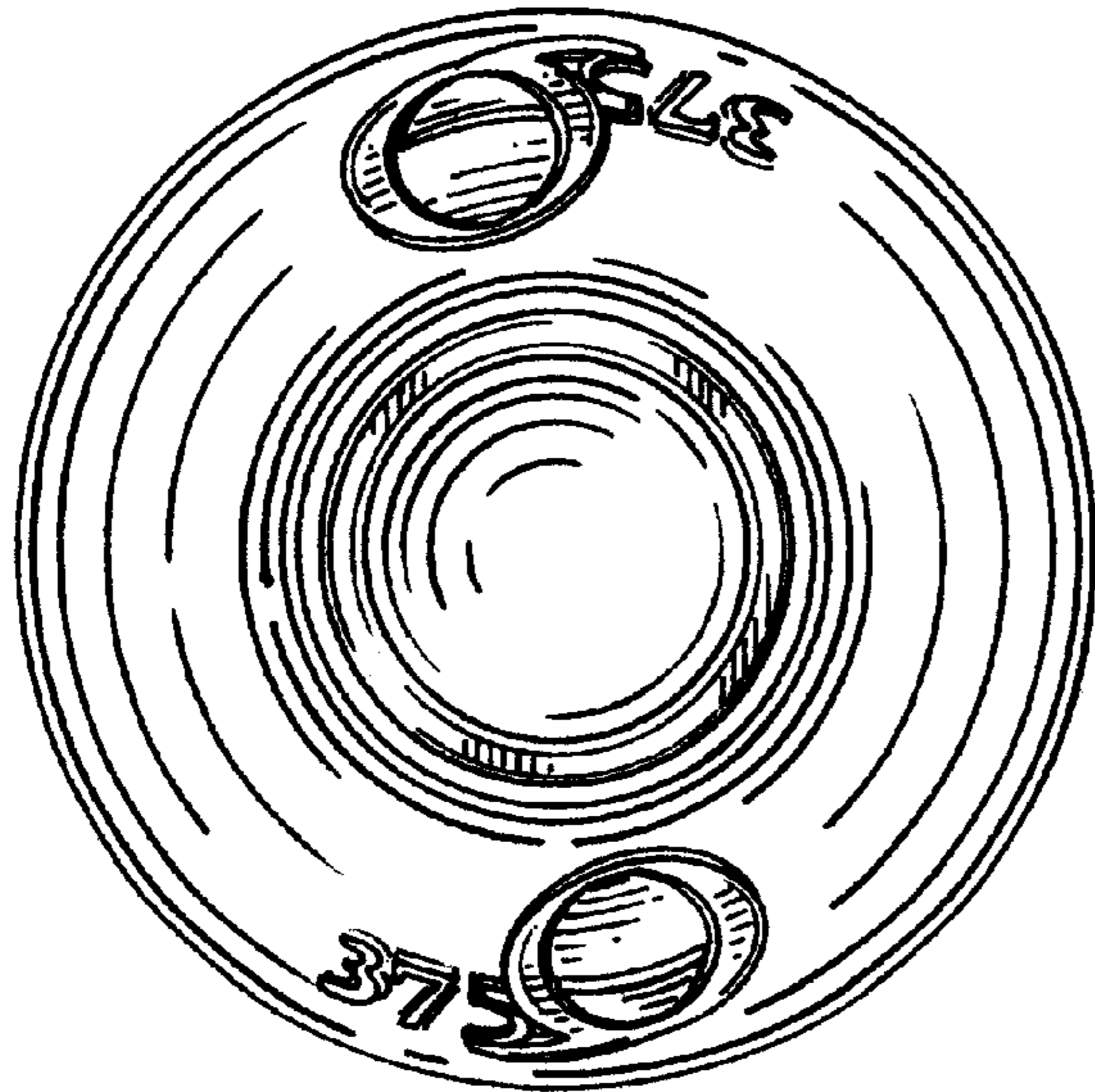

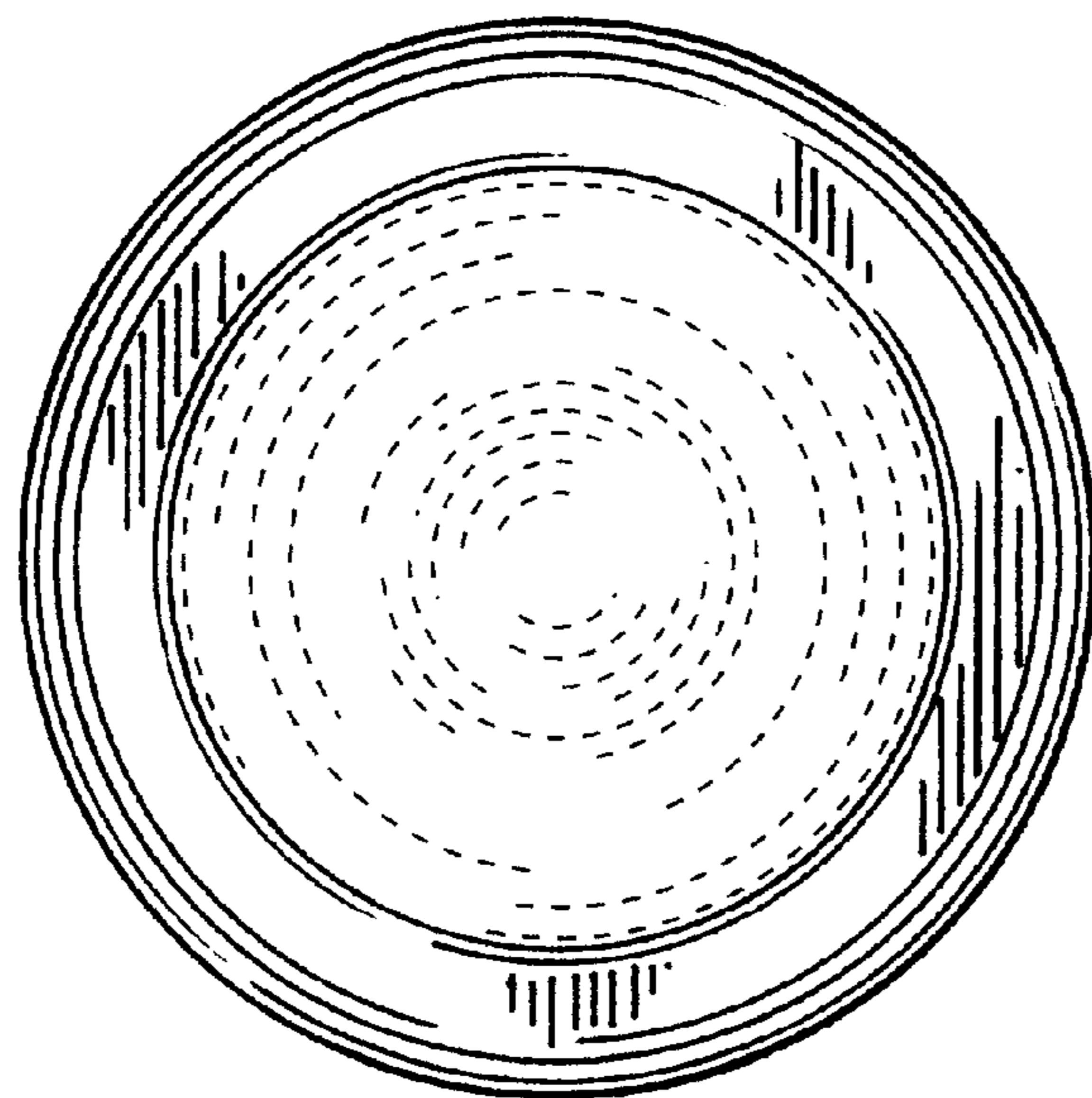
