(57) **CLAIM**

I claim the ornamental design for a combined digital disk player and radio tuner for car audio, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined digital disk player and radio tuner for car audio of the present invention; FIG. 2 is a front view thereof; FIG. 3 is a first side view thereof; FIG. 4 is a second side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a rear view thereof.

The ornamental design which is claimed is shown in solid lines in the drawings. Any broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

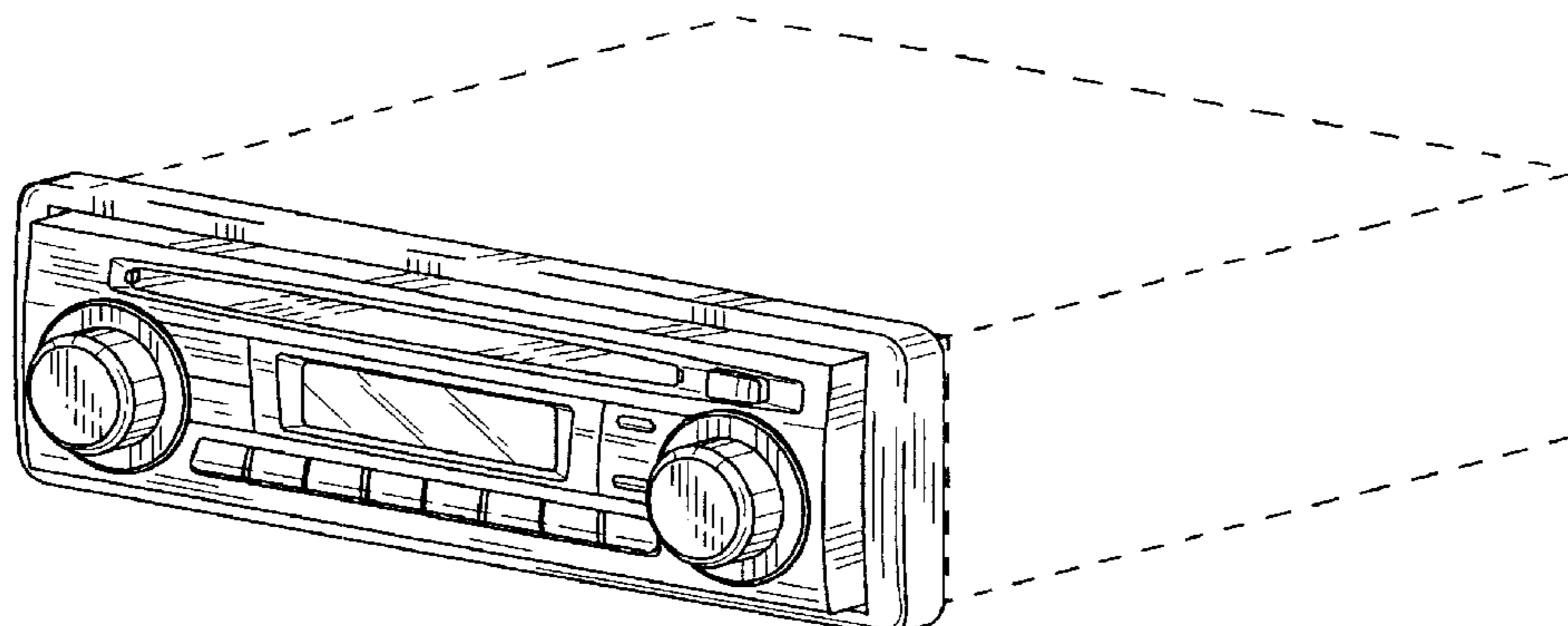

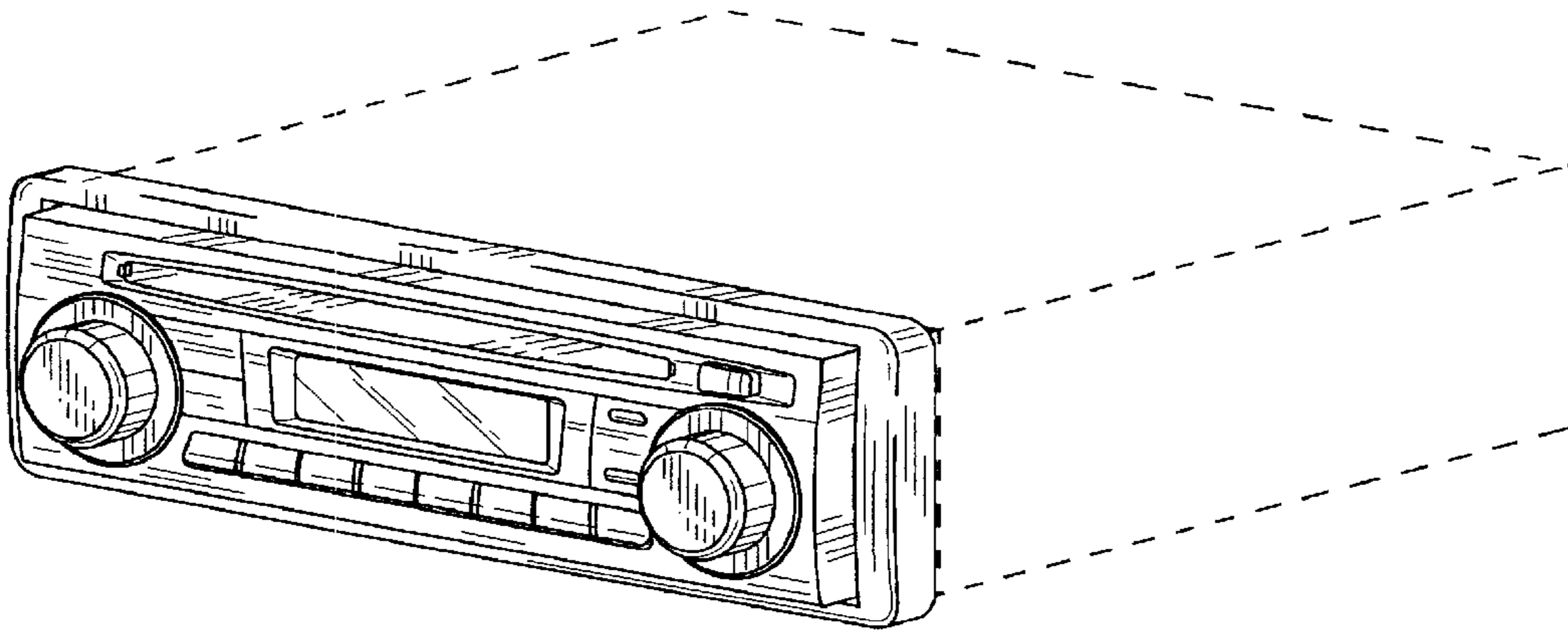

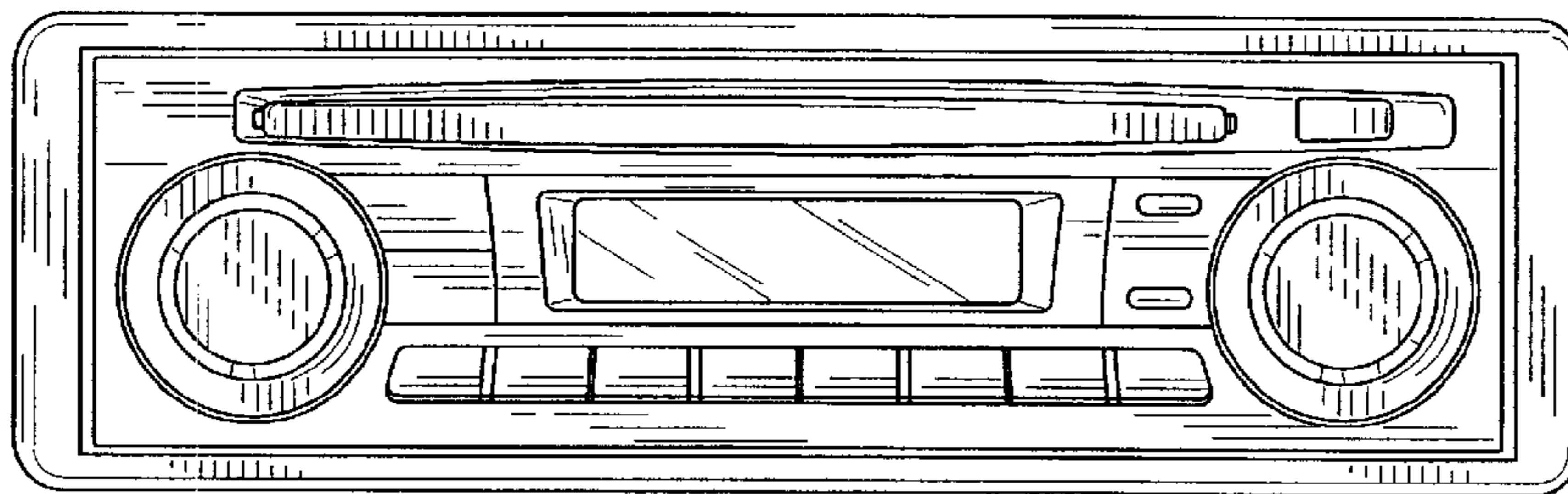

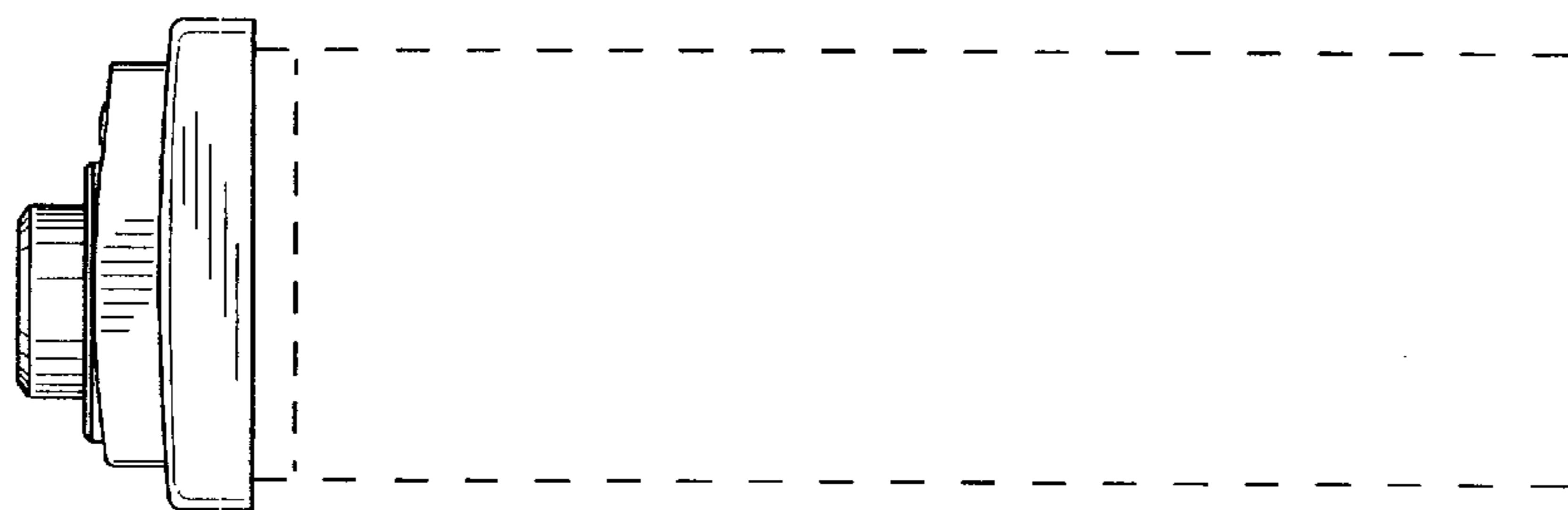

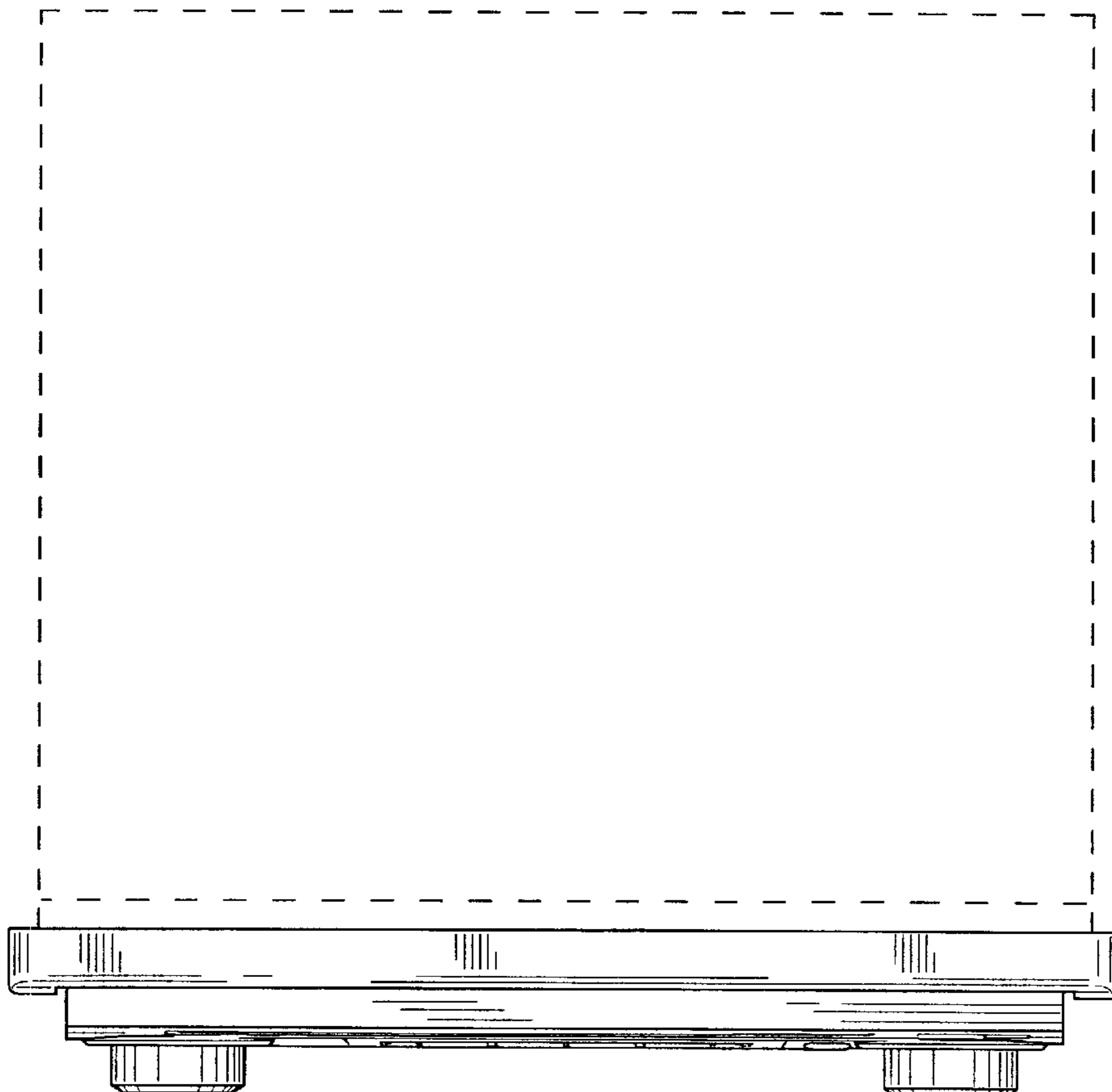

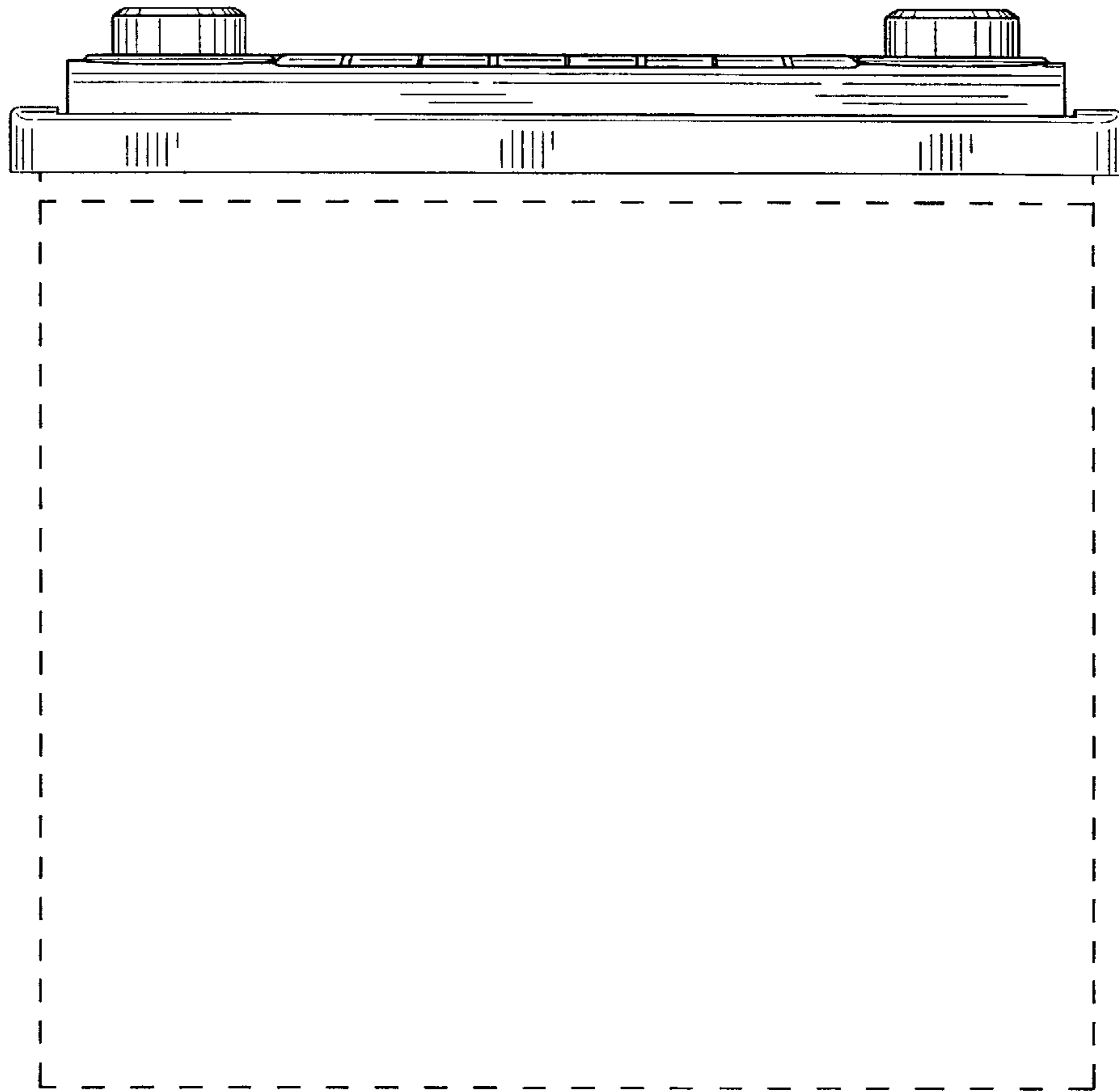
