A design for a doll, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the doll.

FIG. 2 is a rear view of the doll.

FIG. 3 is a left-hand side view of the doll.

FIG. 4 is a right-hand side view of the doll.

FIG. 5 is a top view of the doll.

FIG. 6 is a bottom view of the doll.

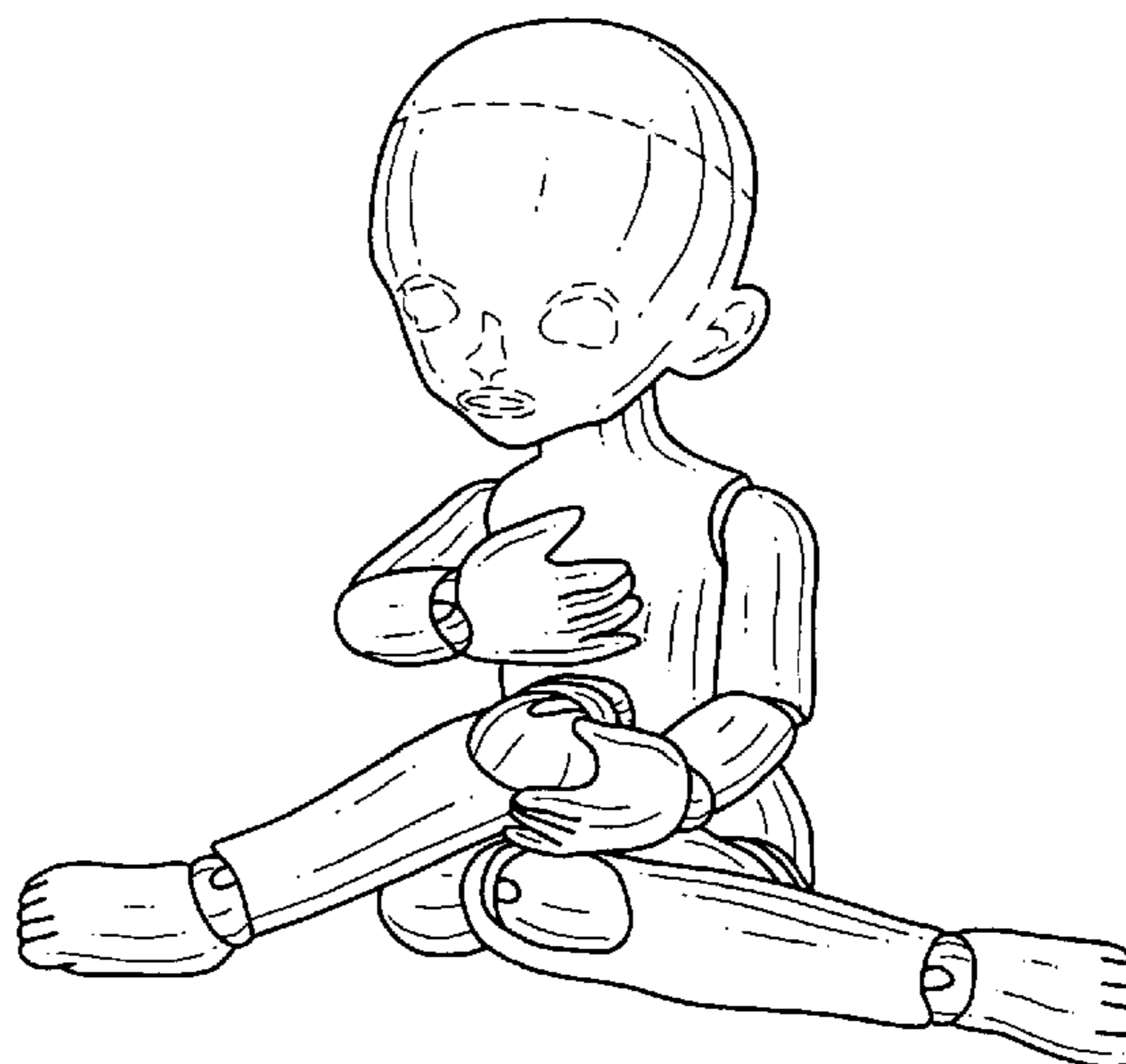
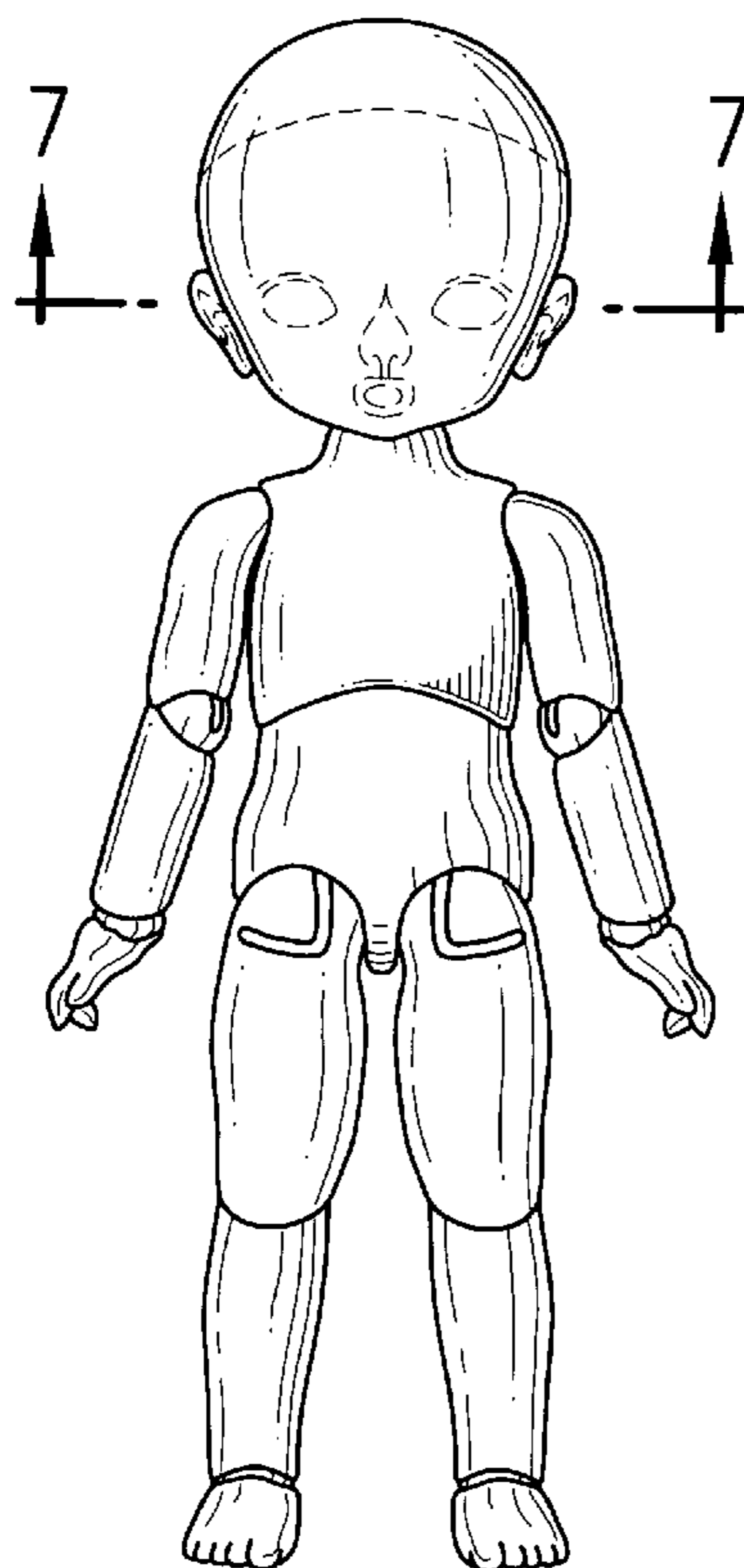
FIG. 7 is a cross section view taken along line 7—7 as shown in FIG. 1;

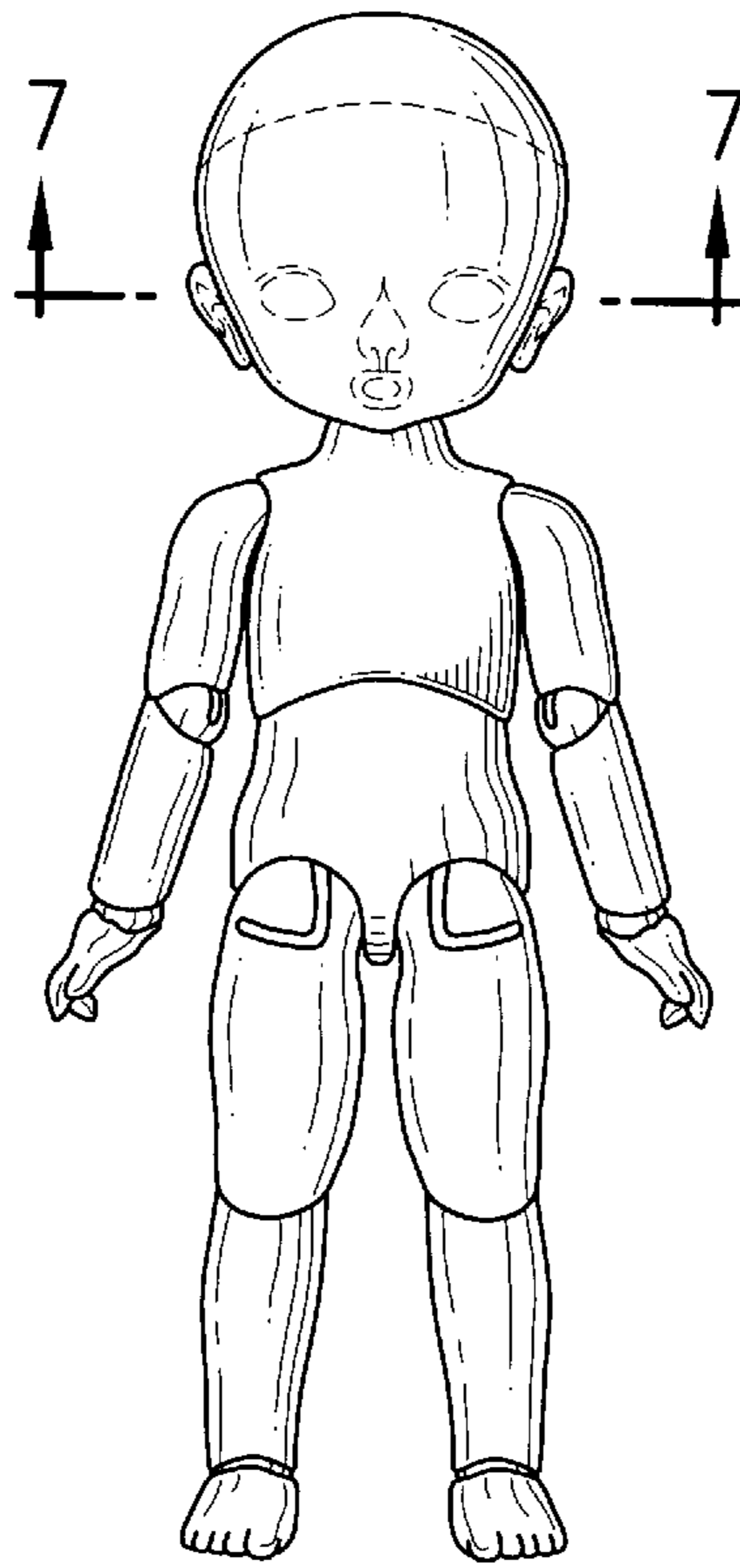

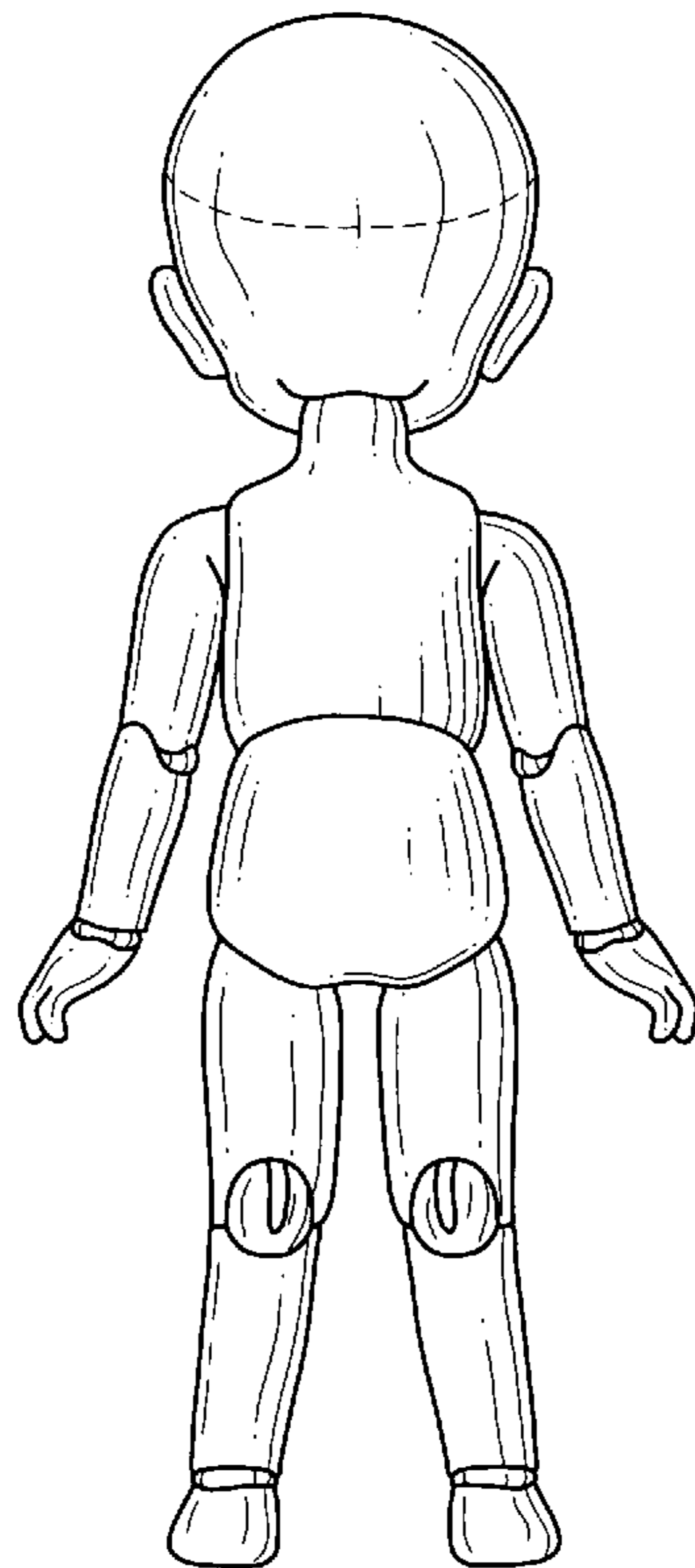

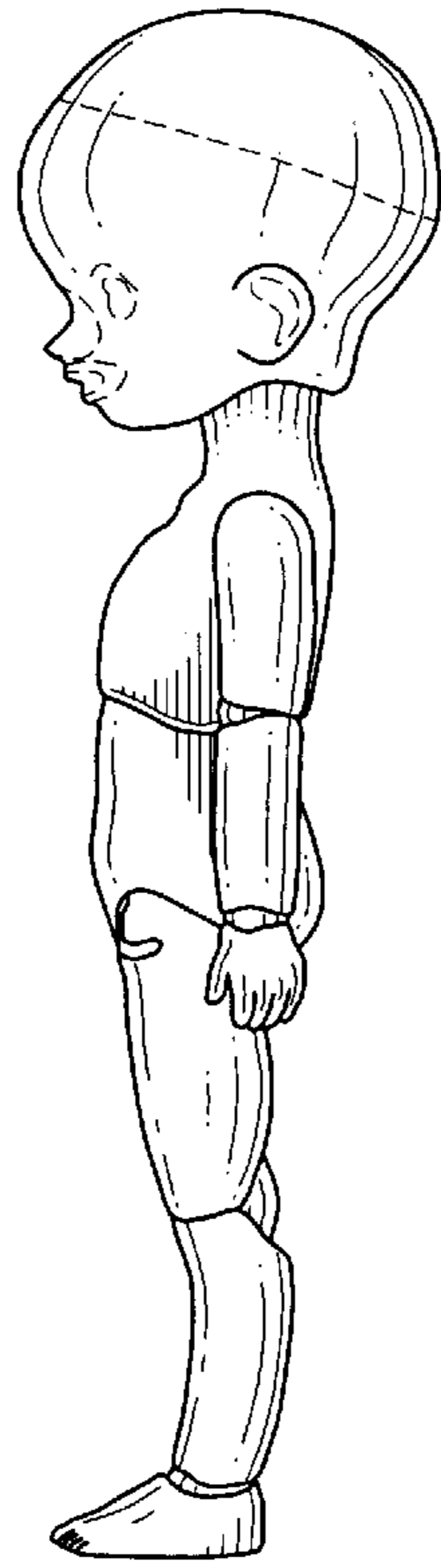

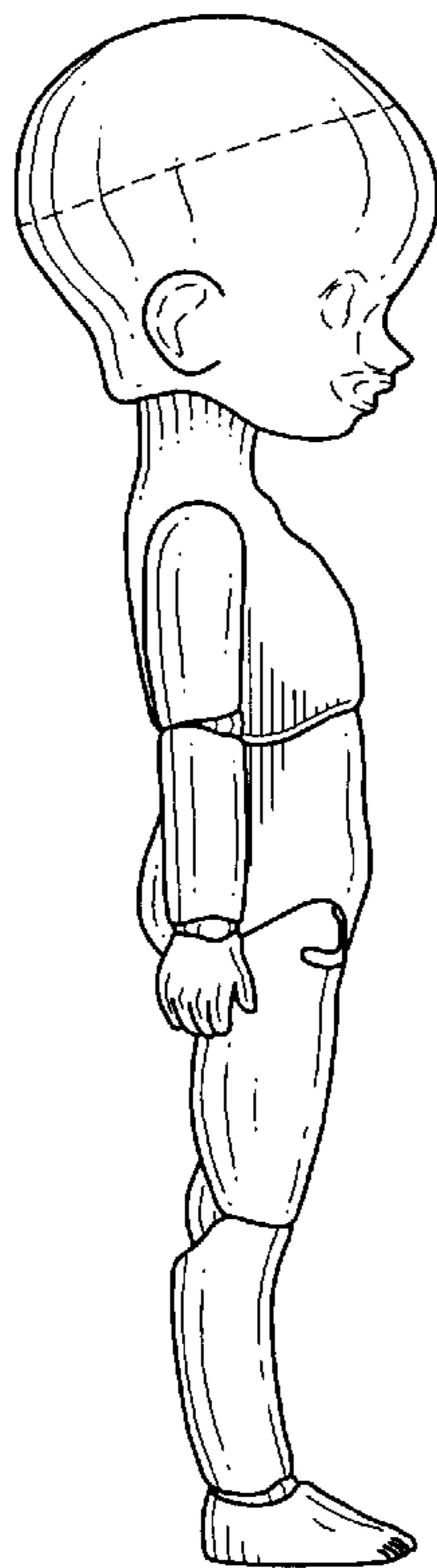

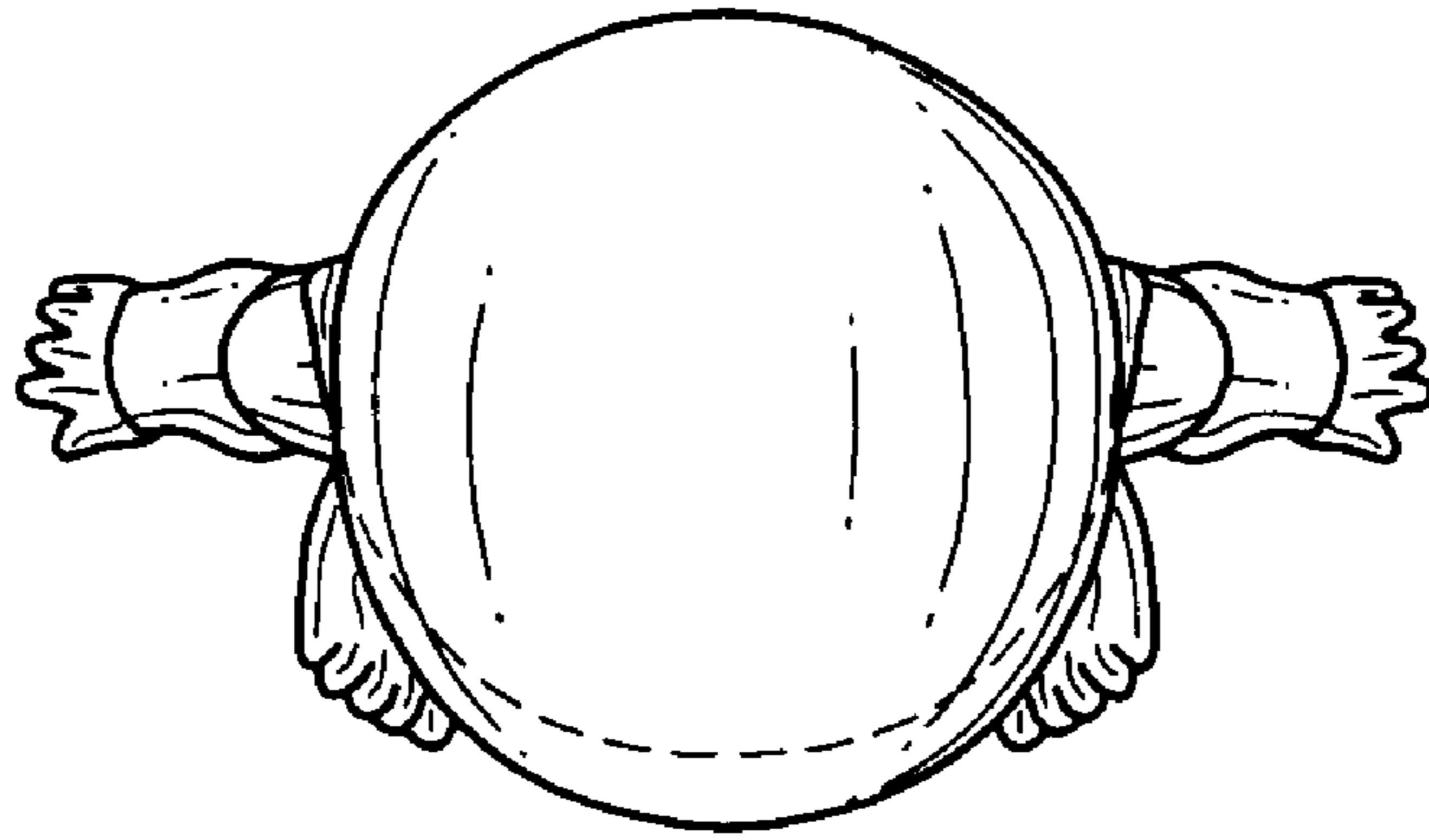

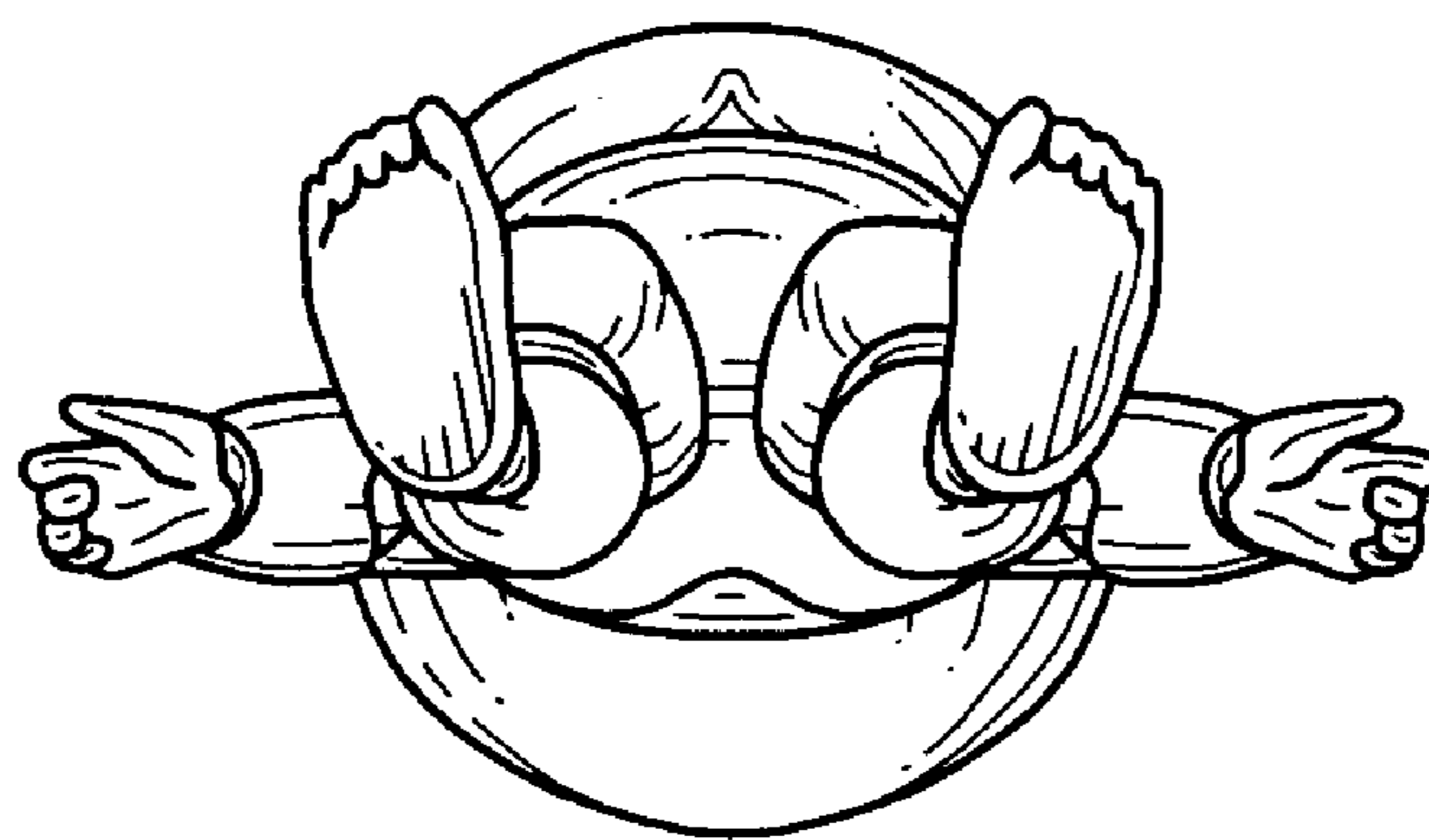

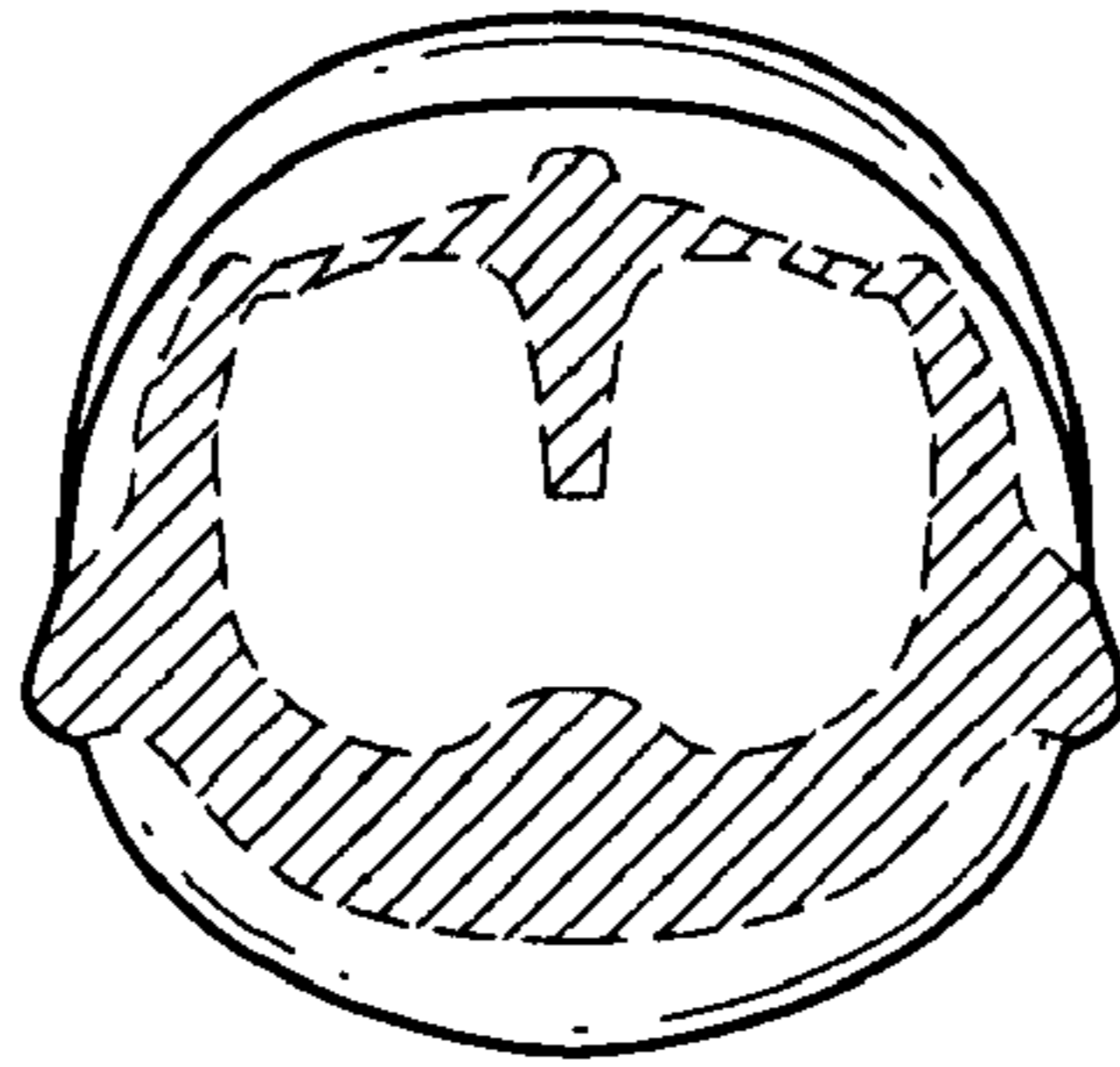

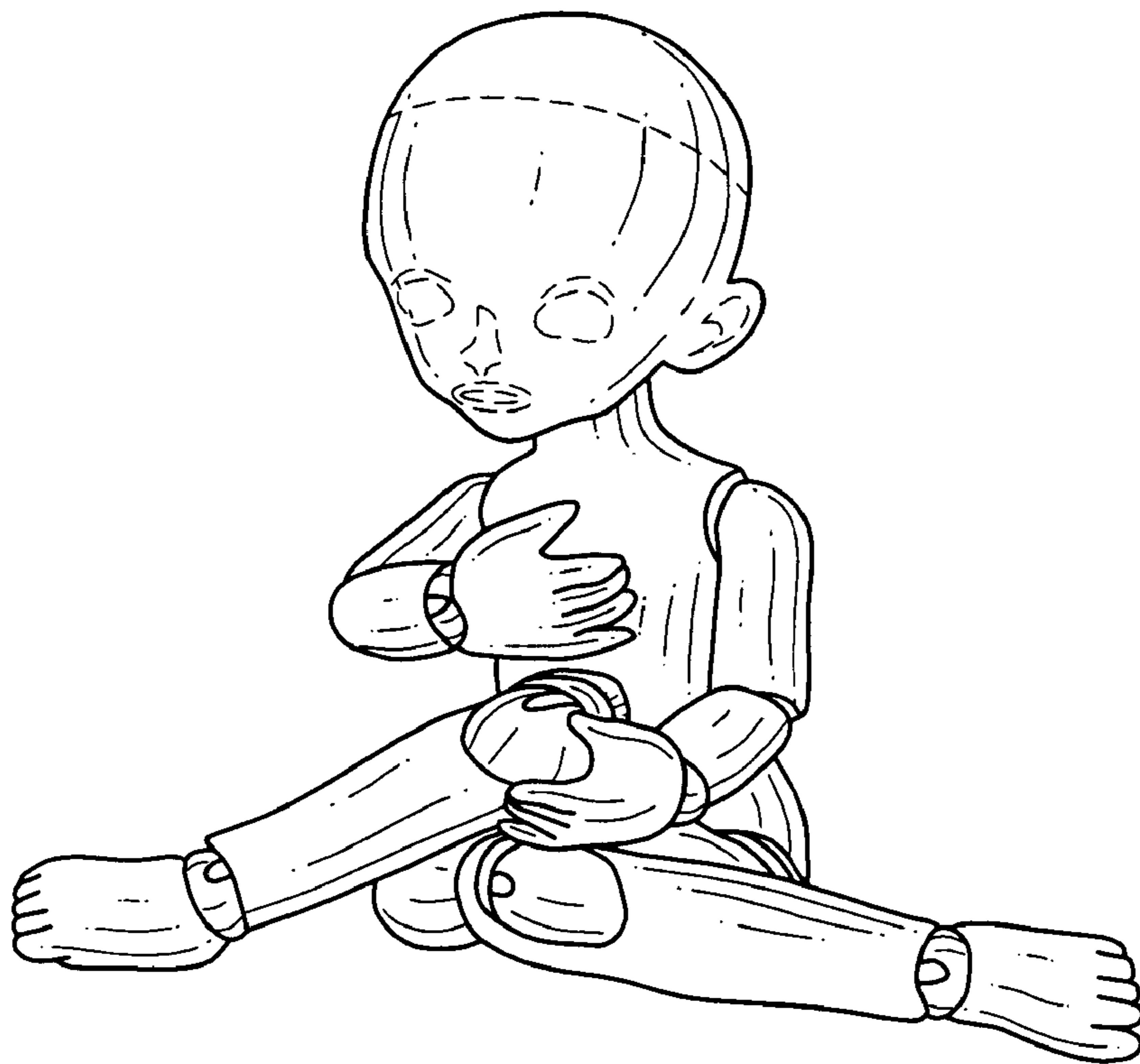

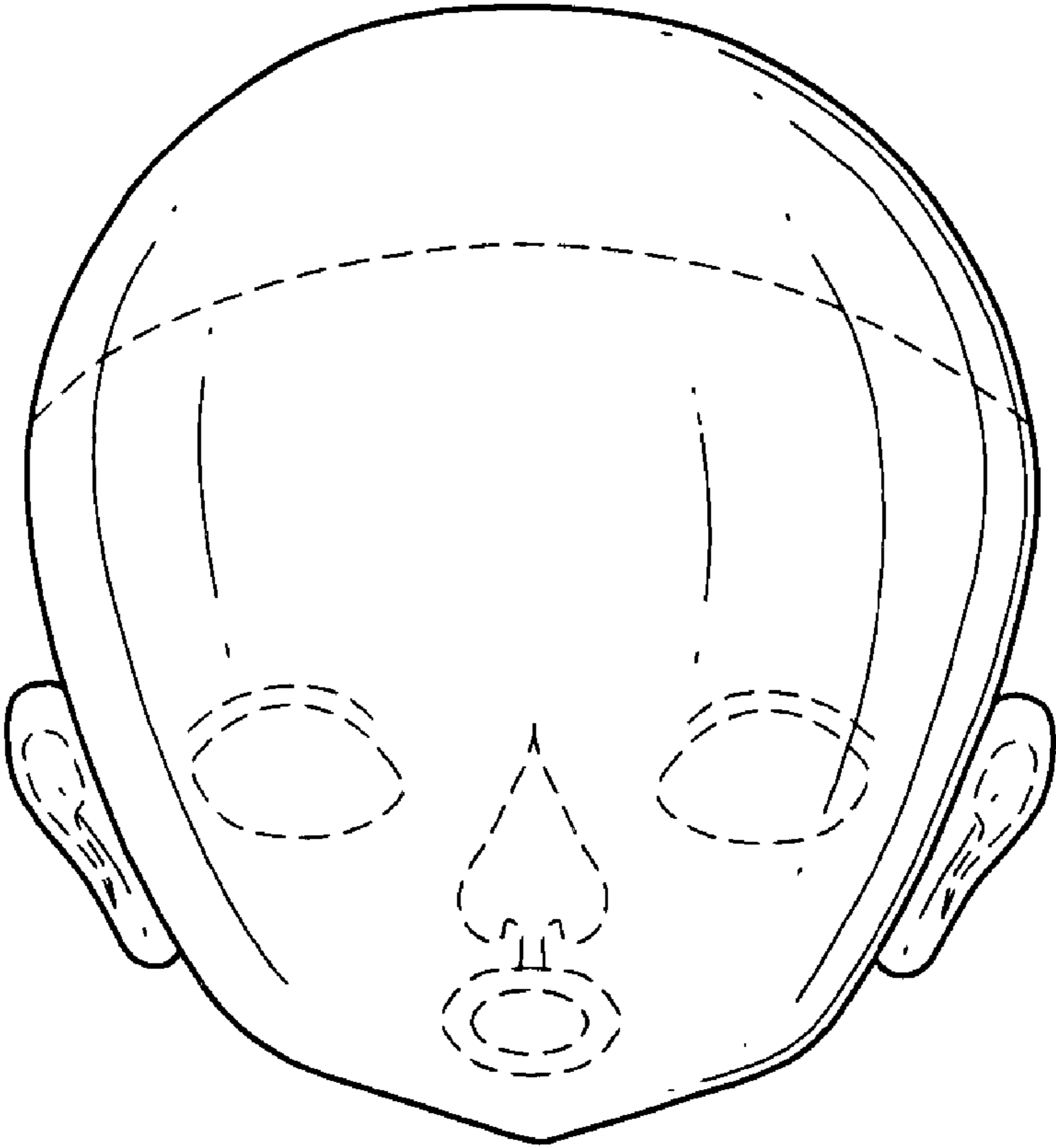
