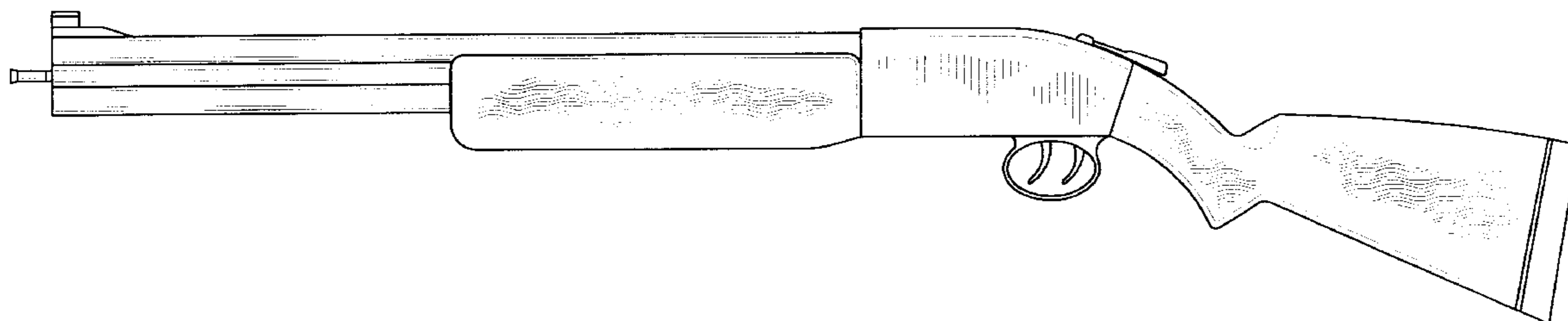
(57) **CLAIM**

We claim the ornamental design for a rifle, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a rifle showing my new design, the right side being a mirror image;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a top plan view thereof; and,

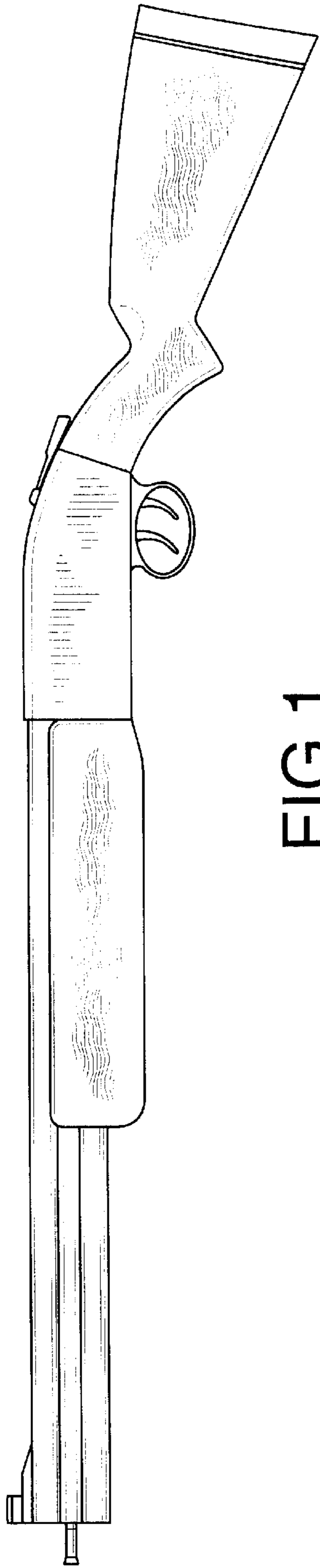

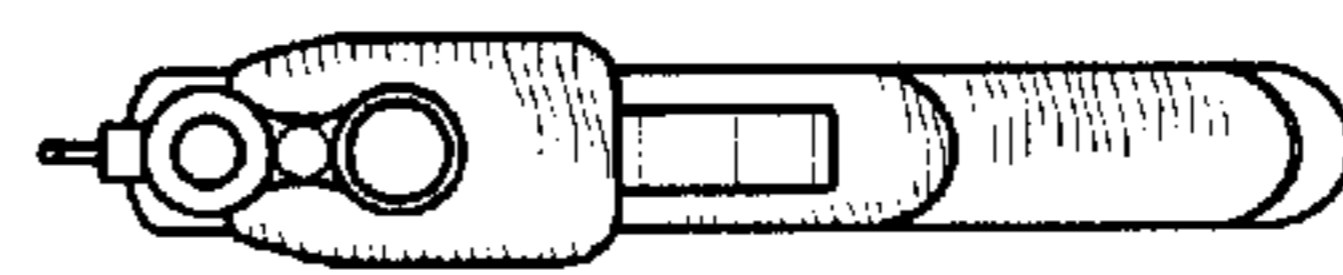

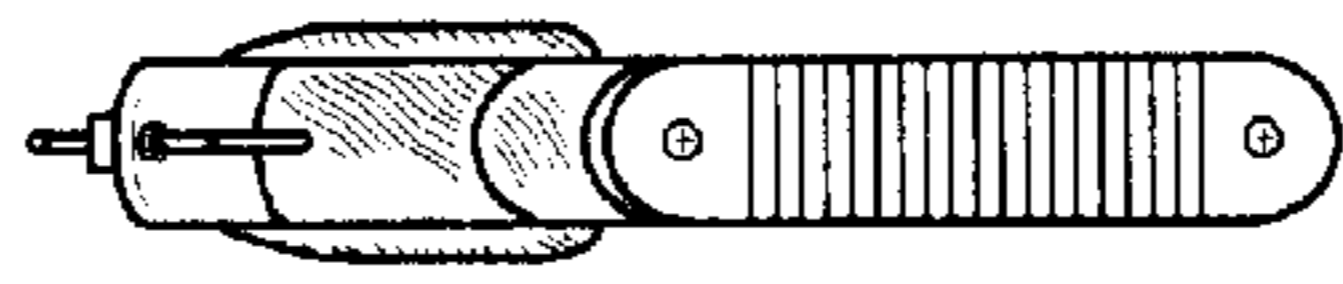
