**DESCRIPTION**

FIG. 1 is a top plan view of a cartridge according to our invention;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a side elevational view thereof;

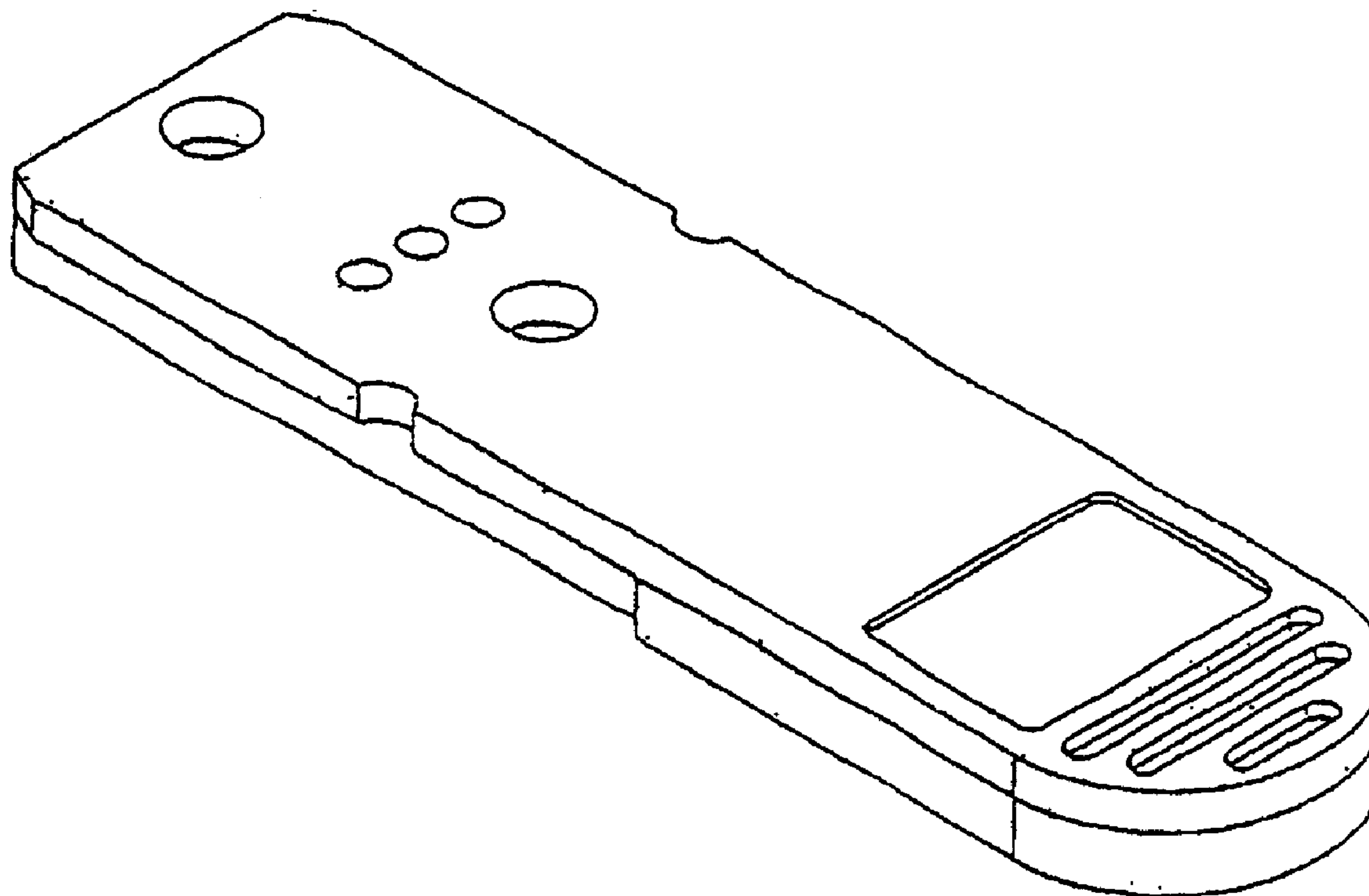
FIG. 4 is a side elevational view of the opposite side from that illustrated in FIG. 3;

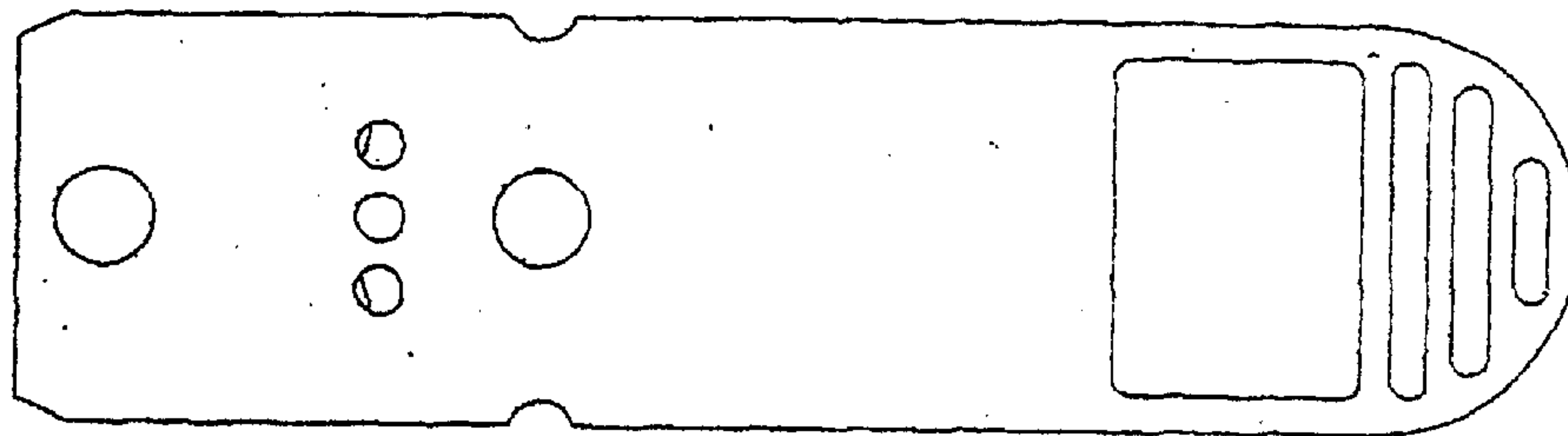

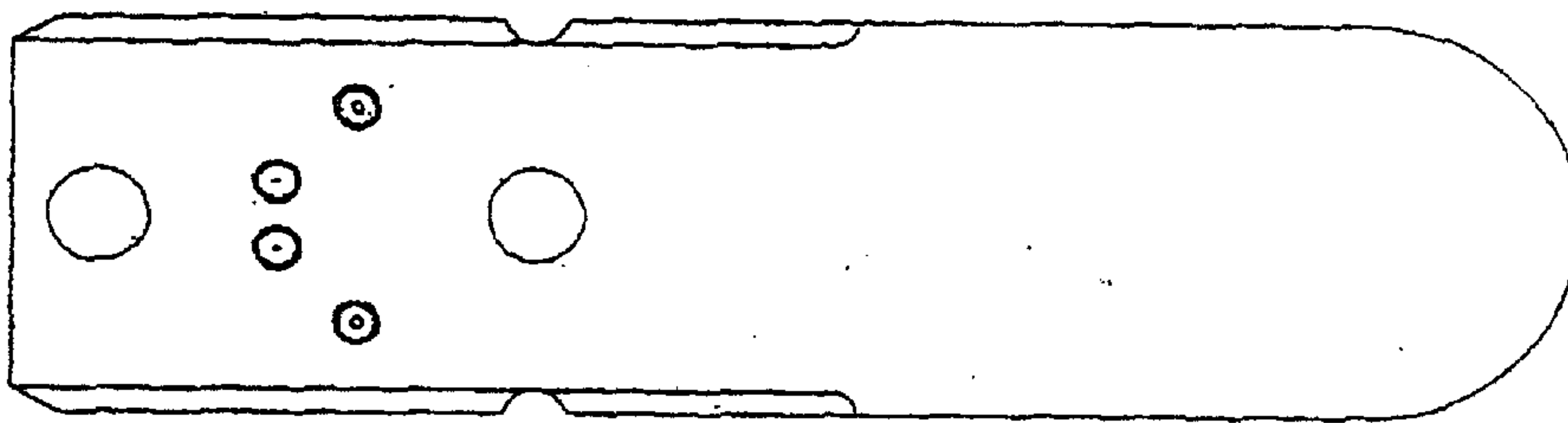

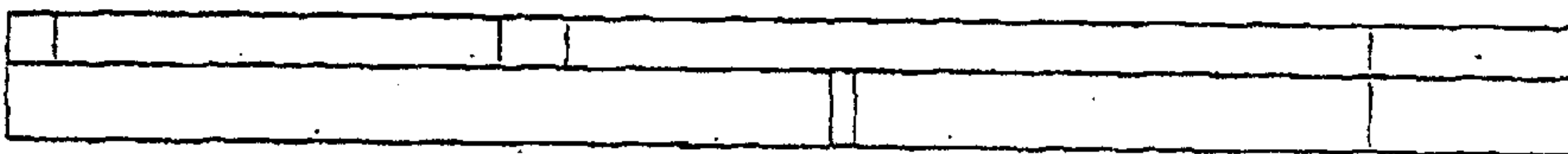

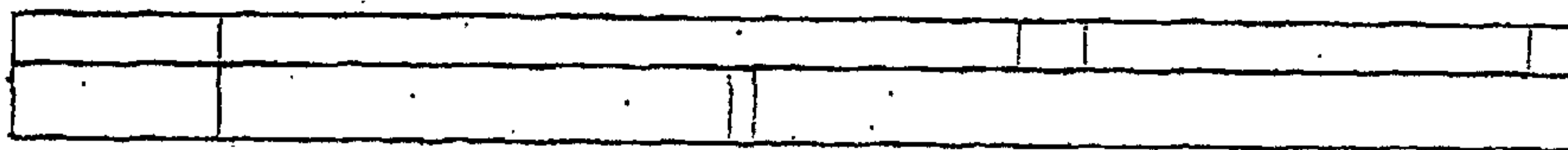

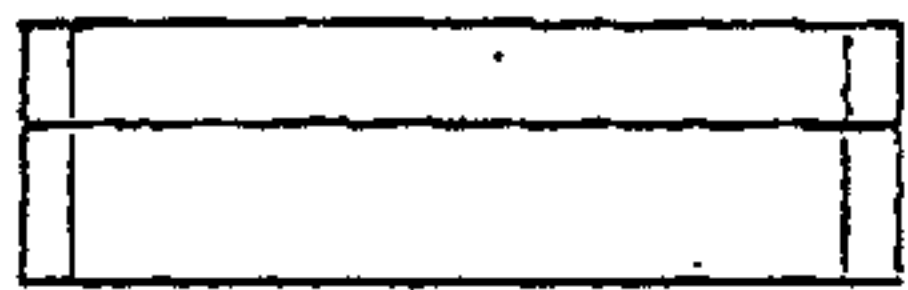

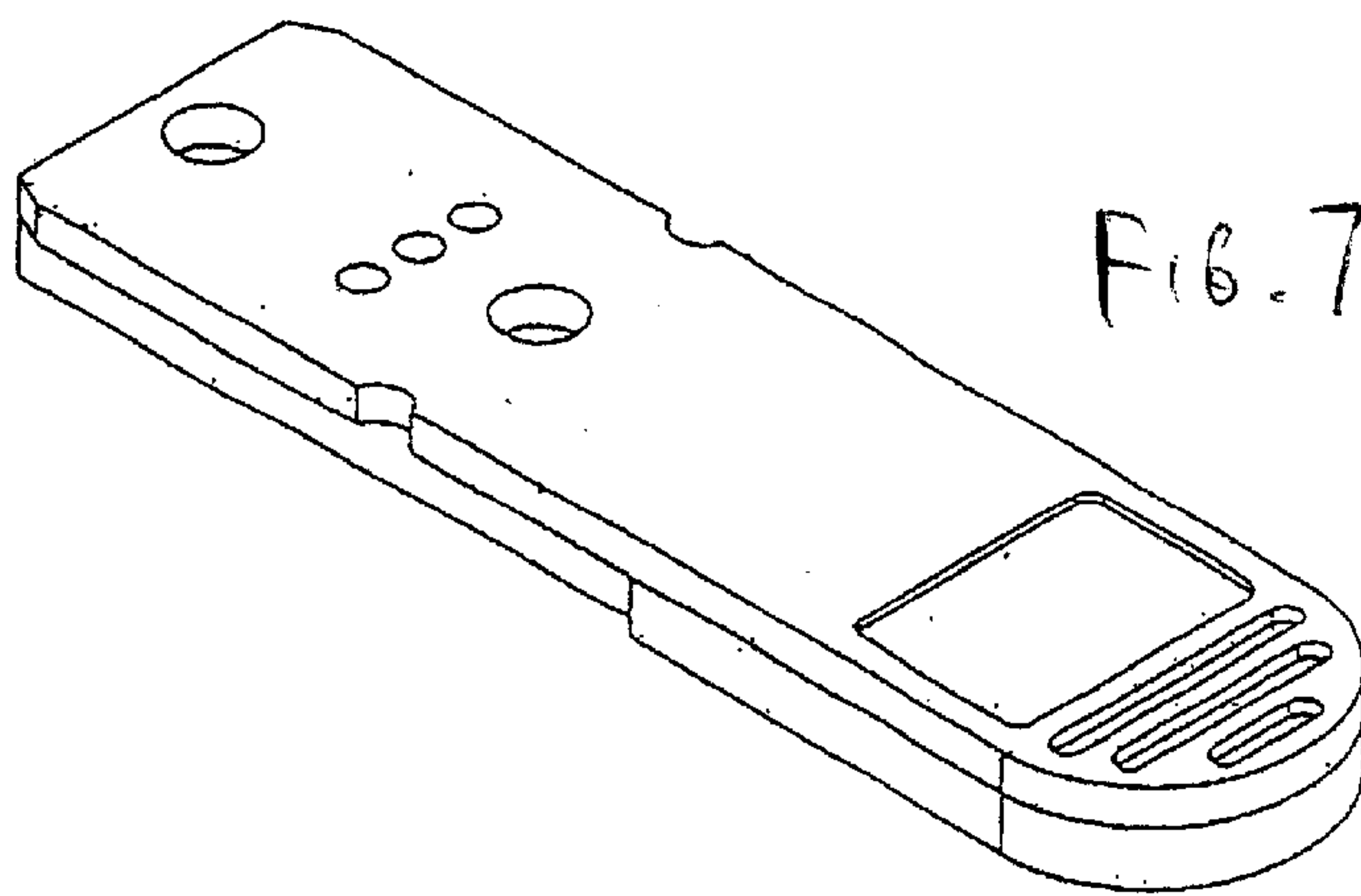
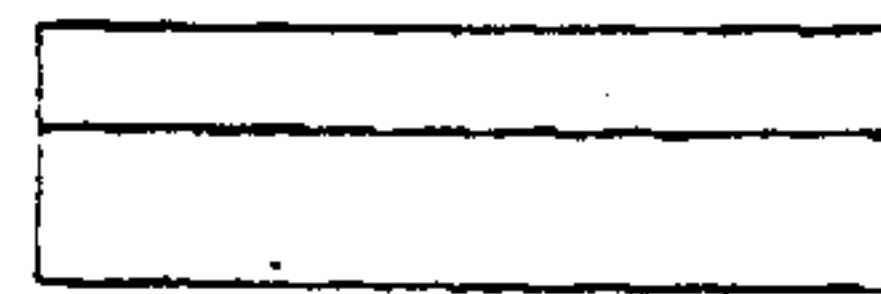
