(57) **CLAIM**

The ornamental design for a ball glove, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the ball glove of the present invention, illustrating, inter alia, the surface pattern applied to the inner pocket of the ball glove;

FIG. 2 is another front perspective view of the ball glove of FIG. 1;

FIG. 3 is back perspective view of the ball glove of FIG. 1, illustrating the surface pattern applied to the four fingers of the ball glove;

FIG. 4 is another back perspective view of the ball glove of FIG. 1;

FIG. 5 is still another back perspective view of the ball glove of FIG. 1;

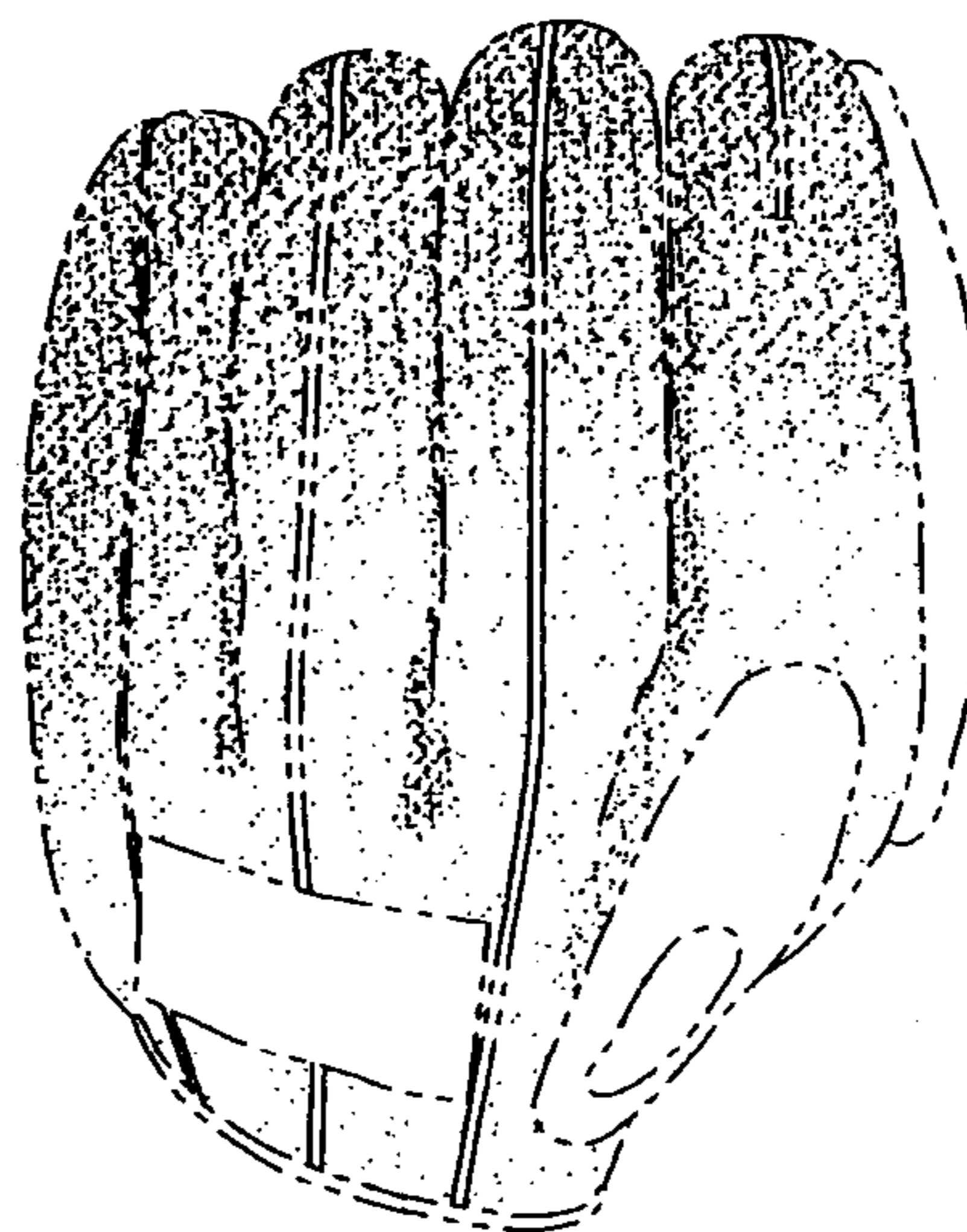
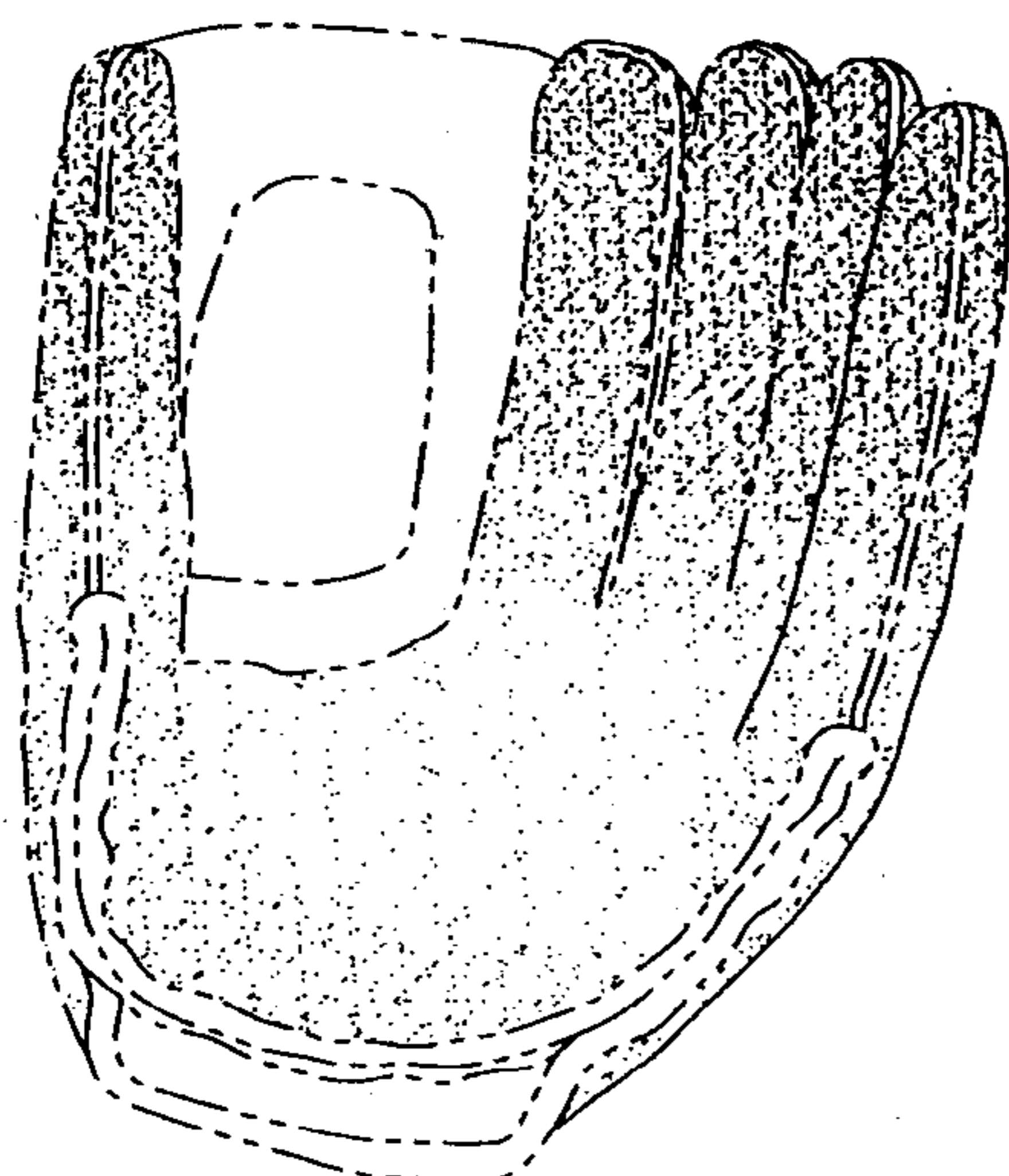
FIG. 6 is top perspective view of the ball glove of FIG. 1;

FIG. 6 is top perspective view of the ball glove of FIG. 1;

FIG. 7 is another top perspective view of the ball glove of FIG. 1; and,

FIG. 8 is a side perspective view of the ball glove of FIG. 1.

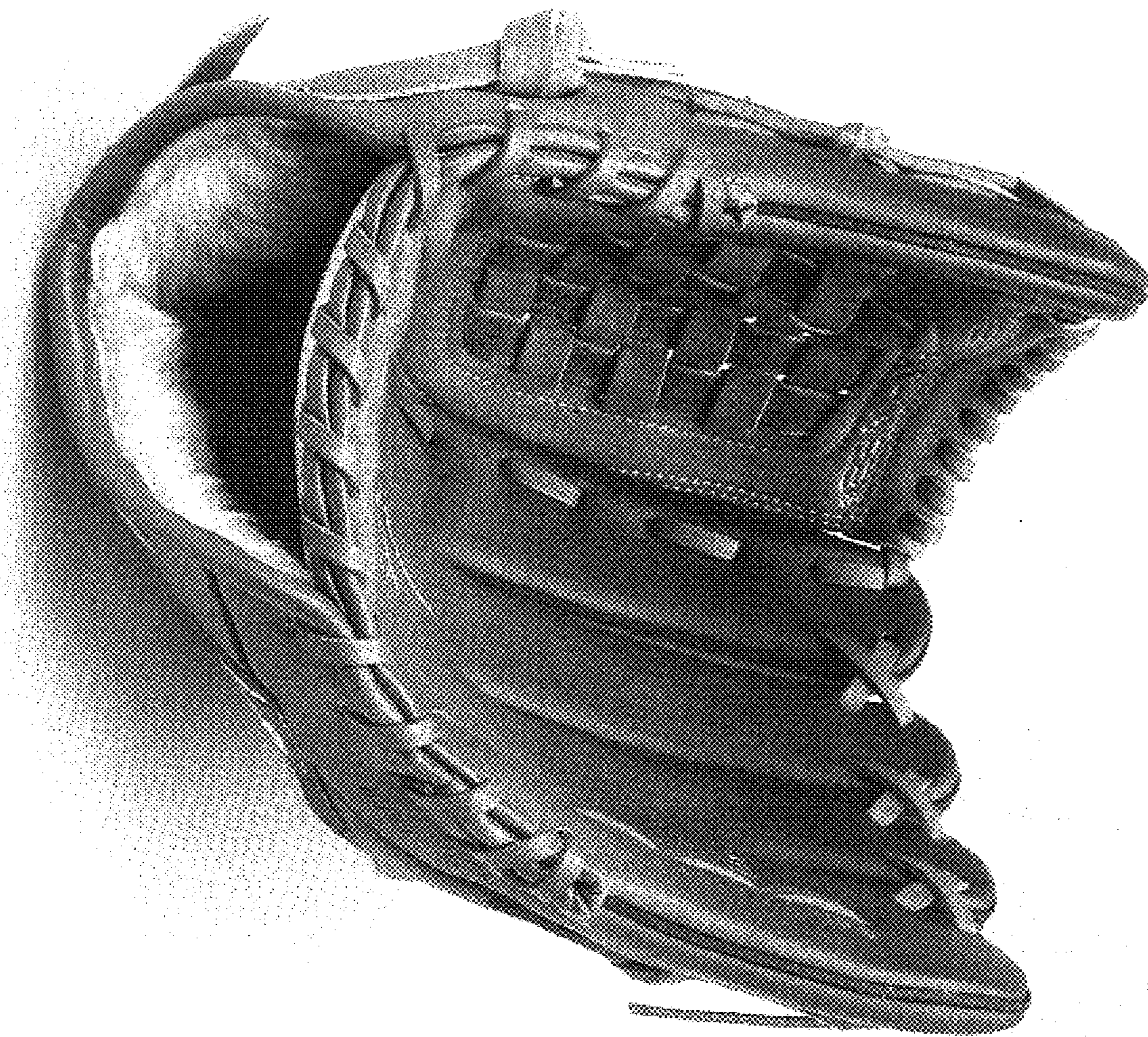

FIG. 5 is still another back perspective view of the ball glove of FIG. 1;

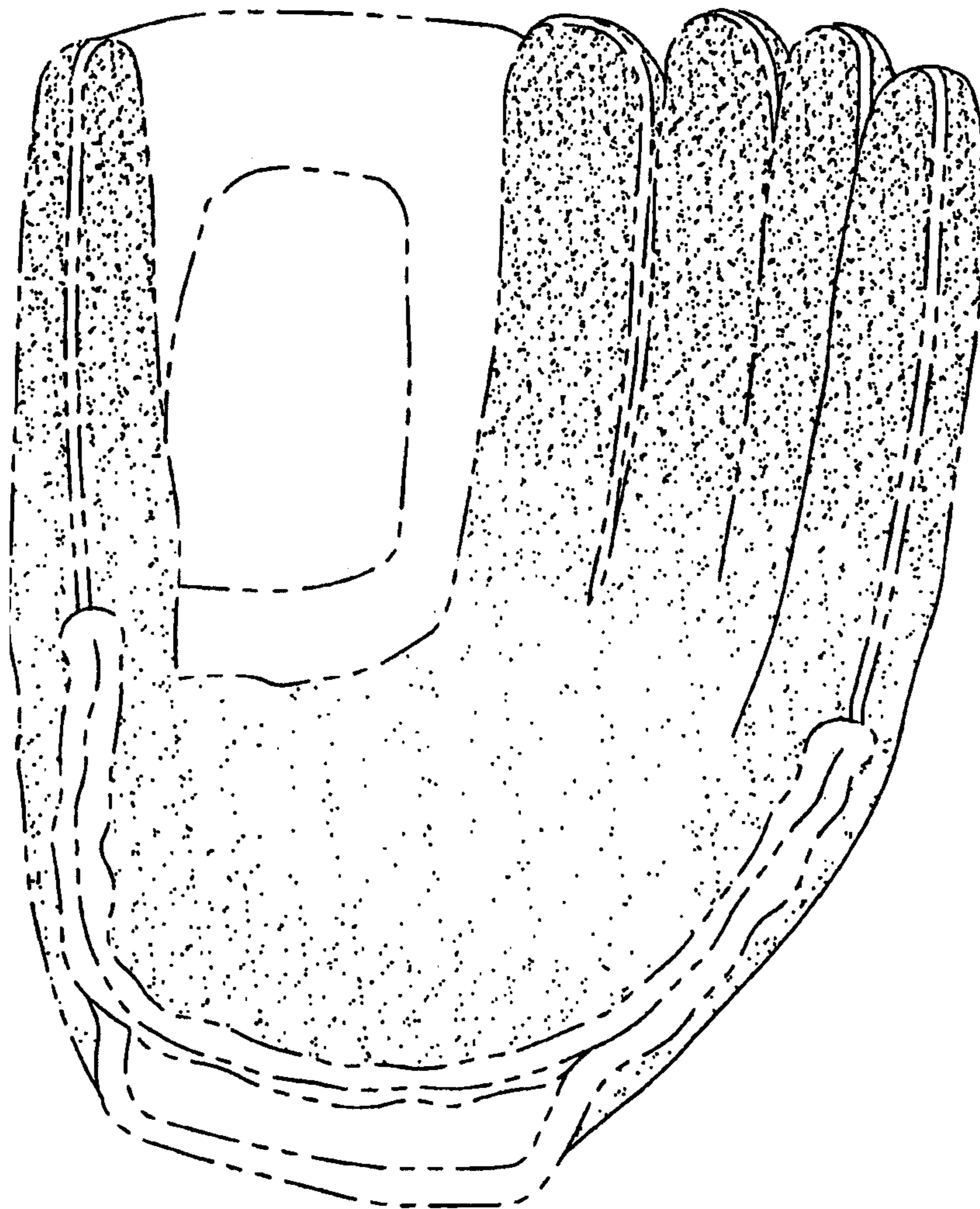

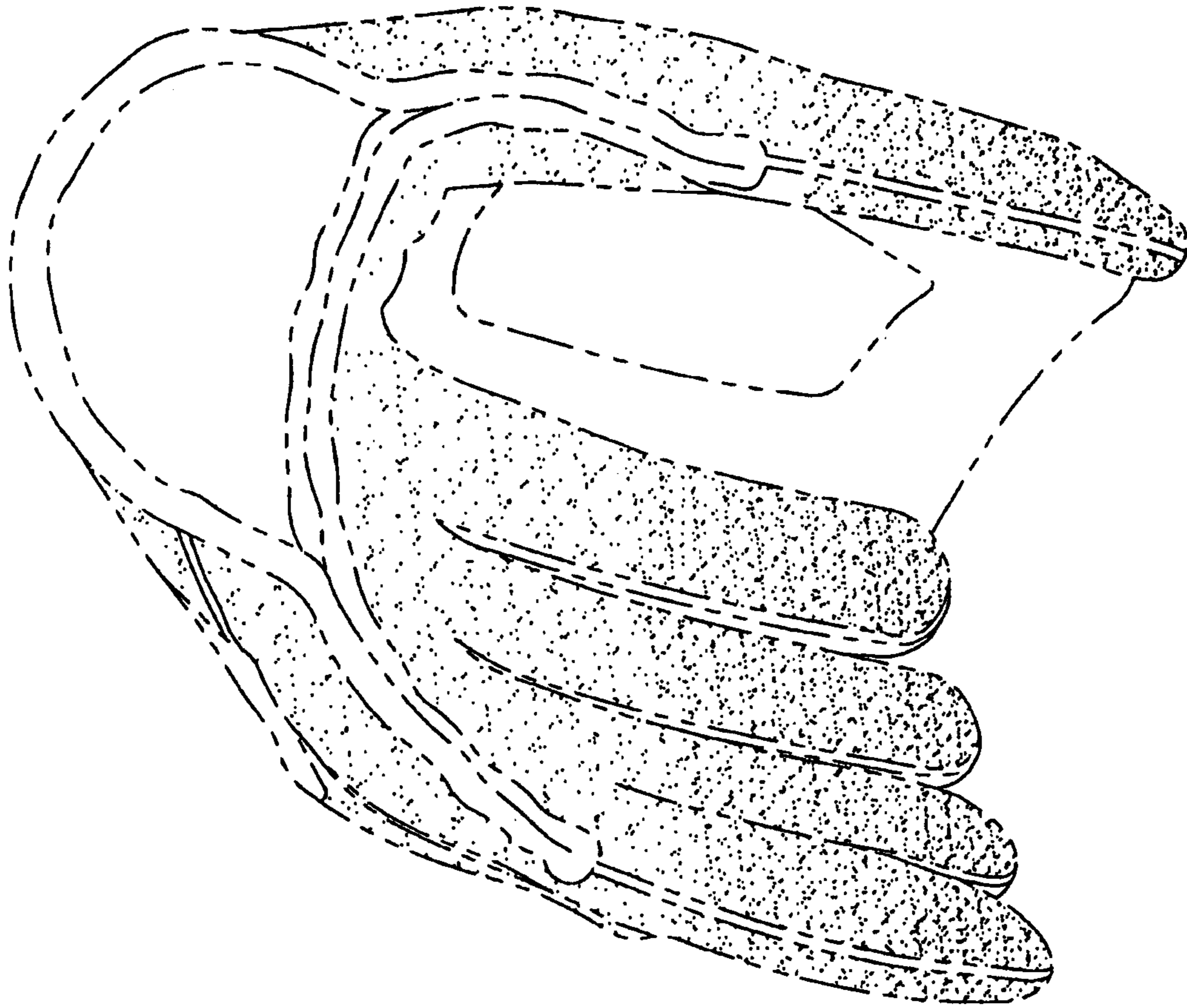

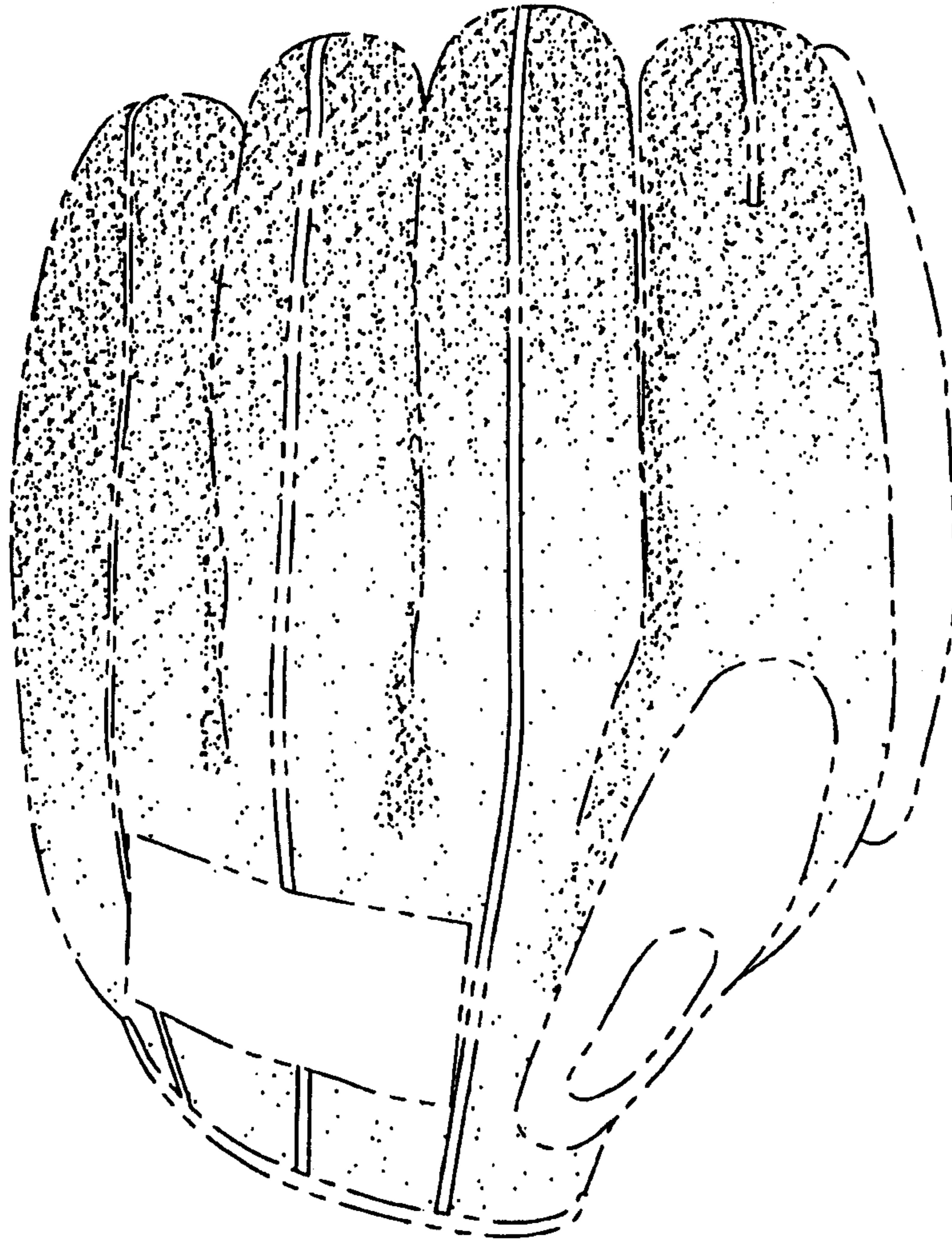

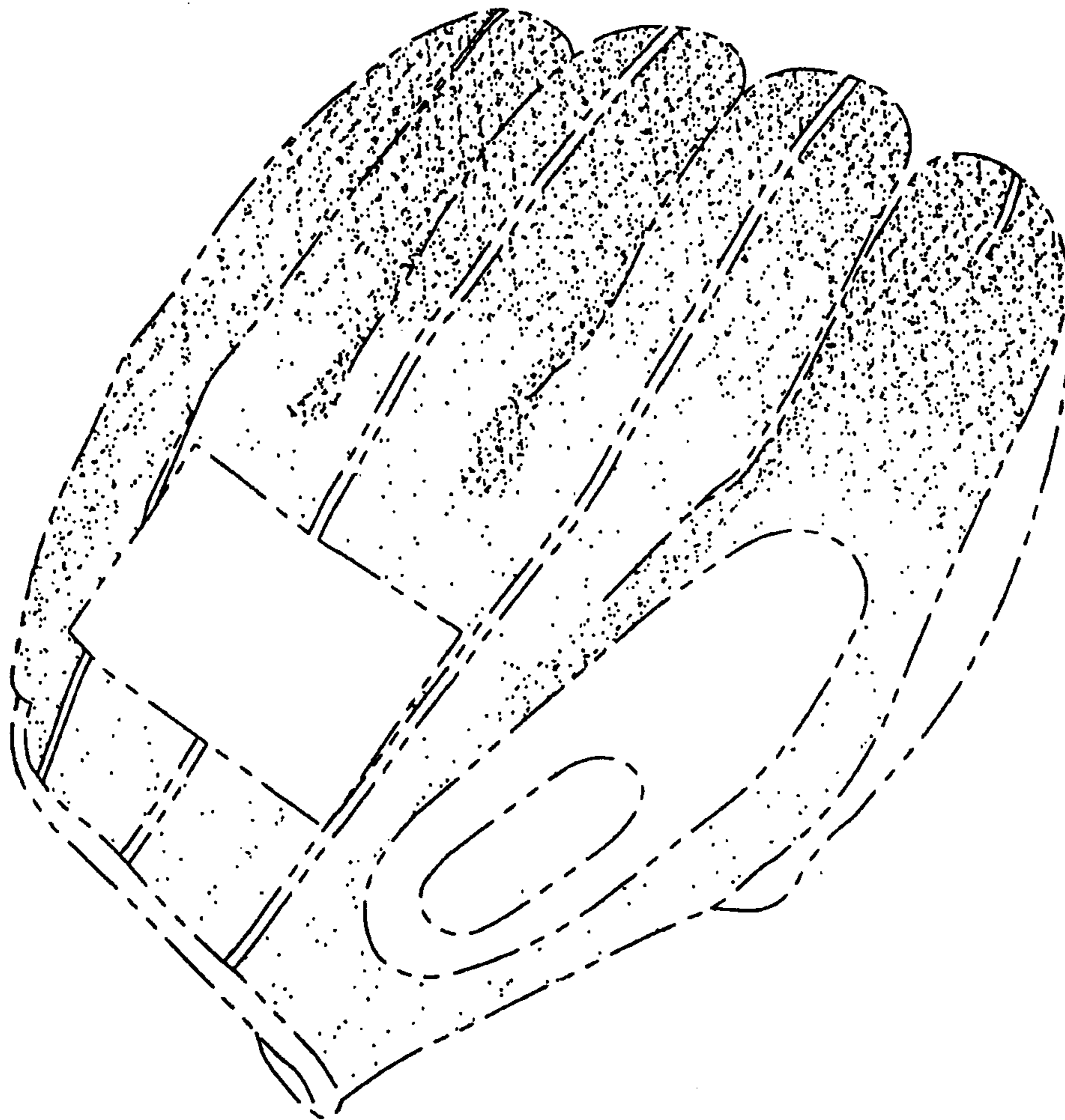

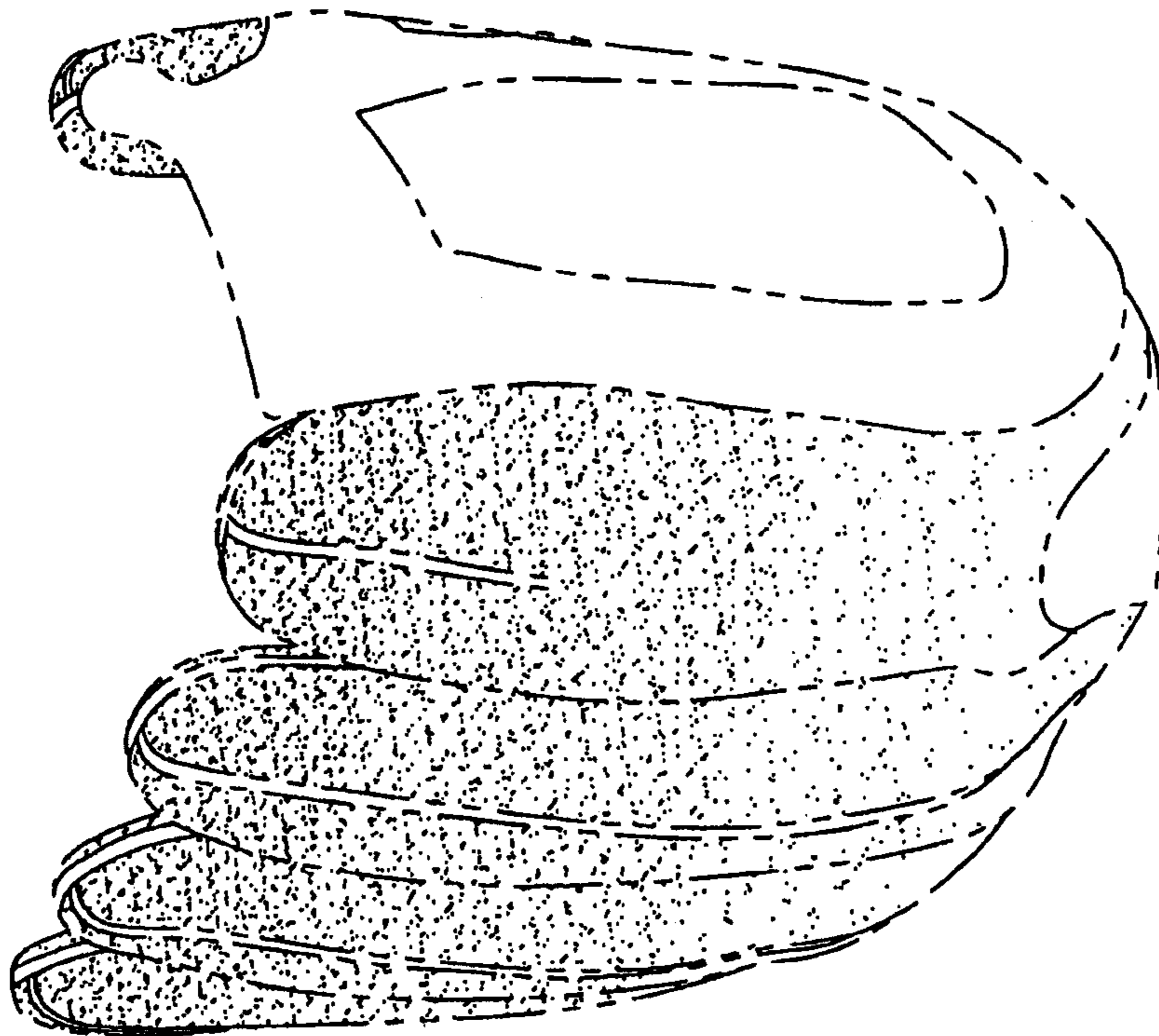

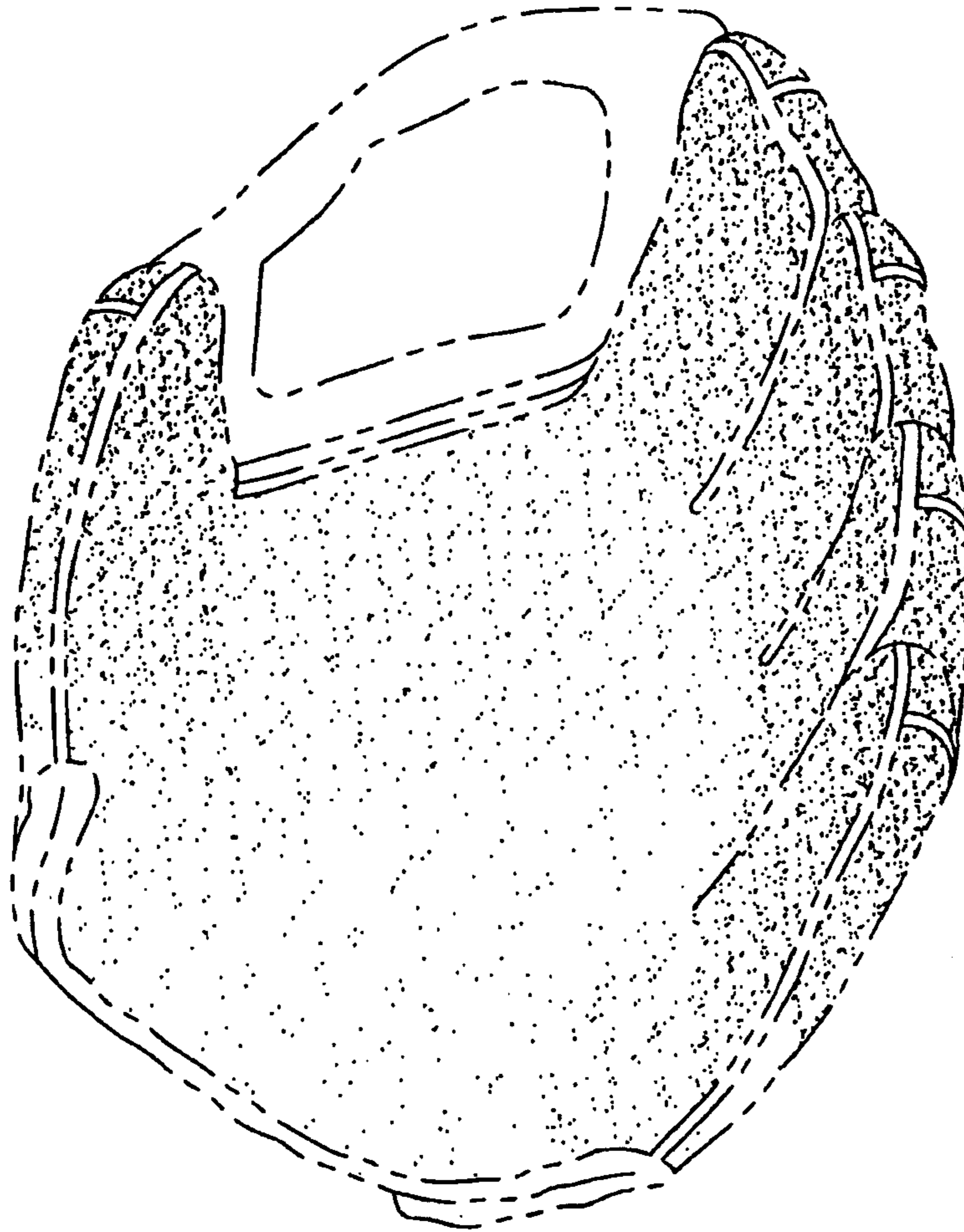

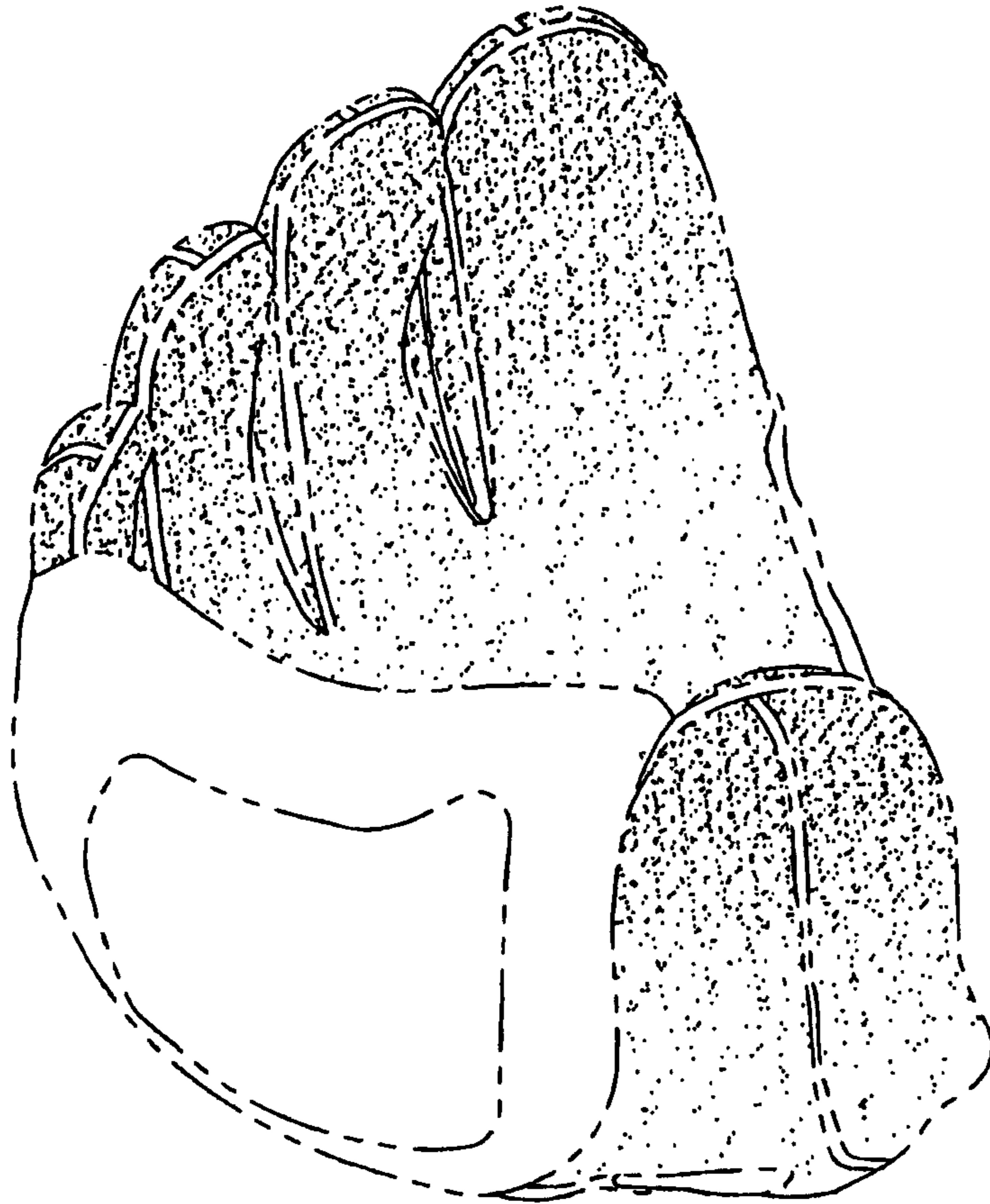

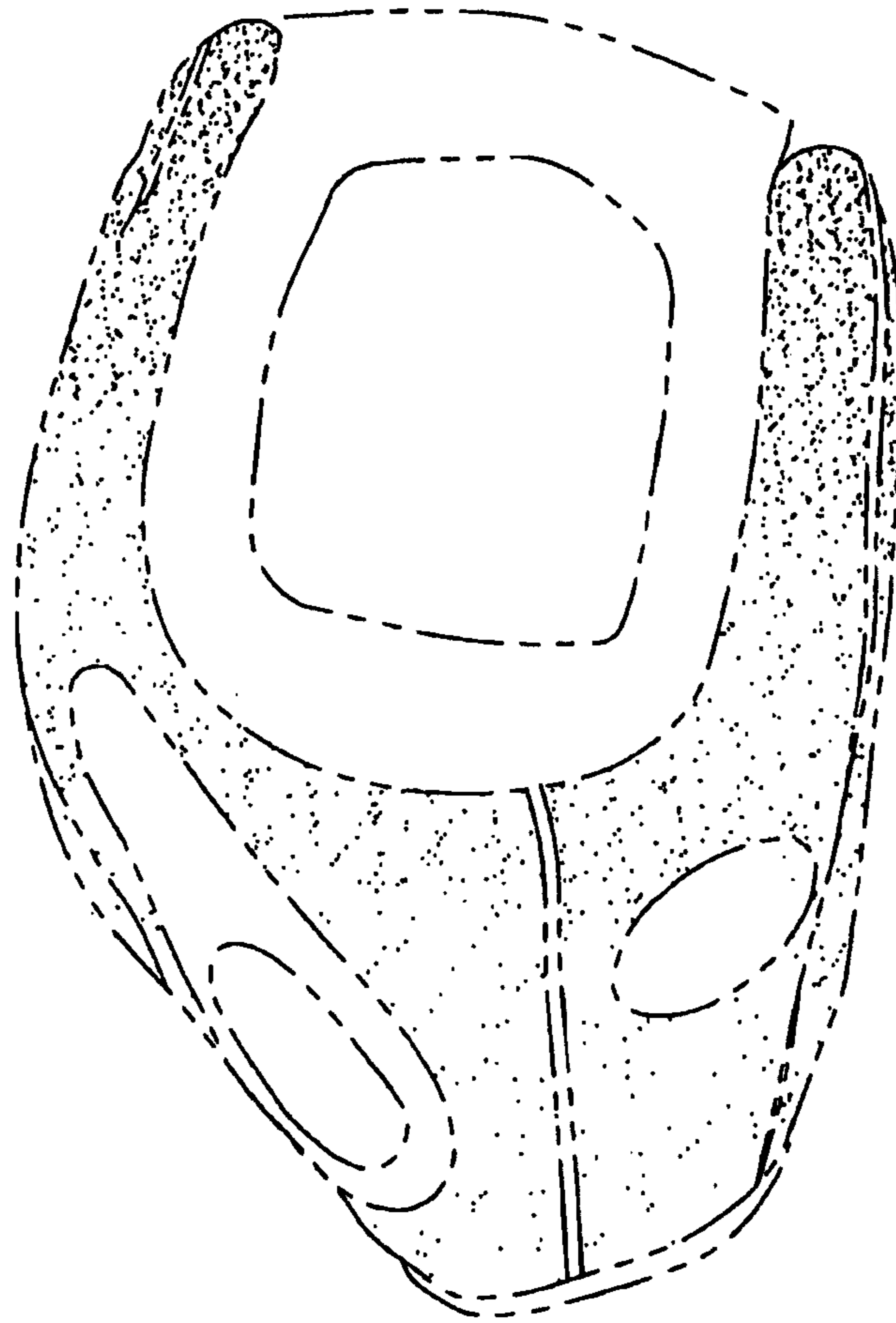
