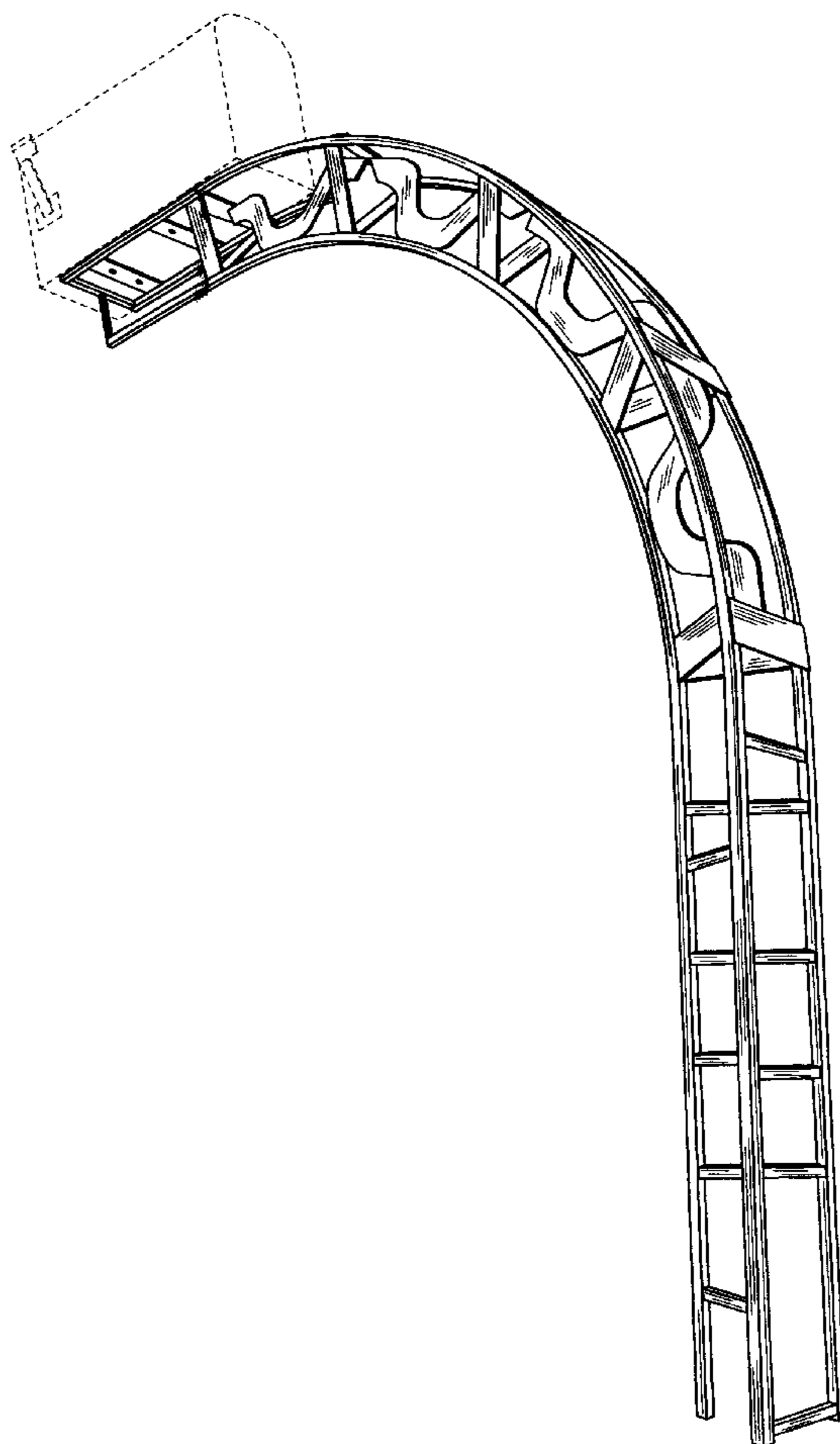
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a preferred embodiment;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left lateral elevational view thereof, the right lateral elevational view being a mirror image thereof;

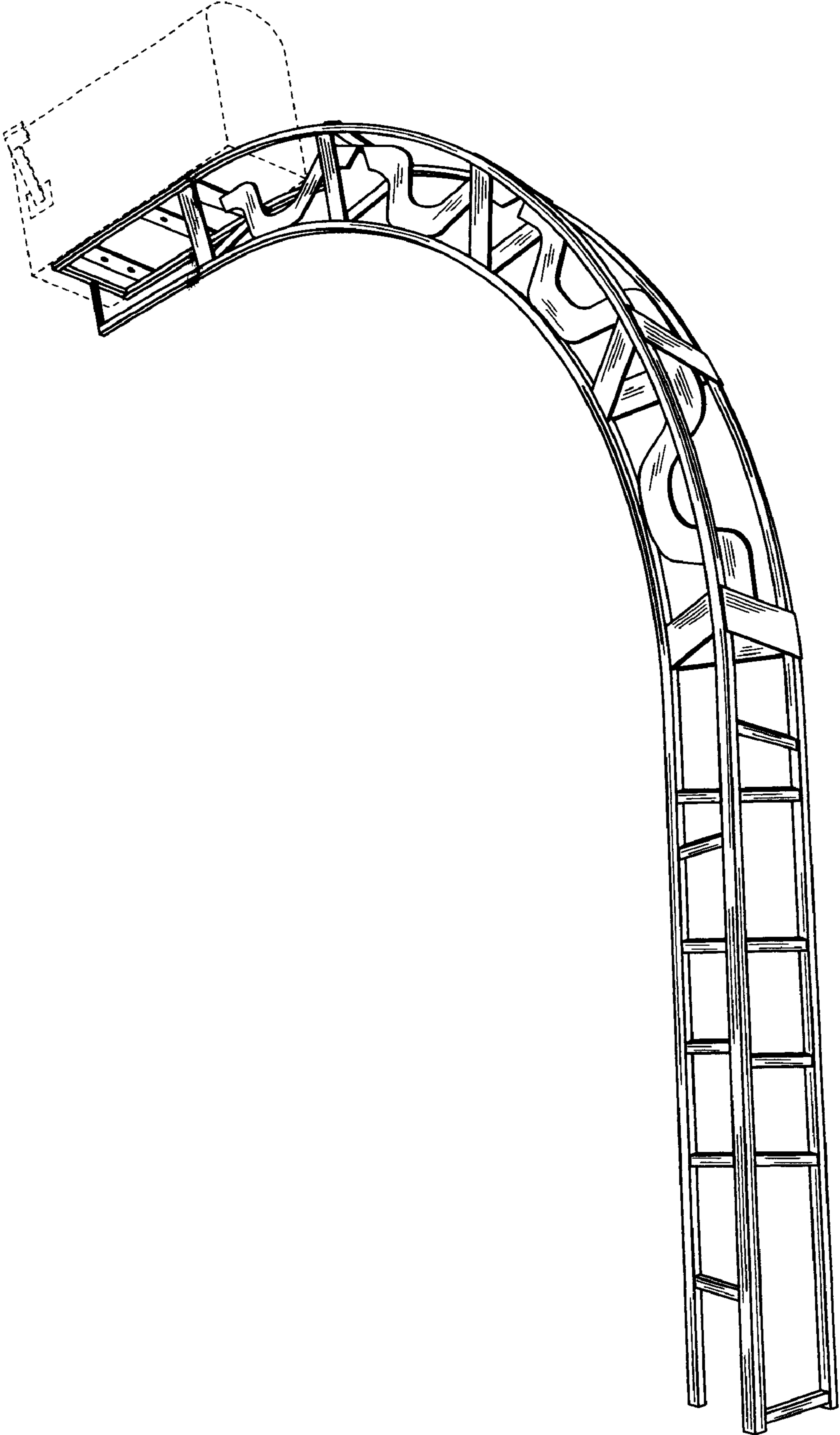
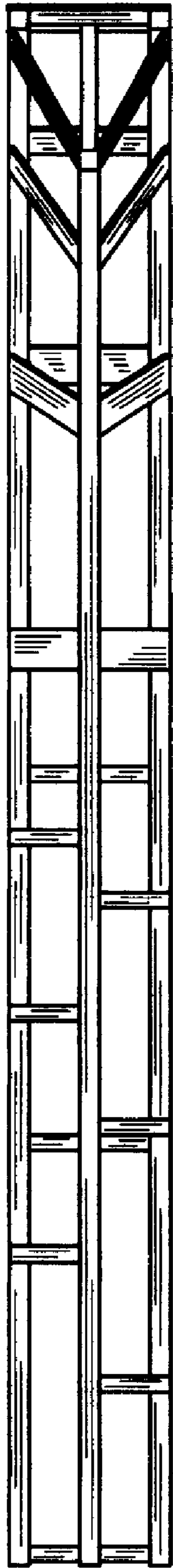
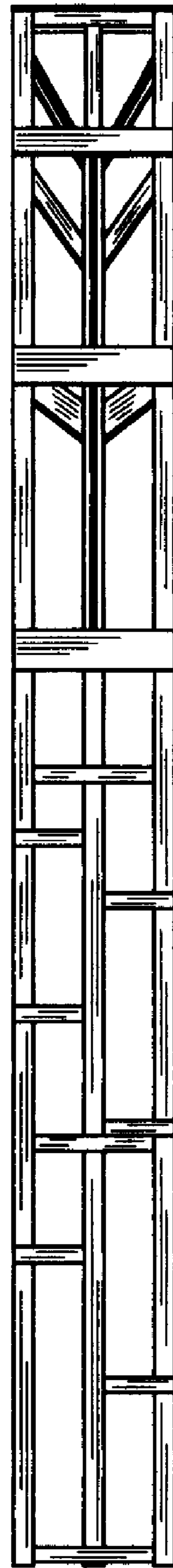

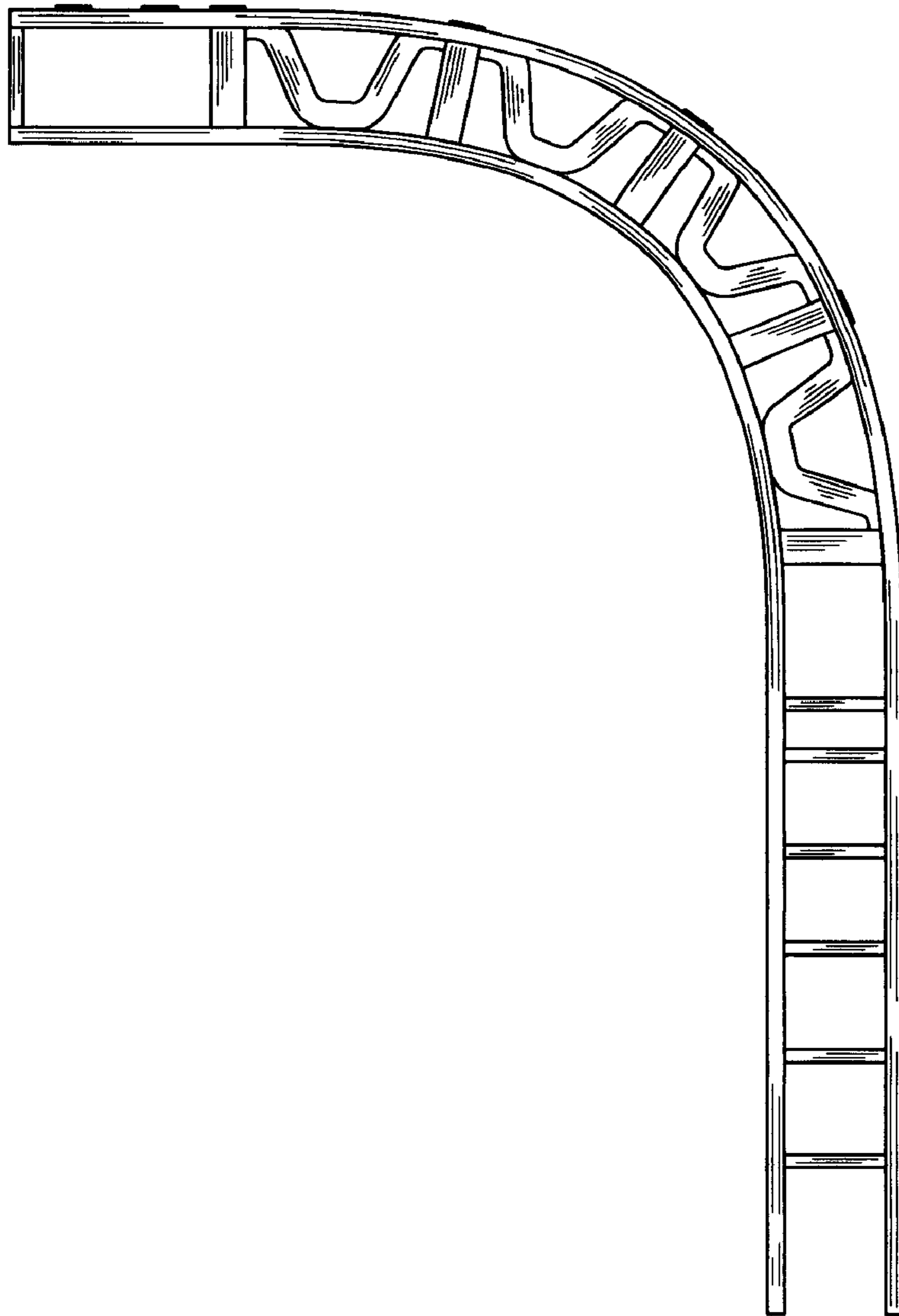

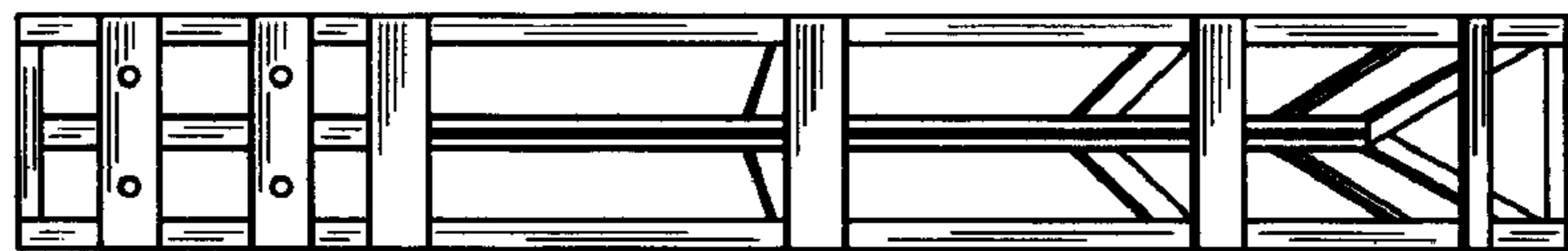
