(57) **CLAIM**

We claim the ornamental design for a jacket with padded collar and detachable sleeves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a jacket with padded collar and detachable sleeves, the sleeves being shown detached;

FIG. 2 is a front elevational view thereof, the sleeves being shown attached;

FIG. 3 is a rear elevational view thereof;

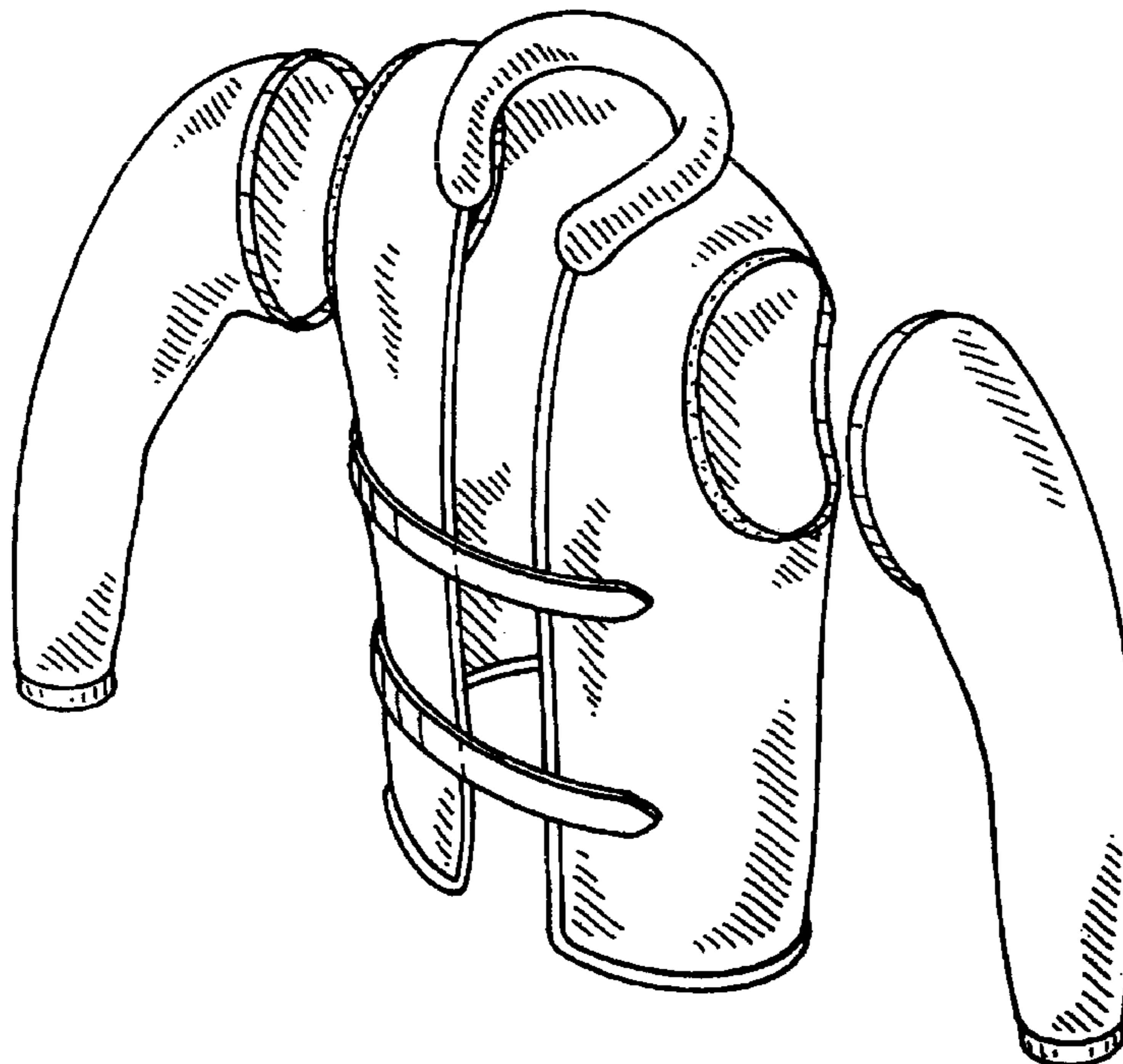
FIG. 4 is a left side elevational view thereof;

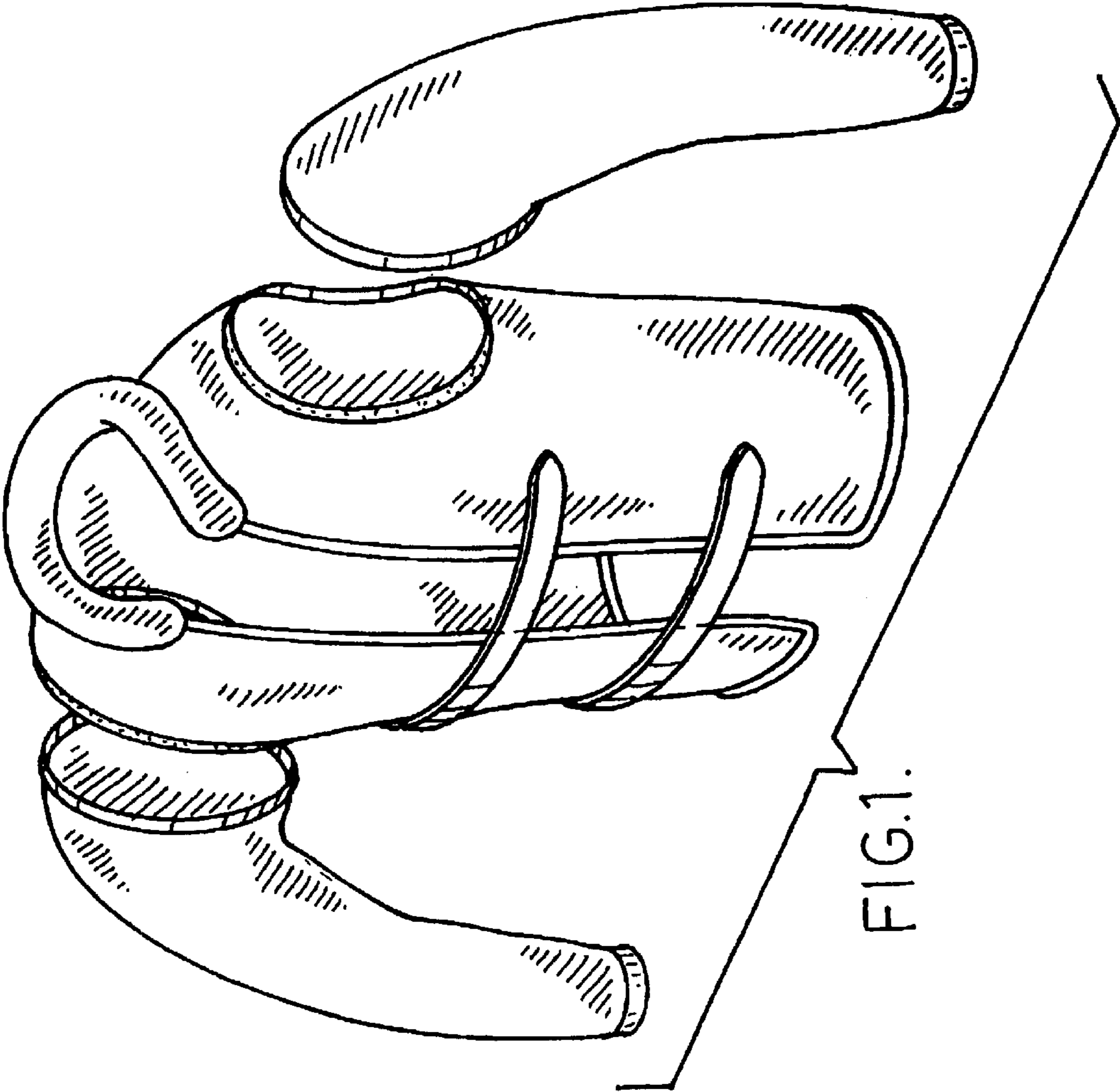
FIG. 5 is a right side elevational view thereof;

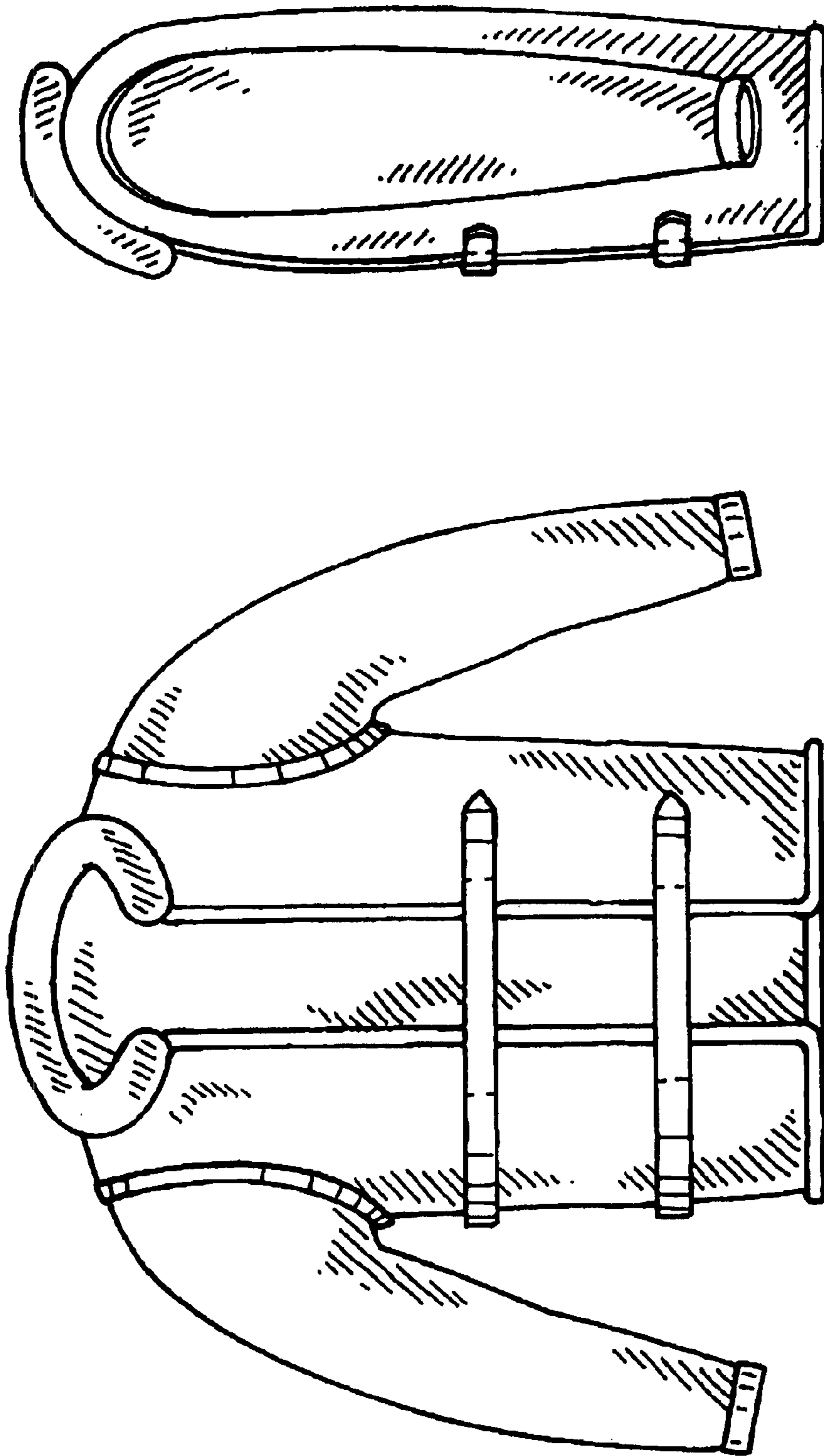

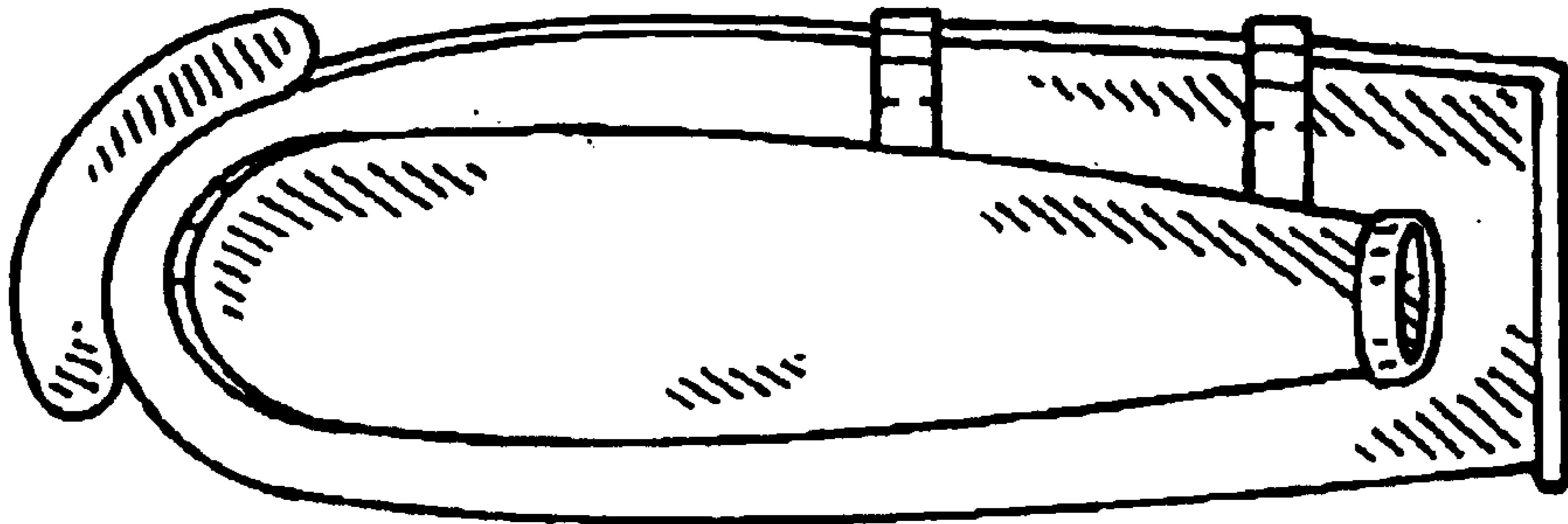

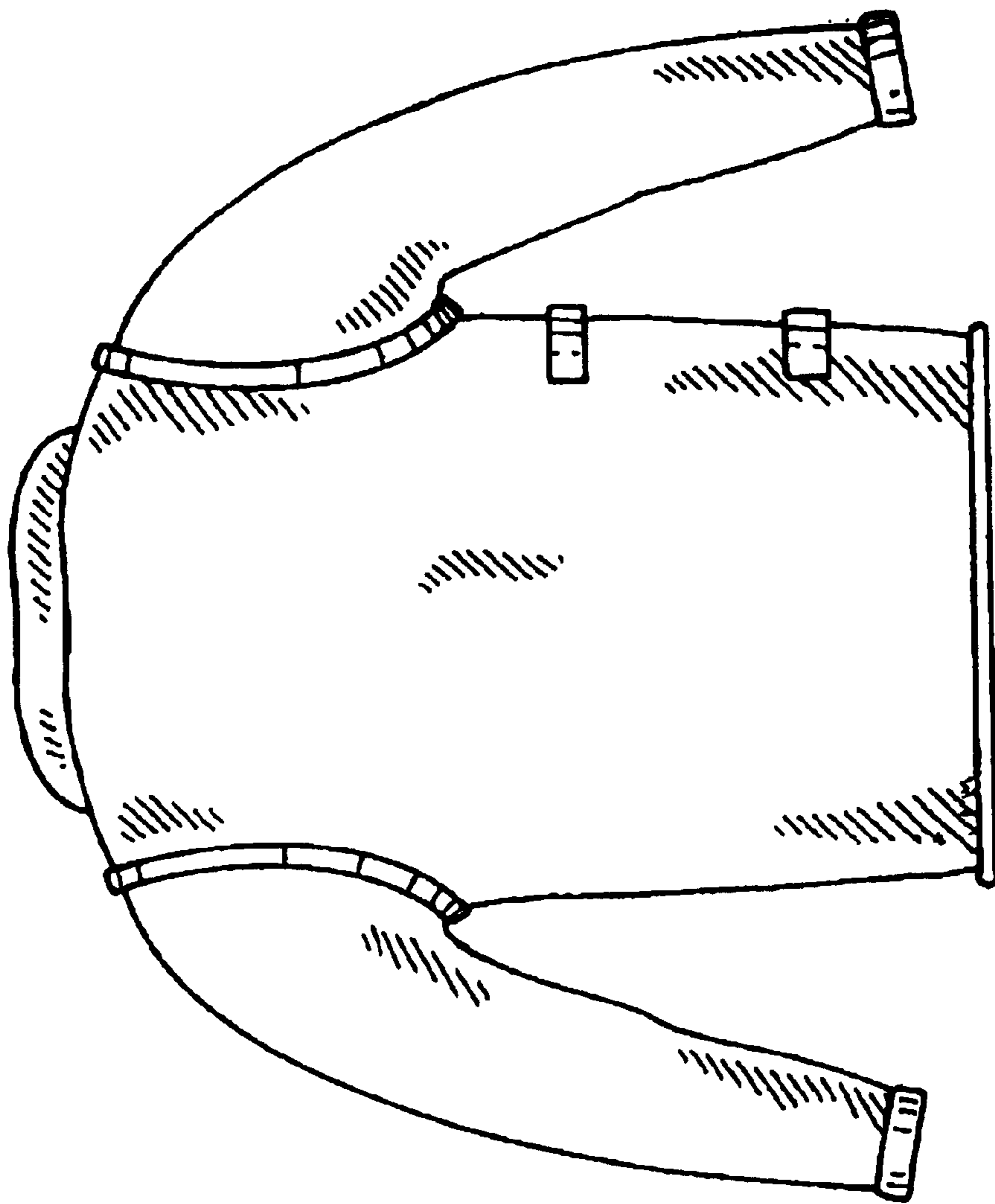

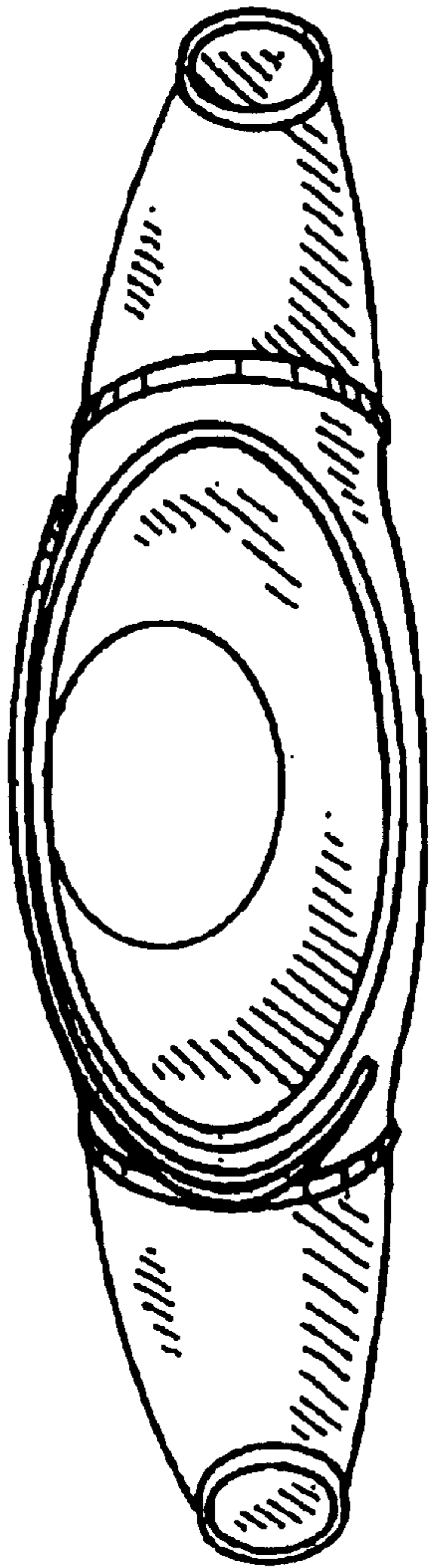

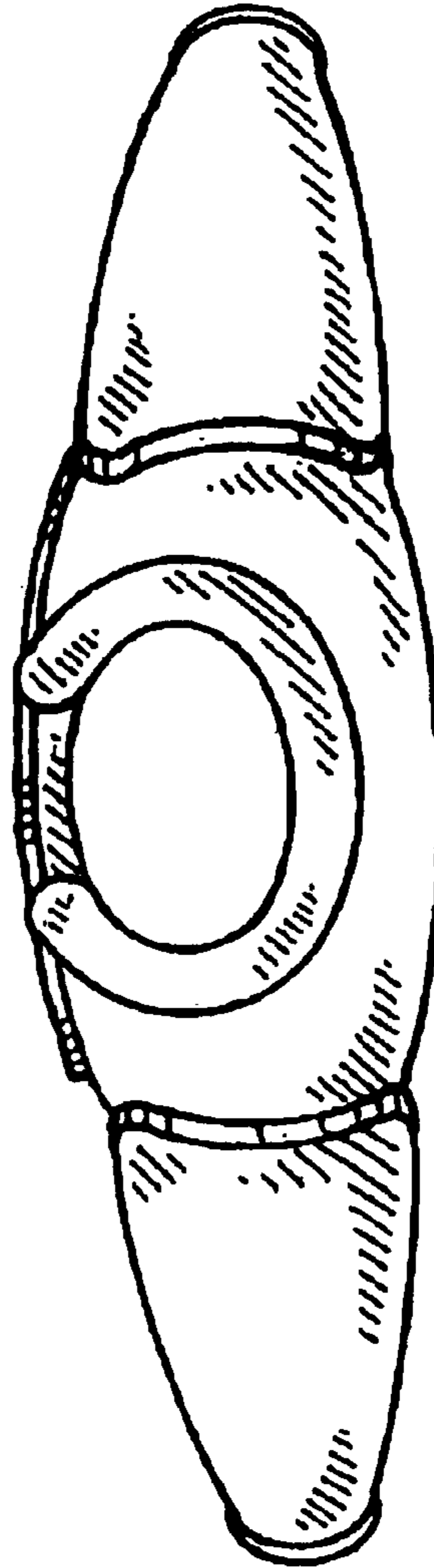
