**DESCRIPTION**

FIG. 1 is an isometric view of a first embodiment of luggage showing my new design;

FIG. 6 is a top view of the luggage of FIG. 1;

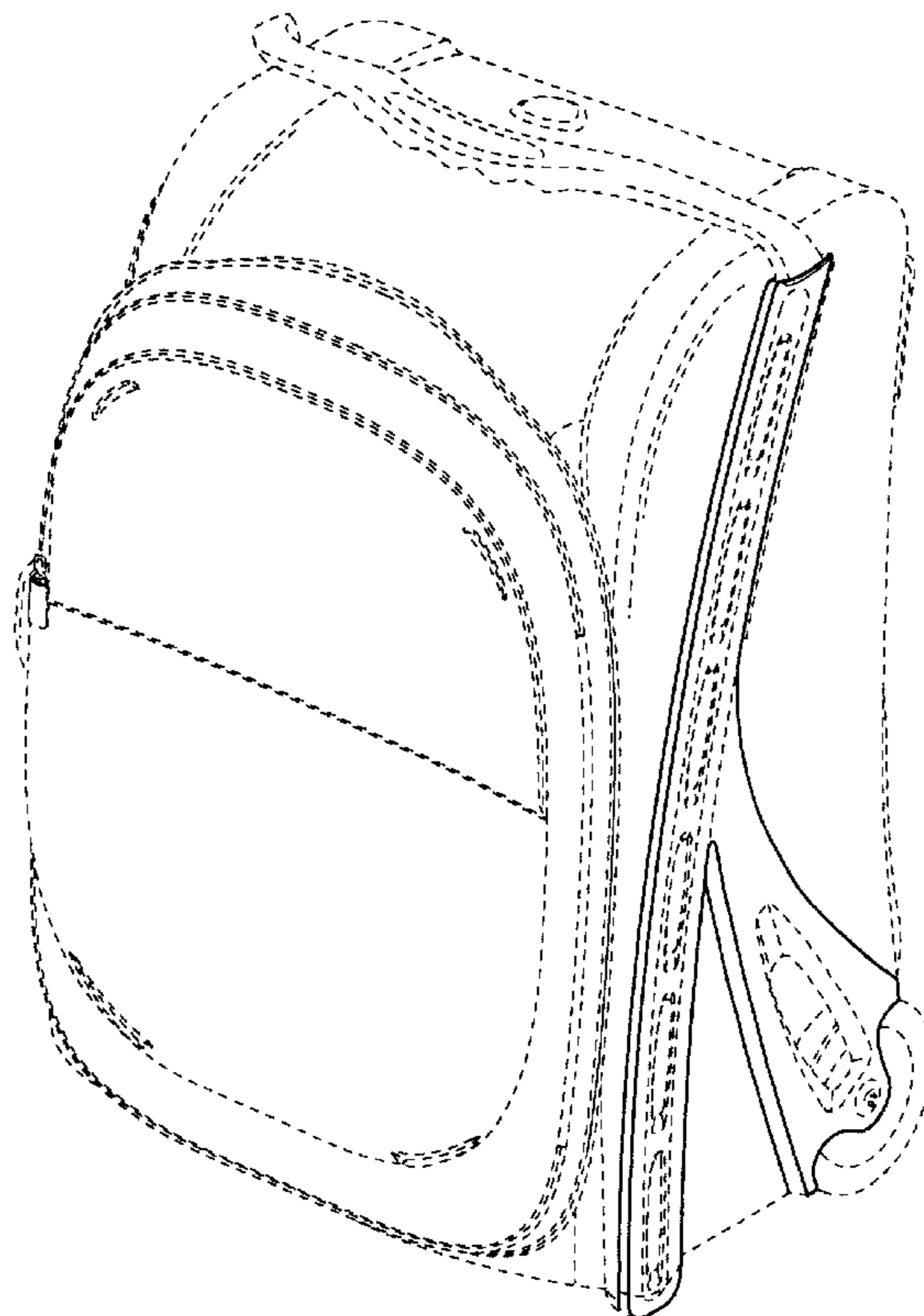
FIG. 7 is an isometric view of a second embodiment of luggage showing my new design;

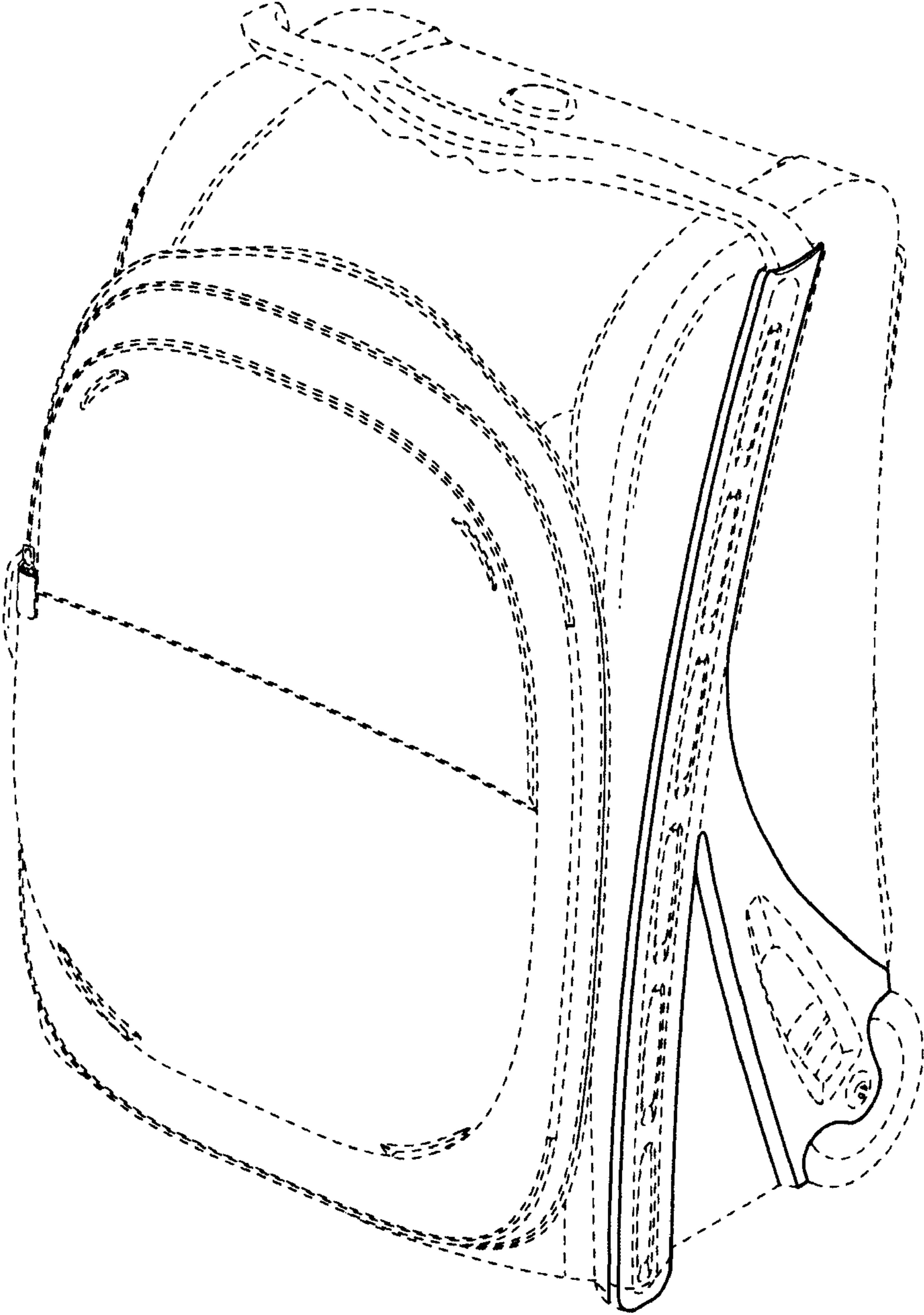

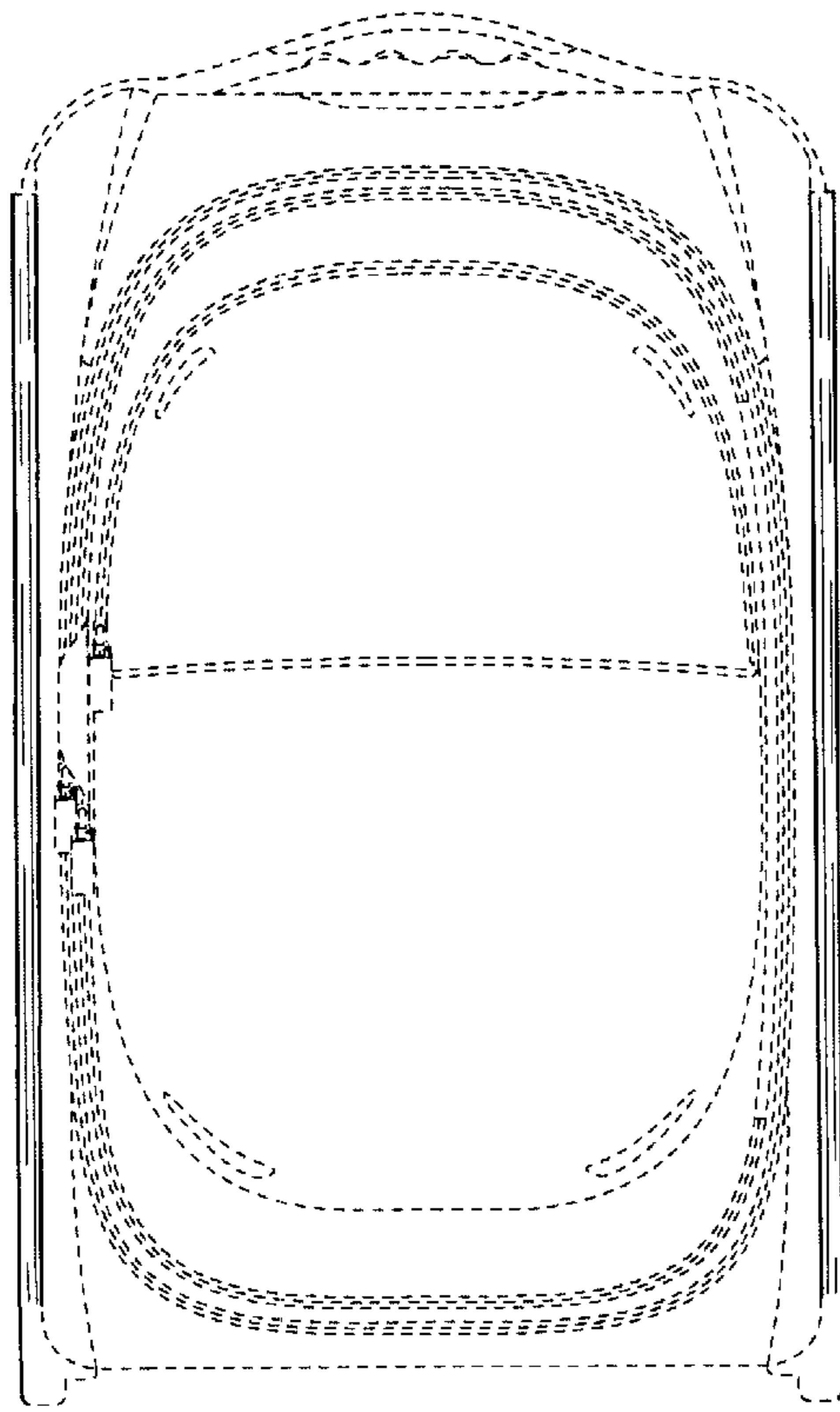

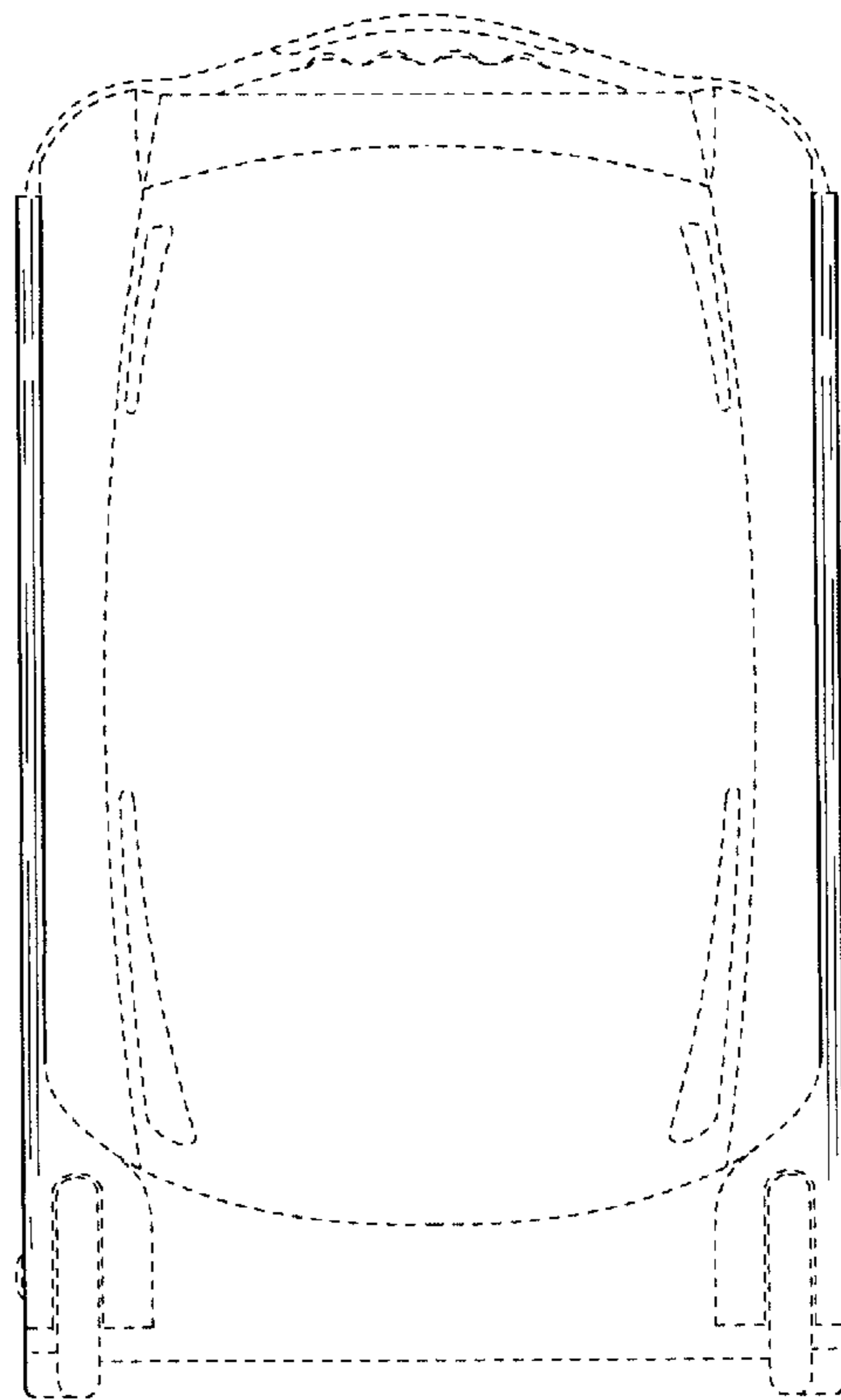

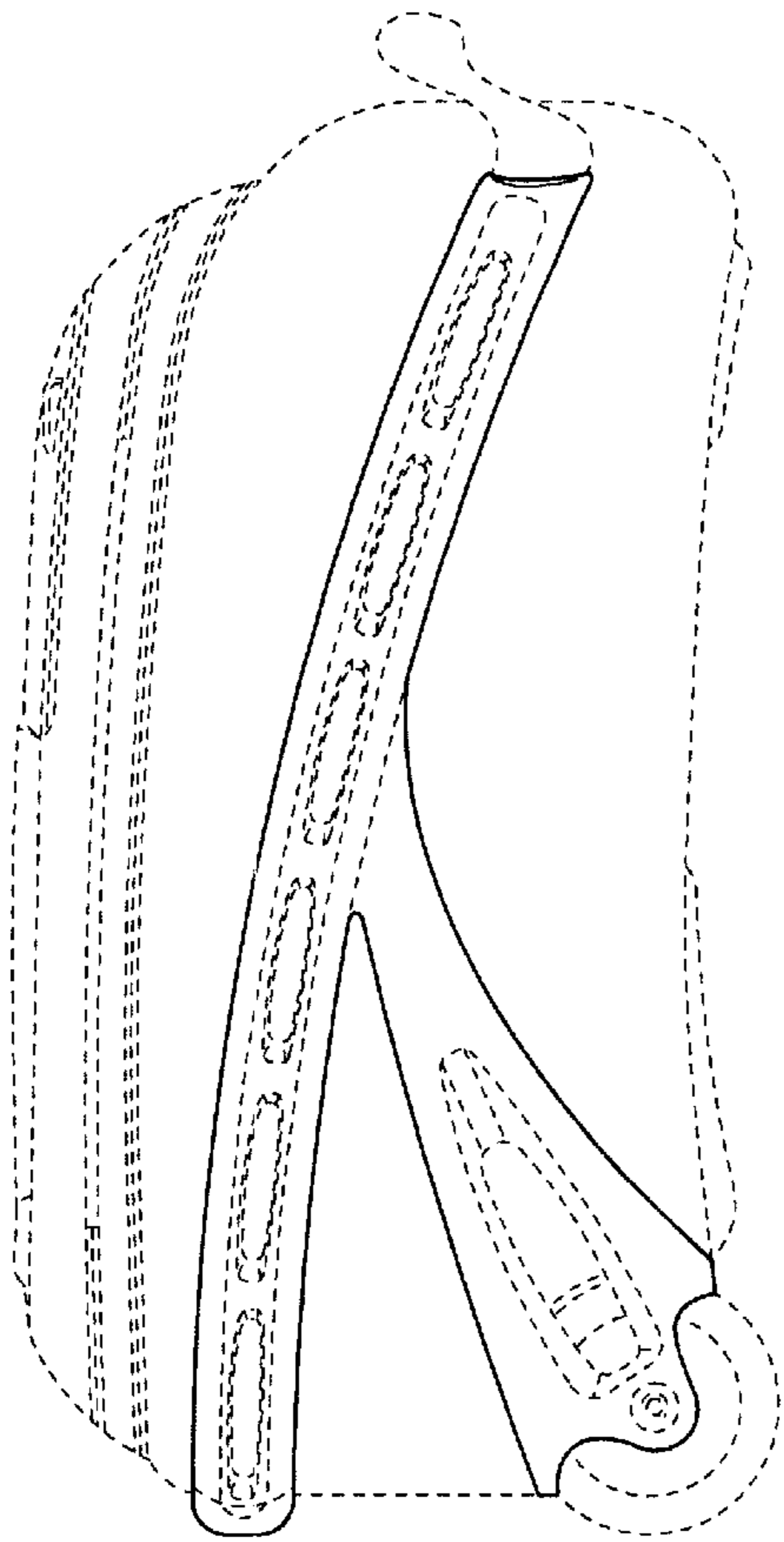

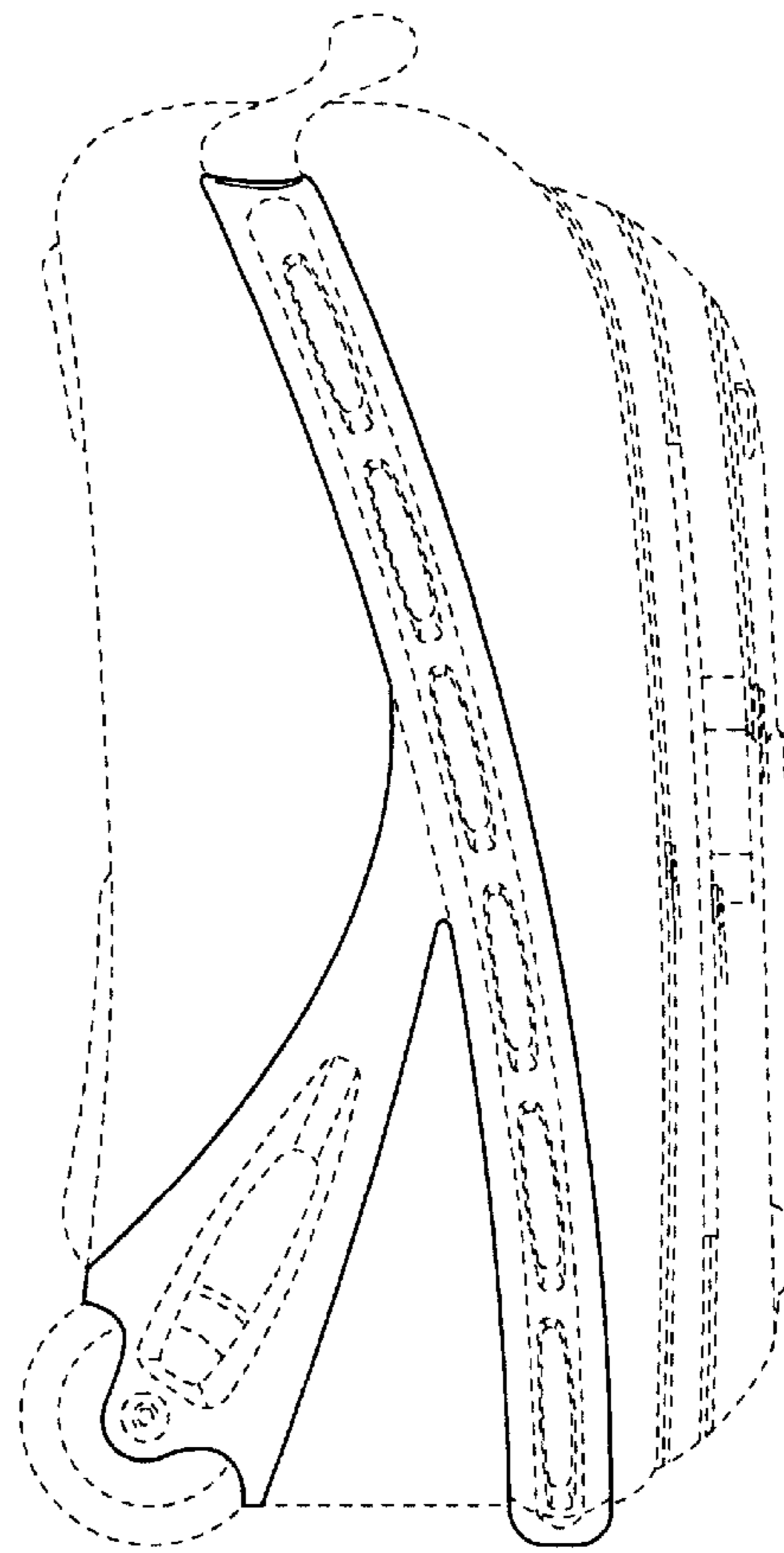

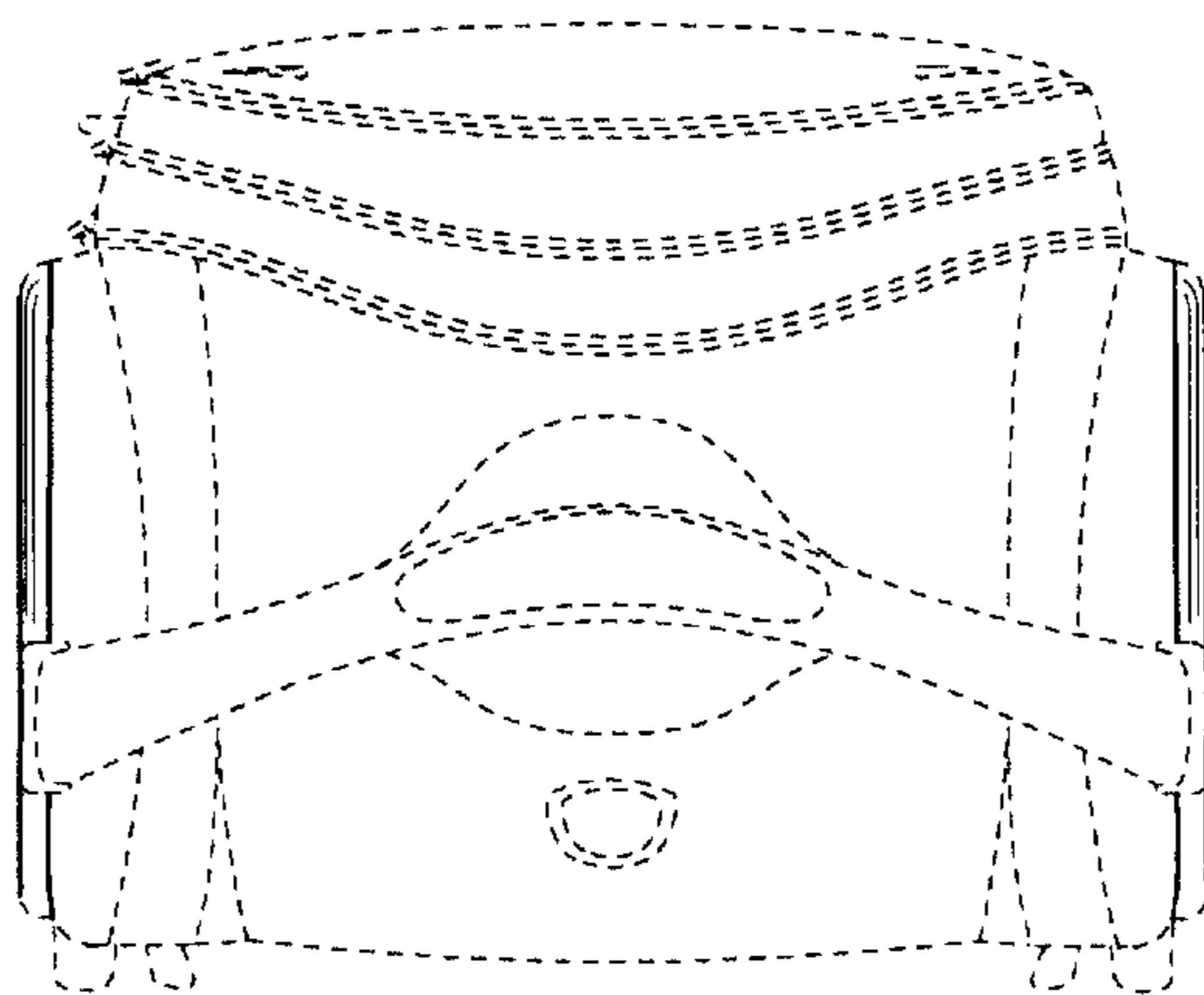

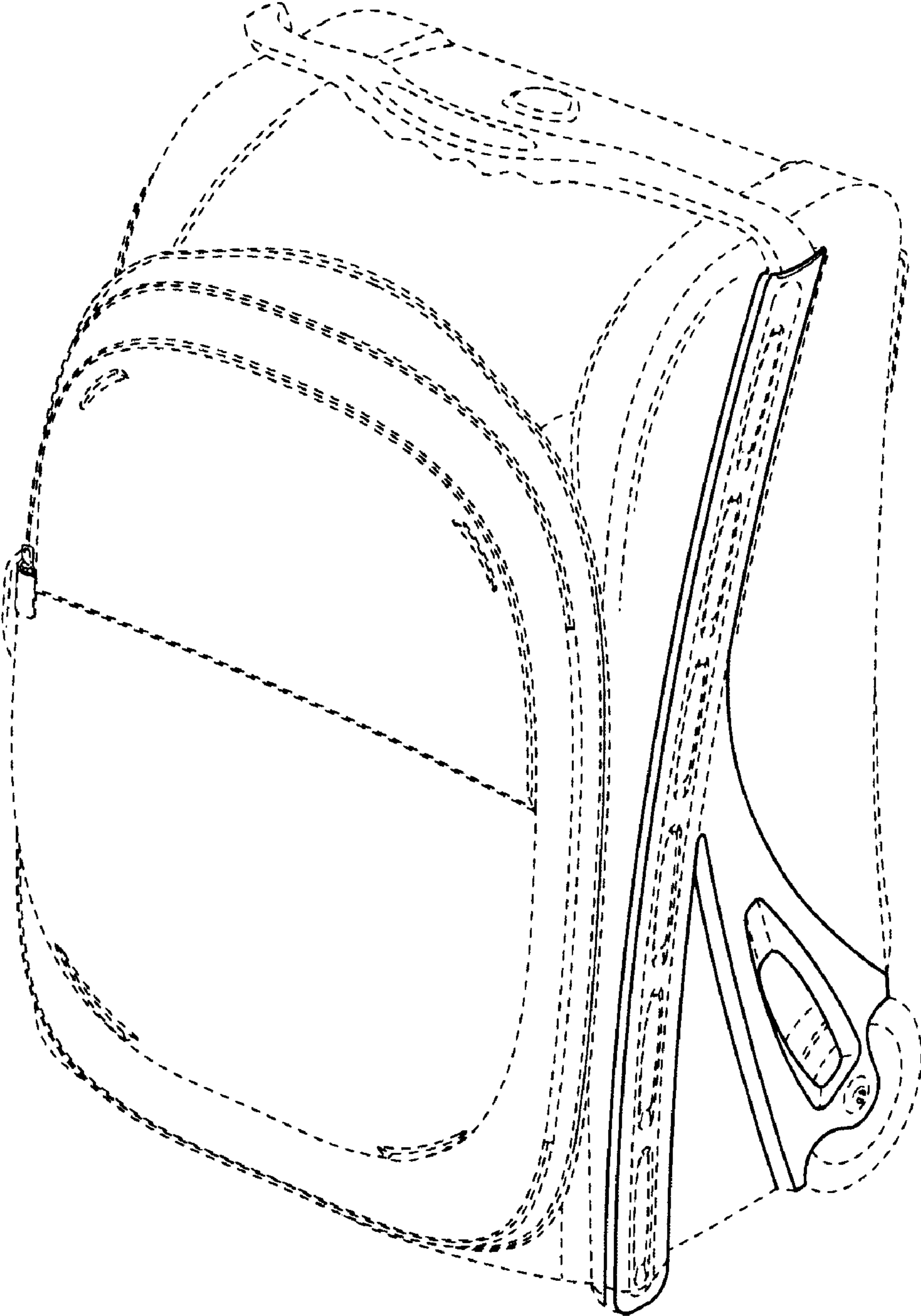

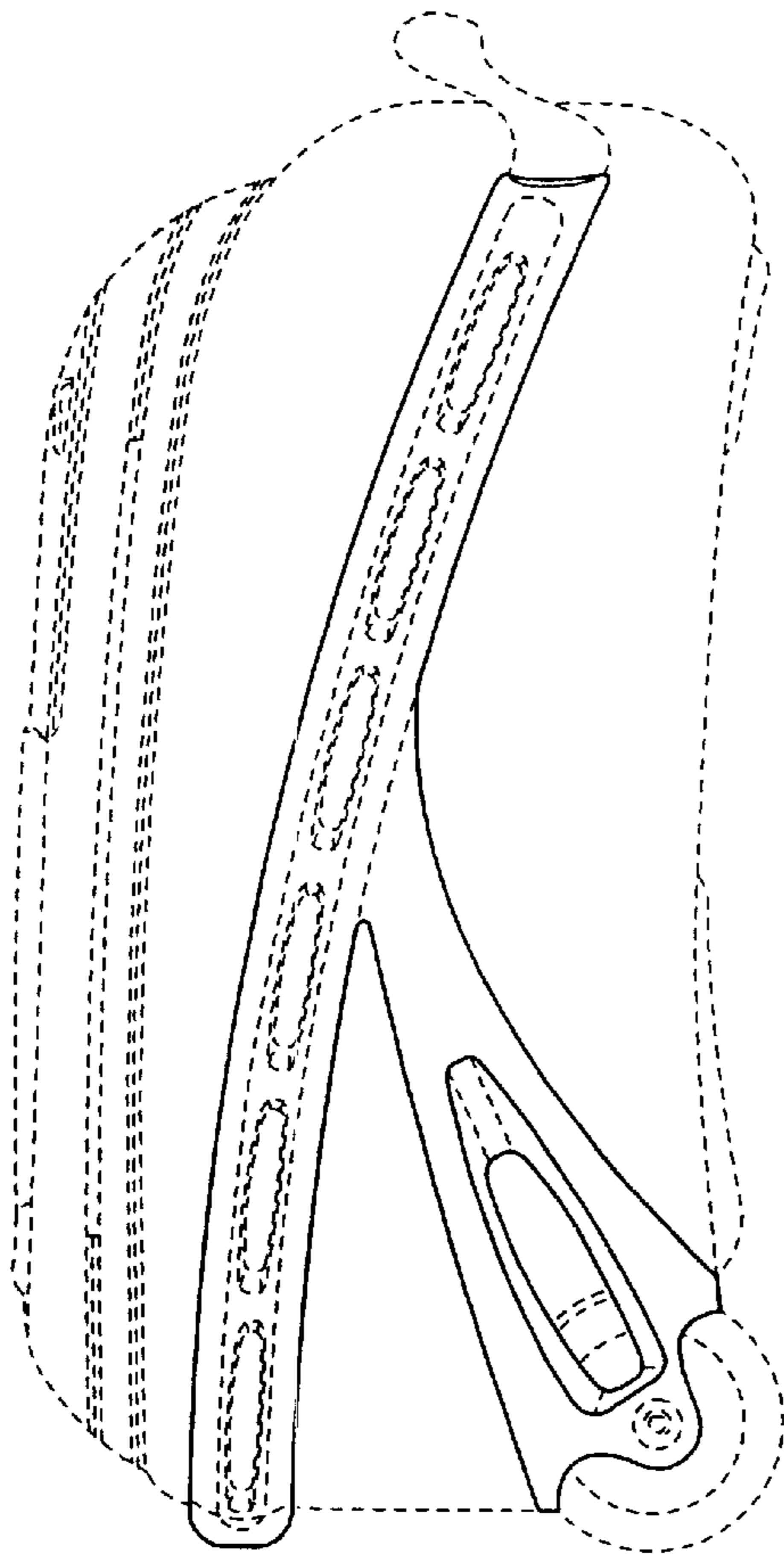

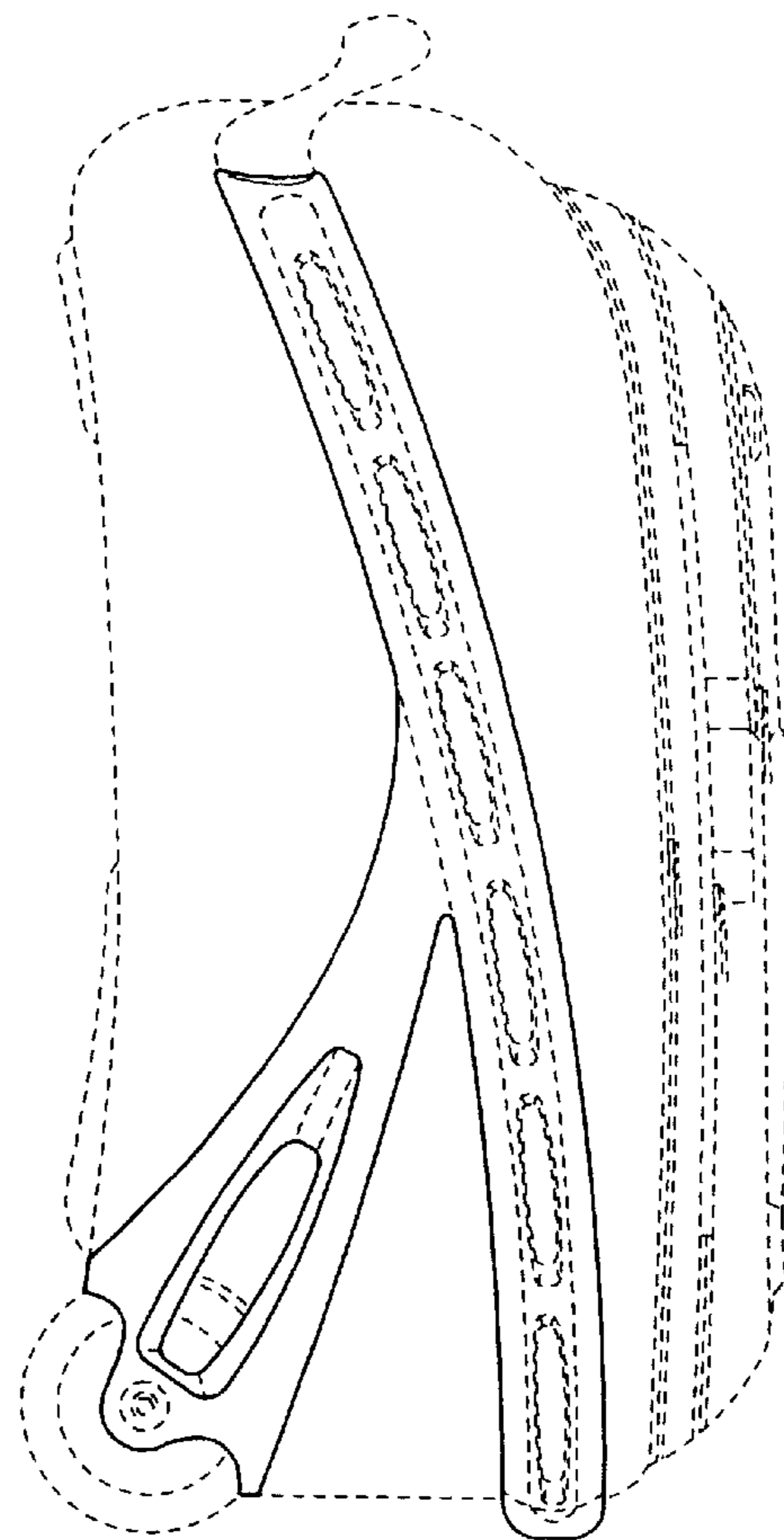
