FIG. 1 is a perspective view of a table according to an embodiment of the invention.

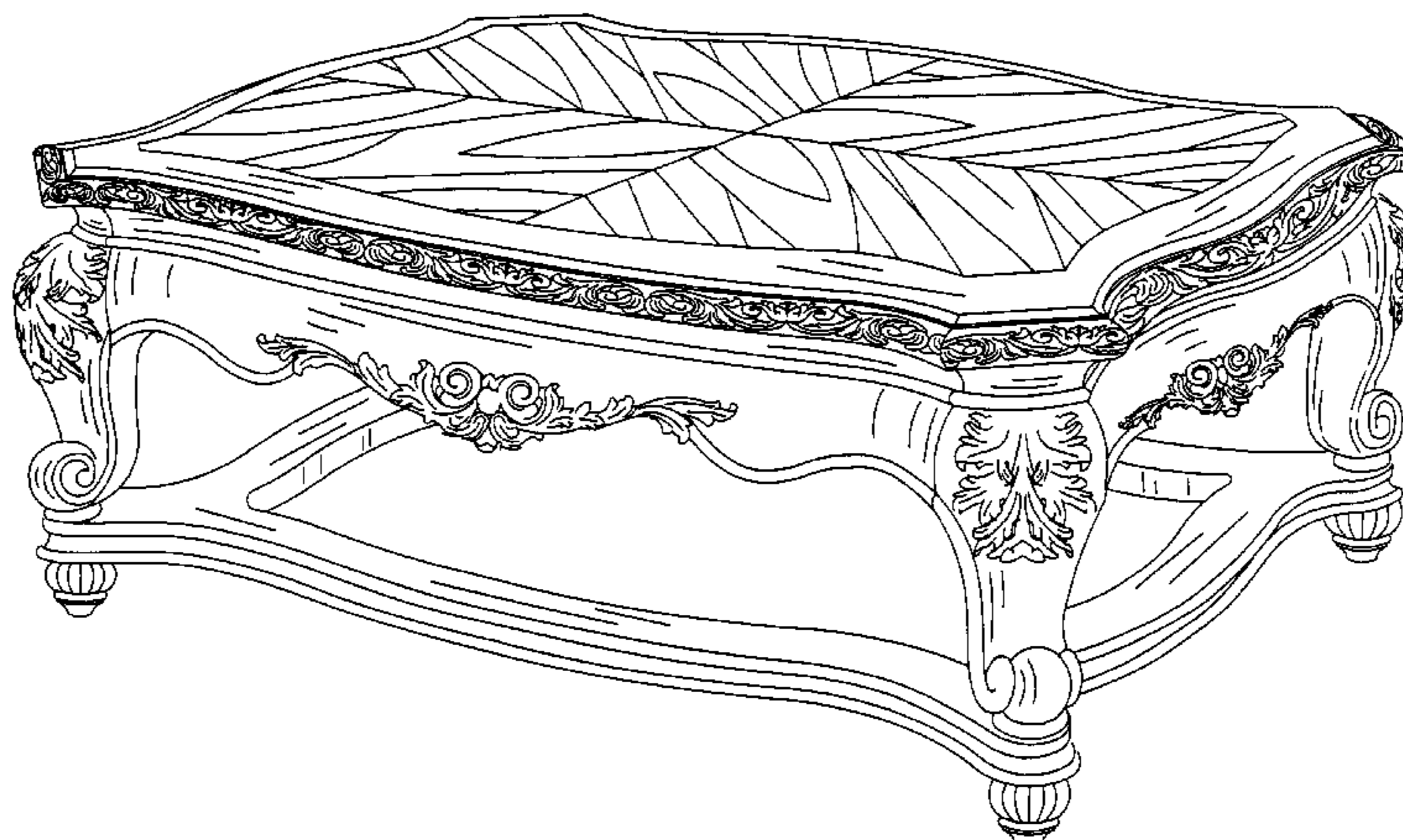
FIG. 2 is a front elevational view of a table according to an embodiment of the invention.

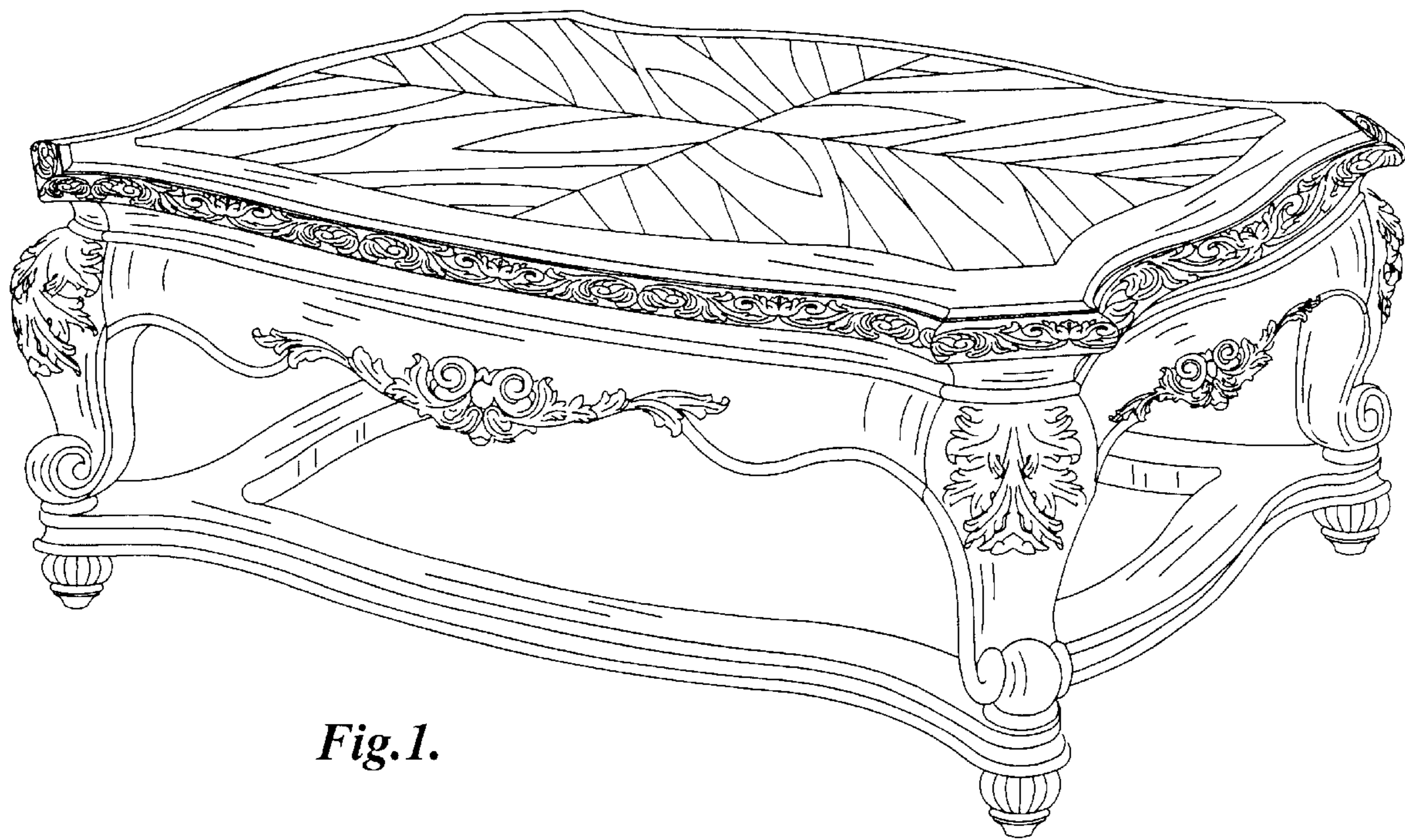

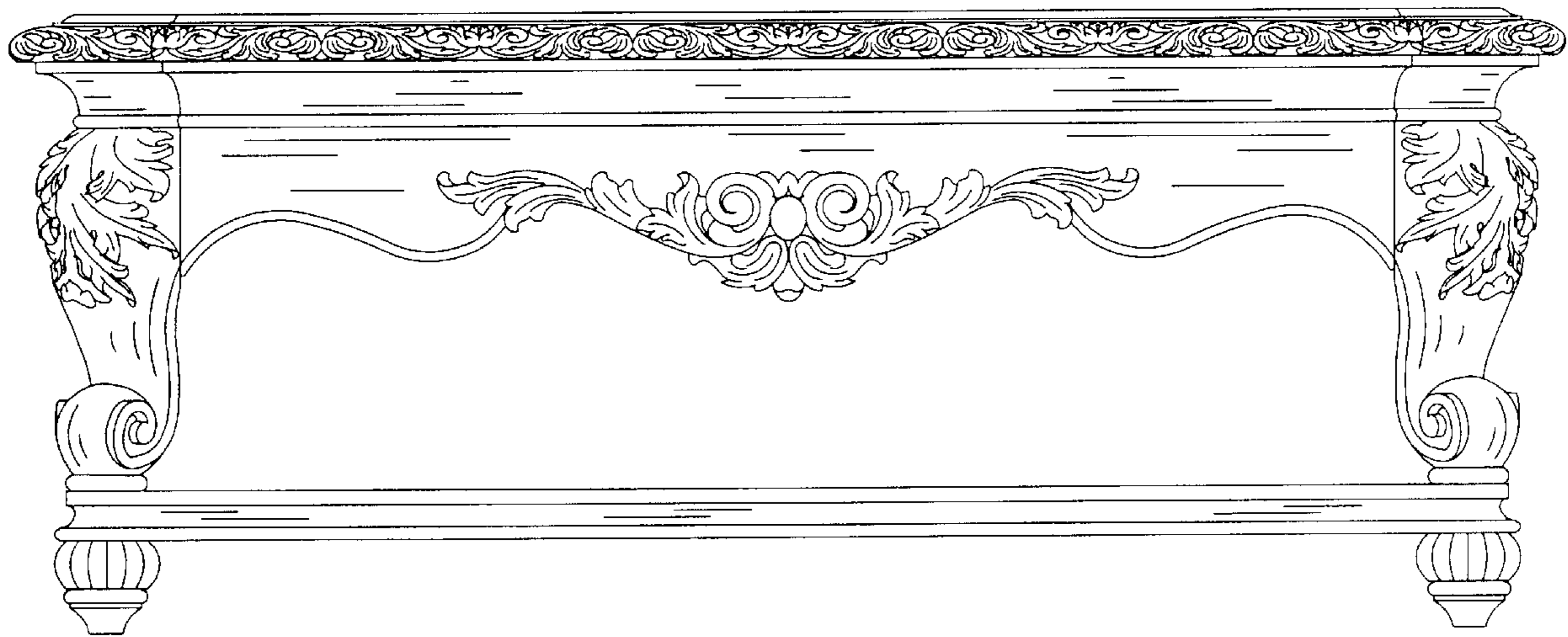

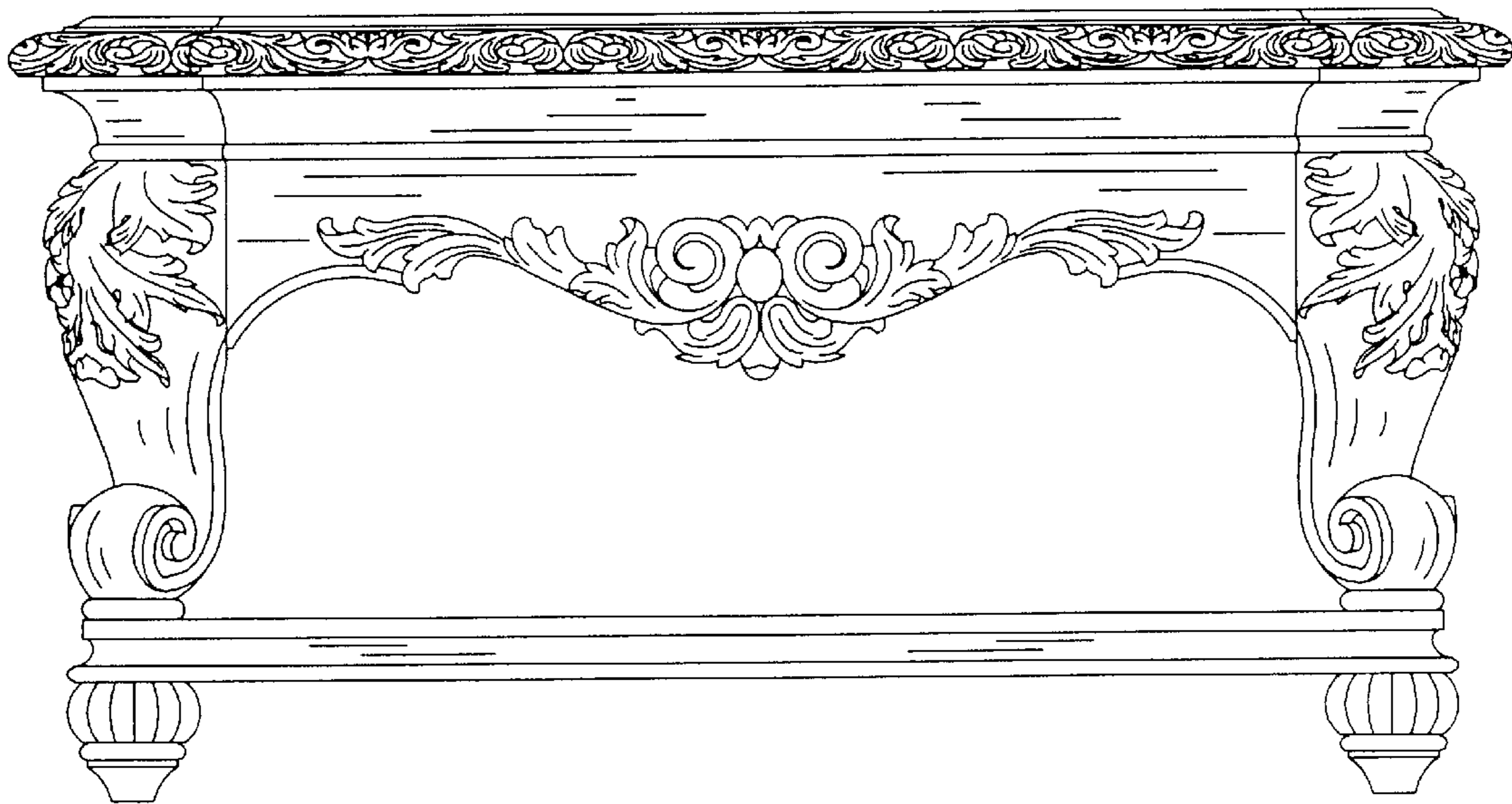

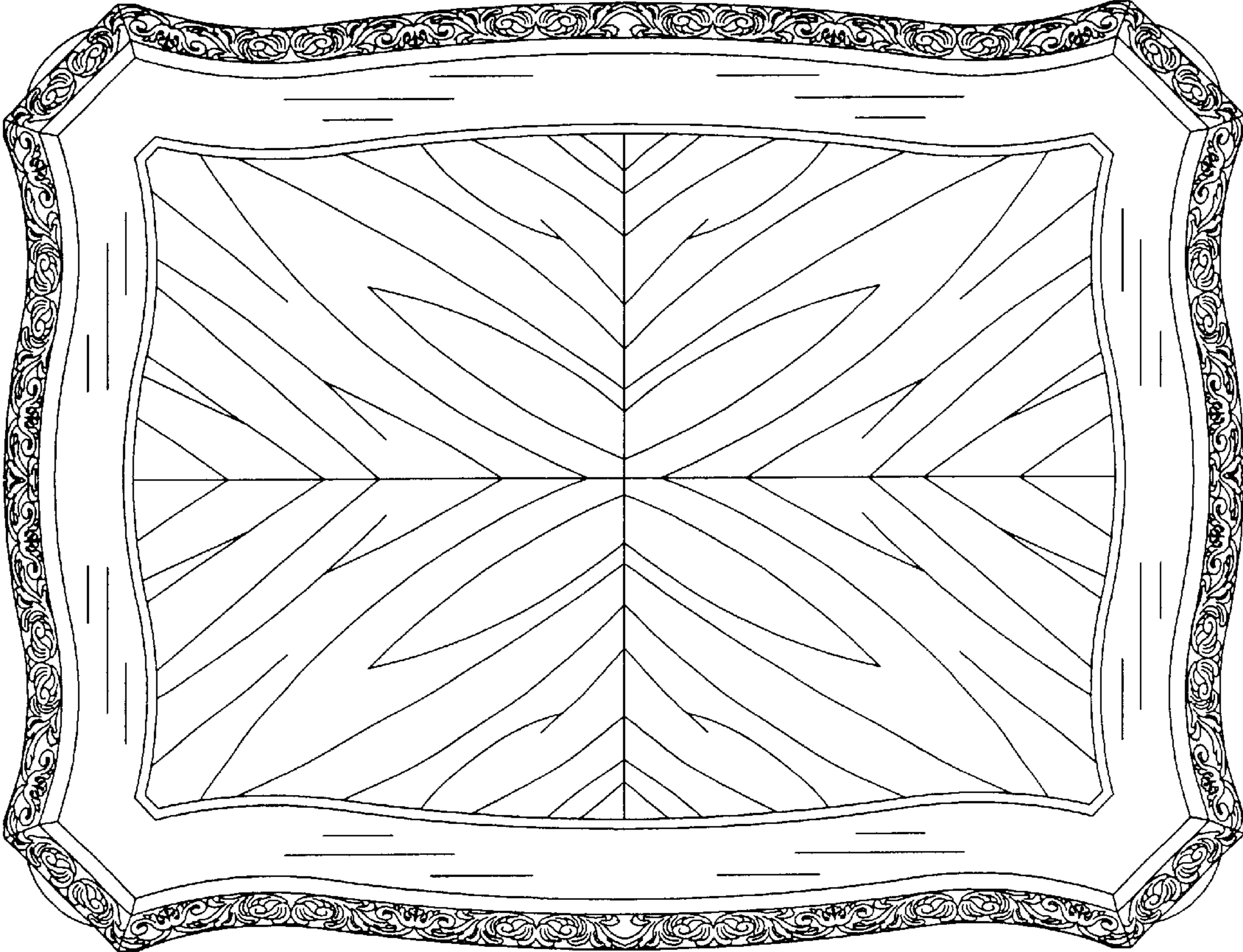
