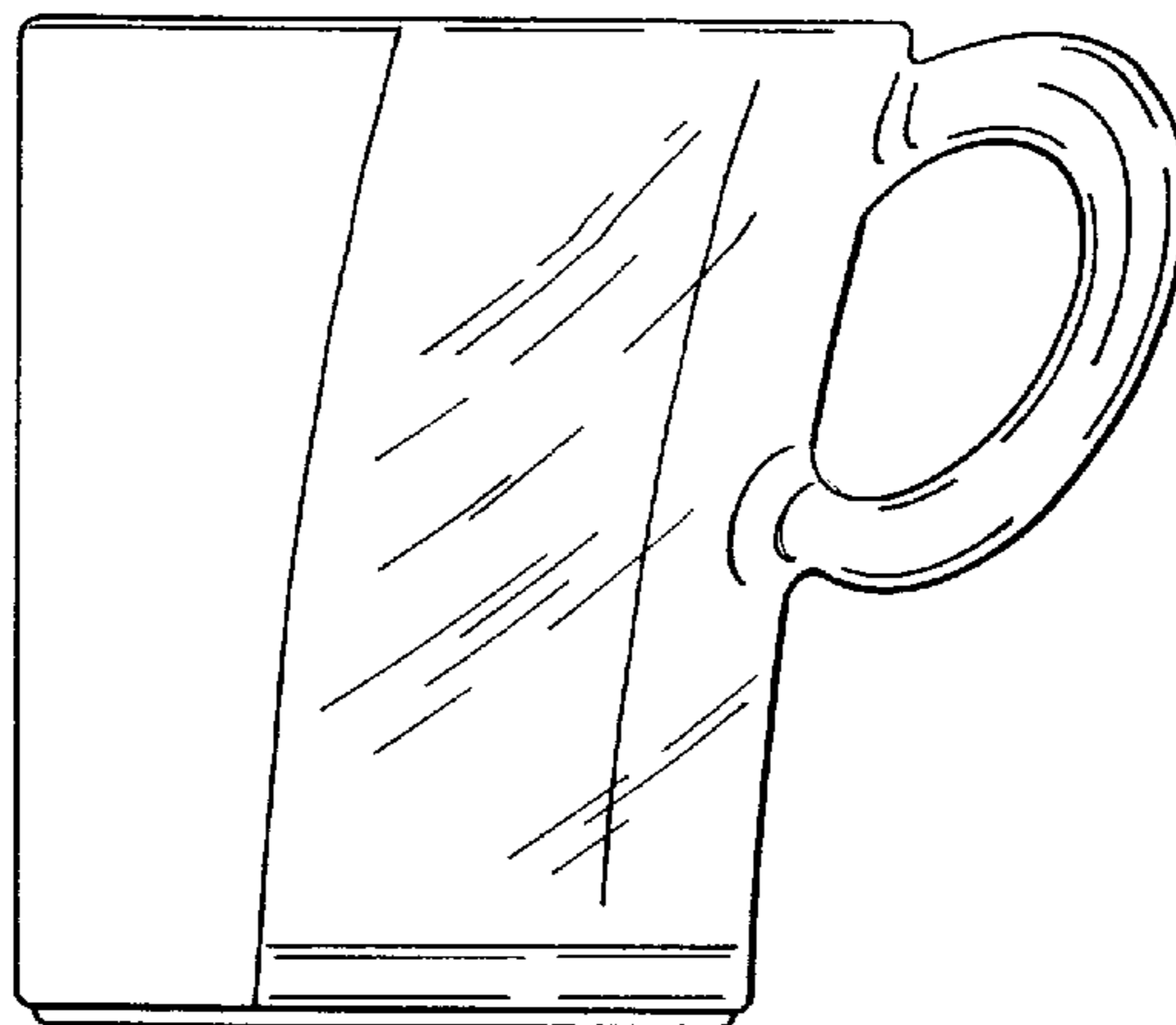
(57) **CLAIM**

We claim the ornamental design for a cup, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a cup showing our new design.
FIG. 2 is a front elevational view of the cup shown in FIG. 1.
FIG. 3 is a rear elevational view of the cup shown in FIG. 1 and FIG. 2.
FIG. 4 is a side elevational view of the cup shown in FIG. 1, FIG. 2, and FIG. 3.
FIG. 5 is another side elevational view of the cup shown in FIG. 1, FIG. 2, FIG. 3, and FIG. 4.
FIG. 6 is a top elevational view of the cup shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, and FIG. 5; and,
FIG. 7 is a bottom elevational view of the cup shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, FIG. 5, and FIG. 6.

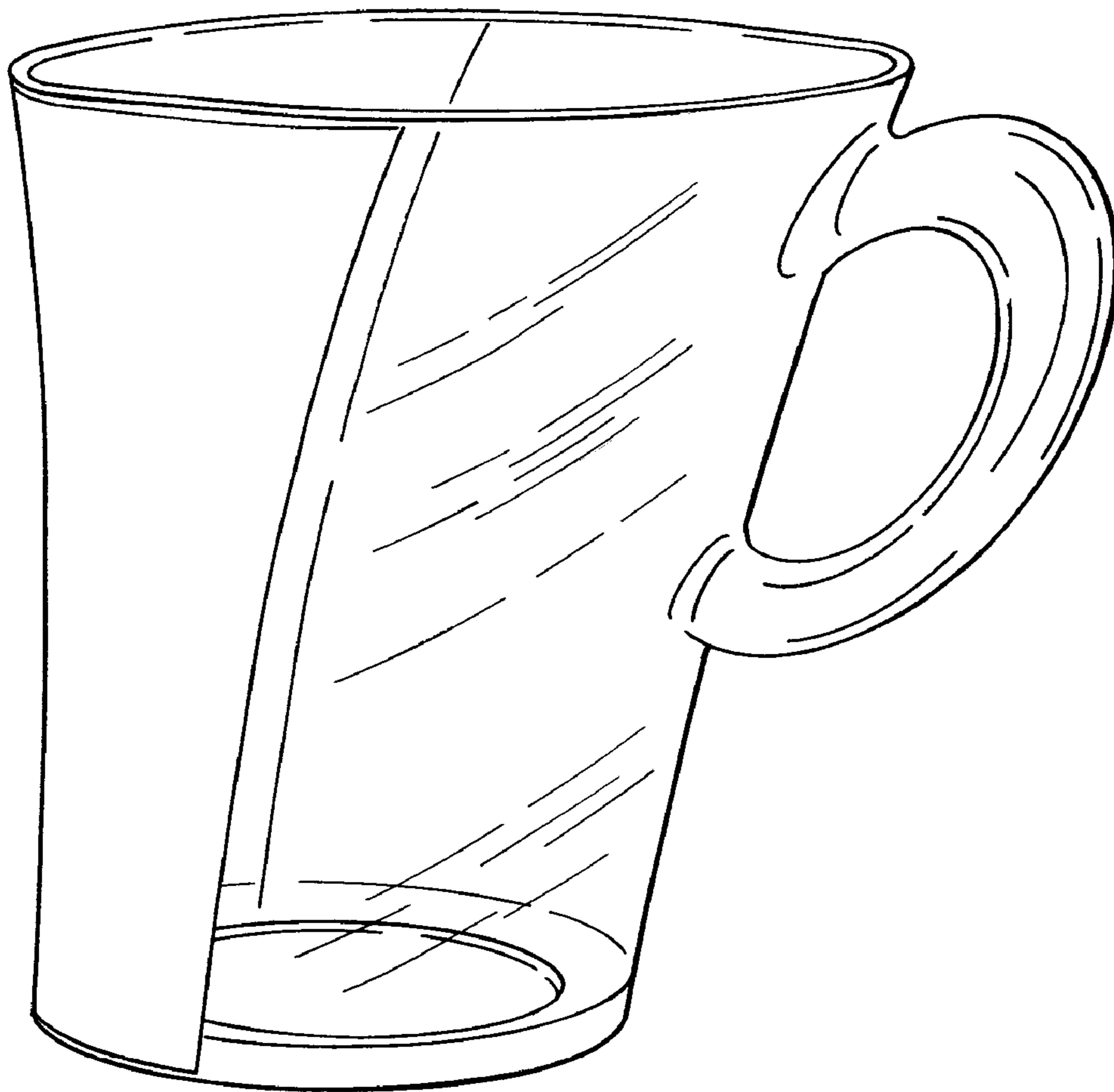

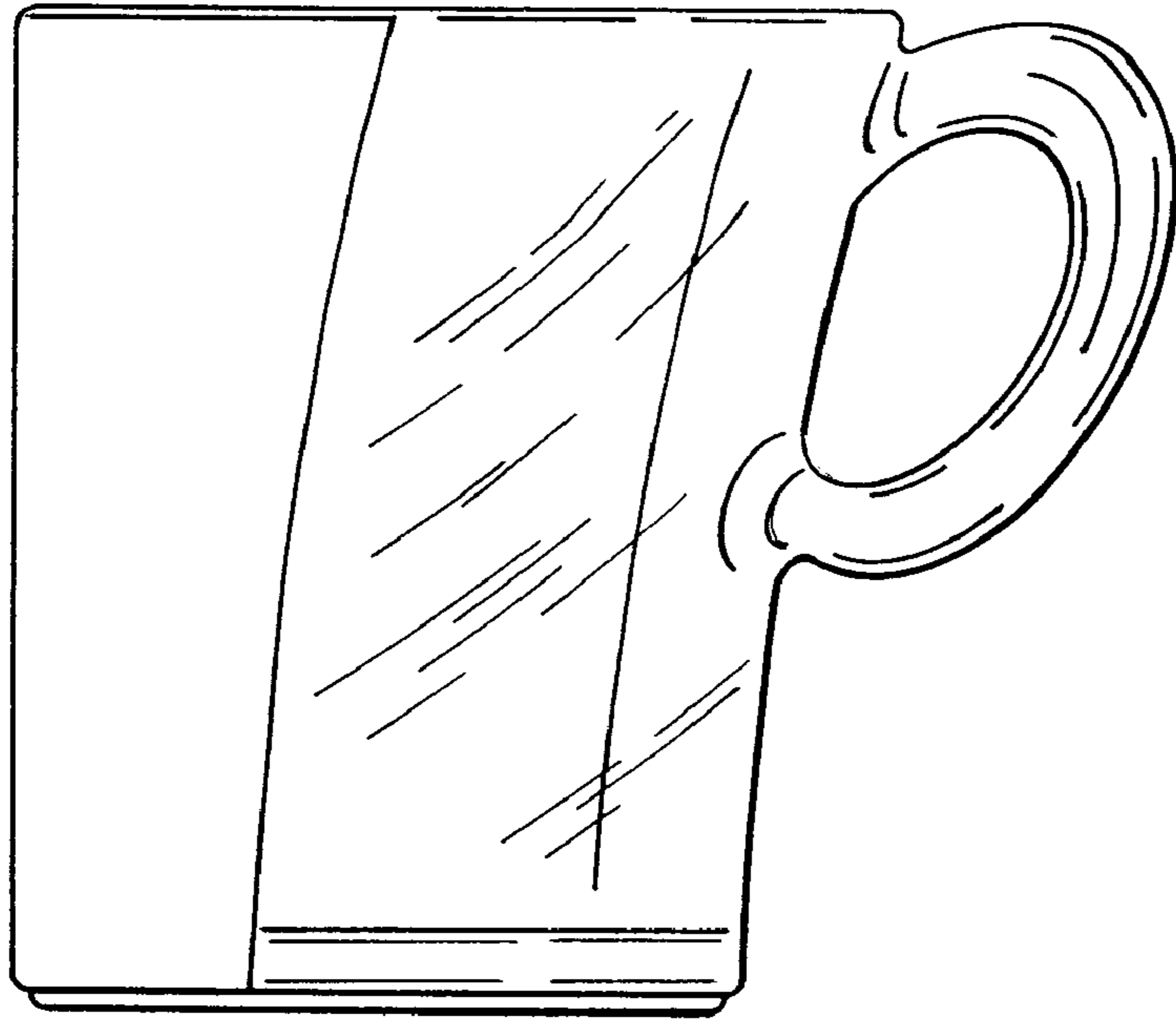

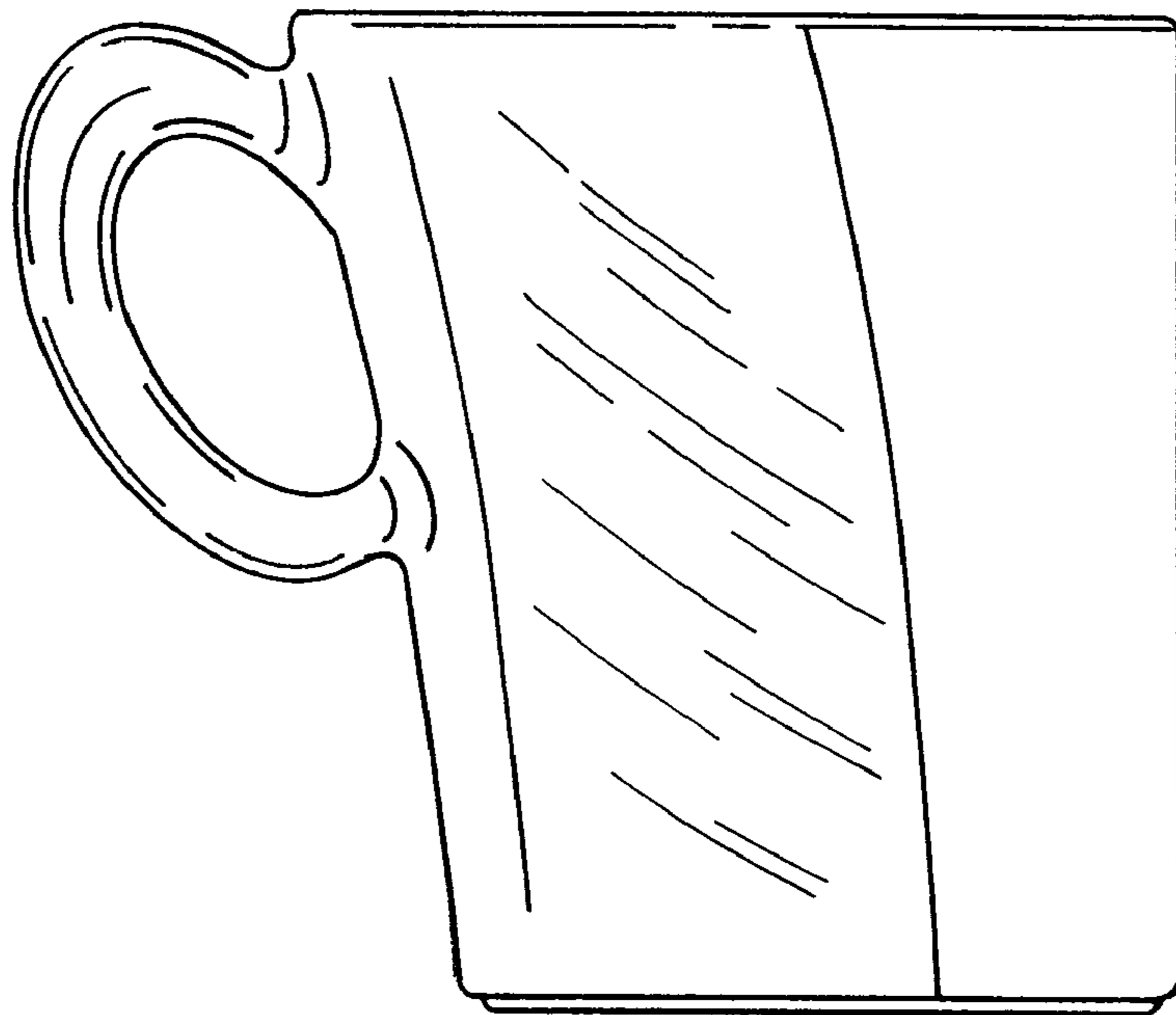

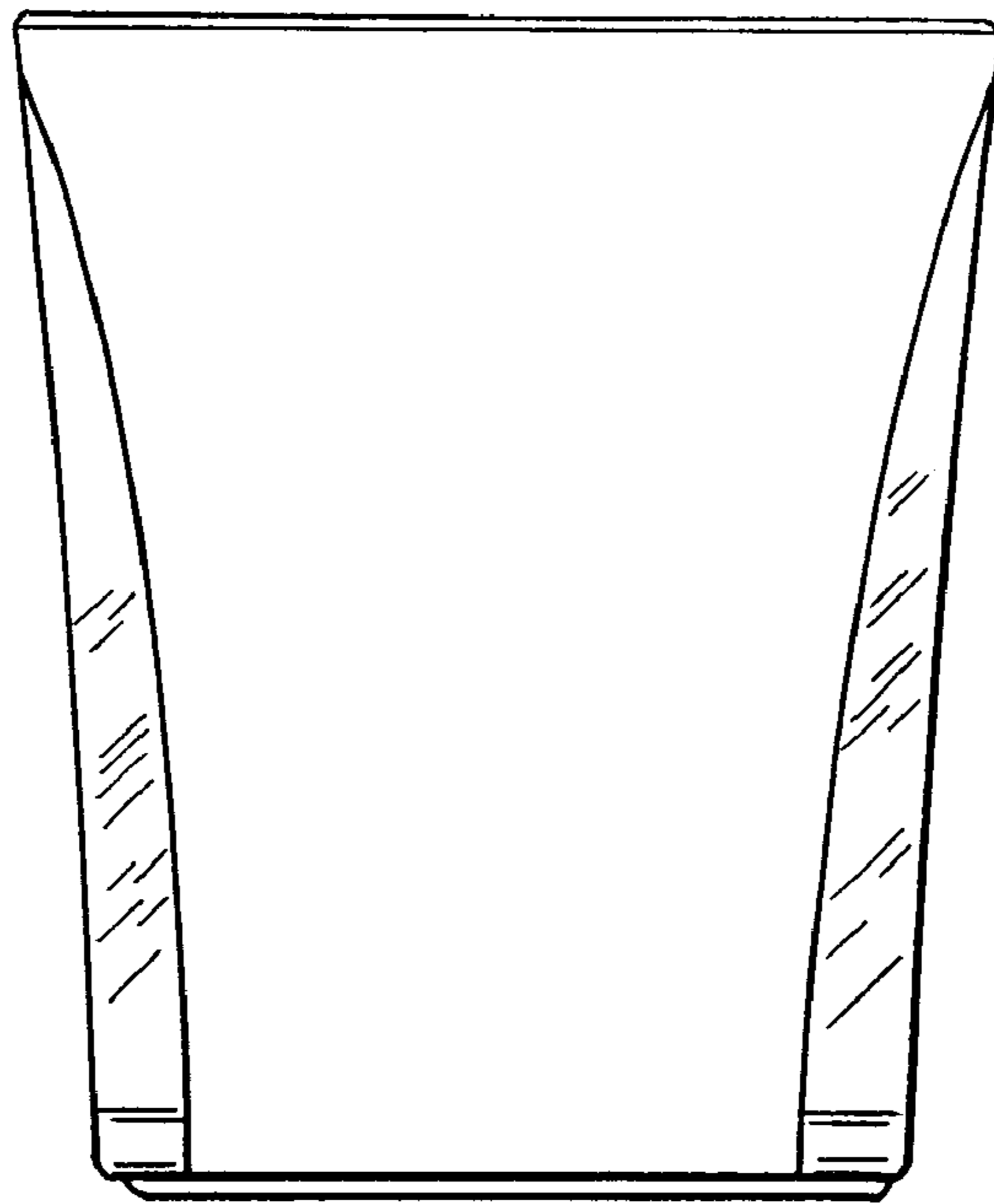

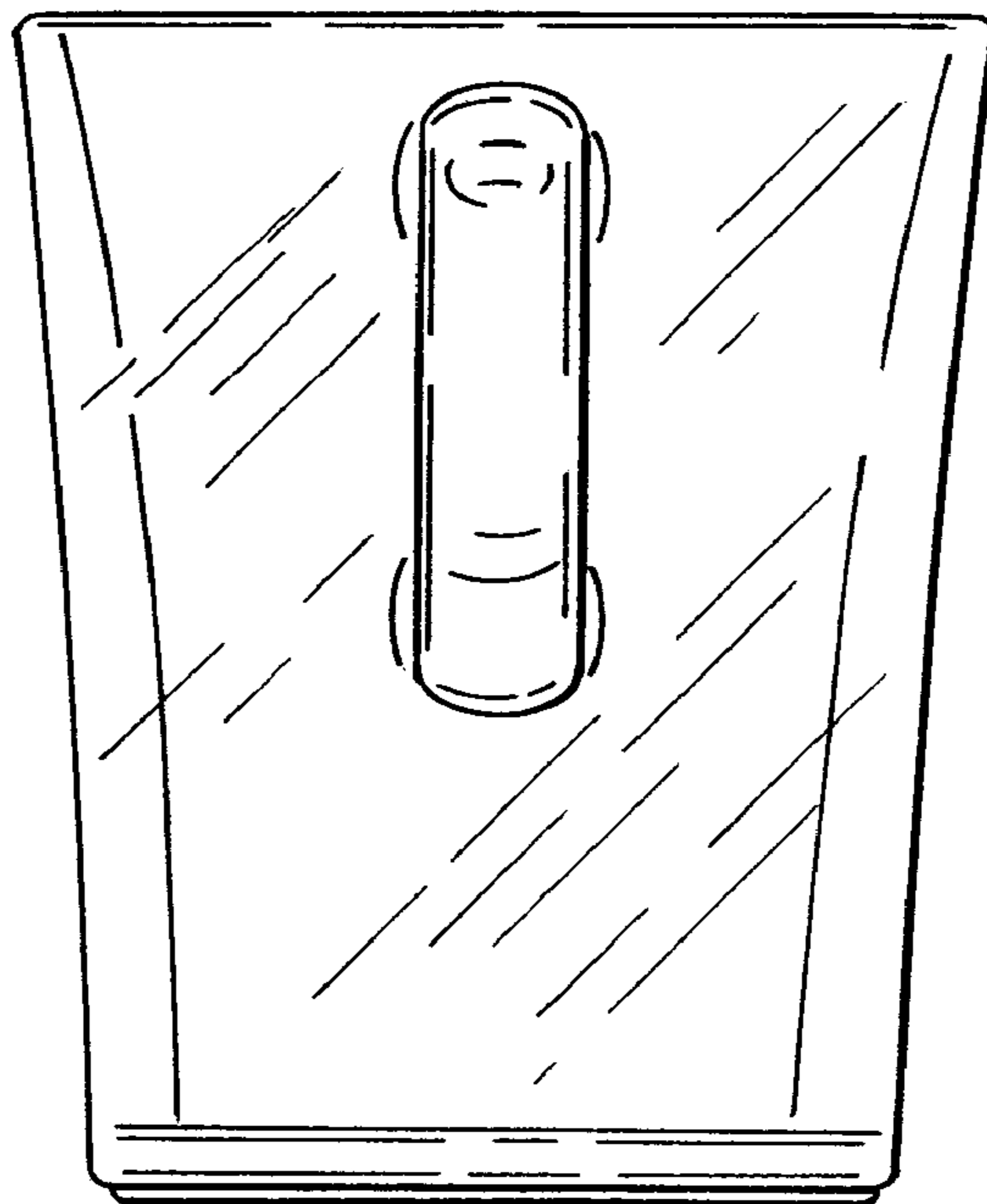

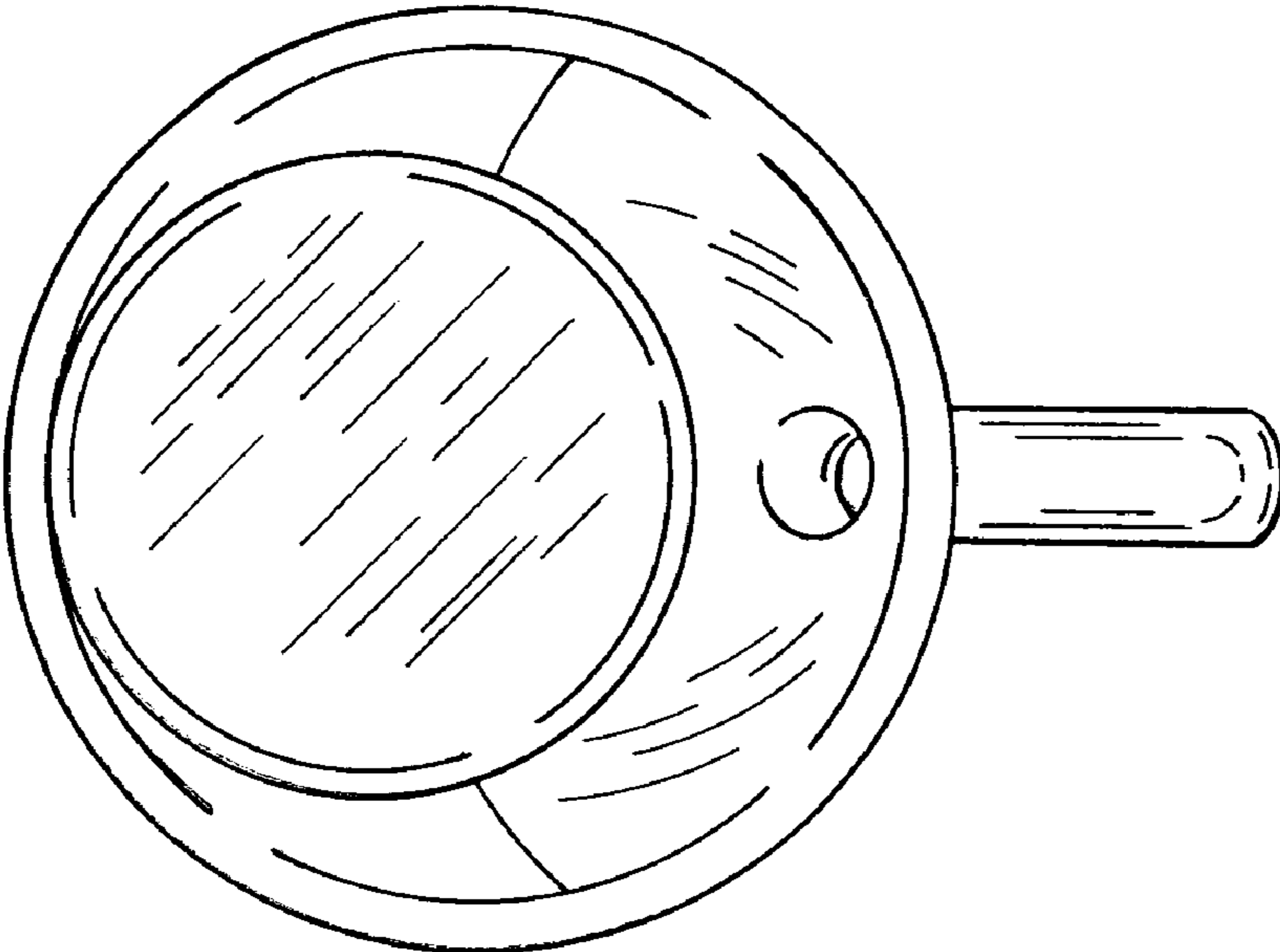

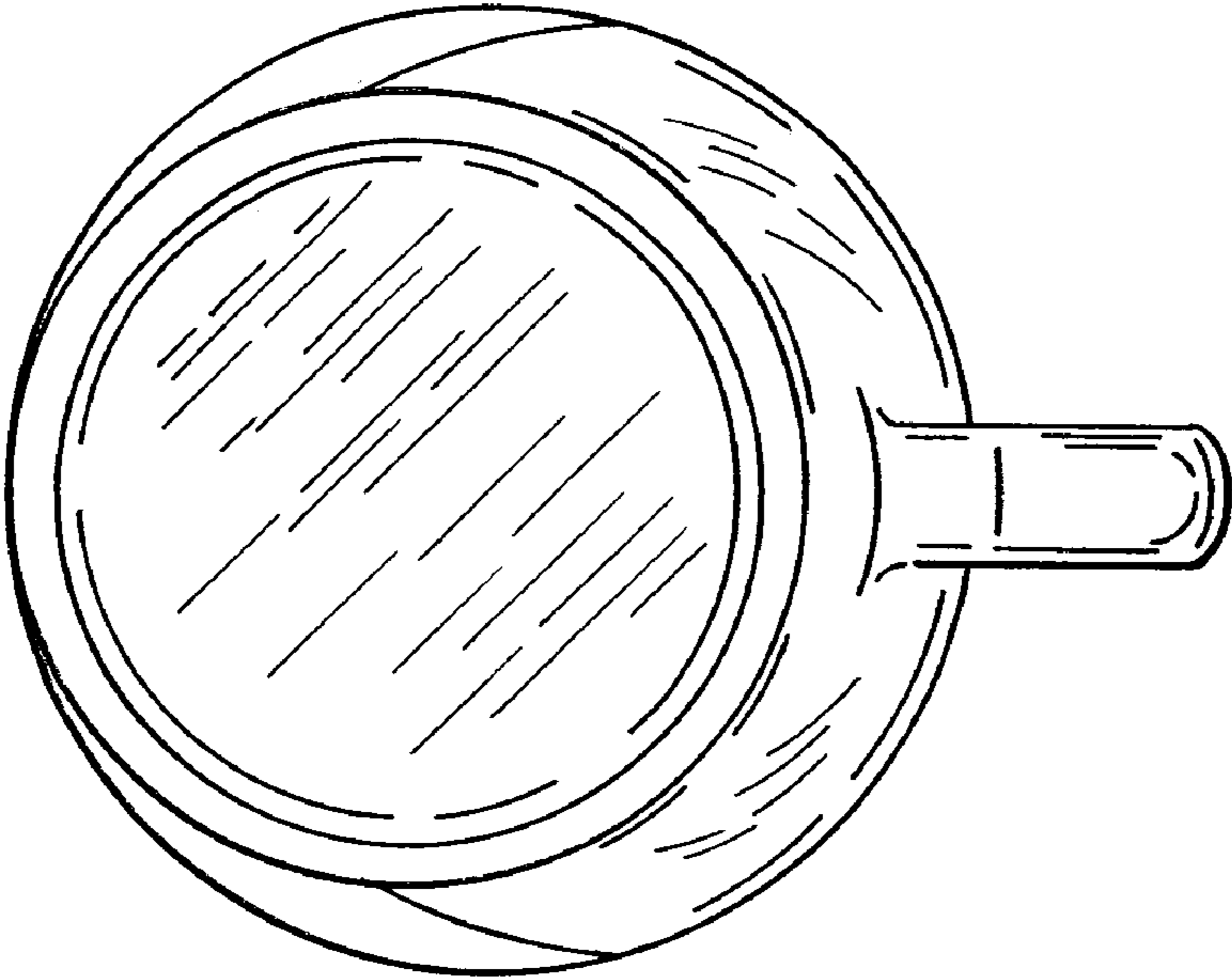
