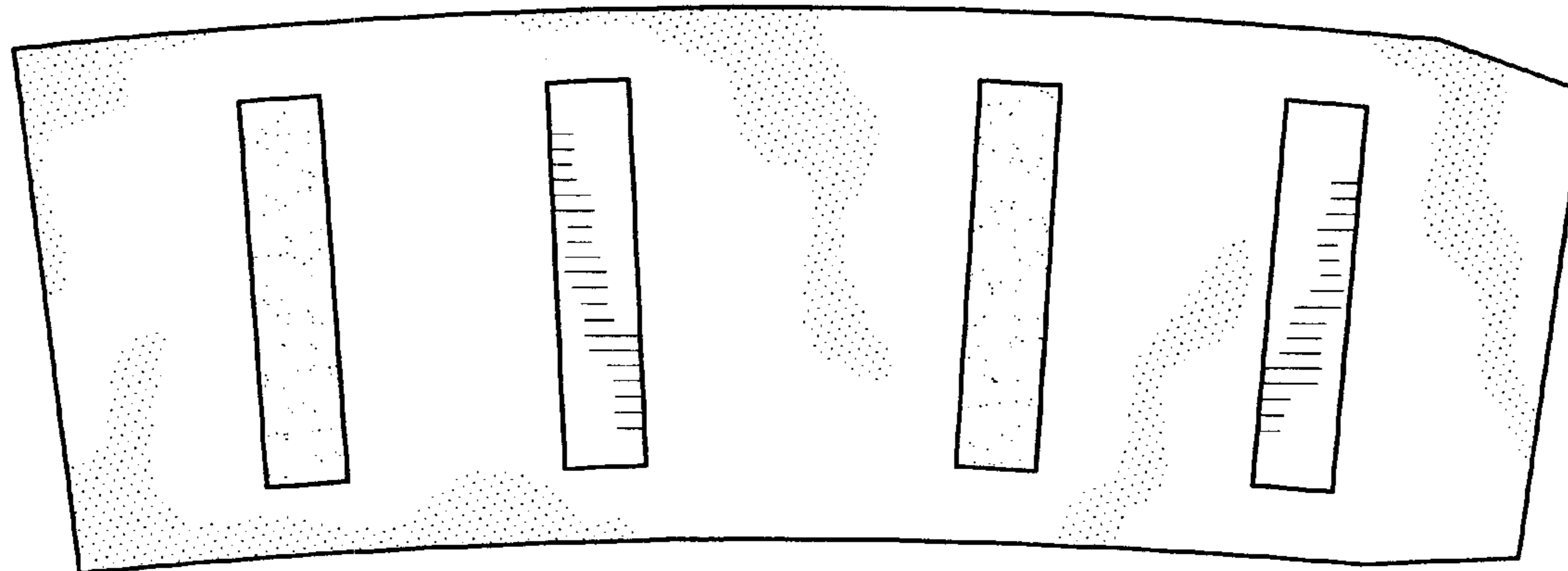
(57) **CLAIM**

The ornamental design for a adhesively affixed holder for supporting a food/drink container, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of a adhesively affixed holder for supporting a food/drink container showing my new design;

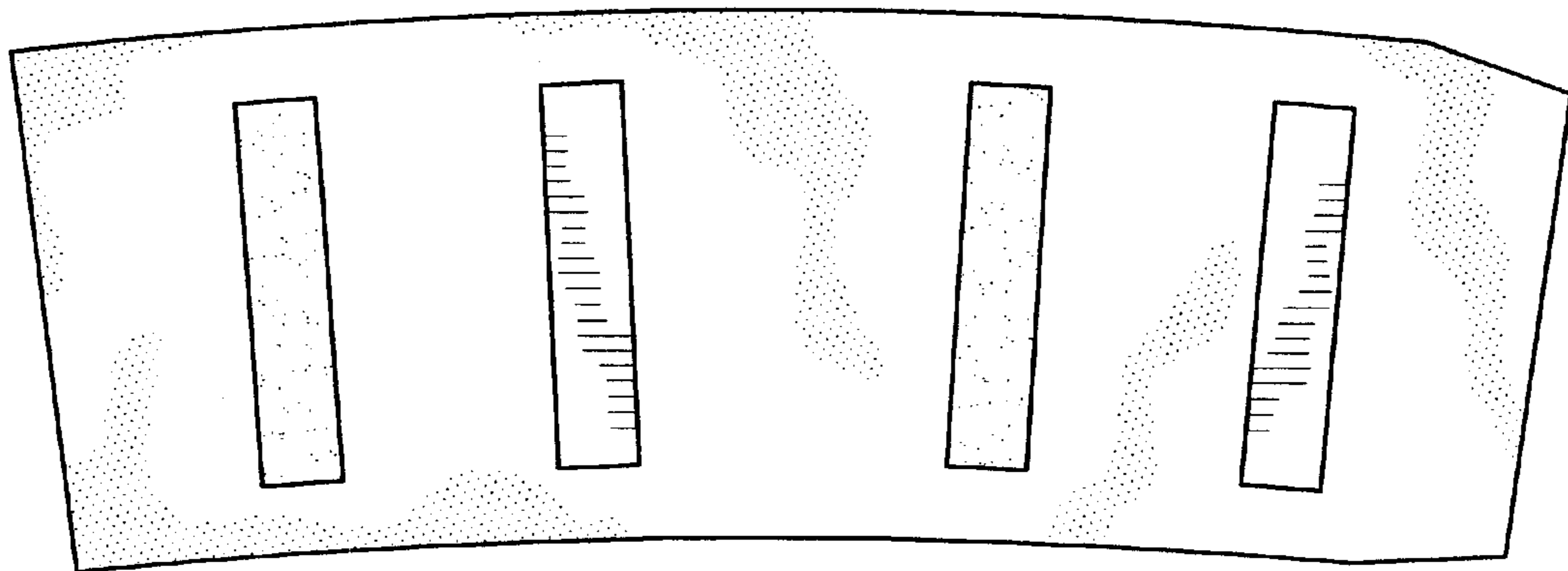

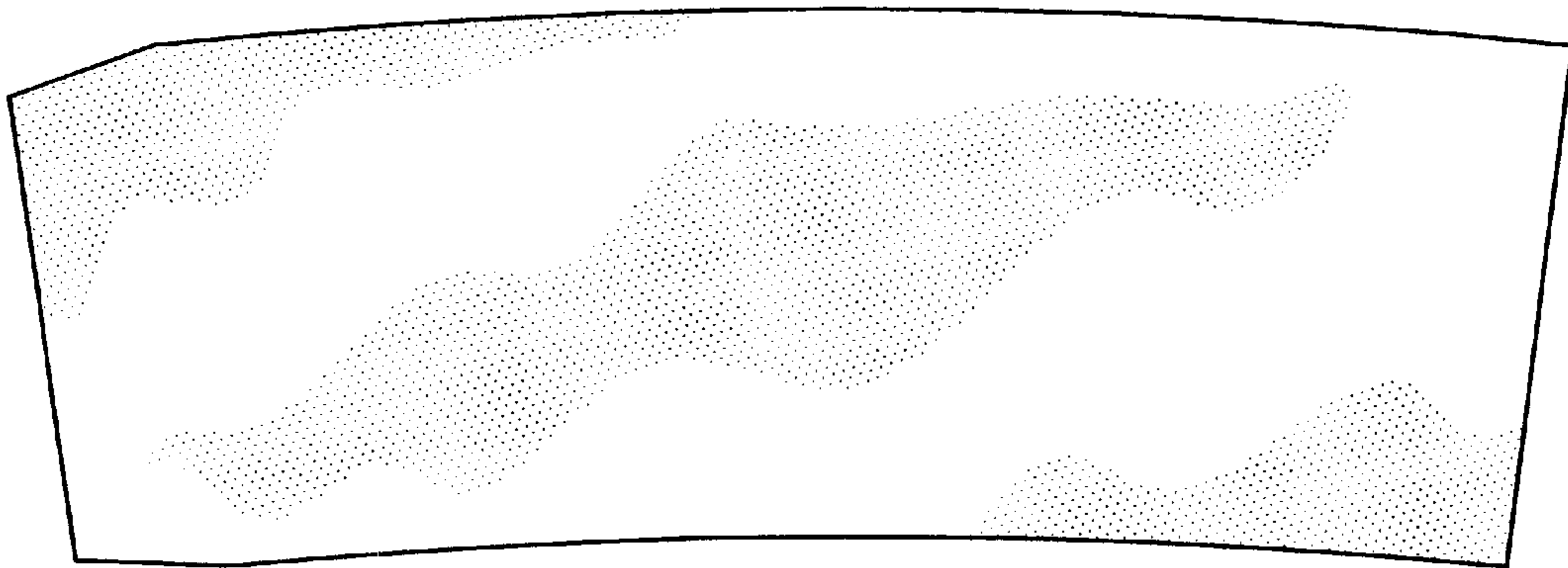

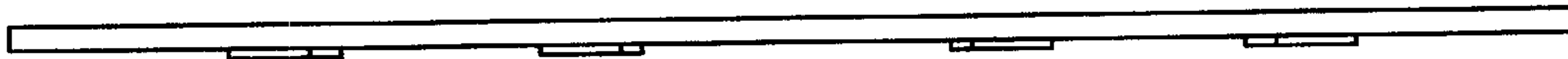

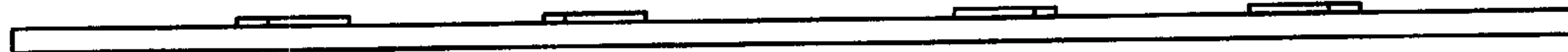
