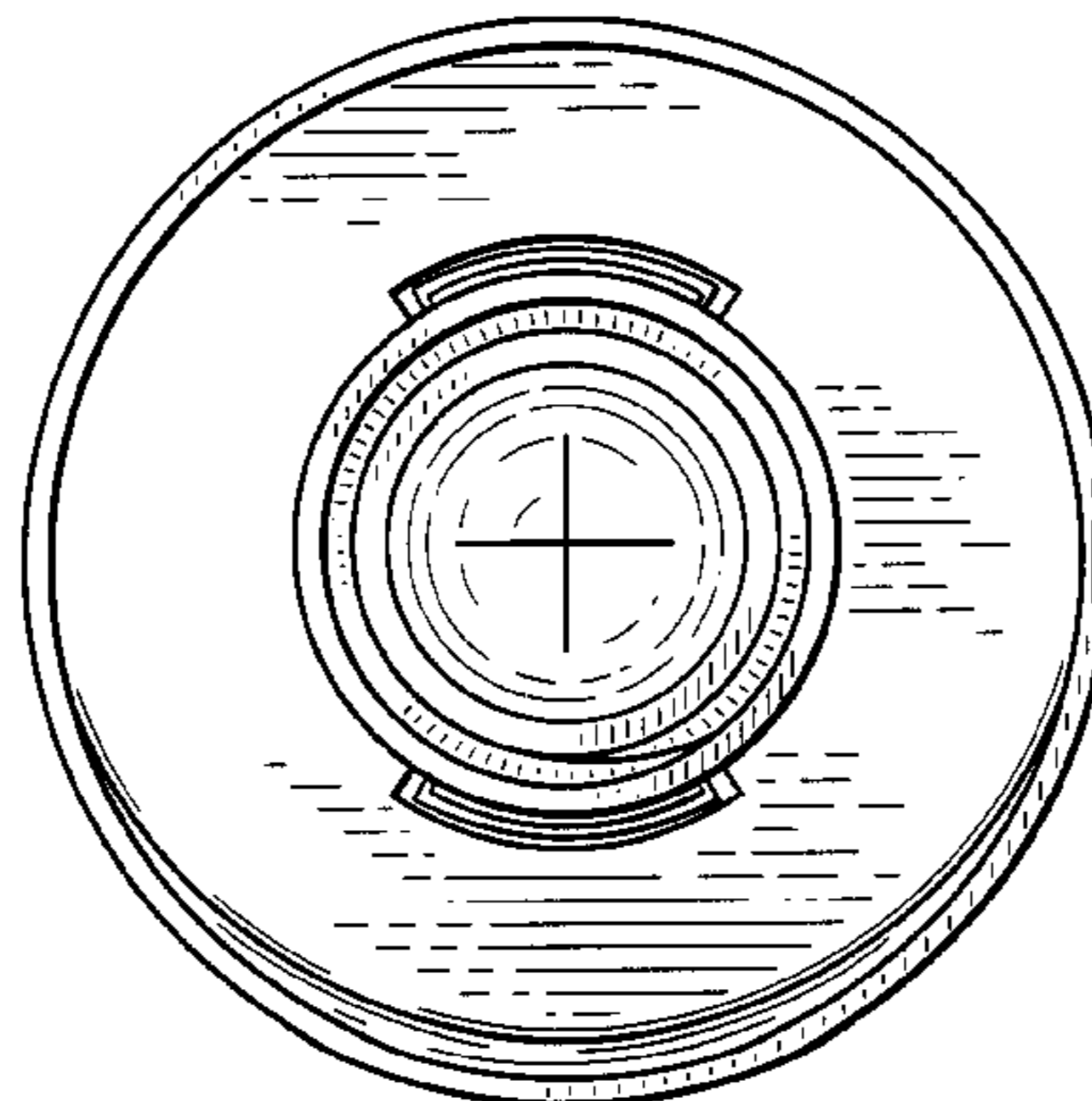
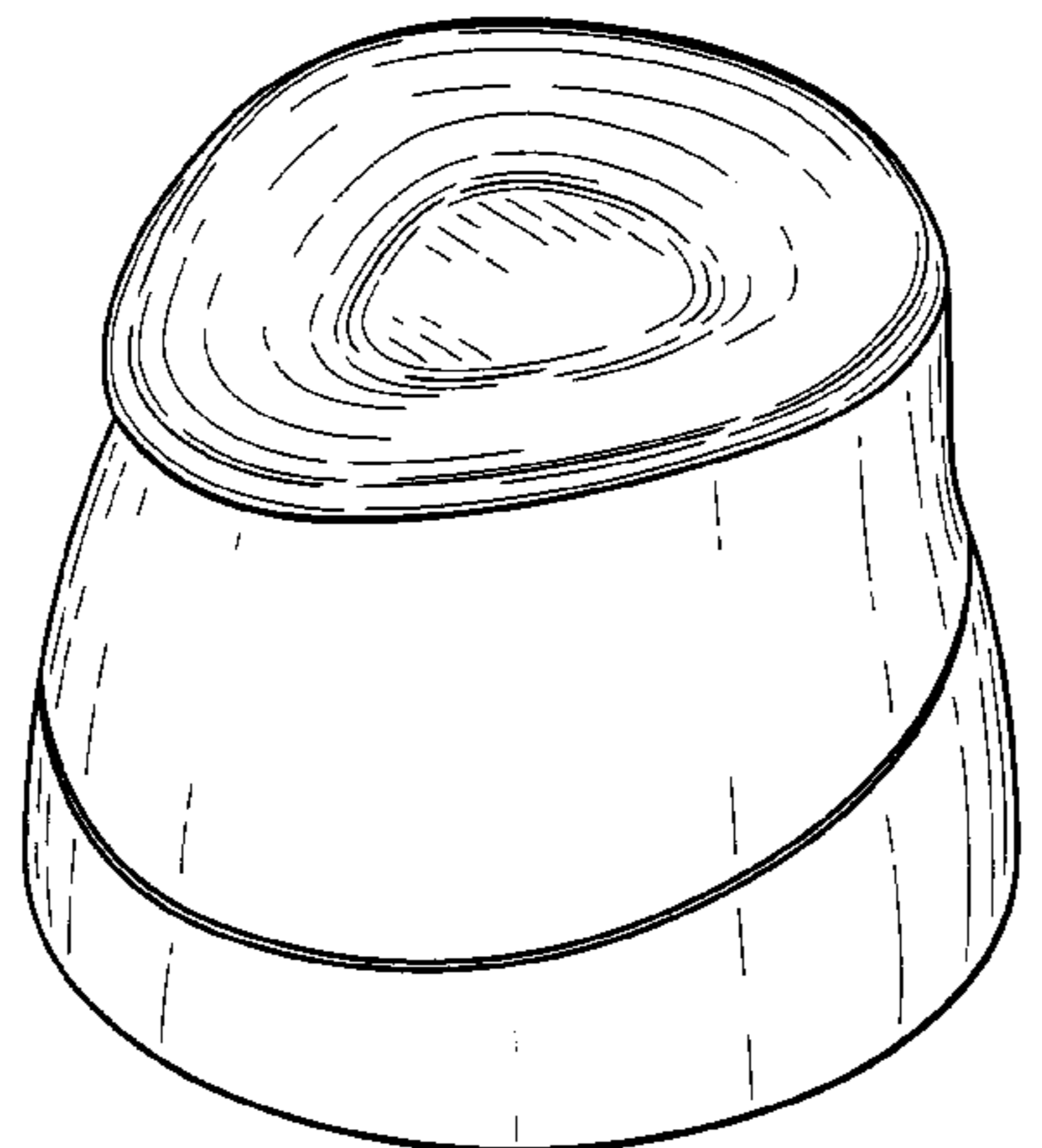
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the closure of our design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof, the left side elevation being a mirror image;
FIG. 5 is a top plan view thereof; and,

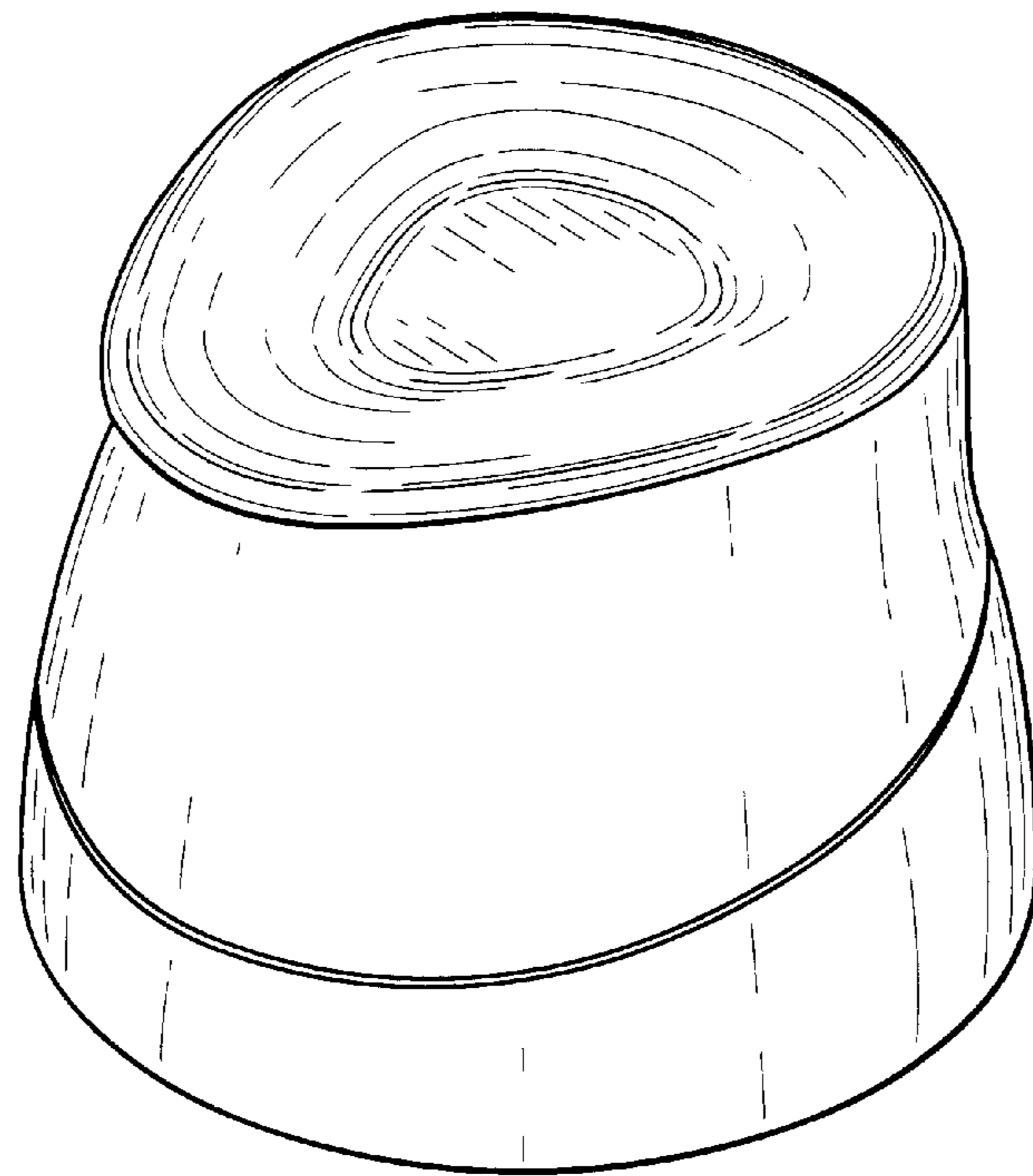

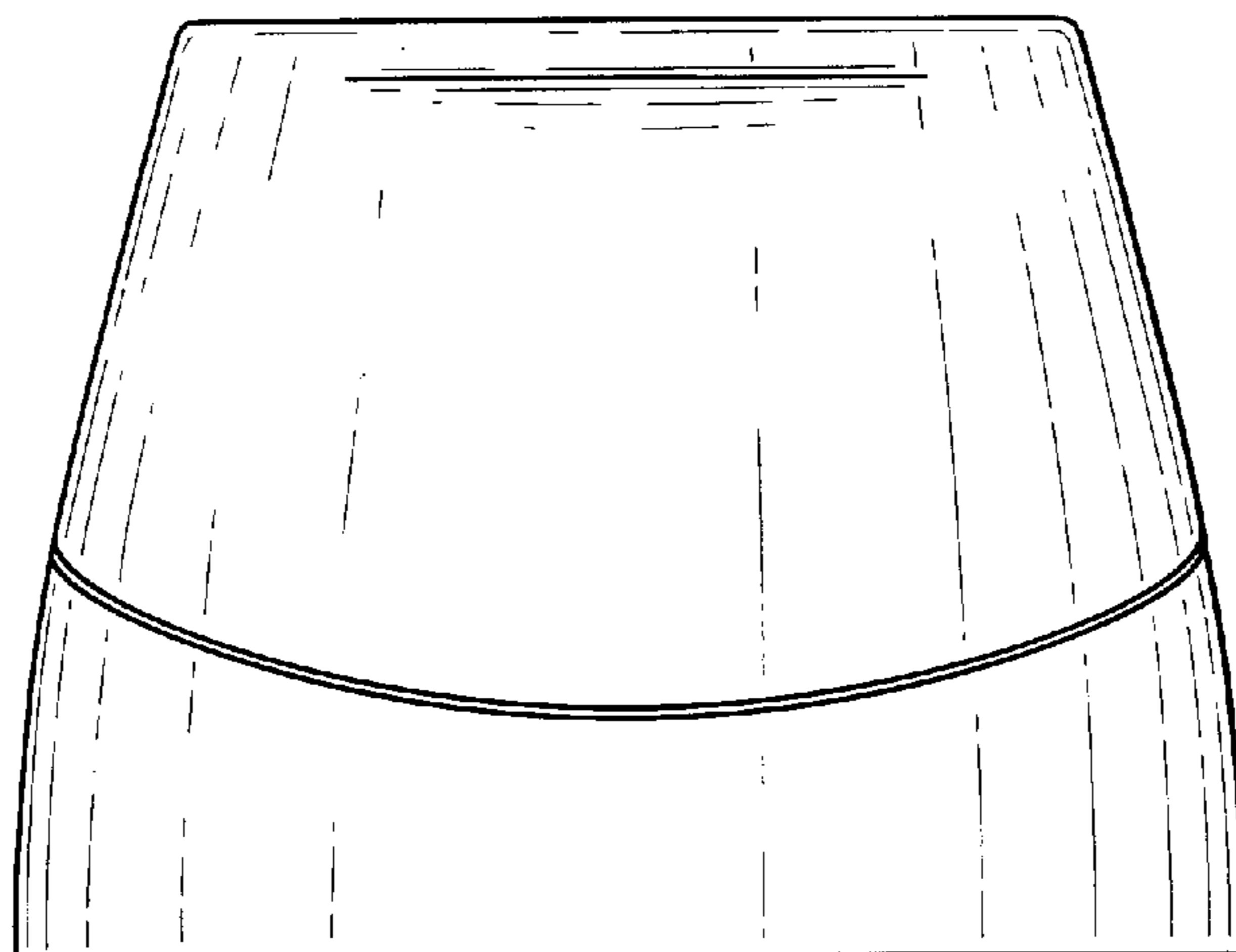

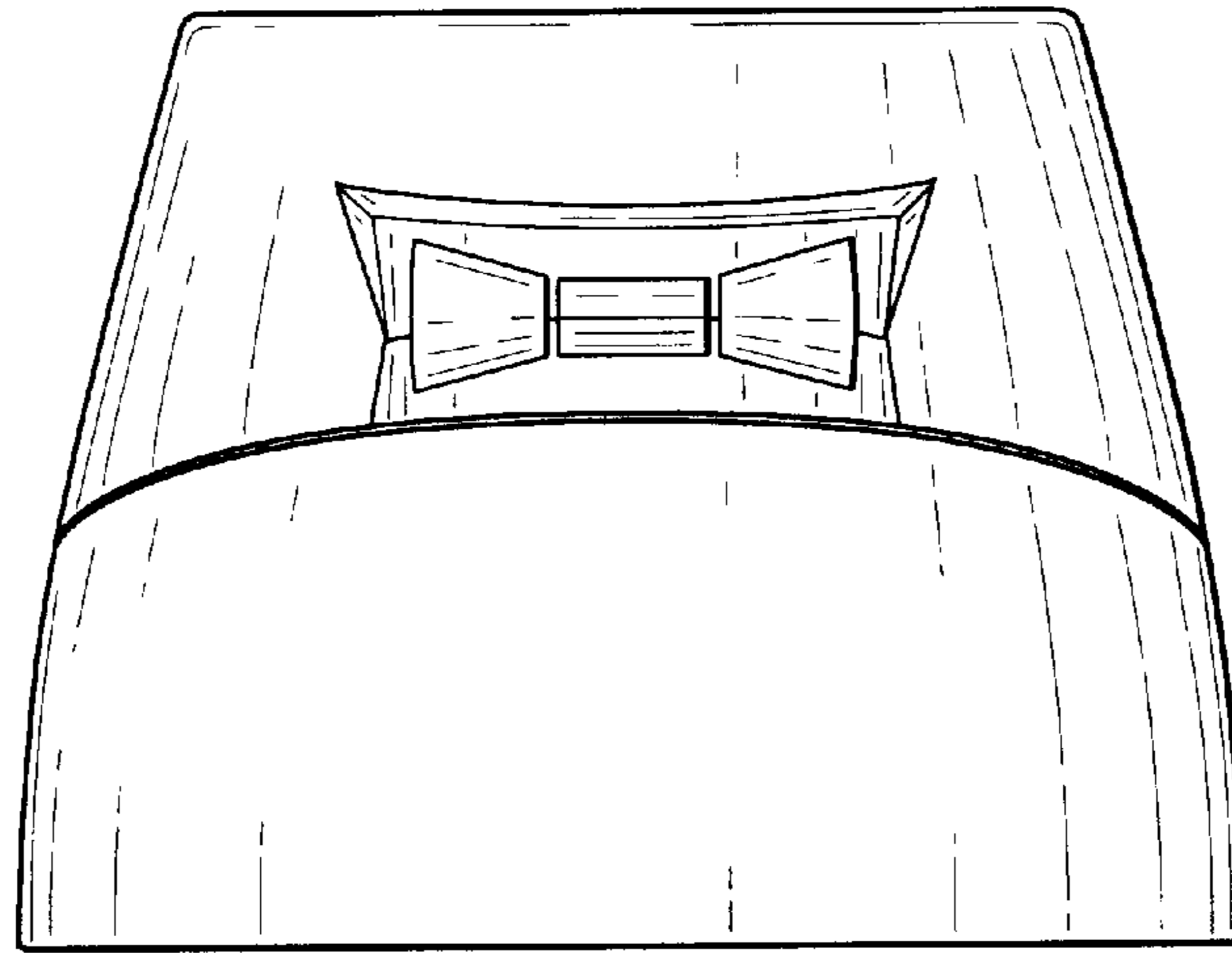

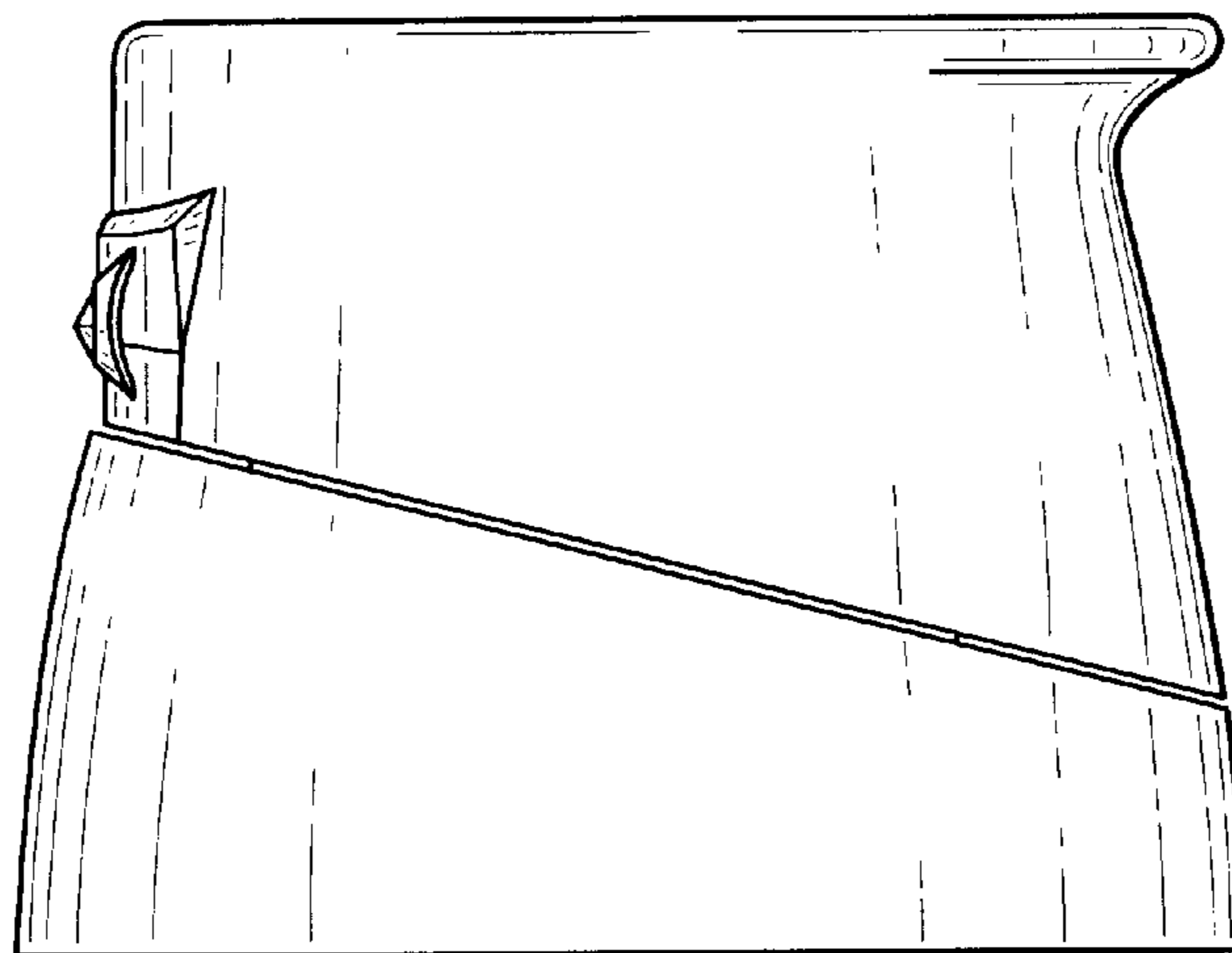

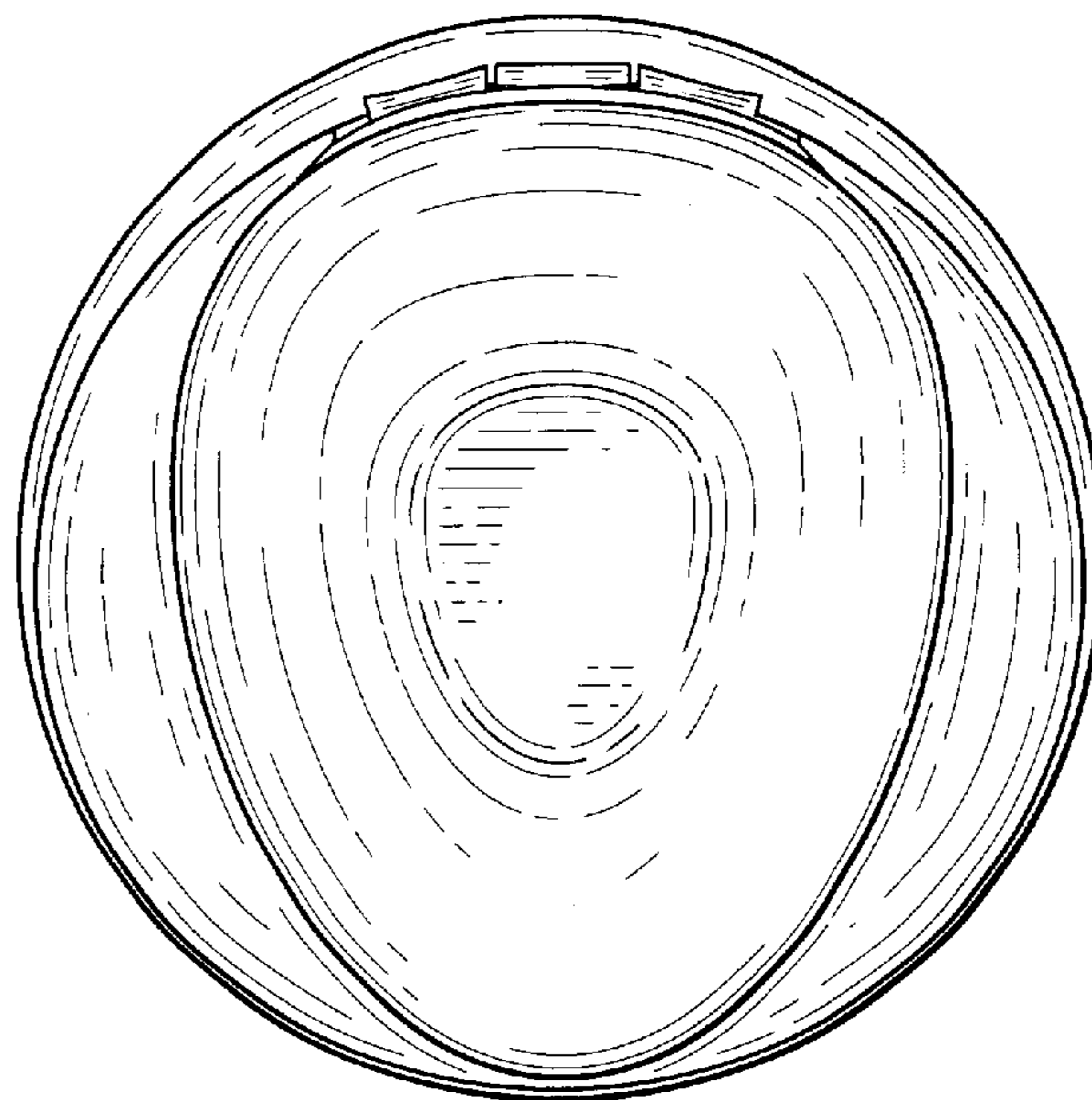

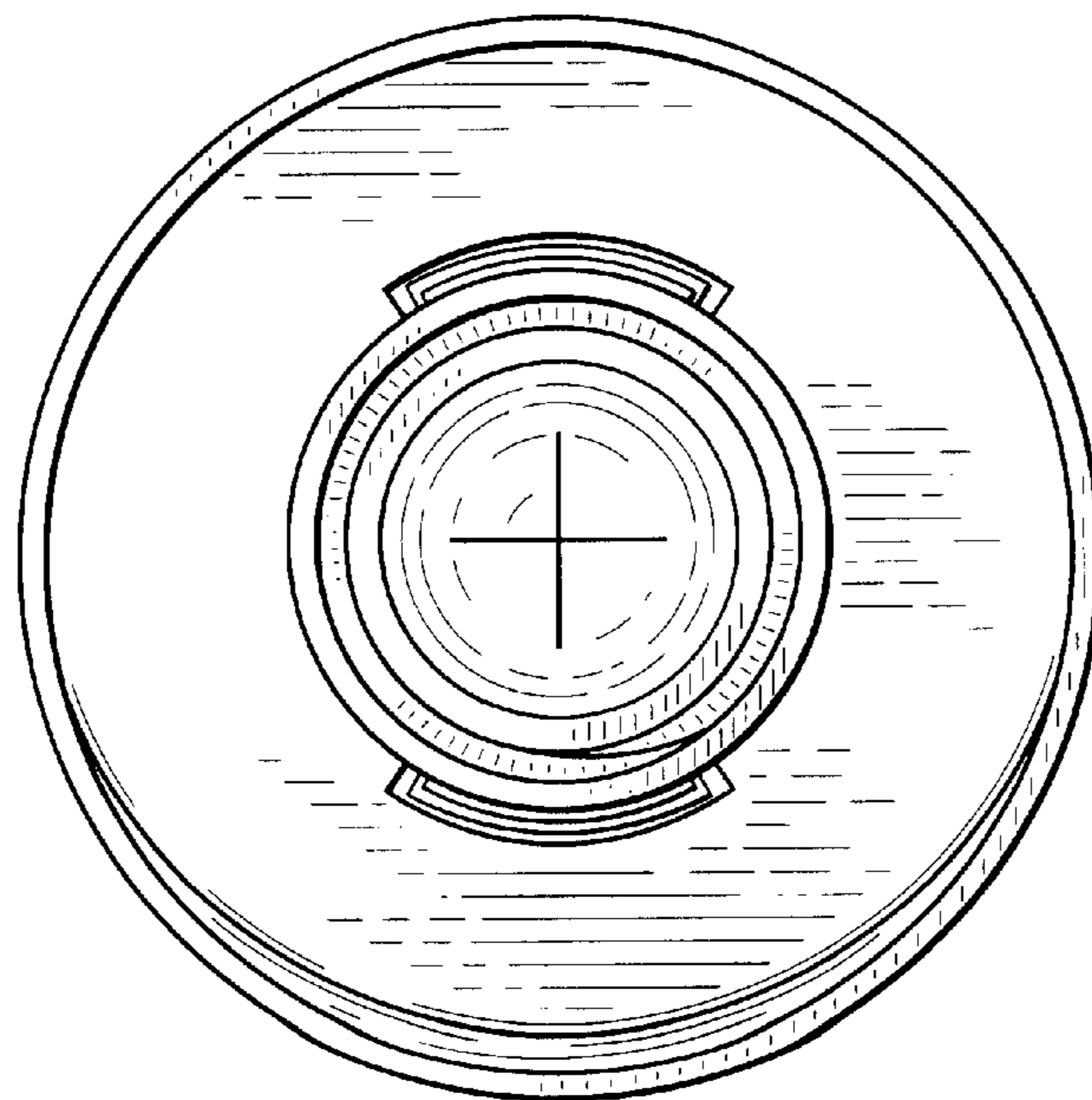
