FIG. 13 is a top plan view of the stacked vampire fangs coffins of FIG. 8;
FIG. 14 is a bottom plan view of the stacked vampire fangs coffins of FIG. 8;
FIG. 15 is a perspective view of a third embodiment of a vampire fangs coffin in a stacked position;
FIG. 16 is a left side elevation view of the stacked vampire fangs coffins of FIG. 15;
FIG. 17 is a front end elevation view of the stacked vampire fangs coffins of FIG. 15;
FIG. 18 is a rear end elevation view of the stacked vampire fangs coffins of FIG. 15;
FIG. 19 is a perspective view of FIG. 15 with the lid removed.

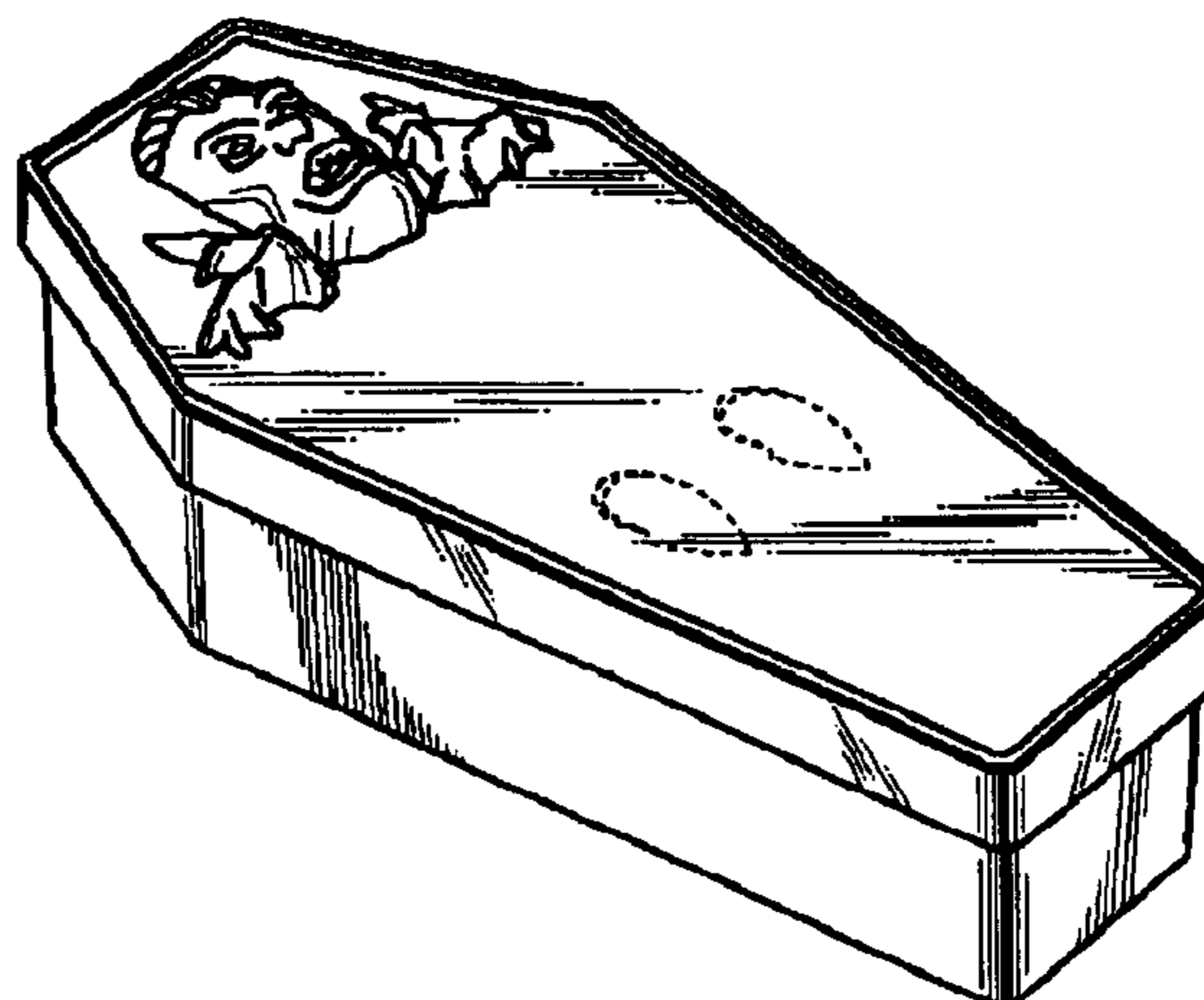

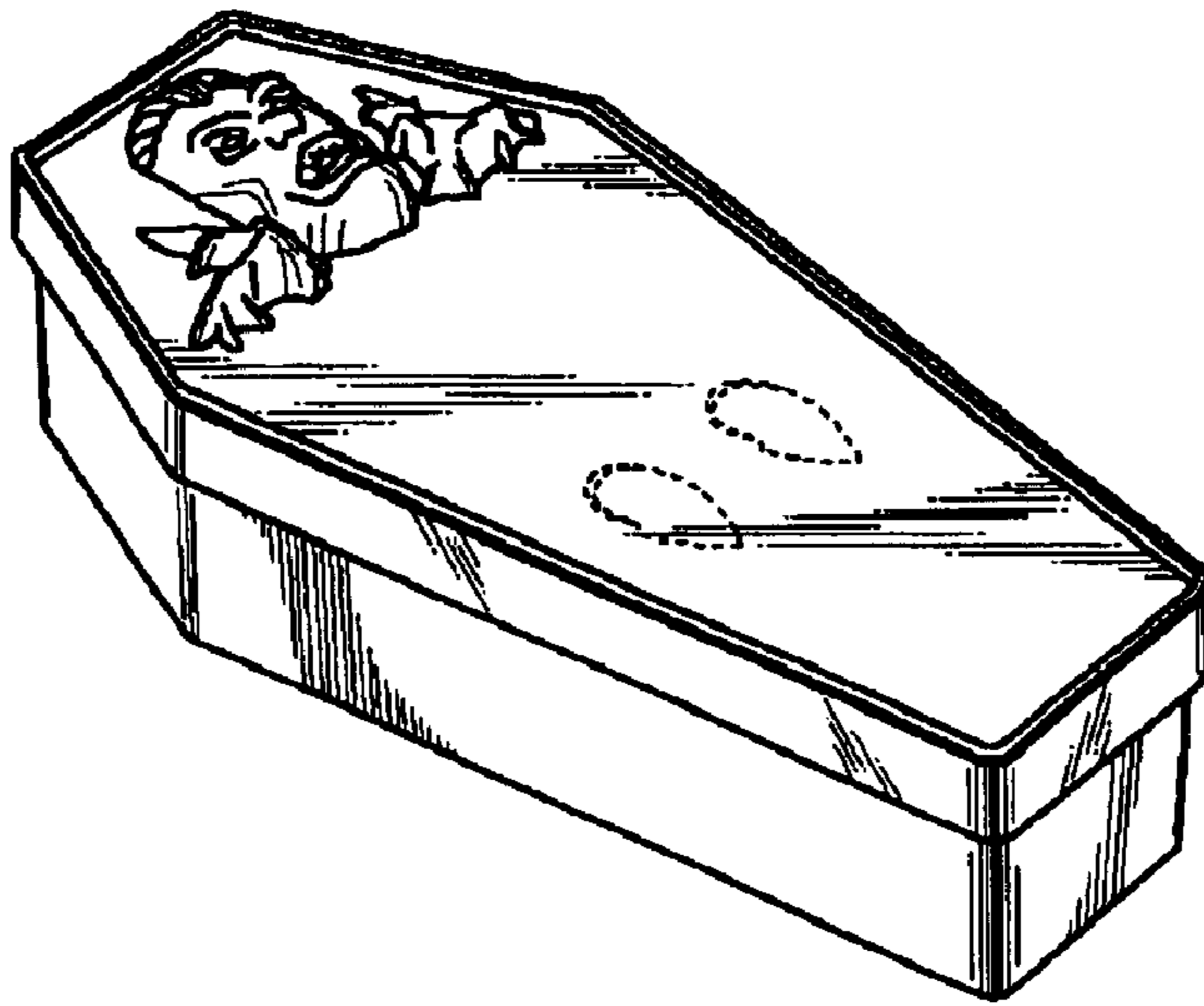

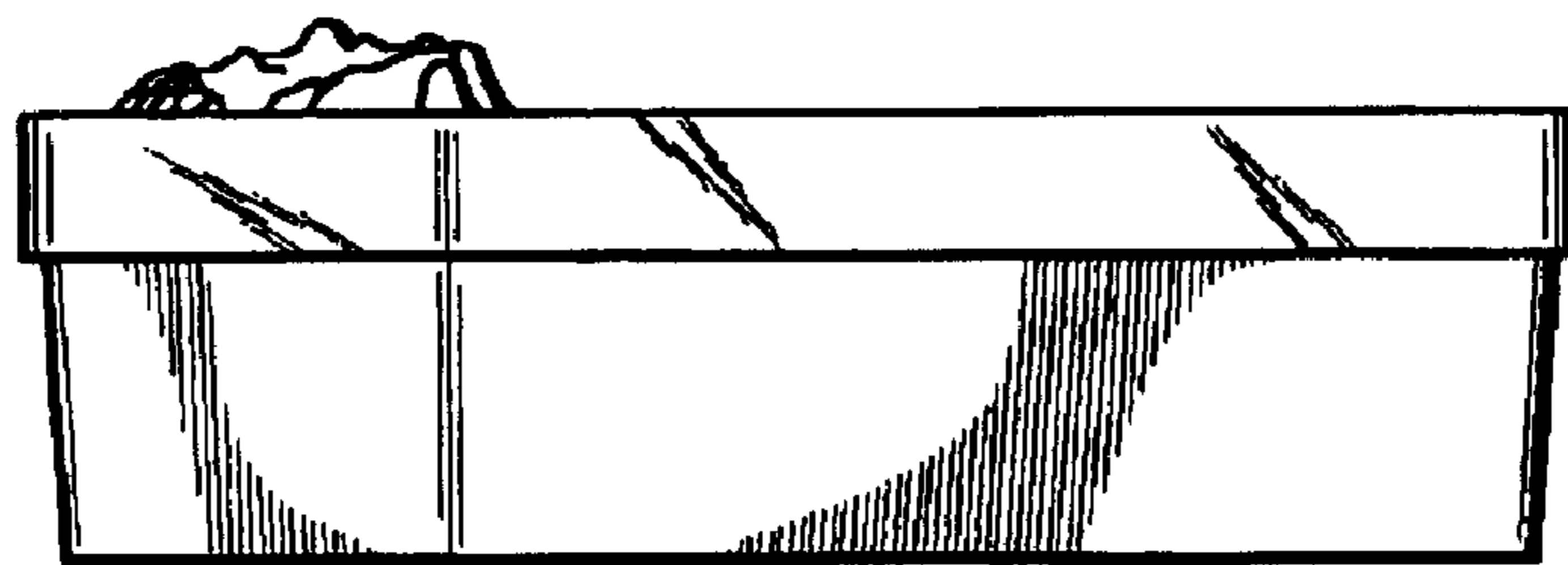

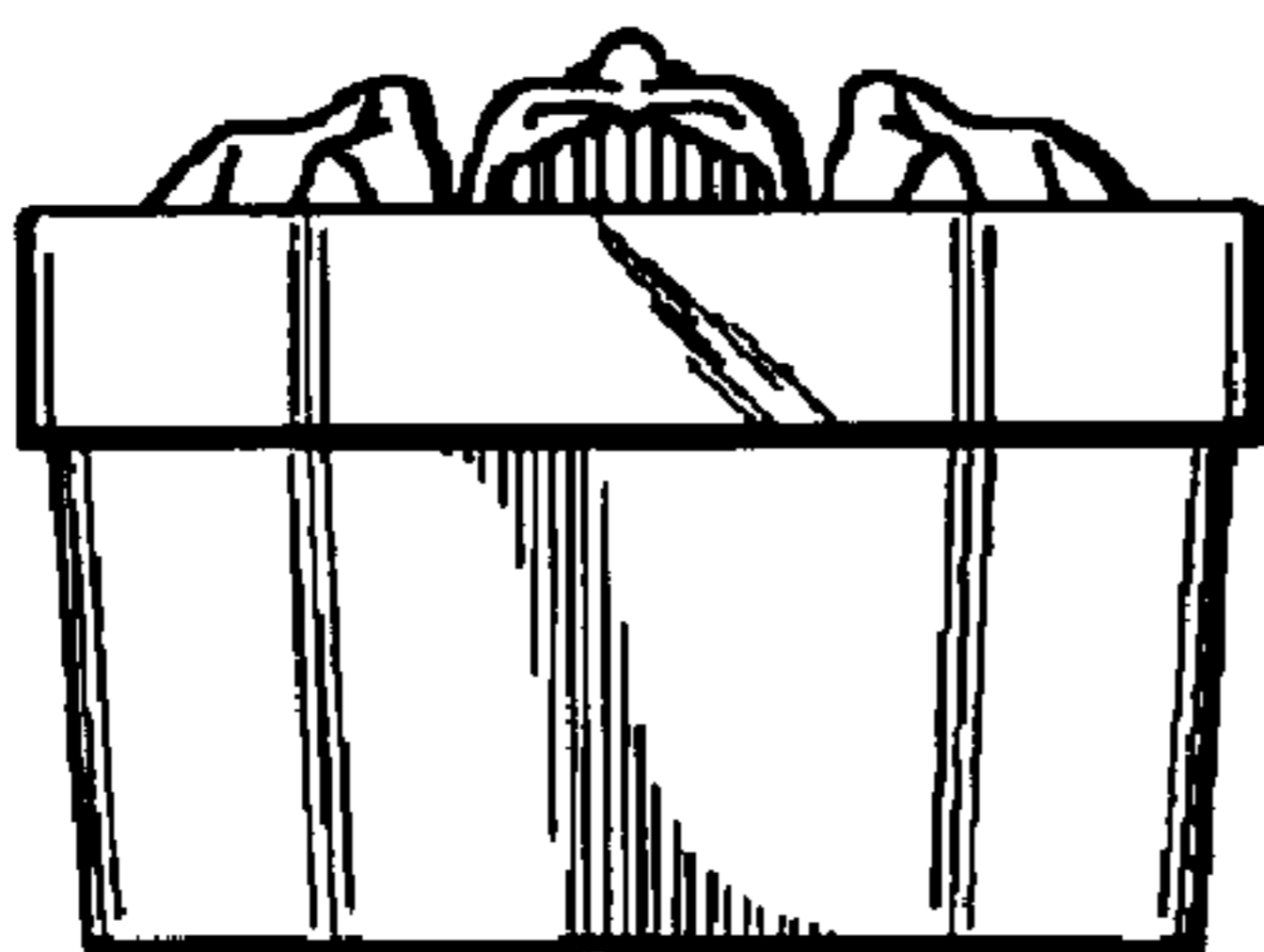

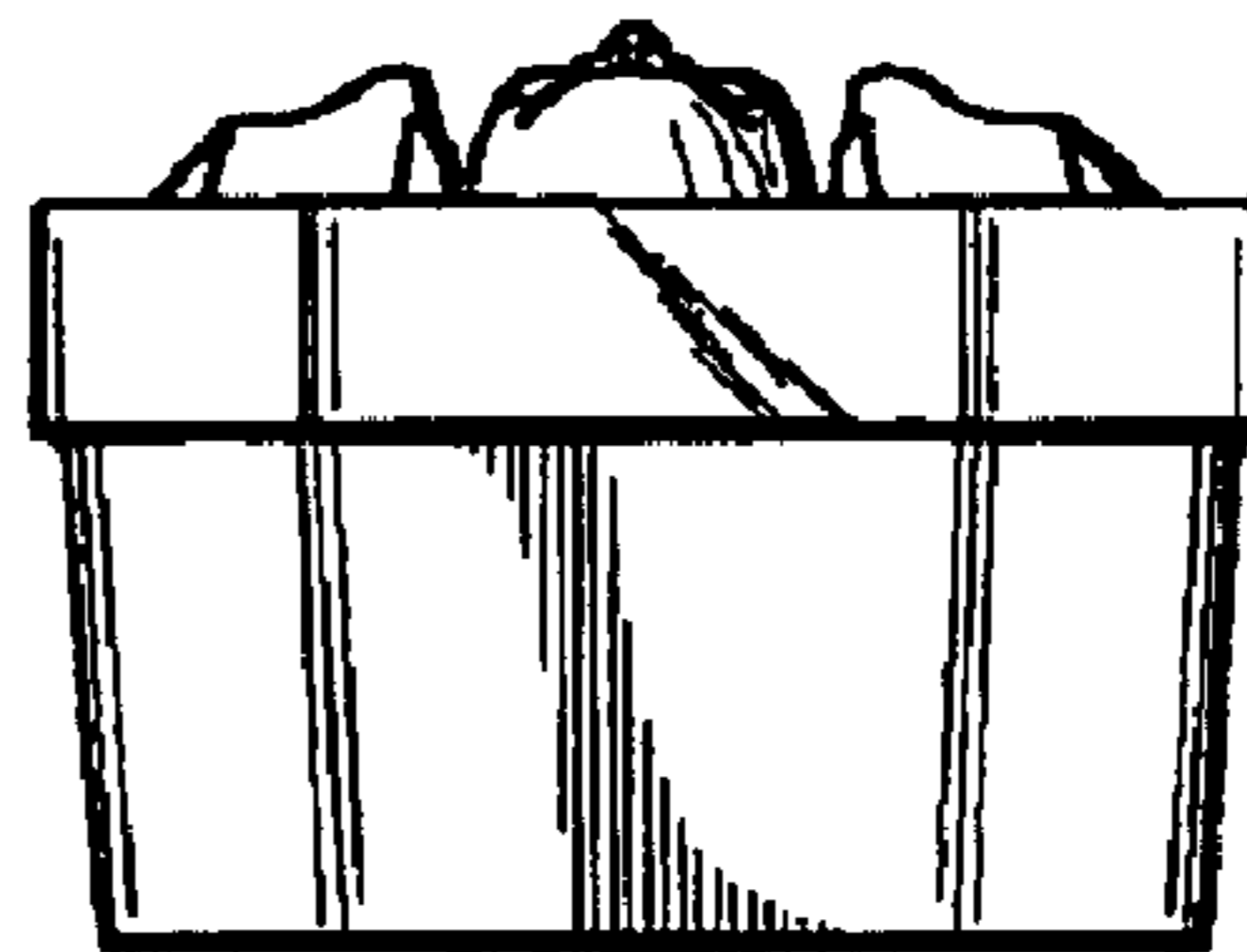

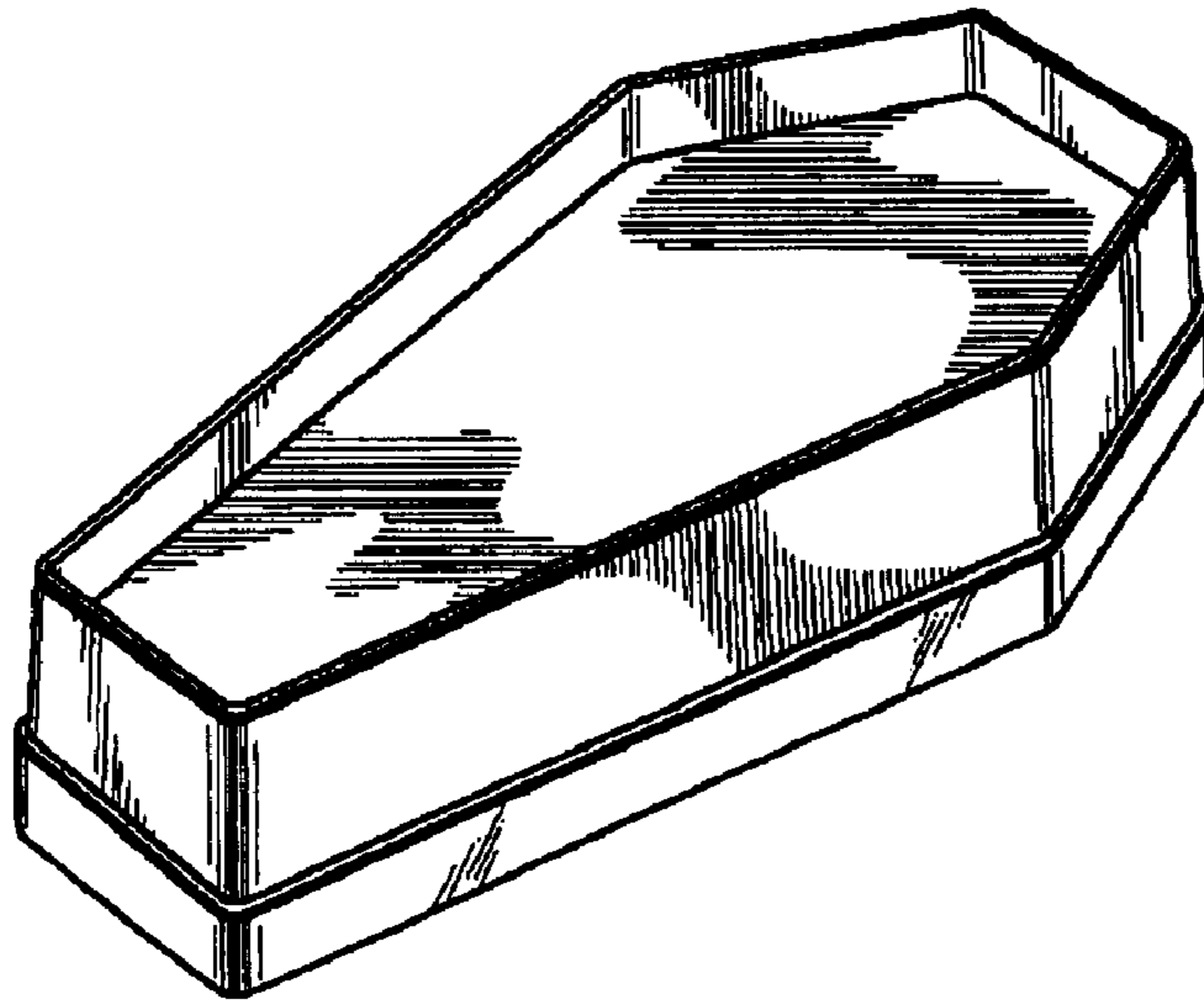

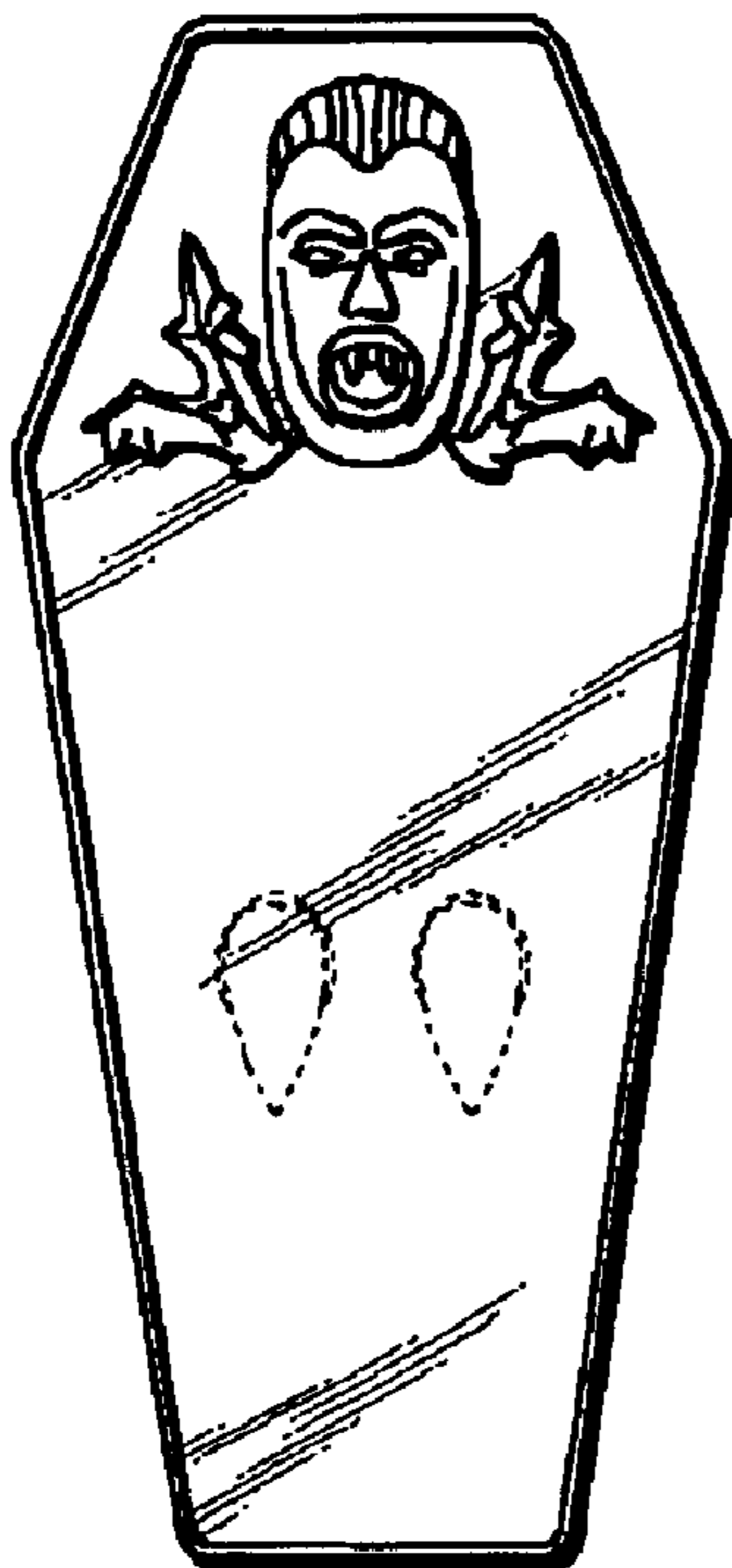

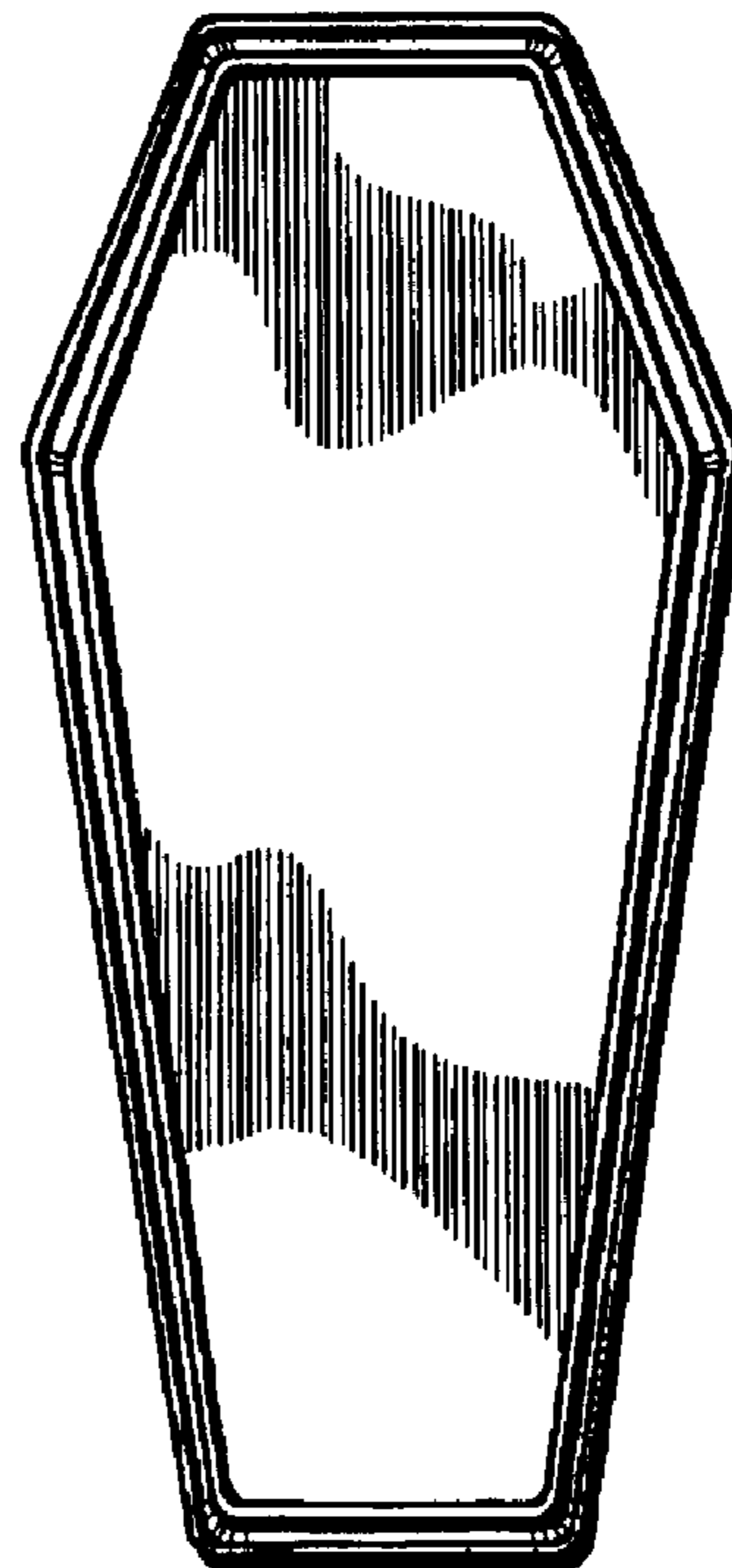

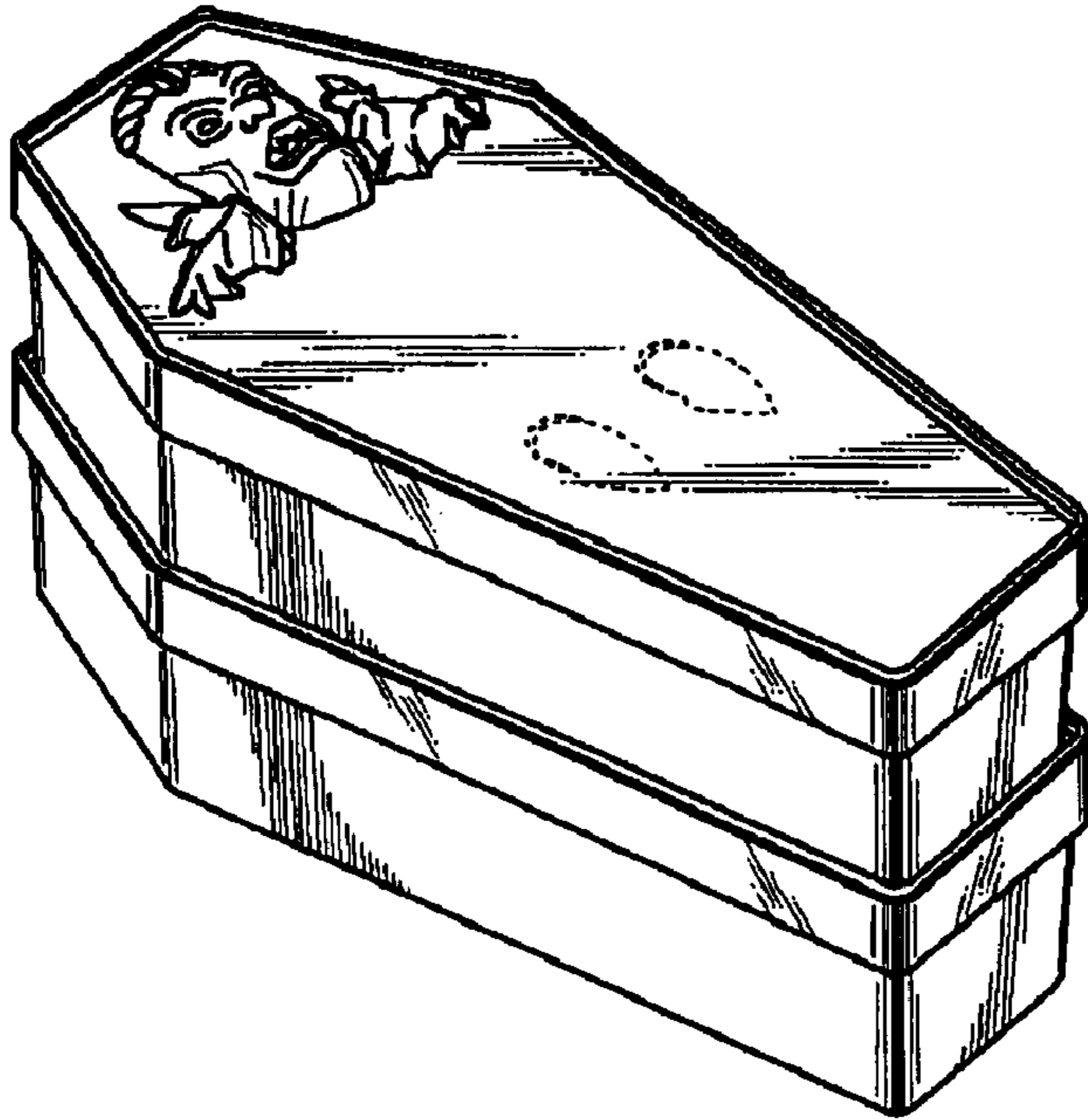

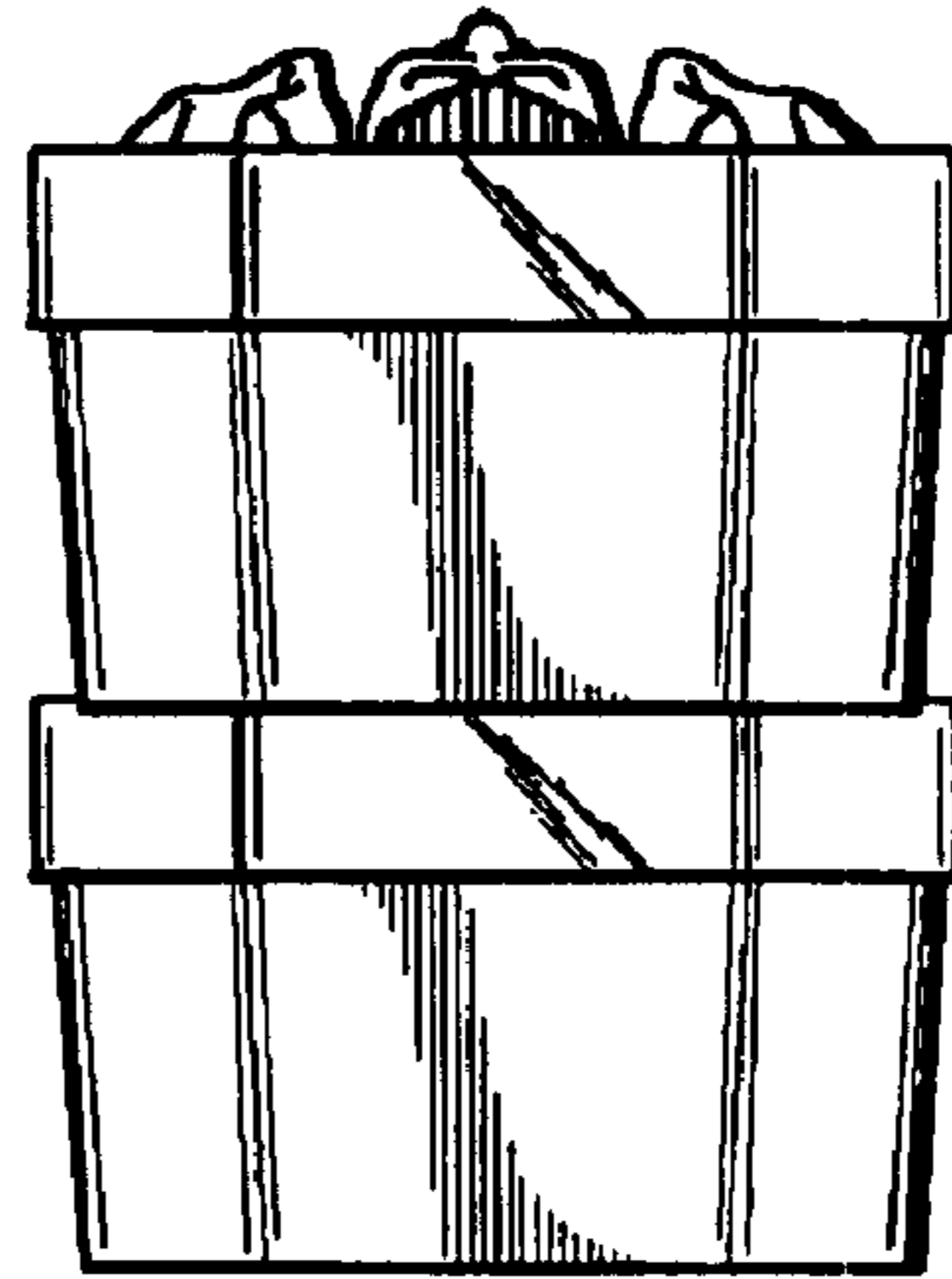

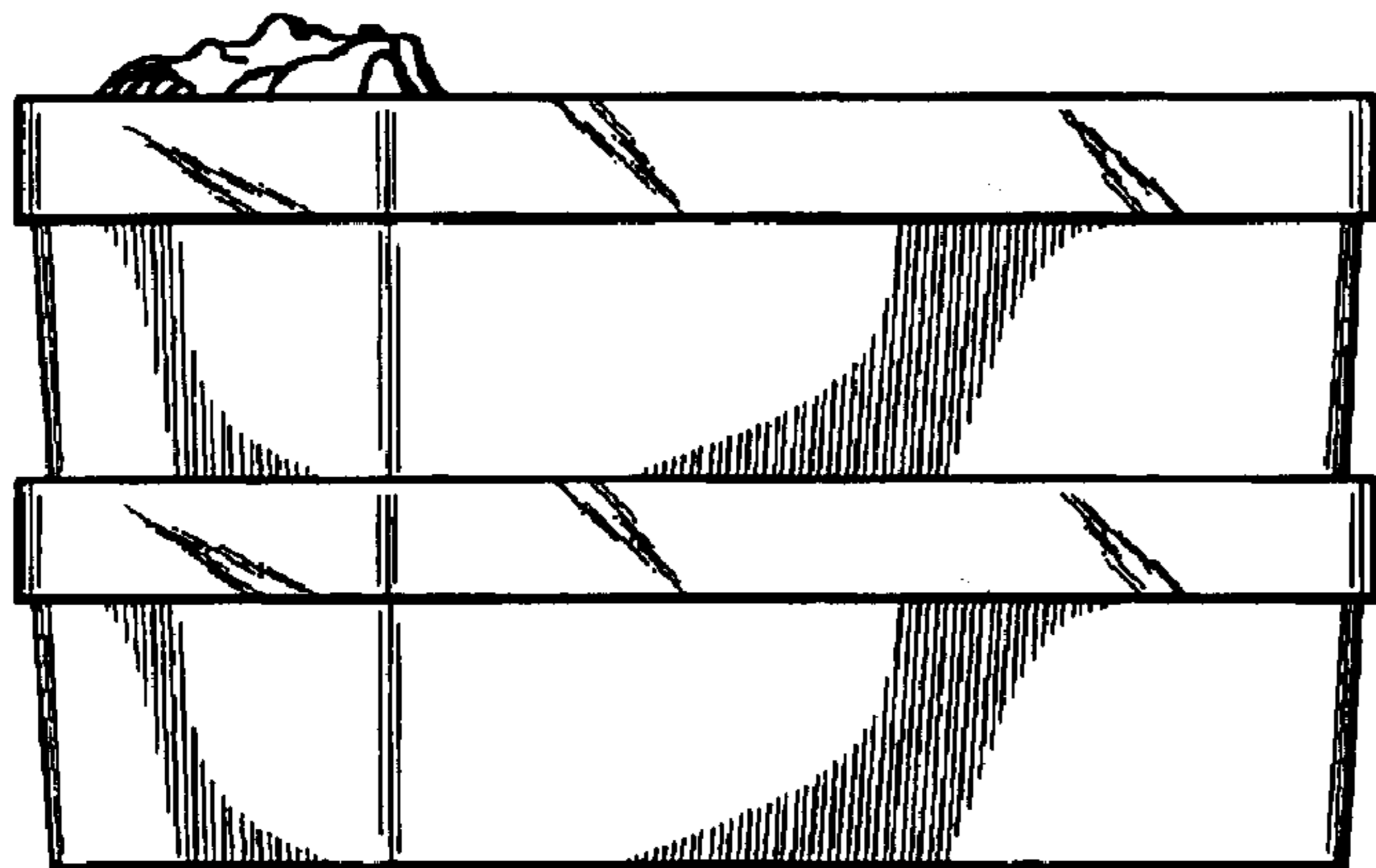

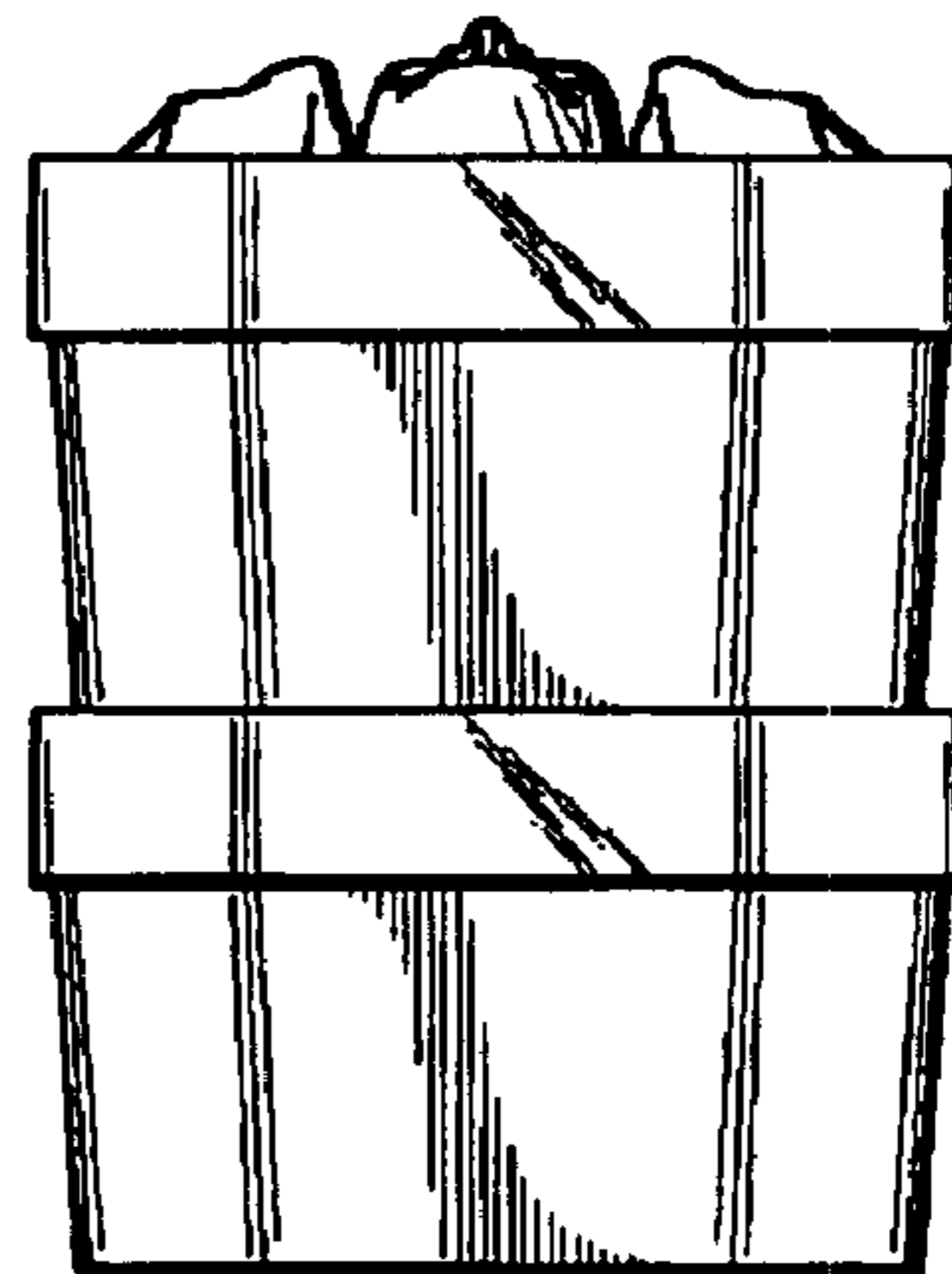

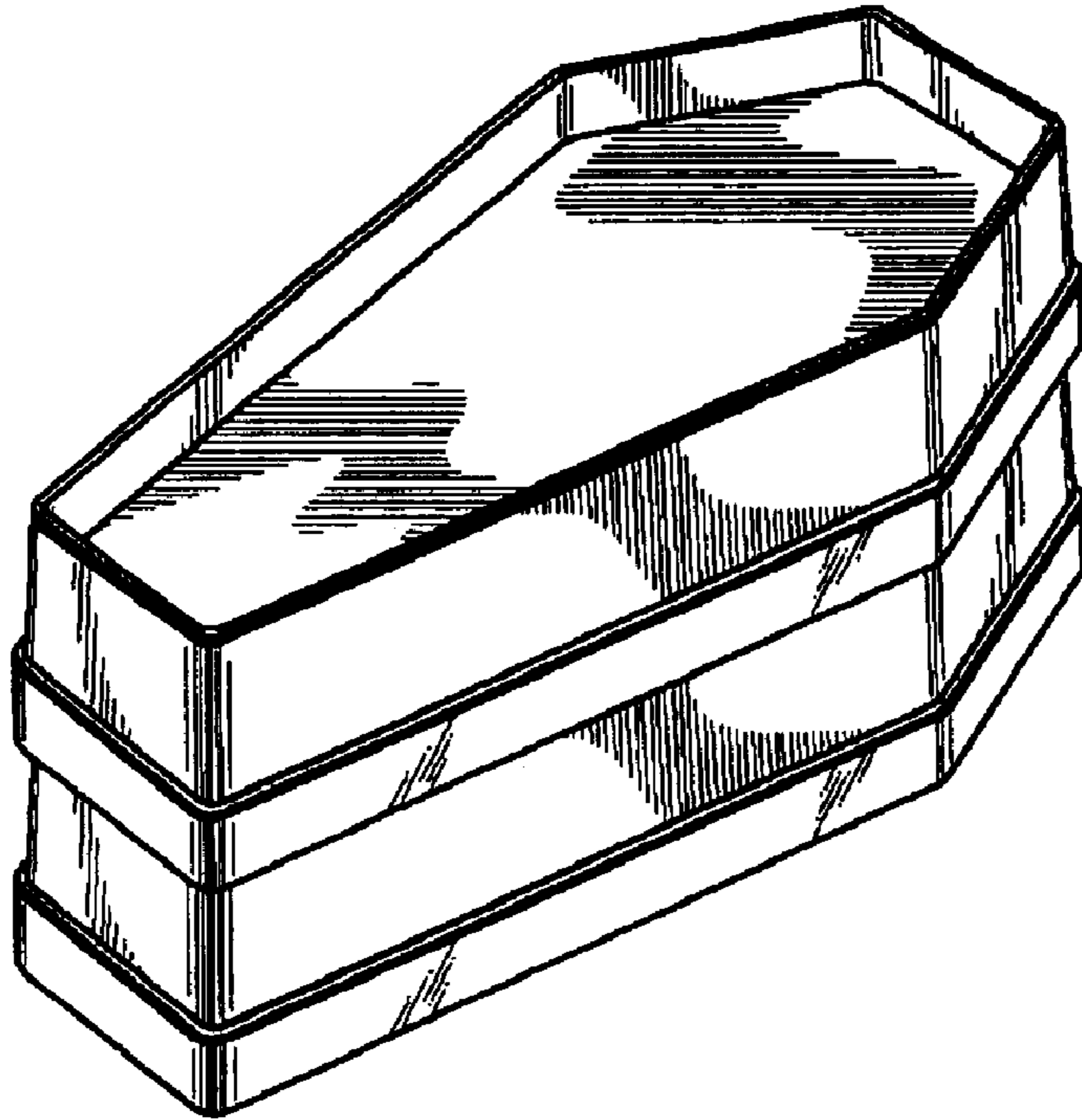

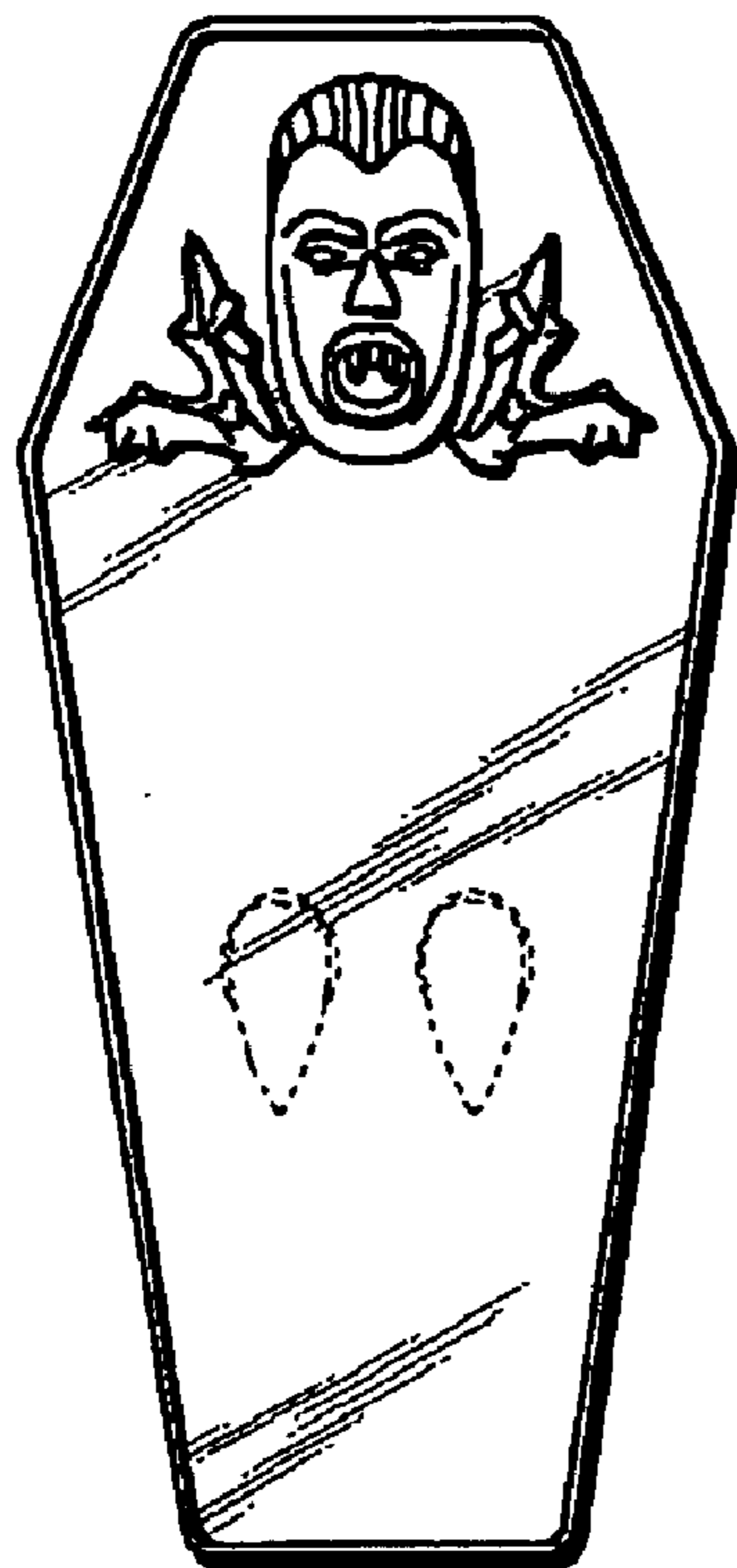

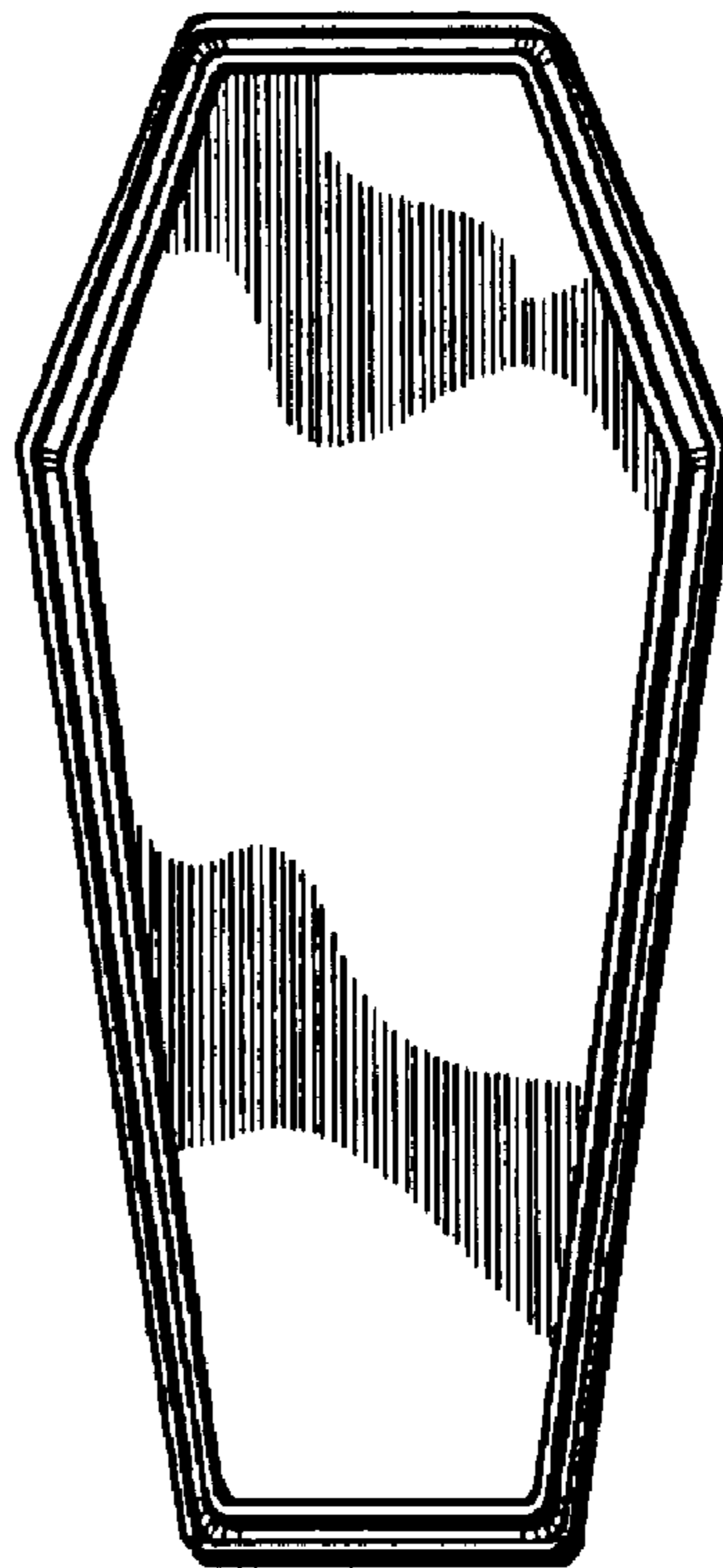

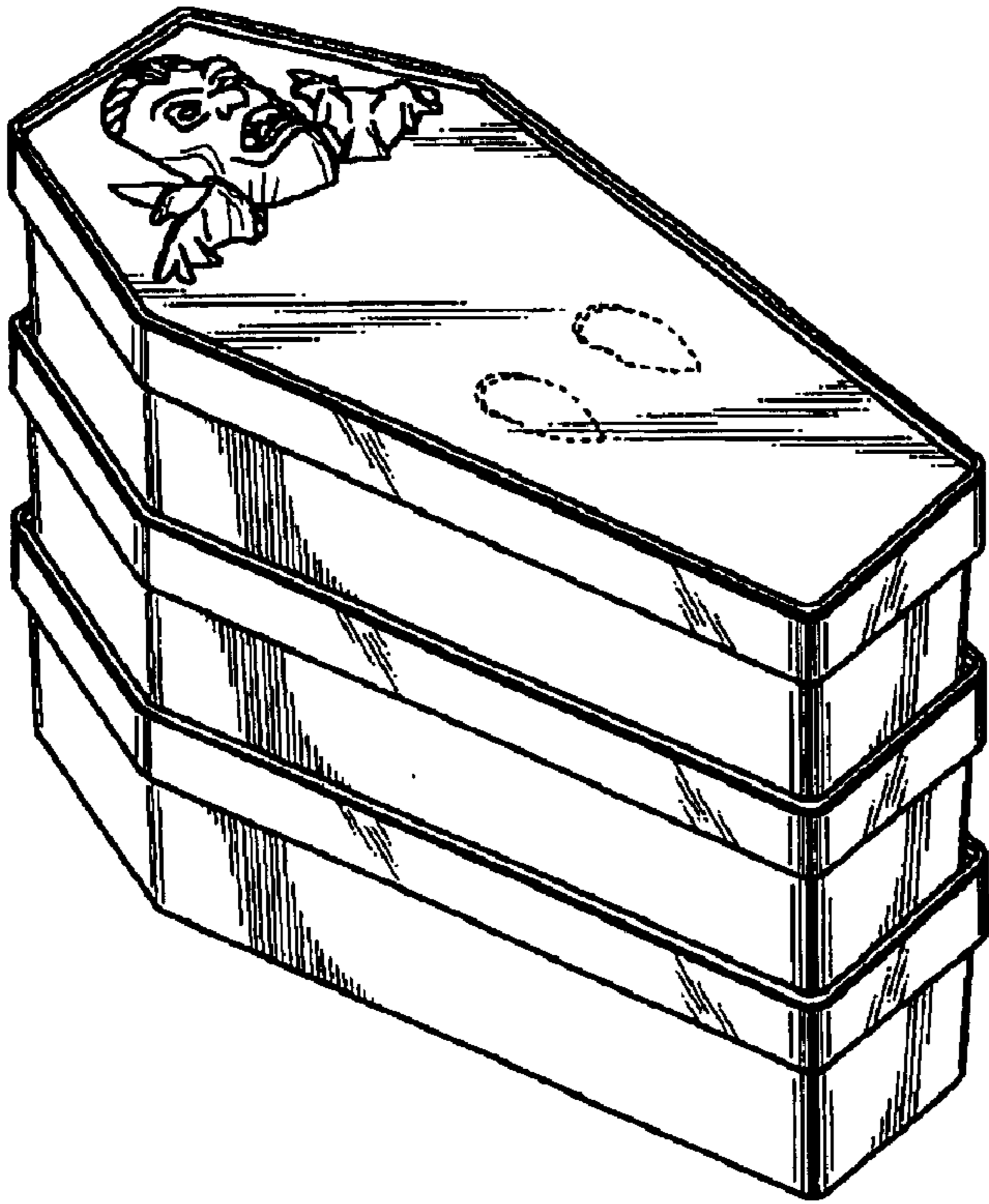

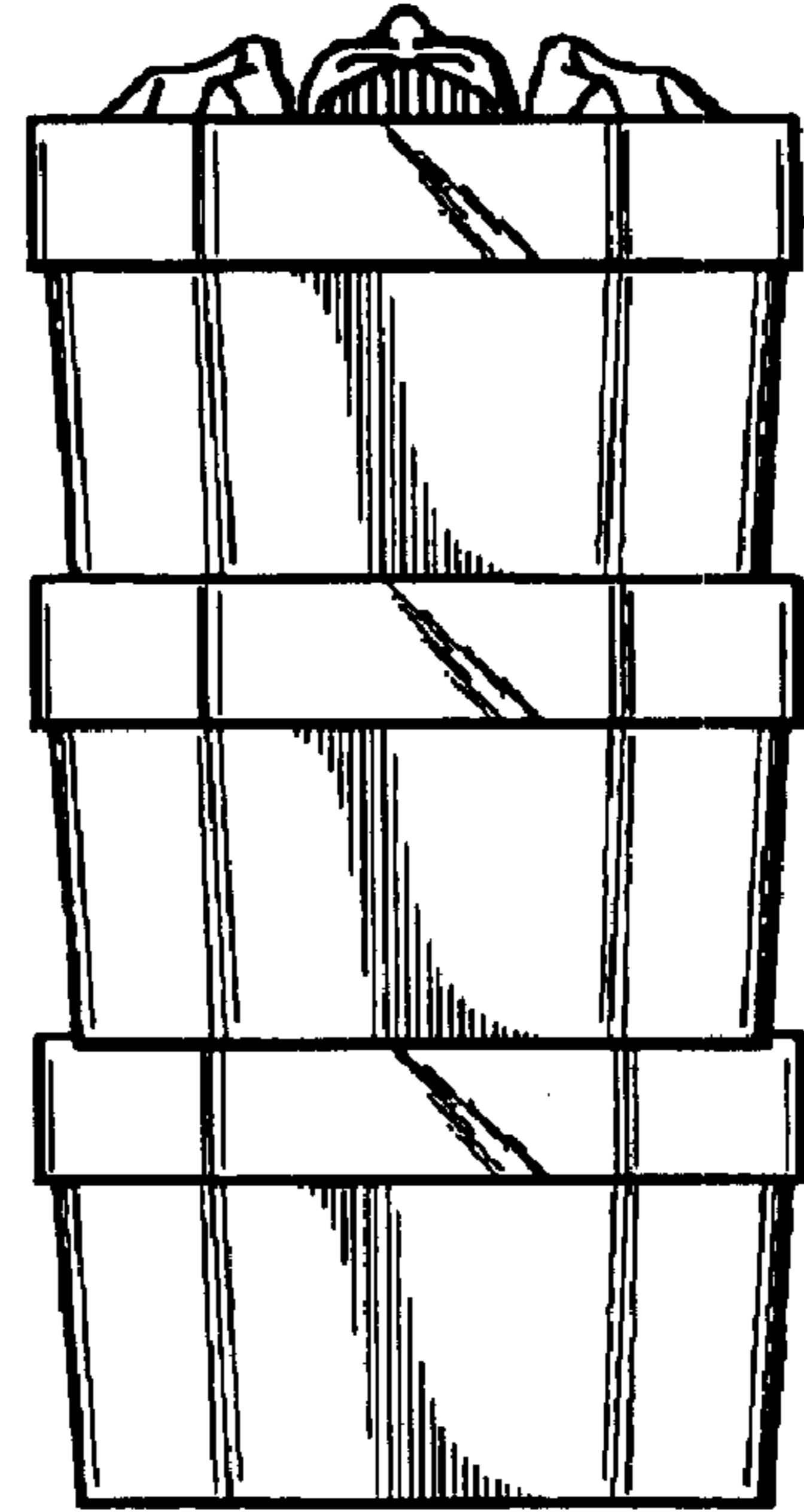

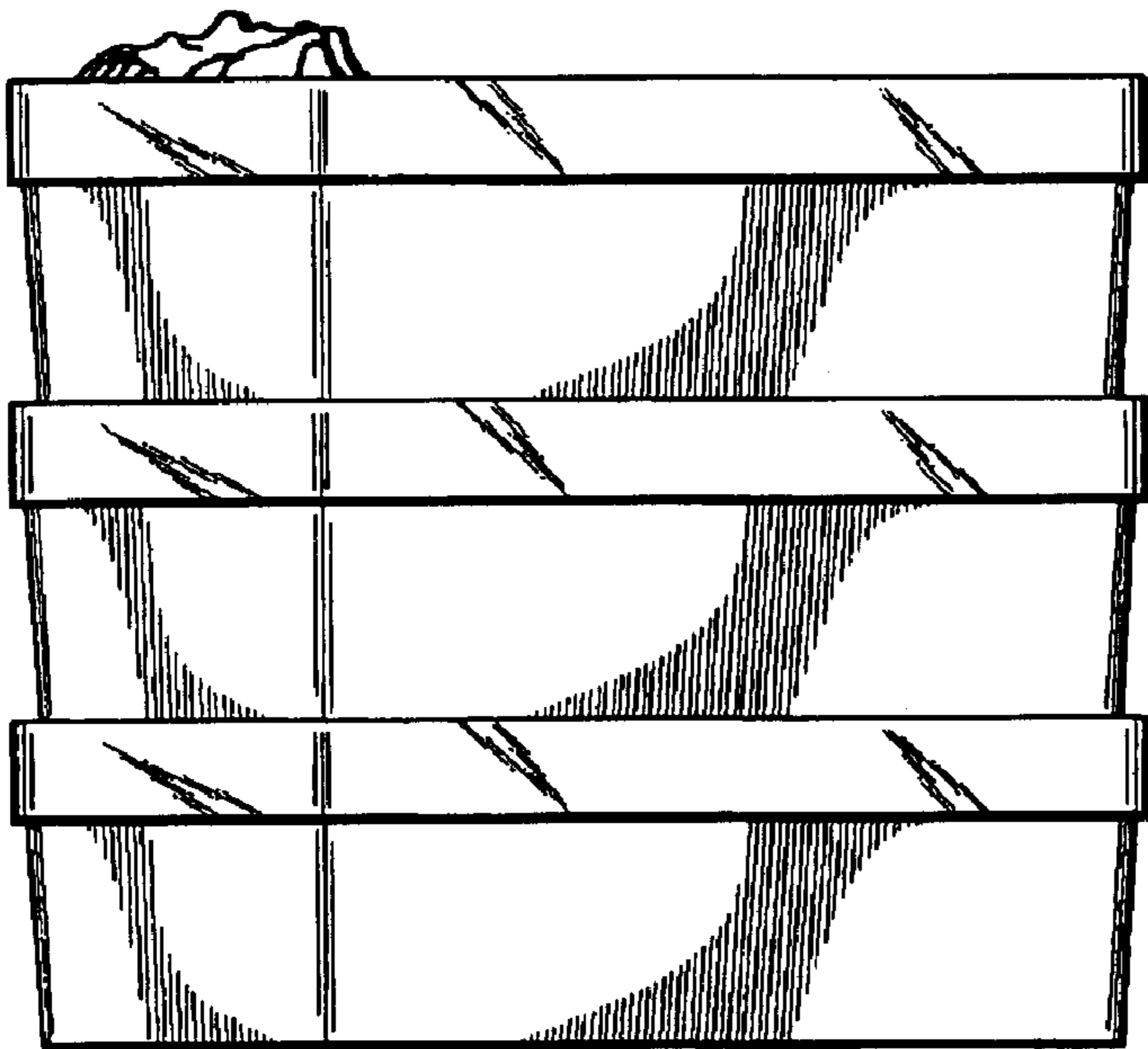

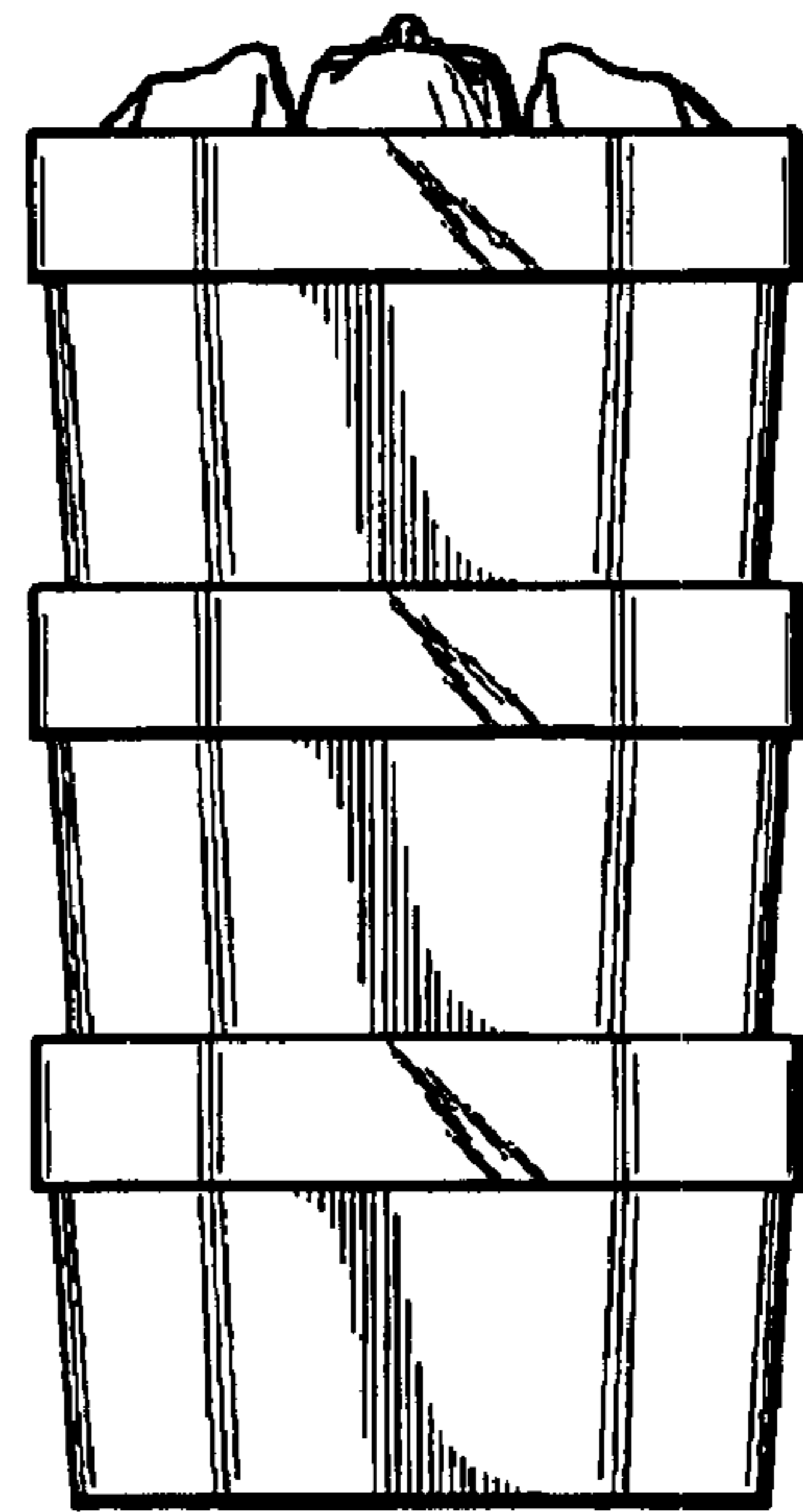

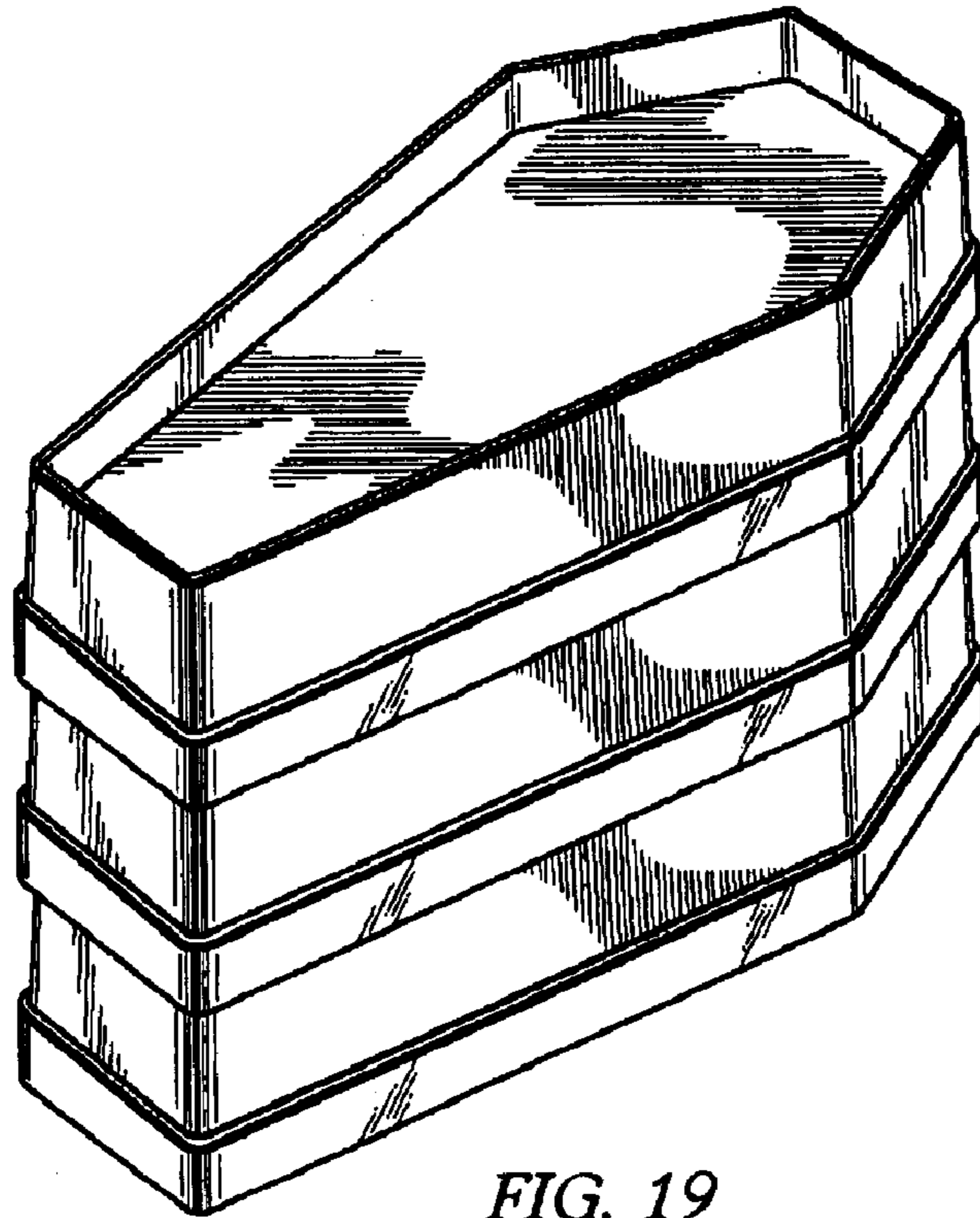

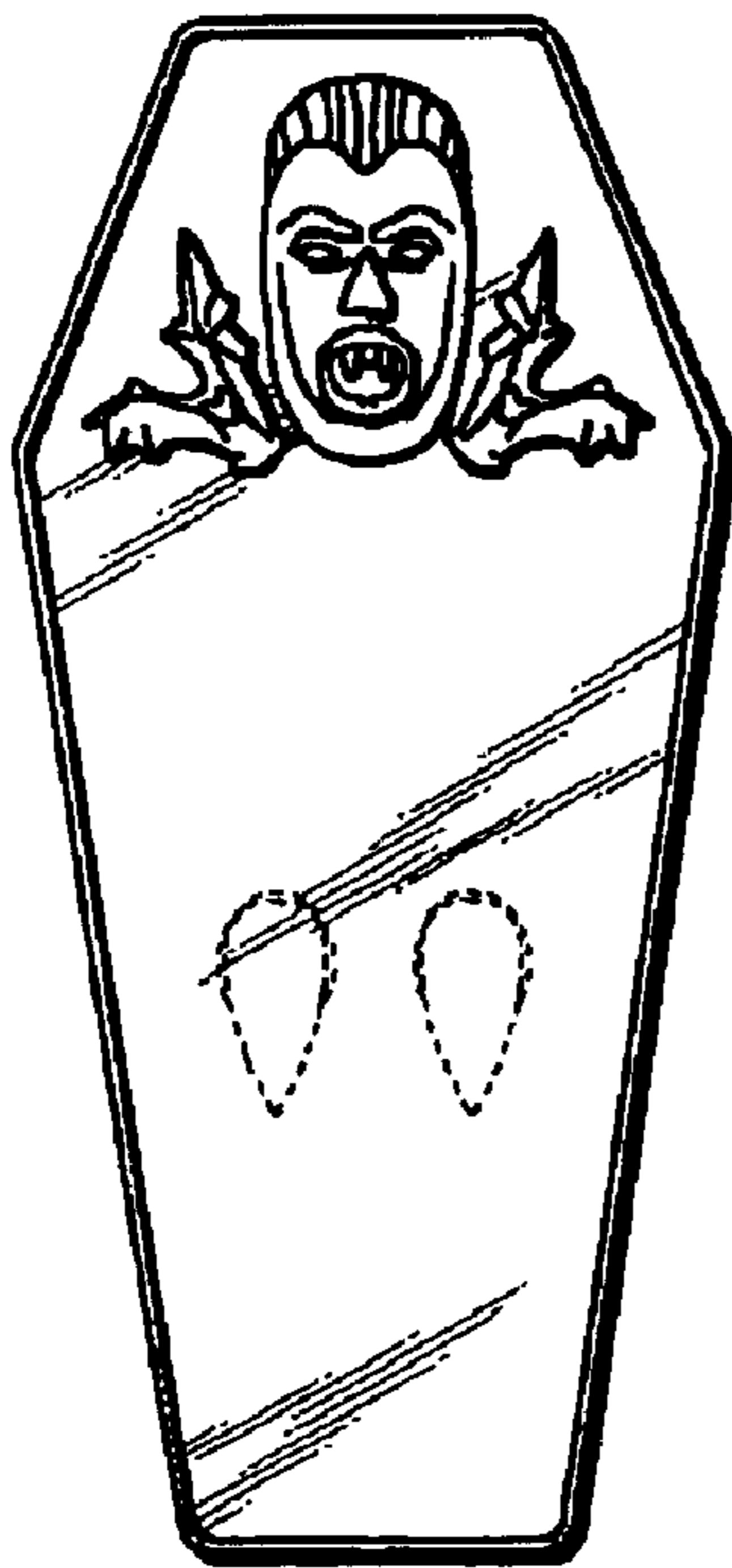

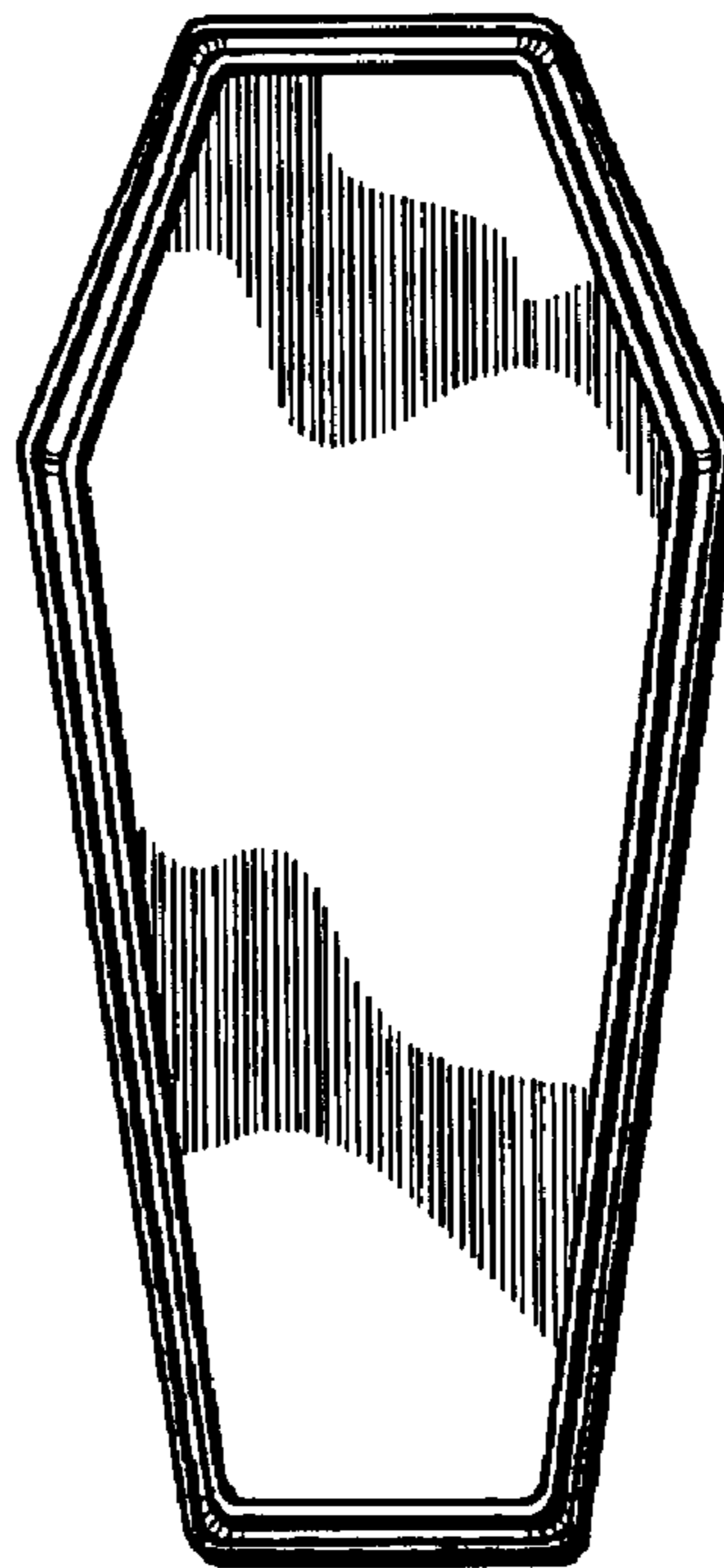
