The ornamental design for a spindle mixer, as shown and described.

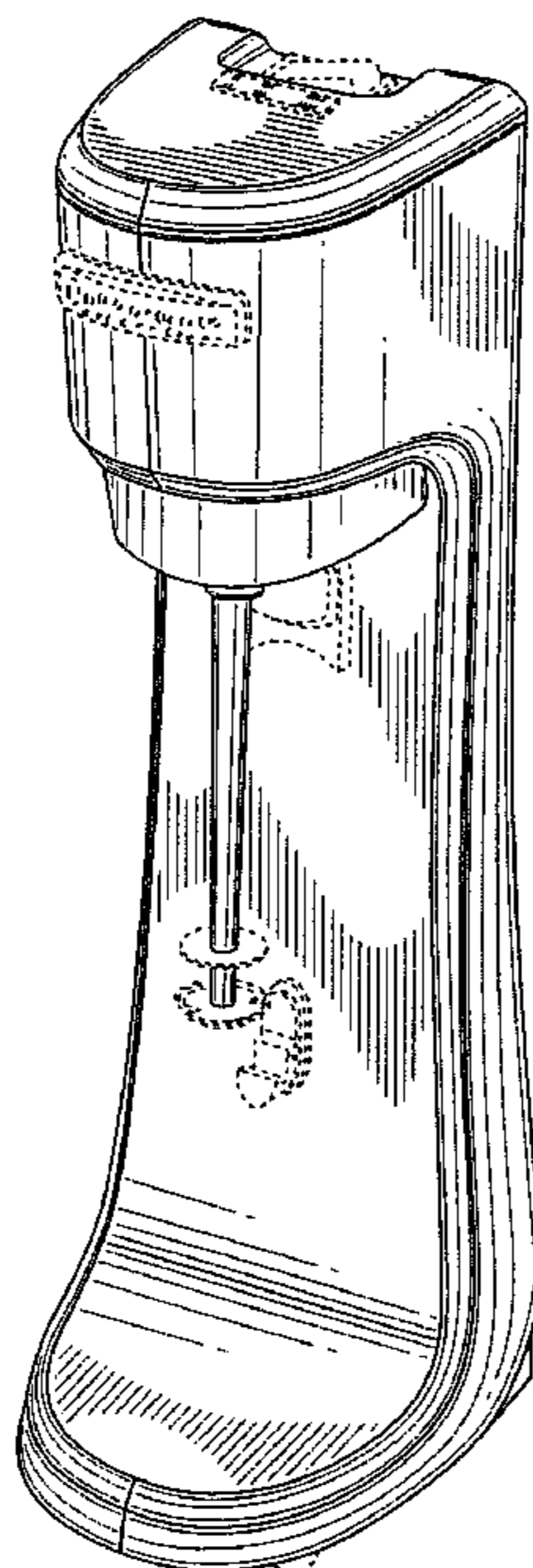
DESCRIPTION

FIG. 1 is a perspective view as seen from the top, front and right side of a spindle mixer showing the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom view thereof. 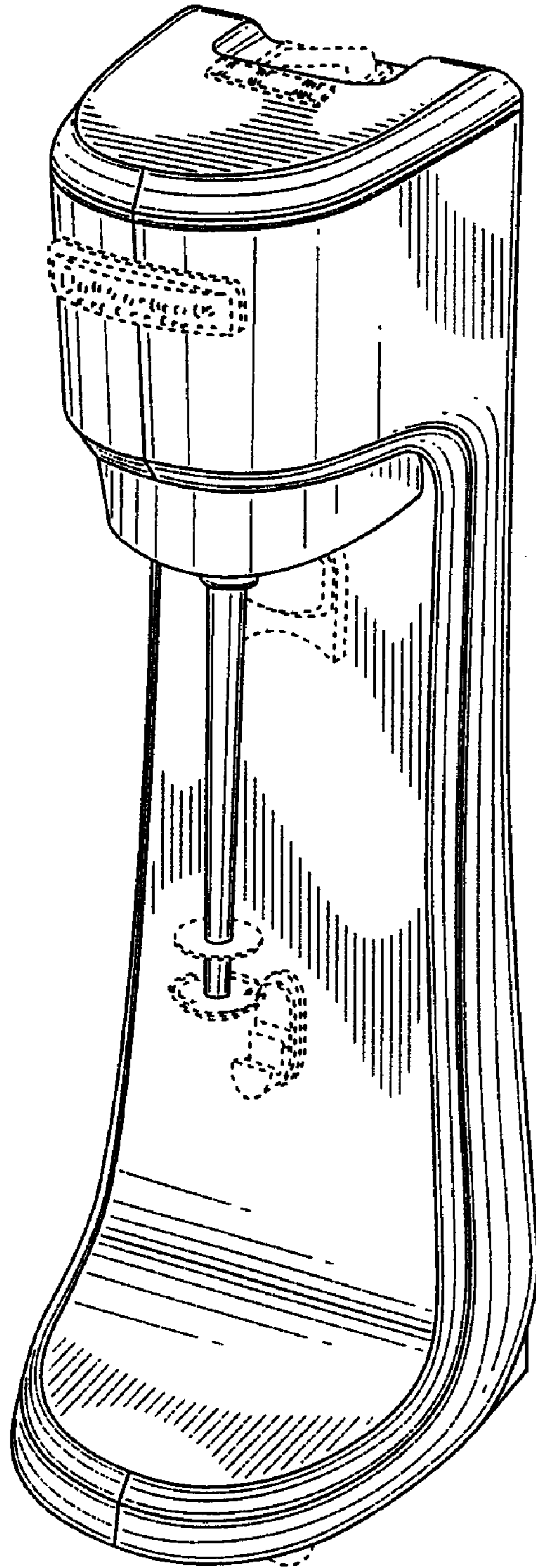

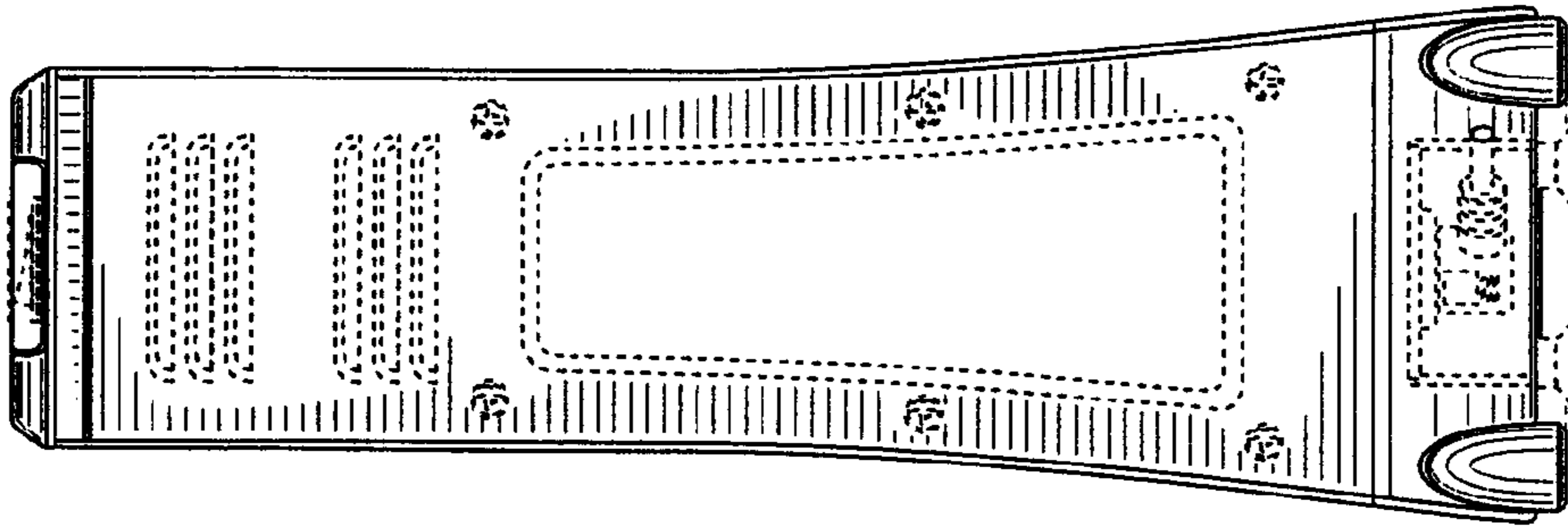

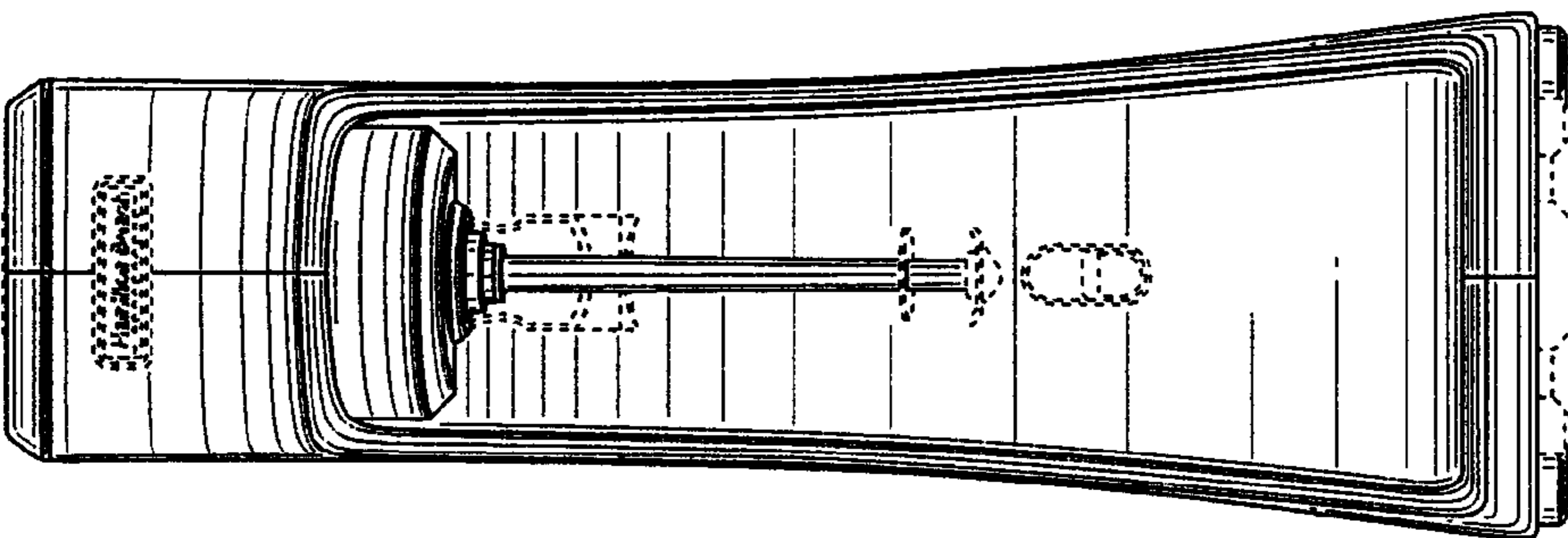

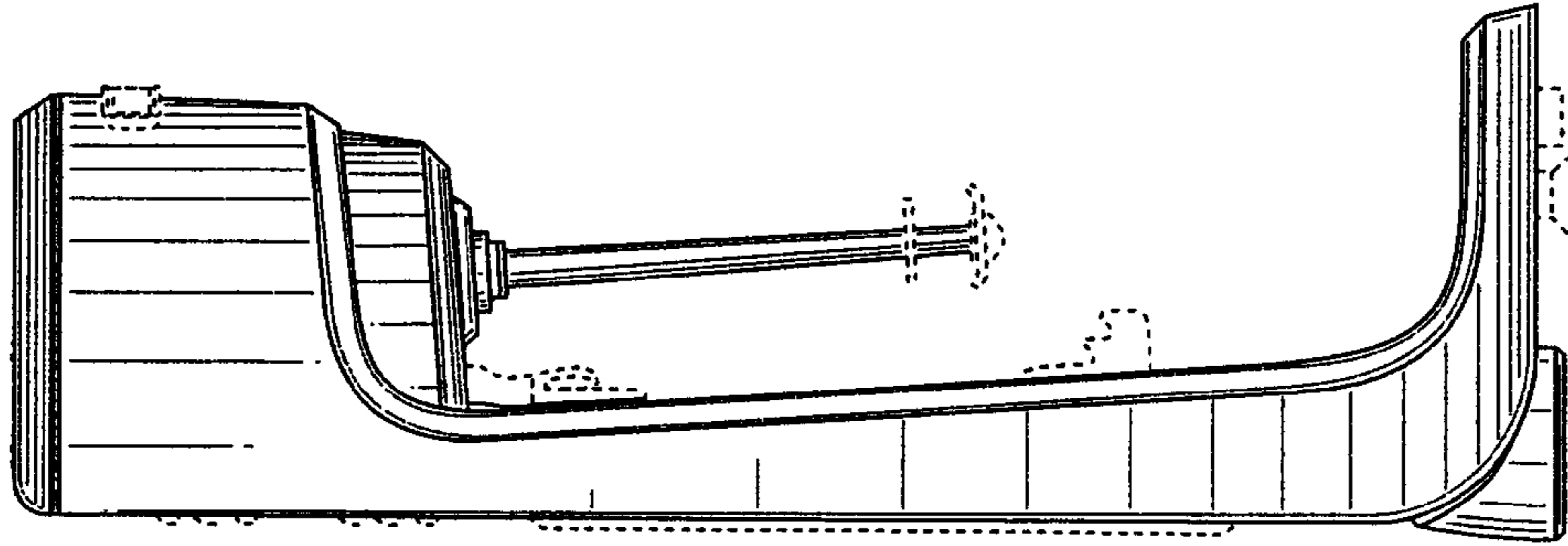

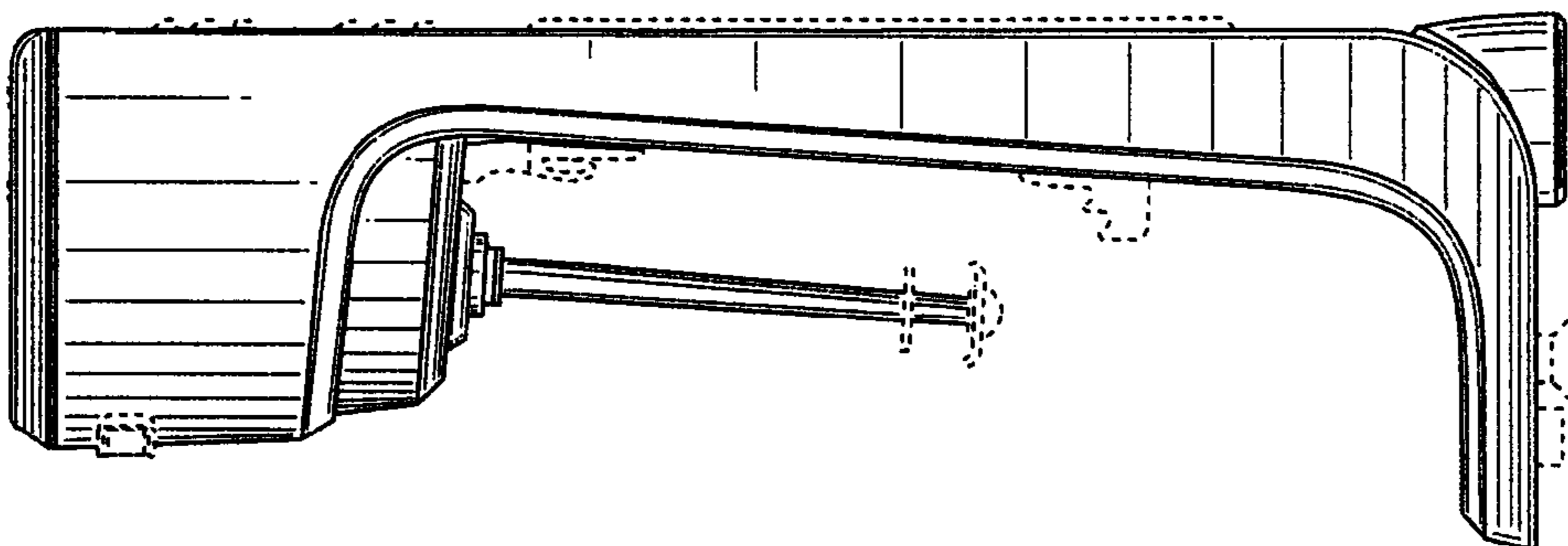

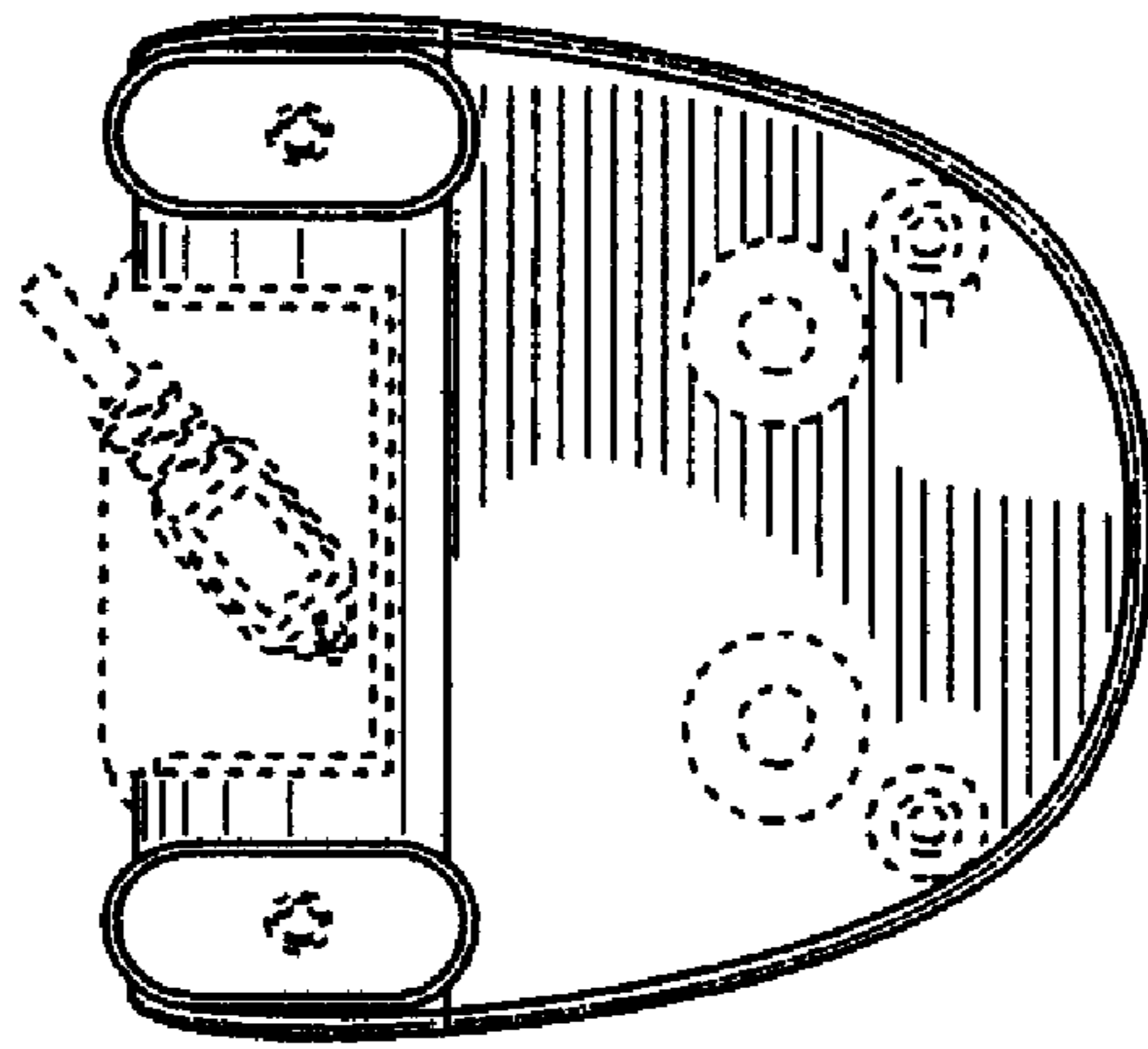

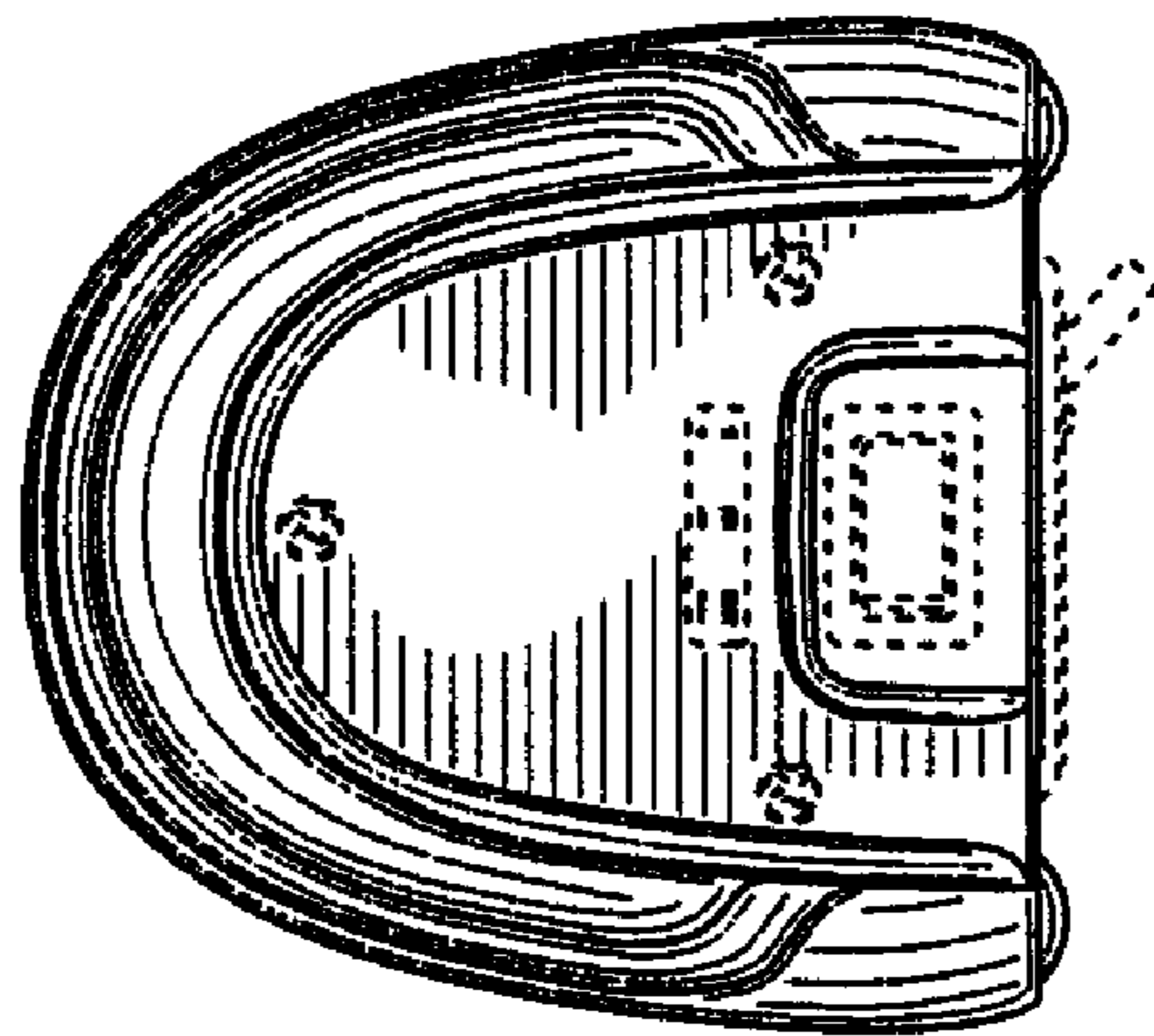
