open condition.

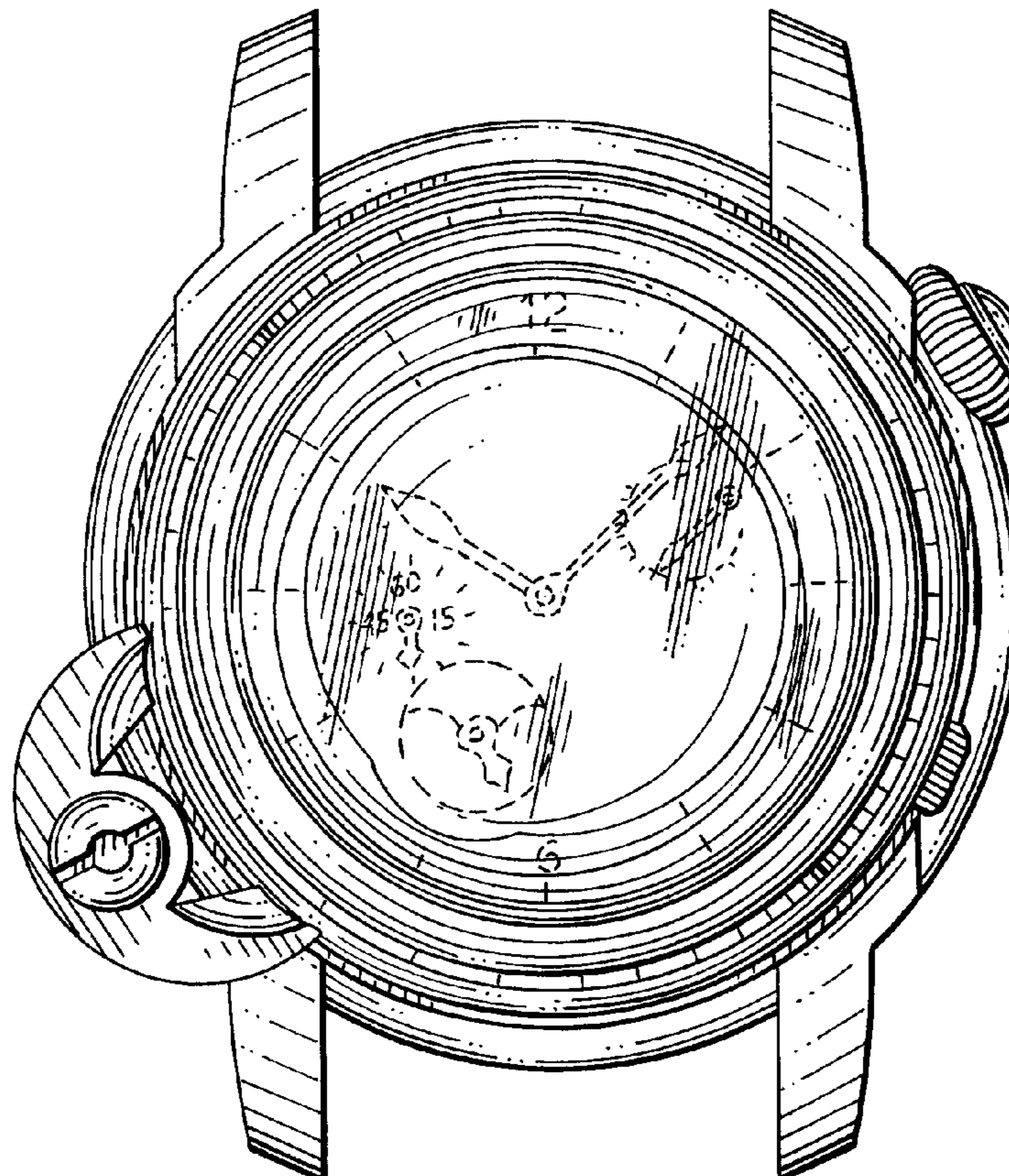

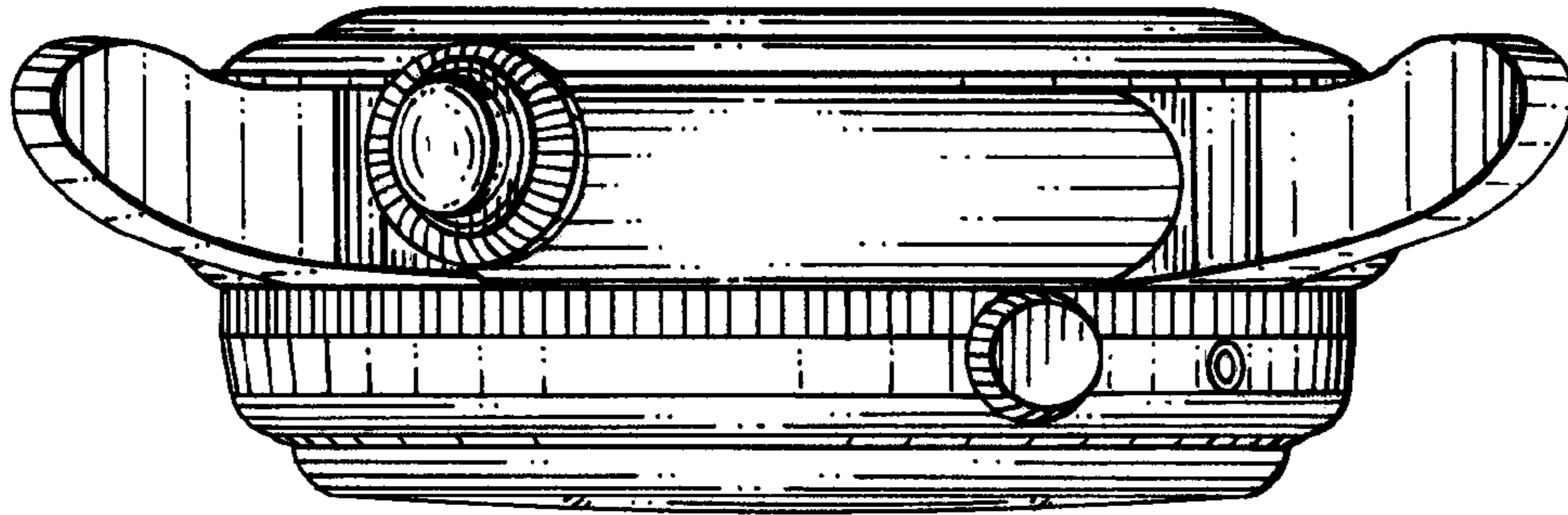

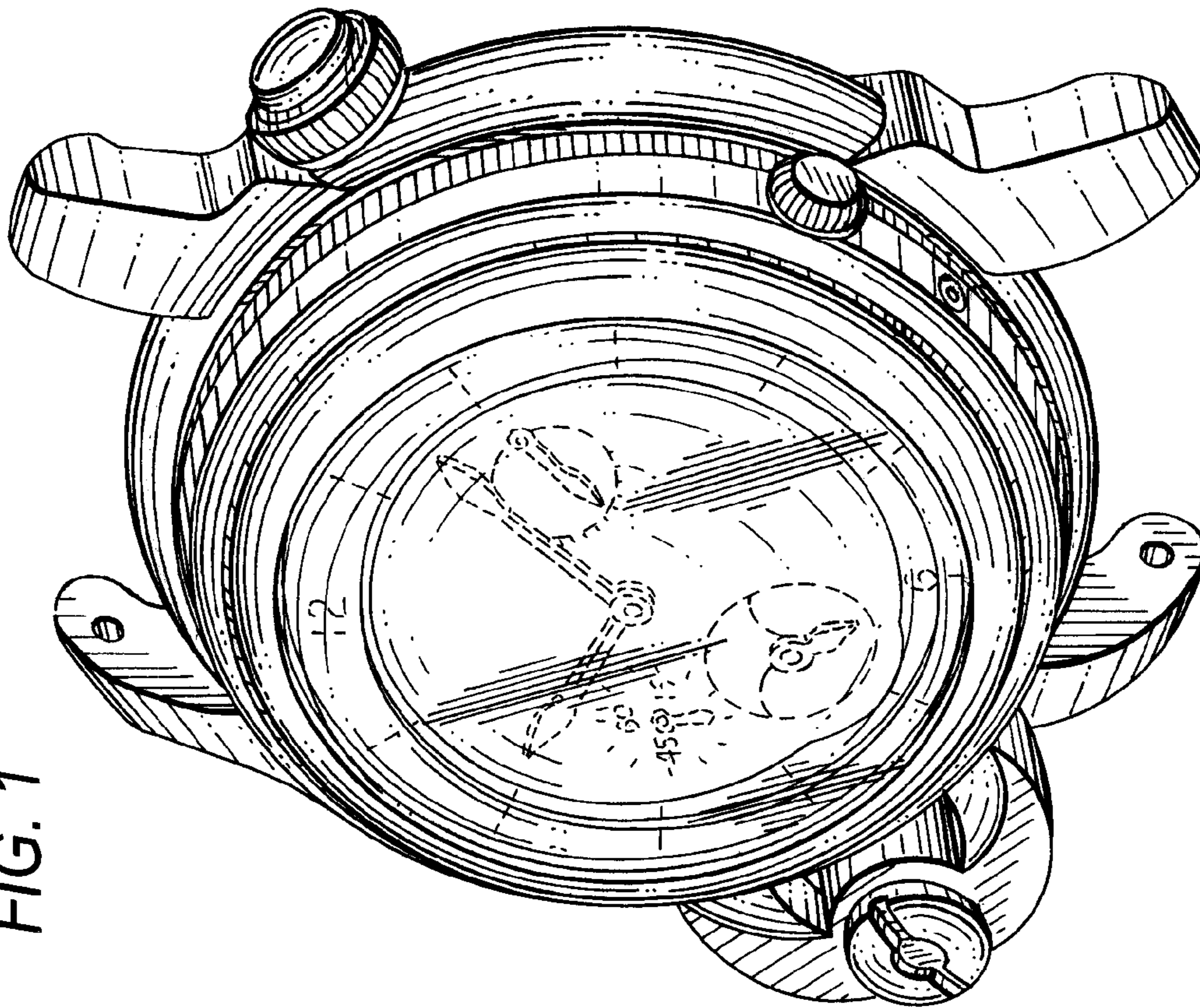

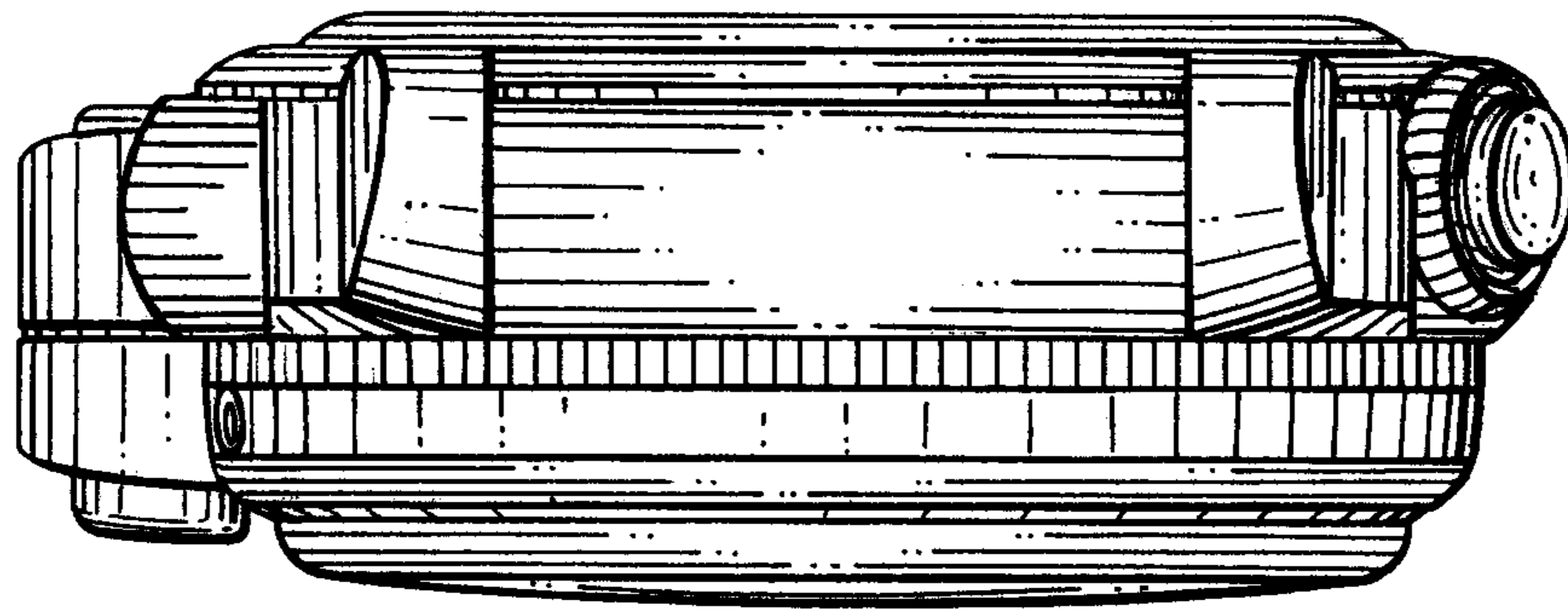

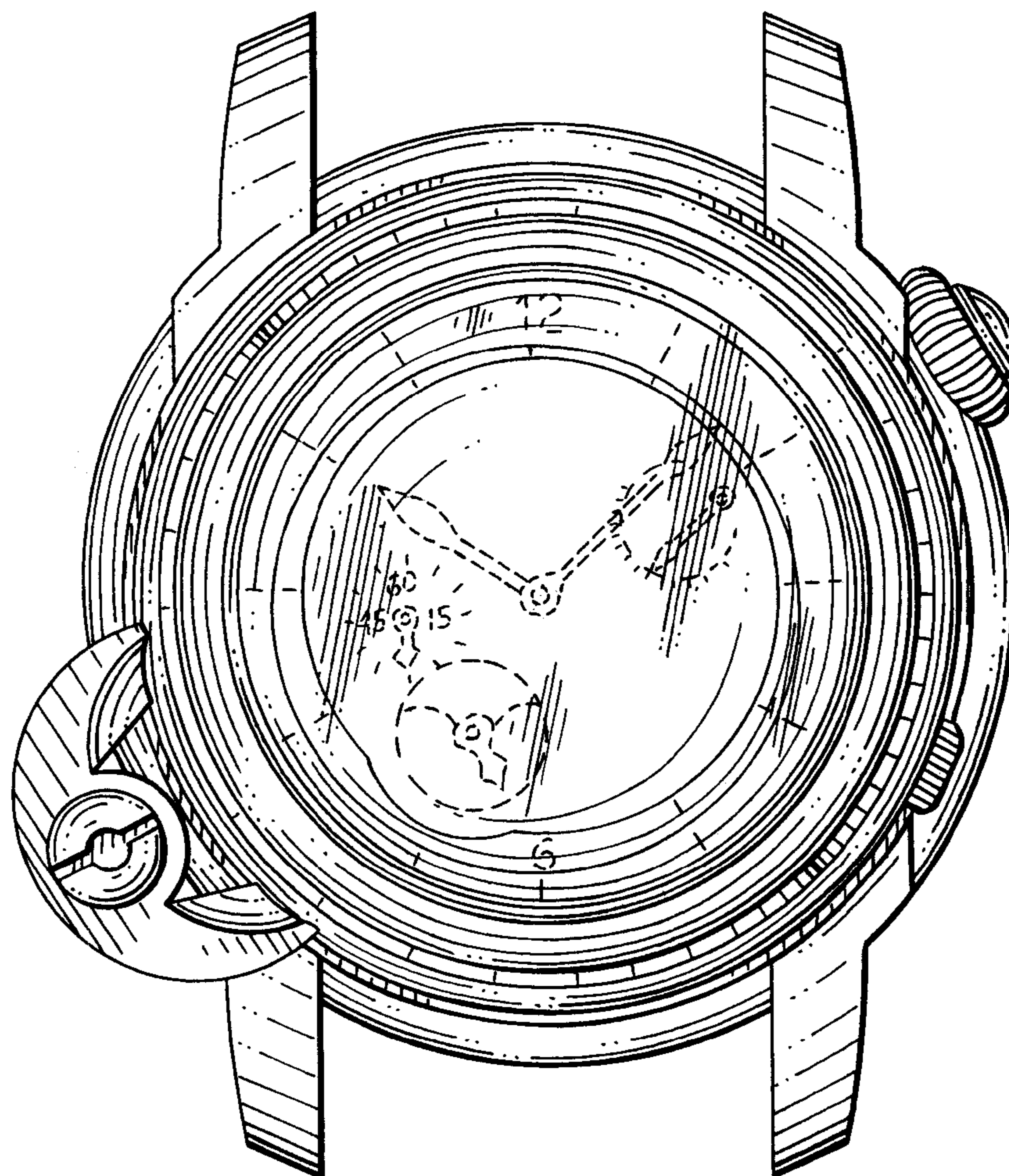

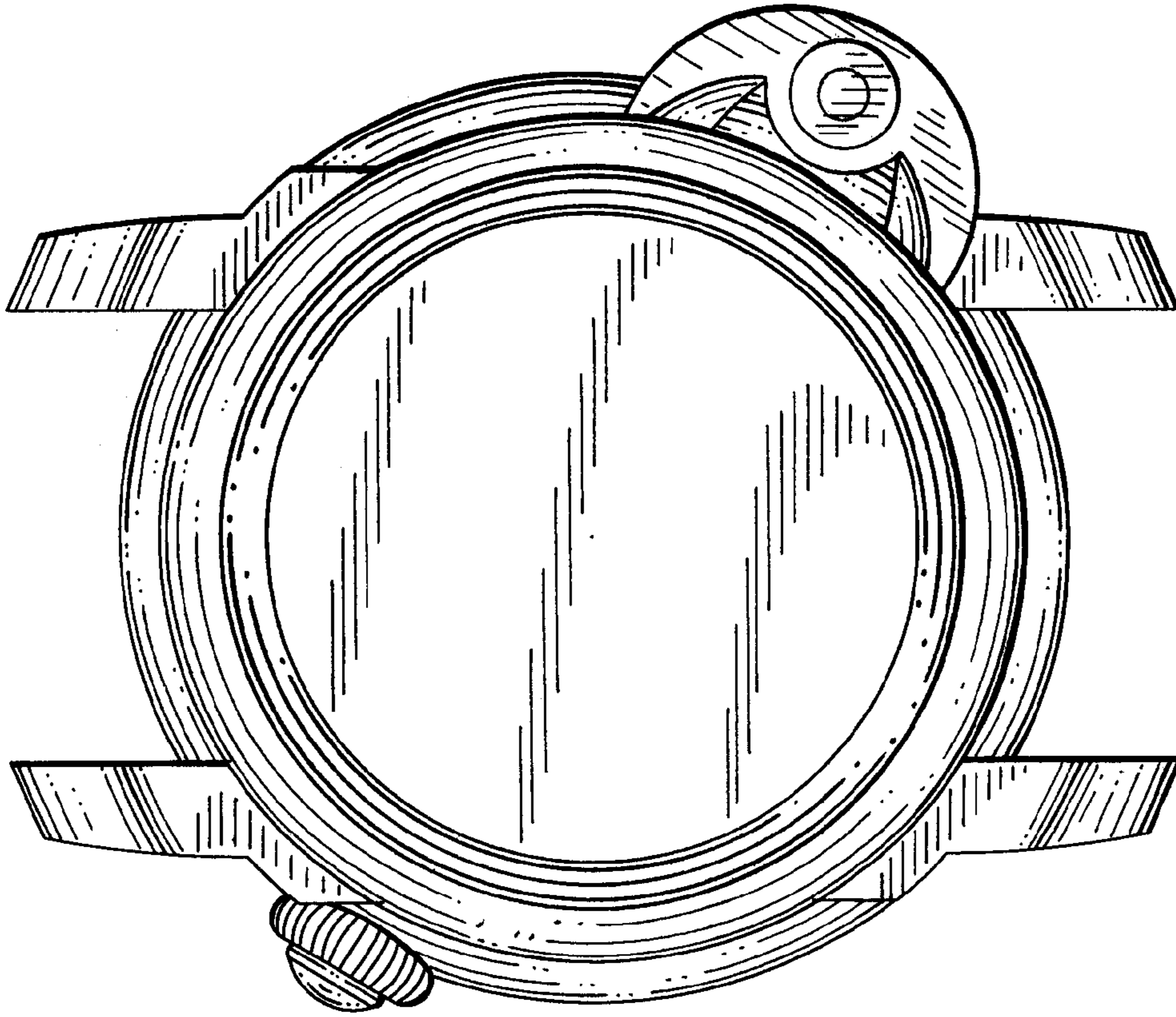

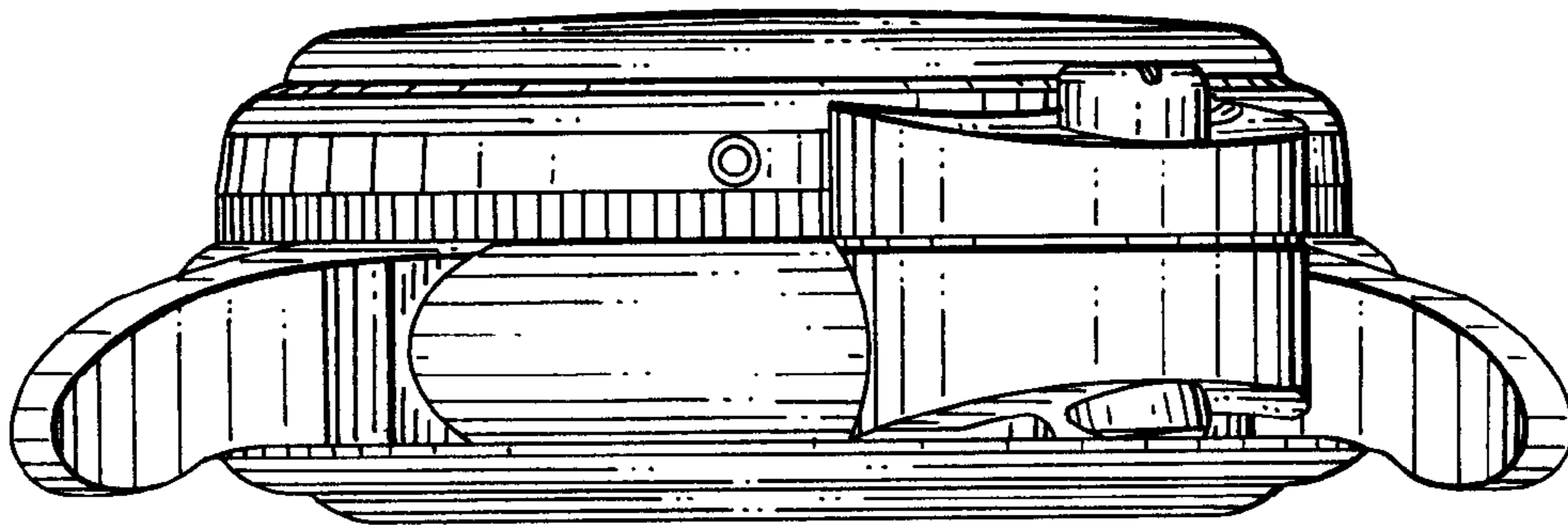

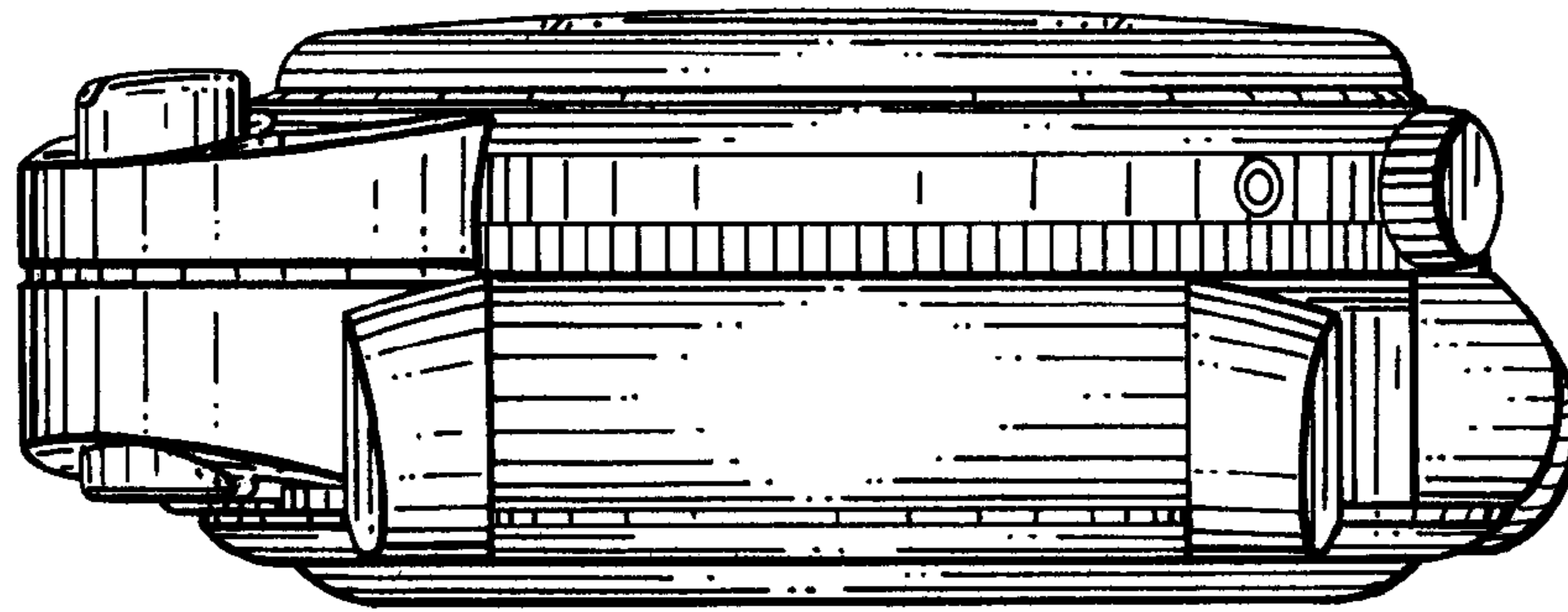

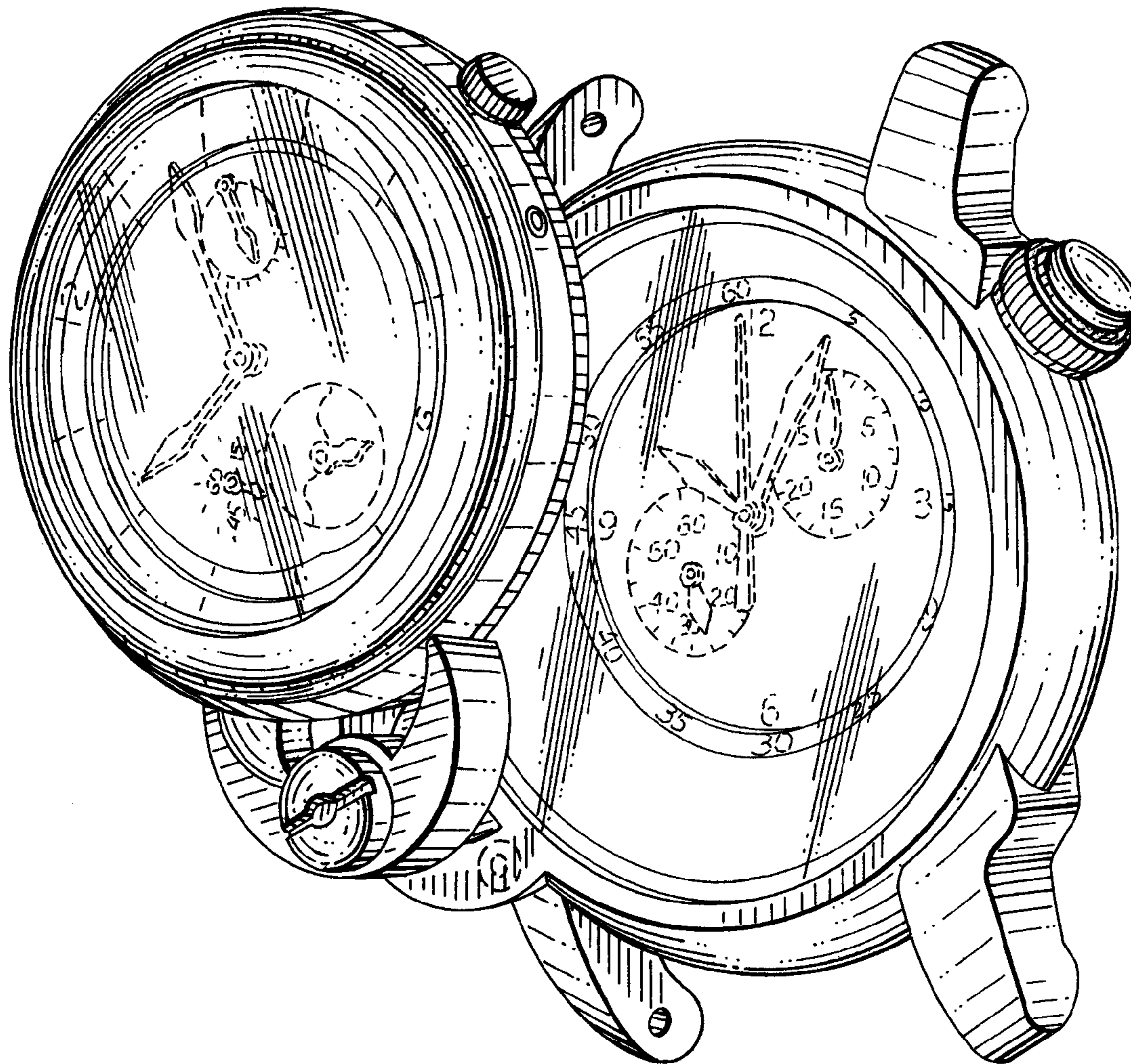
