An ornamental design for a watch dial, as shown and described.

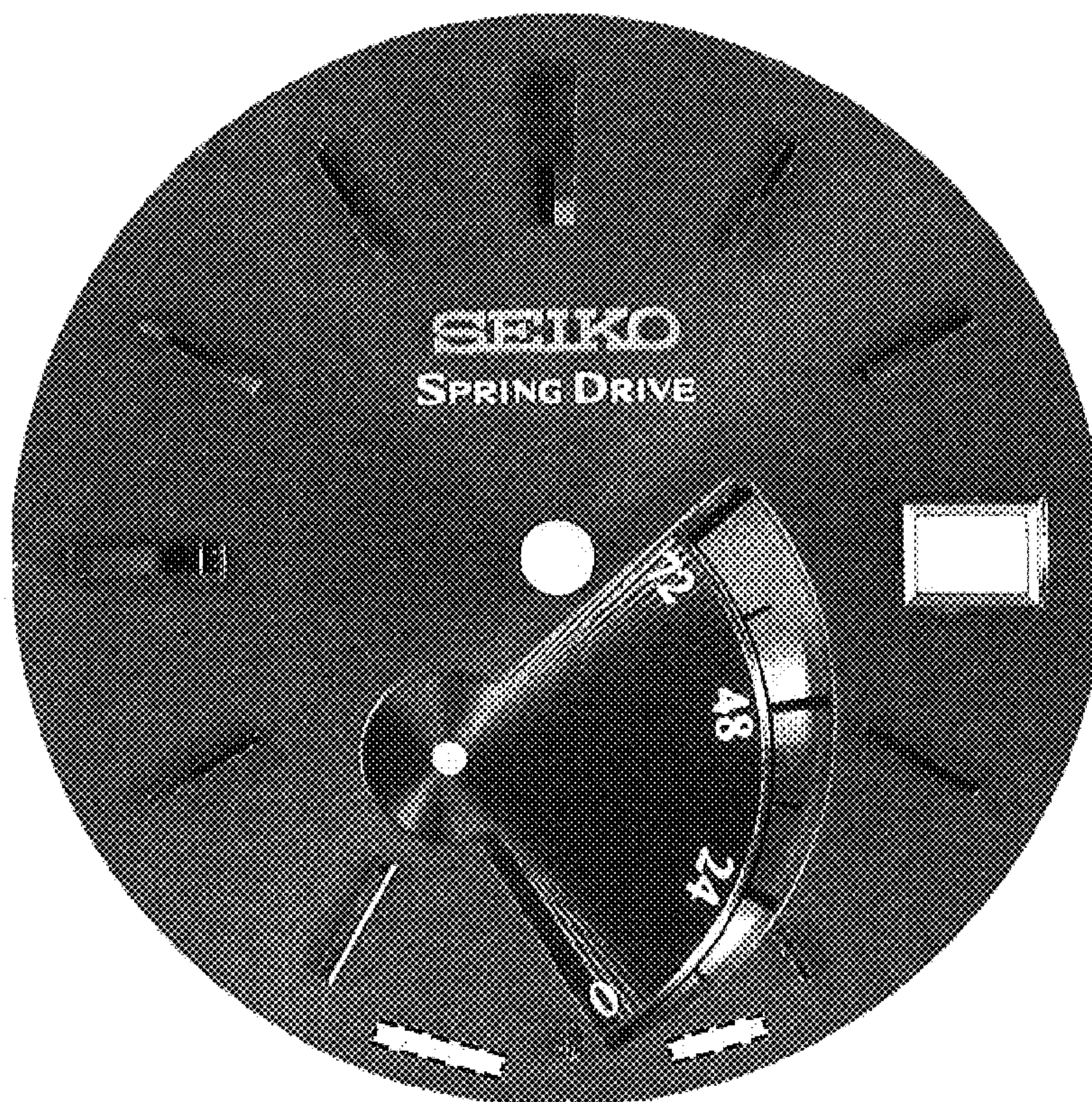

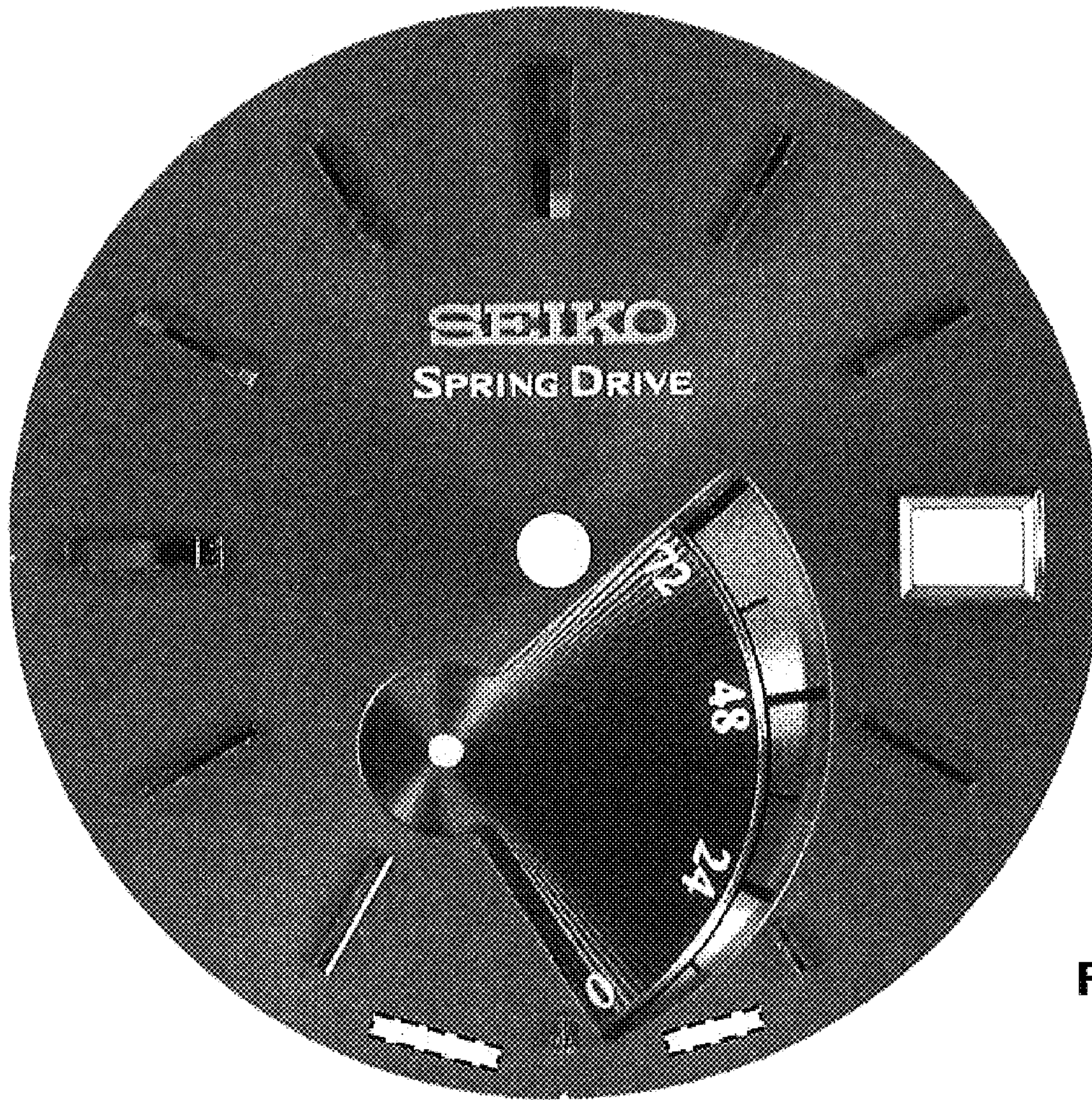

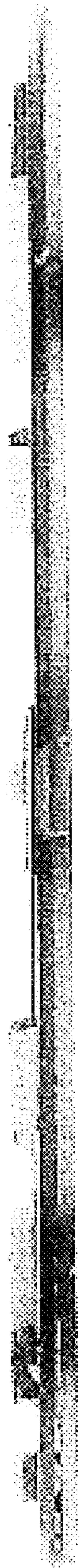
