(57) **CLAIM**

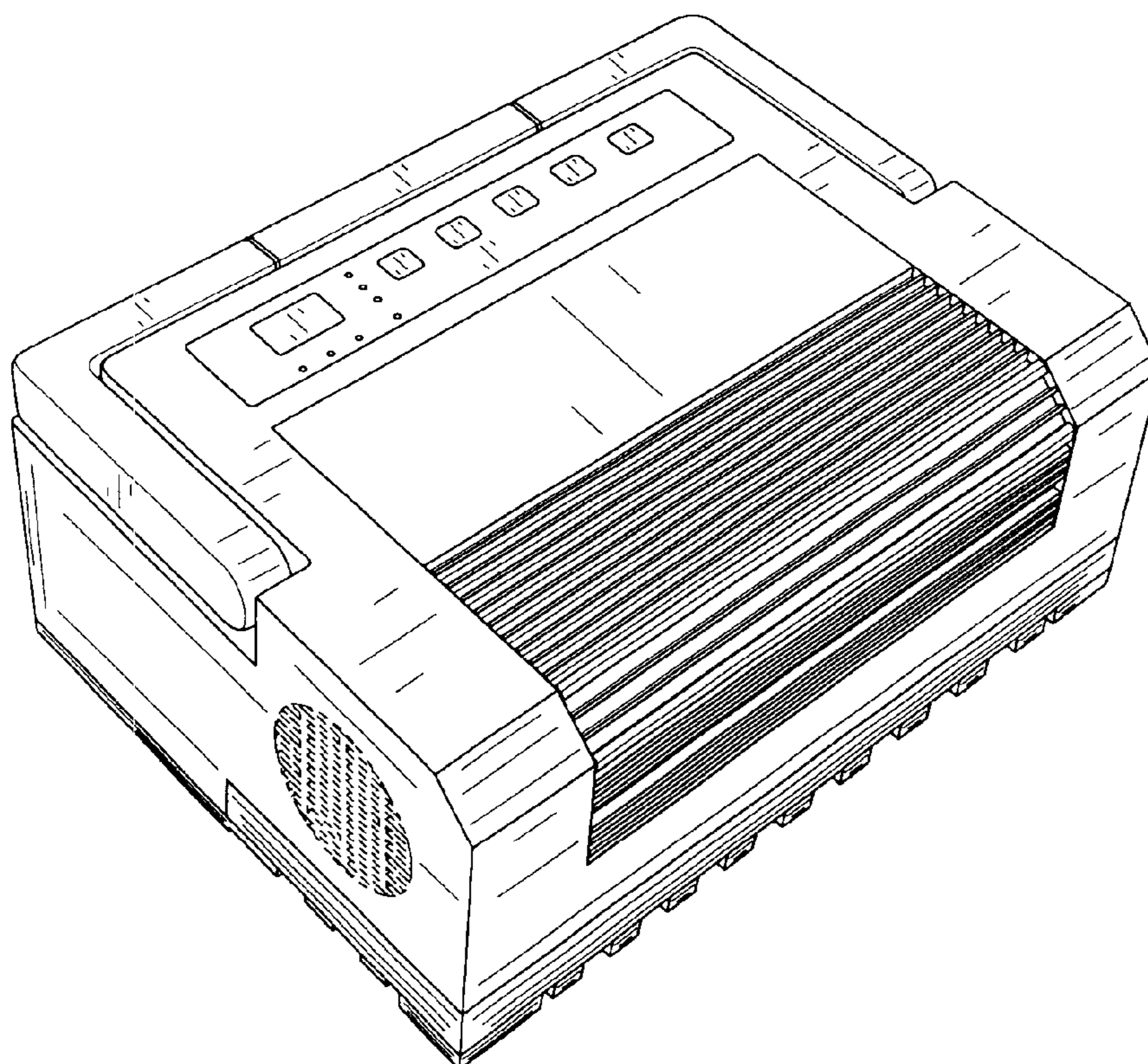
The ornamental design for a marine battery charger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front-top-left side of the battery charger showing our new design; FIG. 2 is a front view of the design shown in FIG. 1; FIG. 3 is a rear view of the design shown in FIG. 1; FIG. 4 is a left side view of the design shown in FIG. 1; FIG. 5 is a right side view of the design shown in FIG. 1; FIG. 6 is a top view of the design shown in FIG. 1; FIG. 7 is a bottom view of the design shown in FIG. 1; and, FIG. 8 is a perspective view as shown in FIG. 1 with the top handle being lifted up.

The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are for illustrative purposes only; the broken lines form no part of the claimed design.

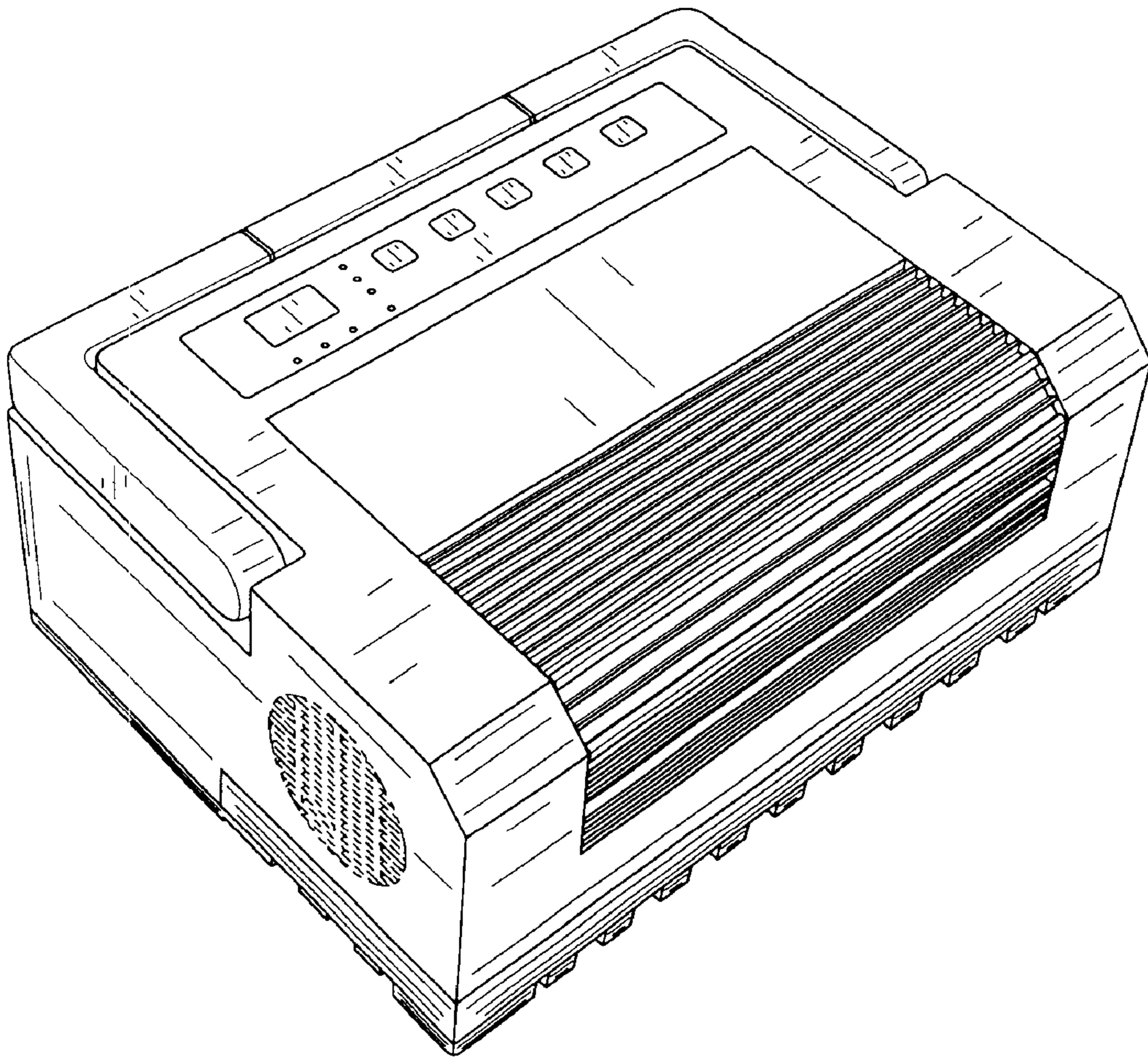

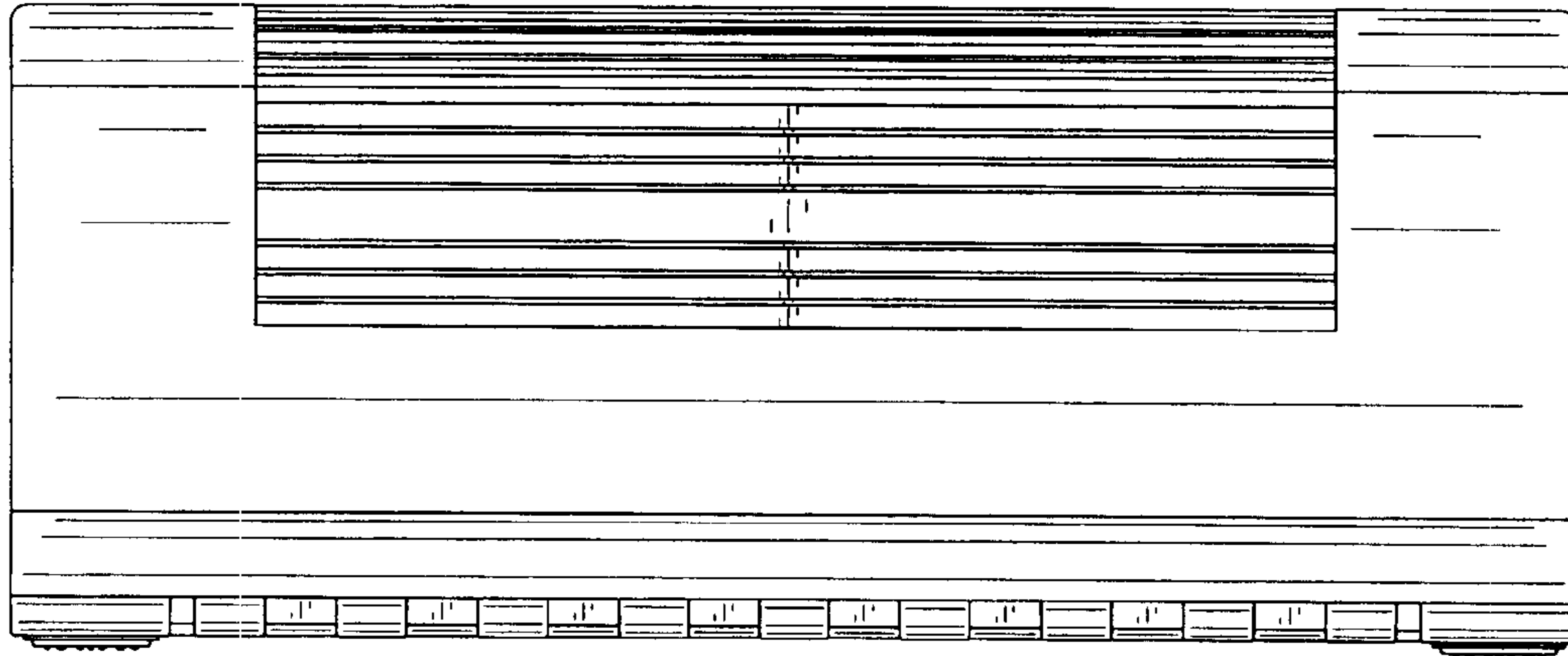

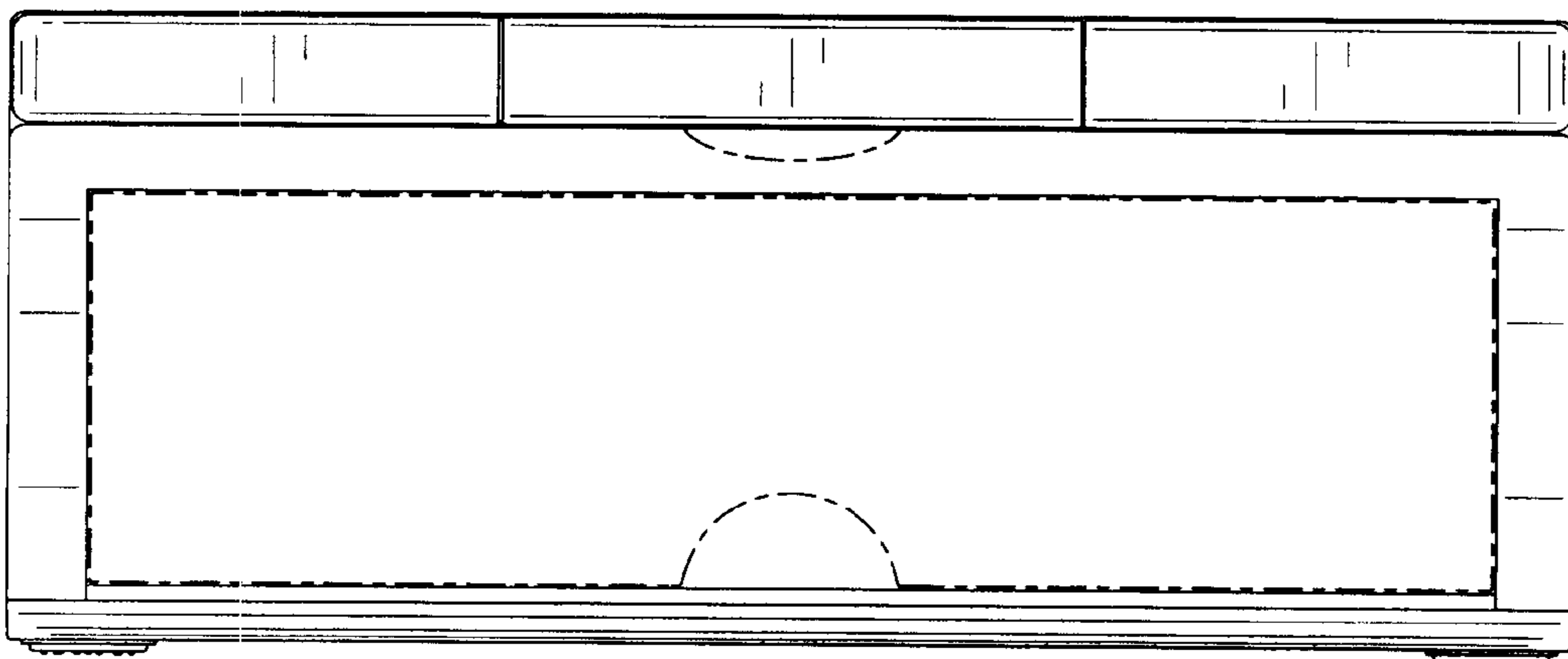

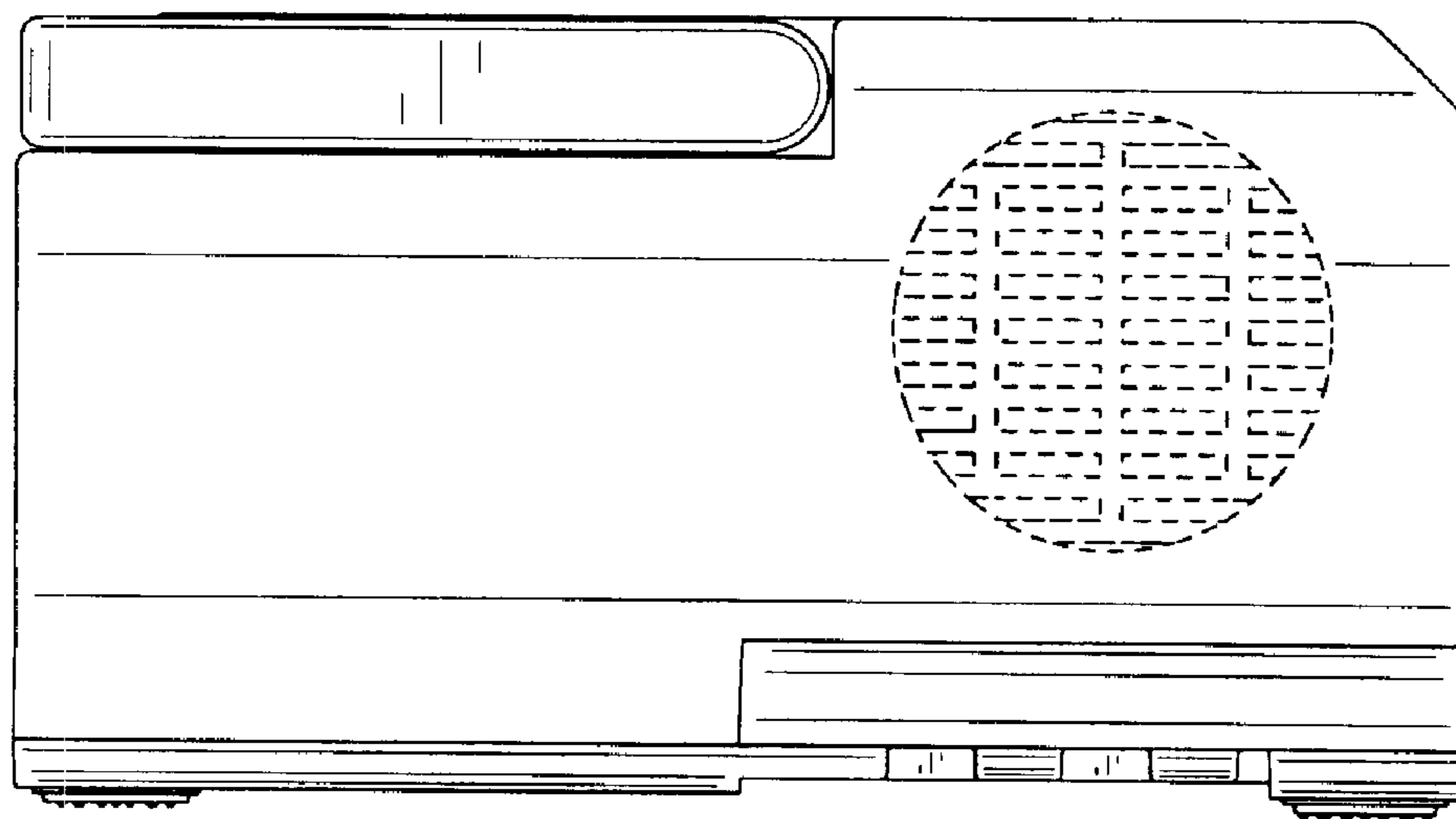

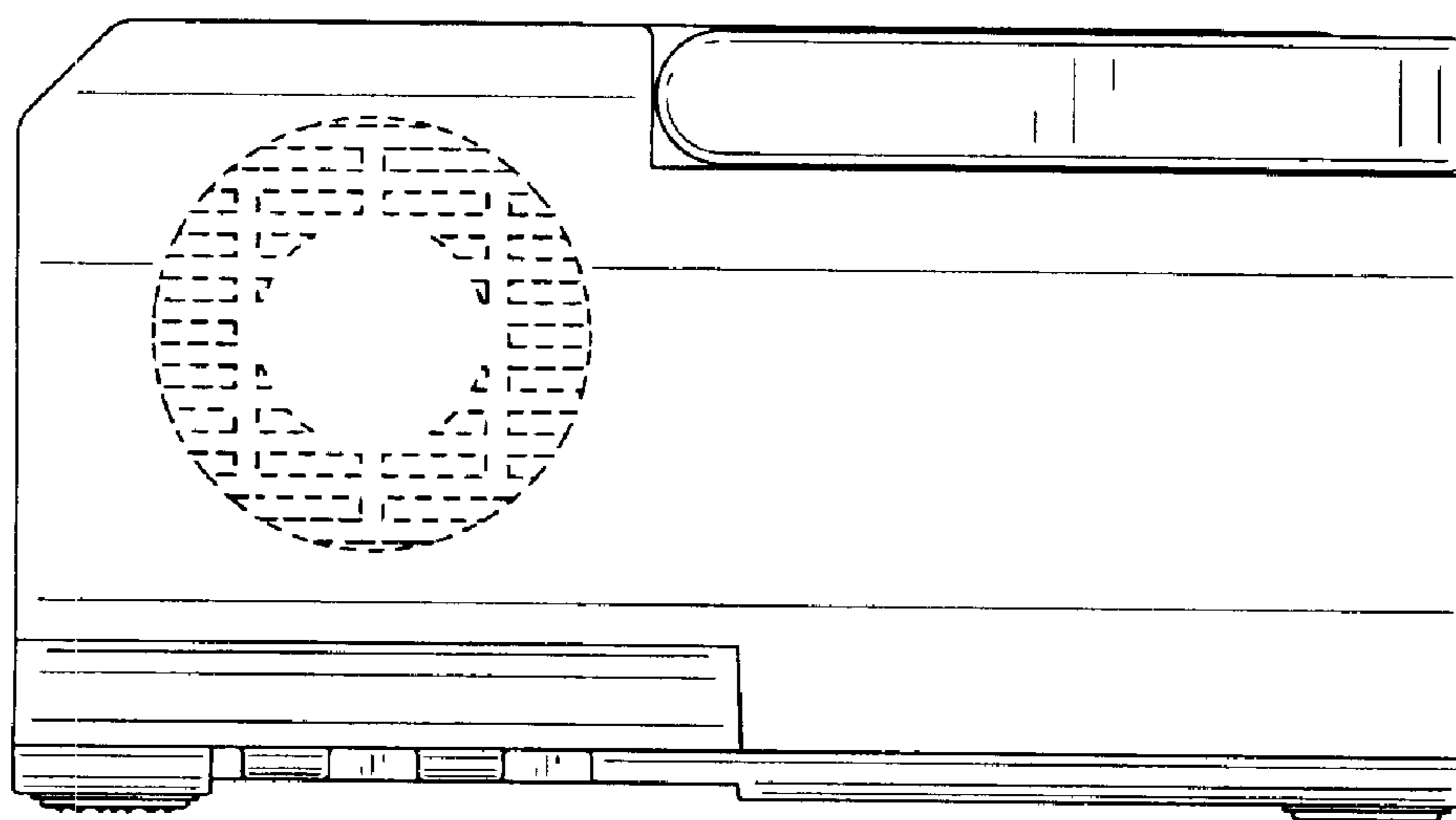

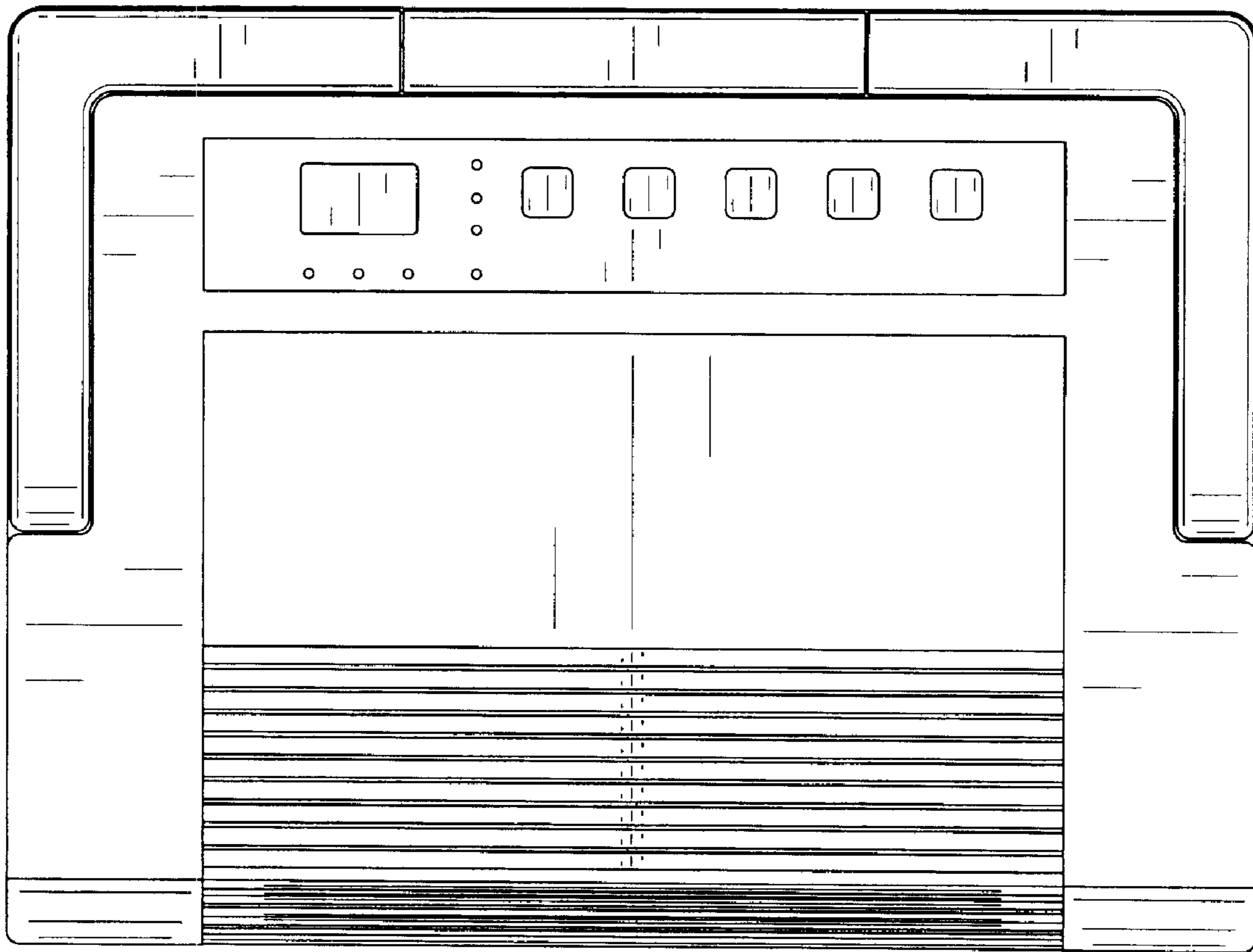

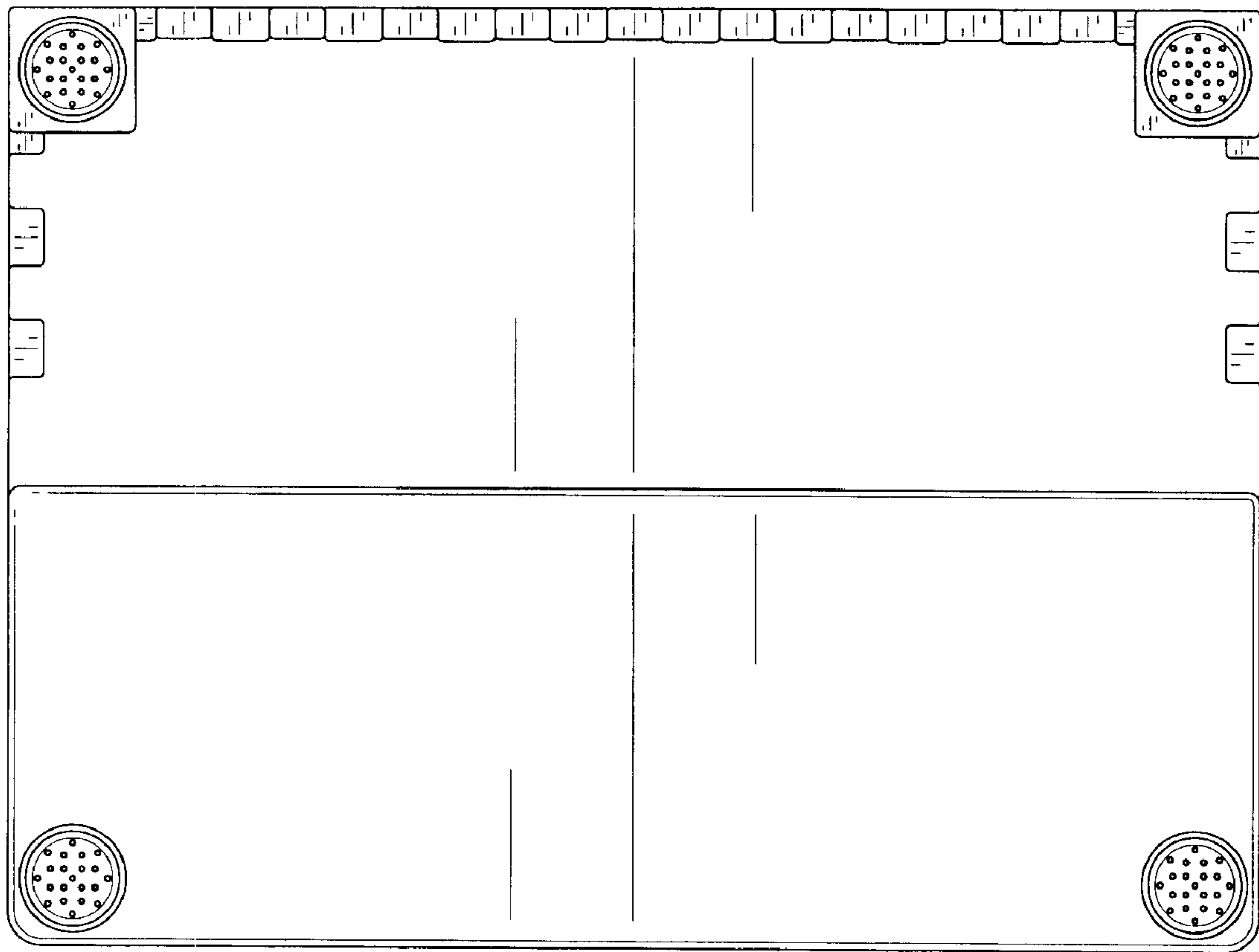

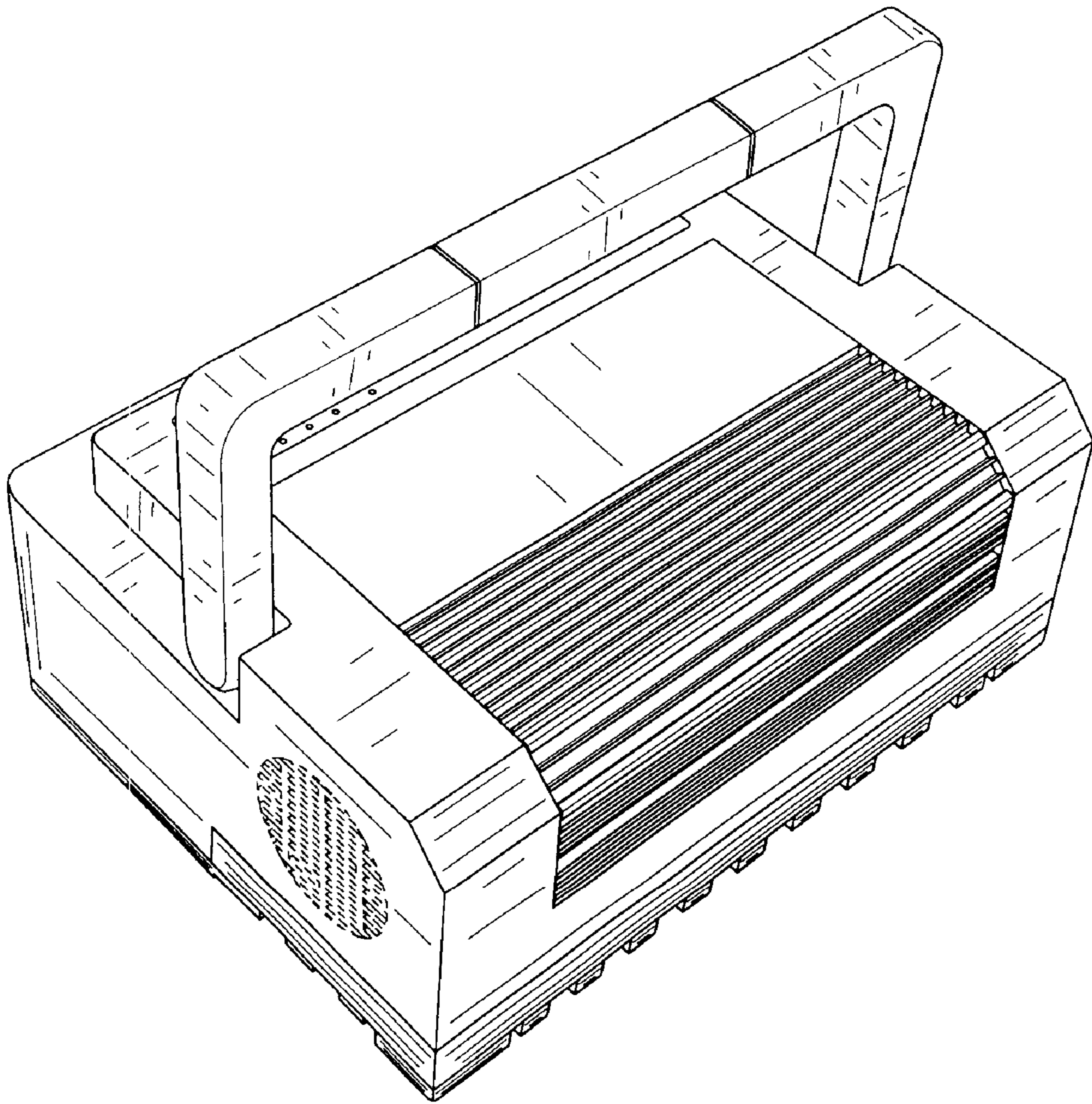
