FIG. 5 is a top, front and right side perspective view of a second embodiment of our new design, being an array of four of the speakers shown in FIGS. 1–4;

FIG. 8 is a bottom plan view thereof.

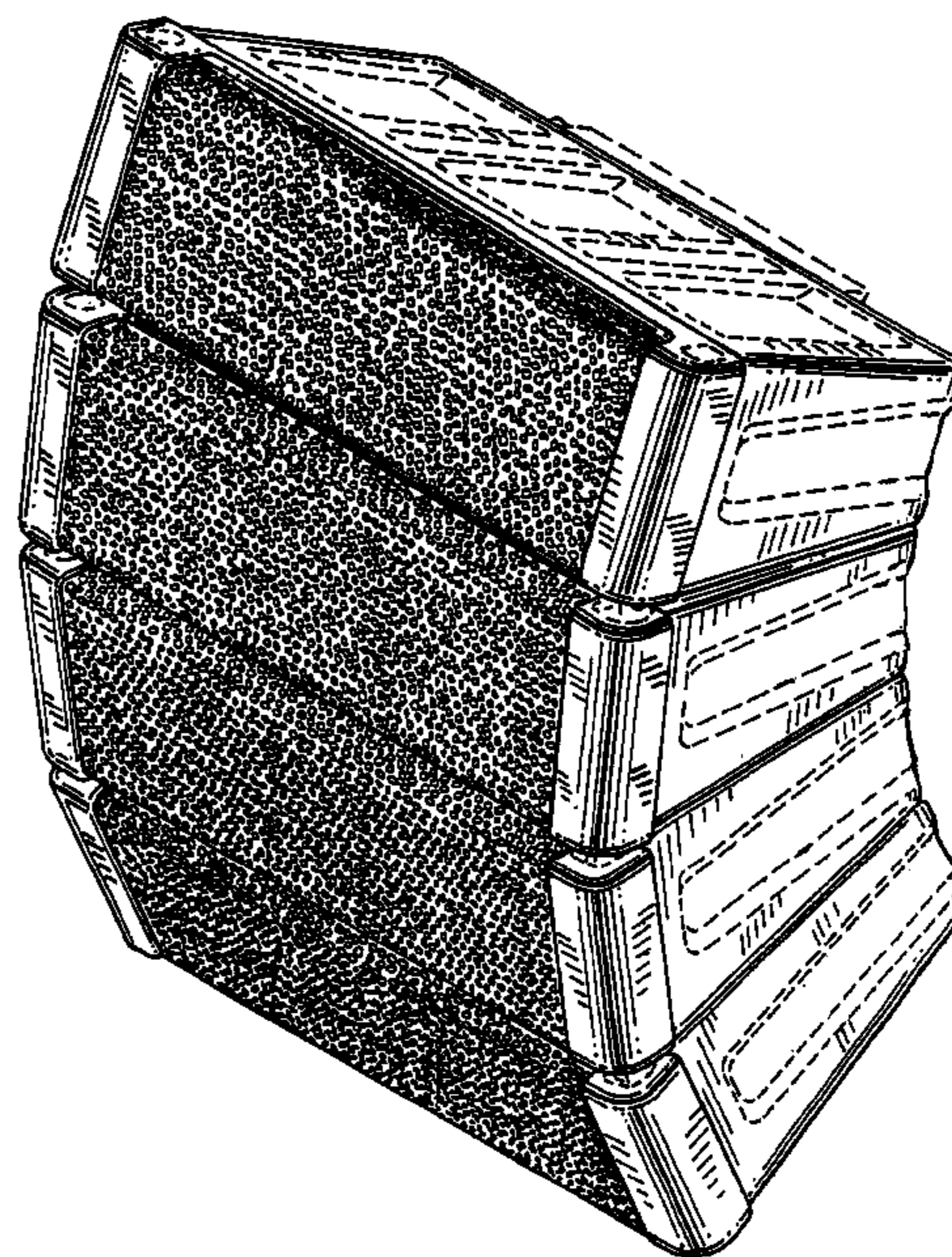
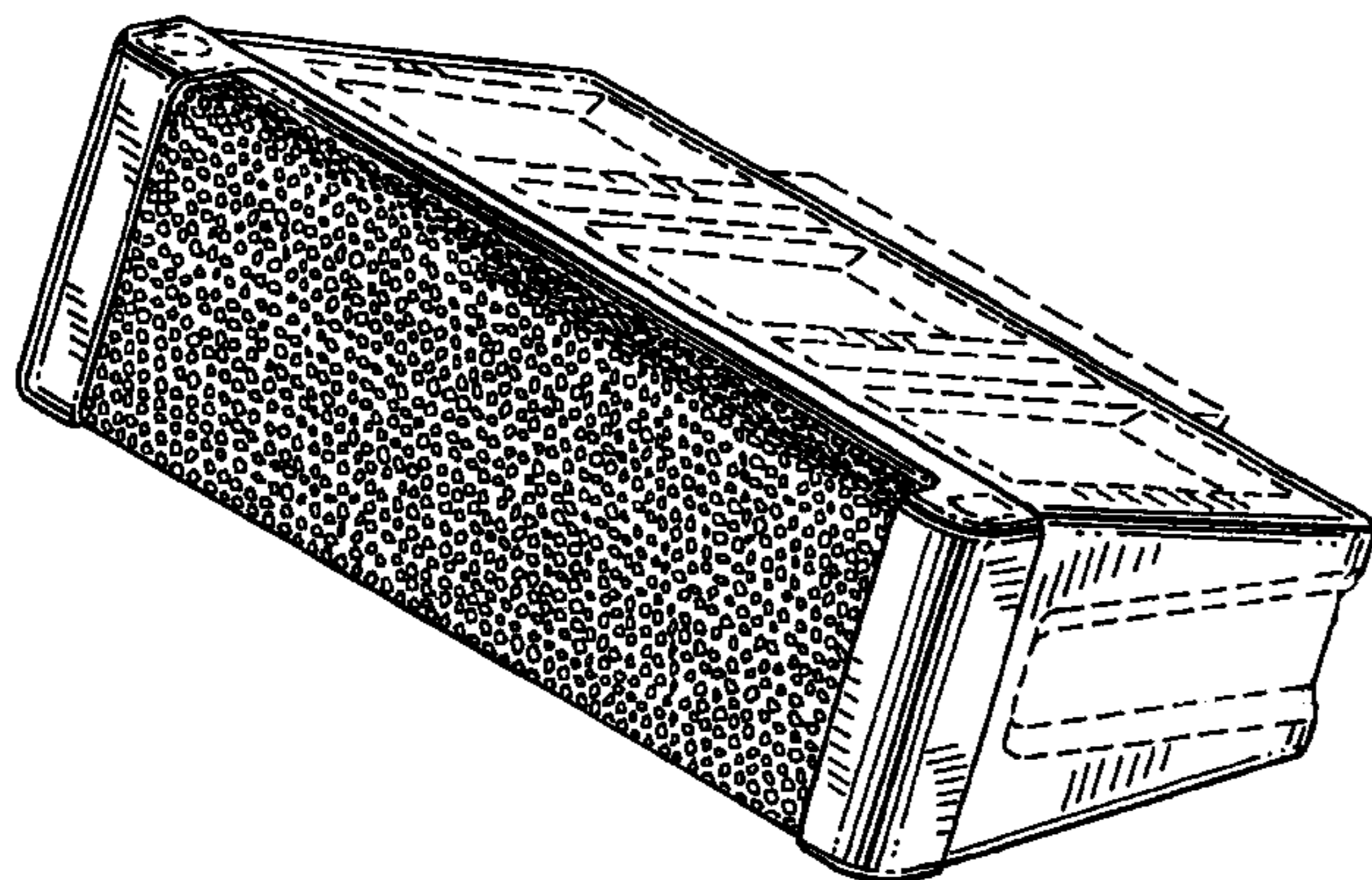

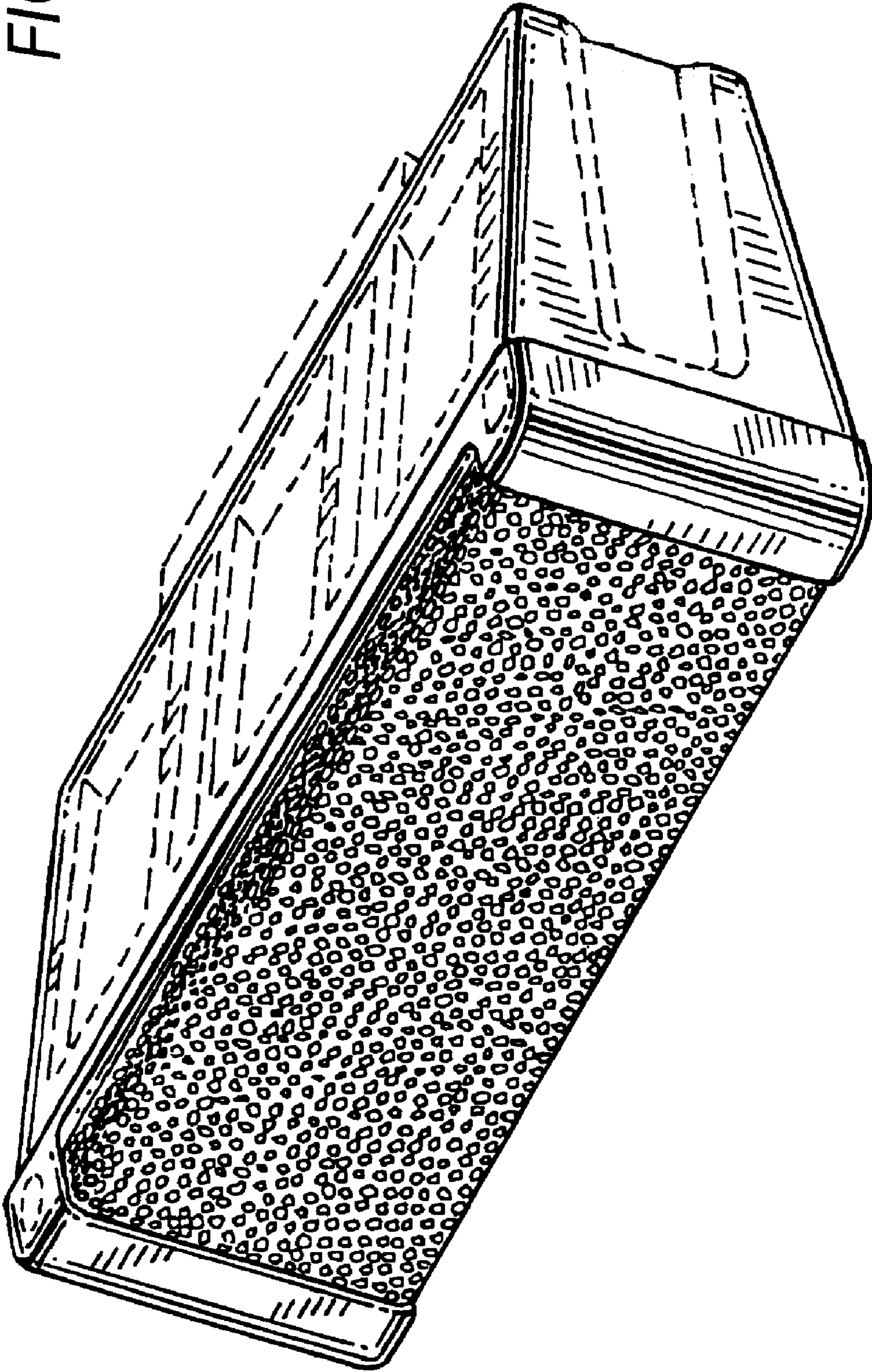

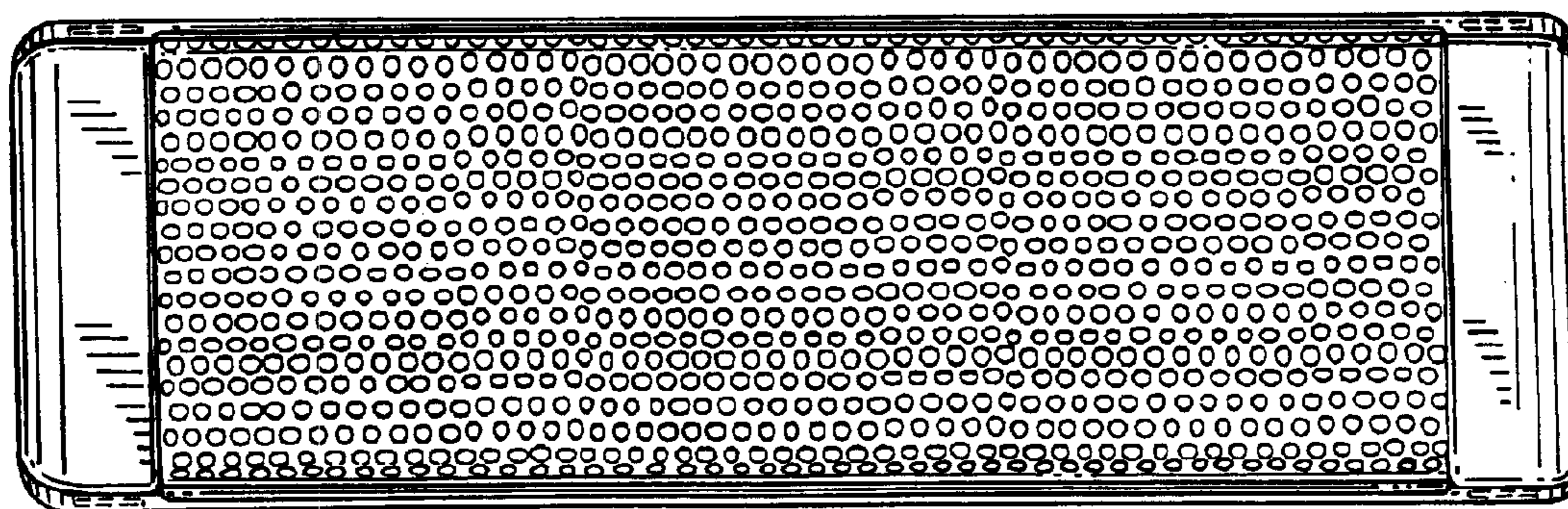
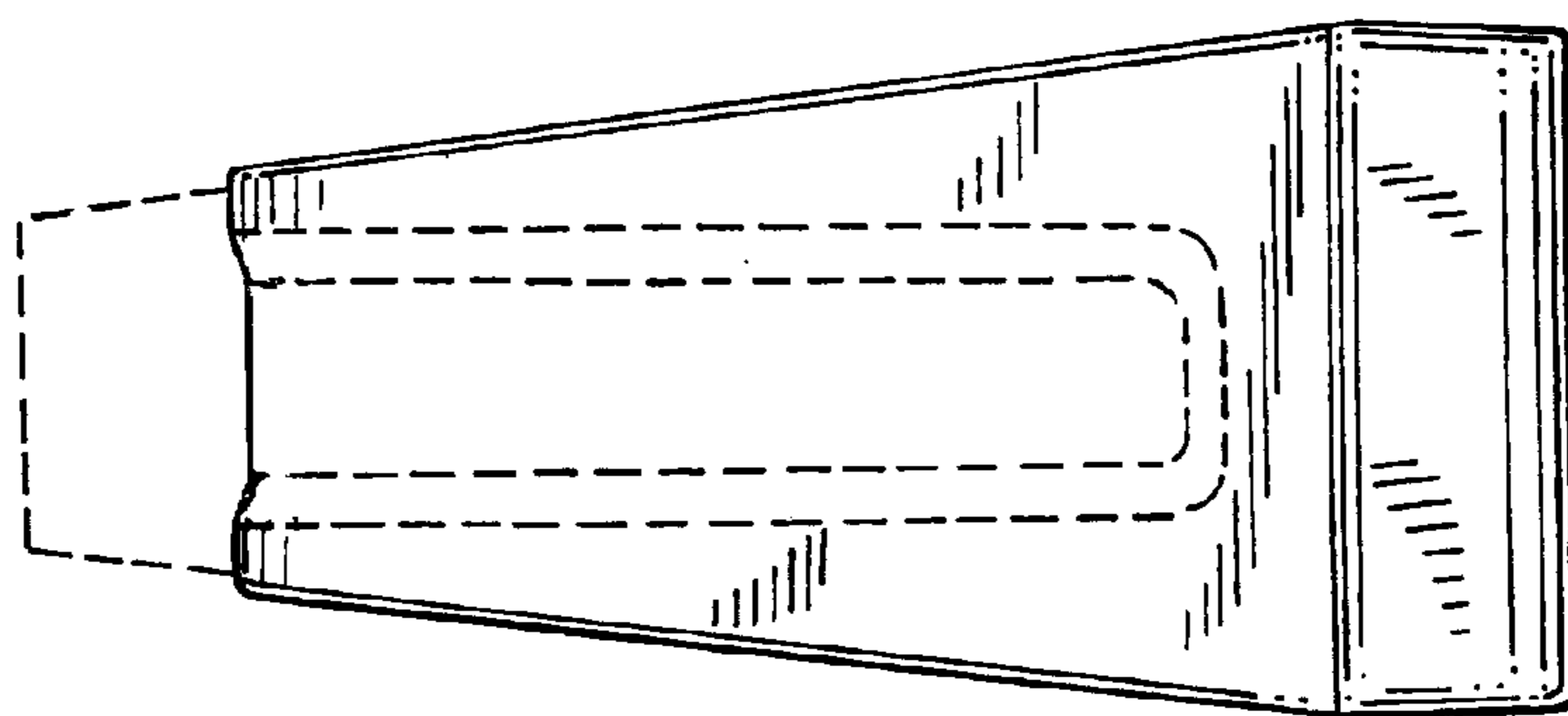

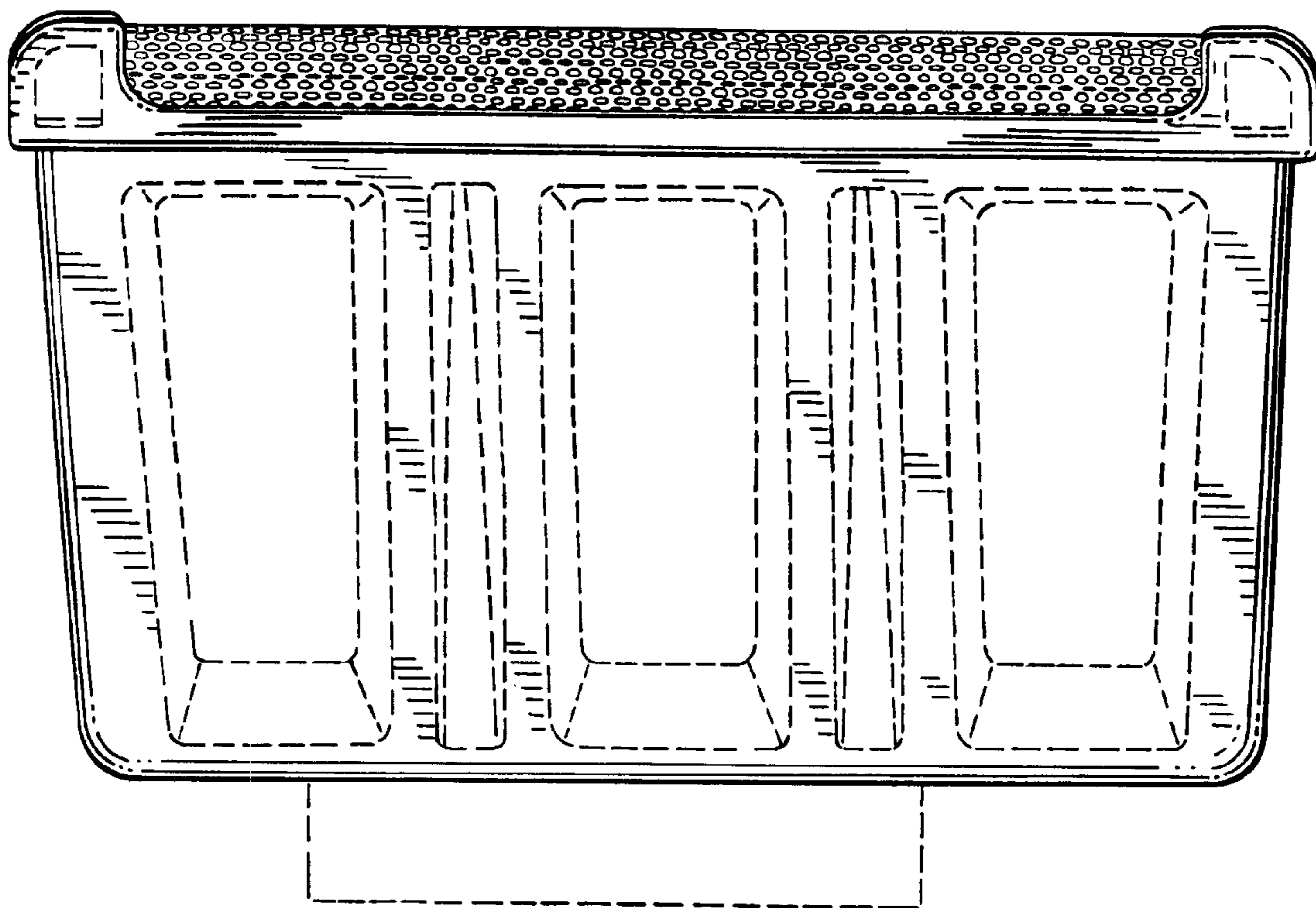

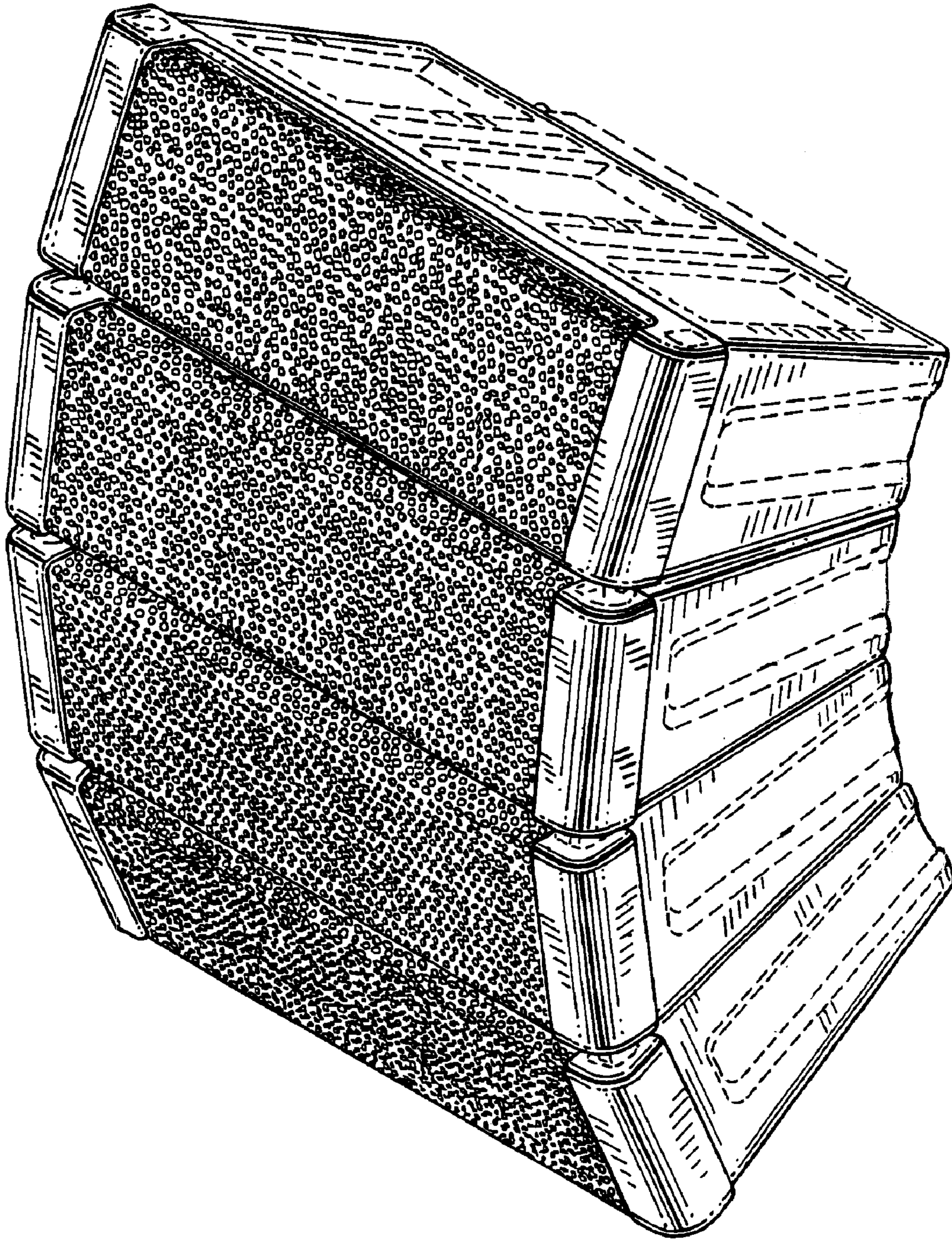

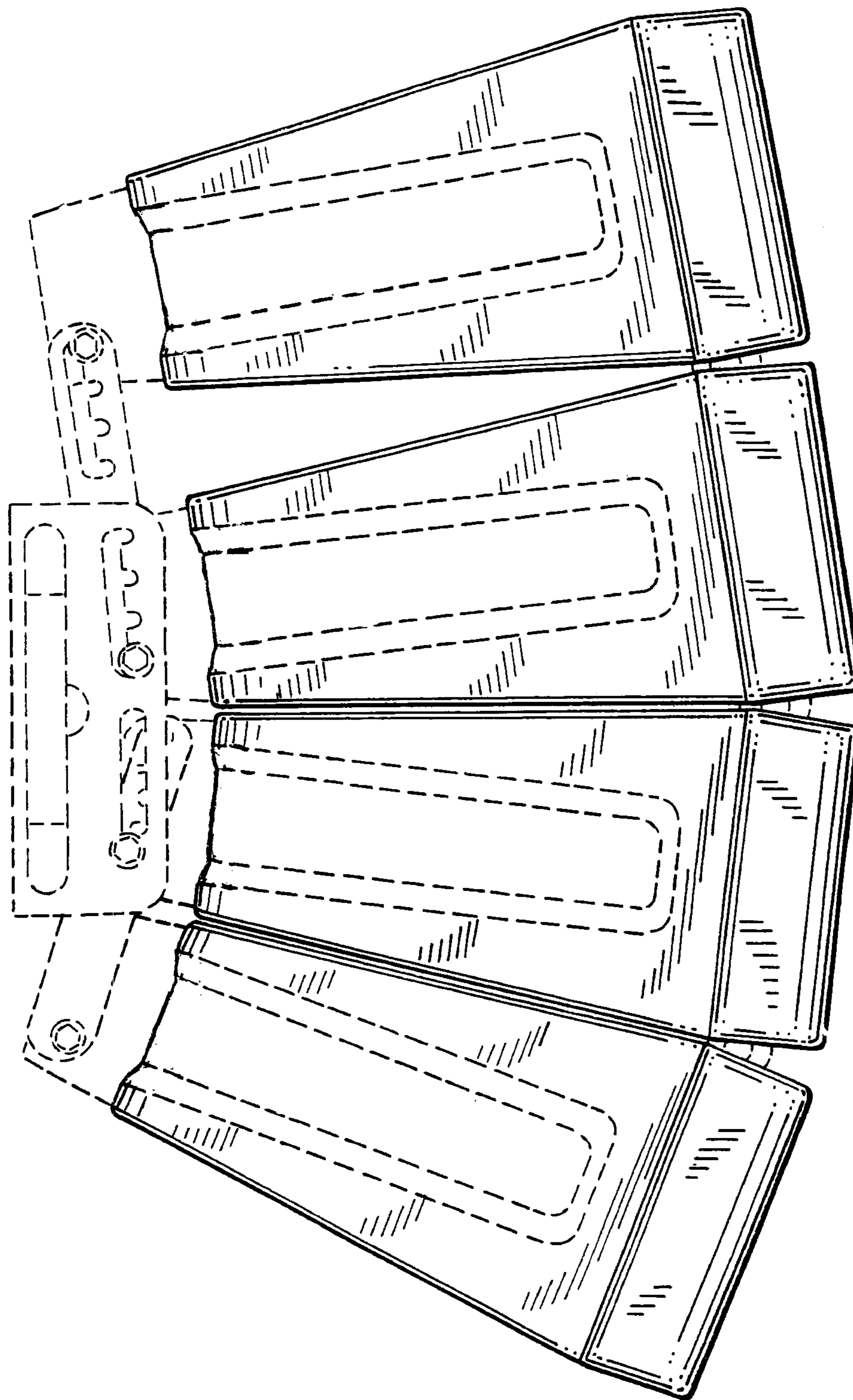

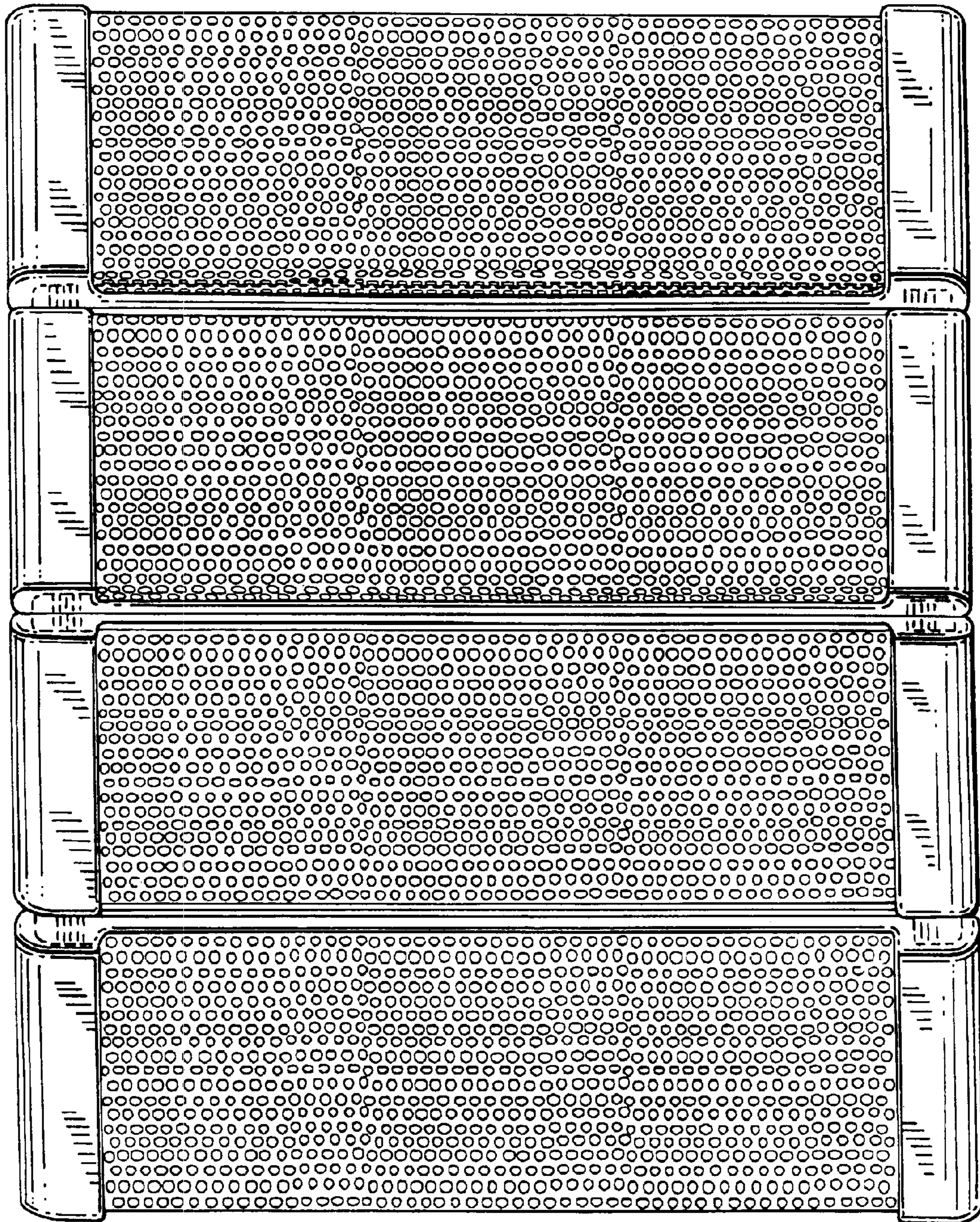

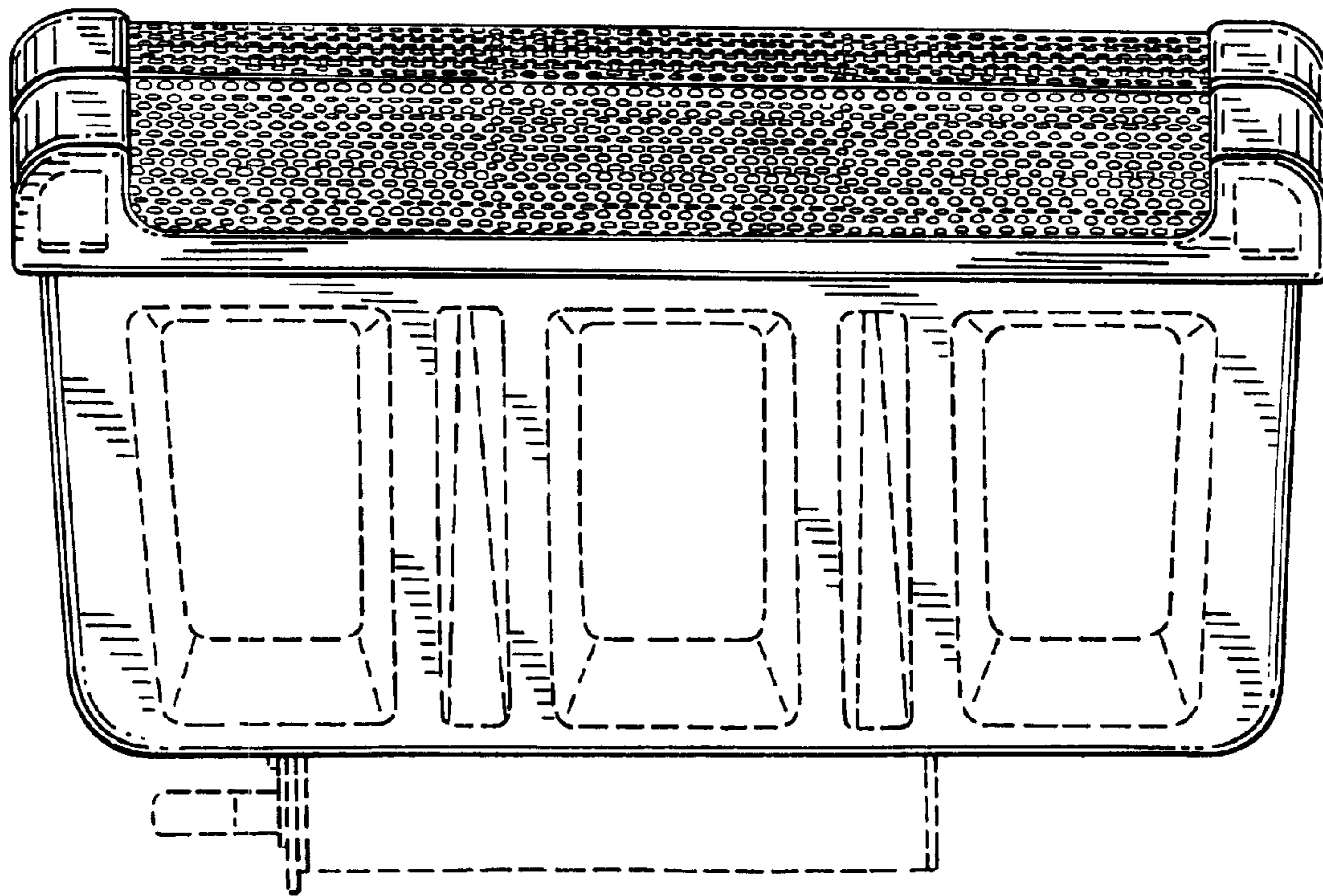
