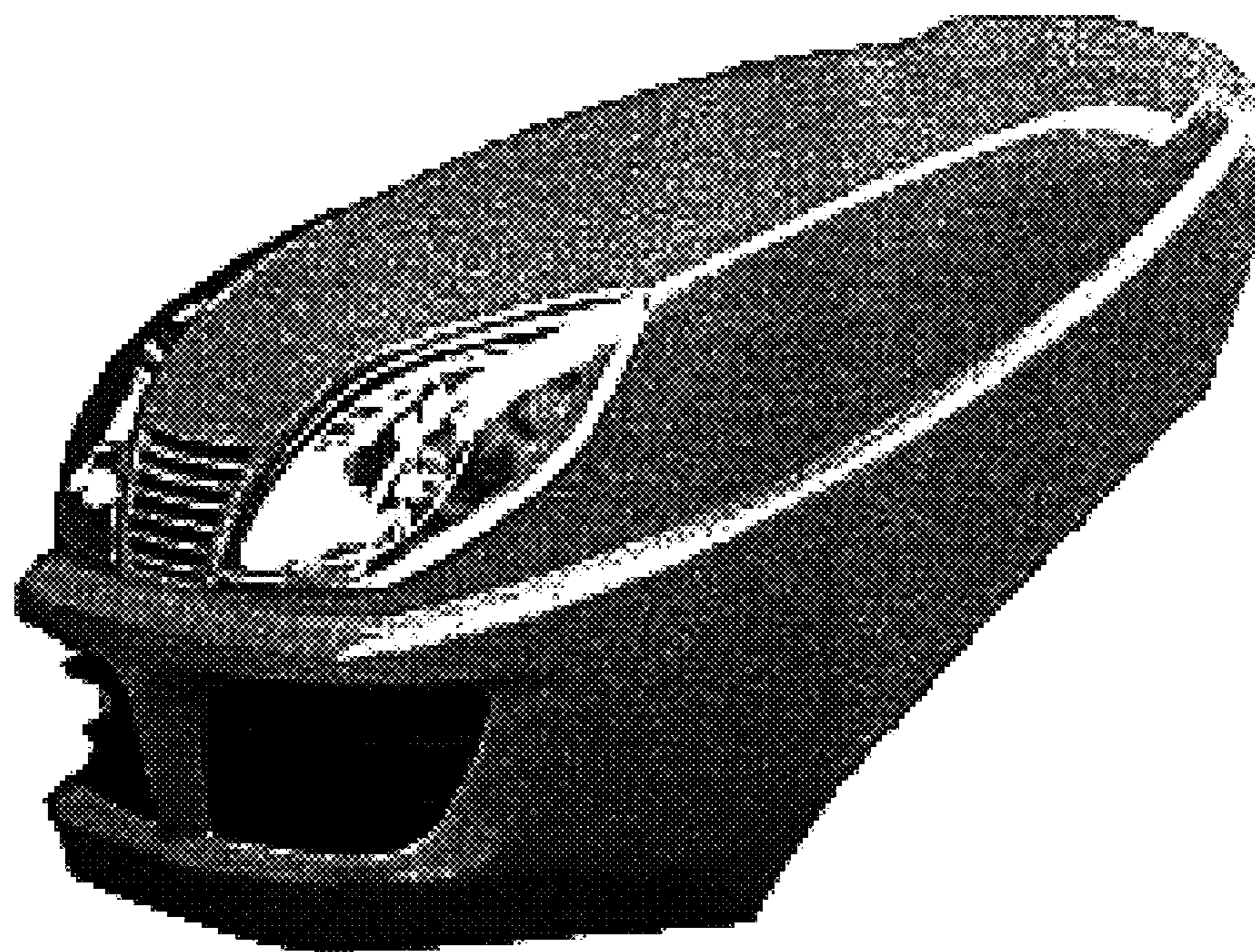
(57) **CLAIM**

The ornamental design for a hood portion of a riding-type mower, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view looking at the right front of a Hood Portion Of A Riding-Type Mower;
FIG. 2 is a perspective view looking at the left front thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a side view of the left side thereof;
FIG. 6 is an enlarged view looking at the right side thereof; and
FIG. 7 is a perspective view similar to FIG. 1. However, the part of the photograph shown in a coarse dot pattern and outlined in dashed lines illustrates a portion of the mower that forms no part of the claimed design.

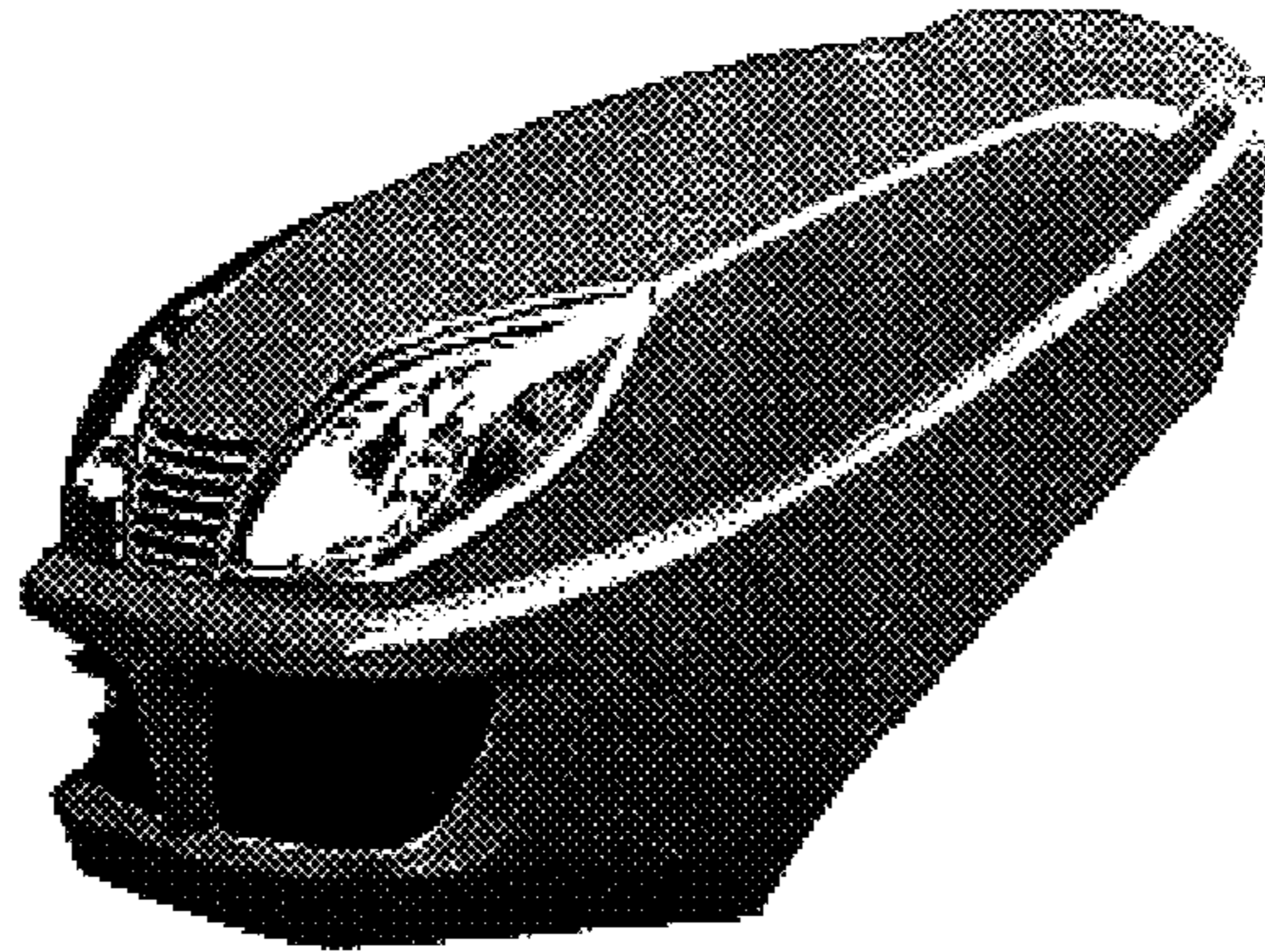

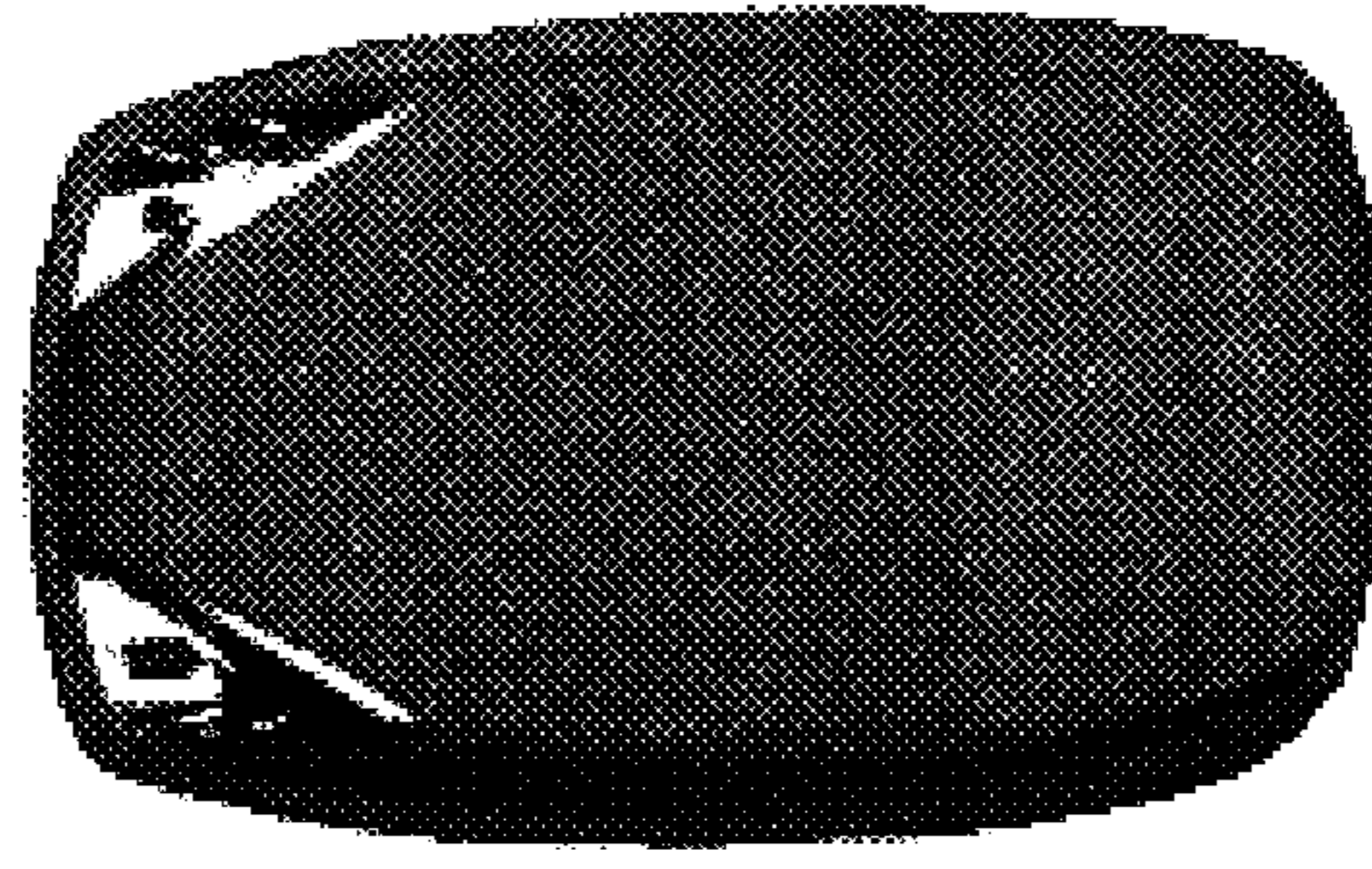

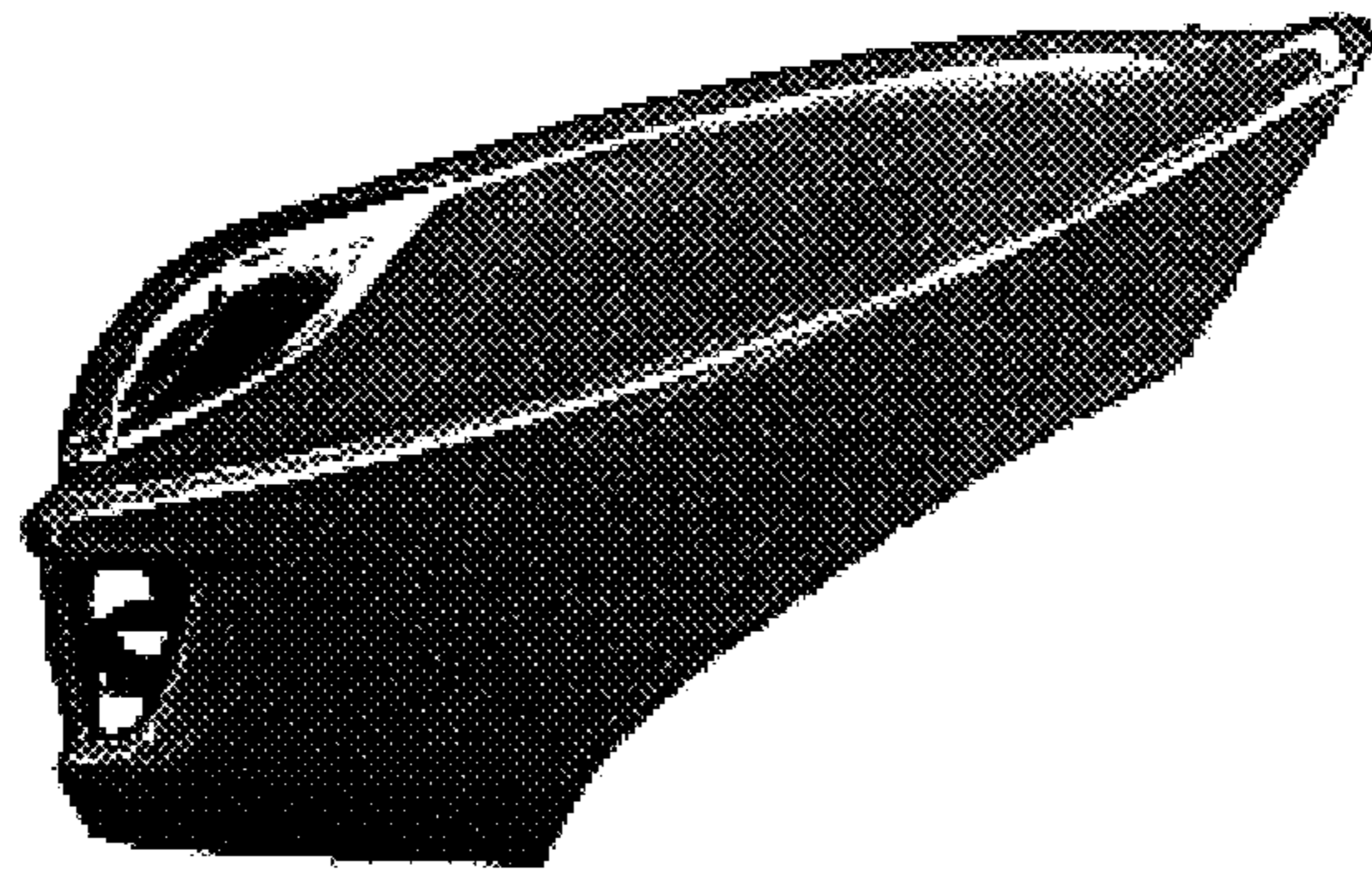

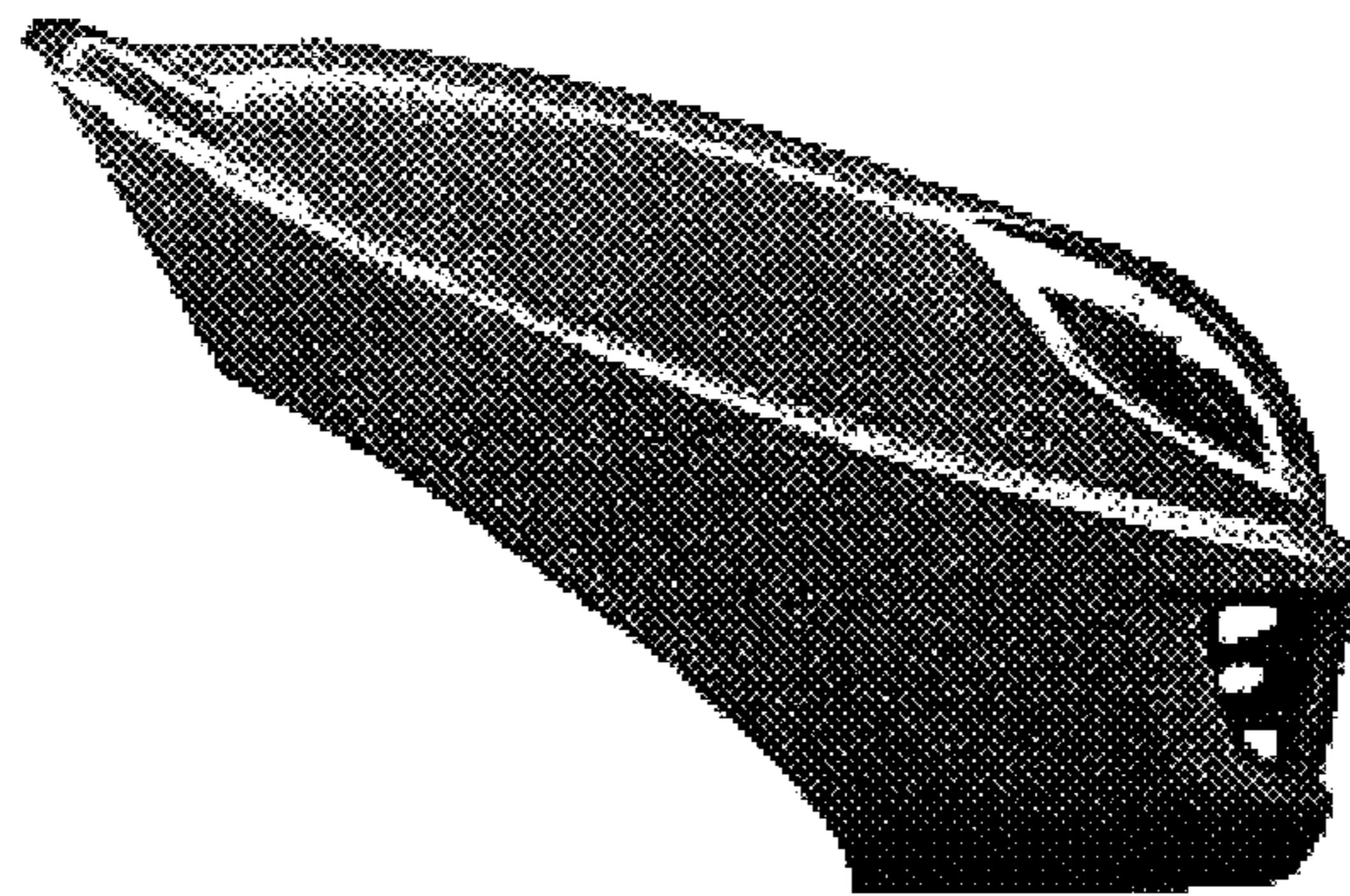

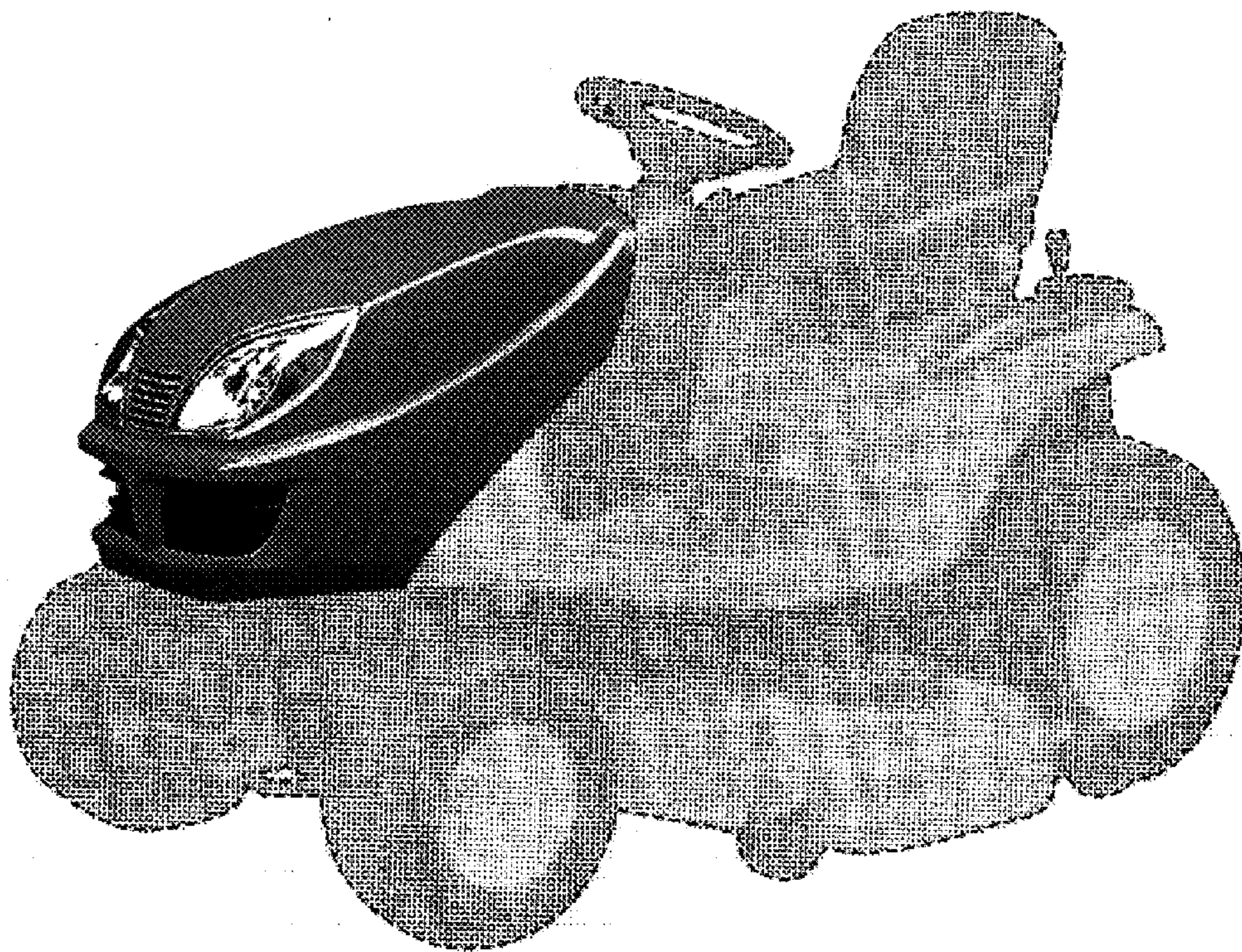
