FIG. 2 is a front elevational view thereof;

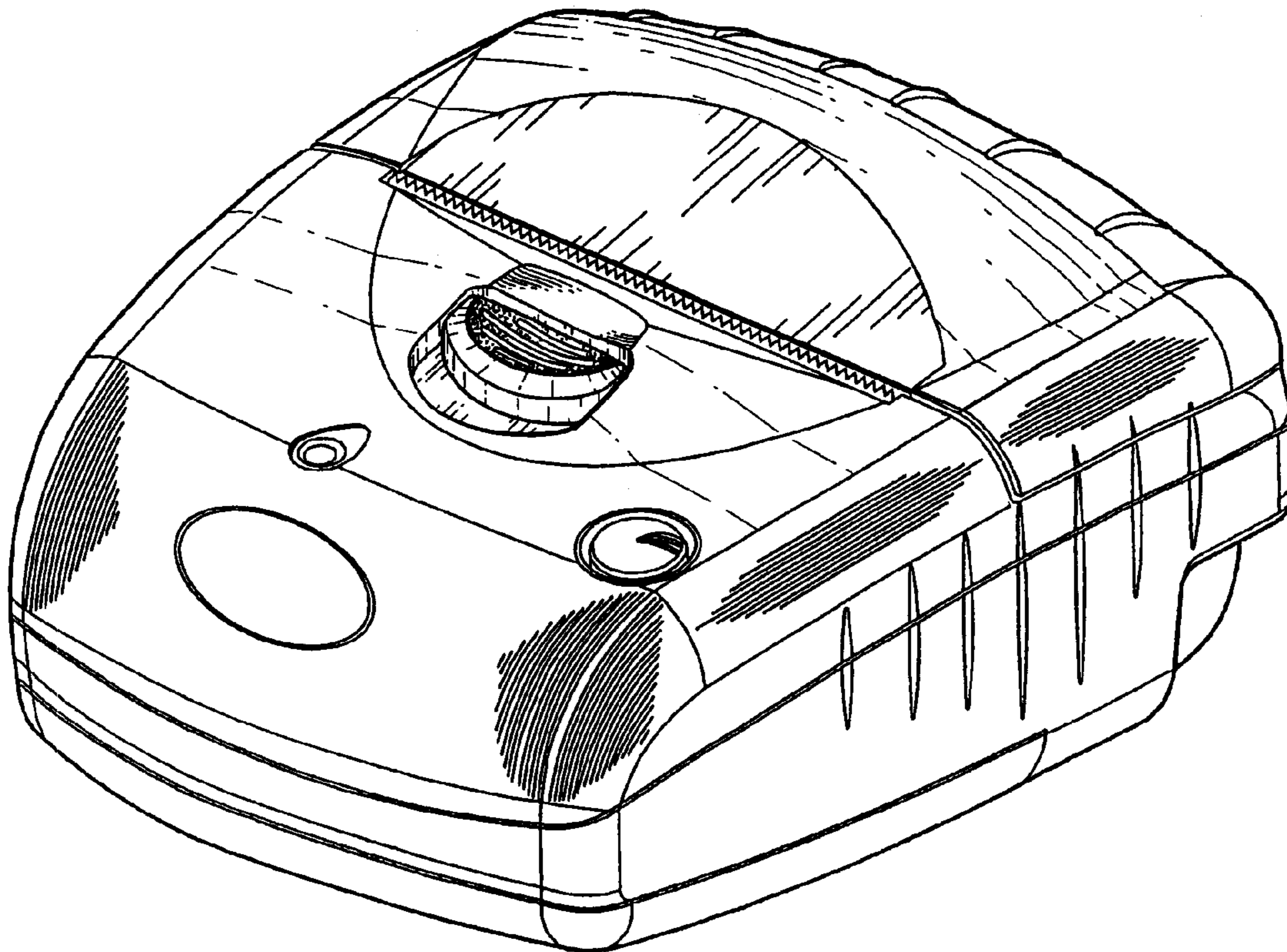
FIG. 3 is a rear elevational view thereof;

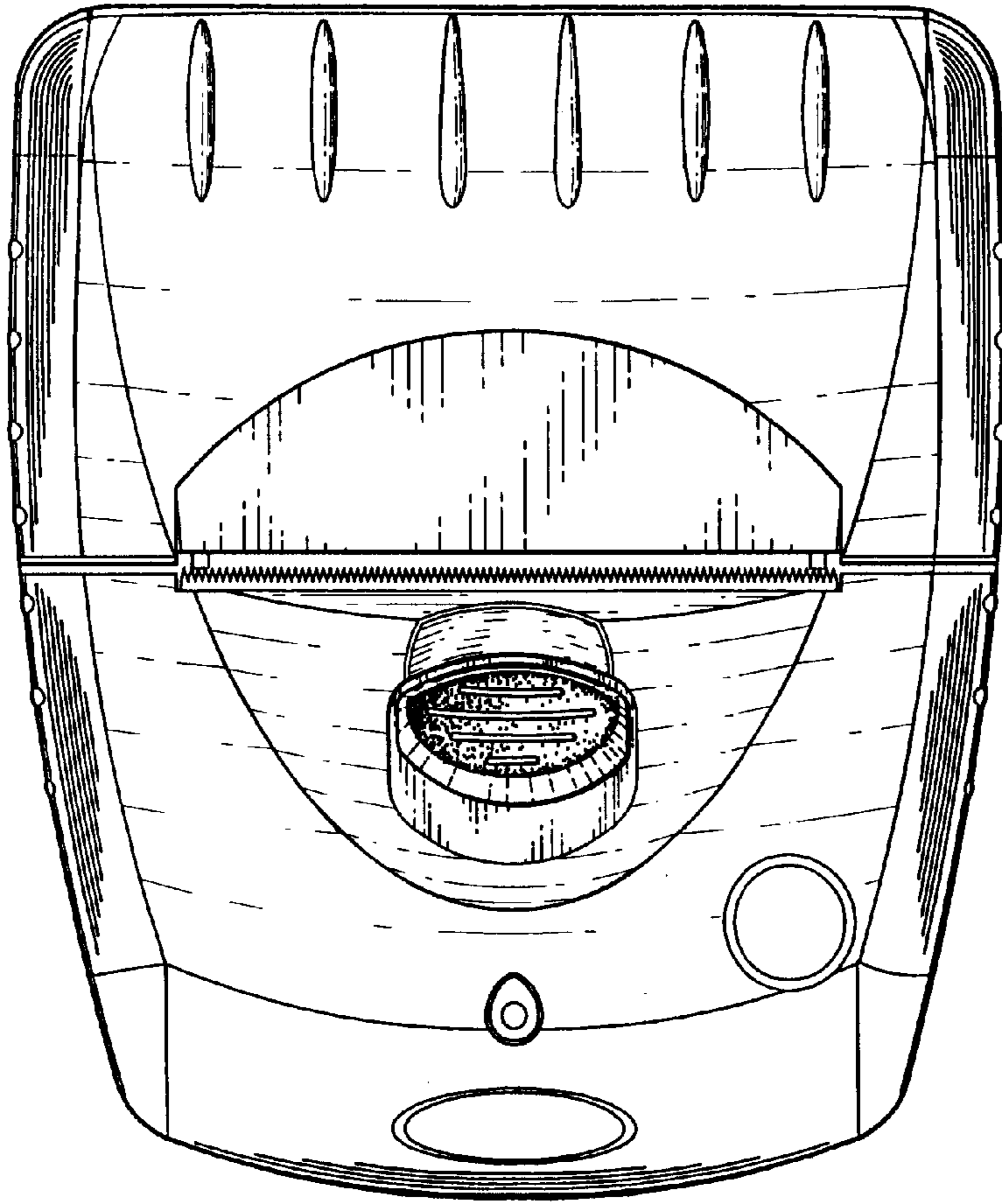
FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side, elevational view thereof; the left side view being symmetrical to the right side view; and,

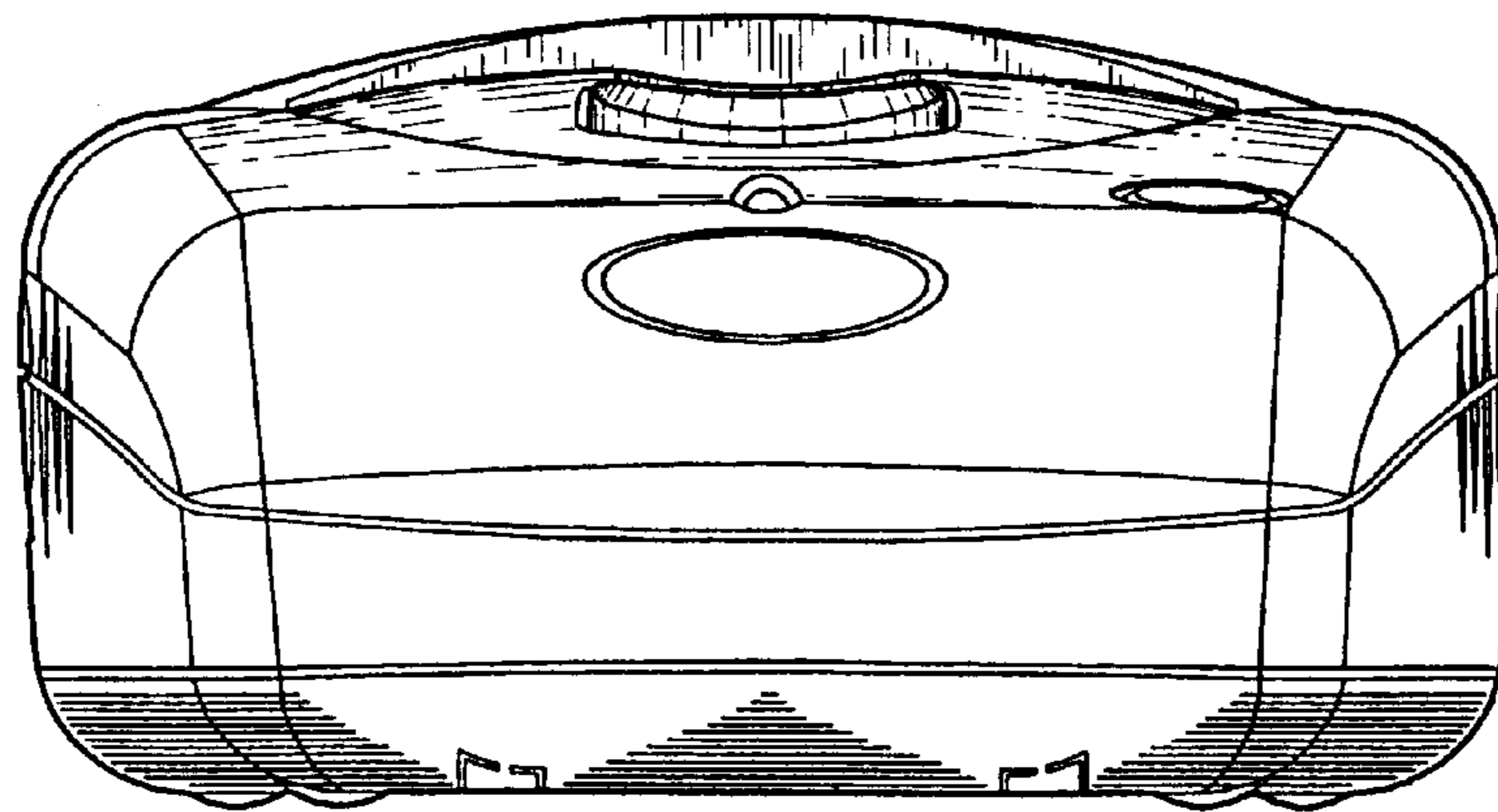
FIG. 6 is a front perspective view thereof.

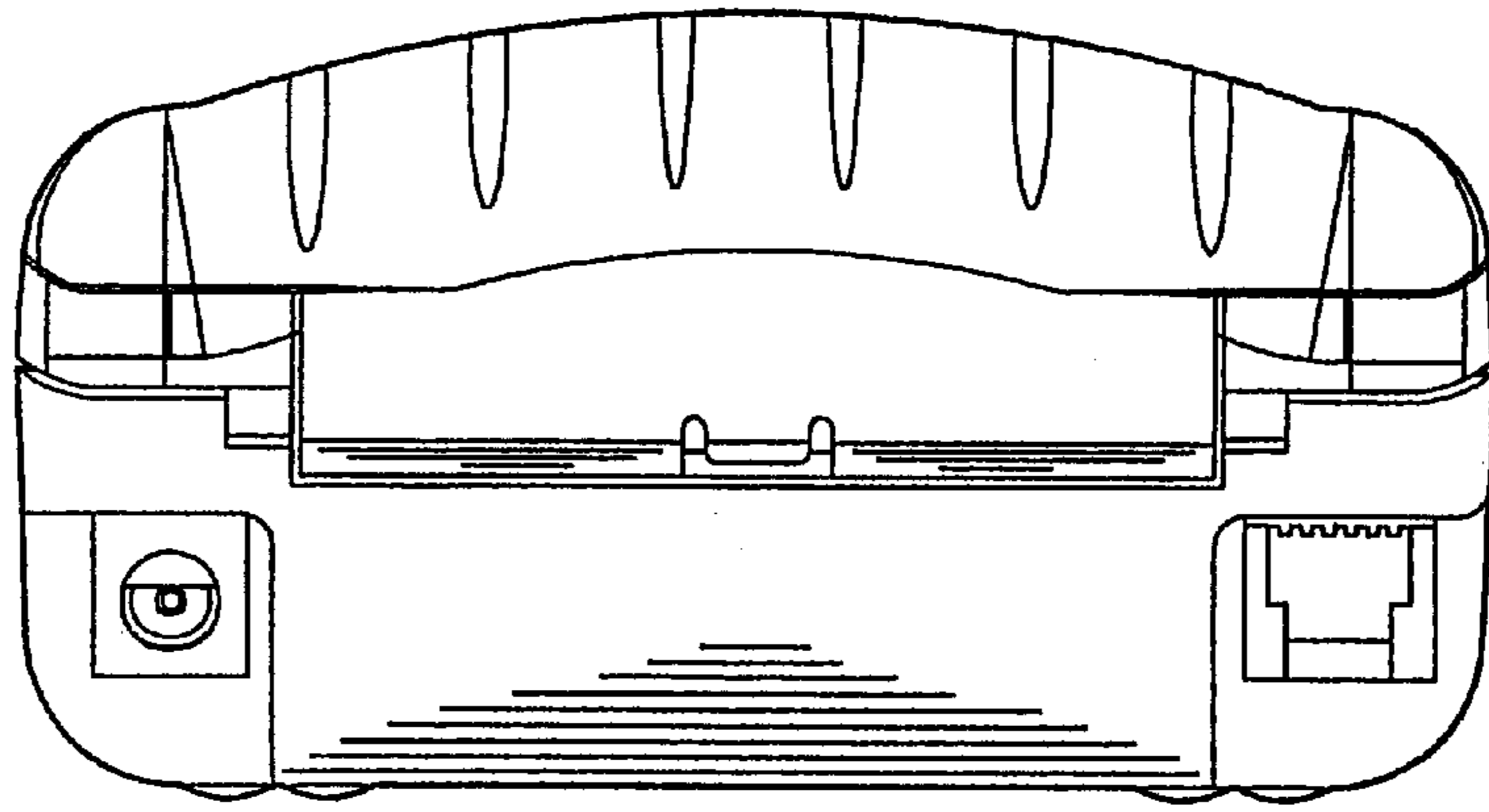




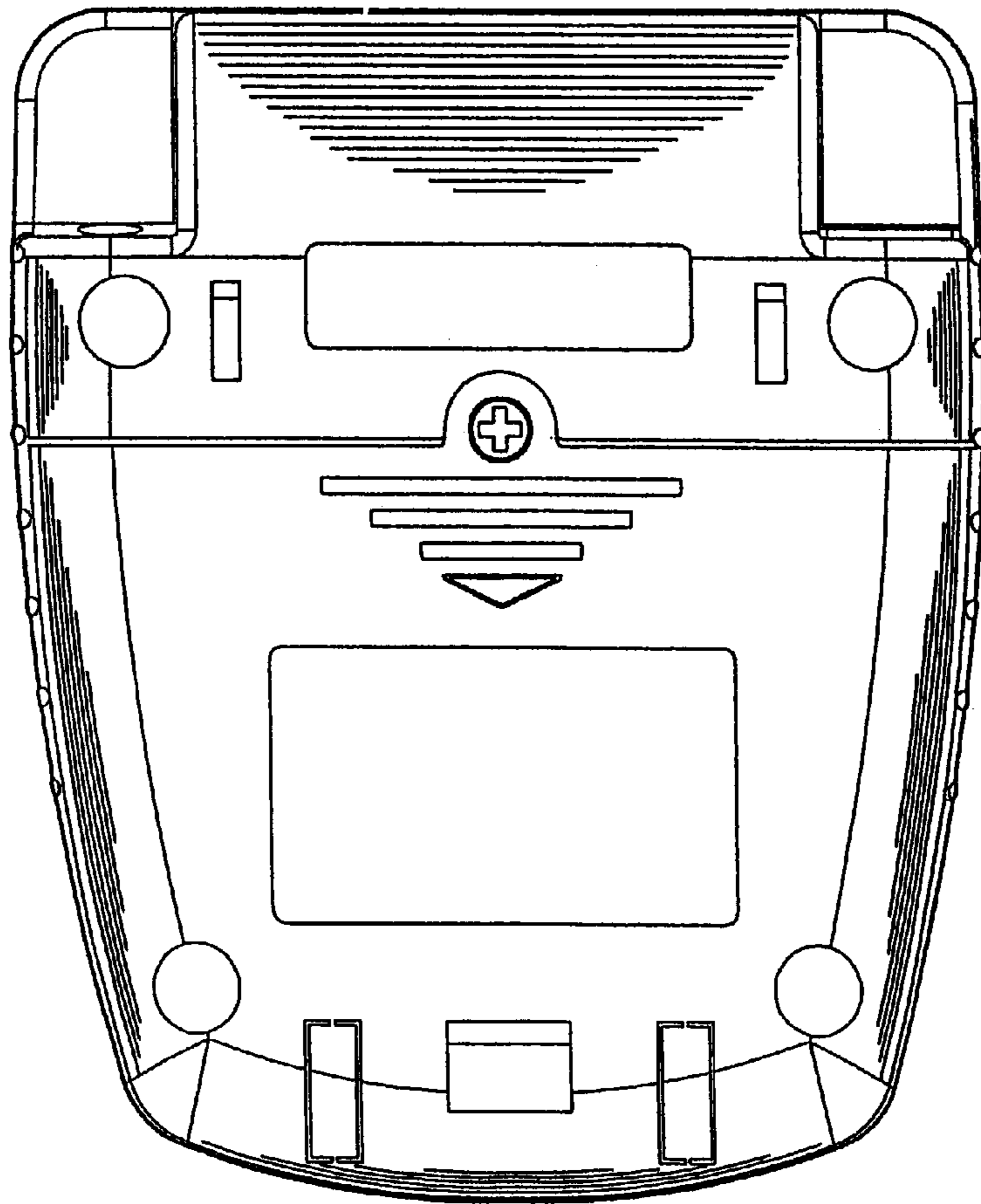

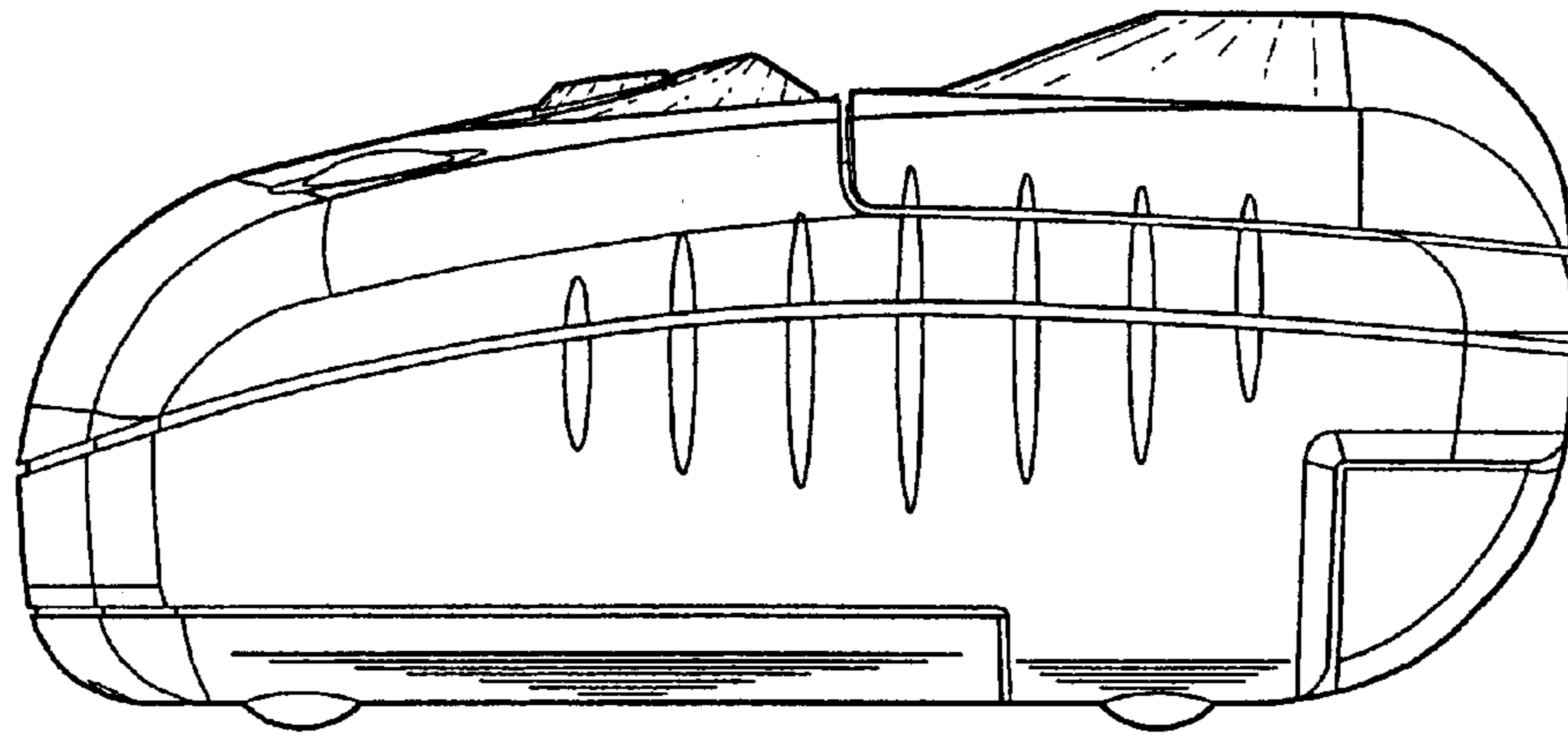

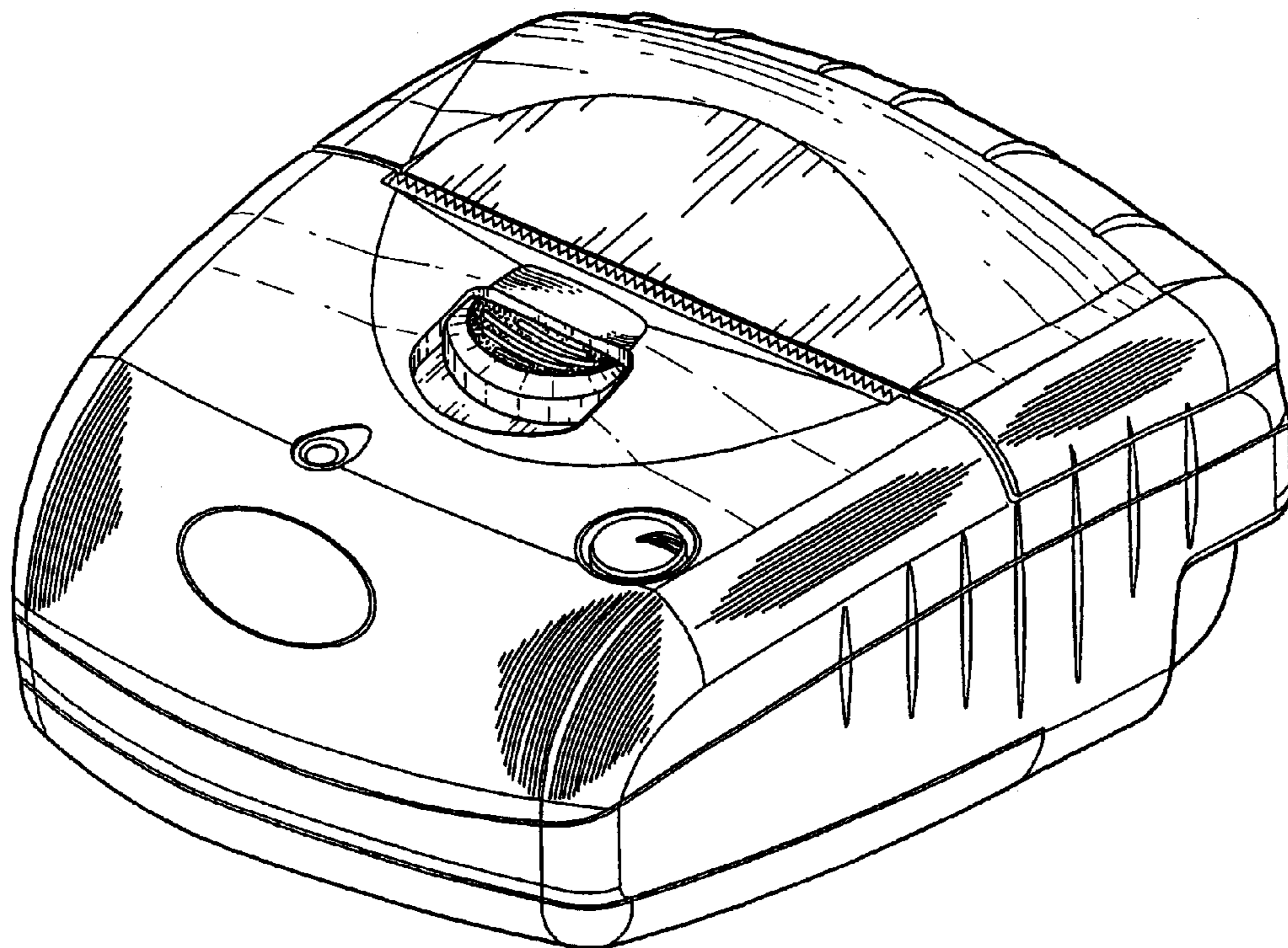
