FIG. 3 is a front elevational view thereof;

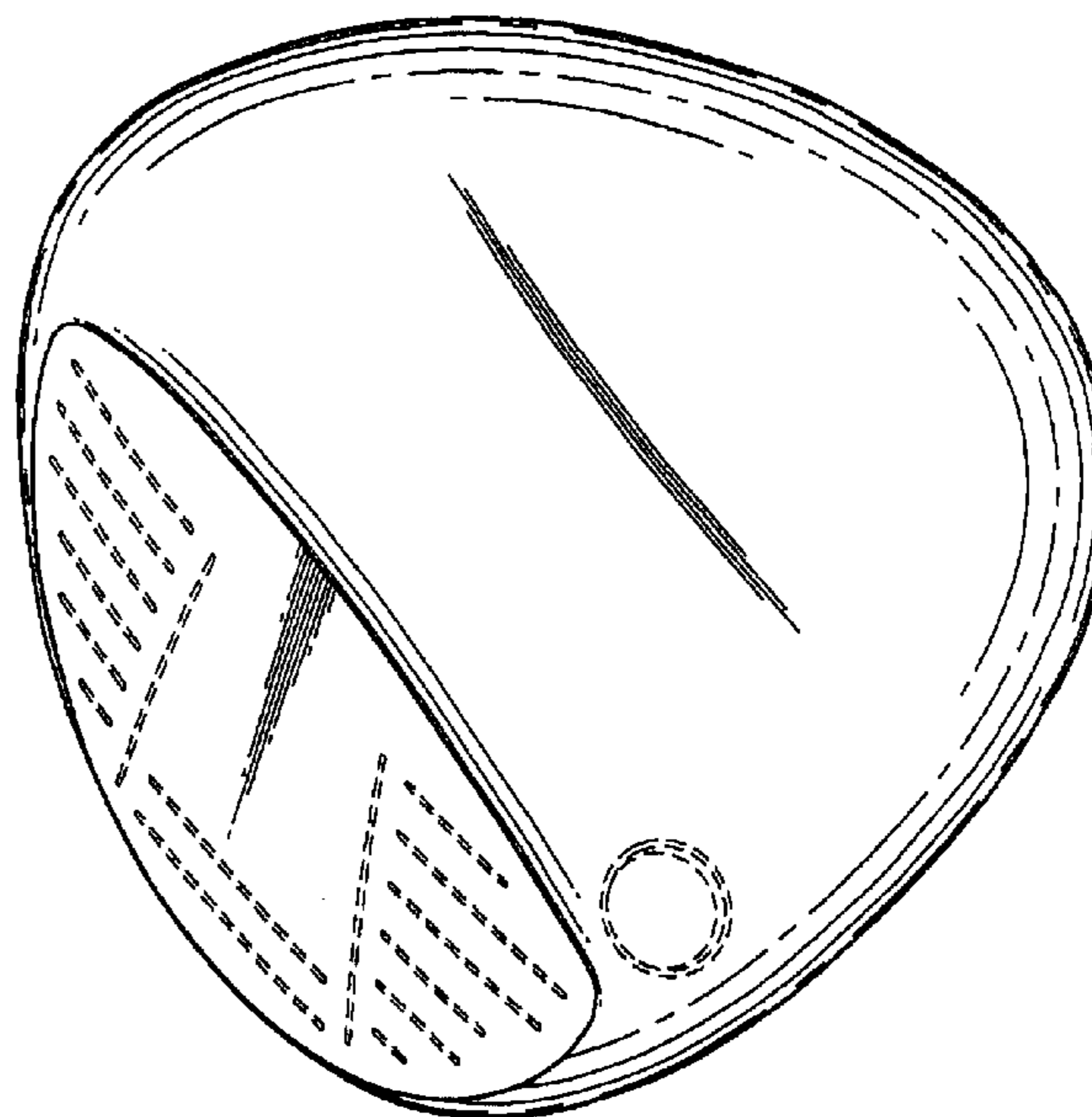
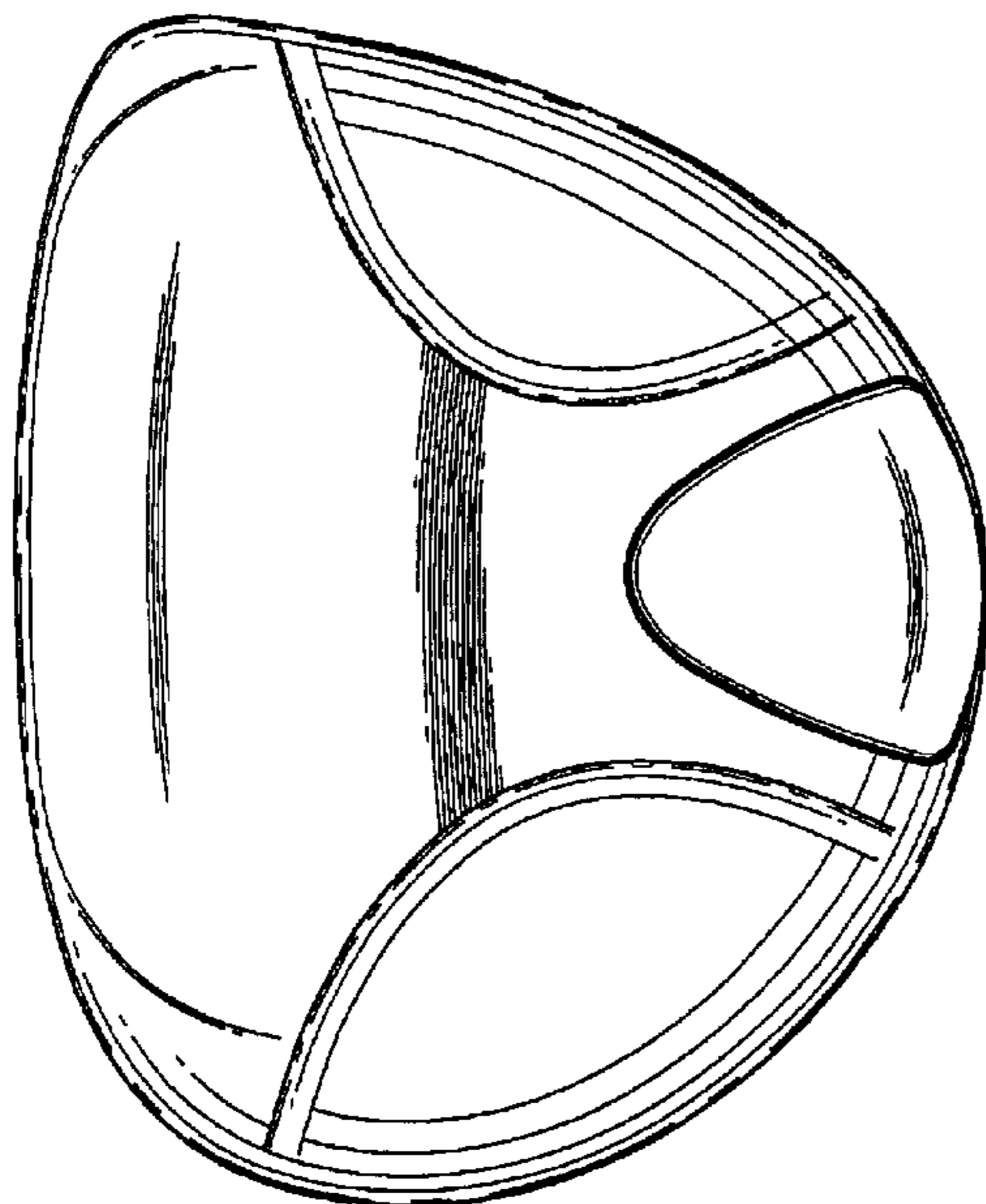
FIG. 4 is a rear elevational view thereof;

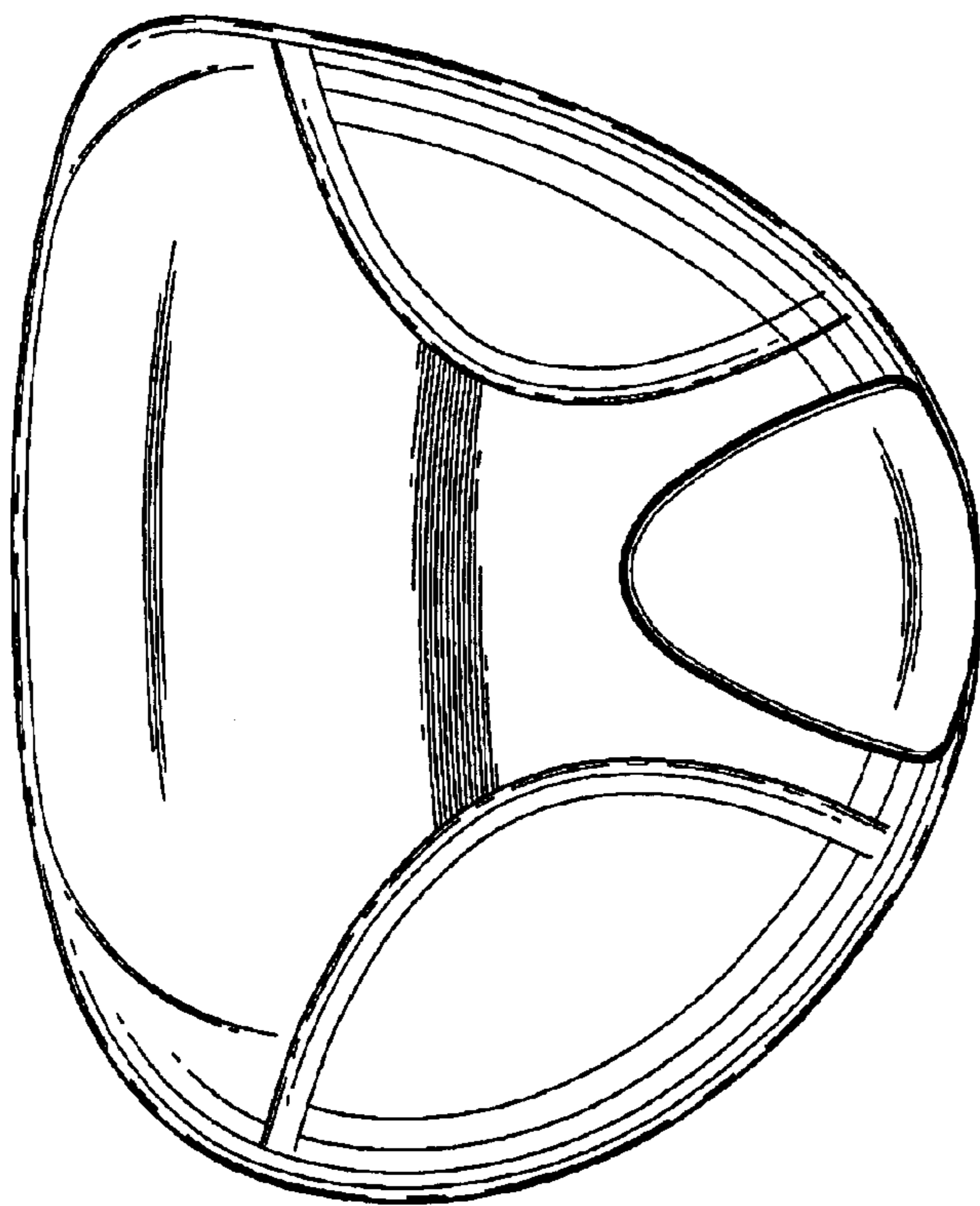
FIG. 5 is a toe side elevational view; and,

FIG. 6 is a heel side elevational view thereof.

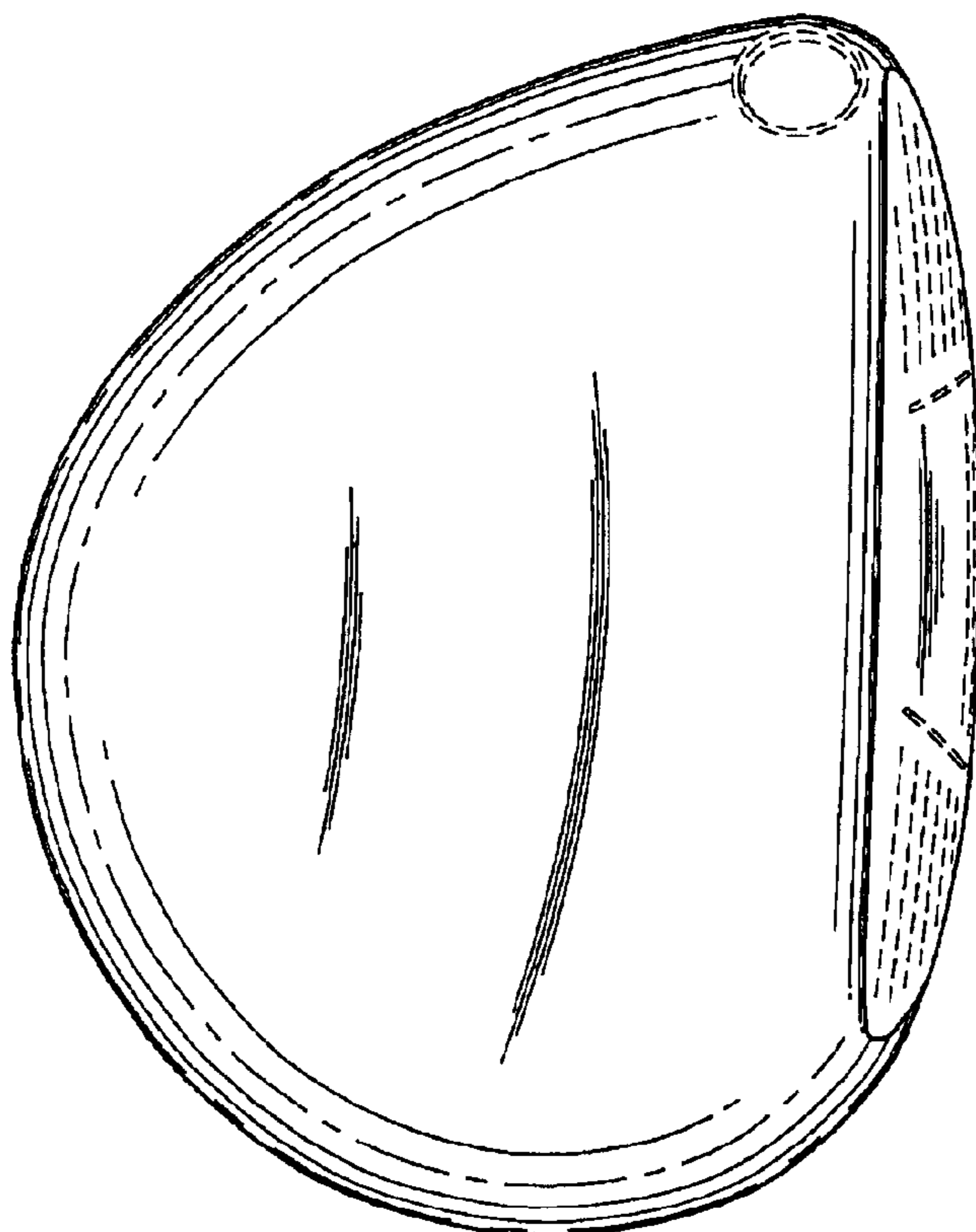

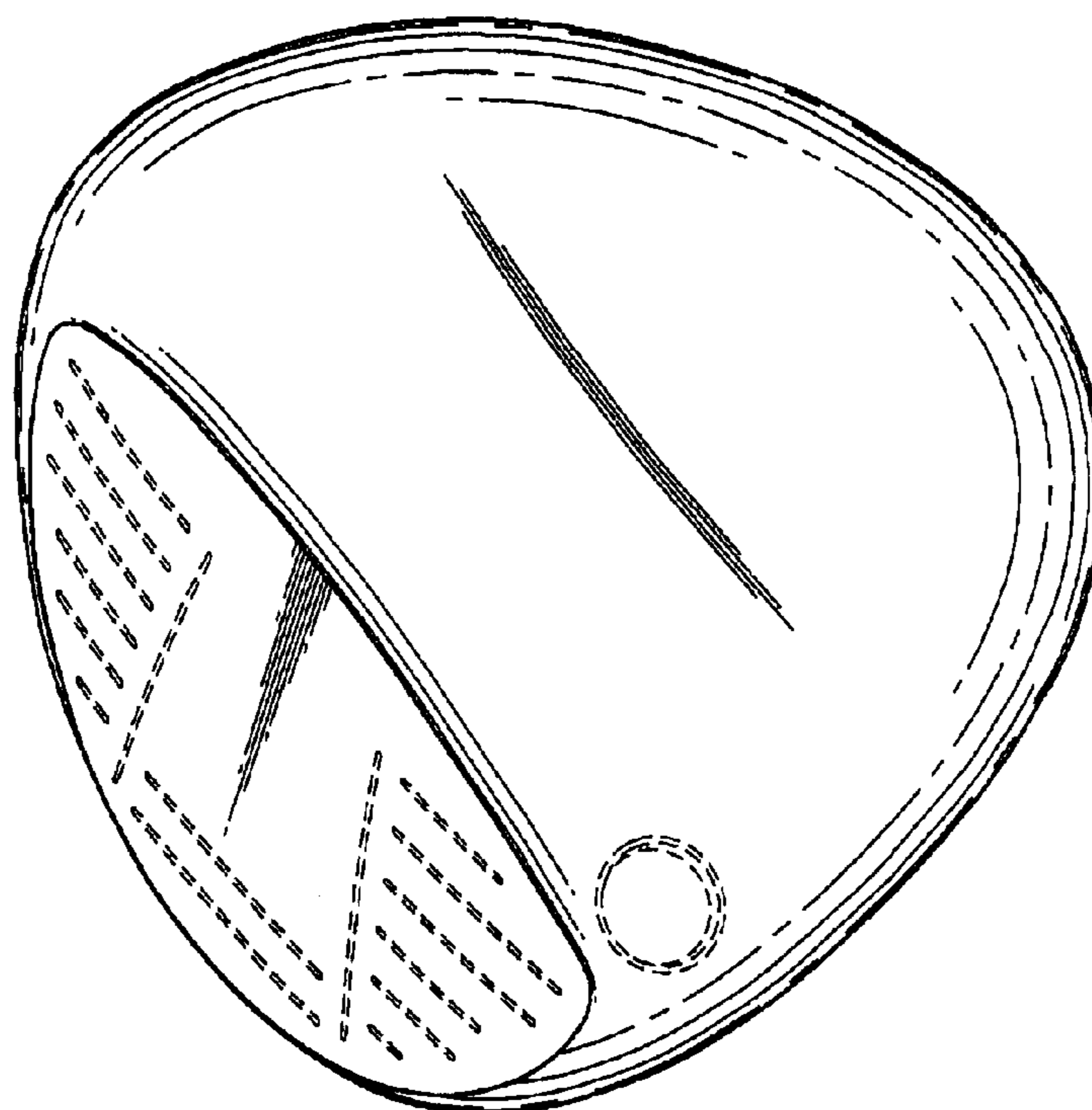




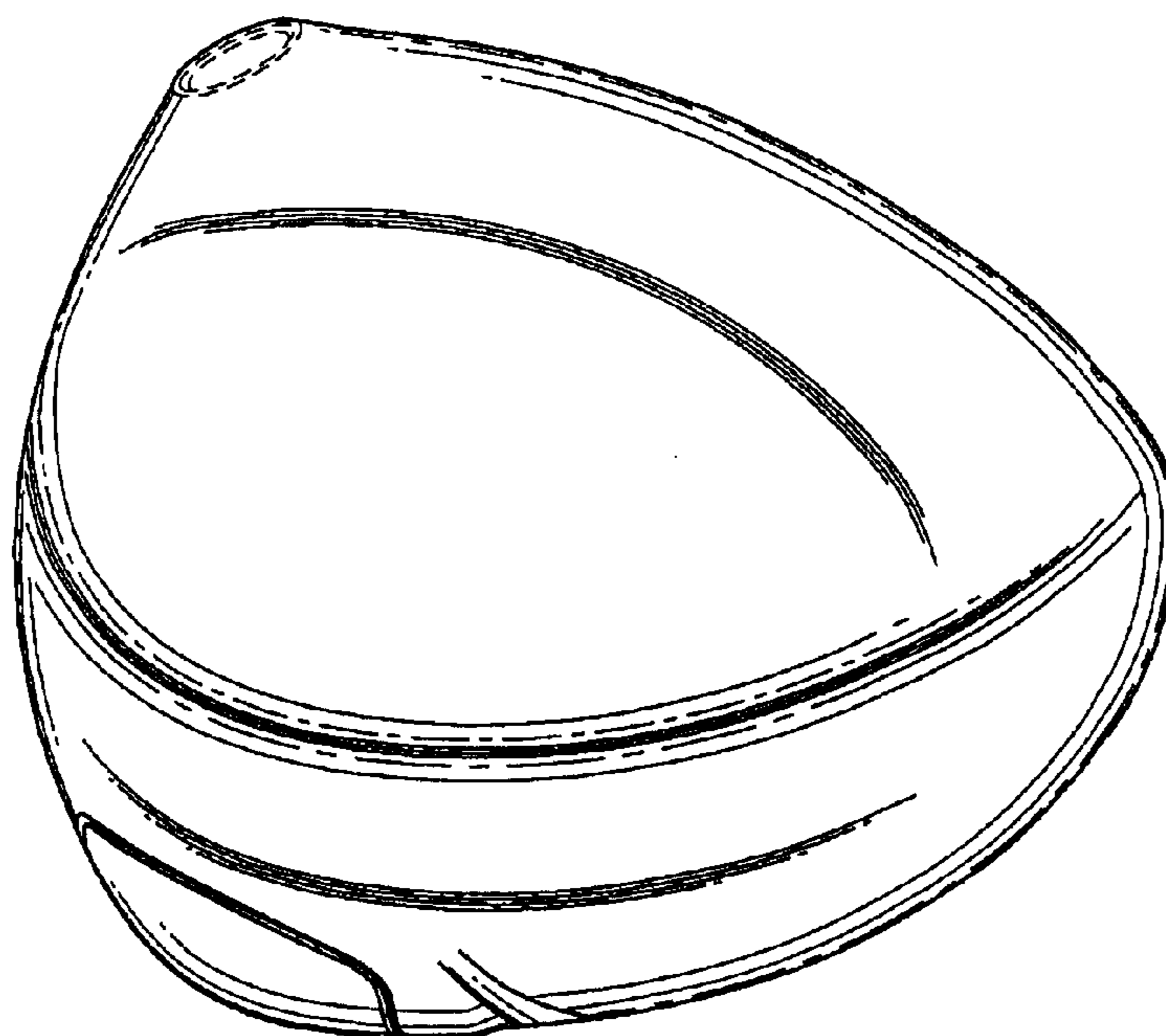

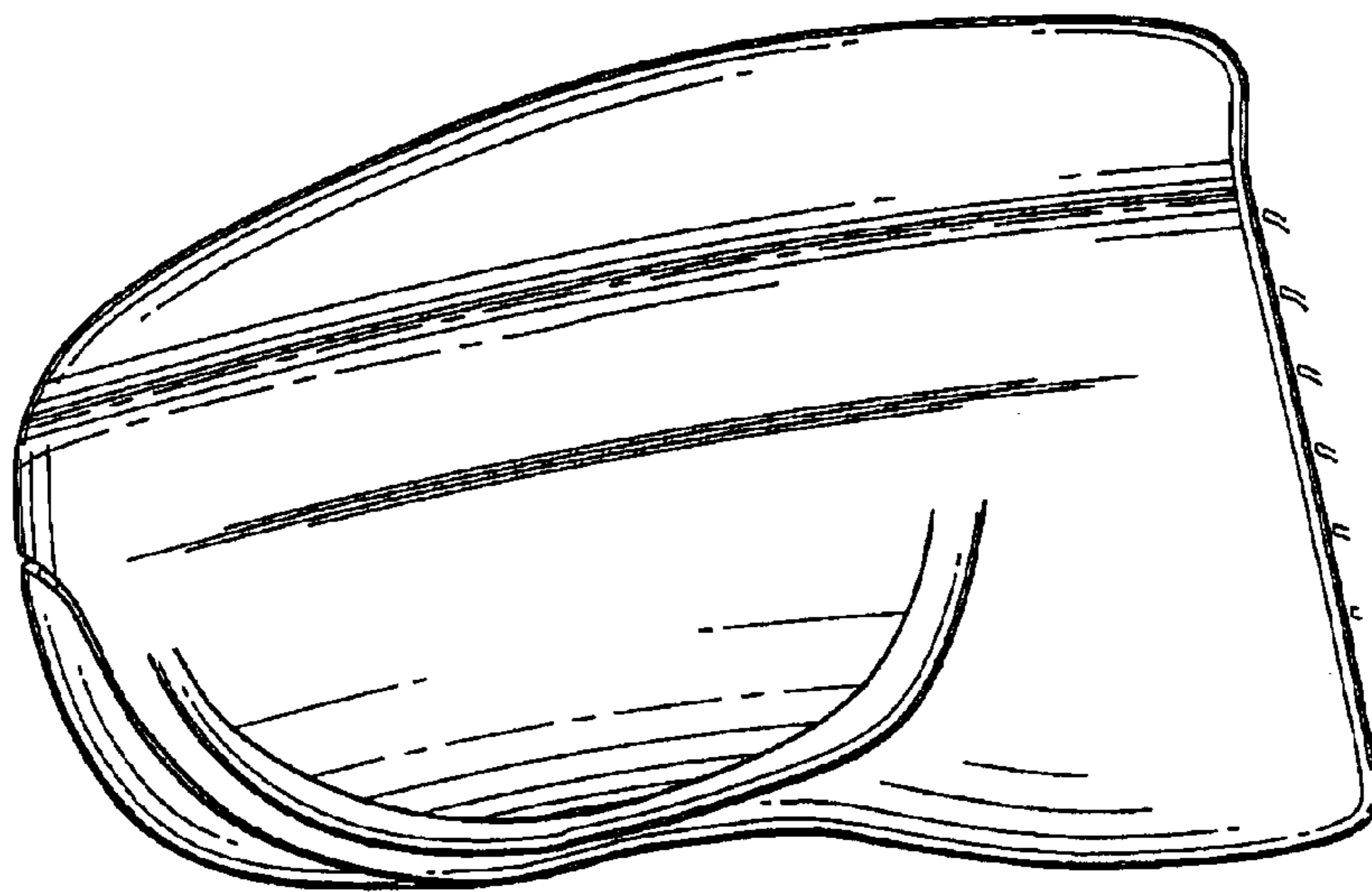

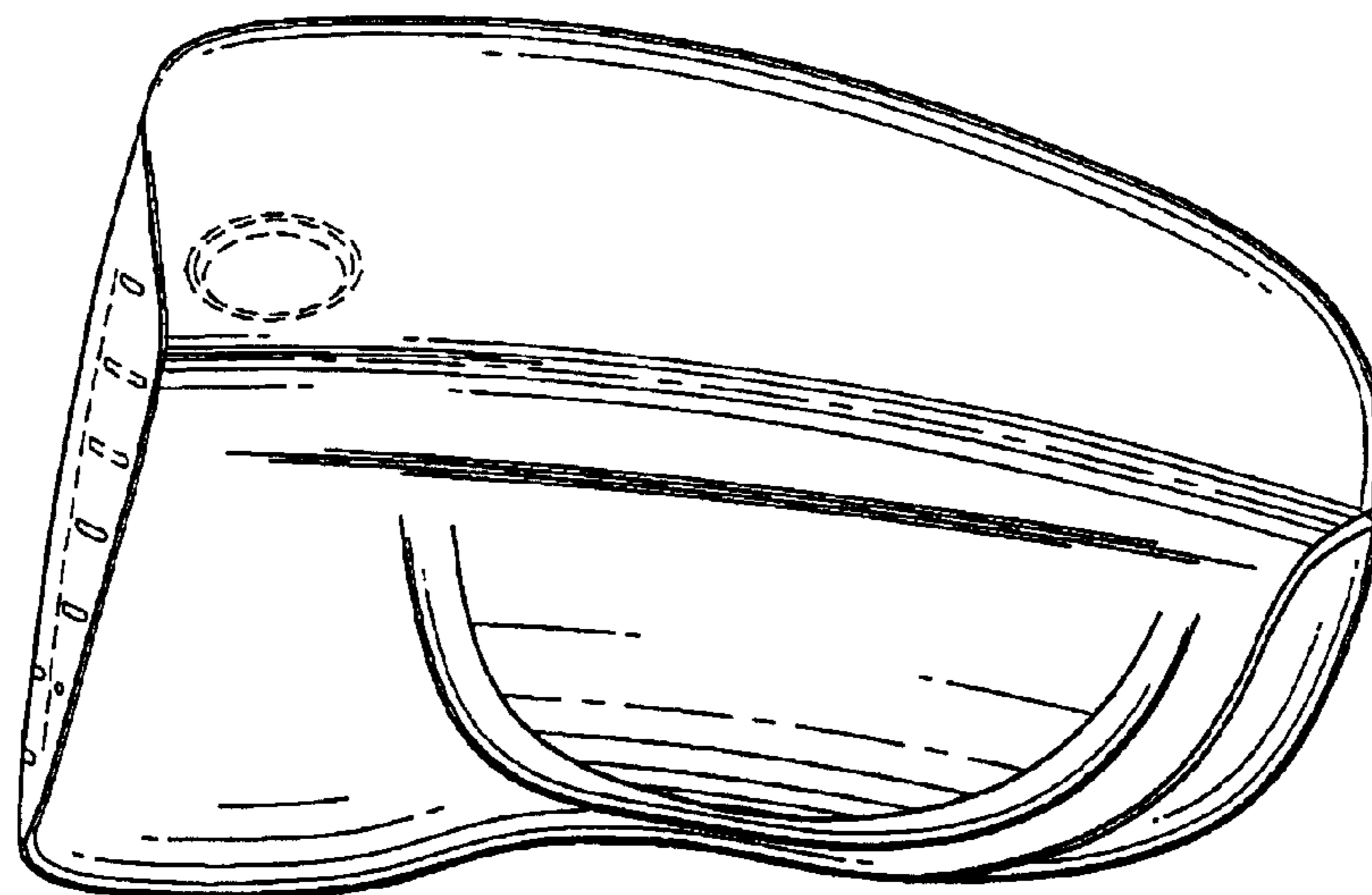
