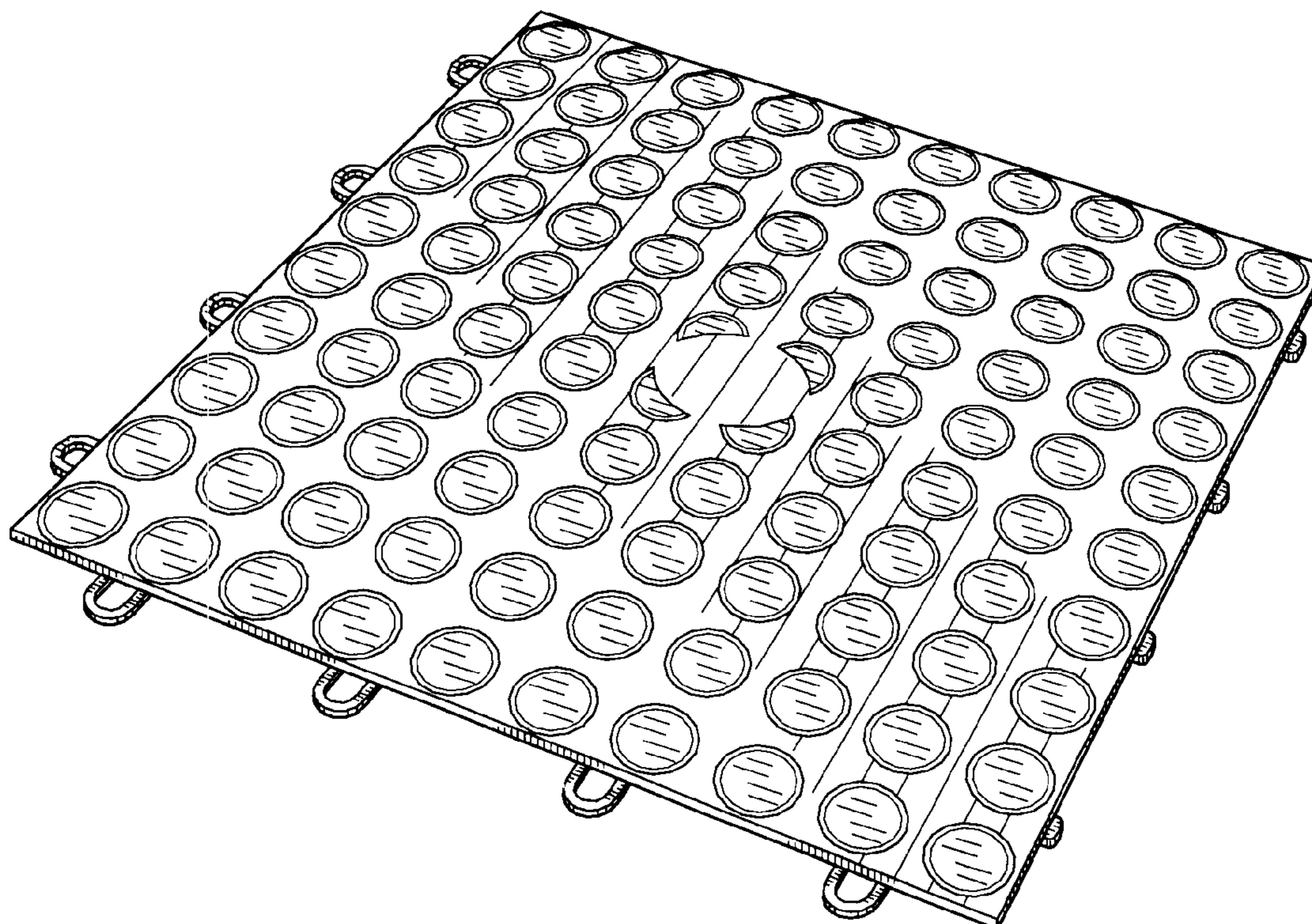
(57) **CLAIM**

The ornamental design for a modular flooring, as shown and described.

DESCRIPTION

FIG. 1 shows a top perspective view of a modular flooring; FIG. 2 shows a front view of the modular flooring; FIG. 3 shows a back view of the modular flooring; FIG. 4 shows a view of the modular flooring which is the bottom with respect to FIG. 2; FIG. 5 shows another view of the modular flooring which is the right side with respect to FIG. 2; FIG. 6 shows another view of the modular flooring which is the top with respect to FIG. 2; and, FIG. 7 shows another view of the modular flooring which is the left side with respect to FIG. 2.

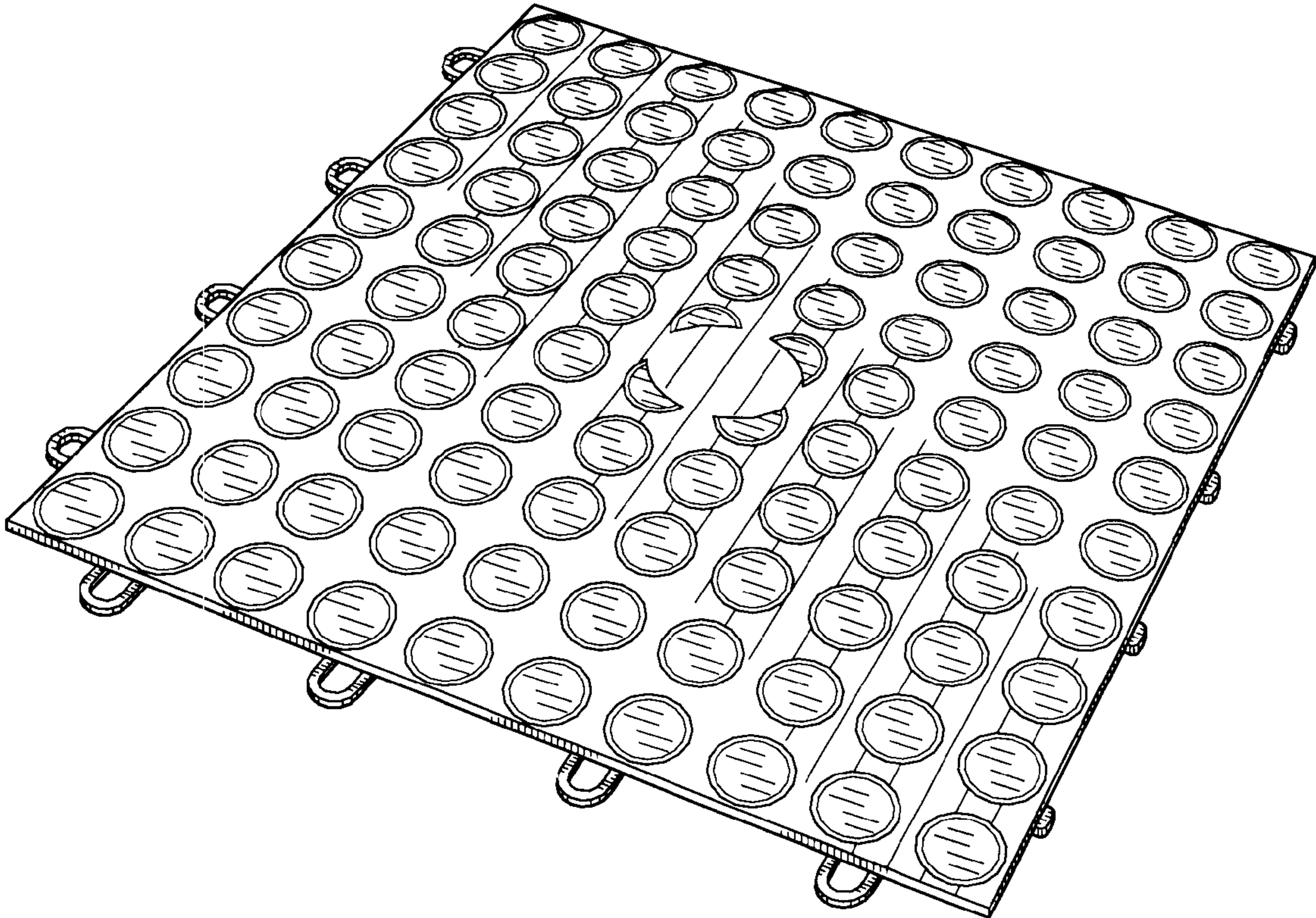

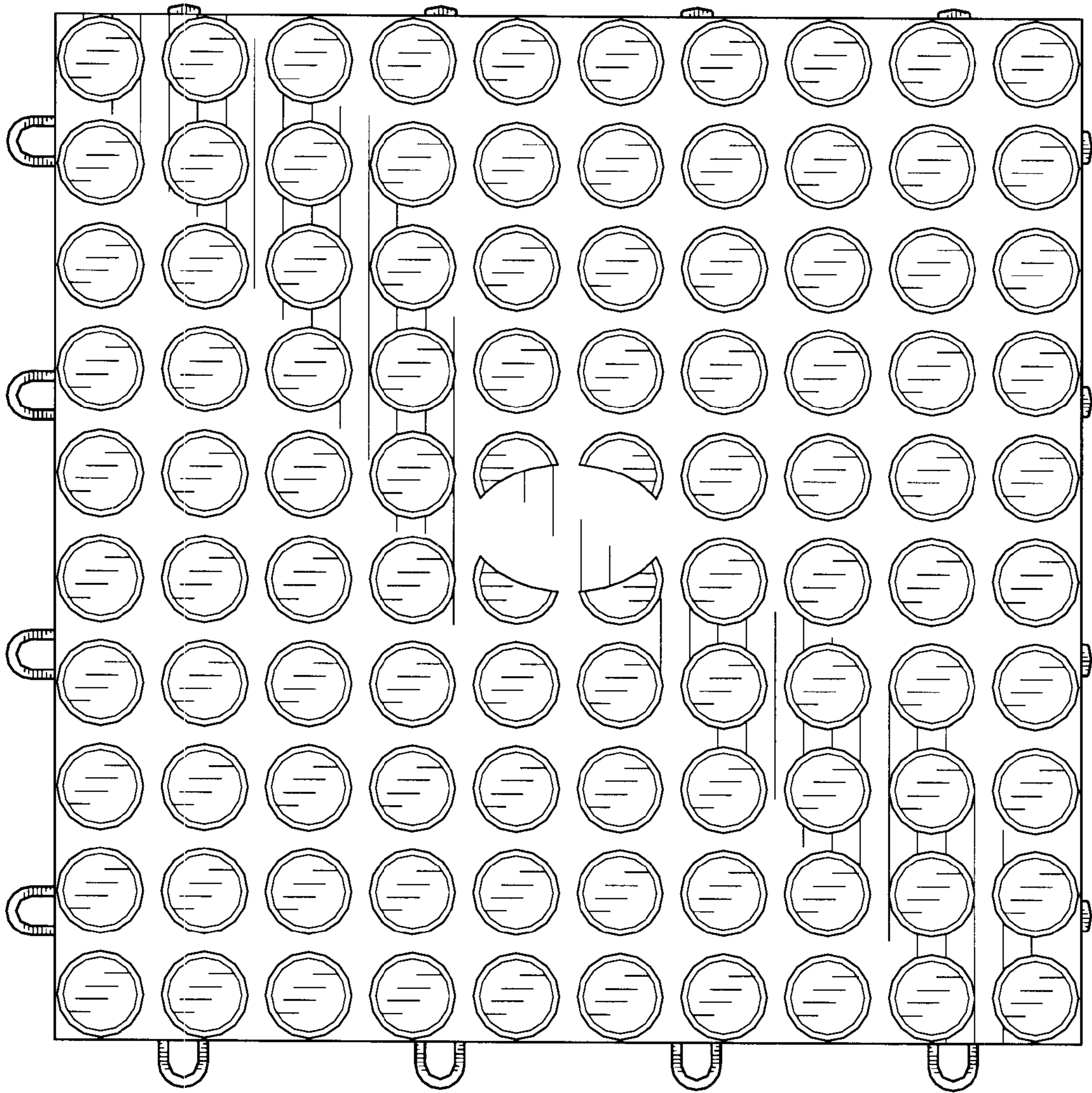

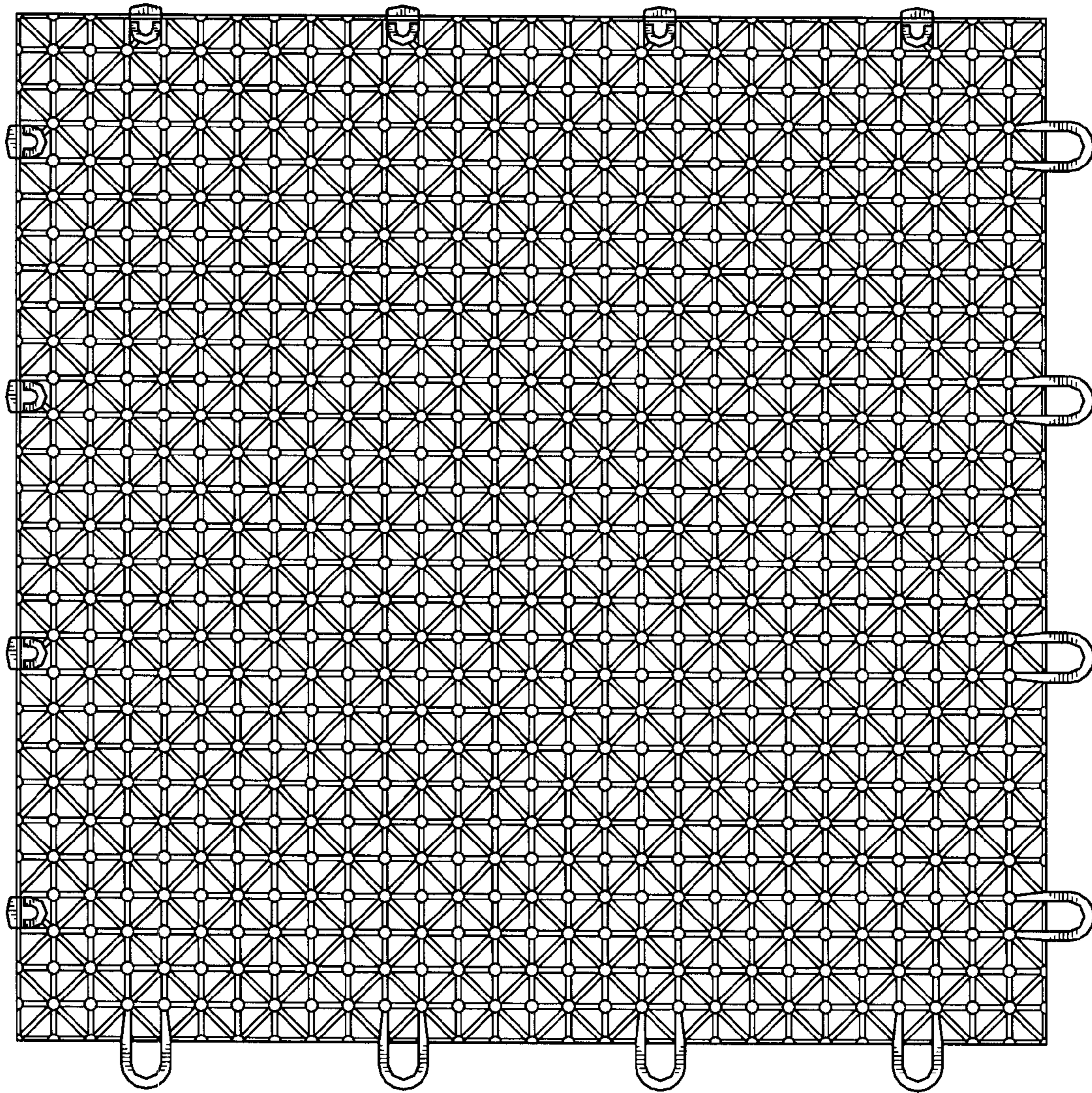
