I claim the ornamental design for a monkey bath puff, as shown.

**DESCRIPTION**

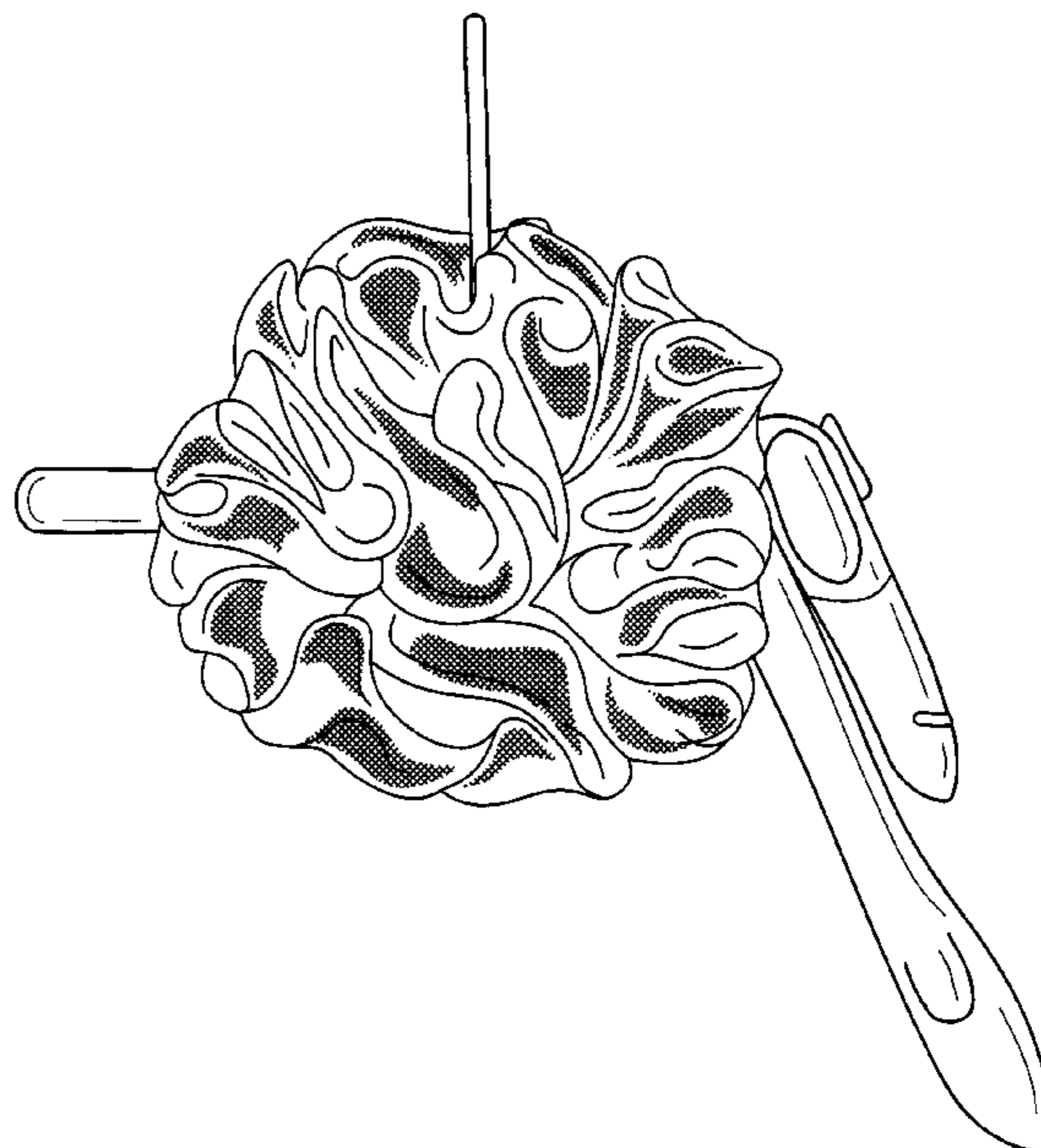
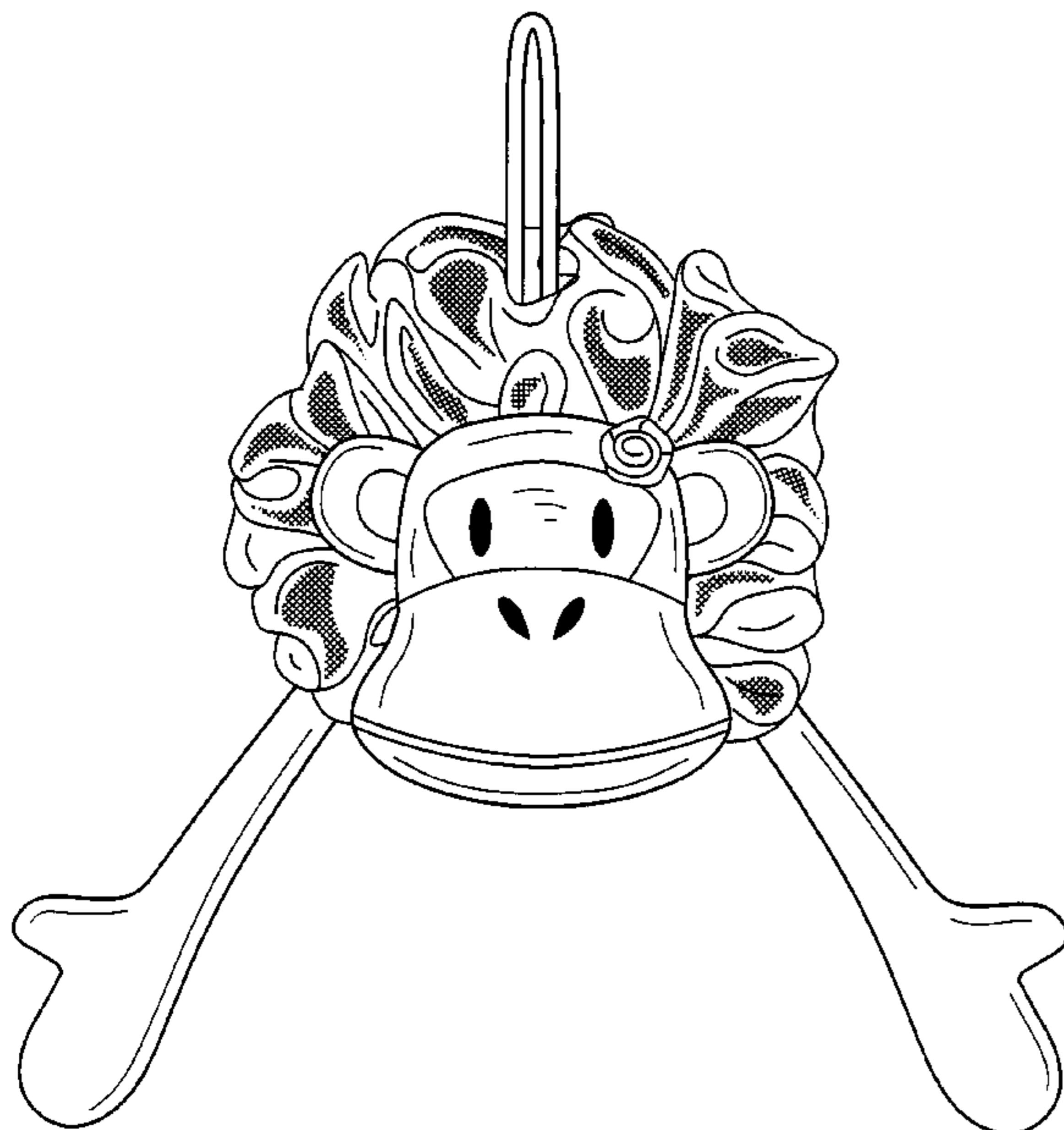

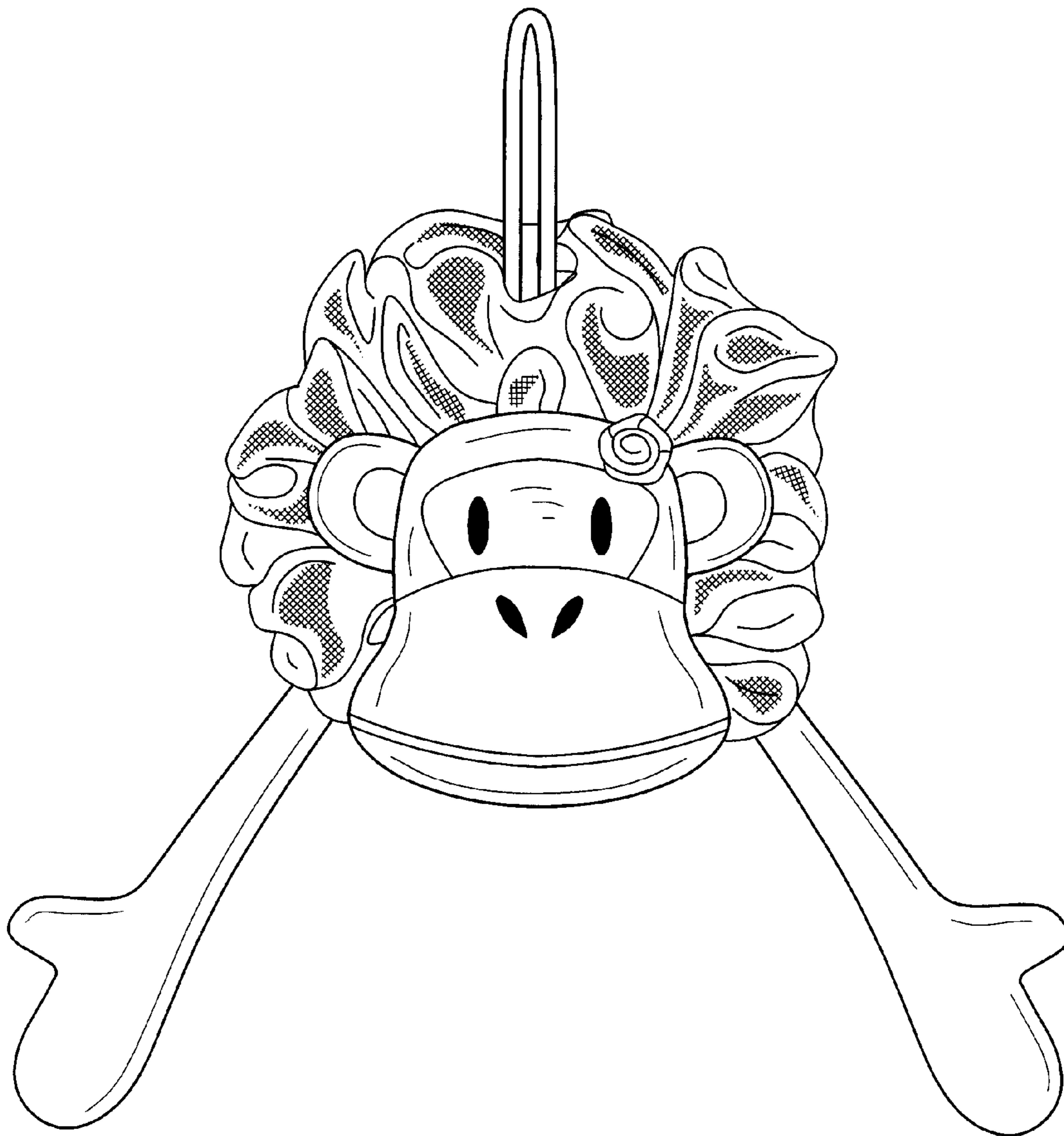

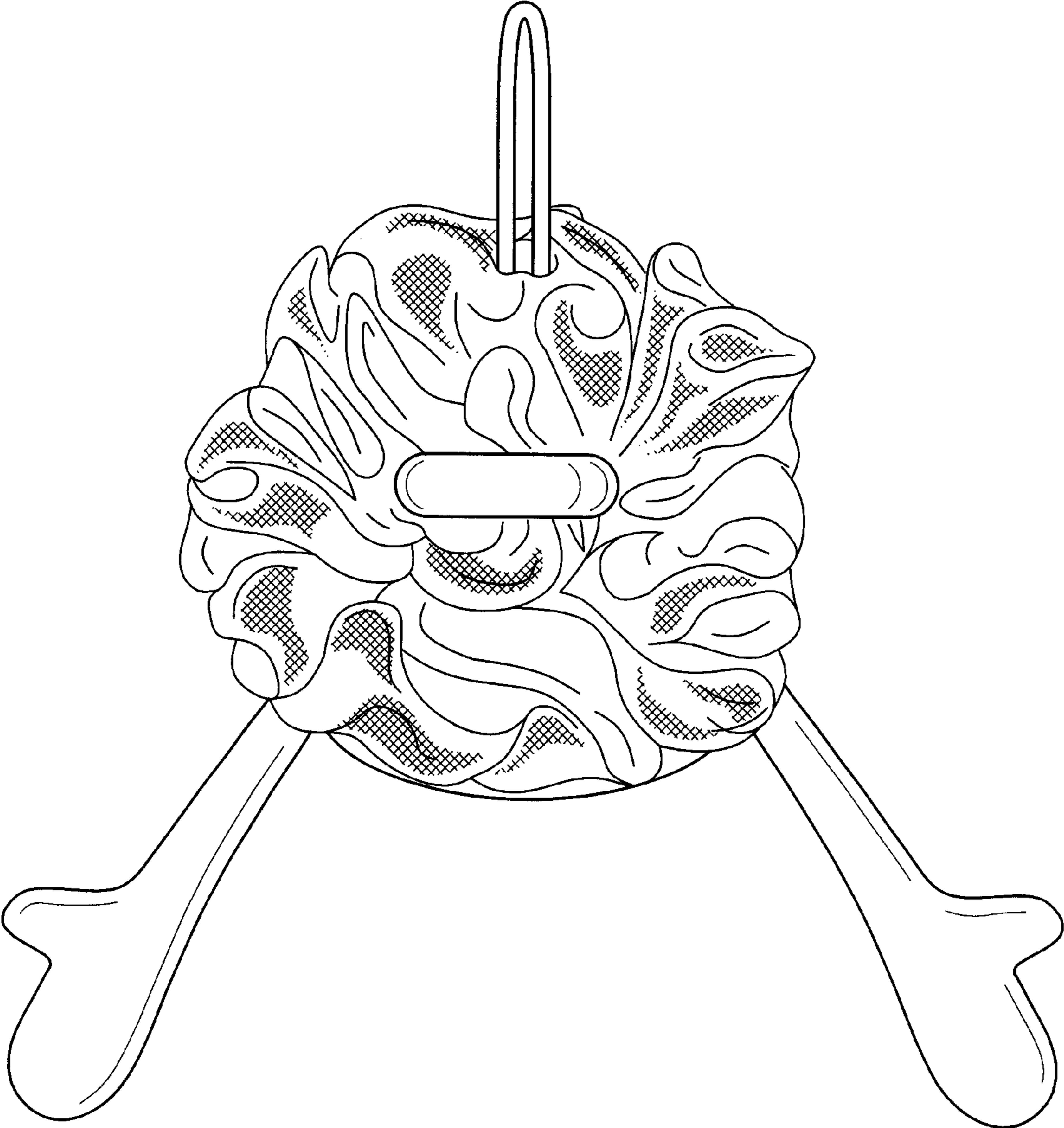

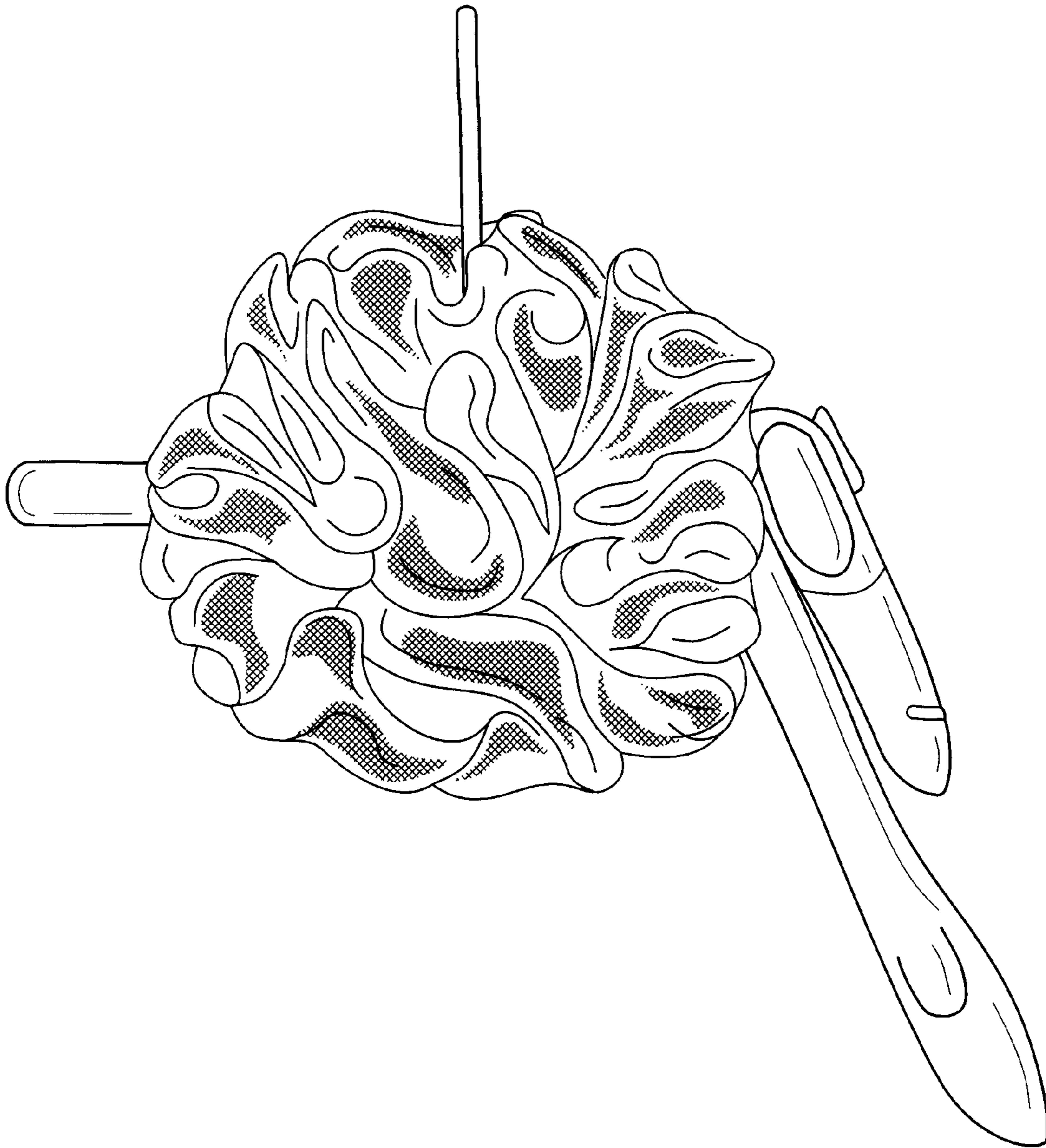

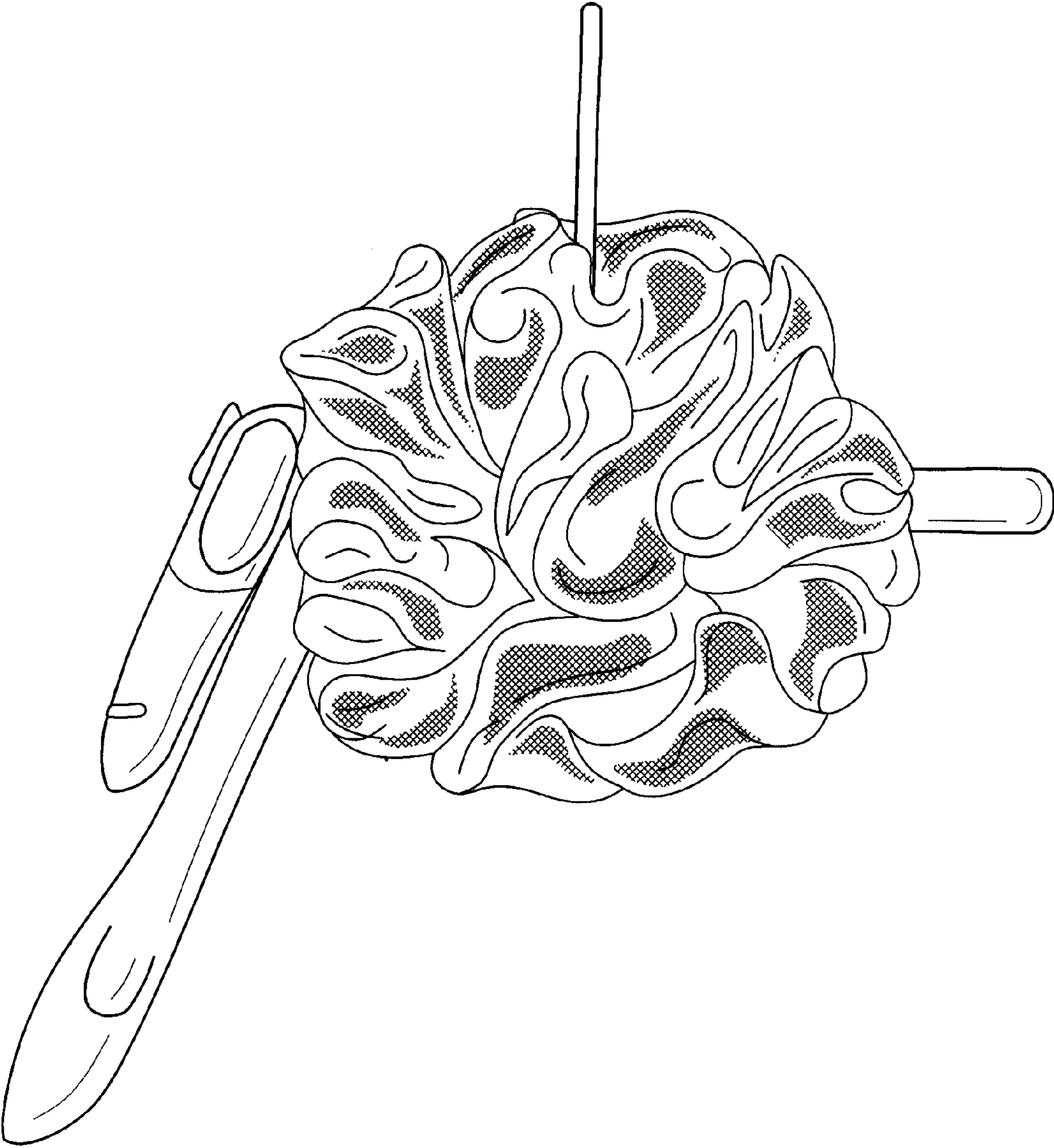

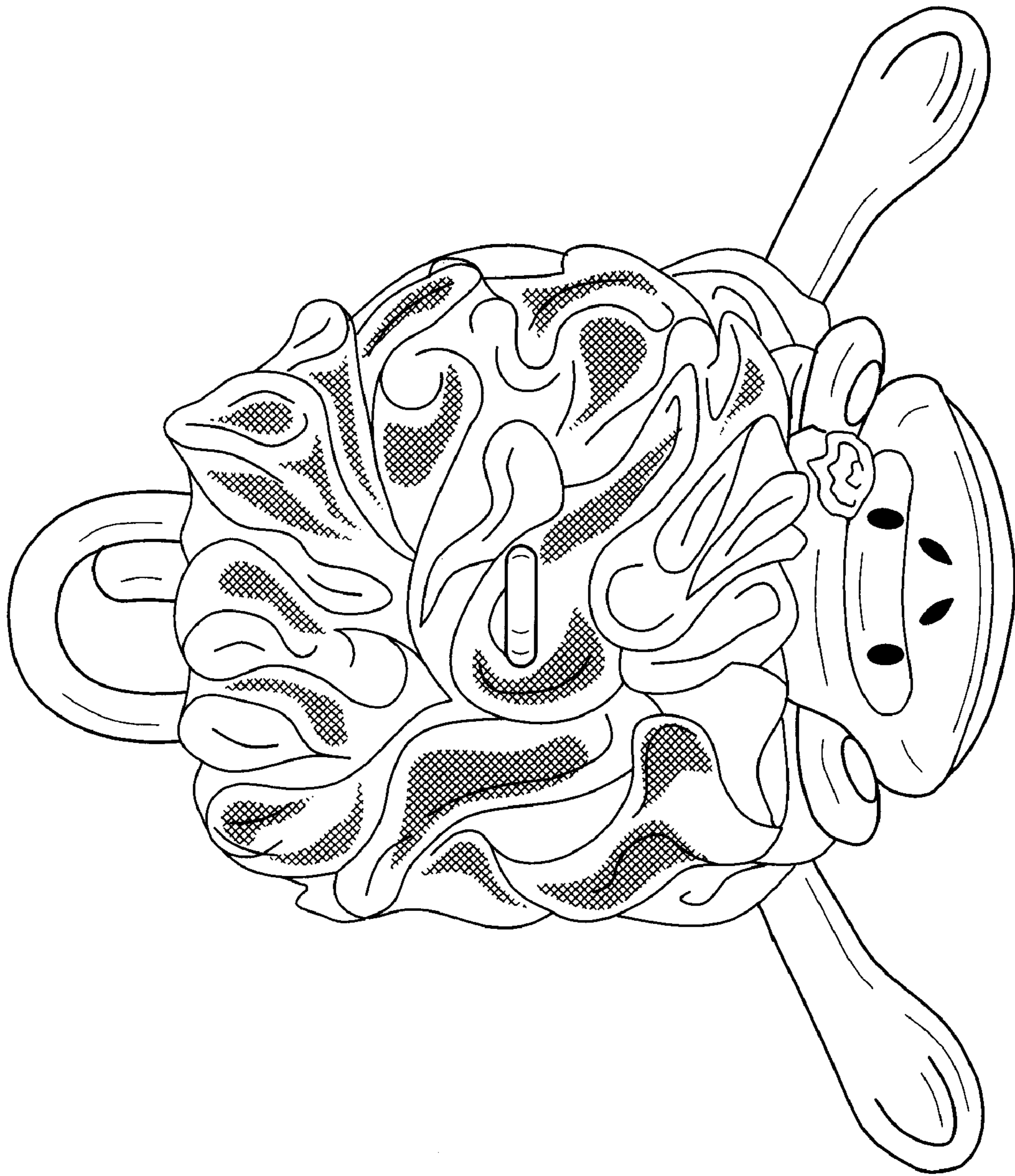
