(57) **CLAIM**

We claim the ornamental design for sweet rolls made on waffle process, as shown and described.

**DESCRIPTION**

FIG. 6 is a top view of the sweet rolls made on waffle process of FIG. 5;

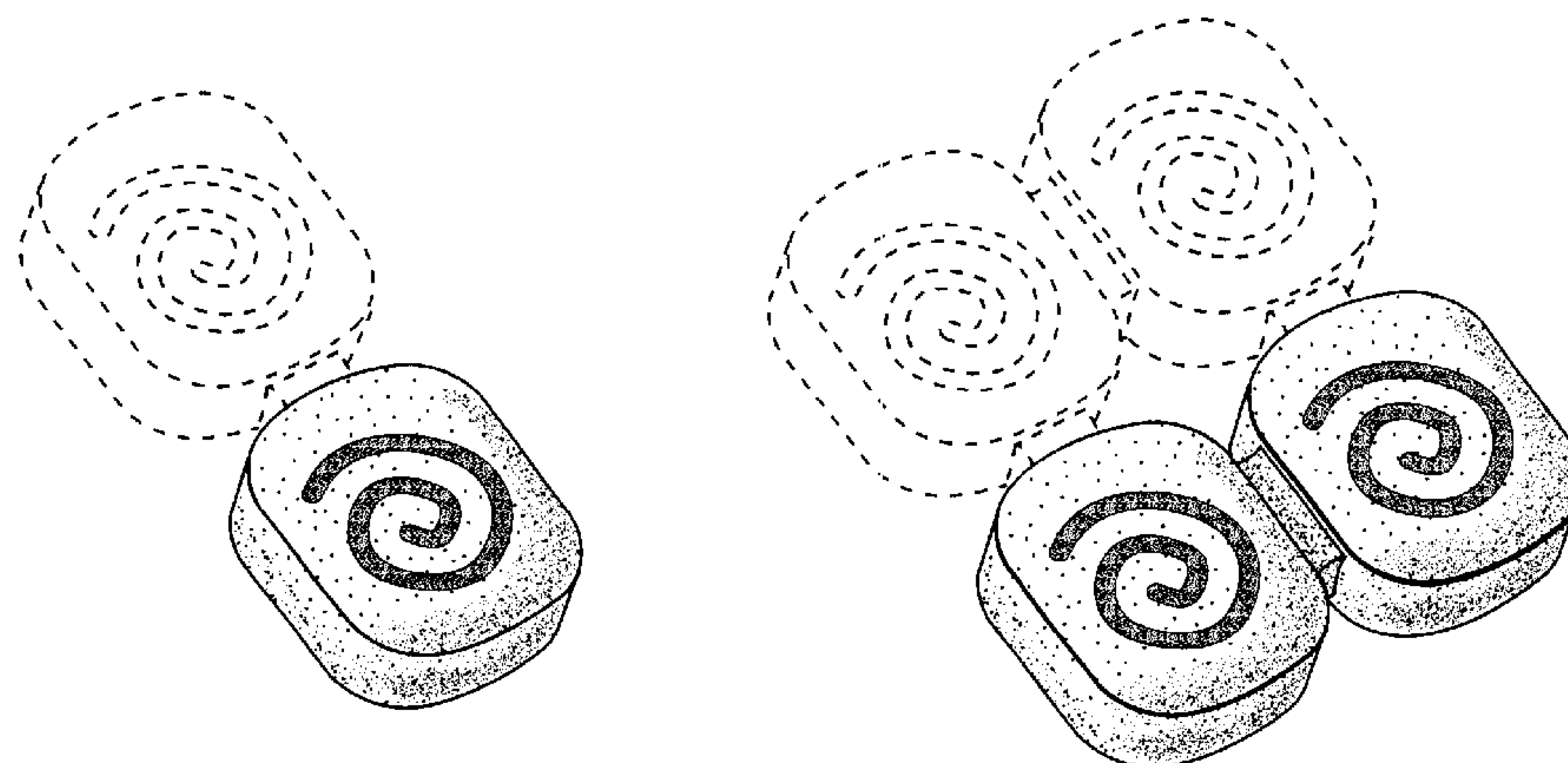
FIG. 7 is a side view of the sweet rolls made on waffle process of FIG. 5;

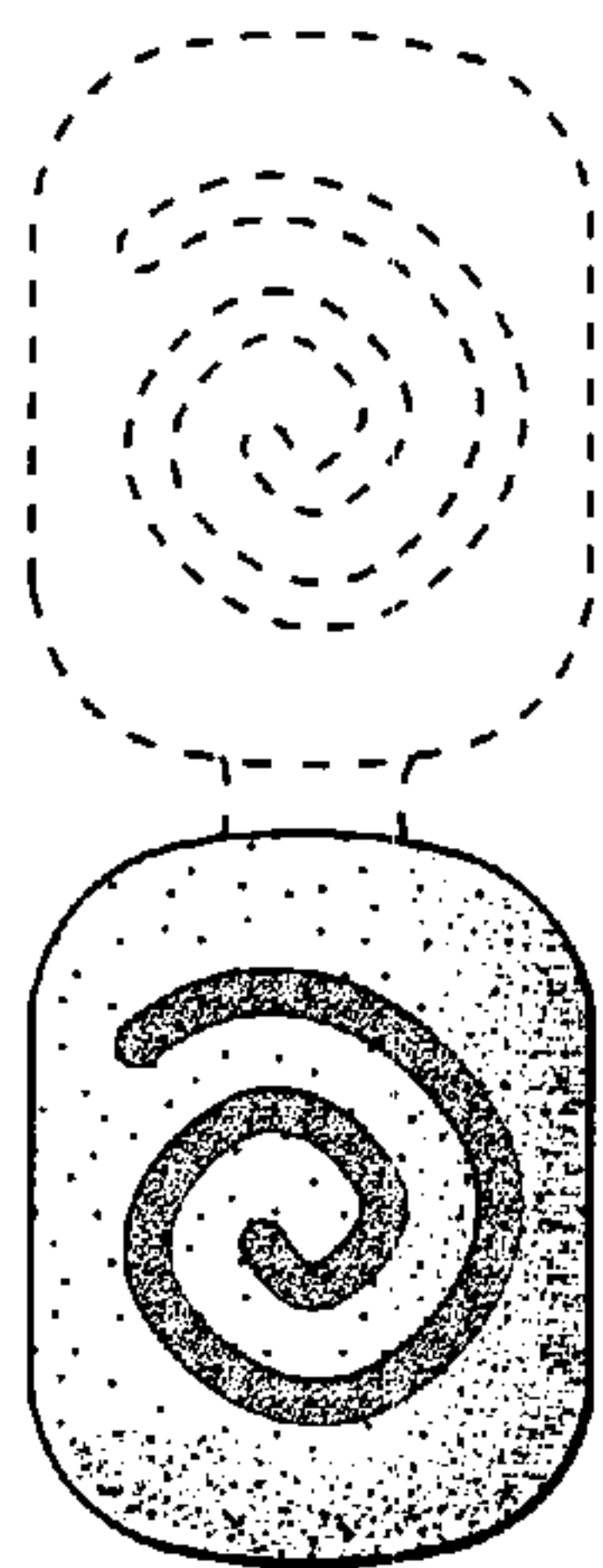
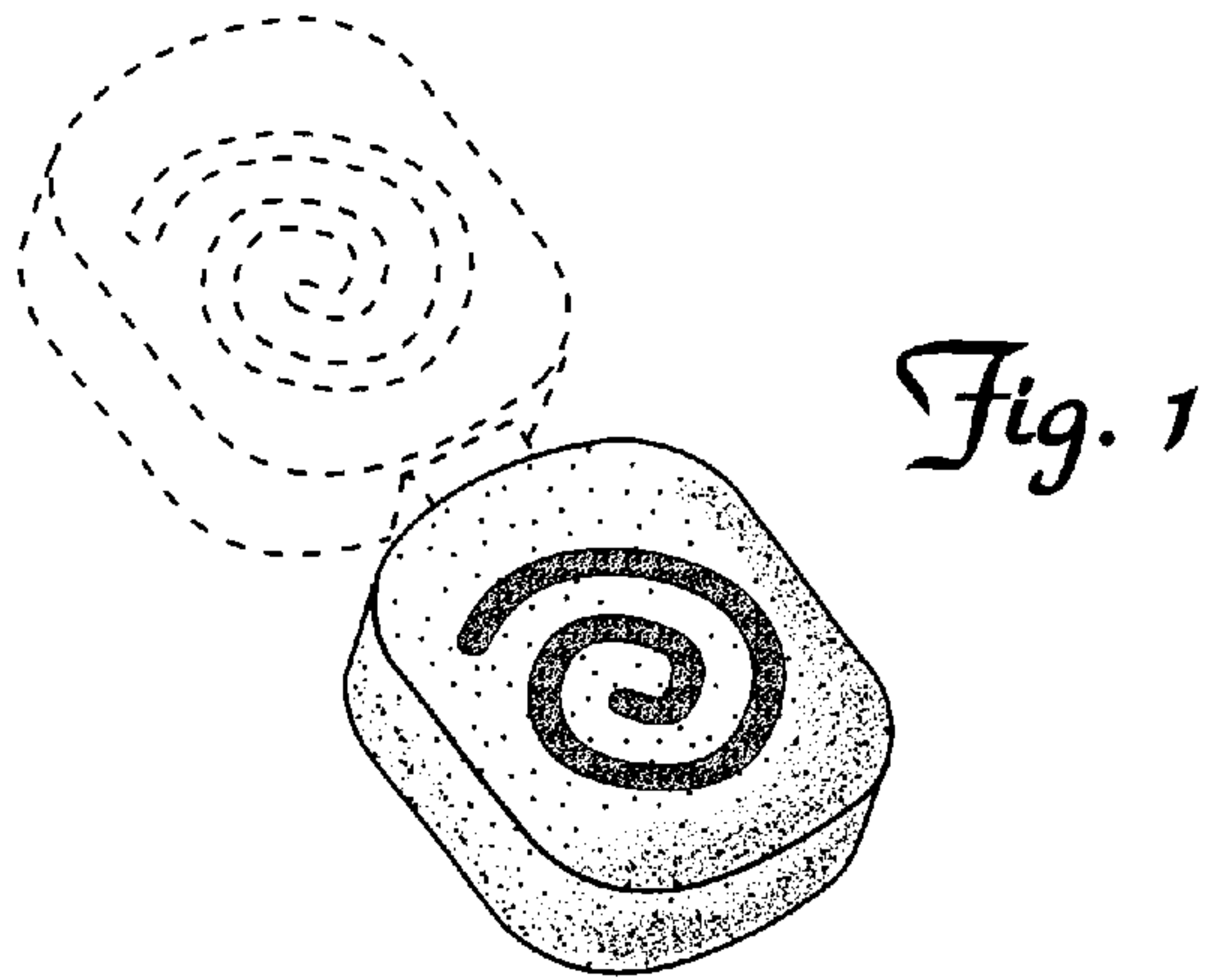
FIG. 8 is a bottom view of the sweet rolls made on waffle process of FIG. 5; and,

FIG. 9 is a top view of a sweet rolls made on waffle process, according to an embodiment of the invention.

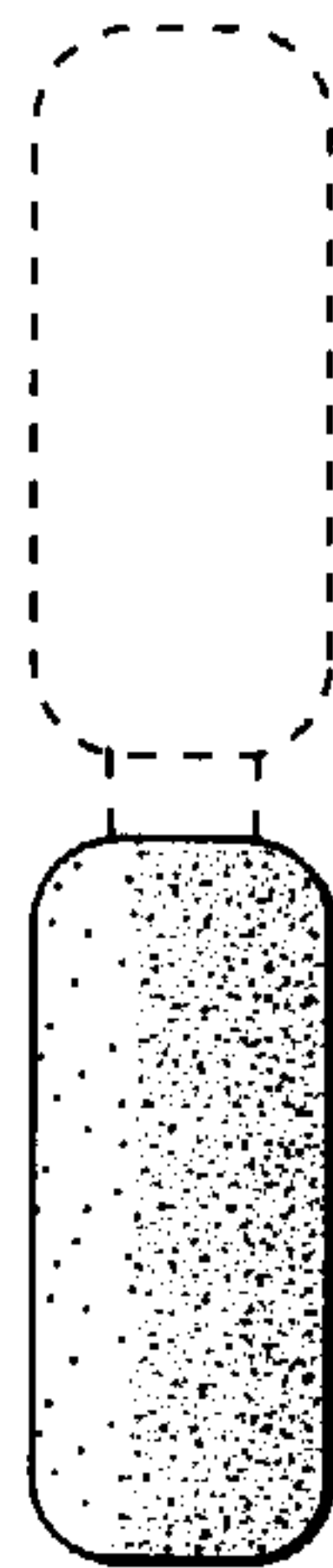

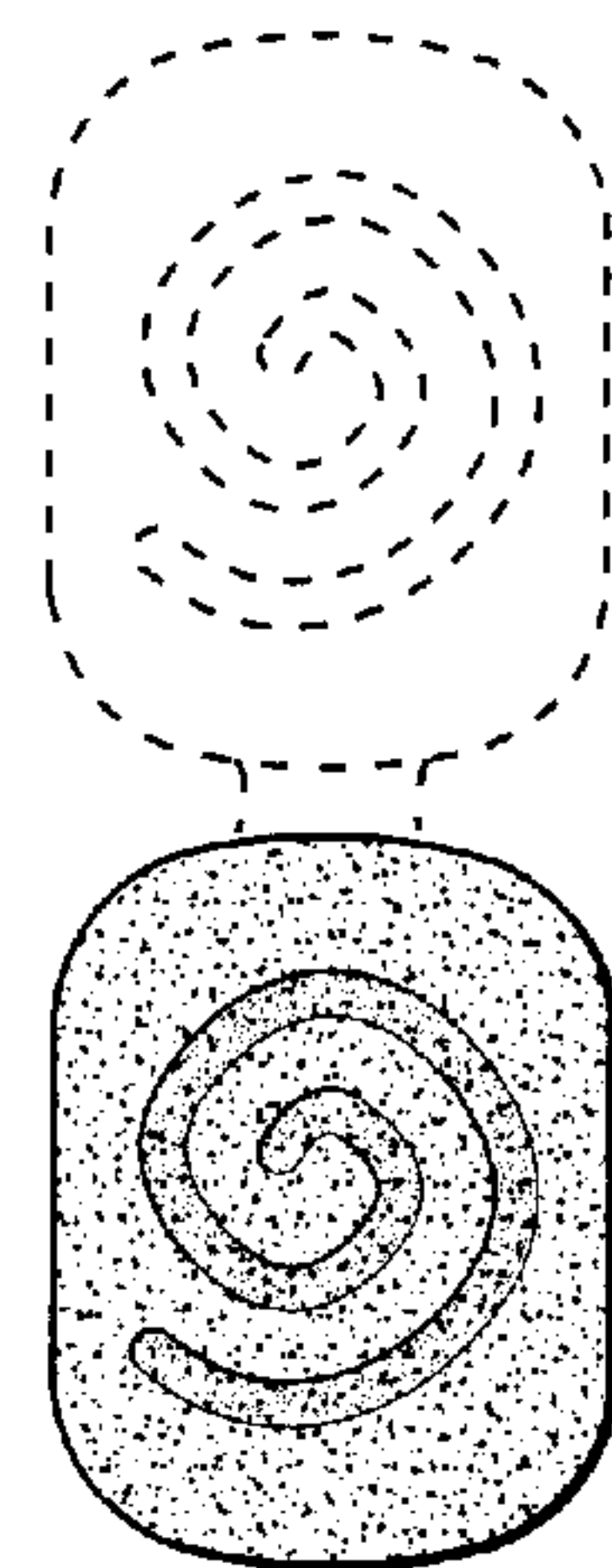




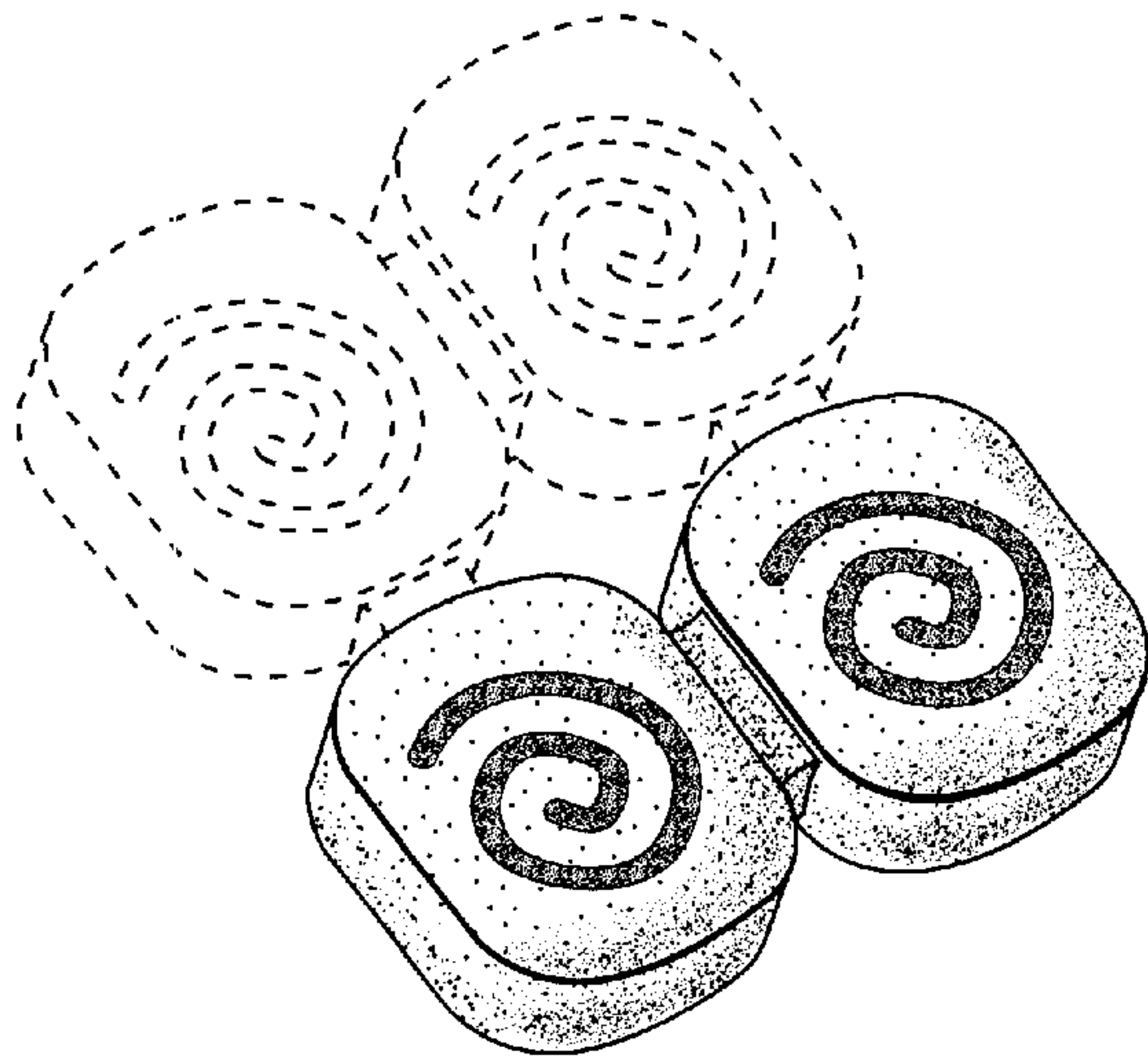

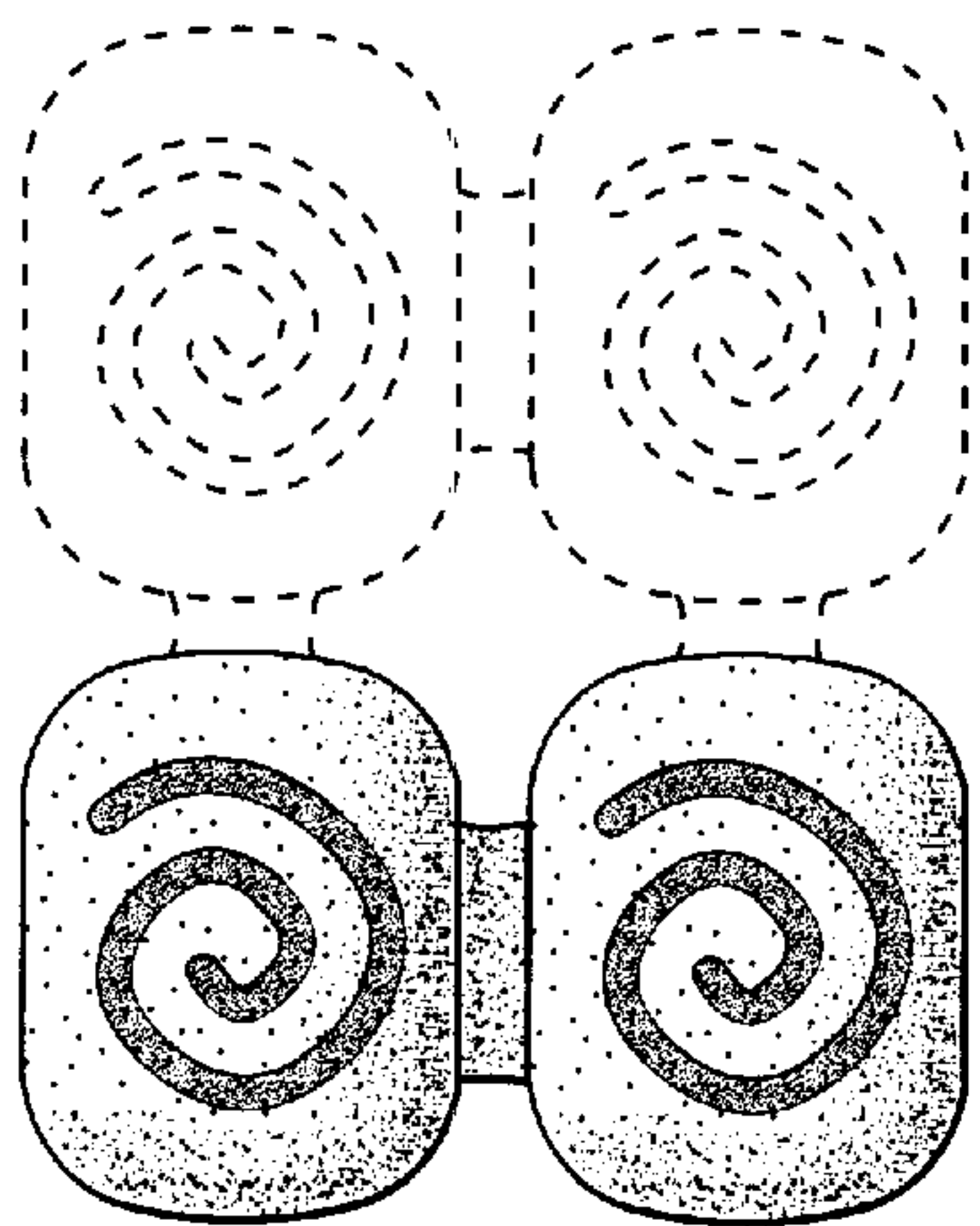

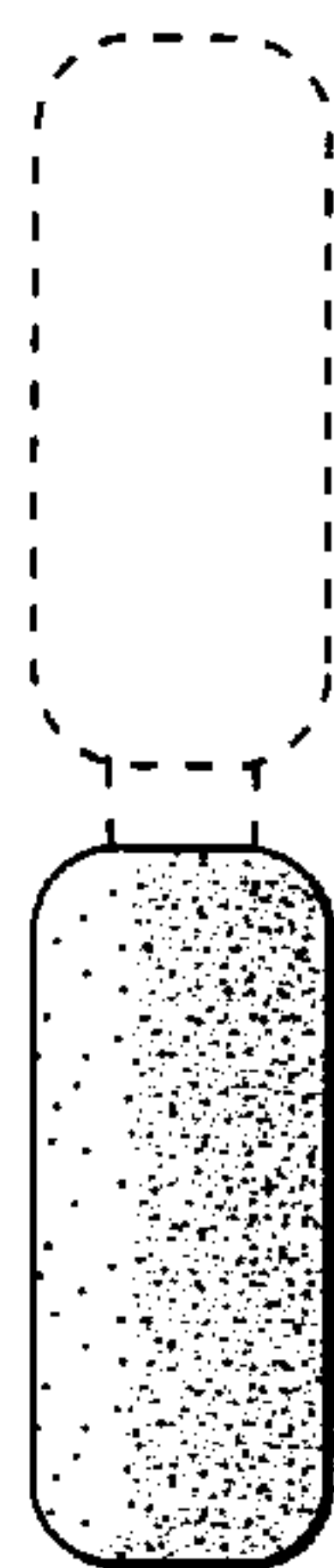

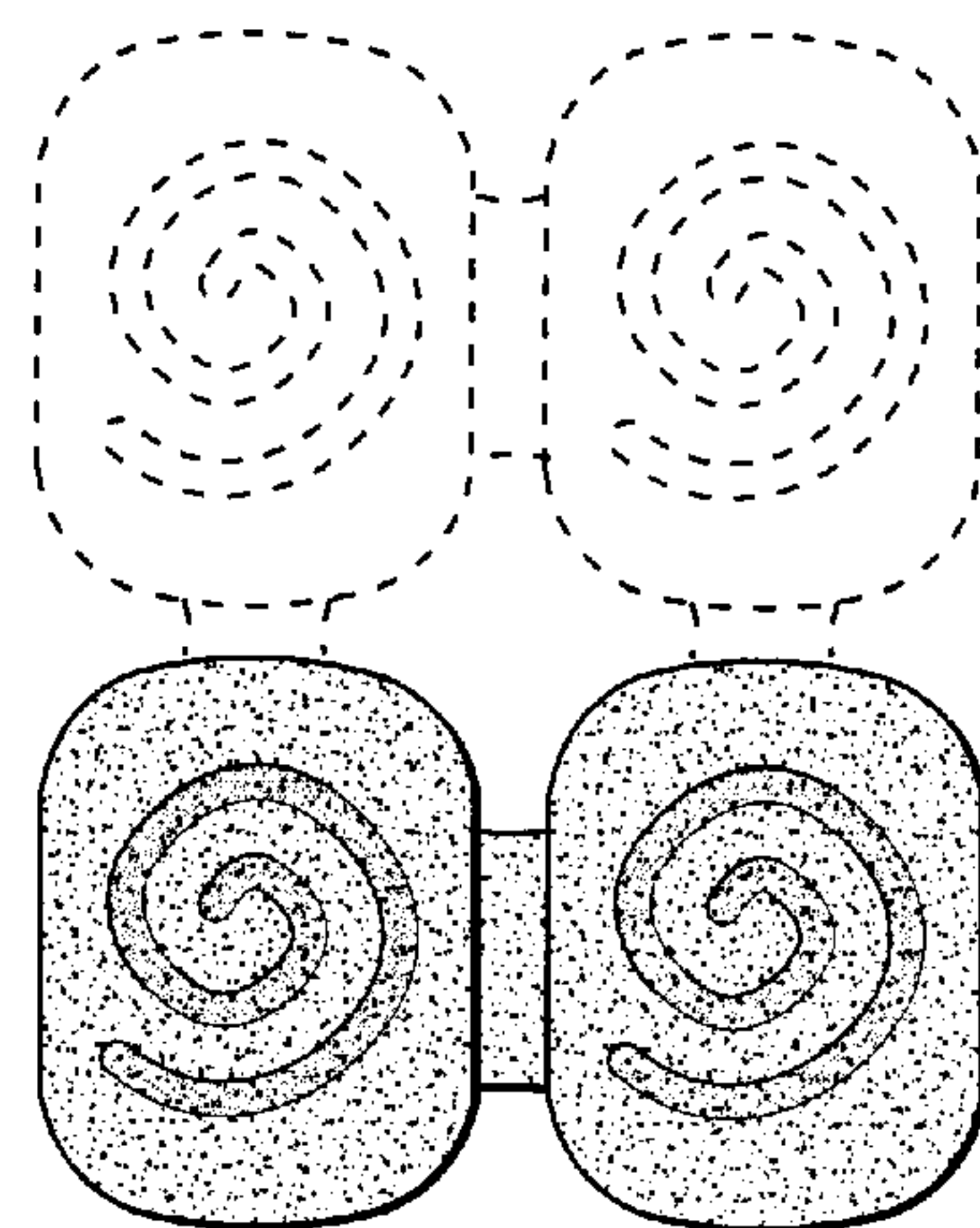

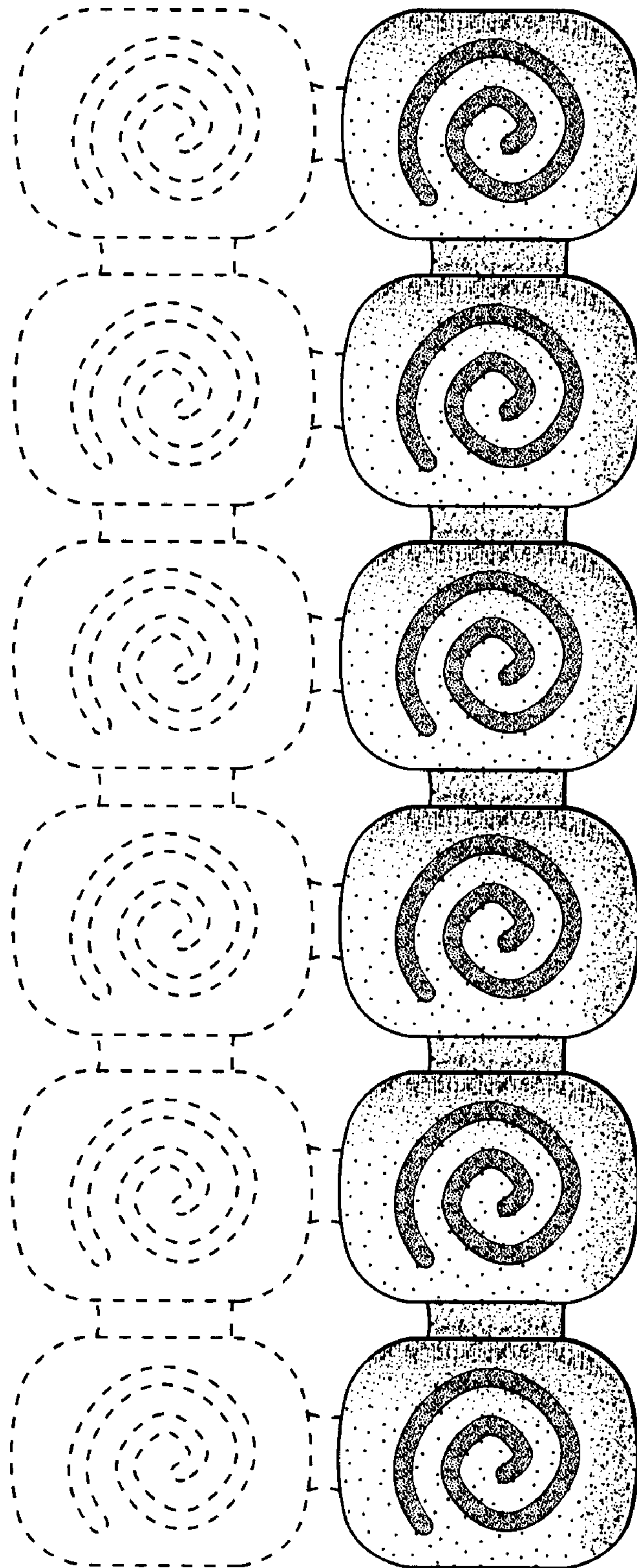
