(57) **CLAIM**

The ornamental design for a belt supported tennis ball holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a belt supported tennis ball holder showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a side view thereof, shown in association with a tennis ball illustrated in phantom outline and not a part of this invention;

FIG. 5 is a side view thereof, shown in its folded state;

FIG. 6 is a front view thereof in its folded state;

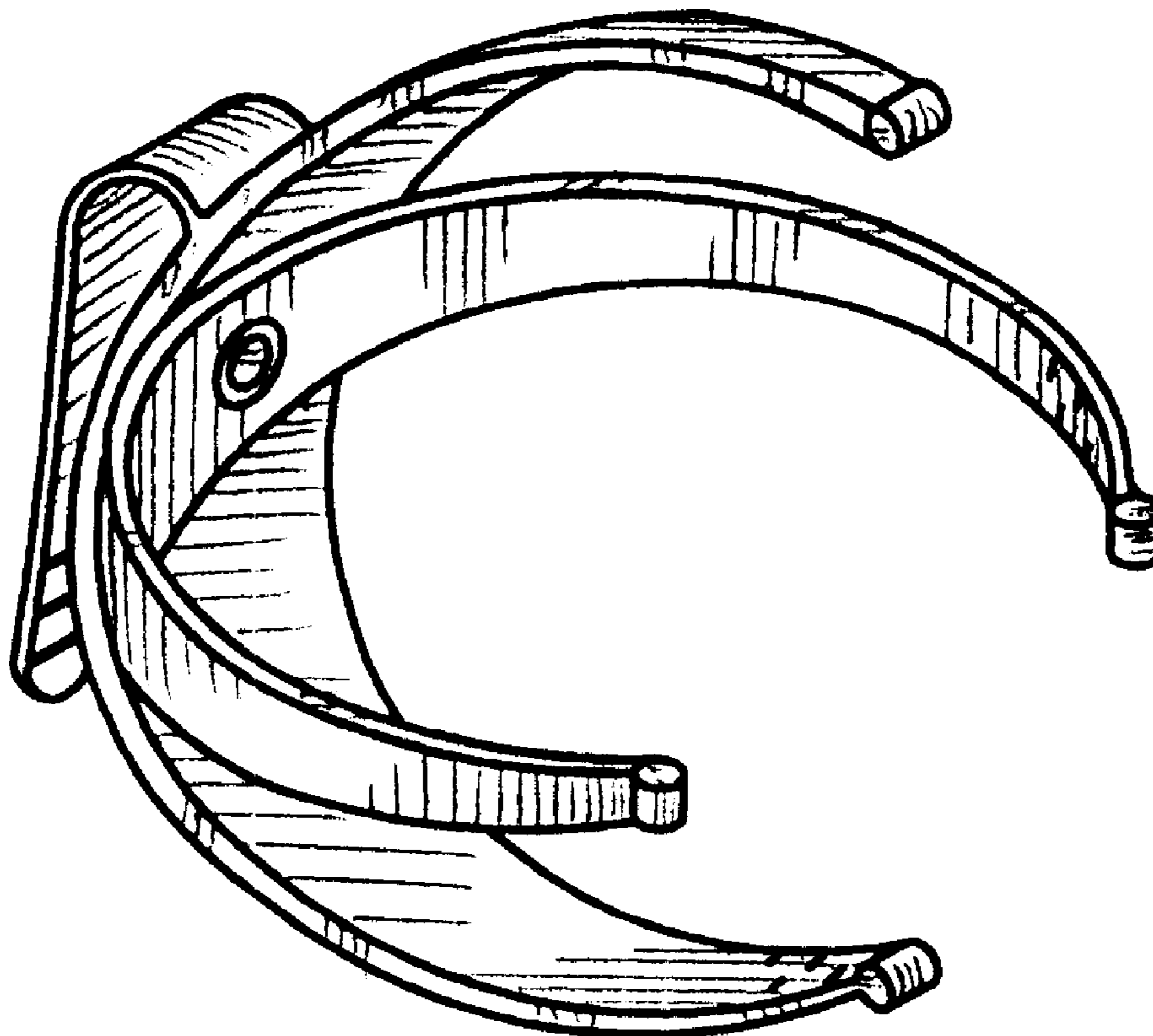
FIG. 7 is a top view thereof in its folded state;

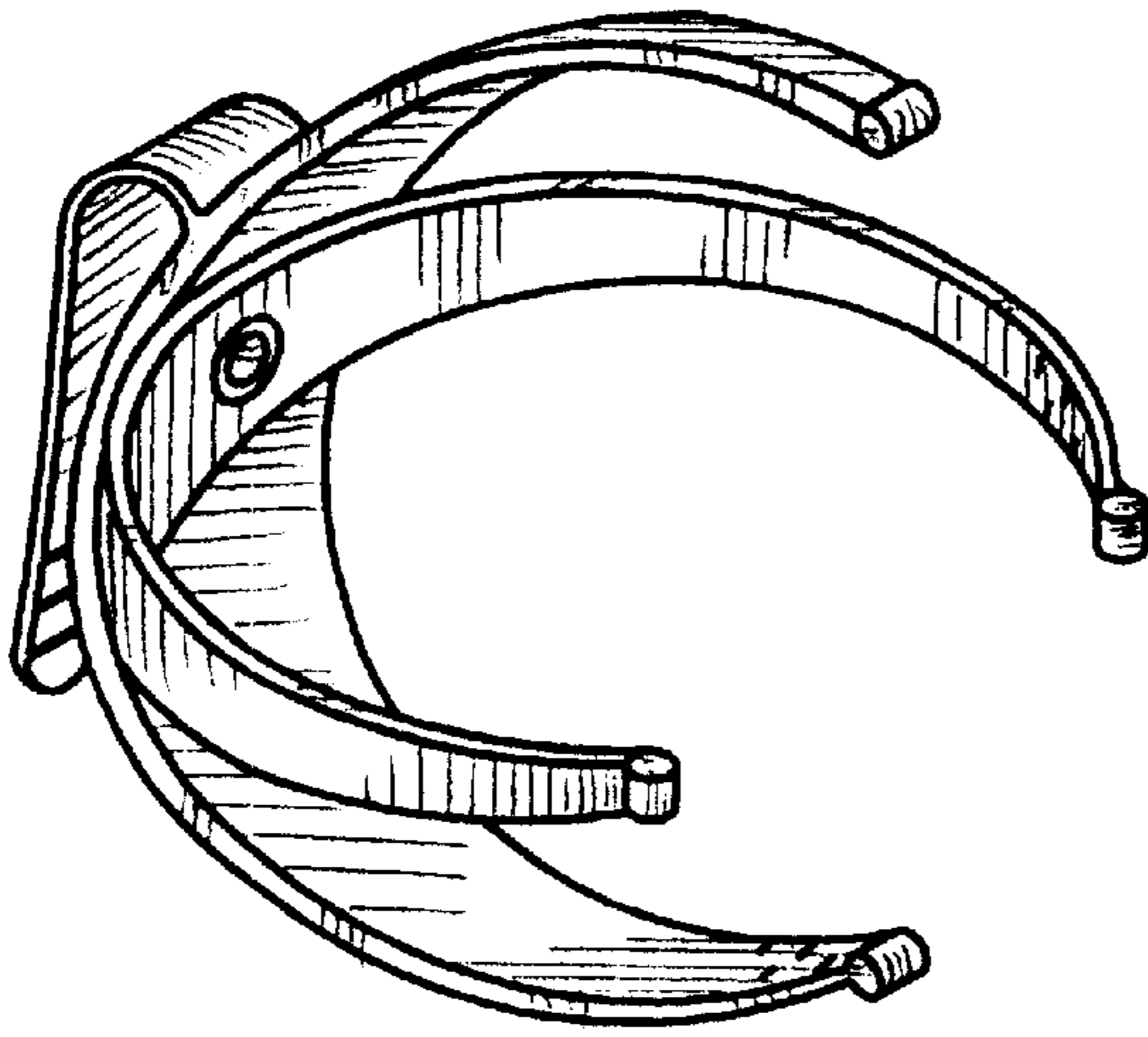
FIG. 8 is top and side view of an equivalent alternative embodiment thereof;

FIG. 9 is a side view of the embodiment of FIG. 8 shown in its folded state; and,

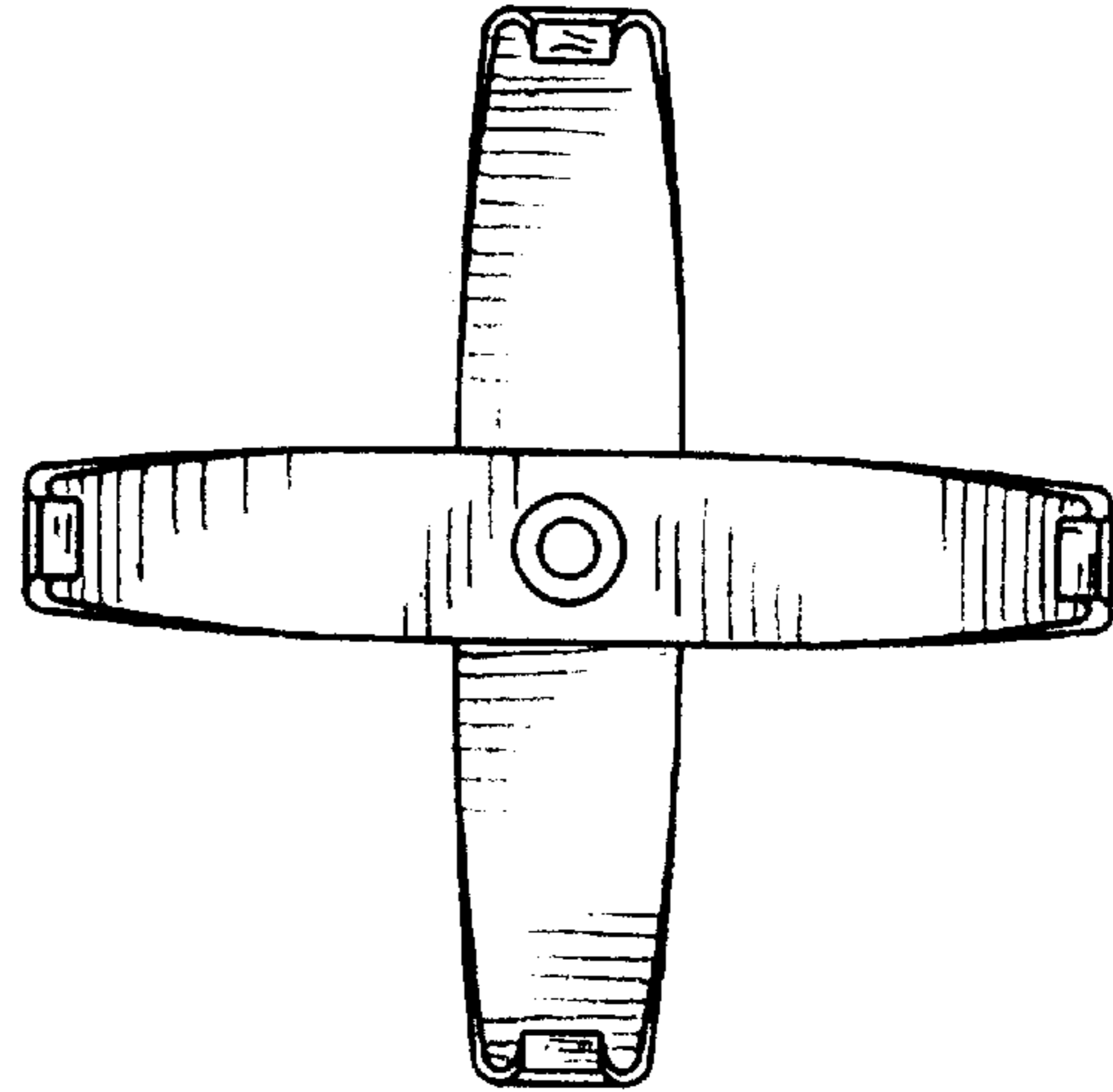
FIG. 10 is a front view of the embodiment of FIG. 8 shown in its folded state.

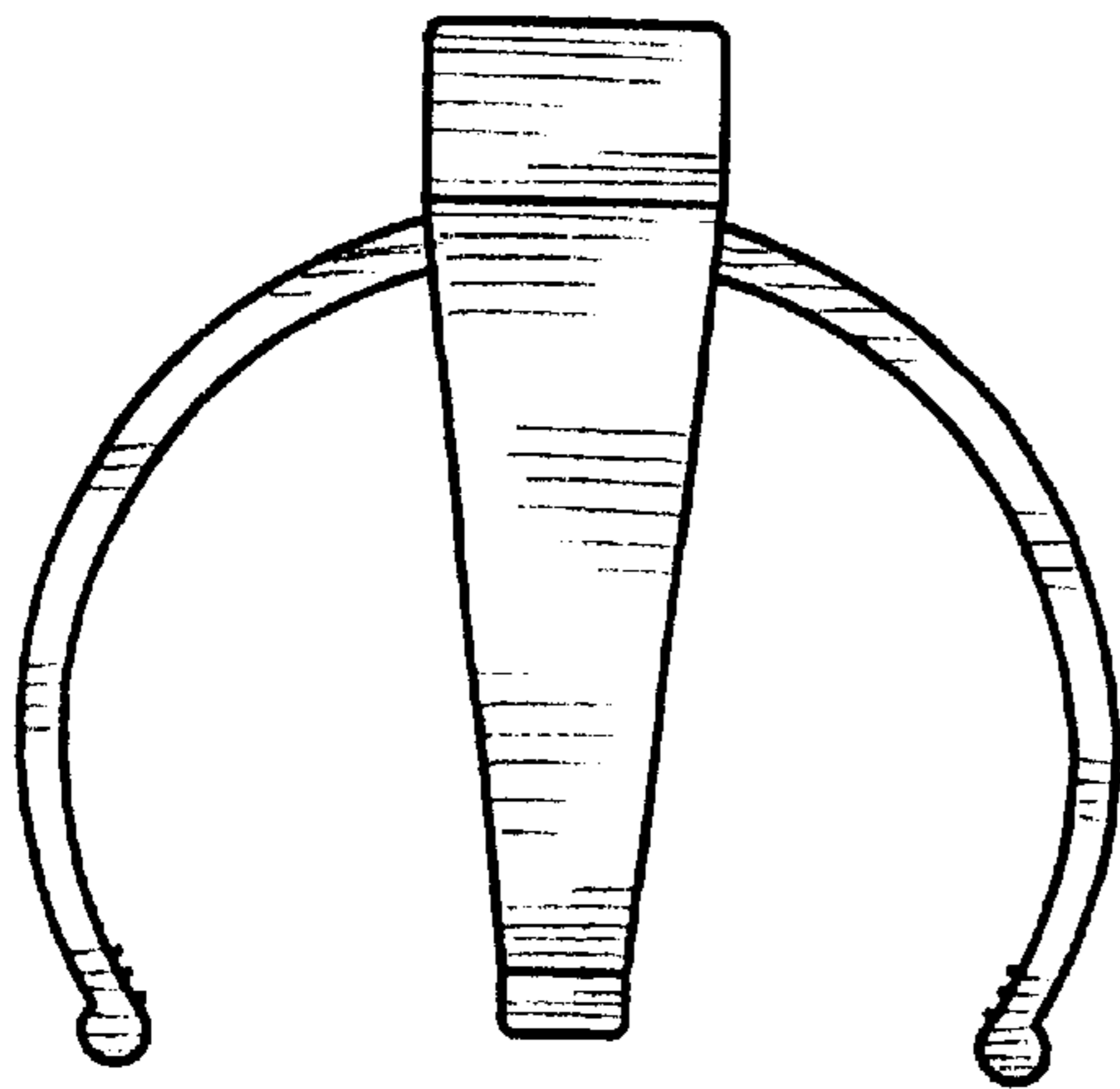




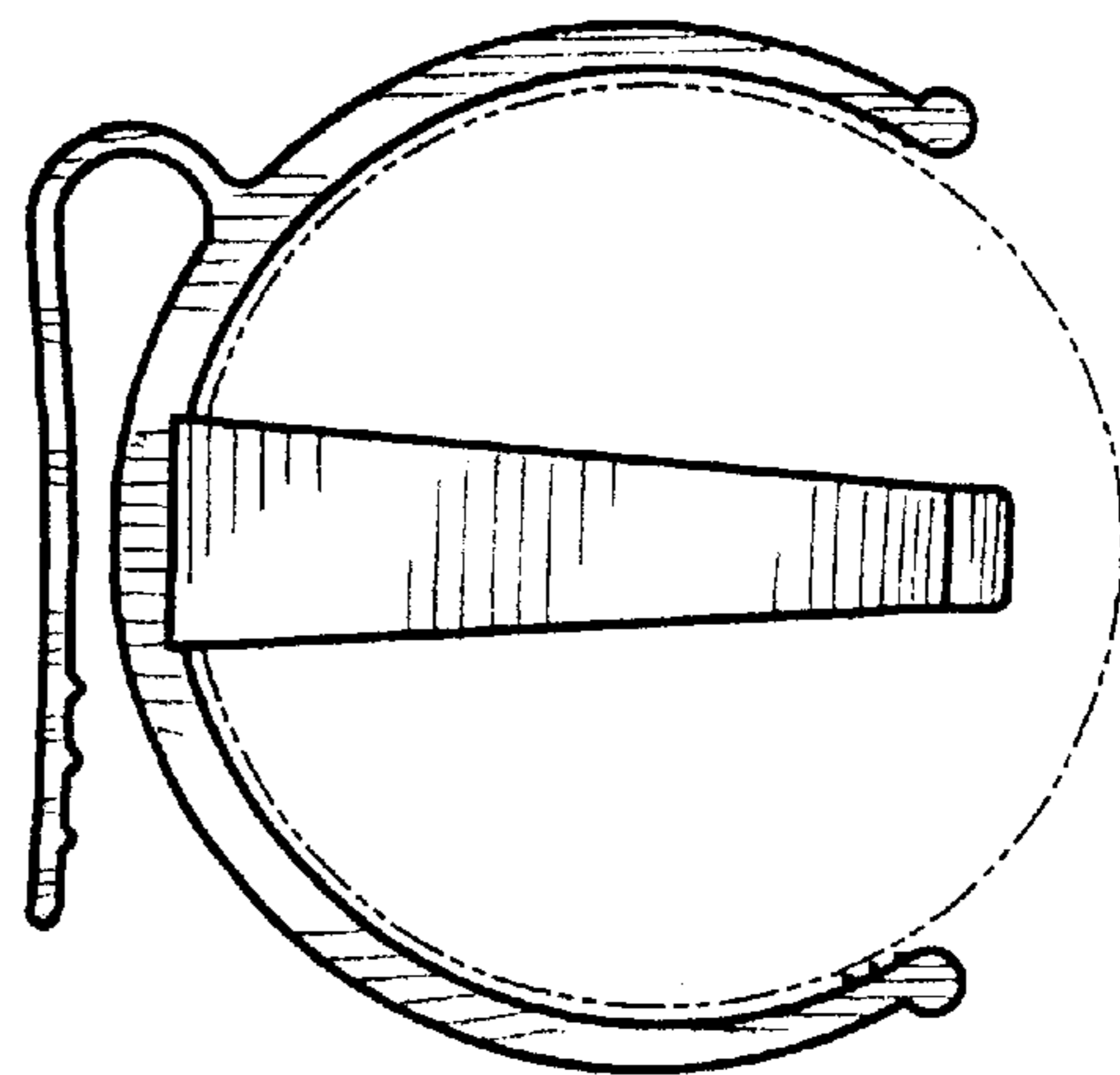

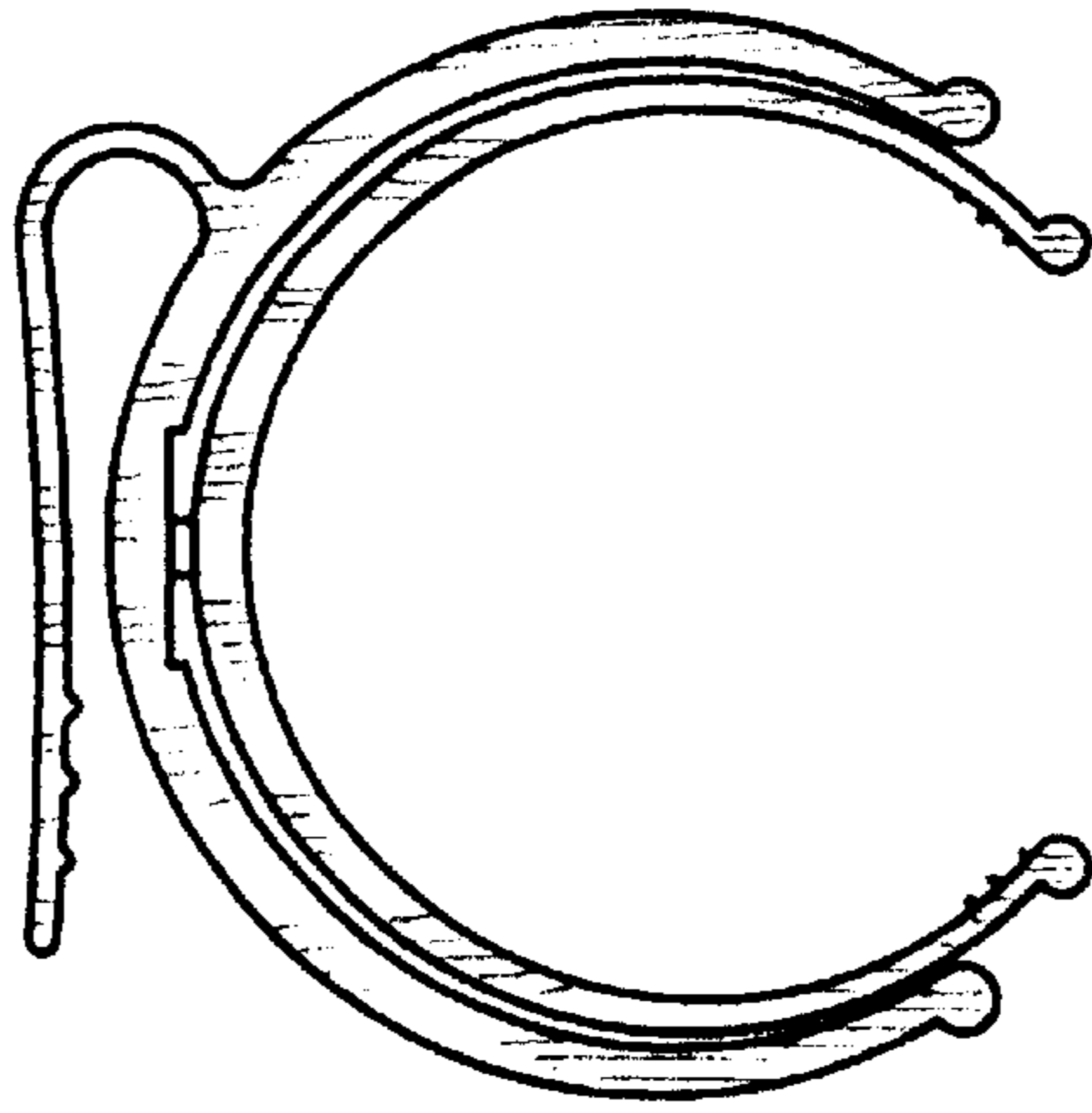

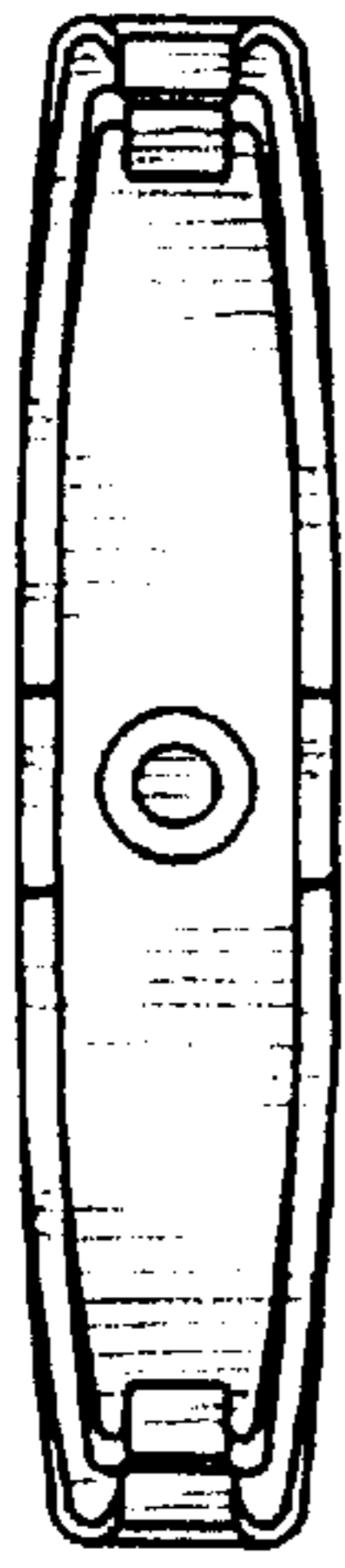

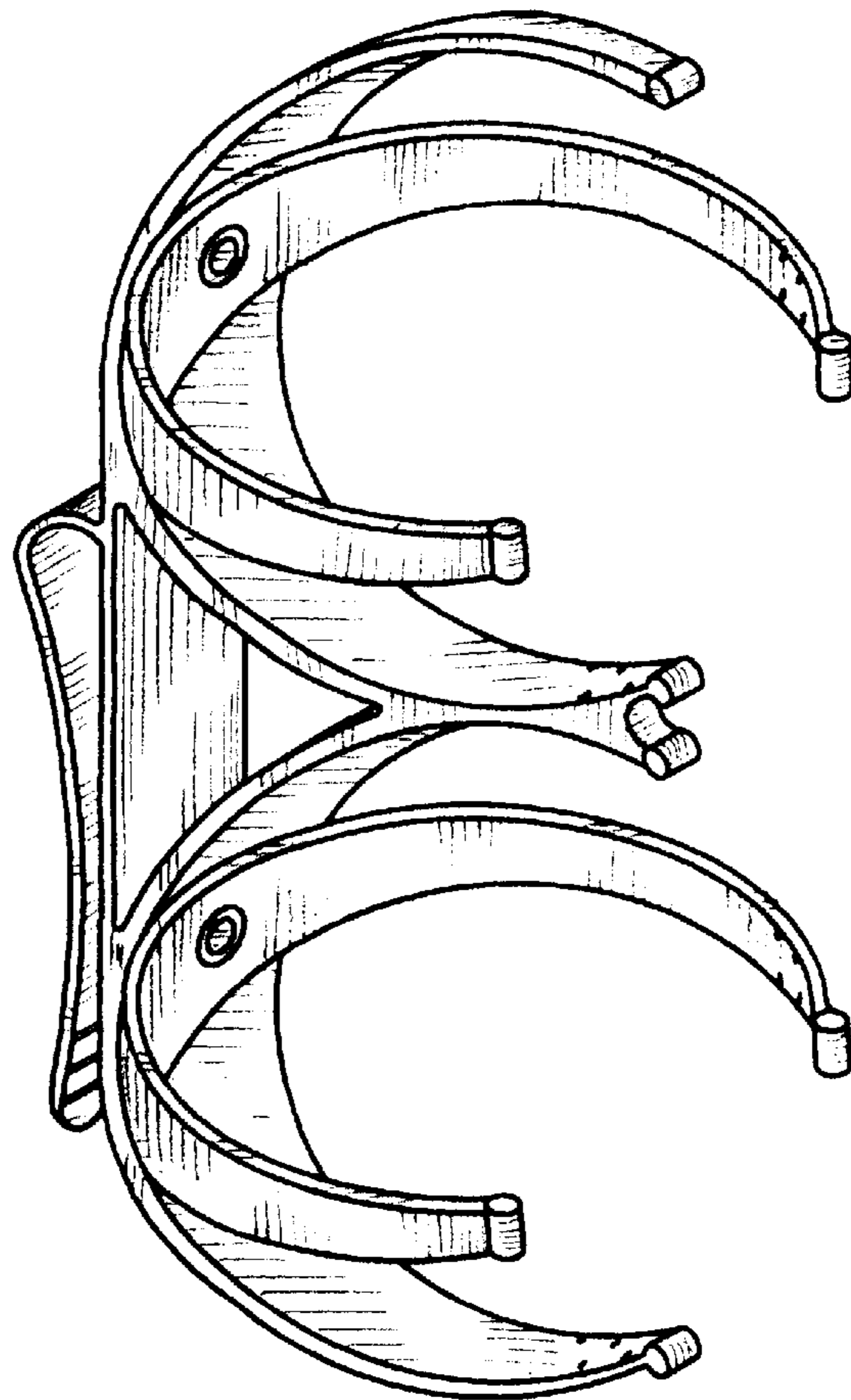

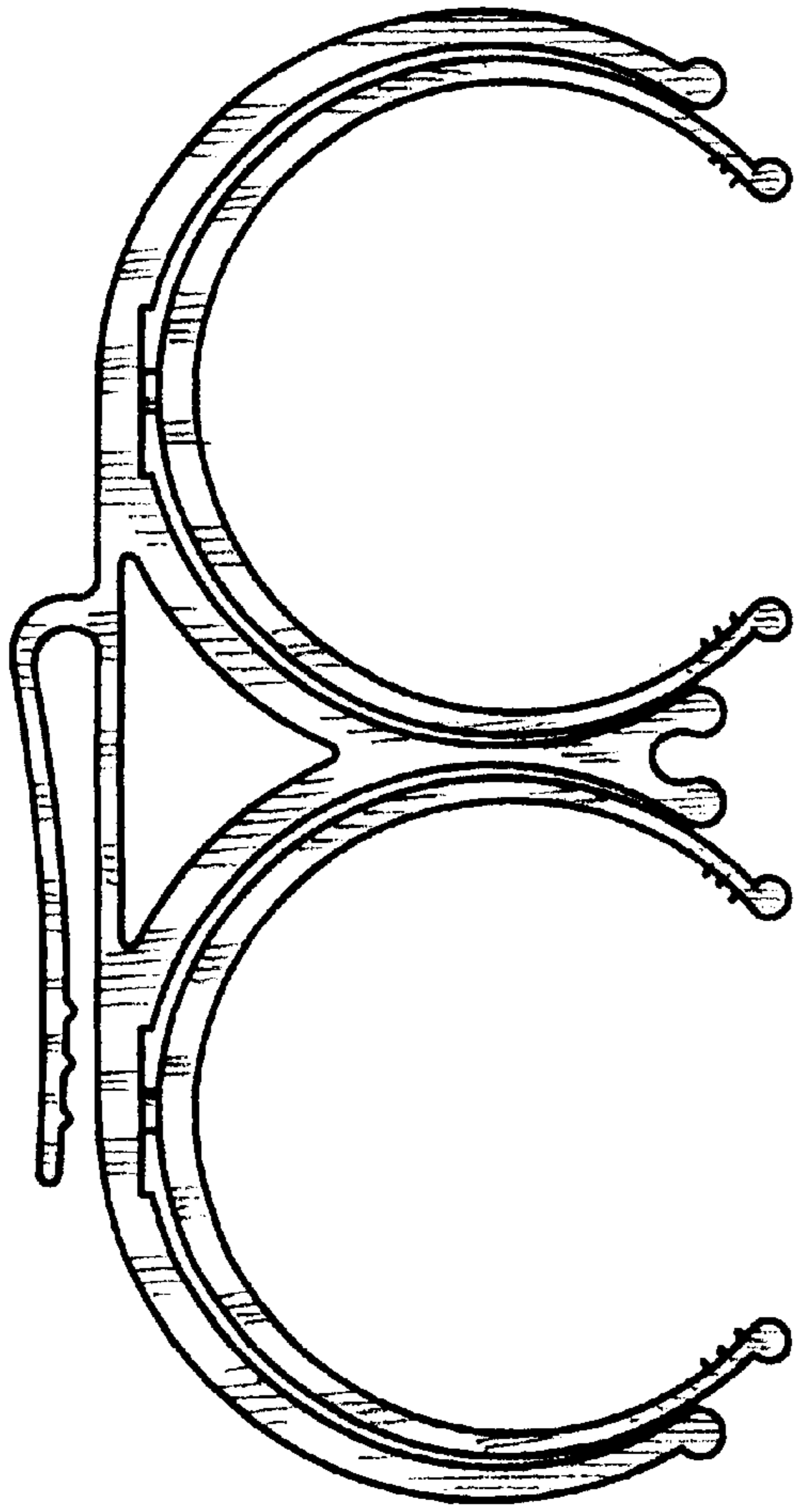

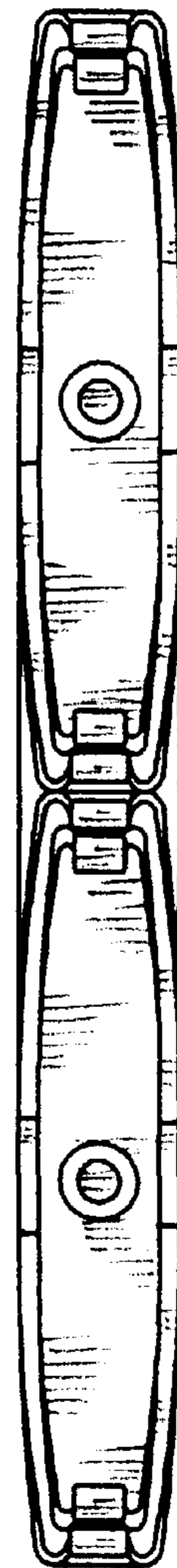
