The ornamental design for a combination leather and fabric handbag with a curved bottom, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combination leather and fabric handbag with a curved bottom showing my new design;

FIG. 6 is a left side elevational view thereof;

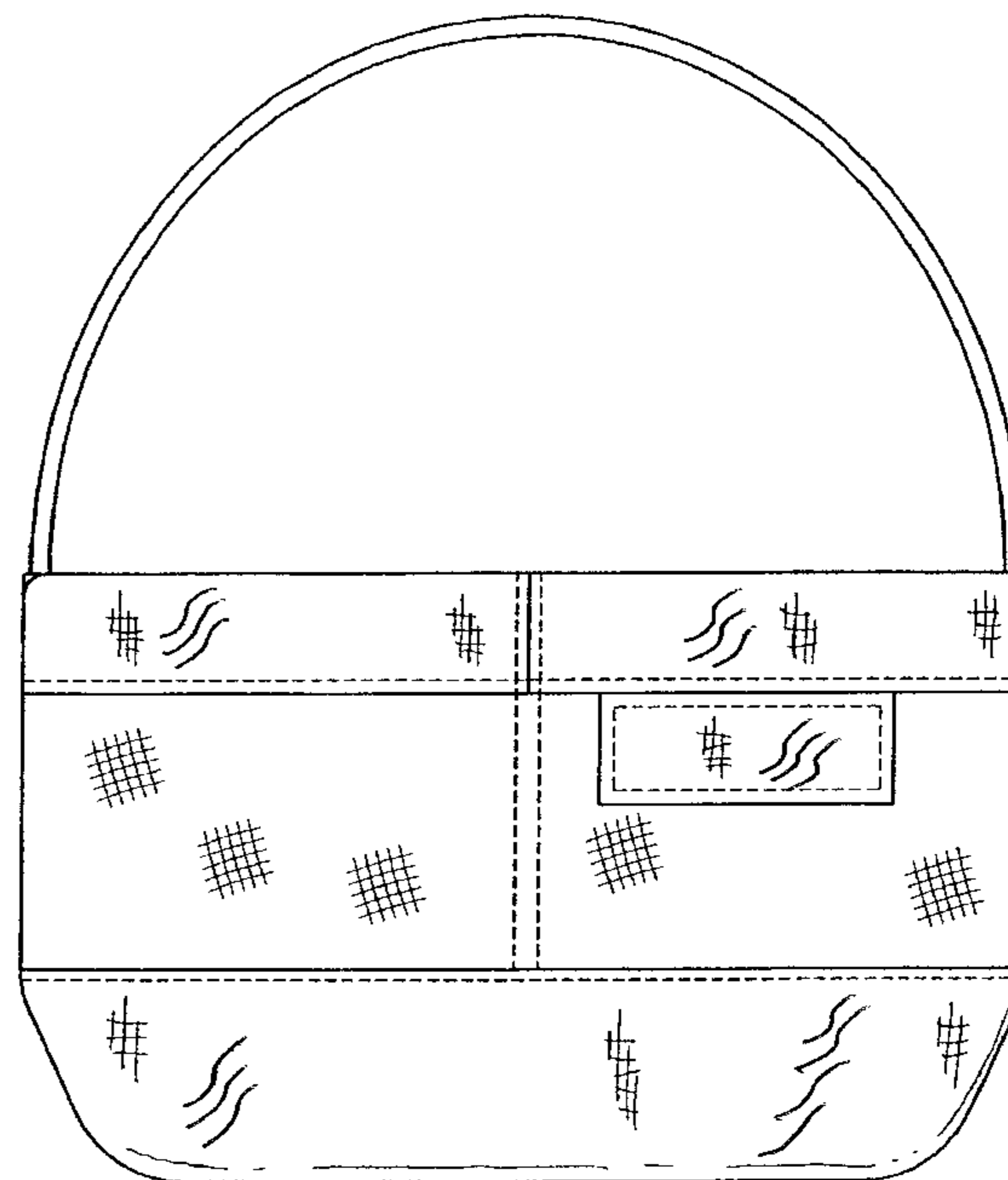
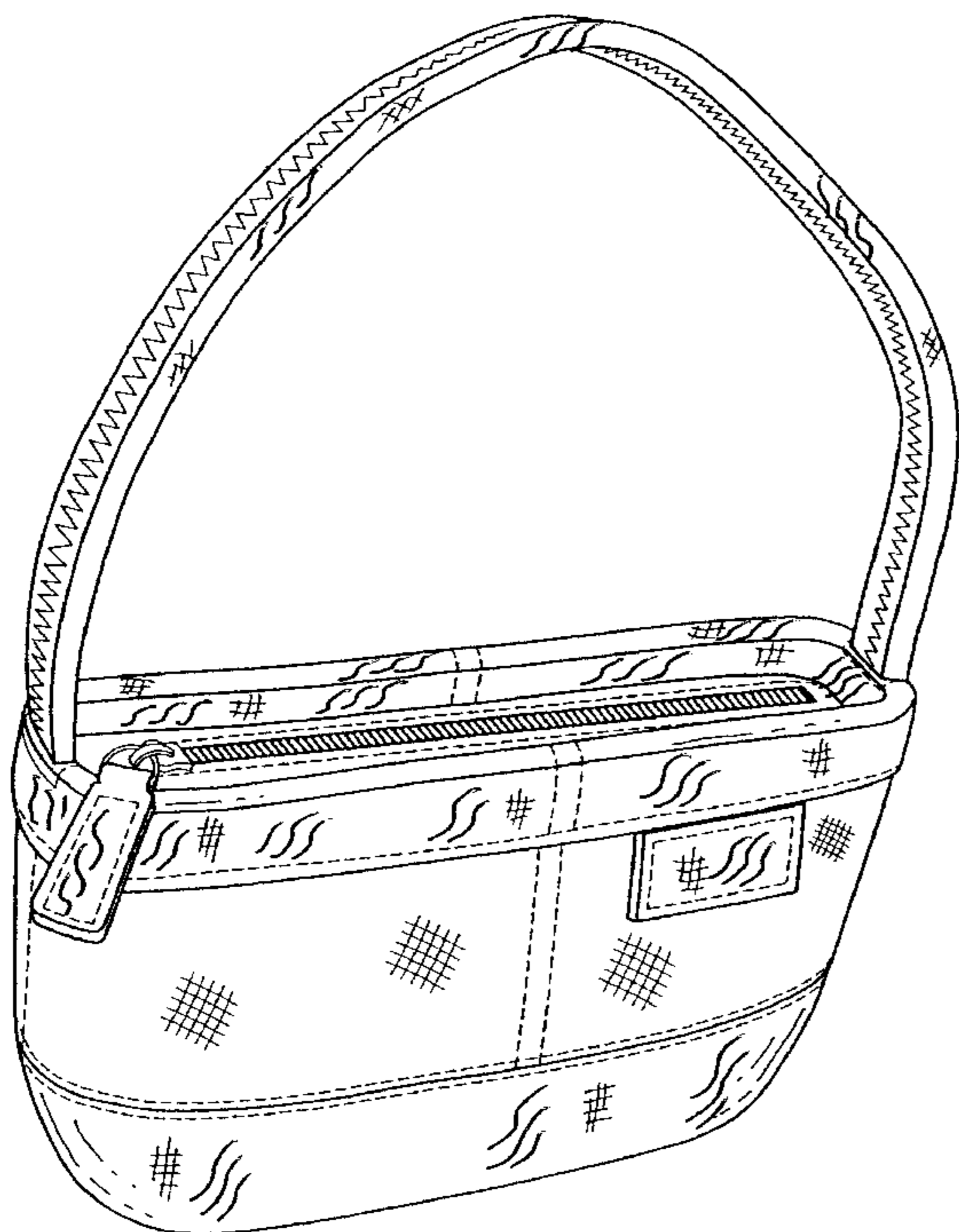
FIG. 7 is a right side elevational view thereof;

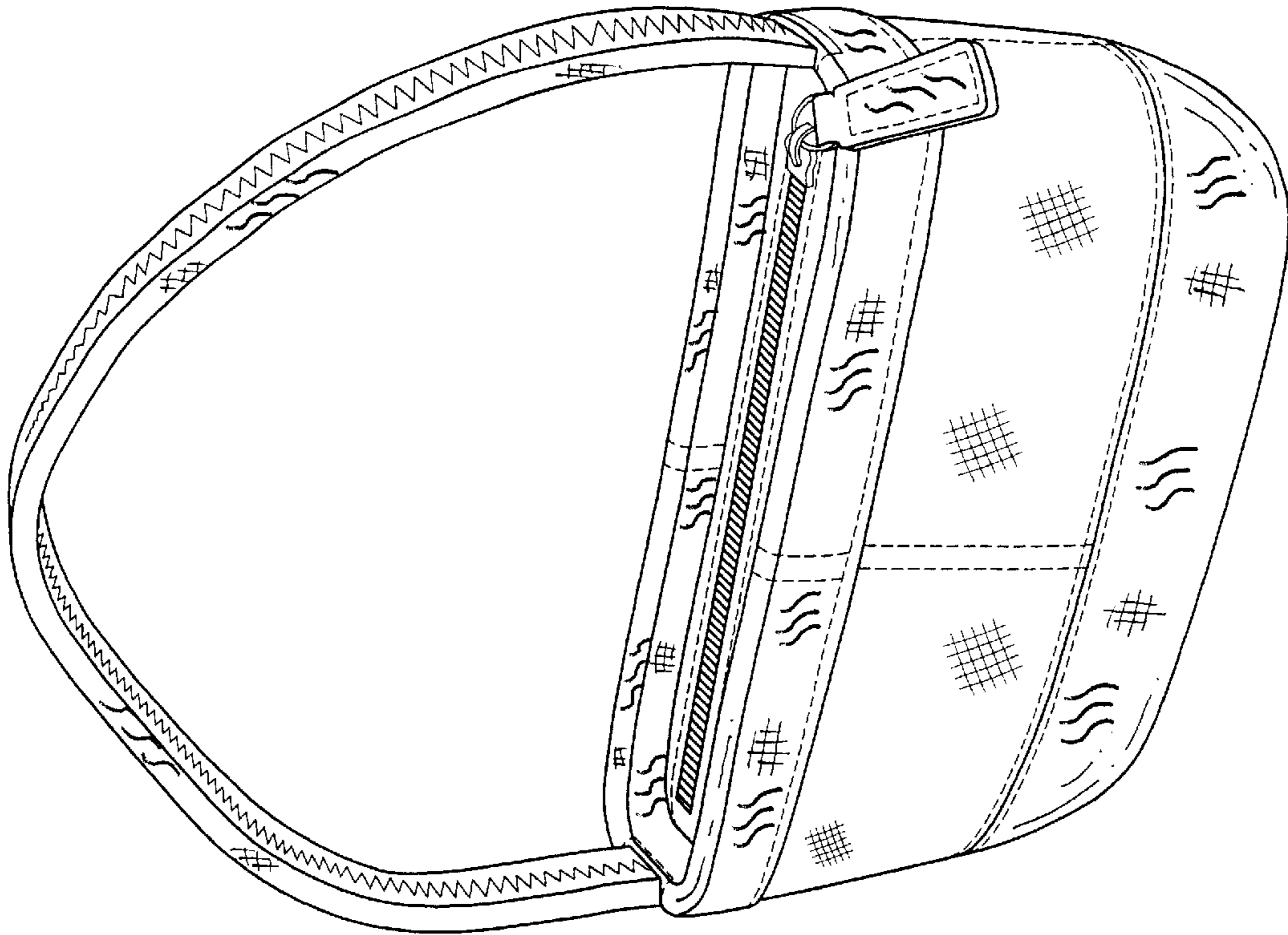

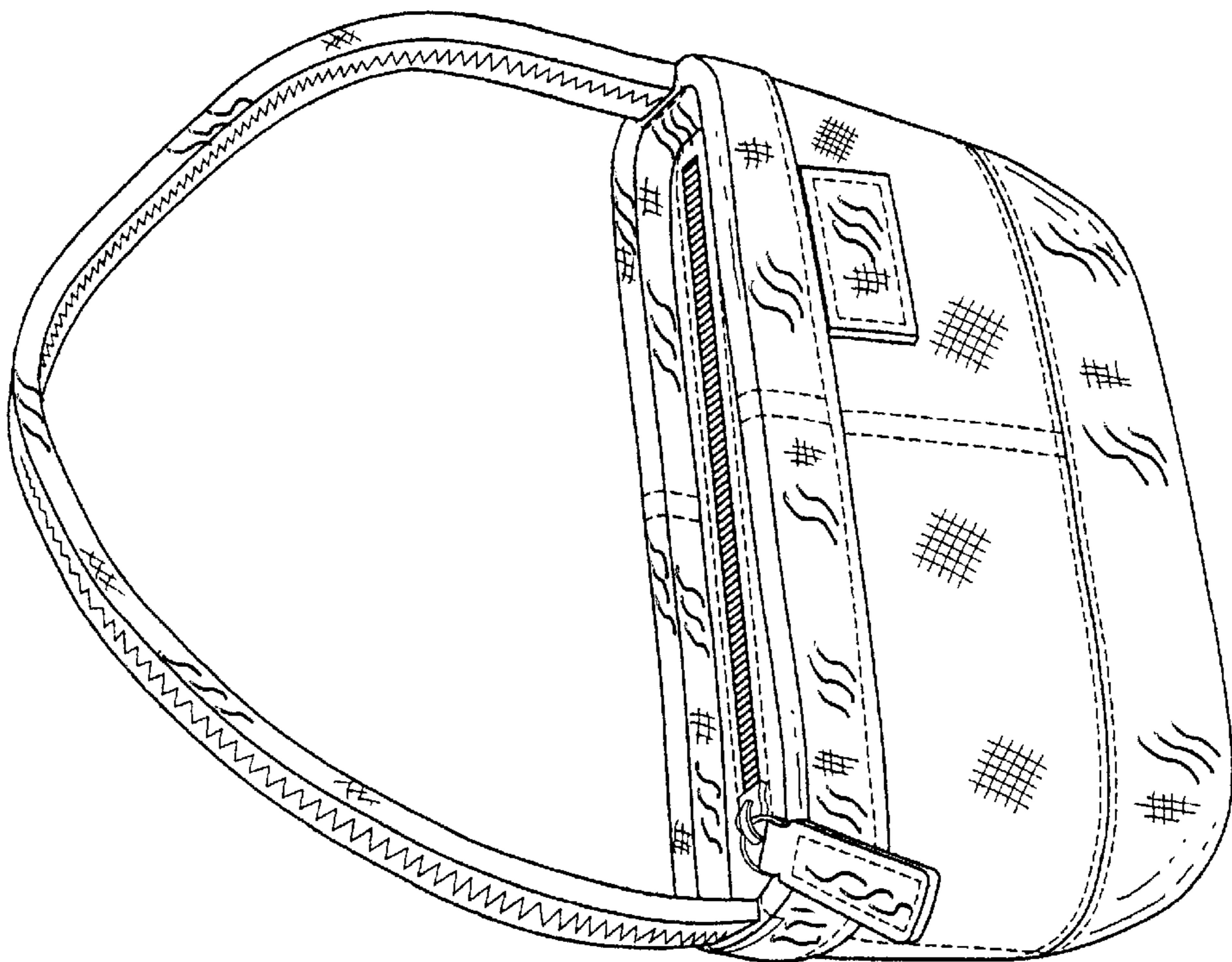

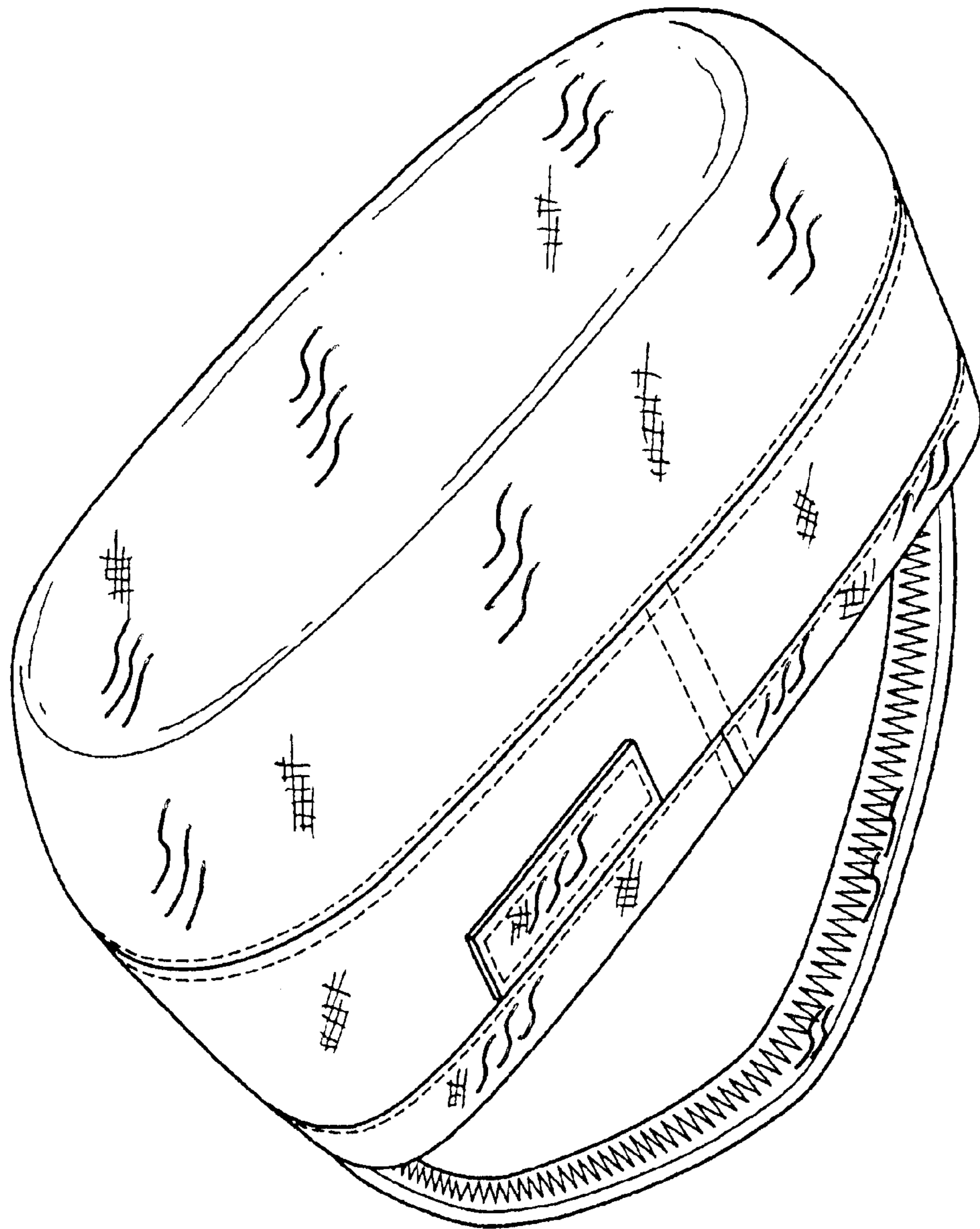

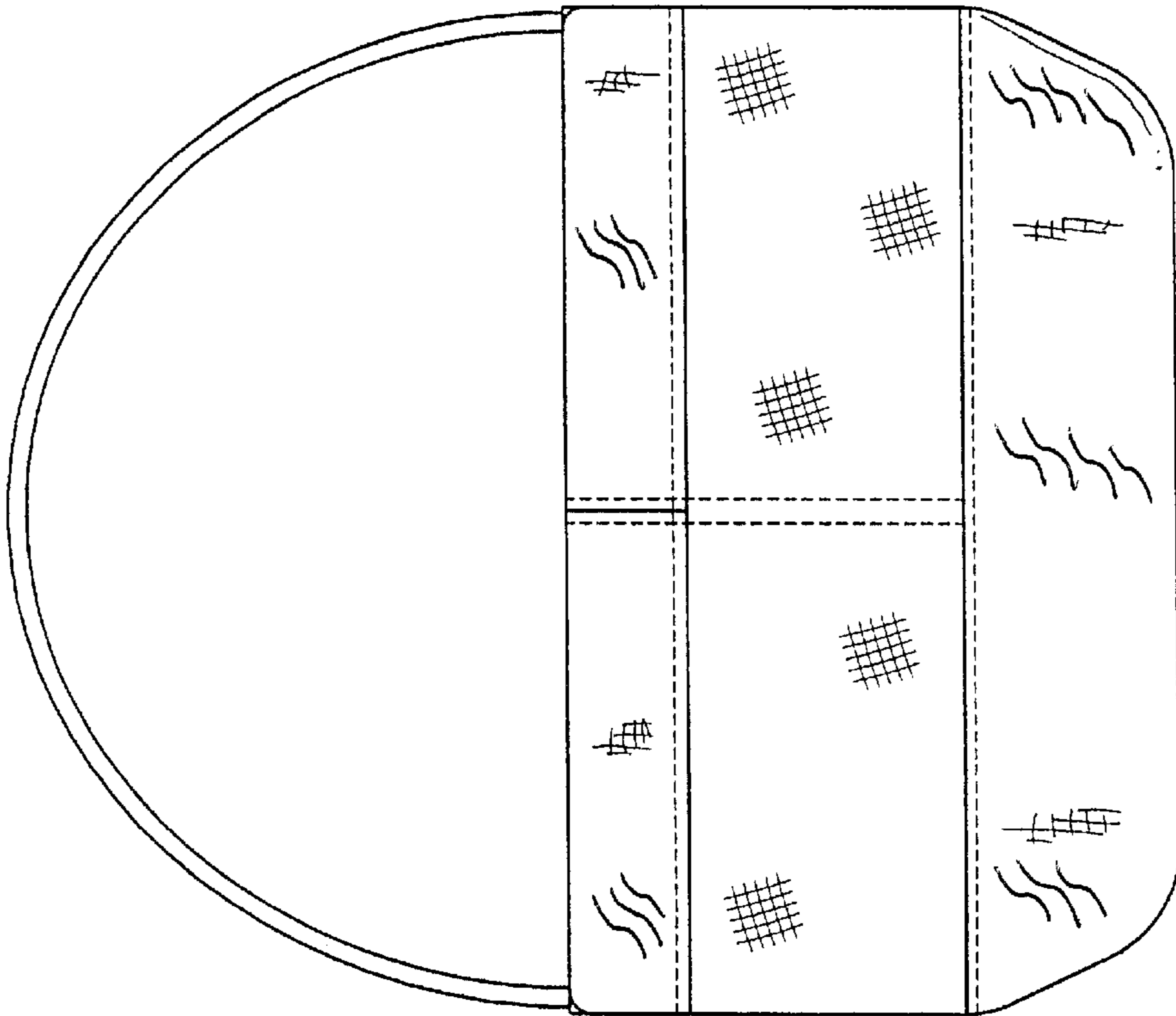

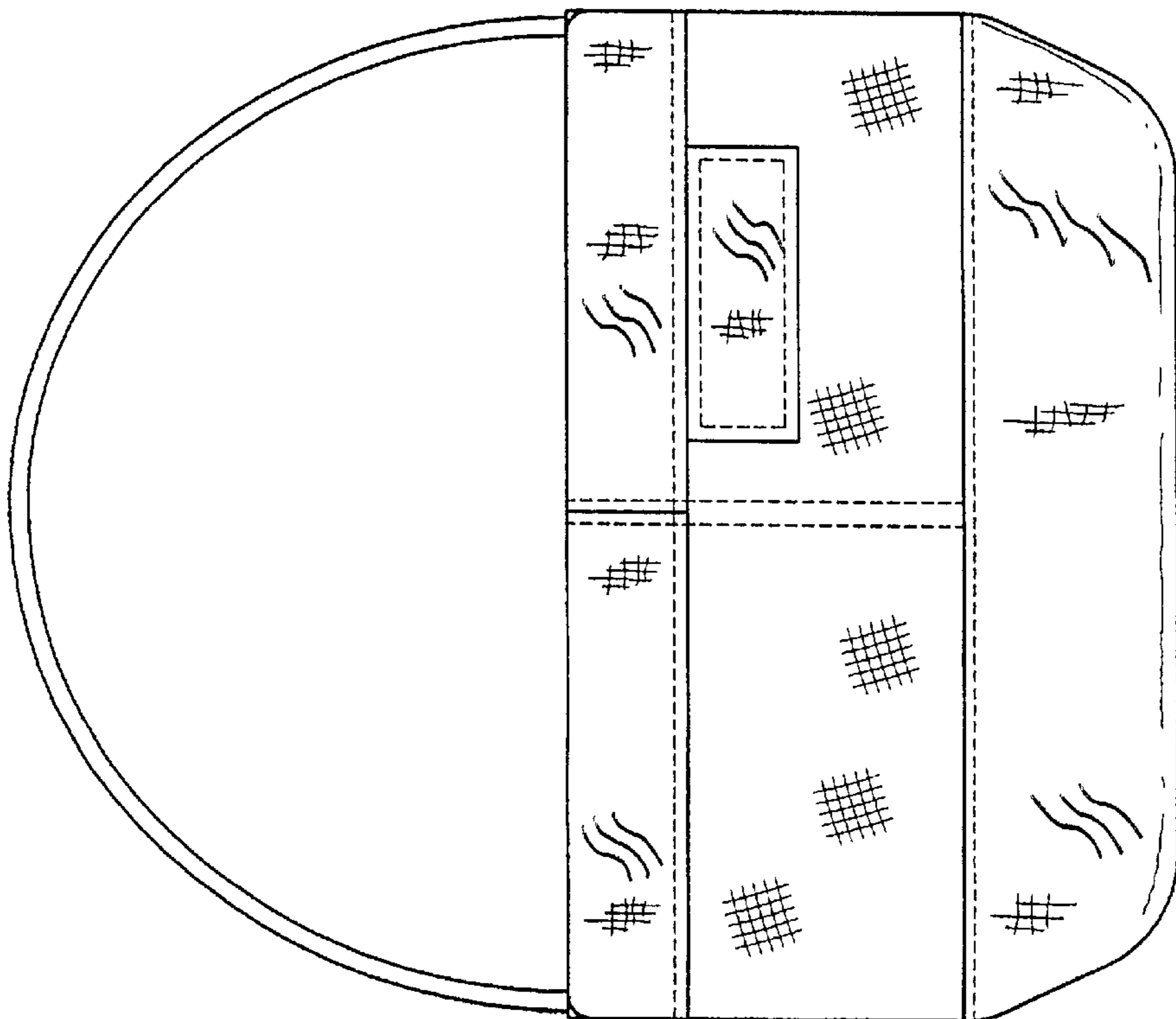

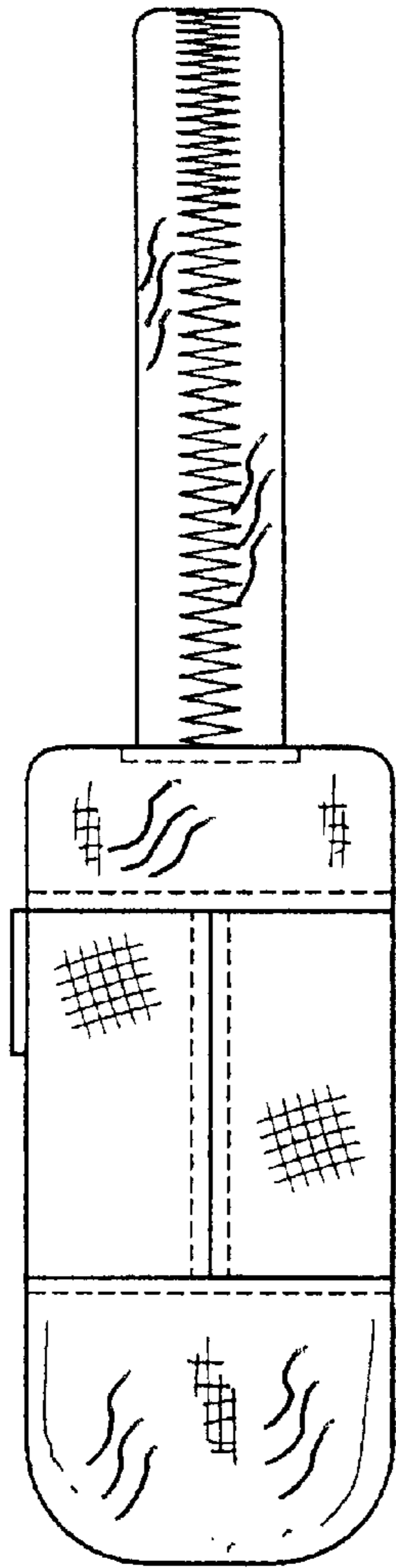

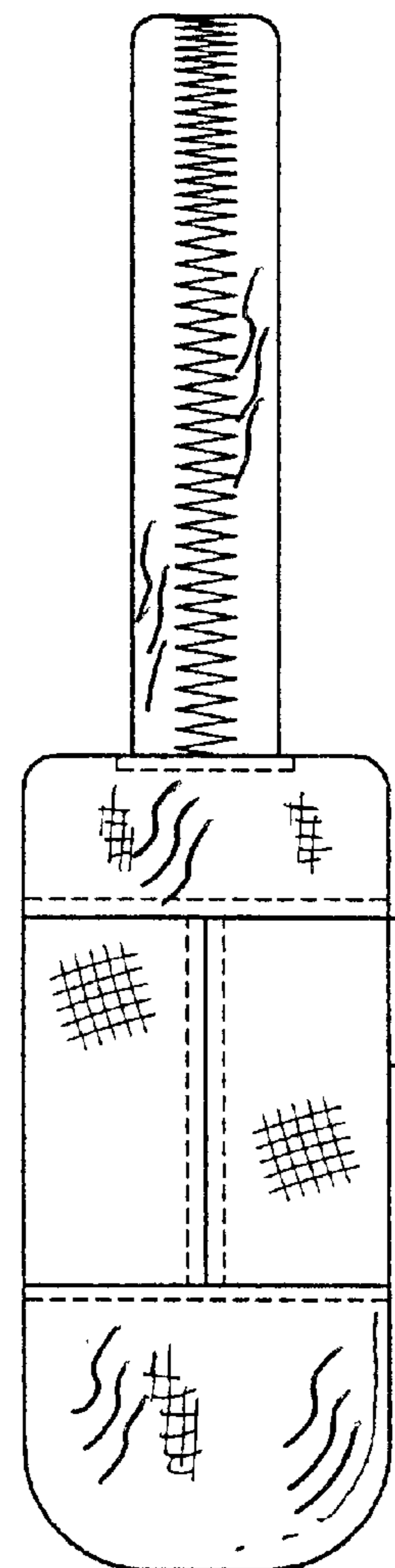

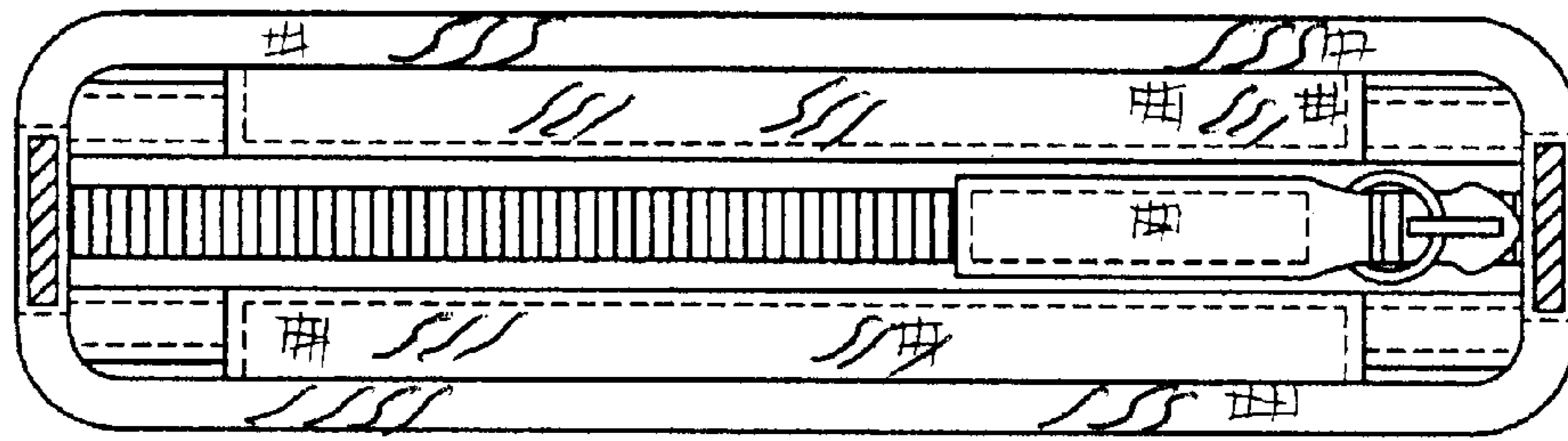

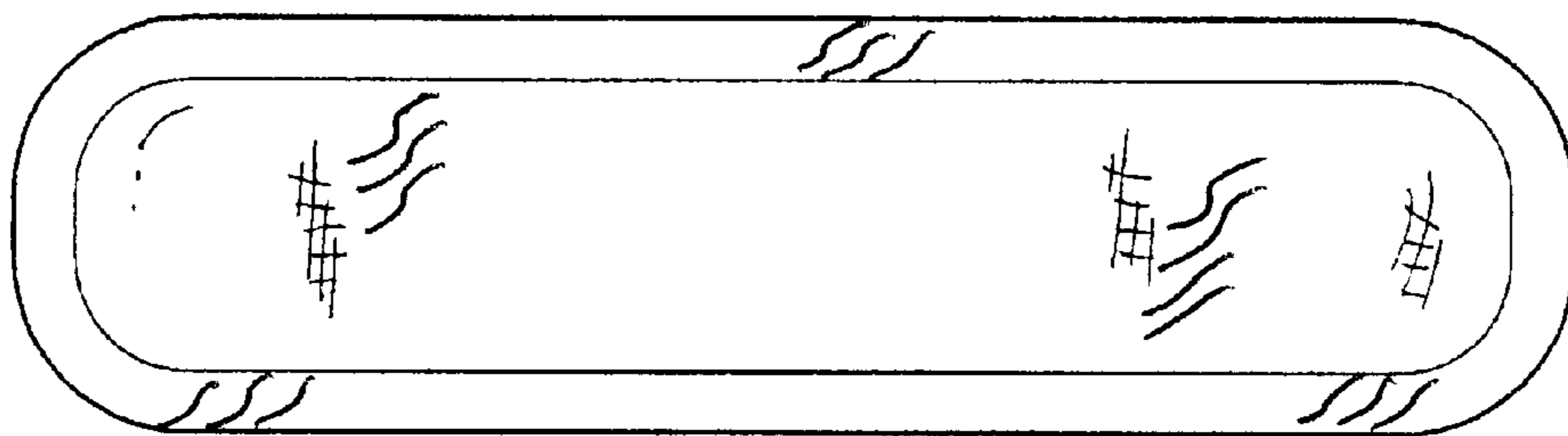
