**DESCRIPTION**

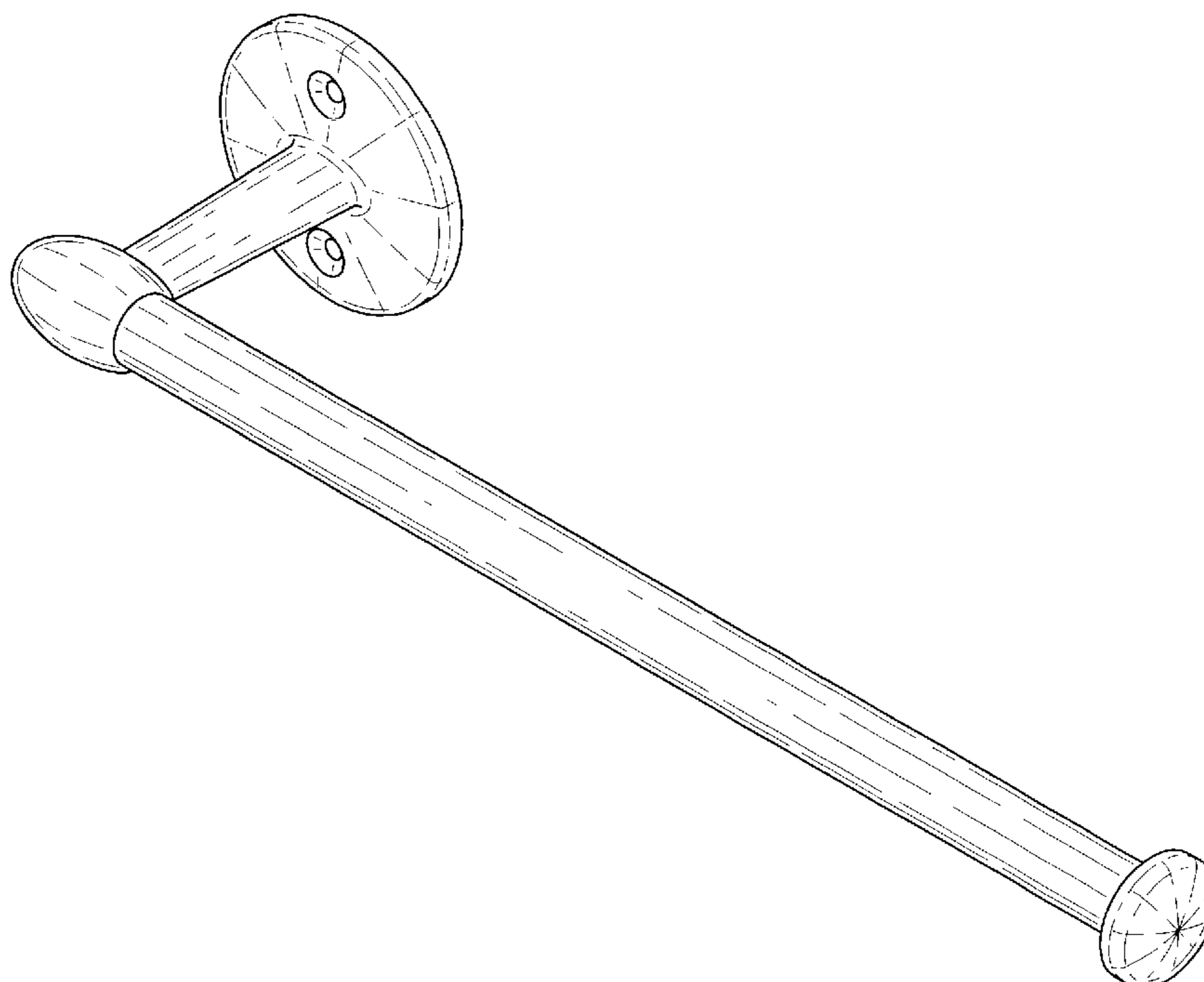
FIG. 1 is a perspective view of the wall mount paper towel holder according to the invention;

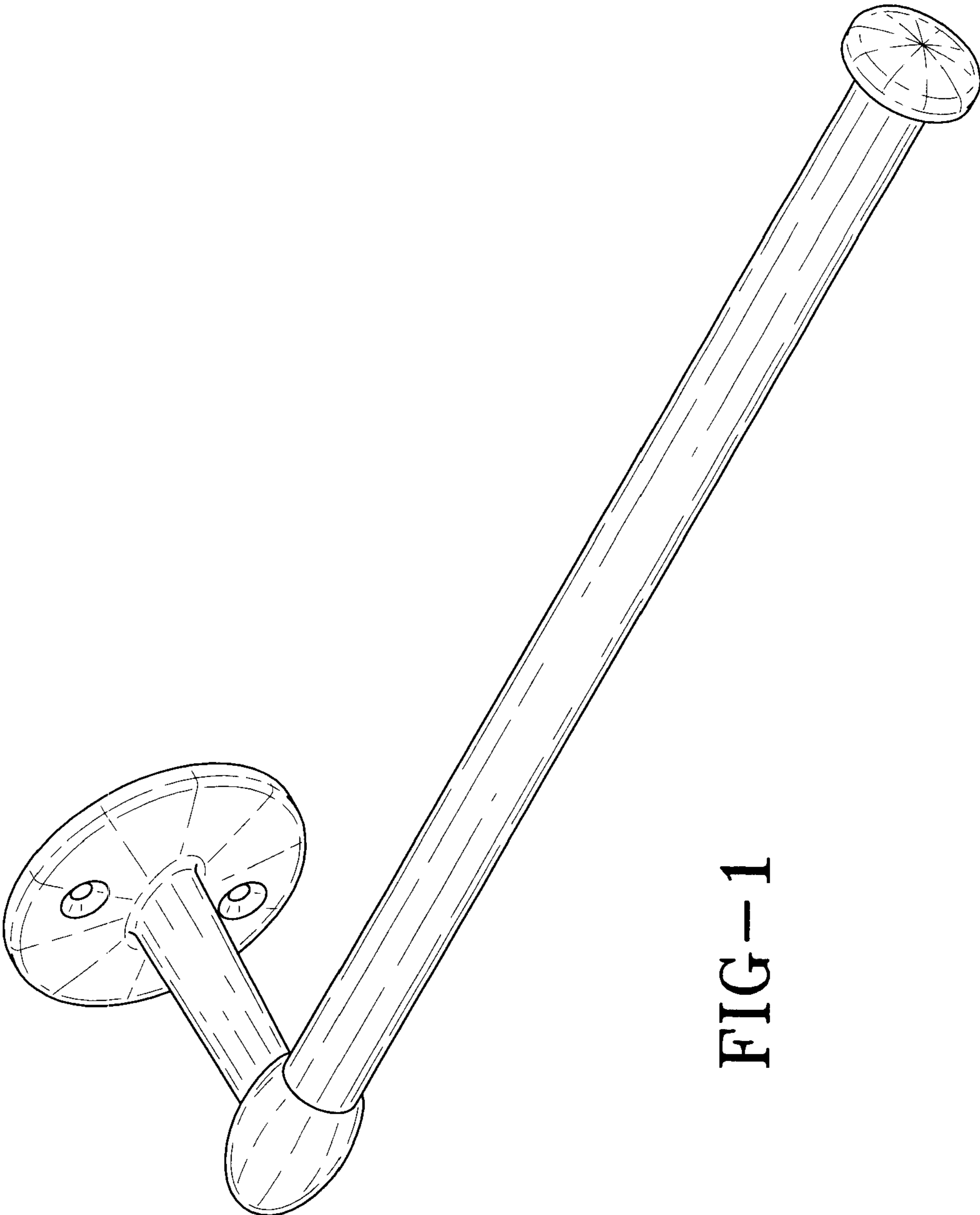

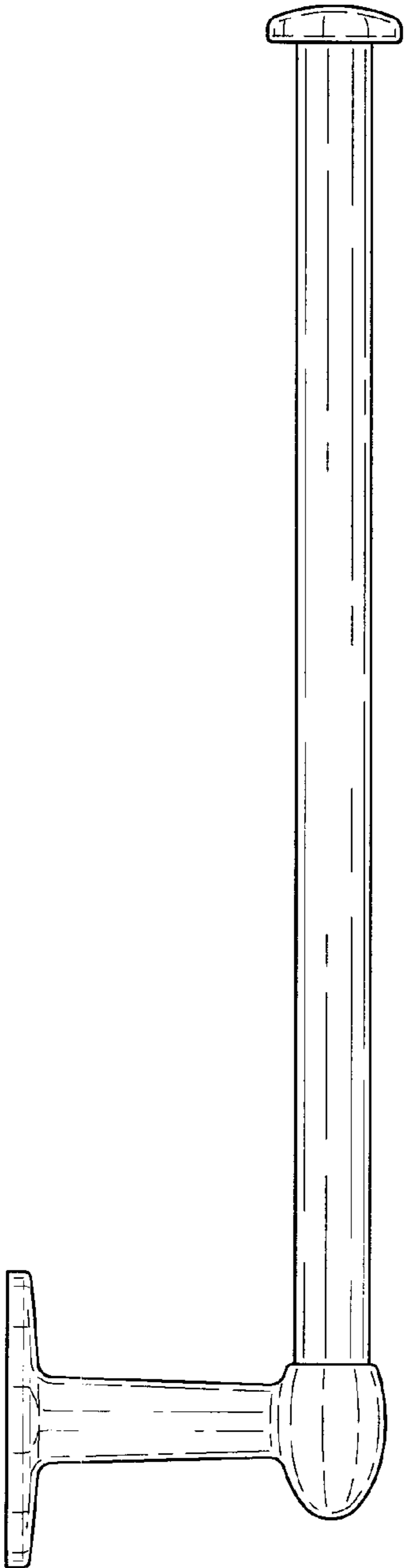

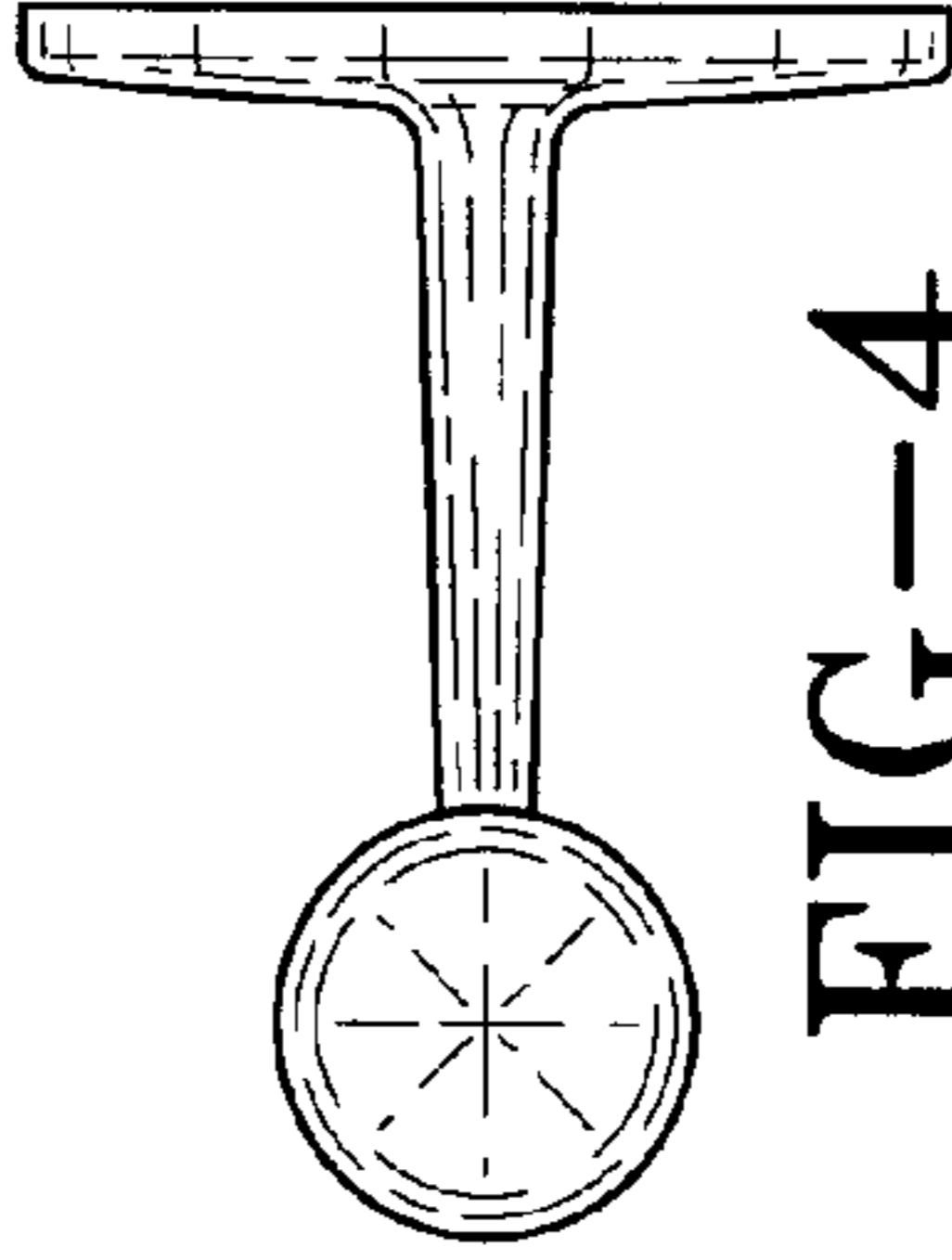

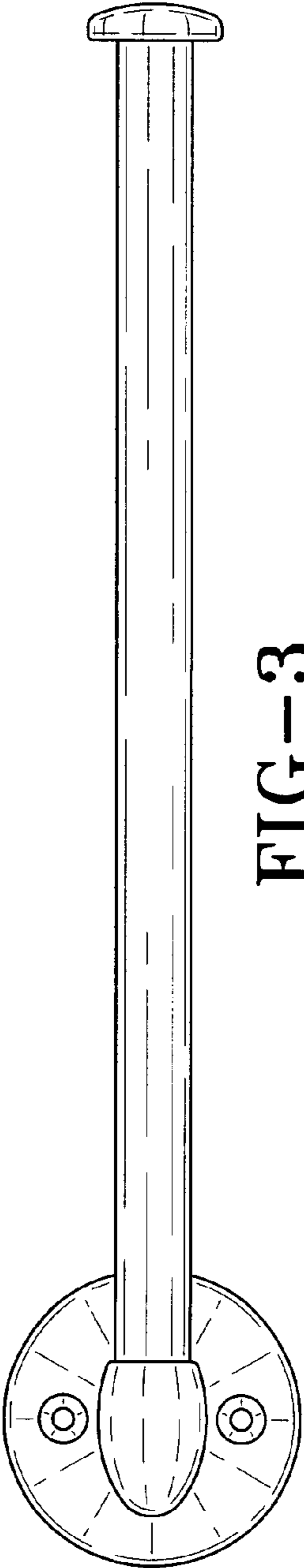

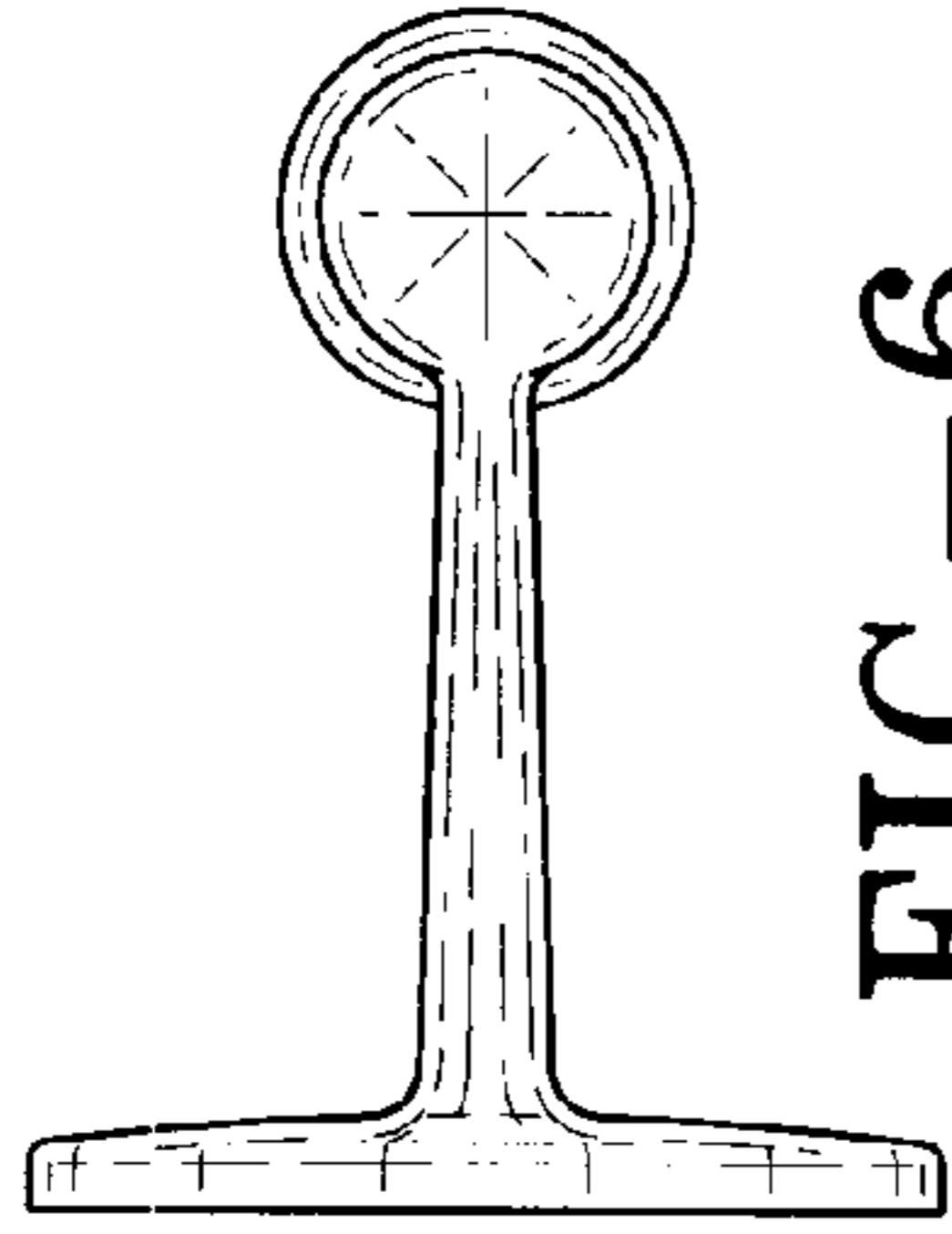

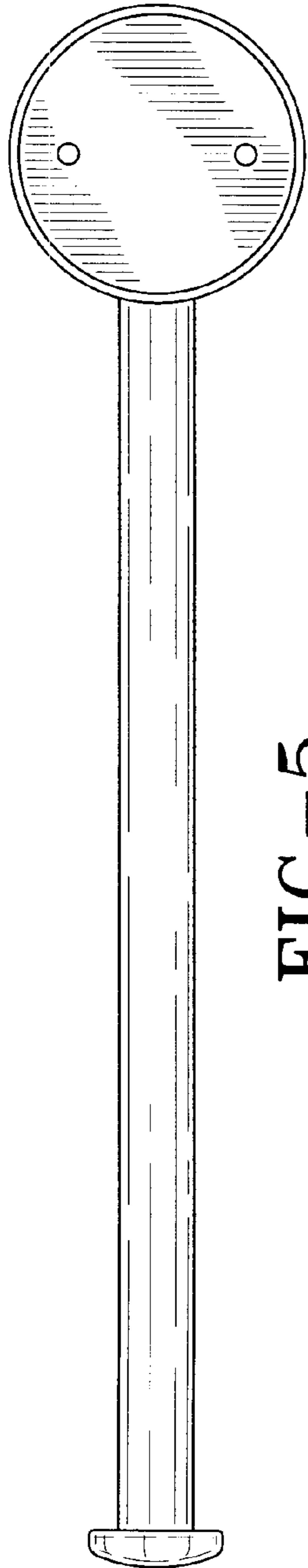

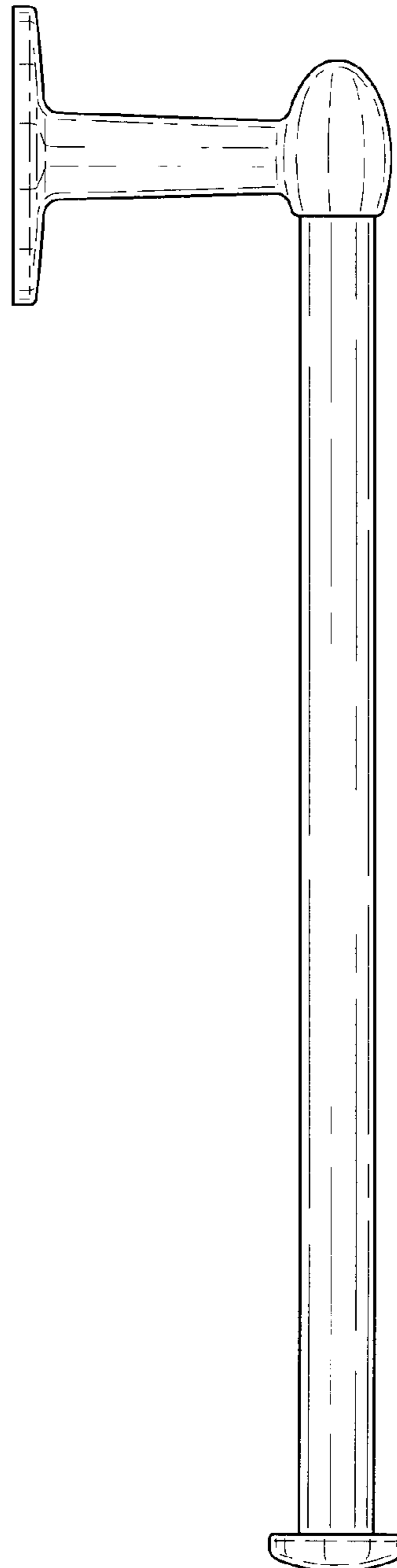
