DESCRIPTION

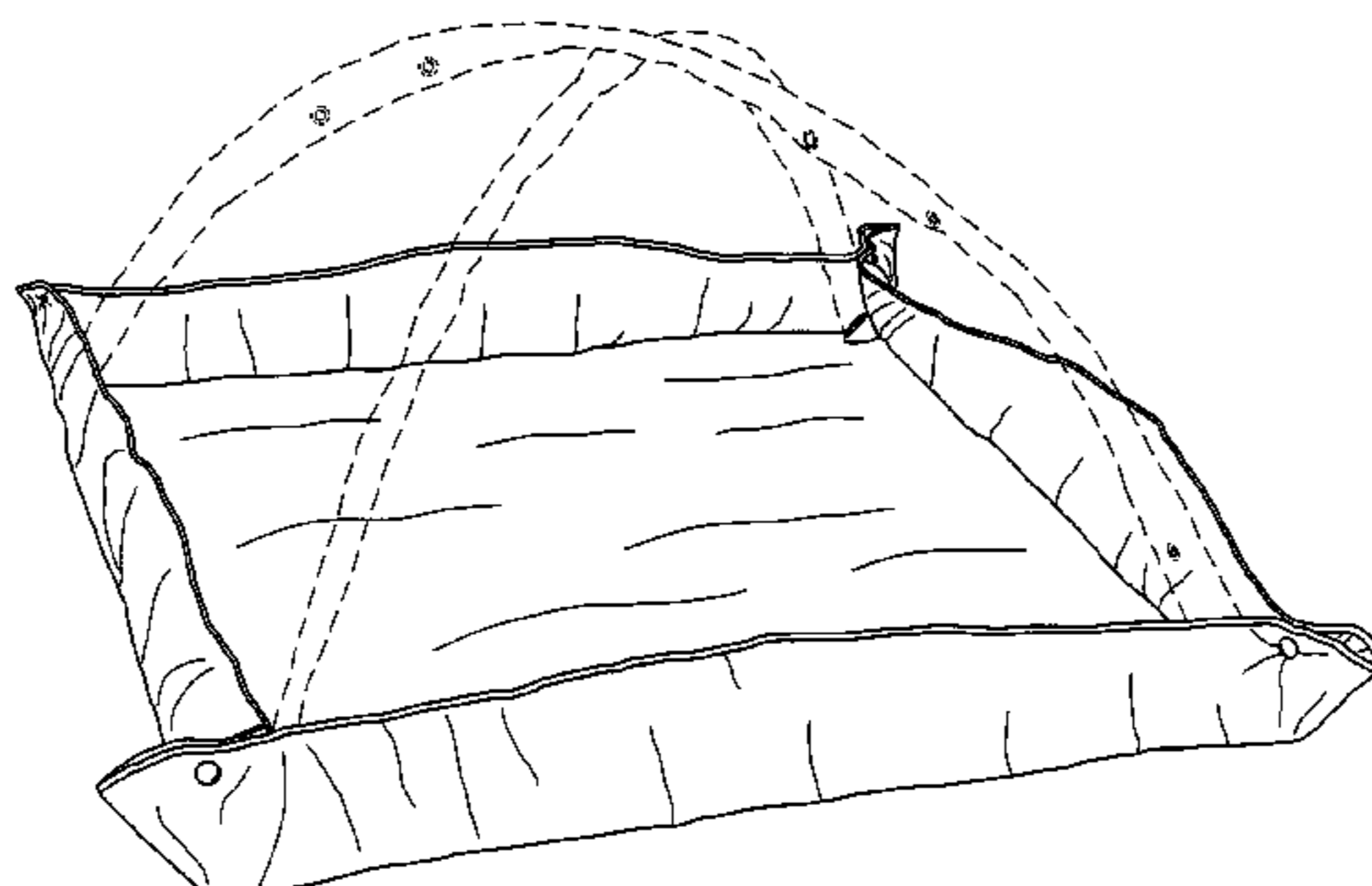
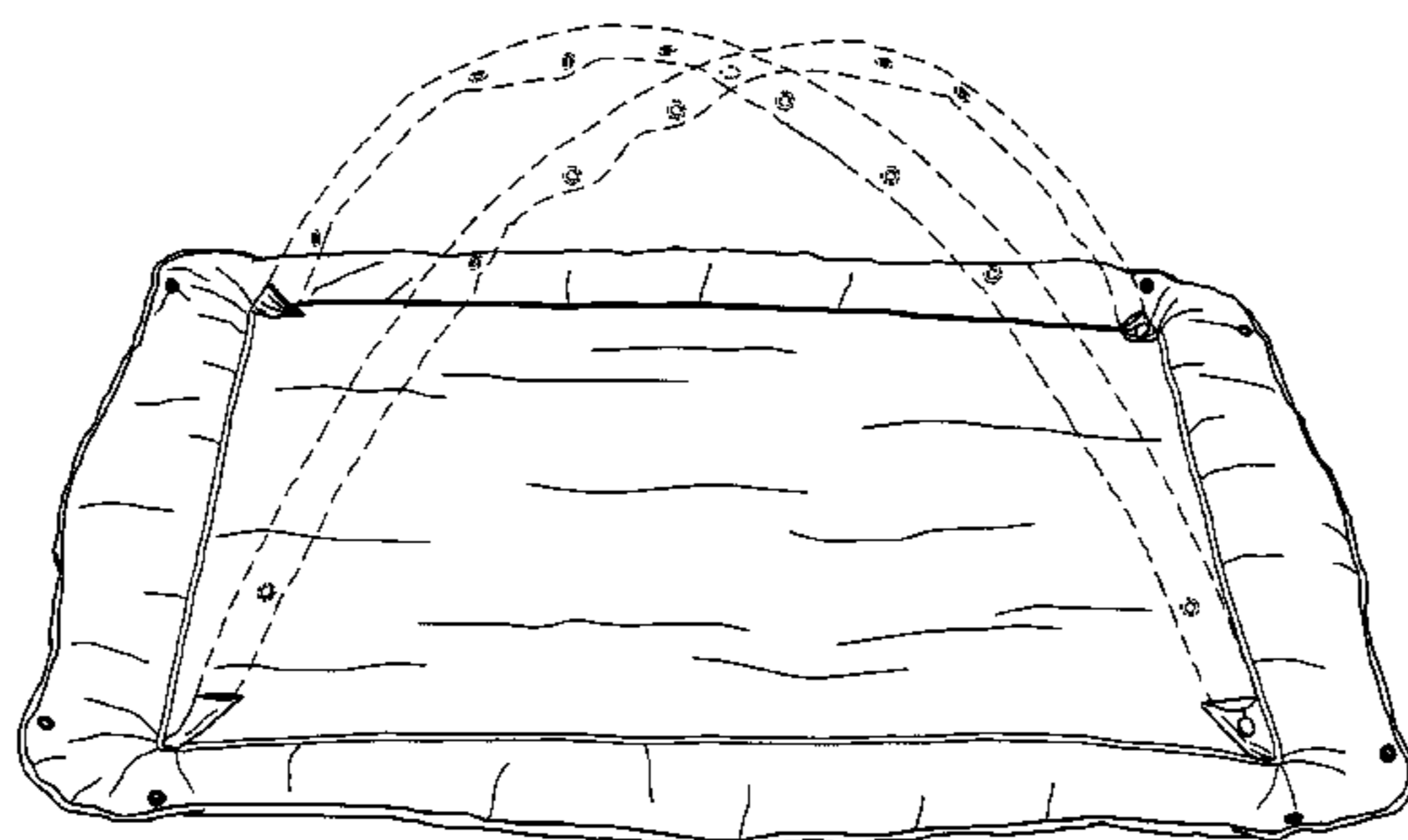
FIG. 1 is an isometric view of the activity mat in a first, flat position;
FIG. 2 is a side view of the activity mat seen in FIG. 1;
FIG. 3 is a top view of the activity mat in FIG. 1;
FIG. 4 is an isometric view of the activity mat in a second position with erected side walls;
FIG. 5 is a side view of the activity mat in the position seen in FIG. 4; and,
FIG. 6 is a top view of the activity mat in the position seen in FIG. 4.

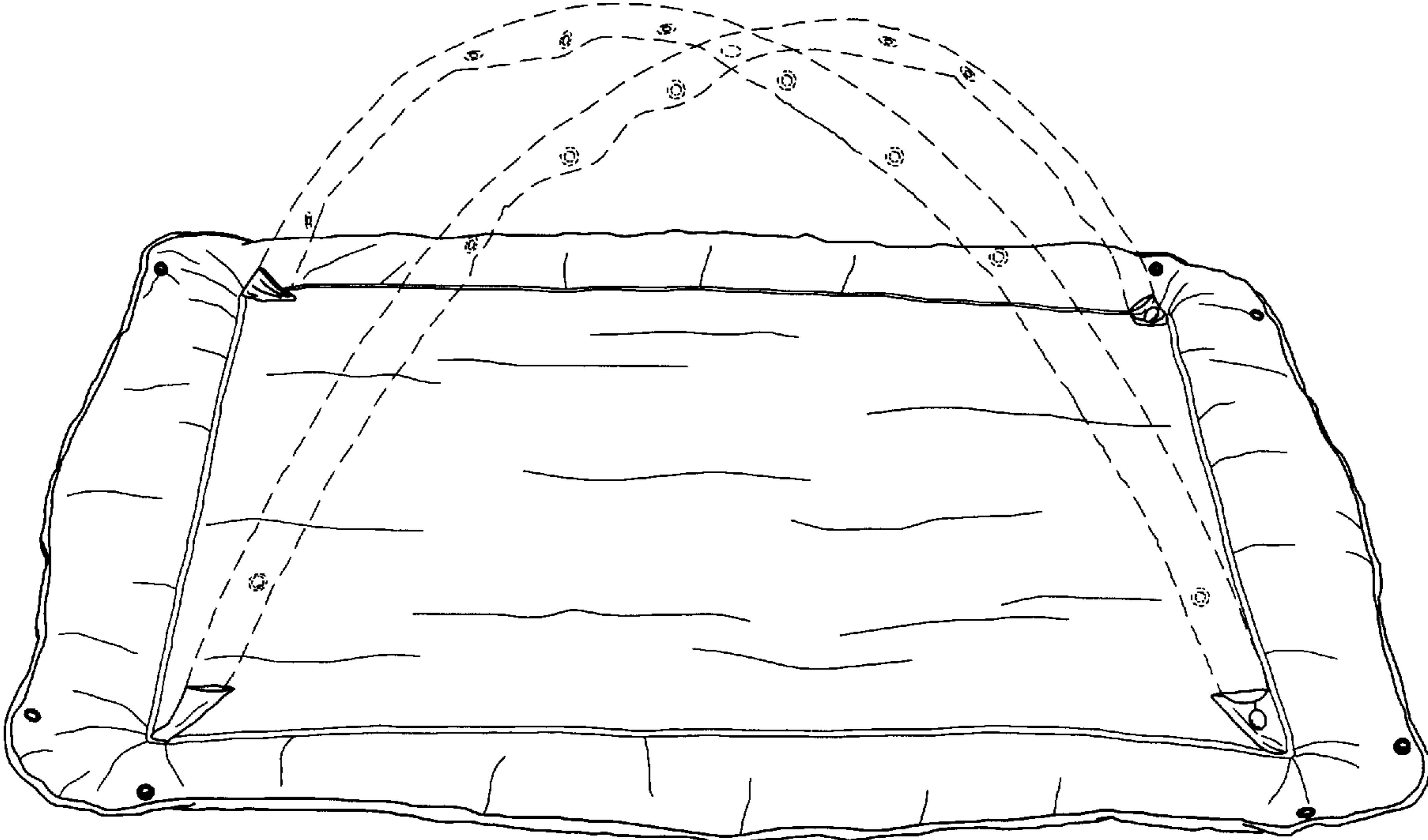

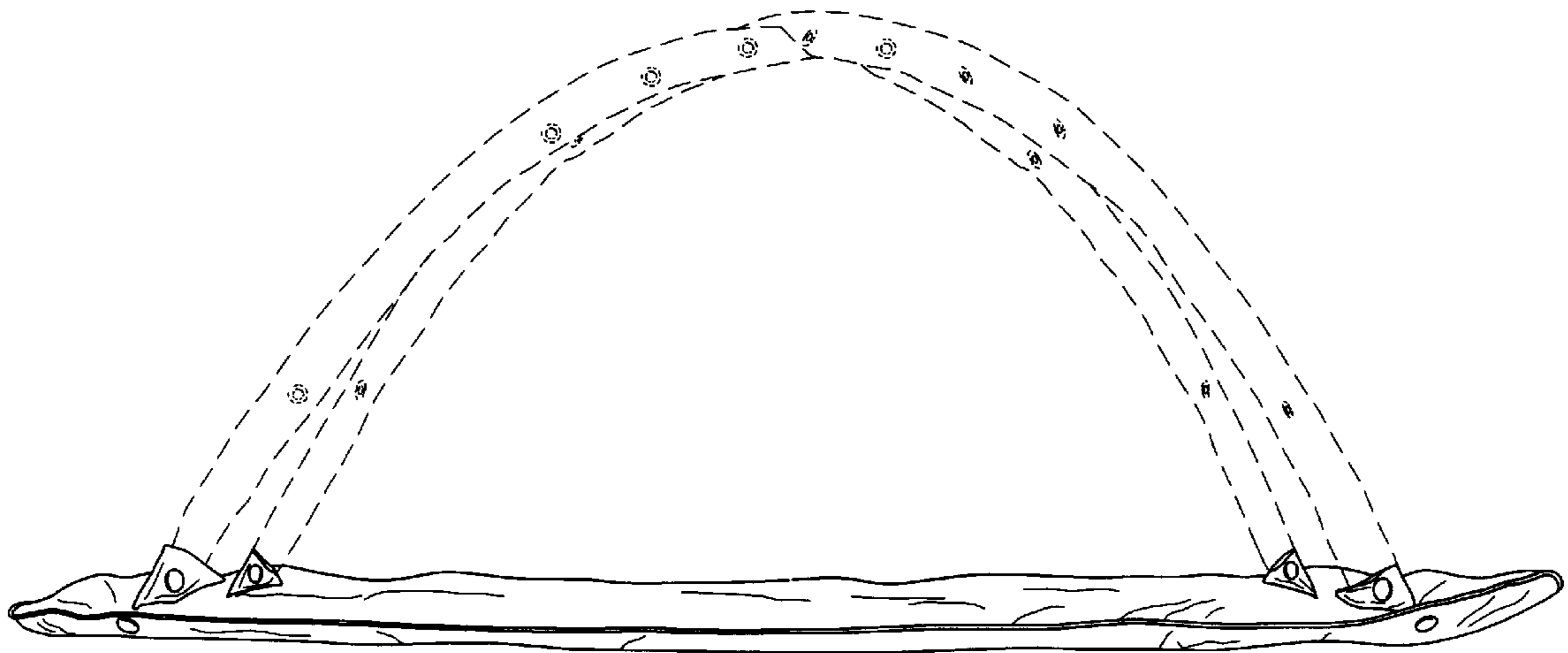

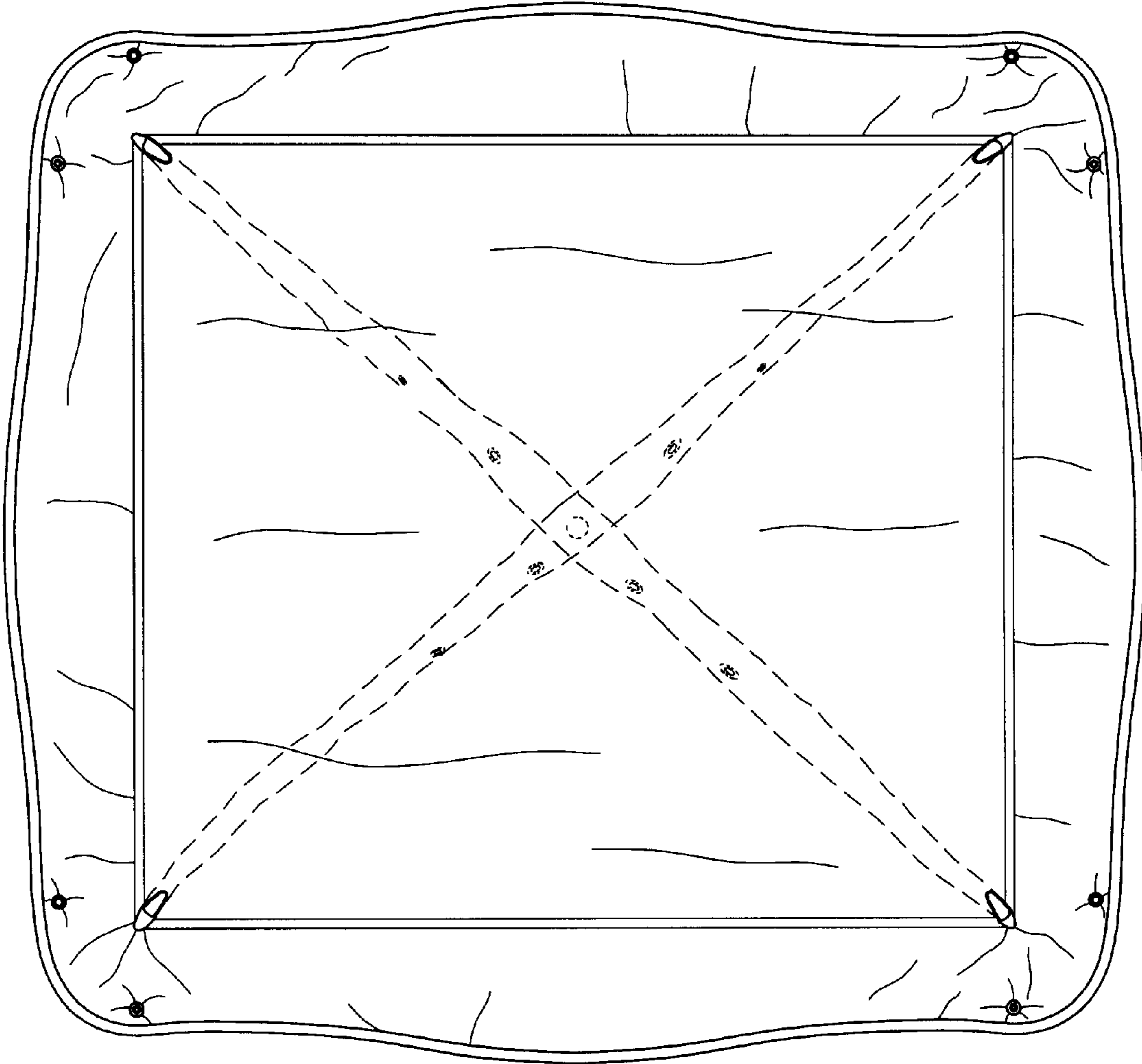

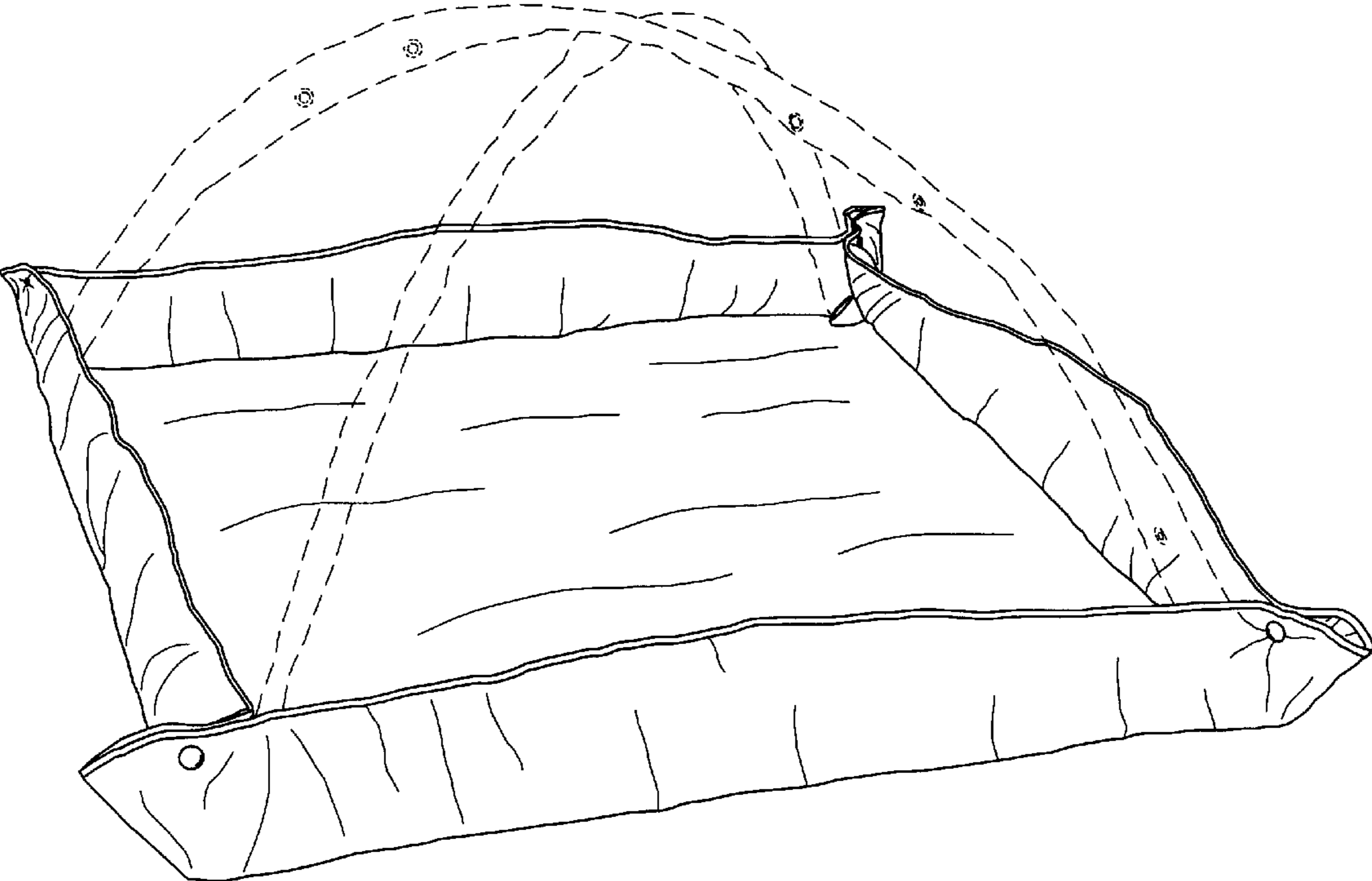

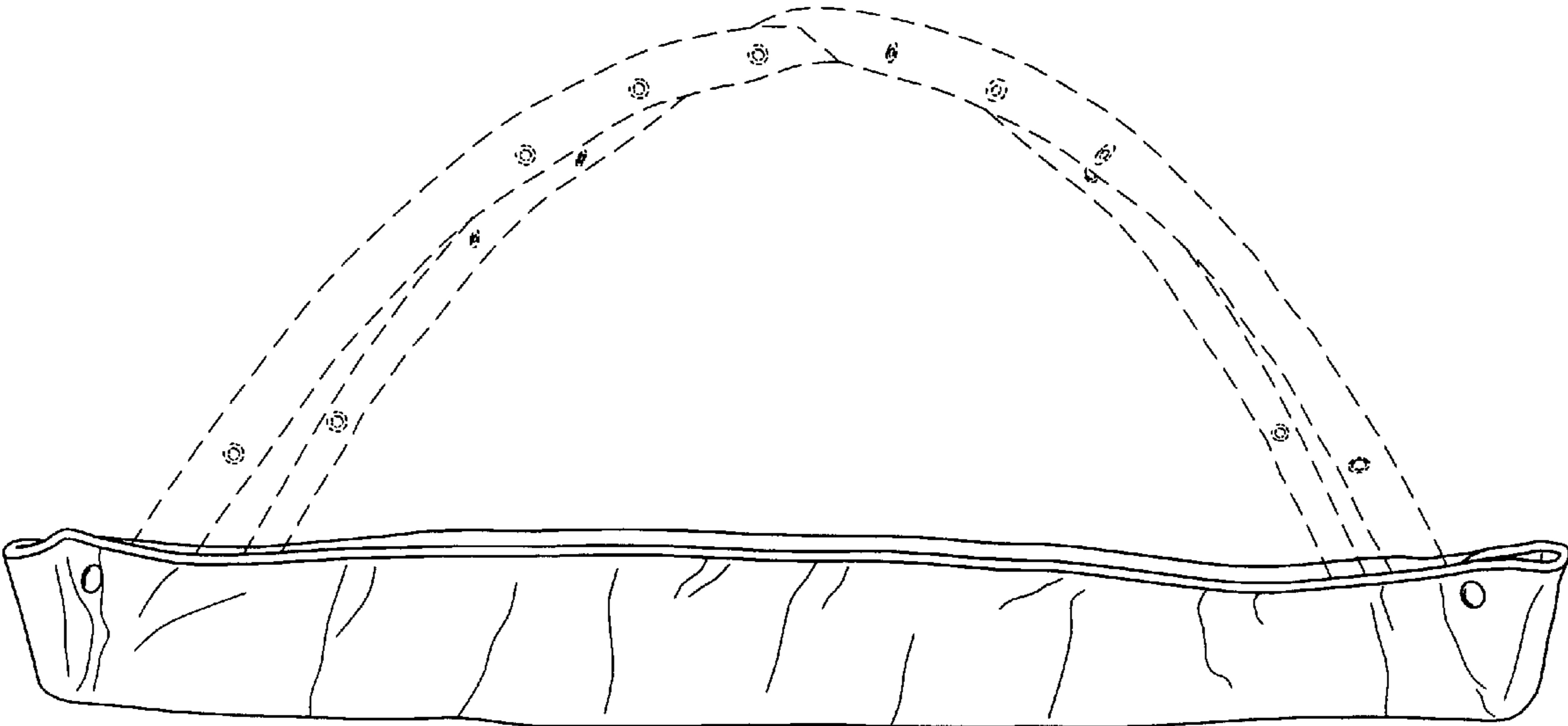

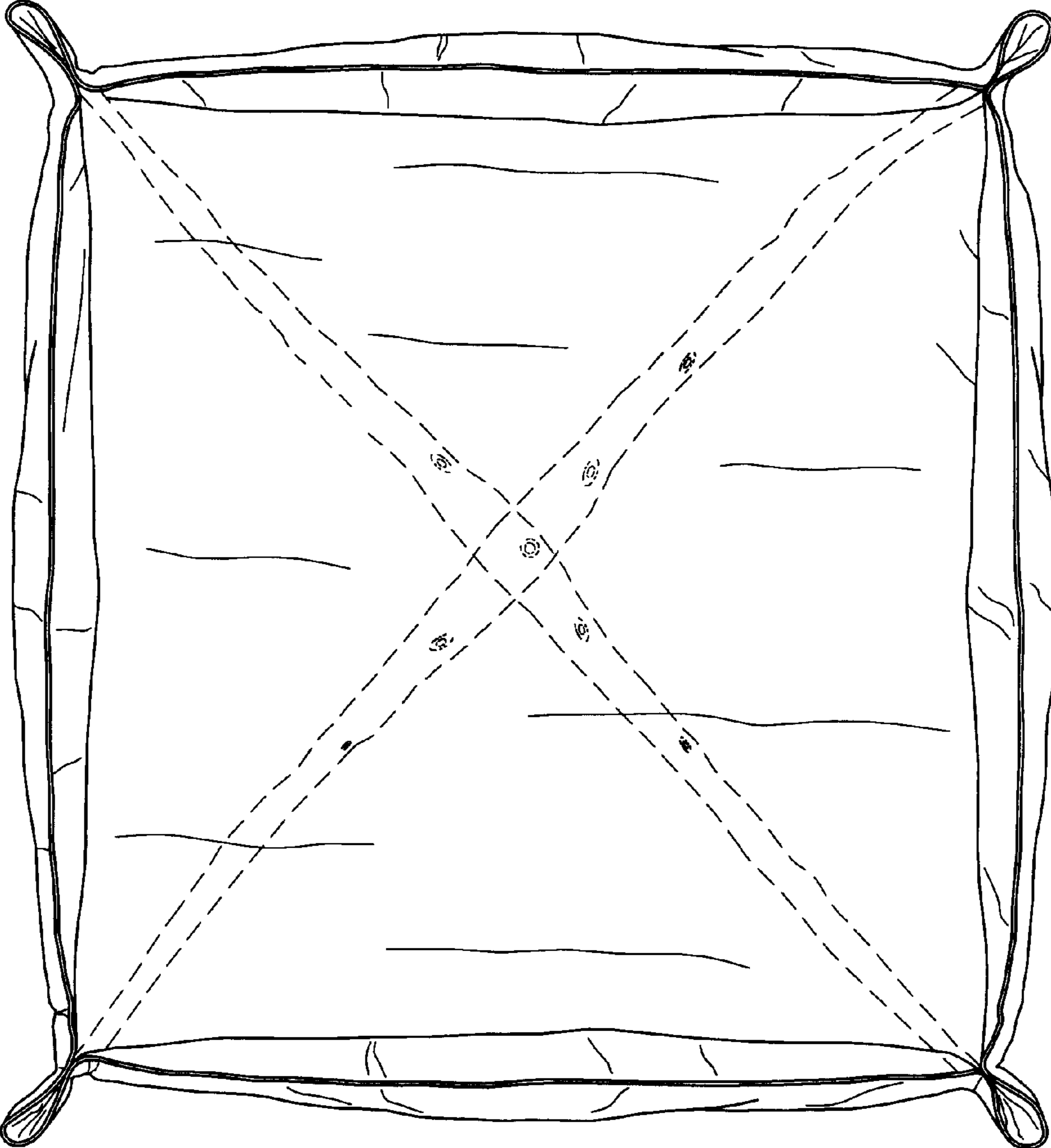
