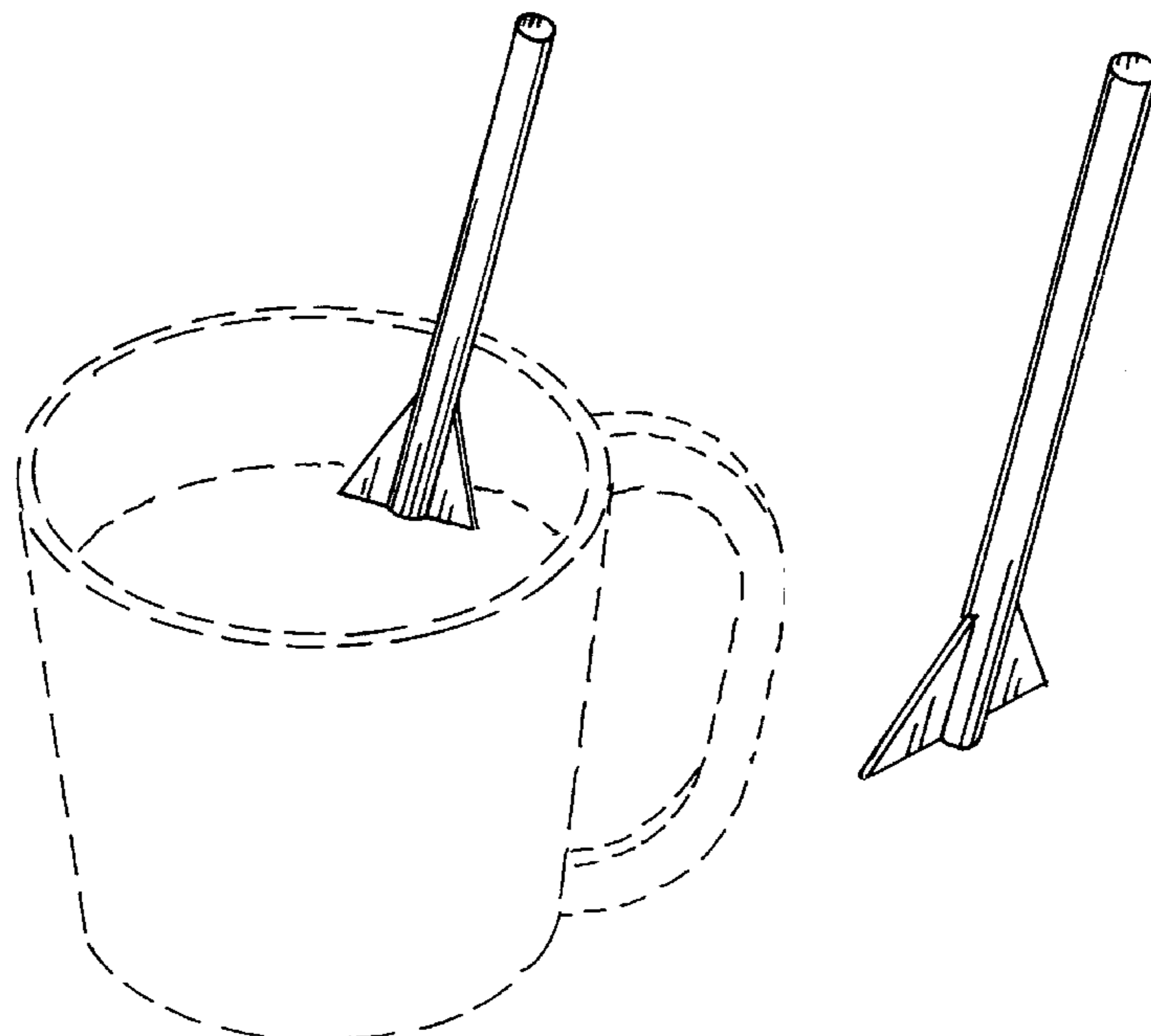
(57) **CLAIM**

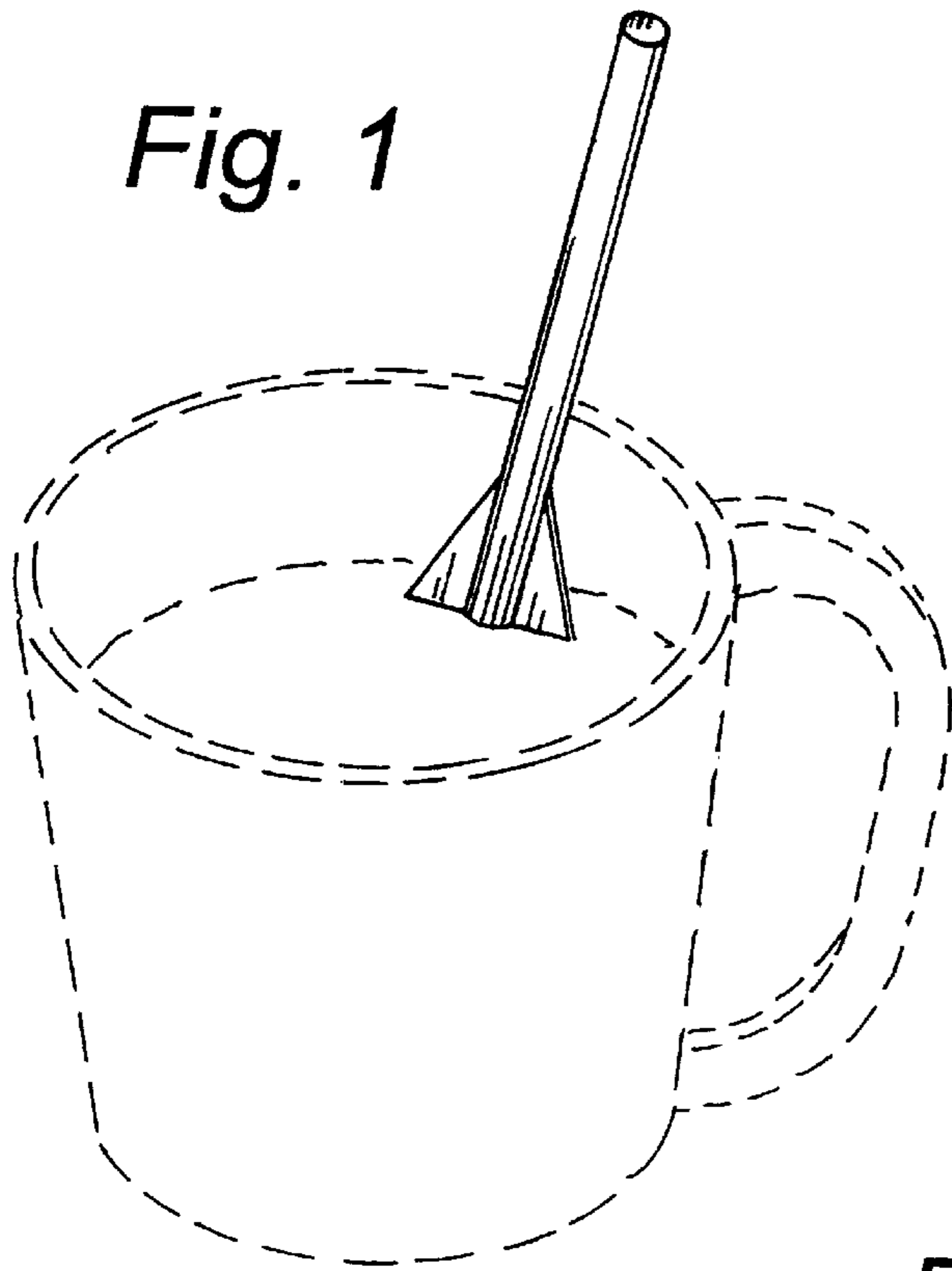
The ornamental design for a drinking straw stirrer, as shown and described.

**DESCRIPTION**

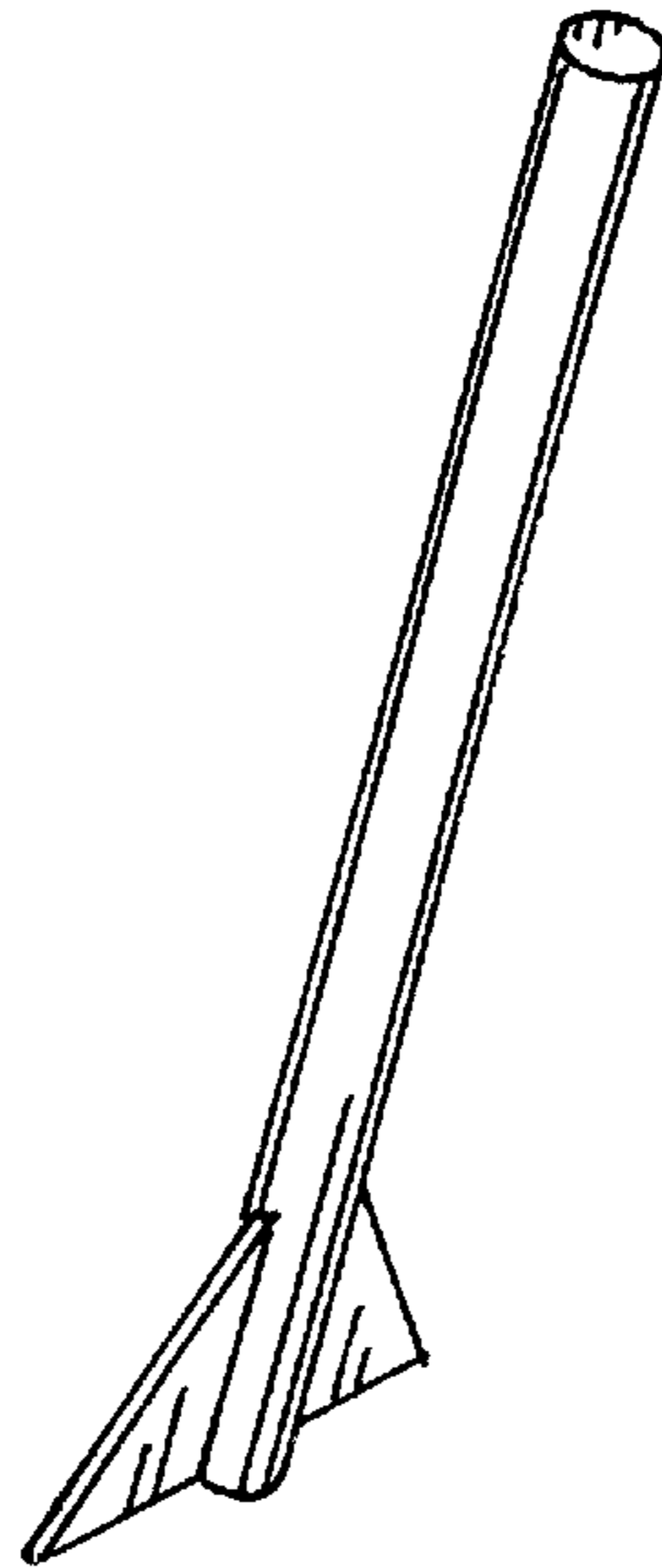
FIG. 1 is a perspective view of the drinking straw stirrer showing my decorative design with a drinking receptacle illustrated in phantom;  
FIG. 2 is an isolated perspective view of the drinking straw stirrer;  
FIG. 3 is a front elevational view thereof with the rear elevational view being the mirror image thereof,  
FIG. 4 is a right side elevational view thereof with the left side elevational view being the mirror image thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken lines are for illustrative purposes only and forms no part of the claimed design.

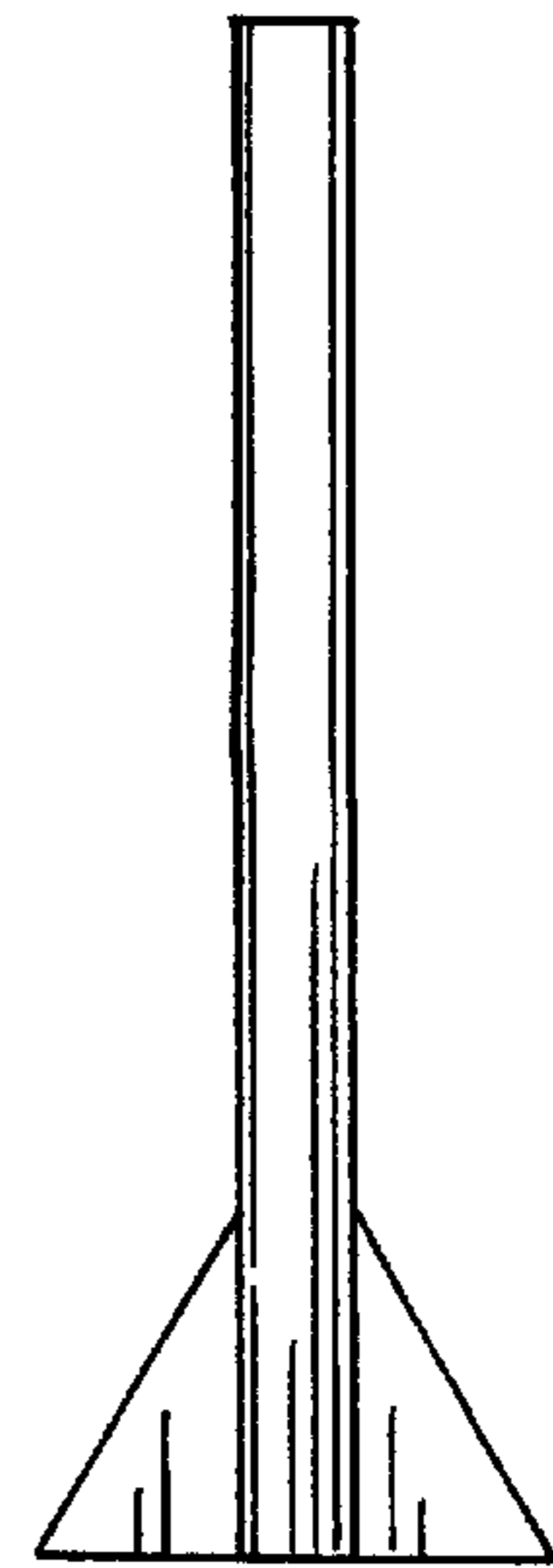




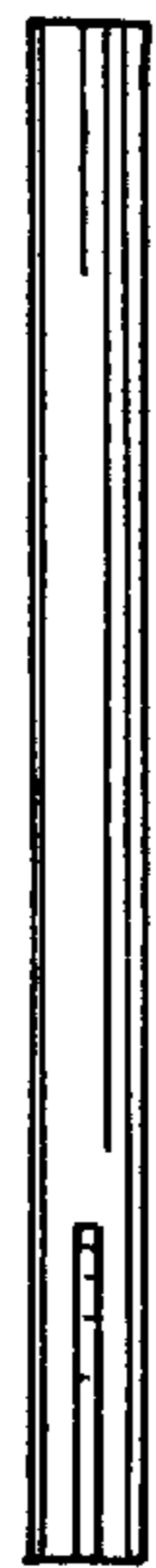
