and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for hand tool
showing our new design;

FIG. 2 is a top plan view of the handle for hand tool of FIG.
1;

FIG. 3 is a bottom plan view of the handle for hand tool of
FIGS. 1 and 2;

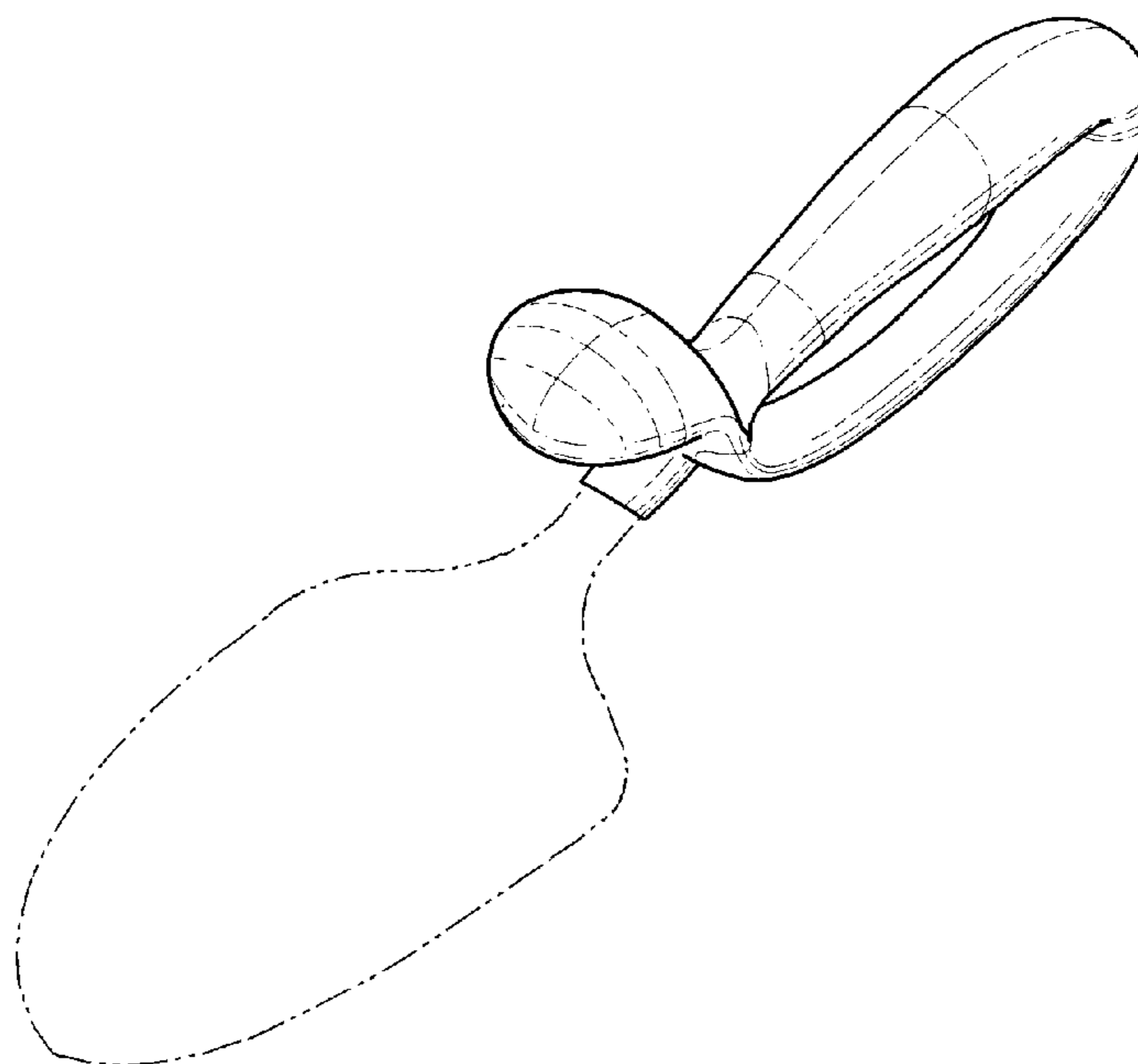
FIG. 4 is a right-side elevational view of the handle for hand
tool of FIG. 1, the left side elevational view being a mirror
image thereof;

FIG. 5 is a front elevational view of the handle for hand tool

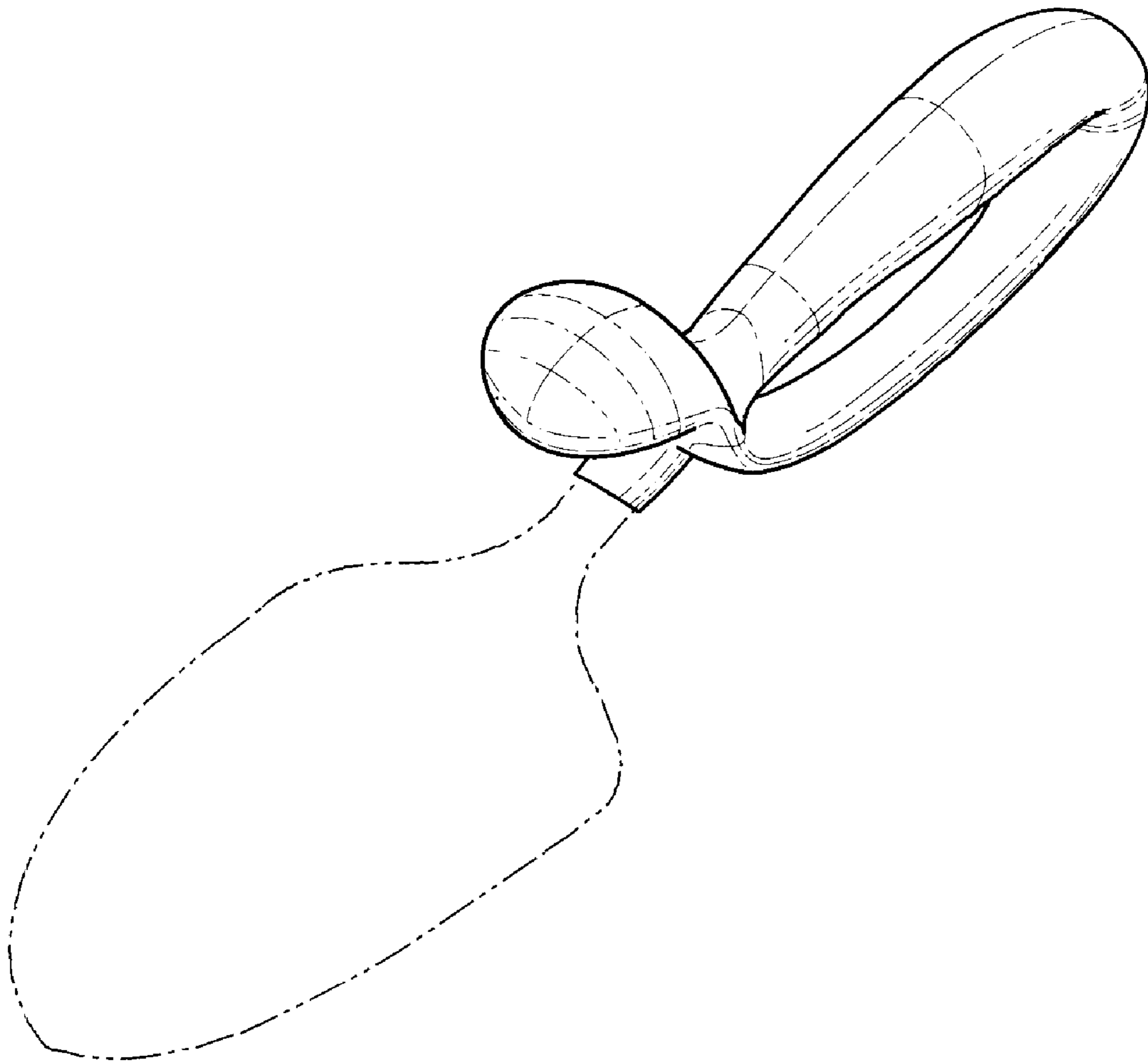

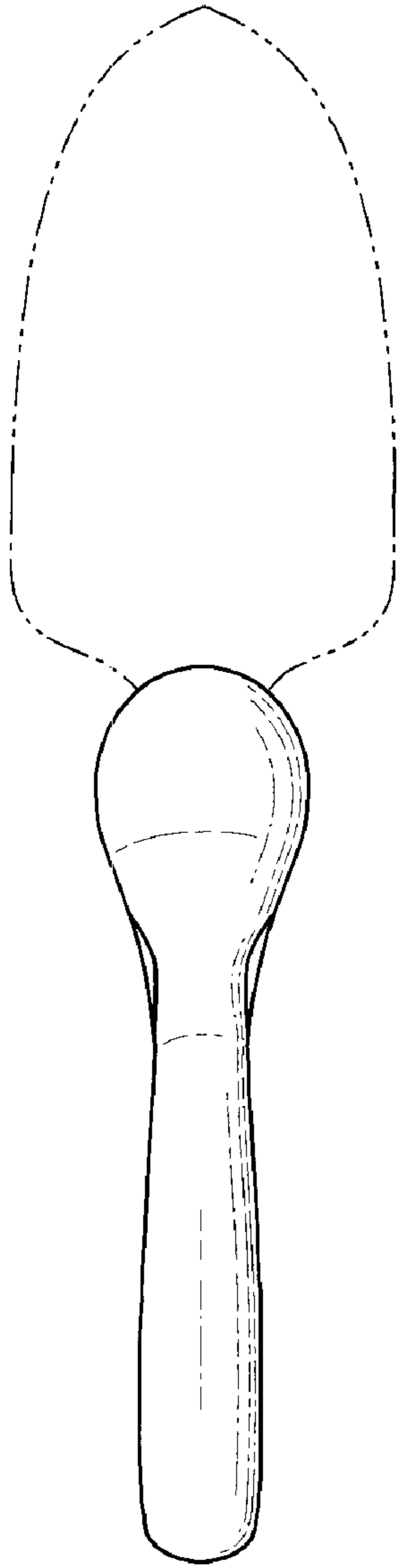

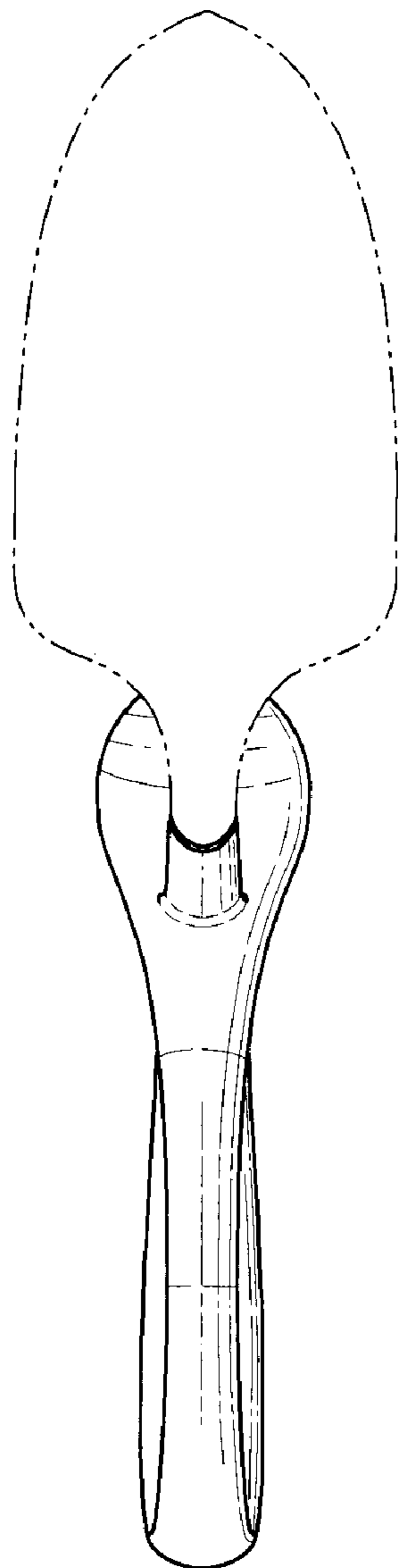

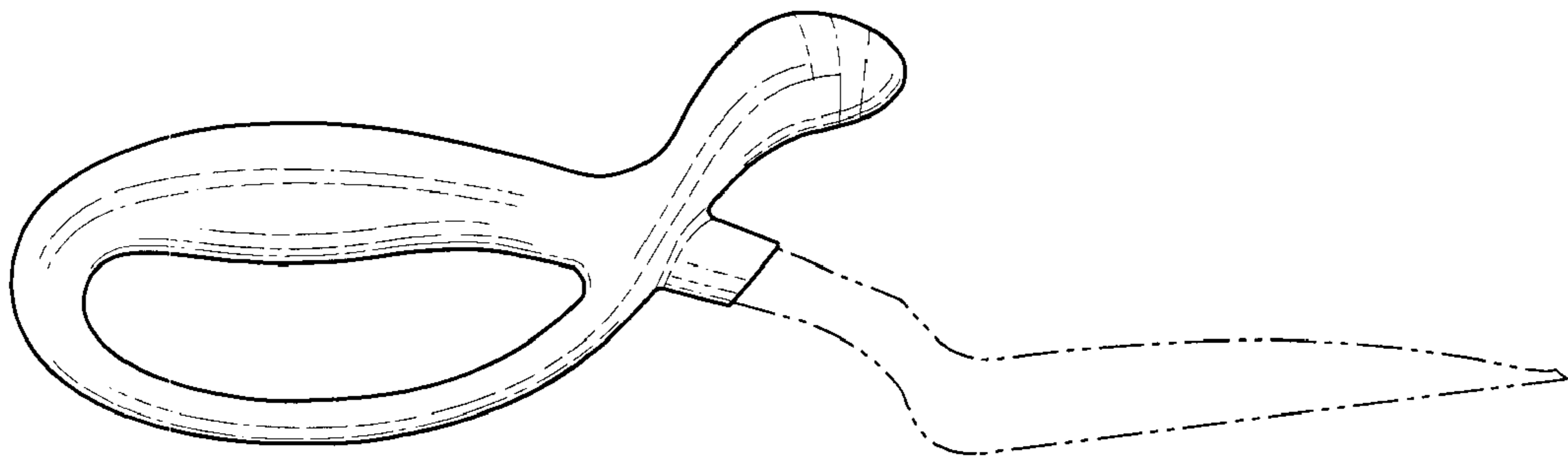

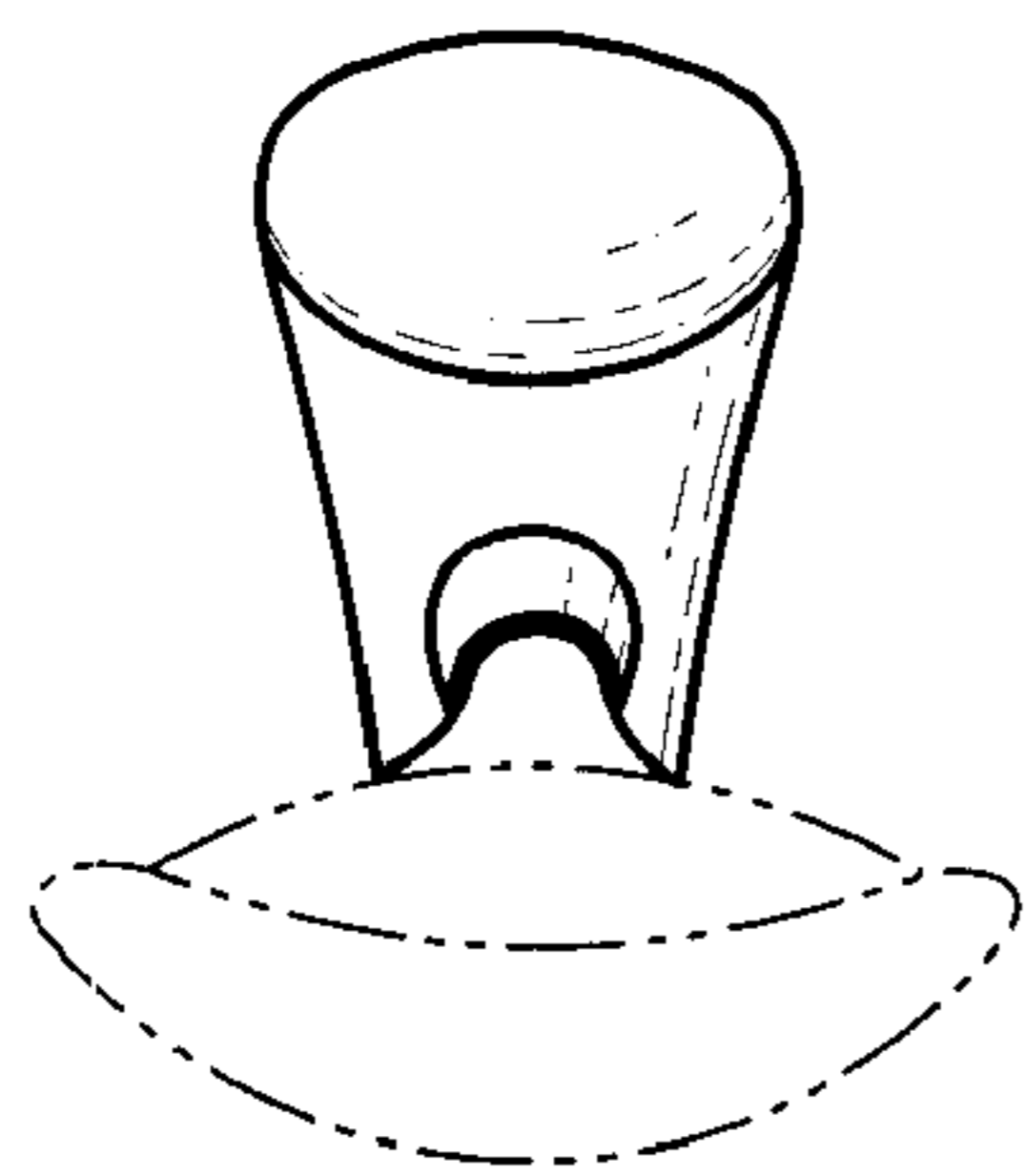

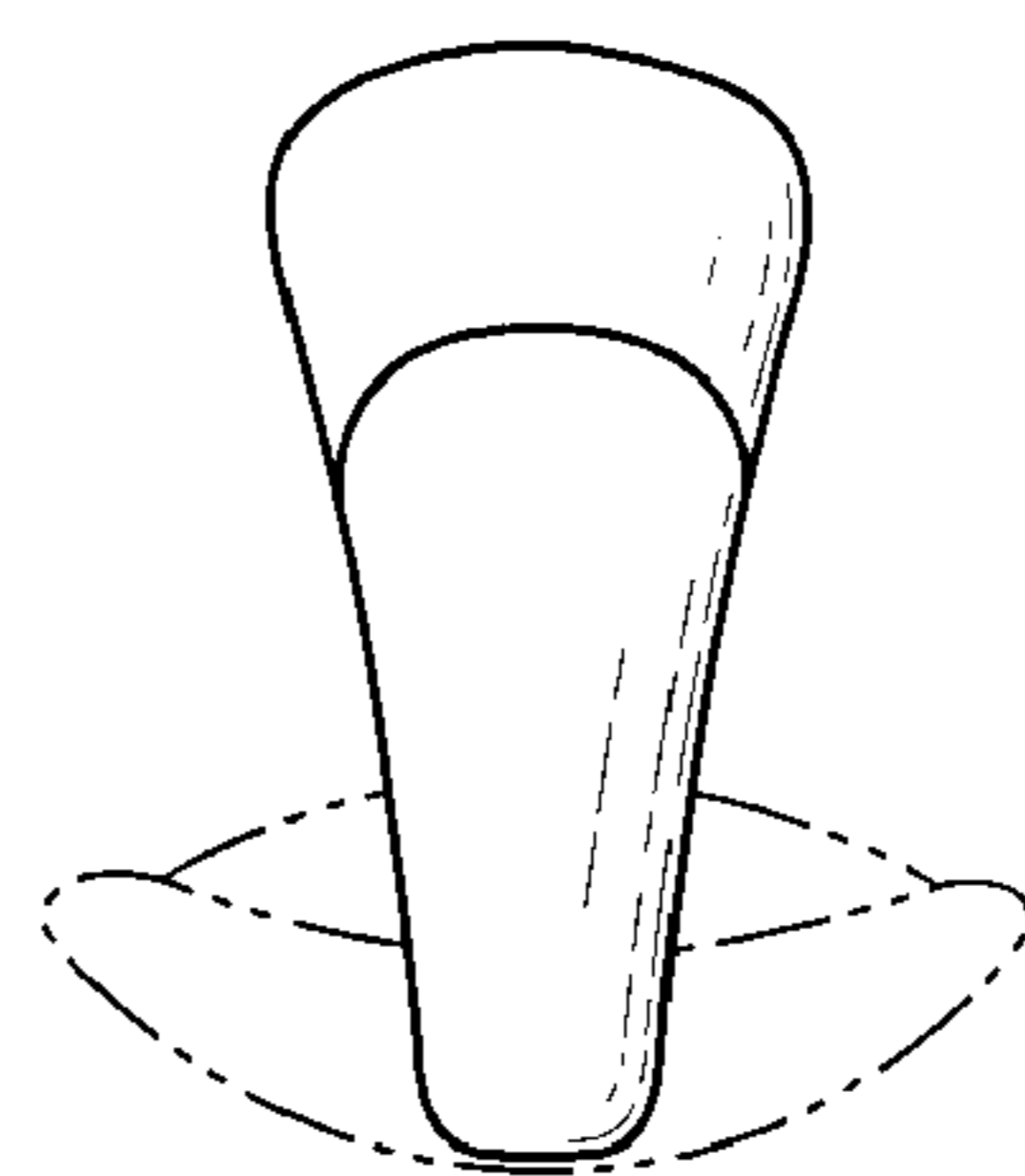
