The ornamental design for a bottle for a battery powered vaporizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle for a battery powered vaporizer showing our new design;

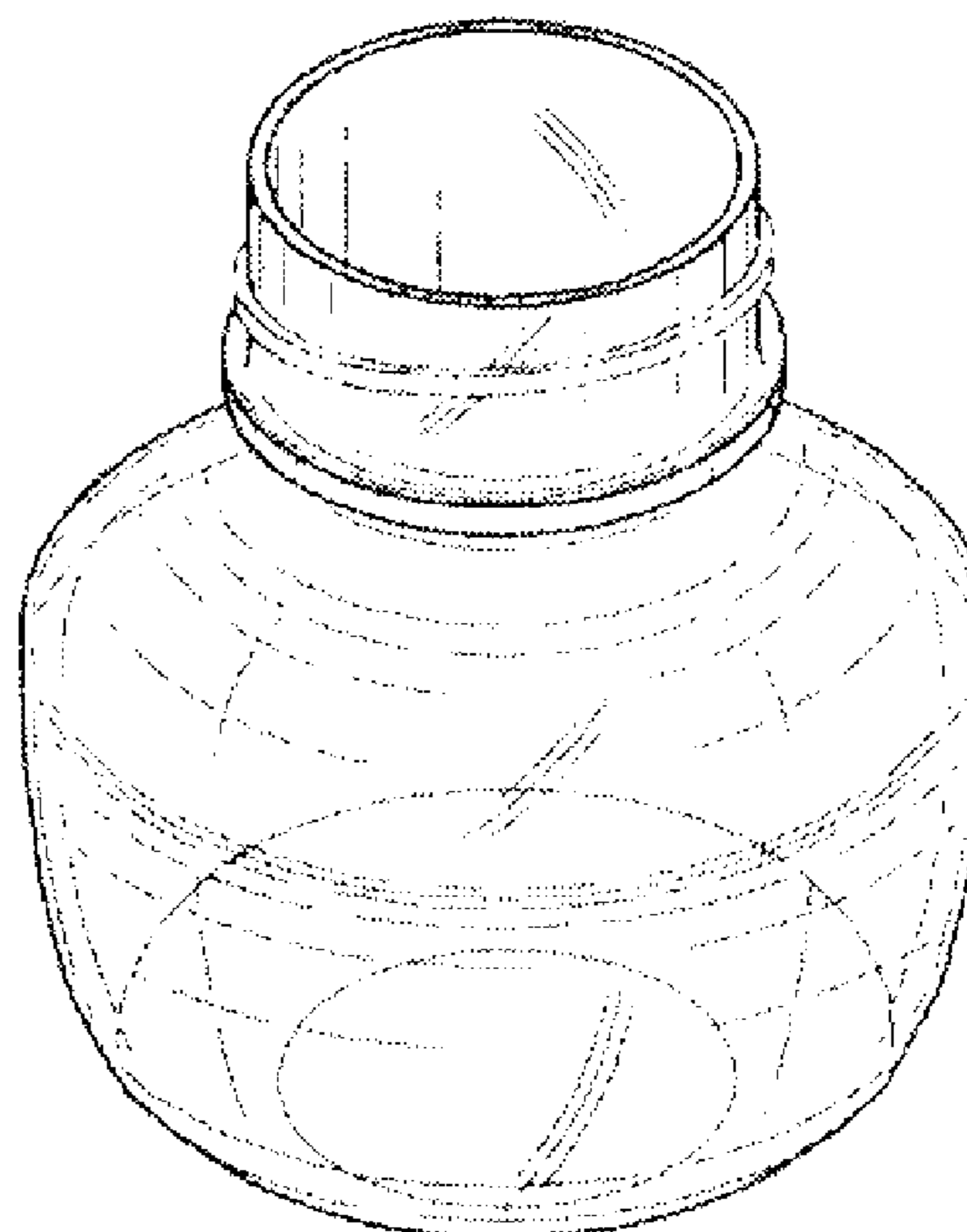
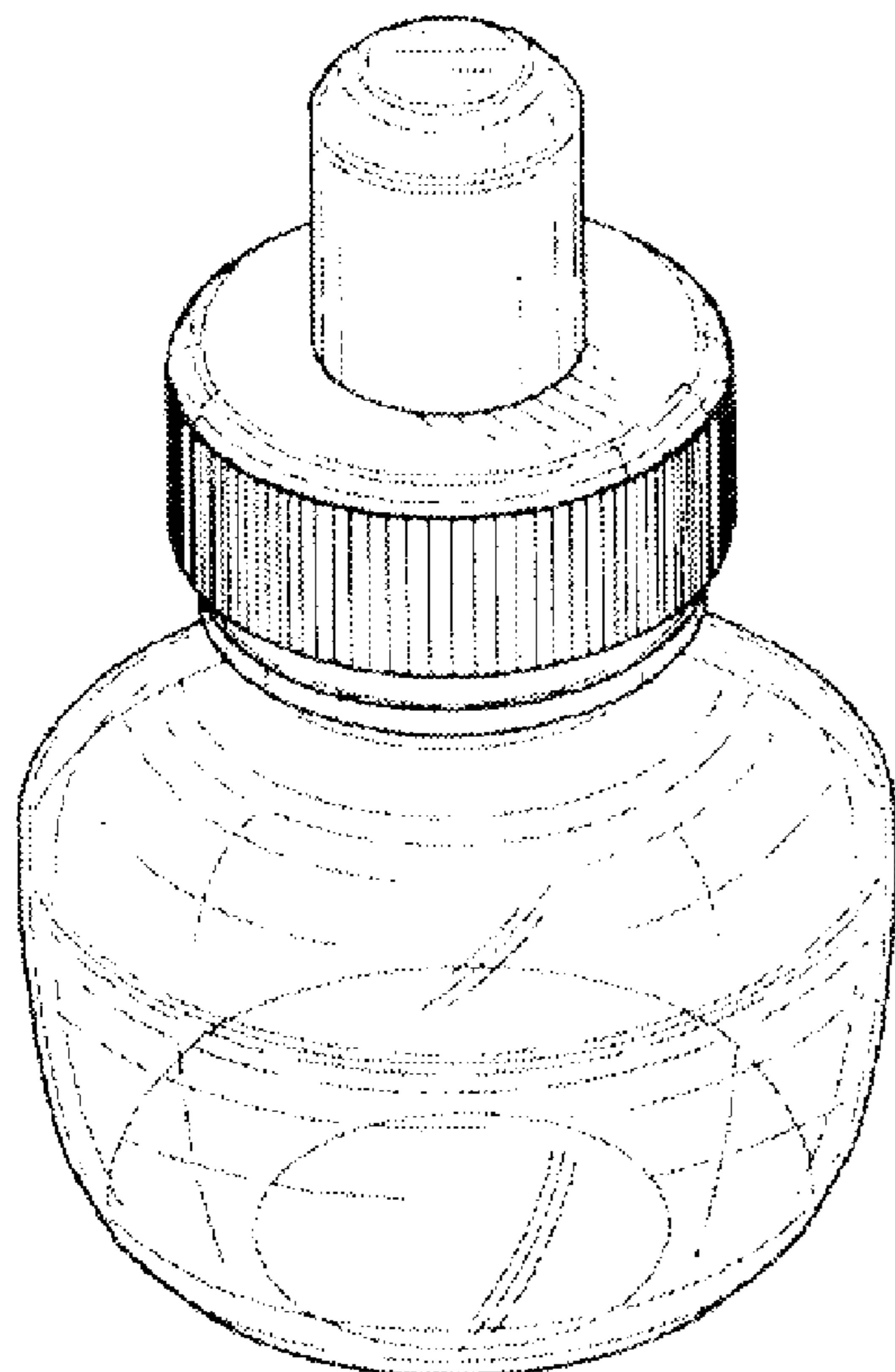

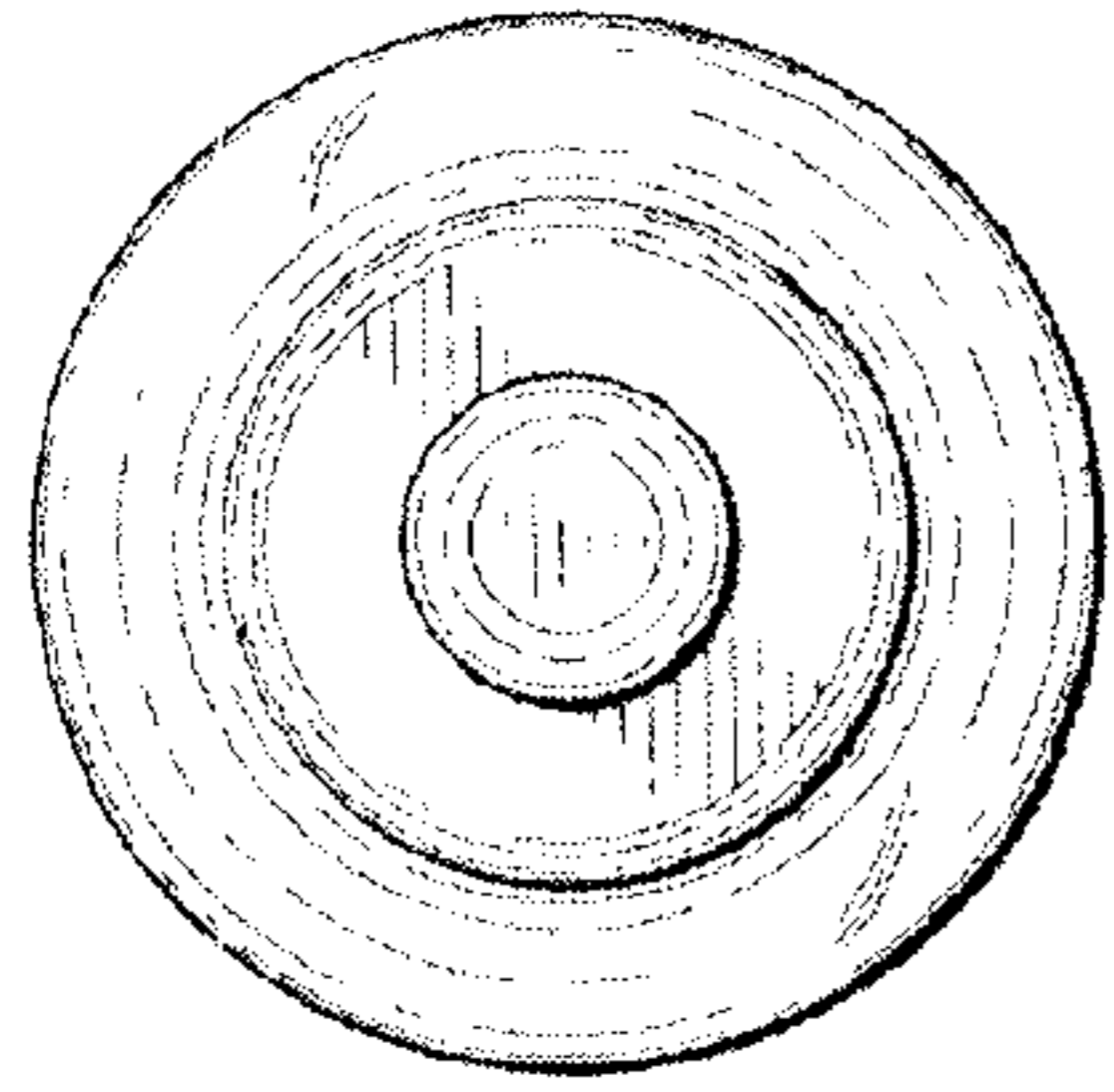

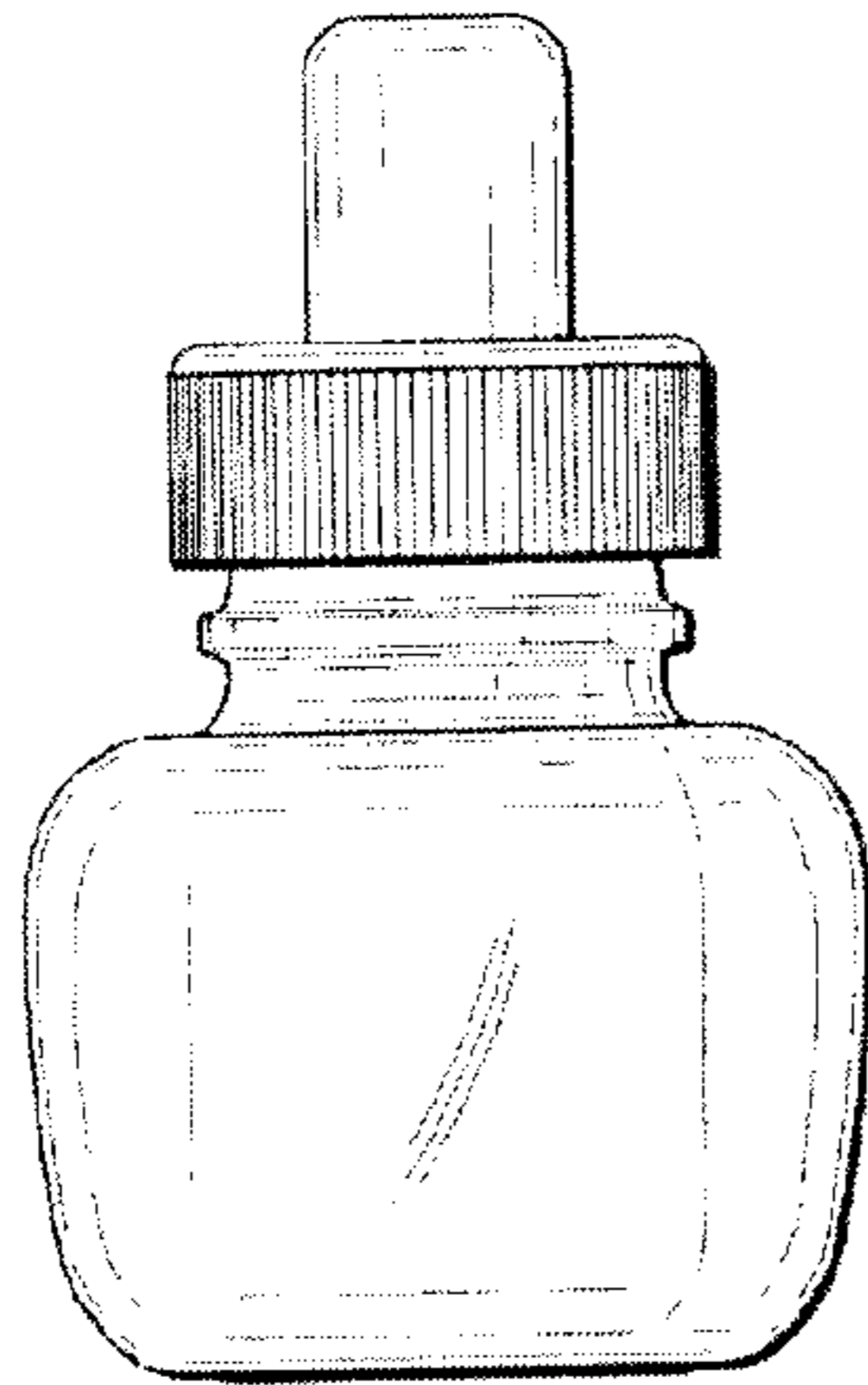

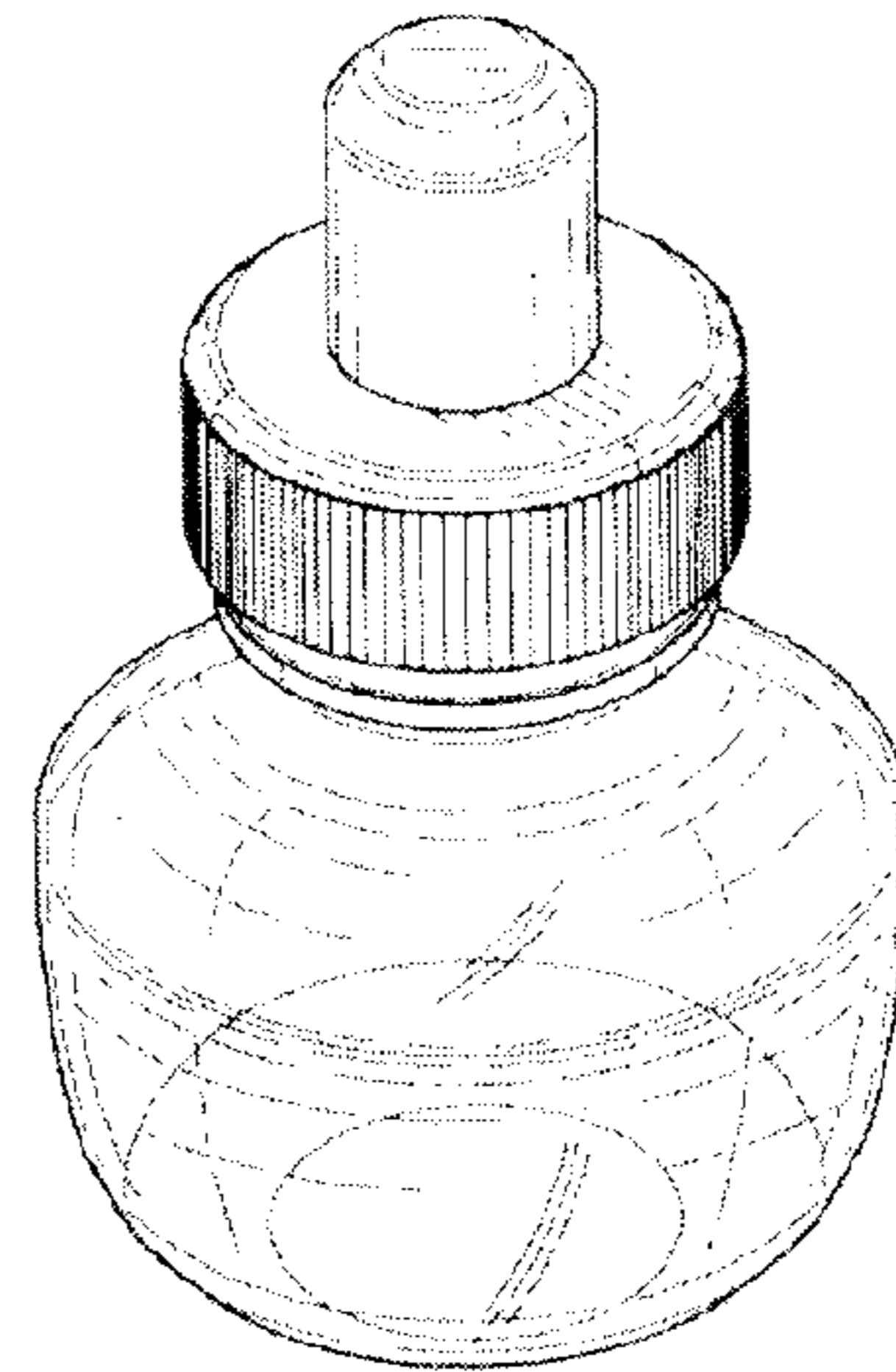

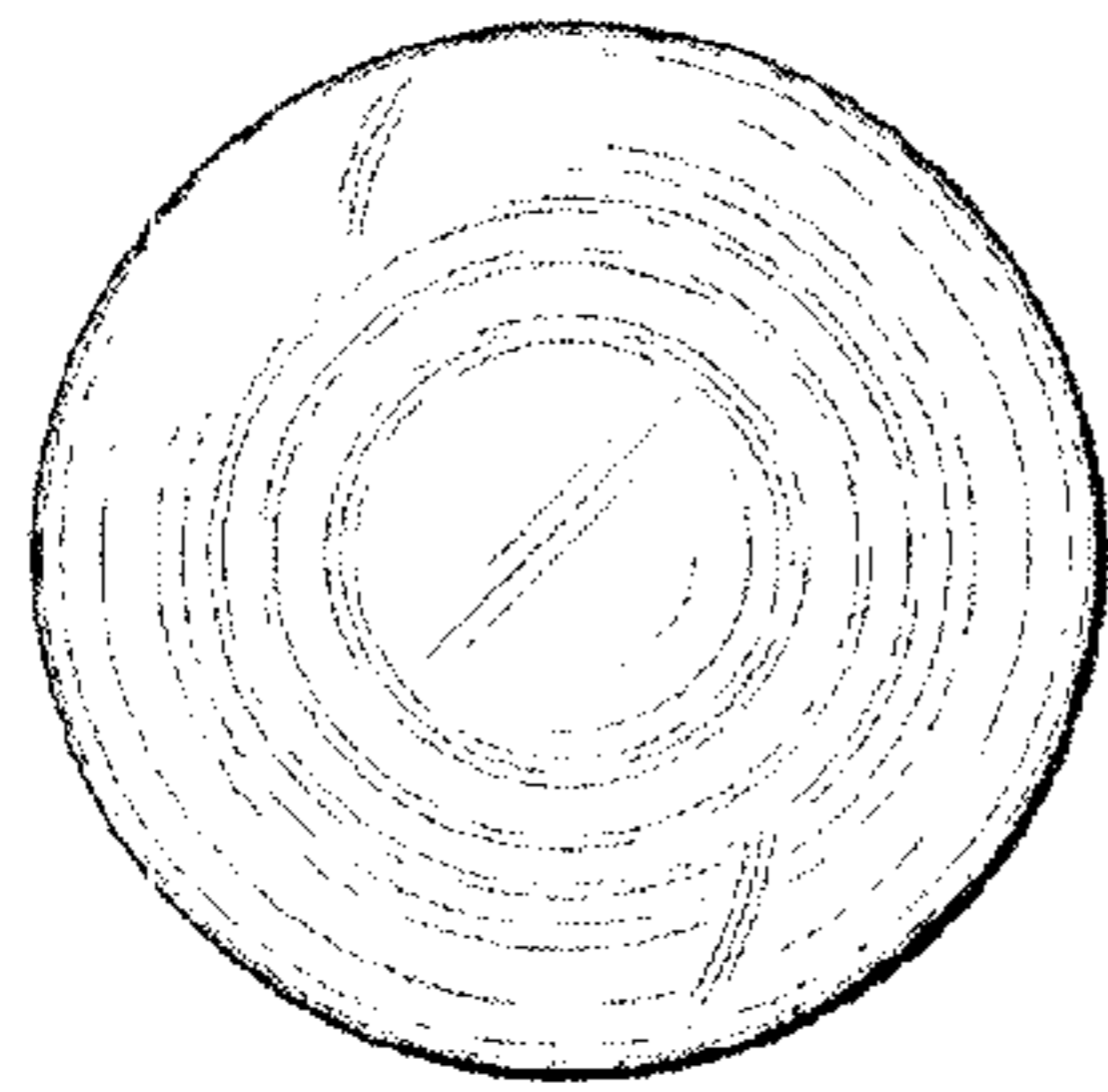

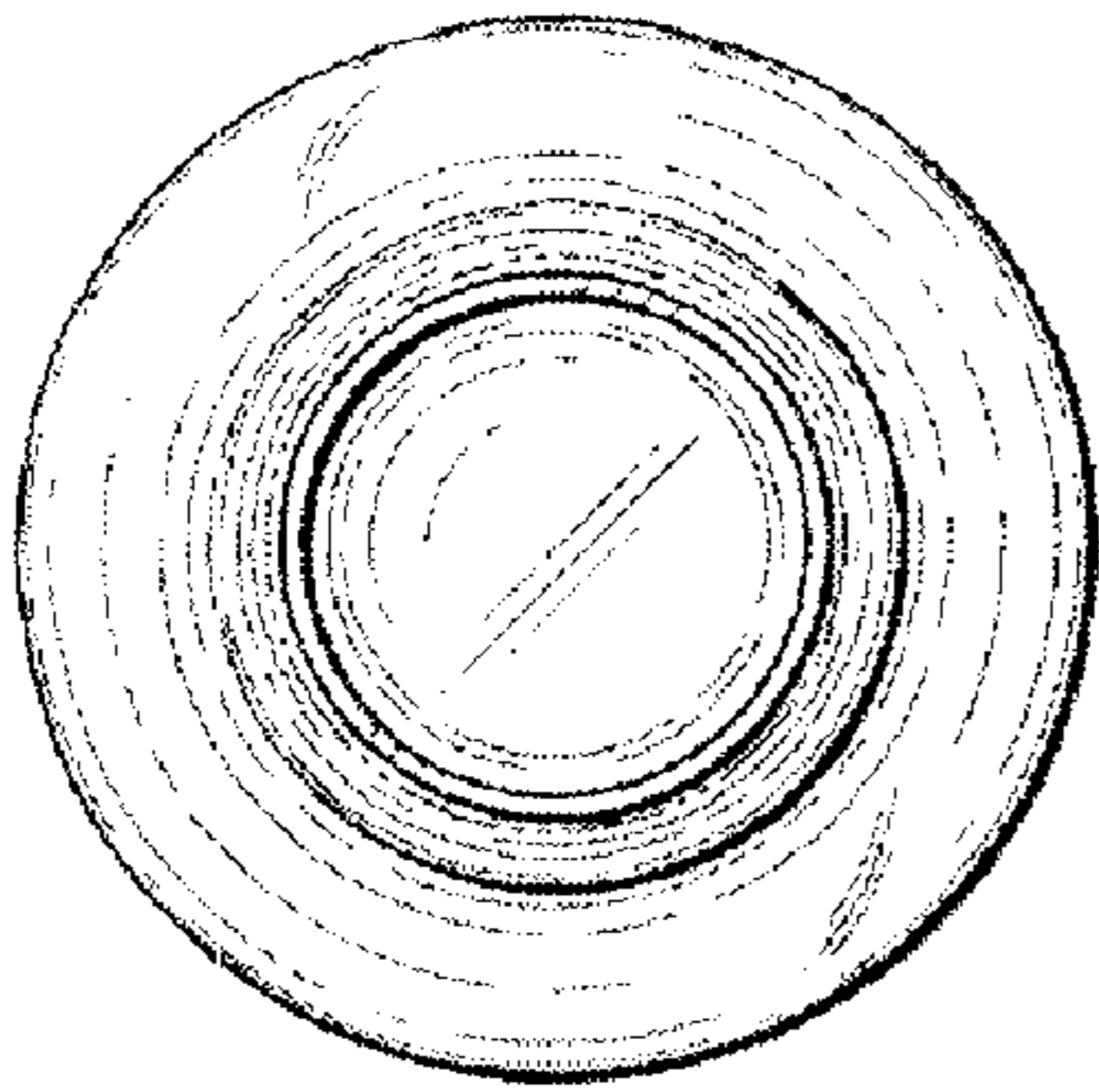

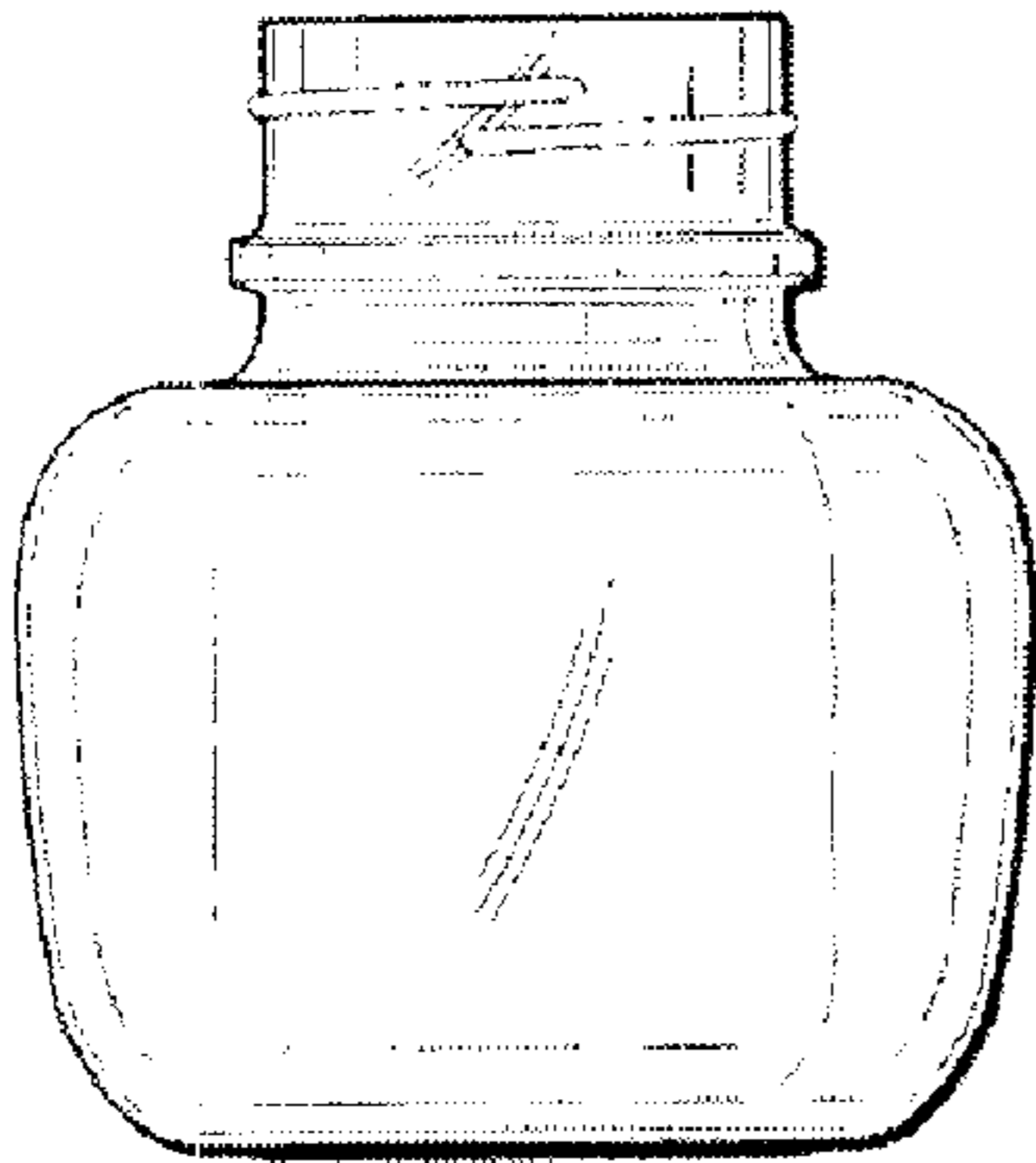
