**DESCRIPTION**

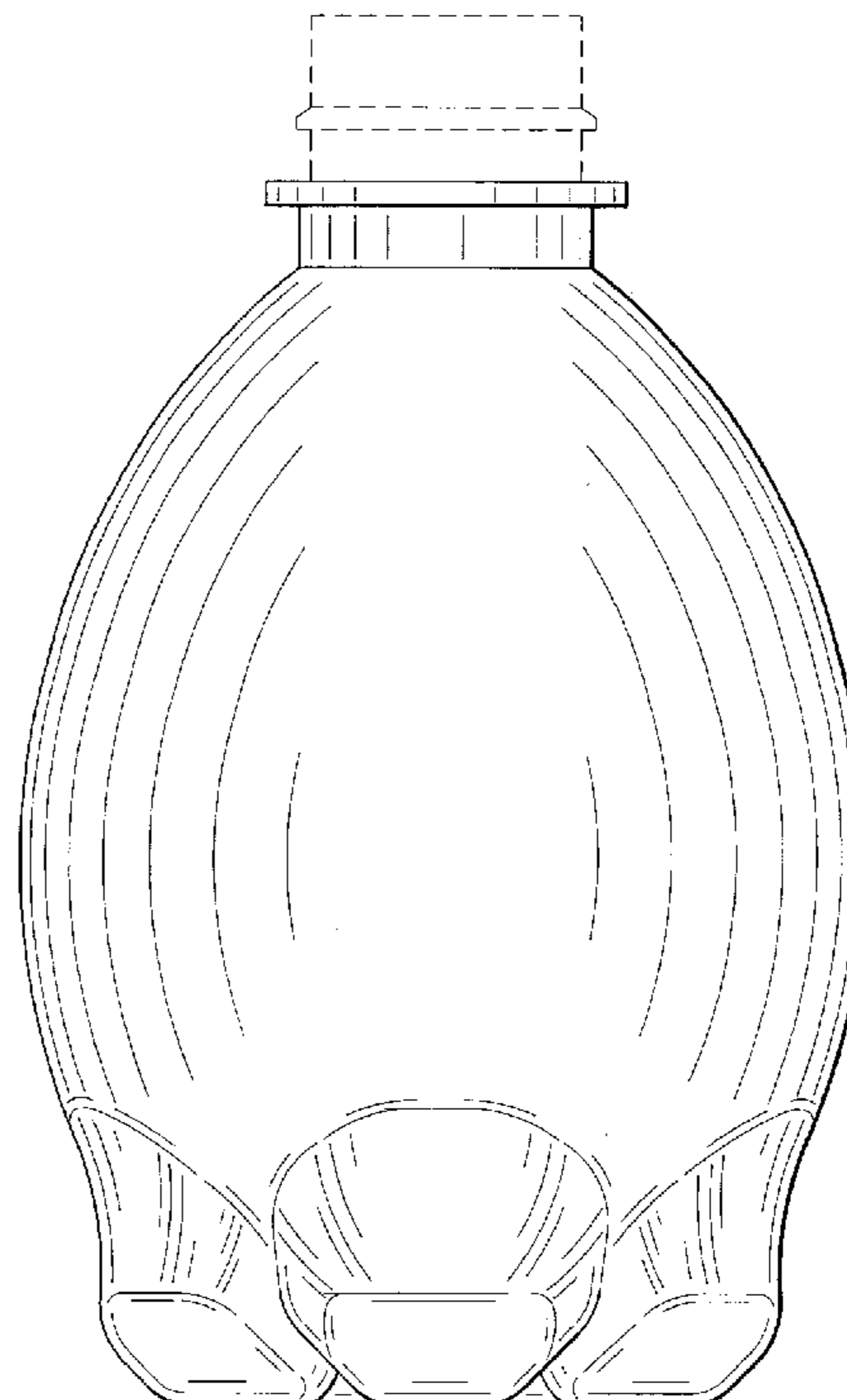

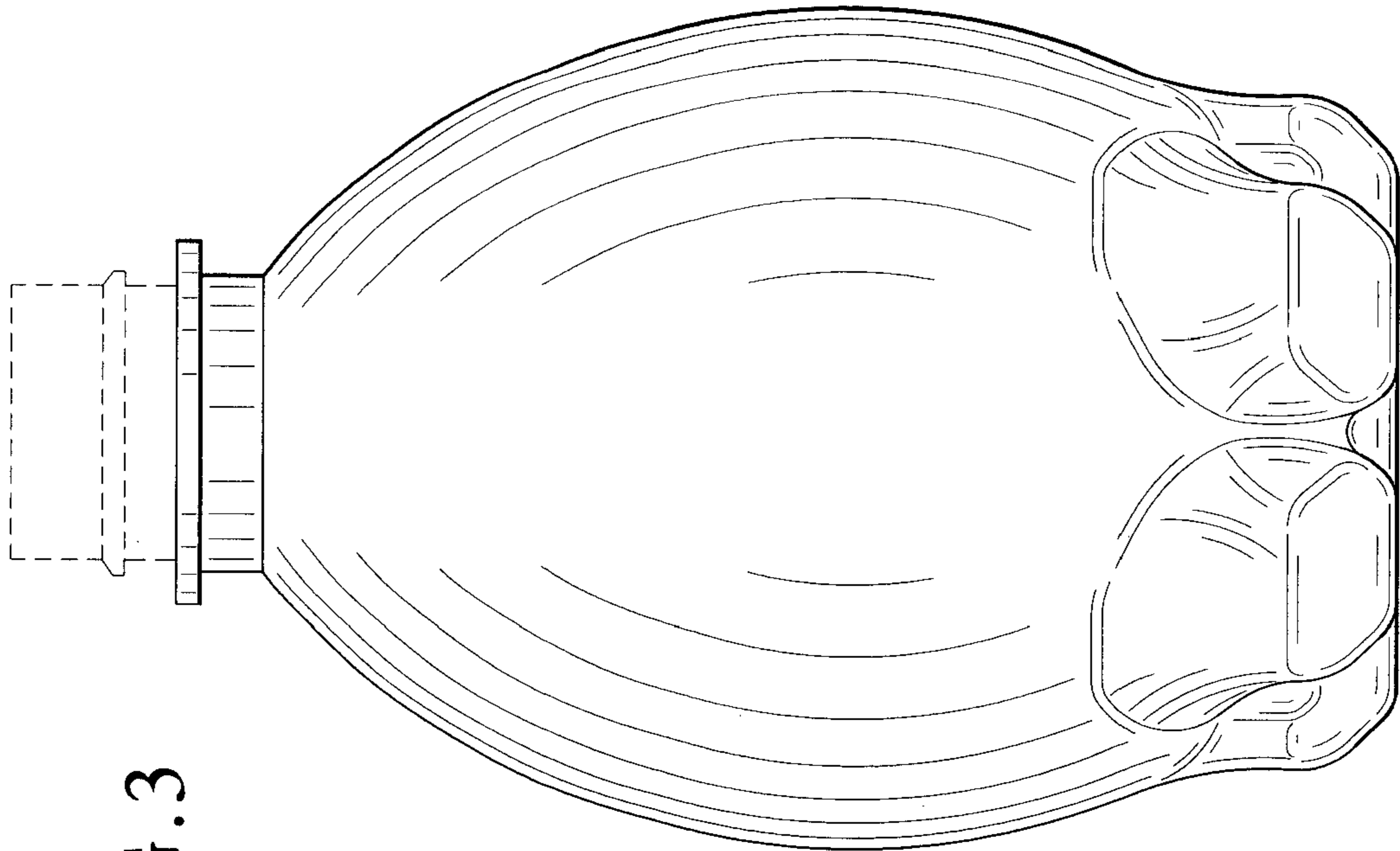

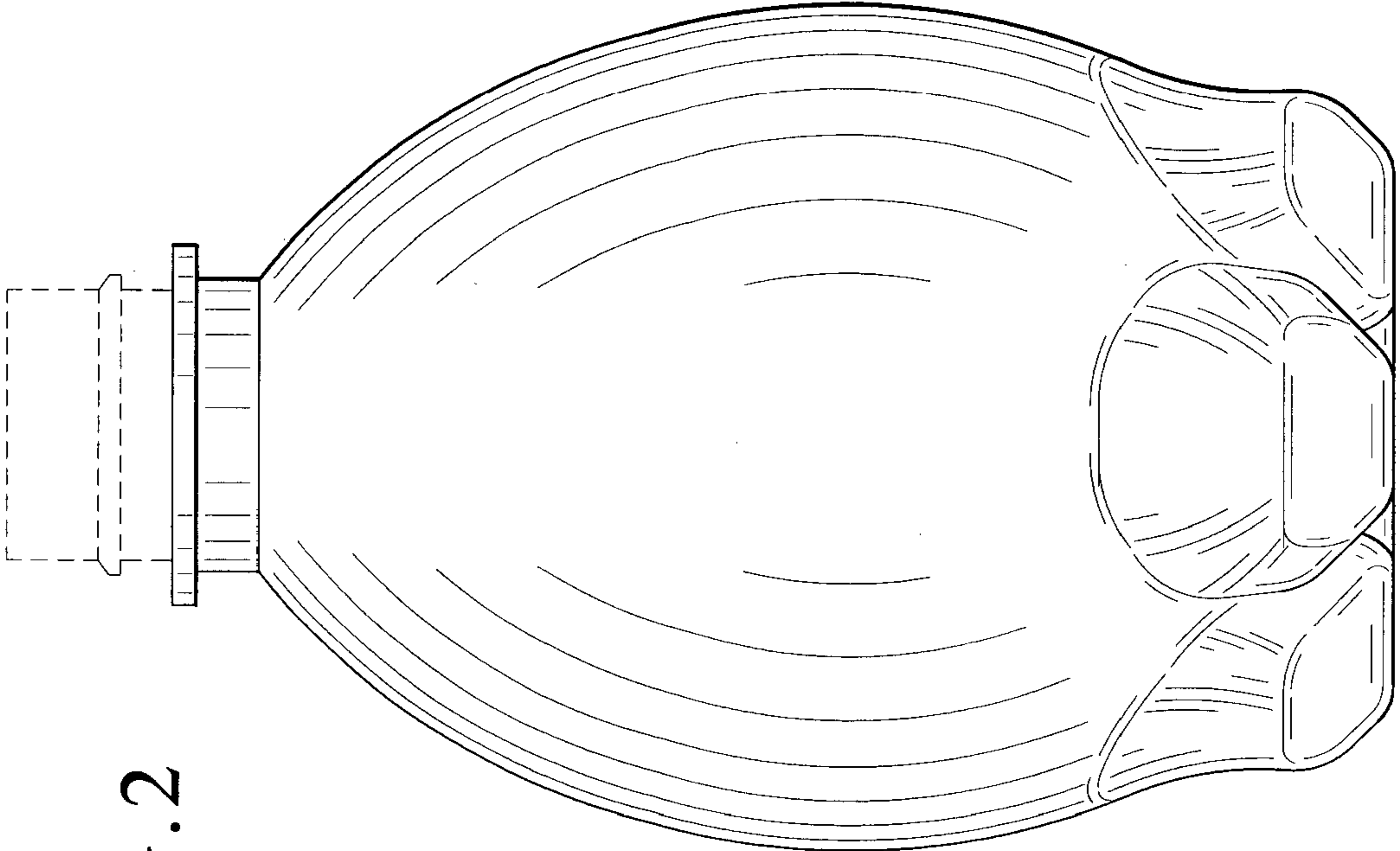

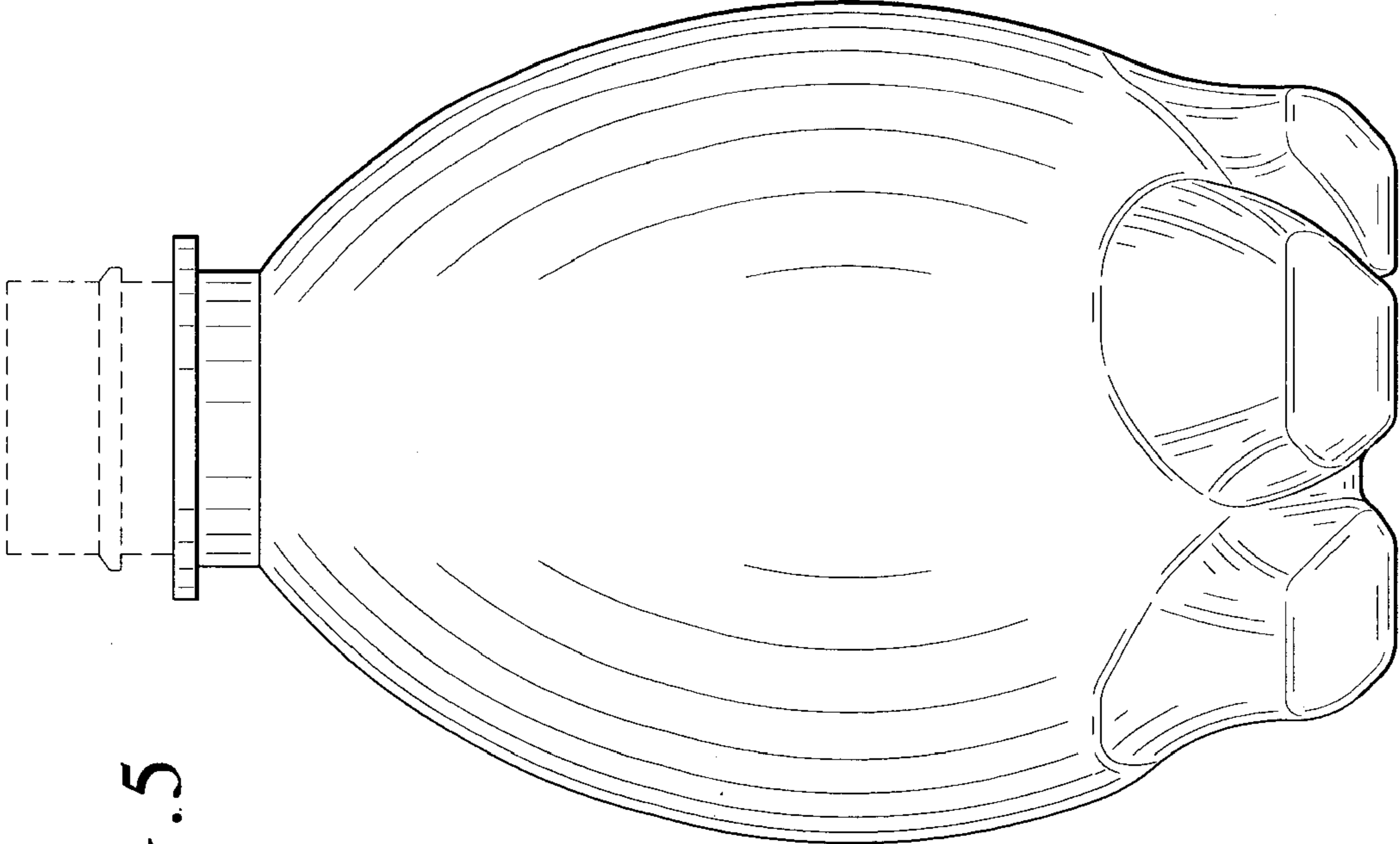

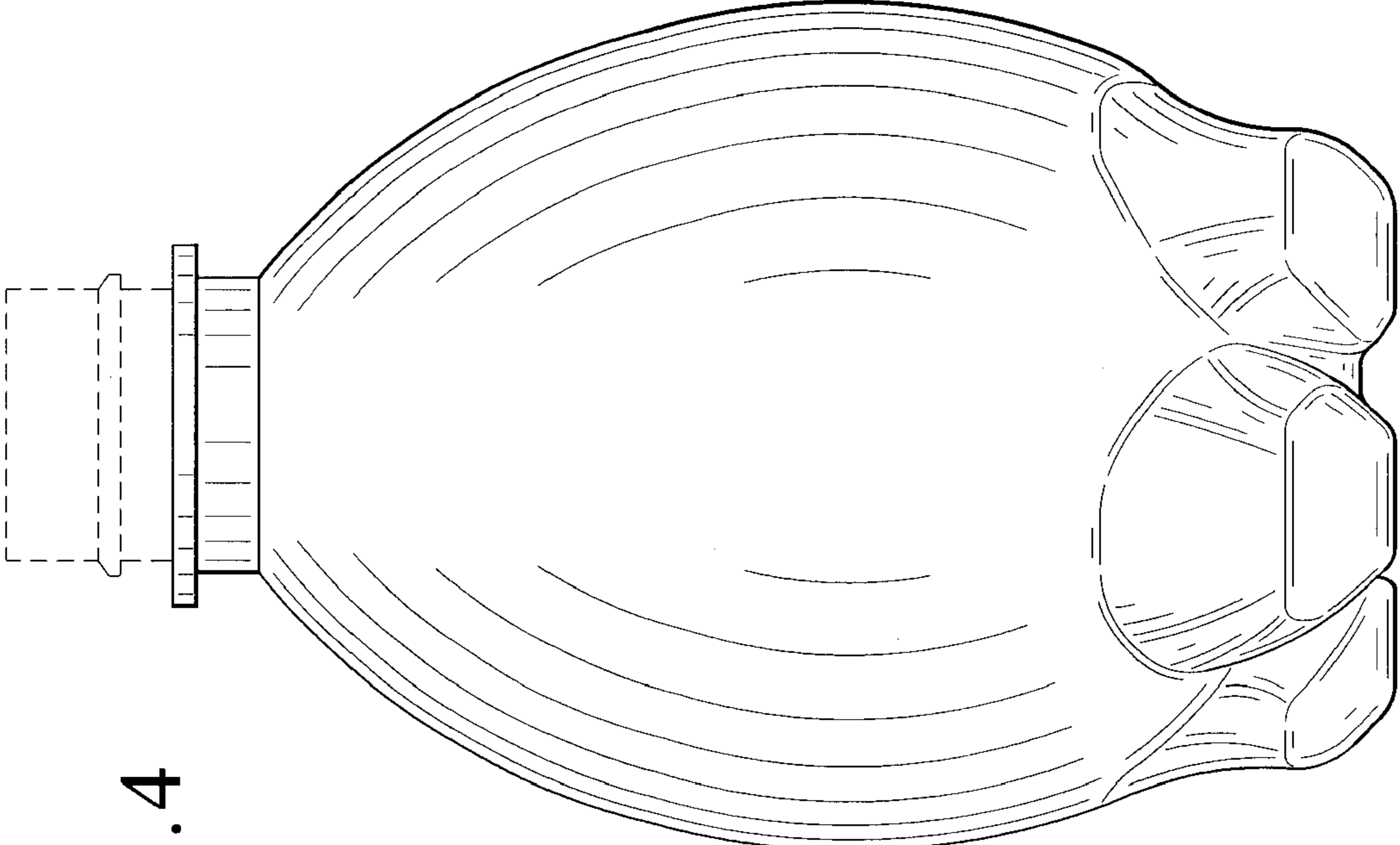

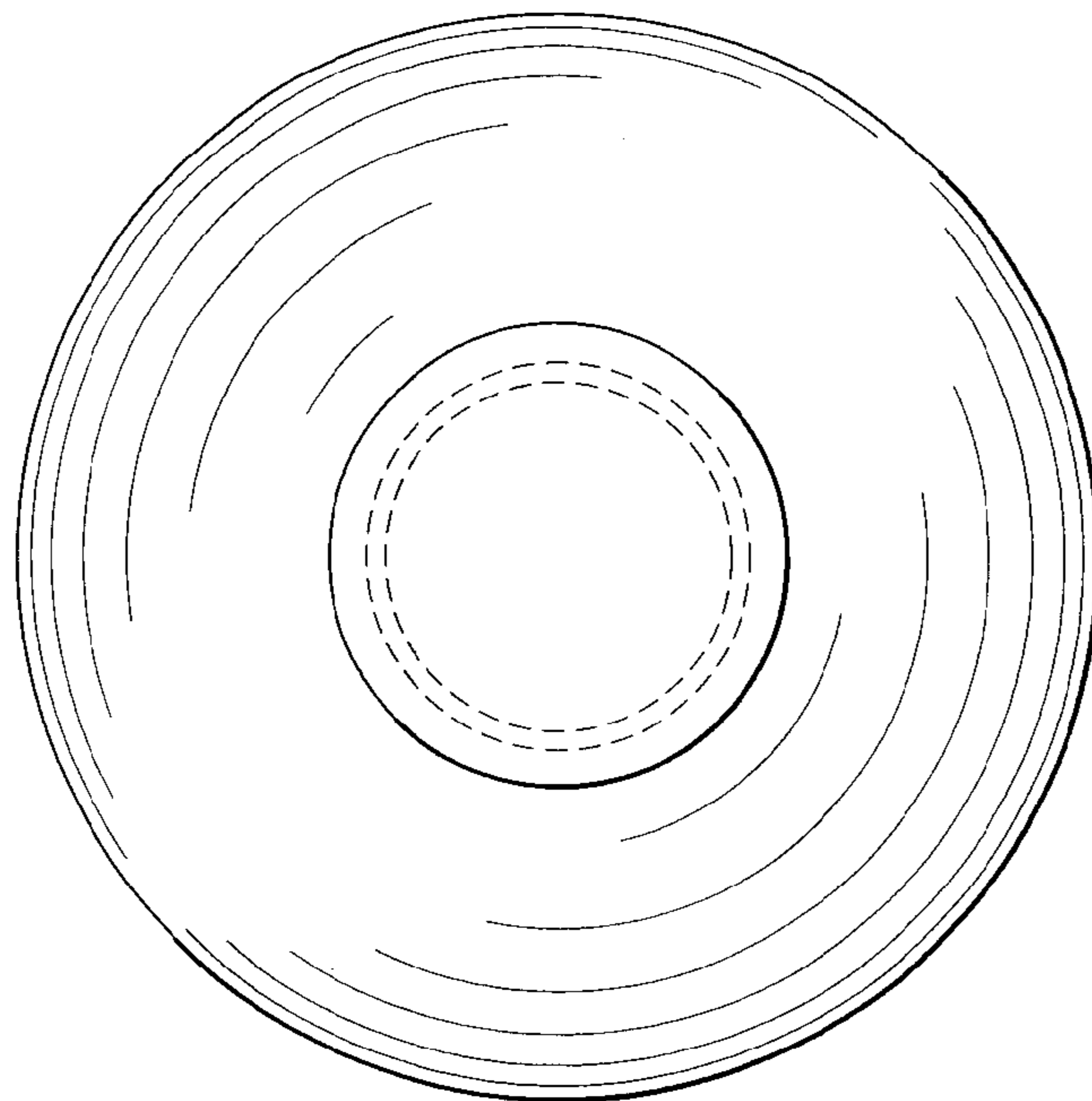
