(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front-top-right side of the bottle showing a first embodiment of our new design; FIG. 2 is a front view of the design shown in FIG. 1; FIG. 3 is a rear view of the design shown in FIG. 1; FIG. 4 is a left side view of the design shown in FIG. 1; FIG. 5 is a right side view of the design shown in FIG. 1; FIG. 6 is a top view of the design shown in FIG. 1; FIG. 7 is a bottom view of the design shown in FIG. 1; FIG. 8 is a perspective view from the front-top-right side of the bottle showing a second embodiment of our new design; FIG. 9 is a front view of the design shown in FIG. 8; FIG. 10 is a rear view of the design shown in FIG. 8; FIG. 11 is a left side view of the design shown in FIG. 8; FIG. 12 is a right side view of the design shown in FIG. 8; FIG. 13 is a top view of the design shown in FIG. 8; and, FIG. 14 is a bottom view of the design shown in FIG. 8.

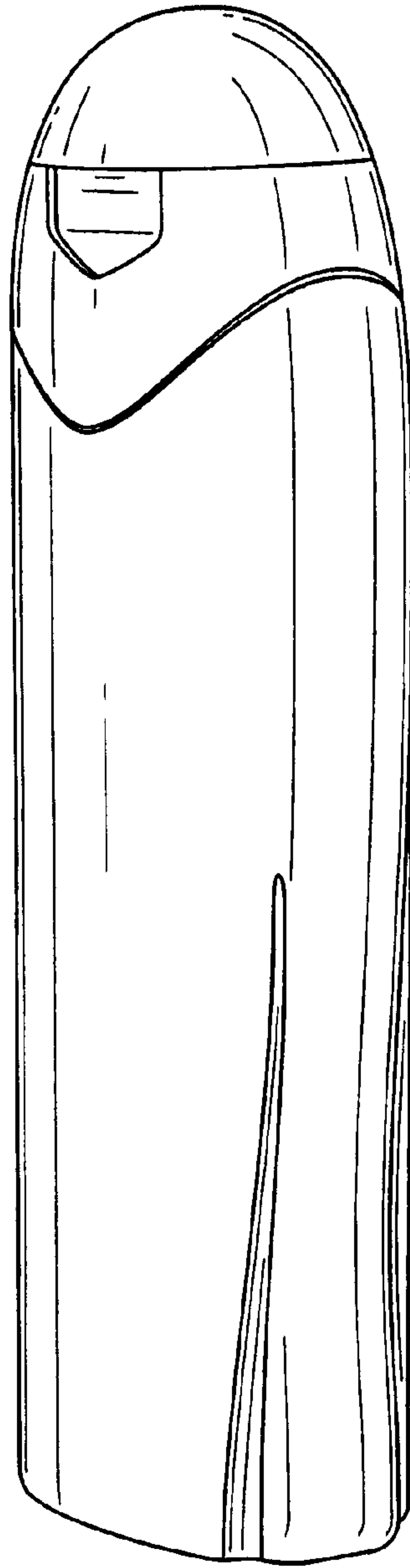

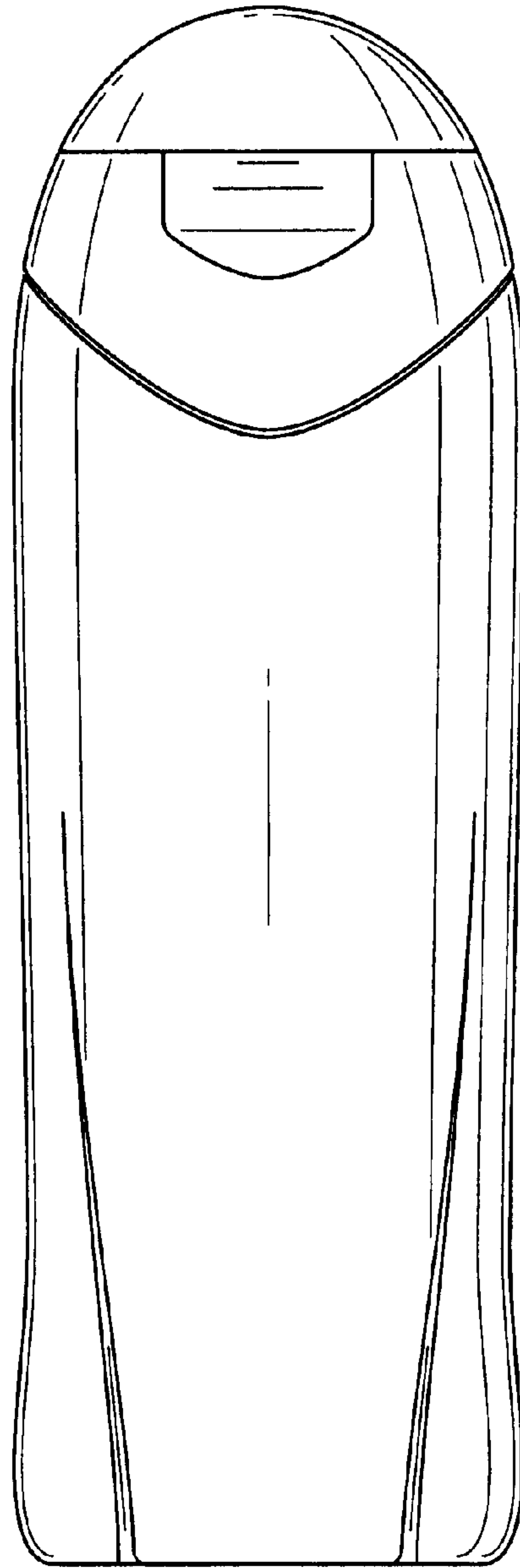

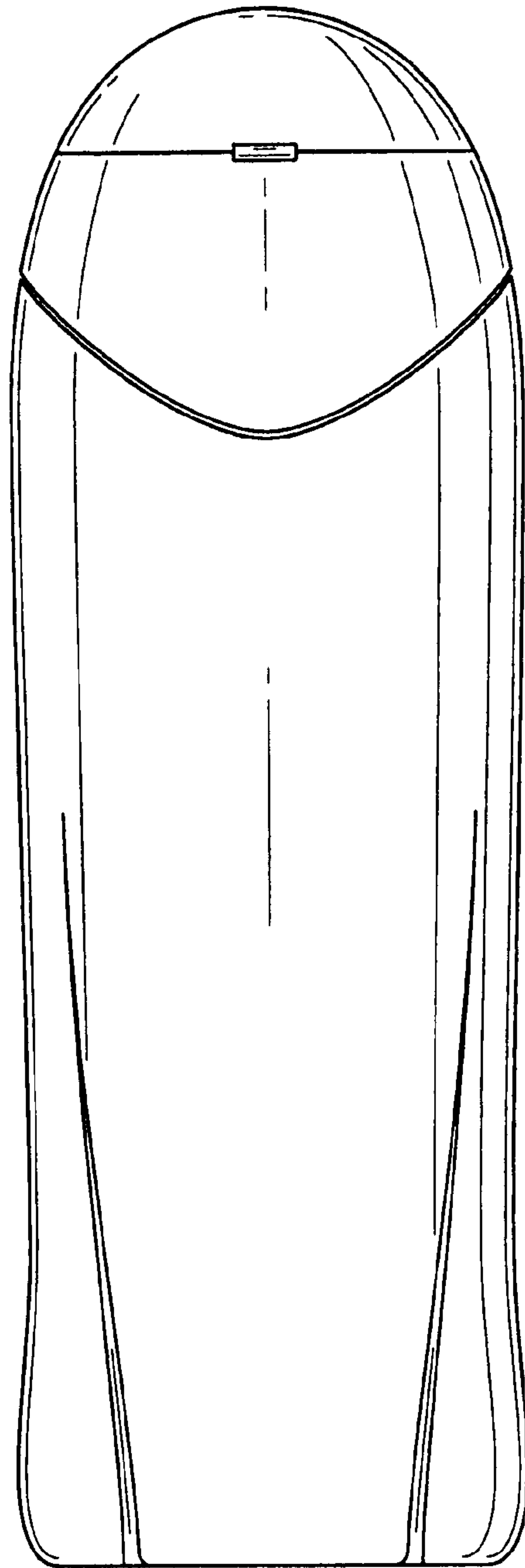

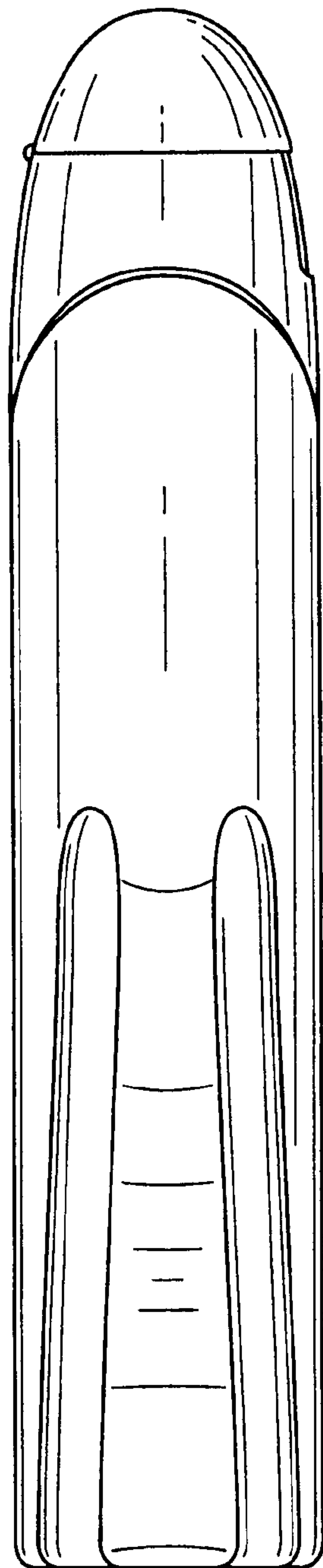

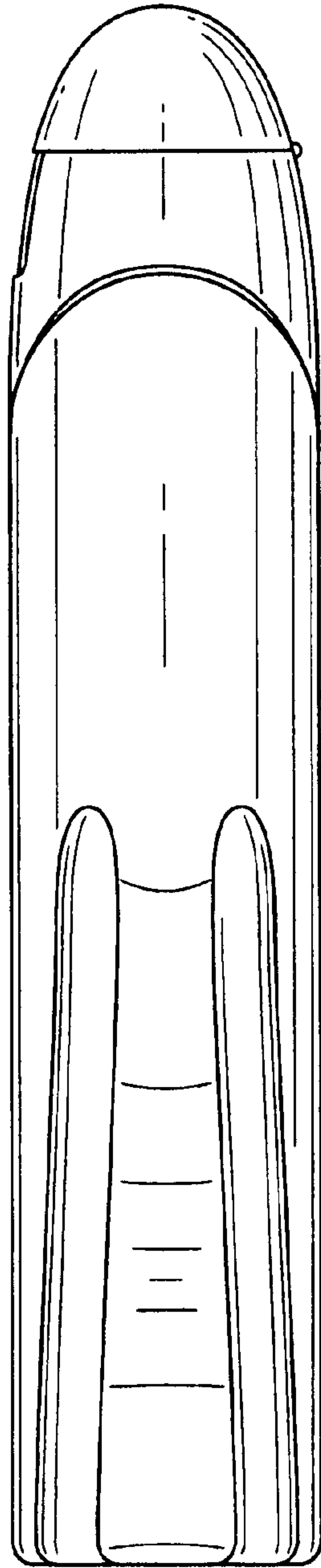

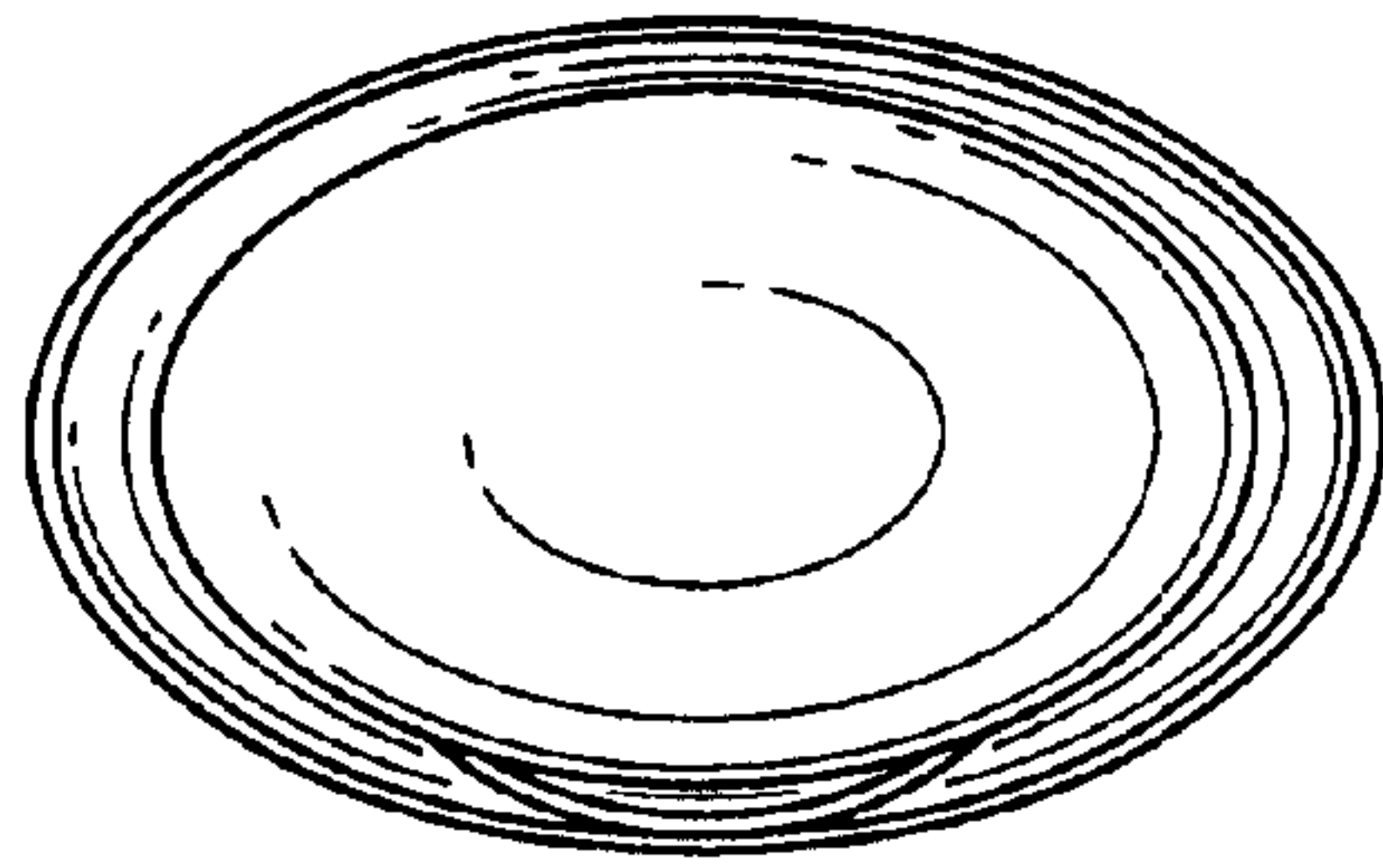

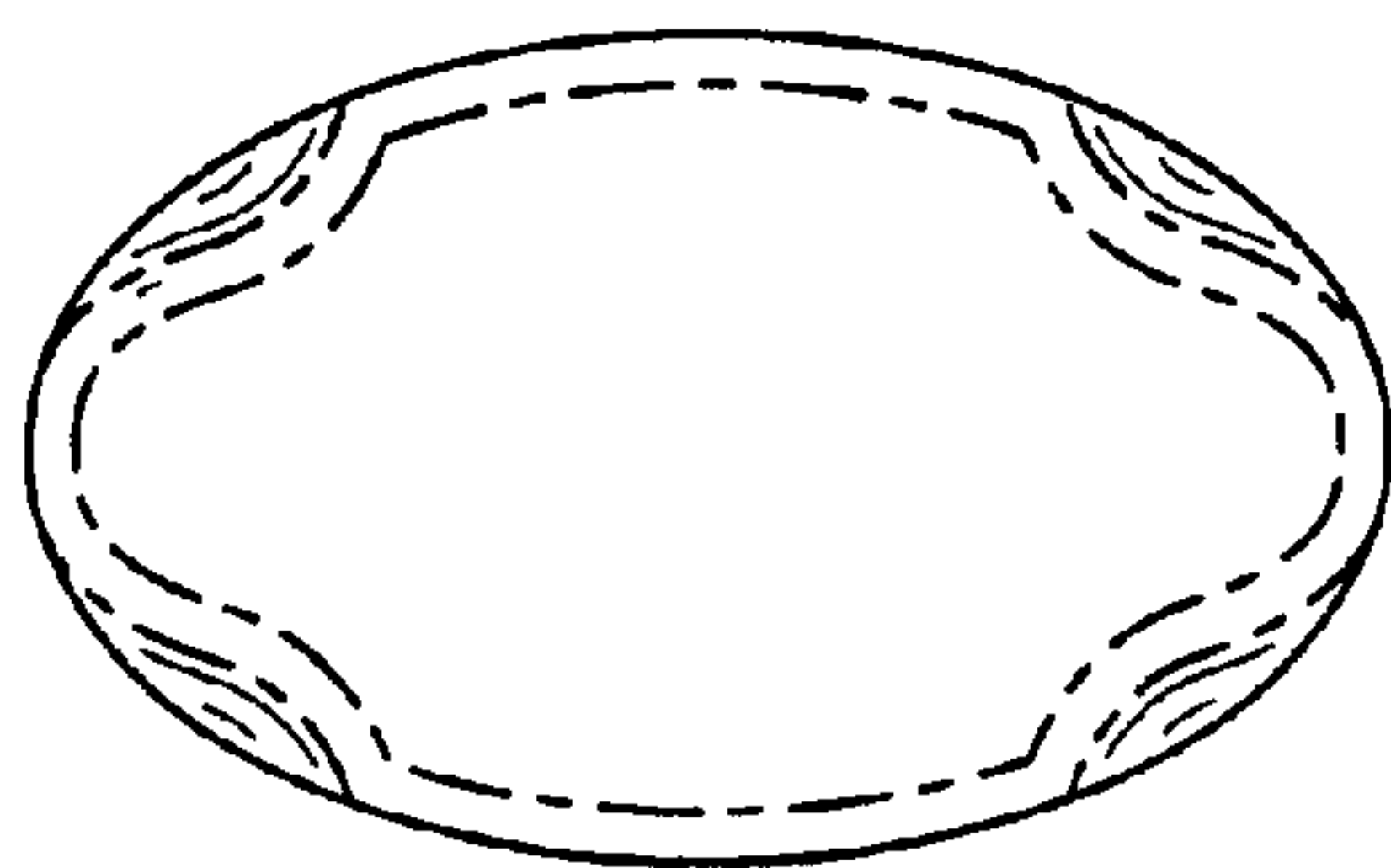

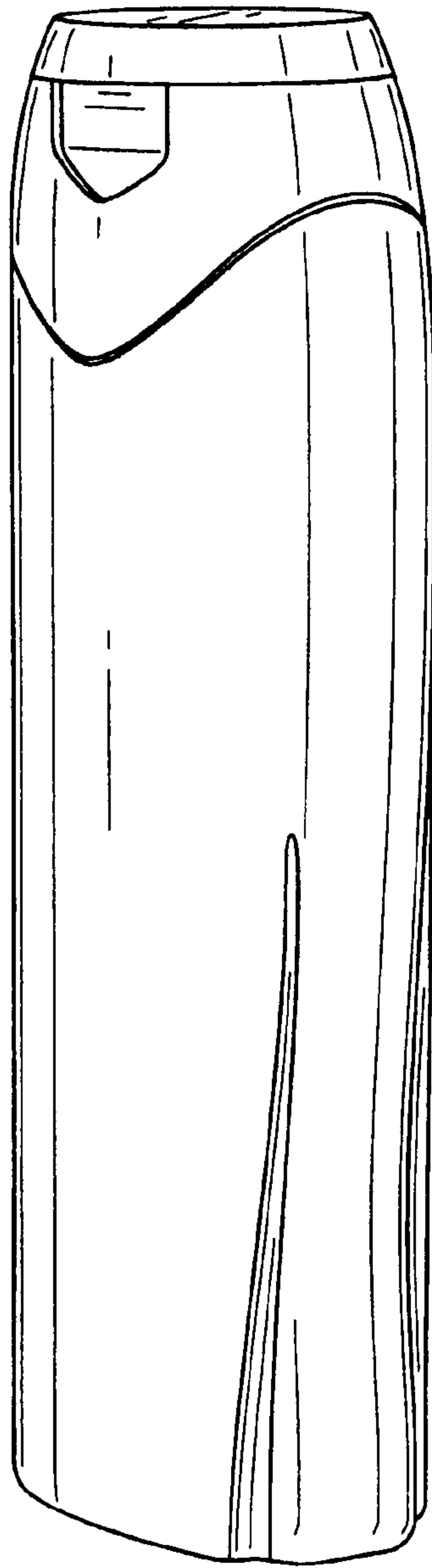

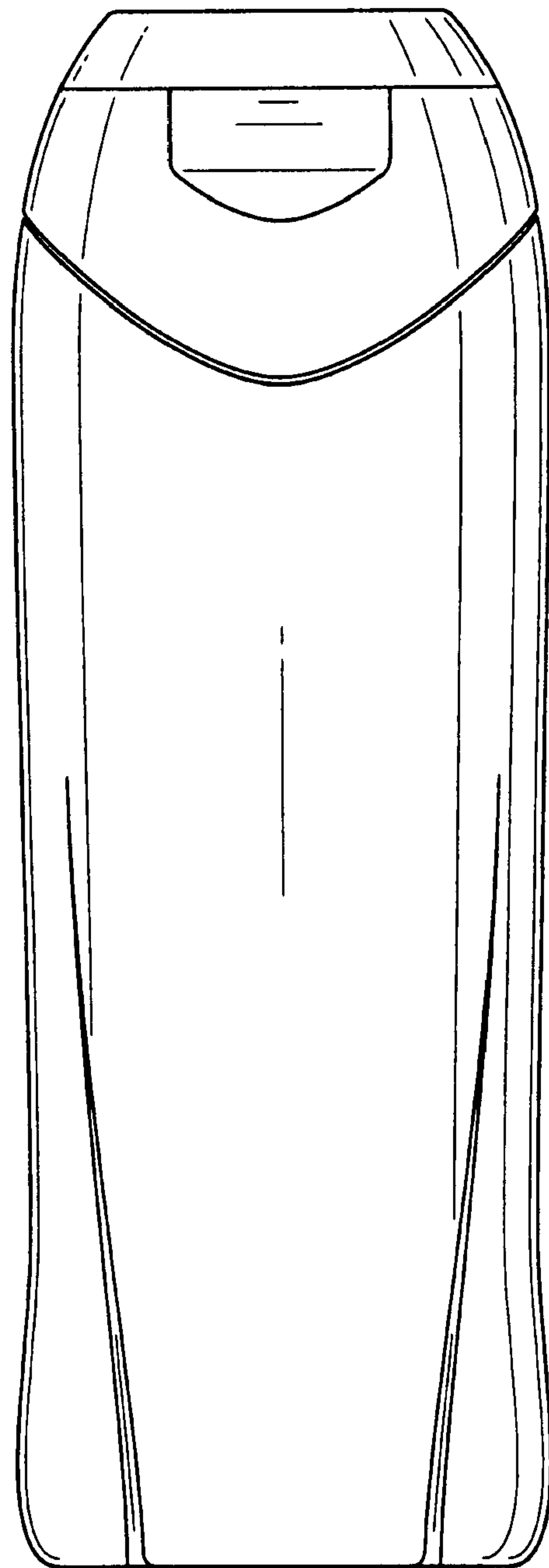

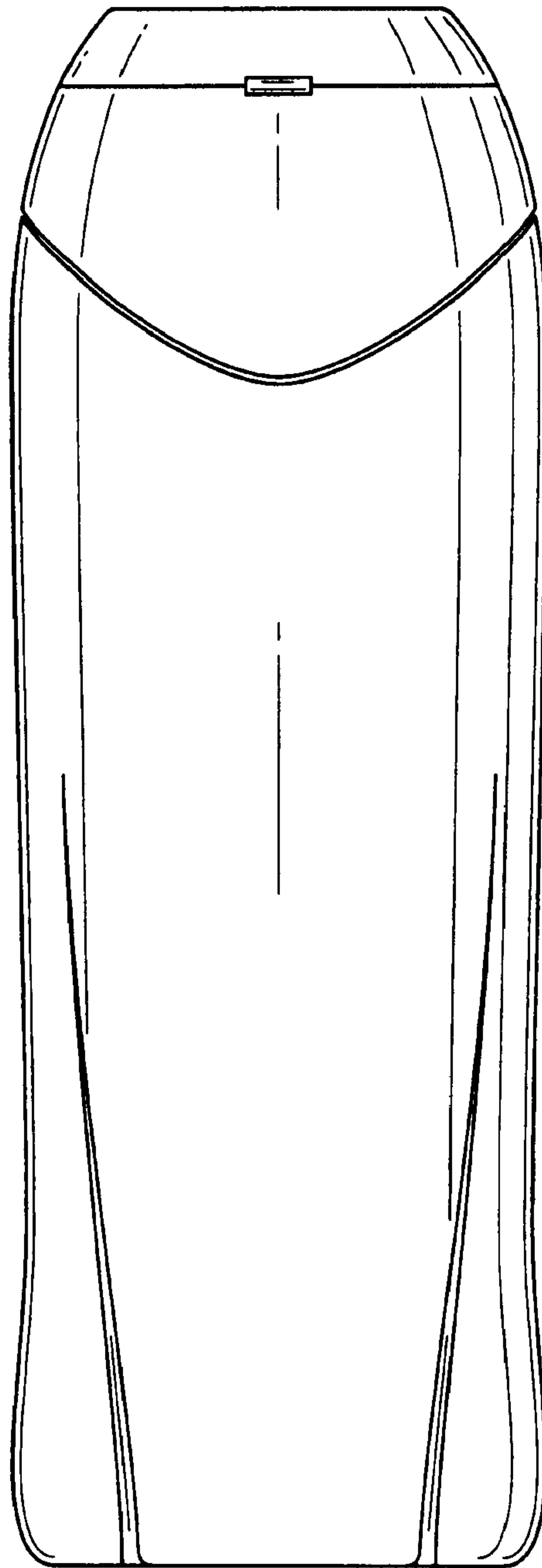

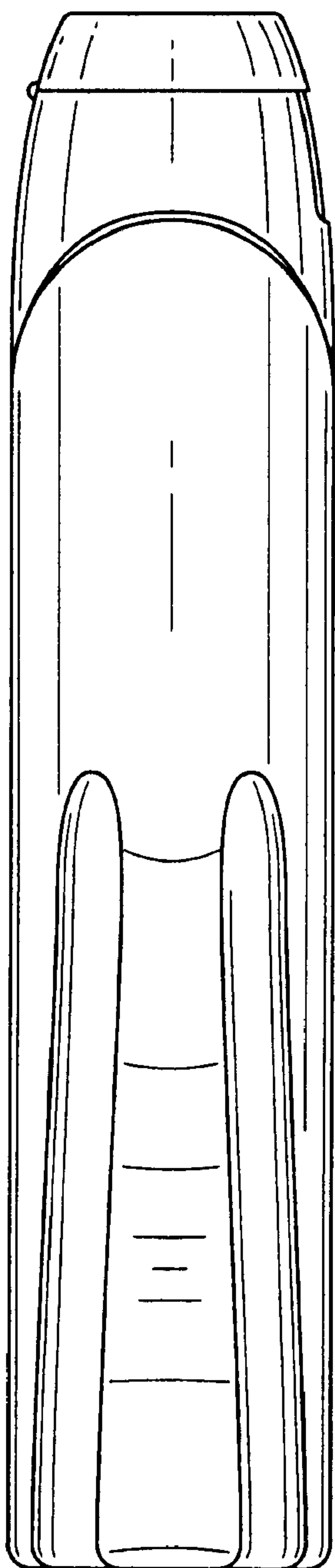

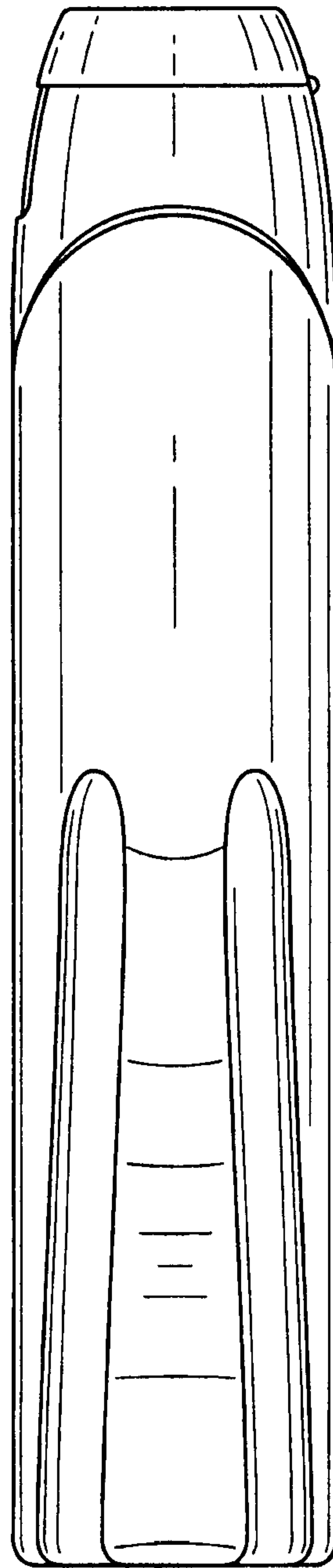

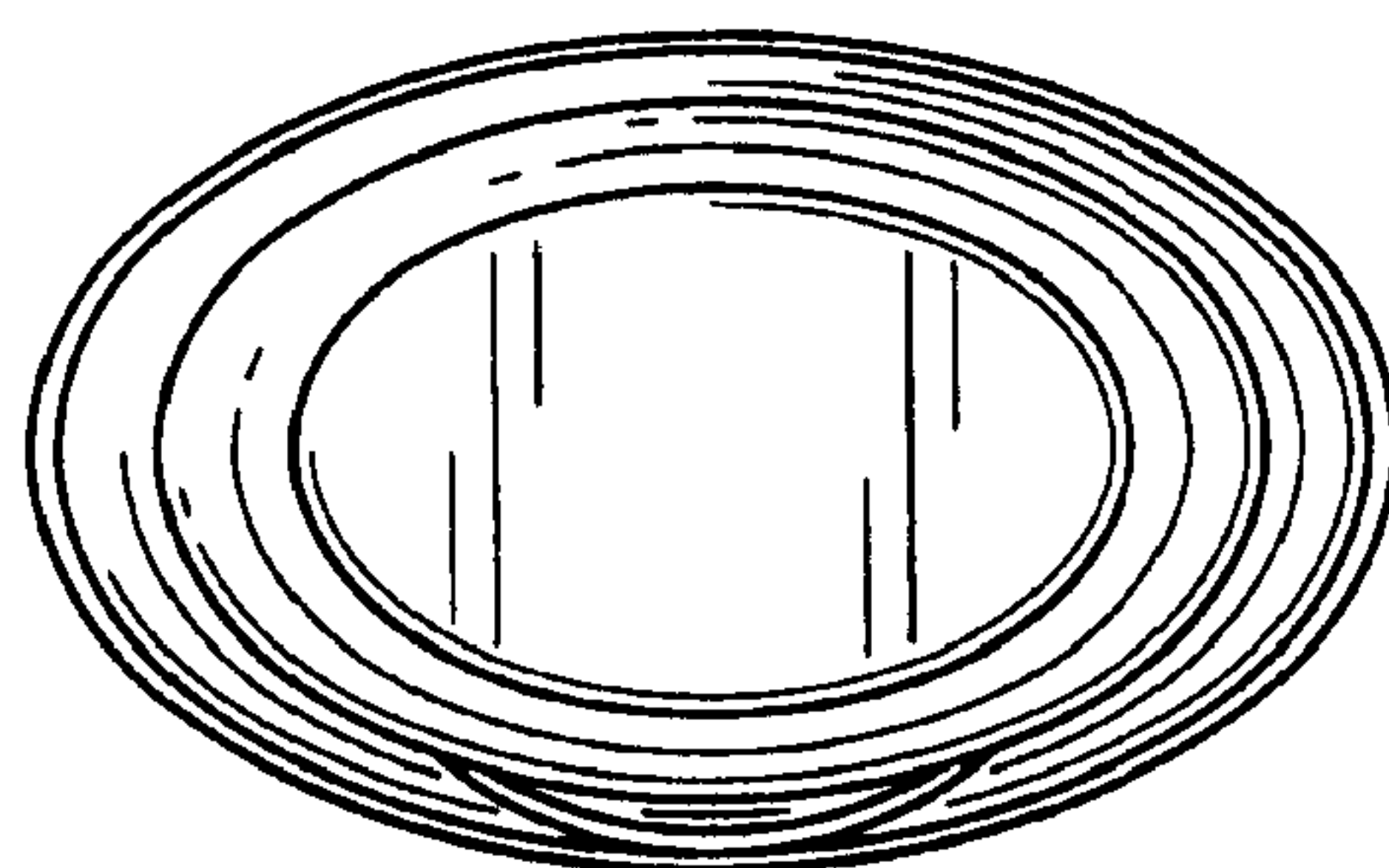

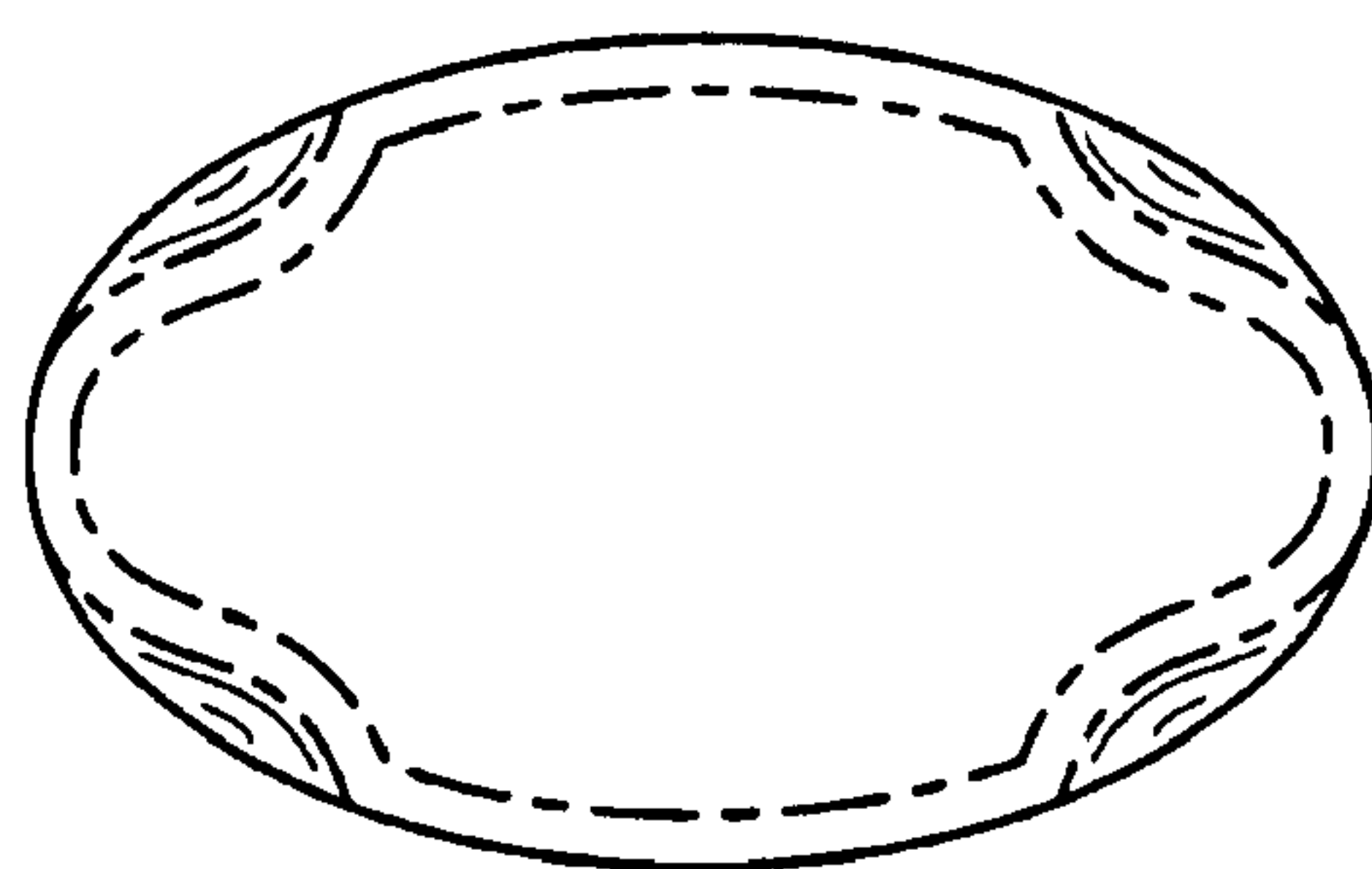
