The ornamental design for a wrist watch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of the wrist watch showing my new design;
FIG. 2 is a front elevational view thereof;

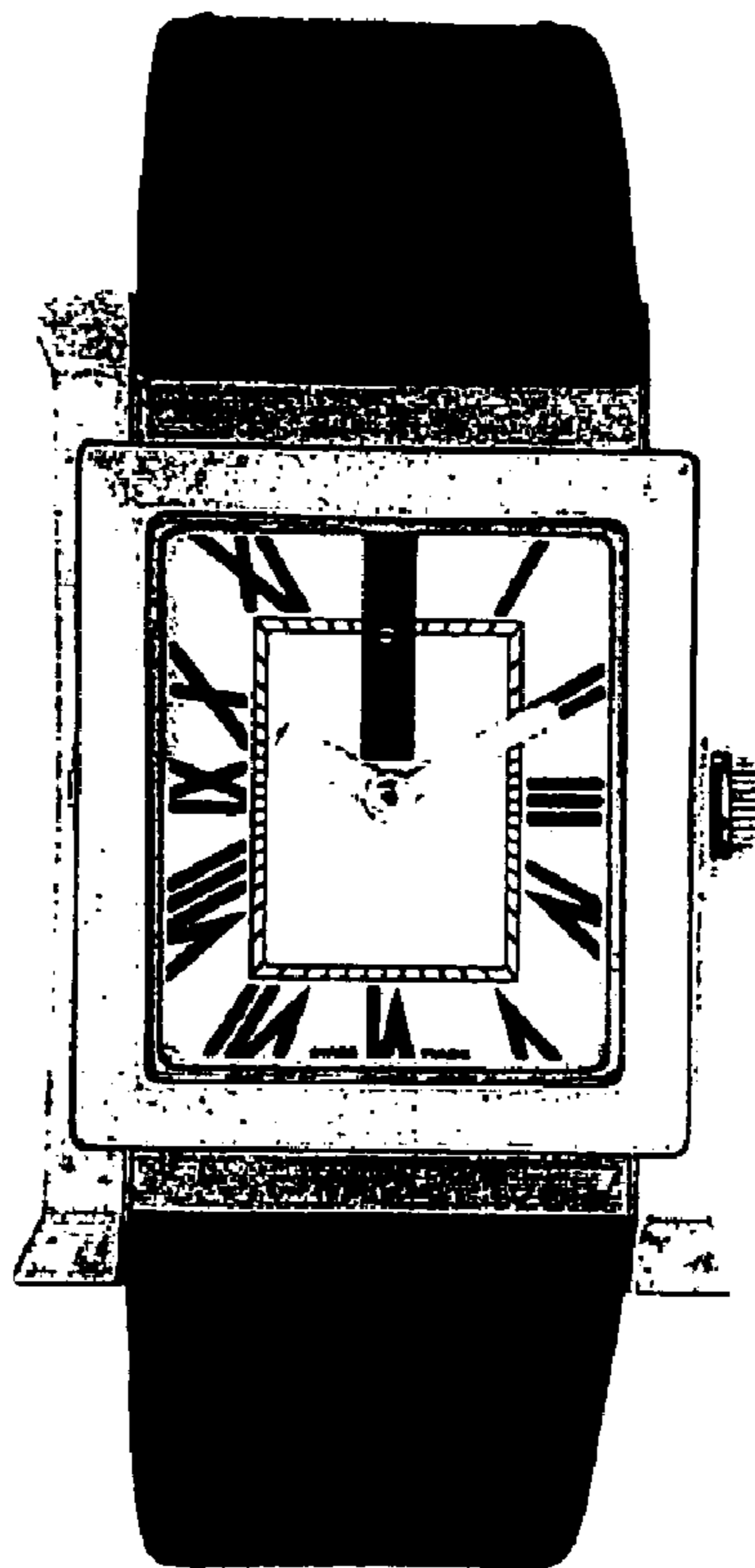

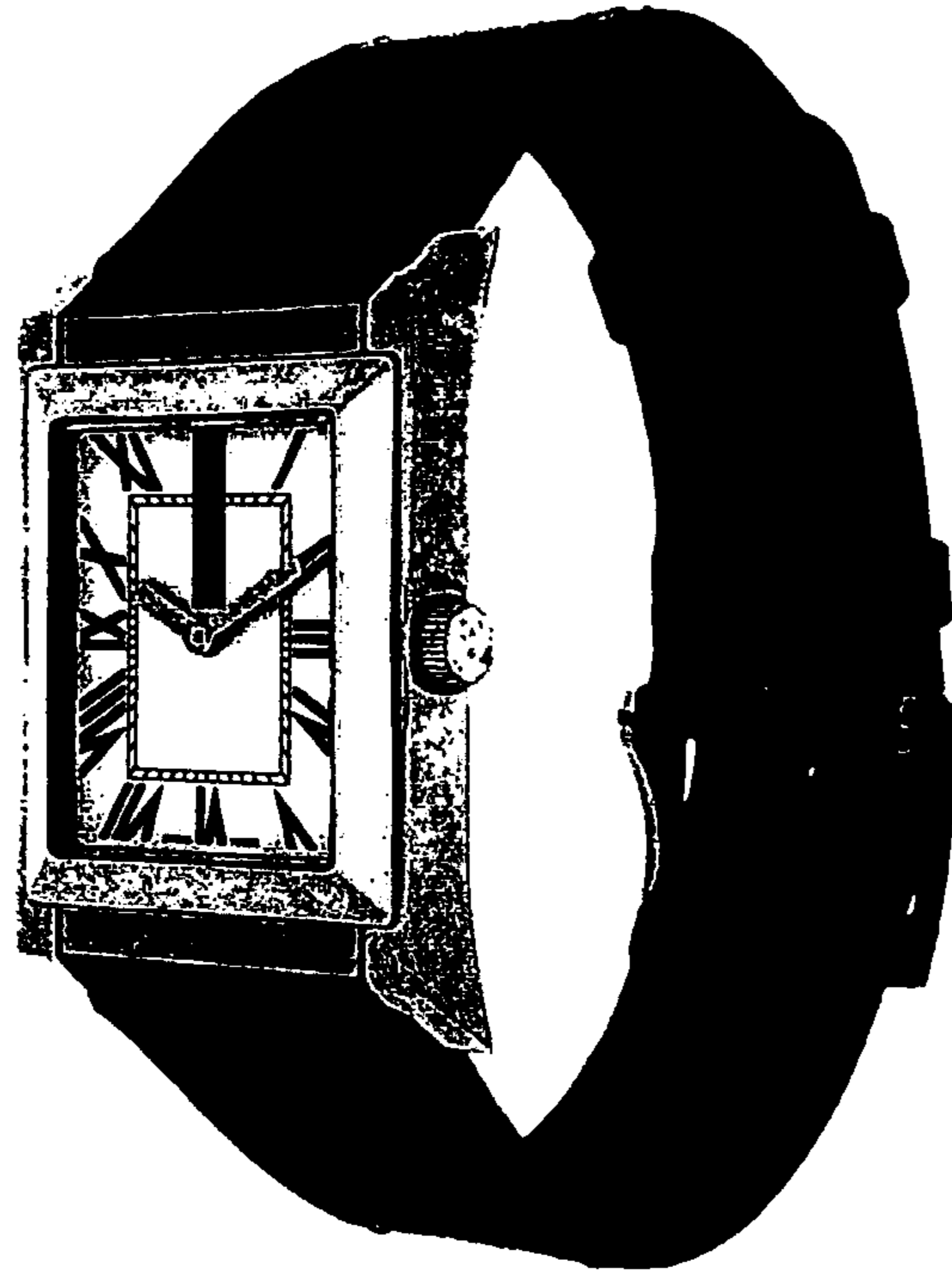

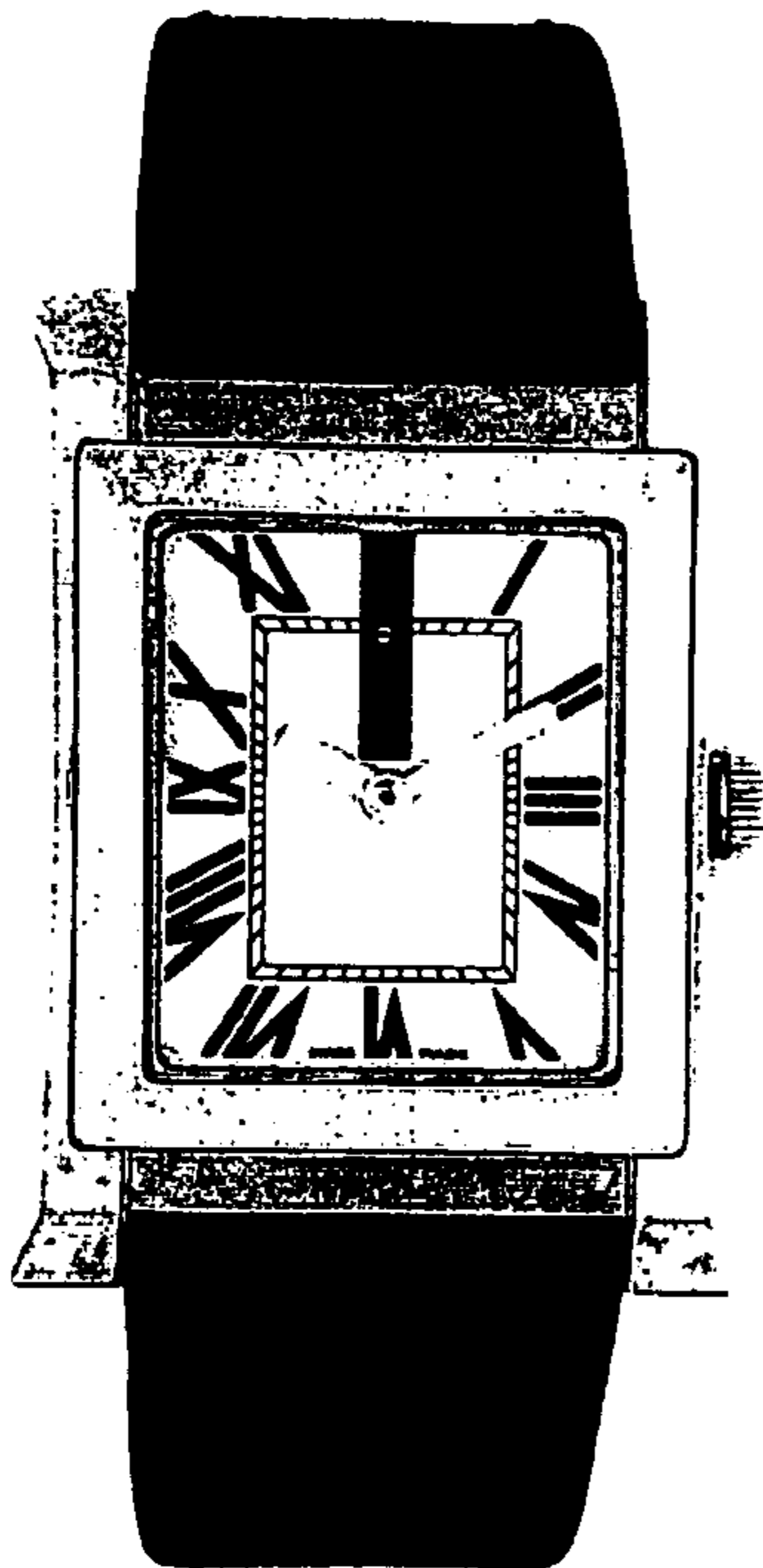

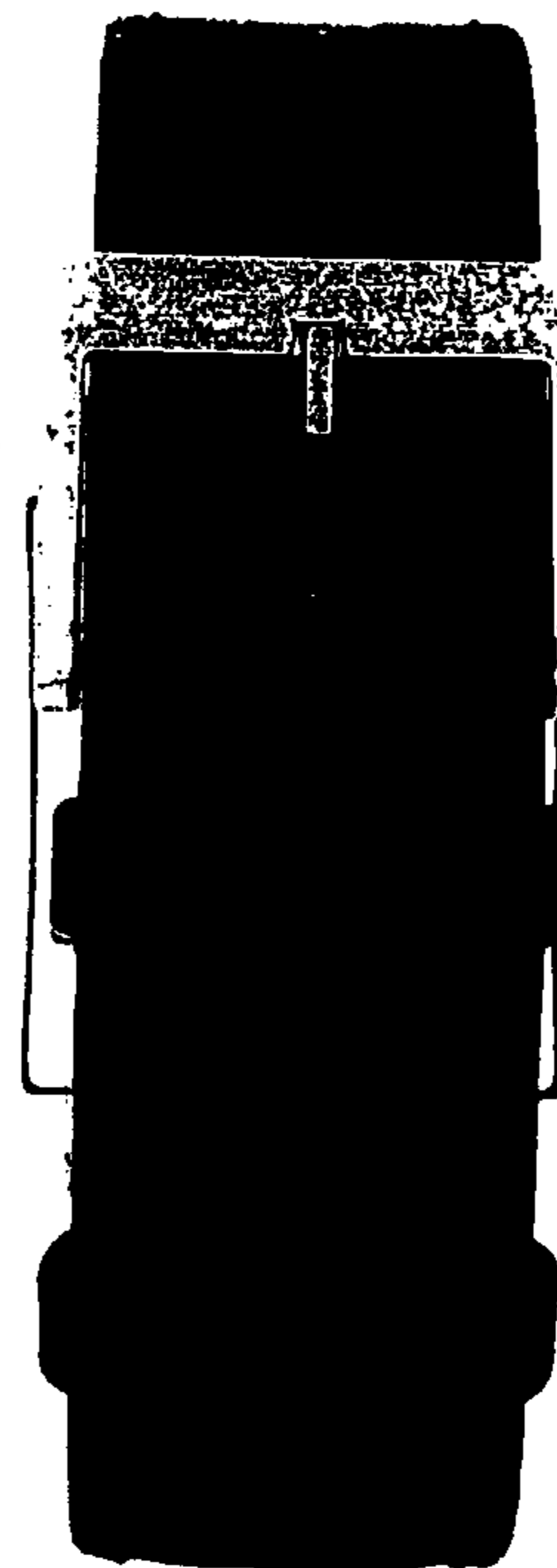

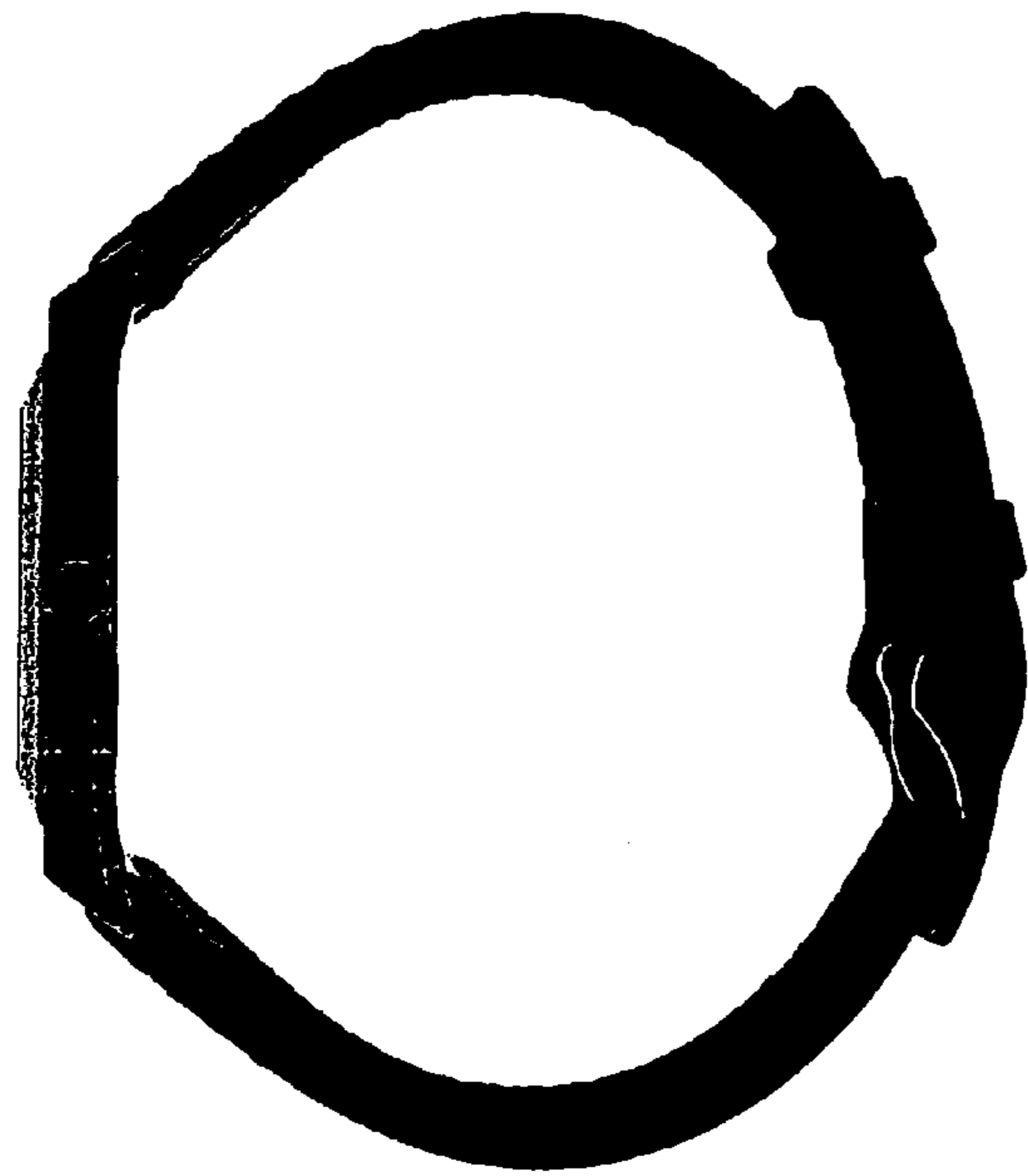

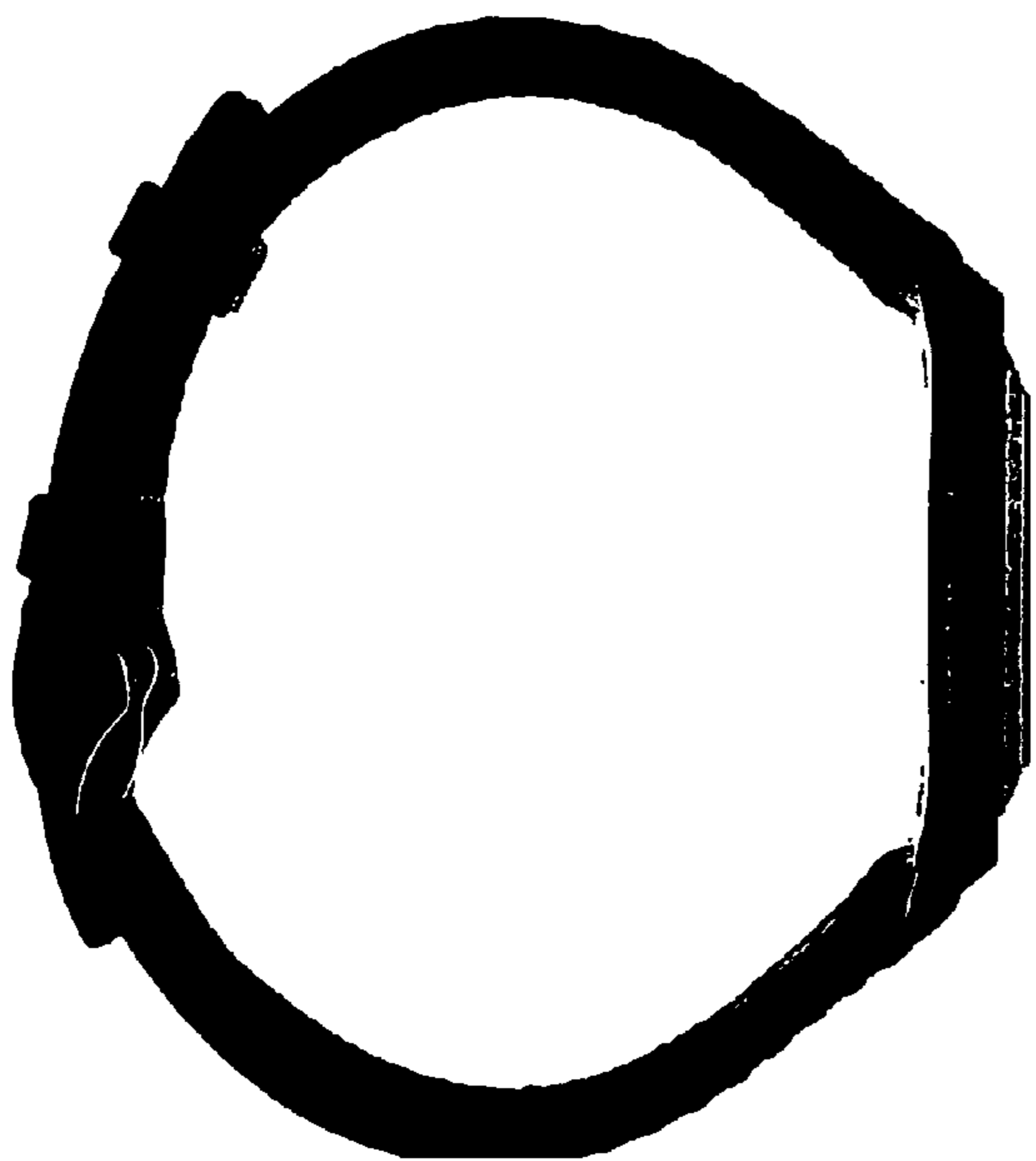
