The ornamental design for a modular track electric connector and jack, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a modular track electric connector and jack, showing my new design;

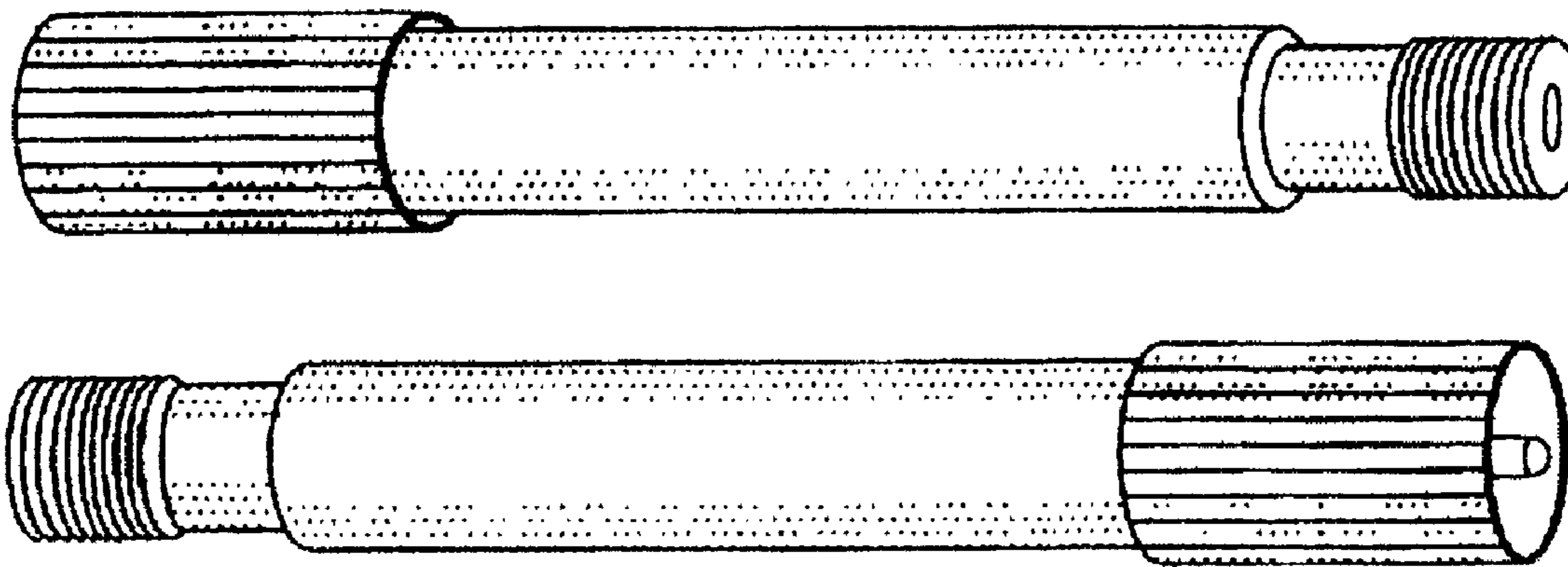

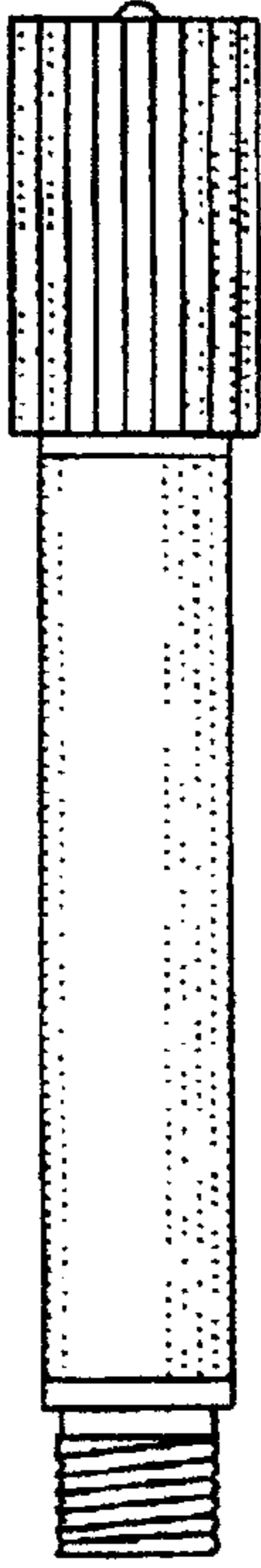

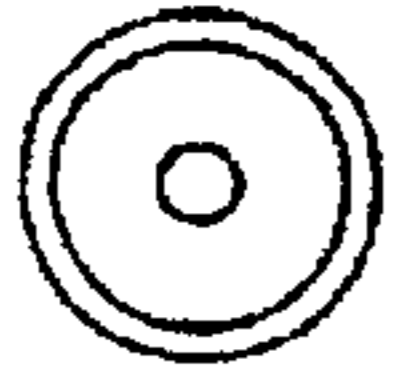

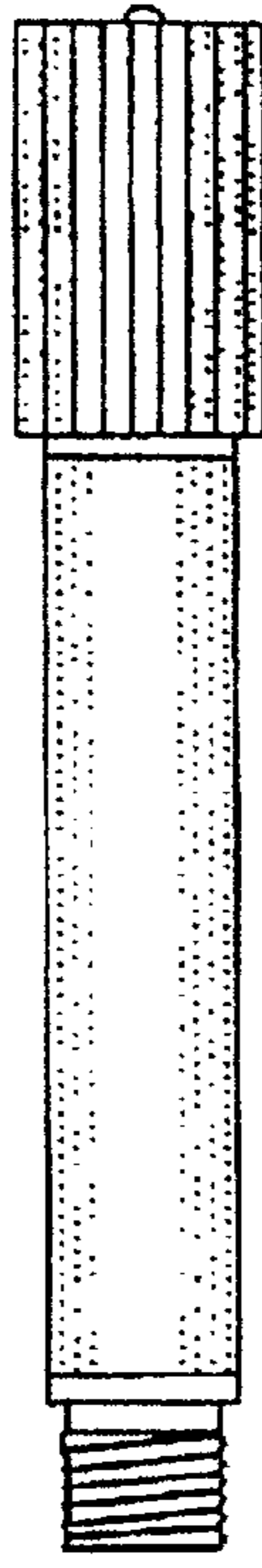

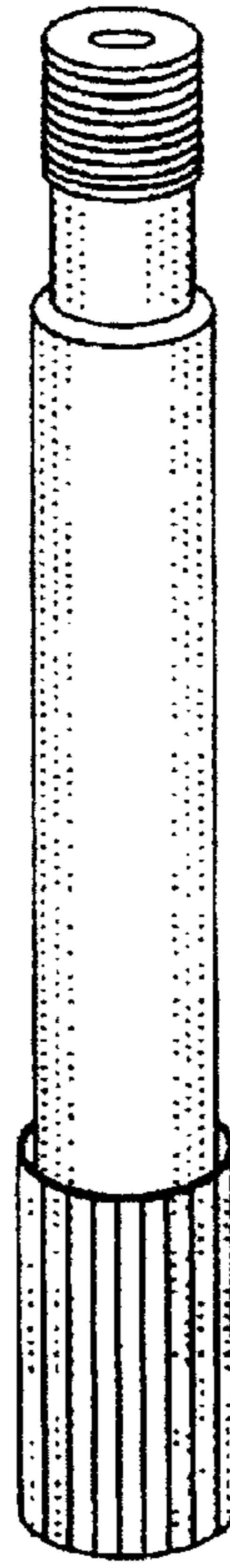
