(57) **CLAIM**

The ornamental design for a DB9 to euro connector, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a DB9 to euro connector showing my new design;

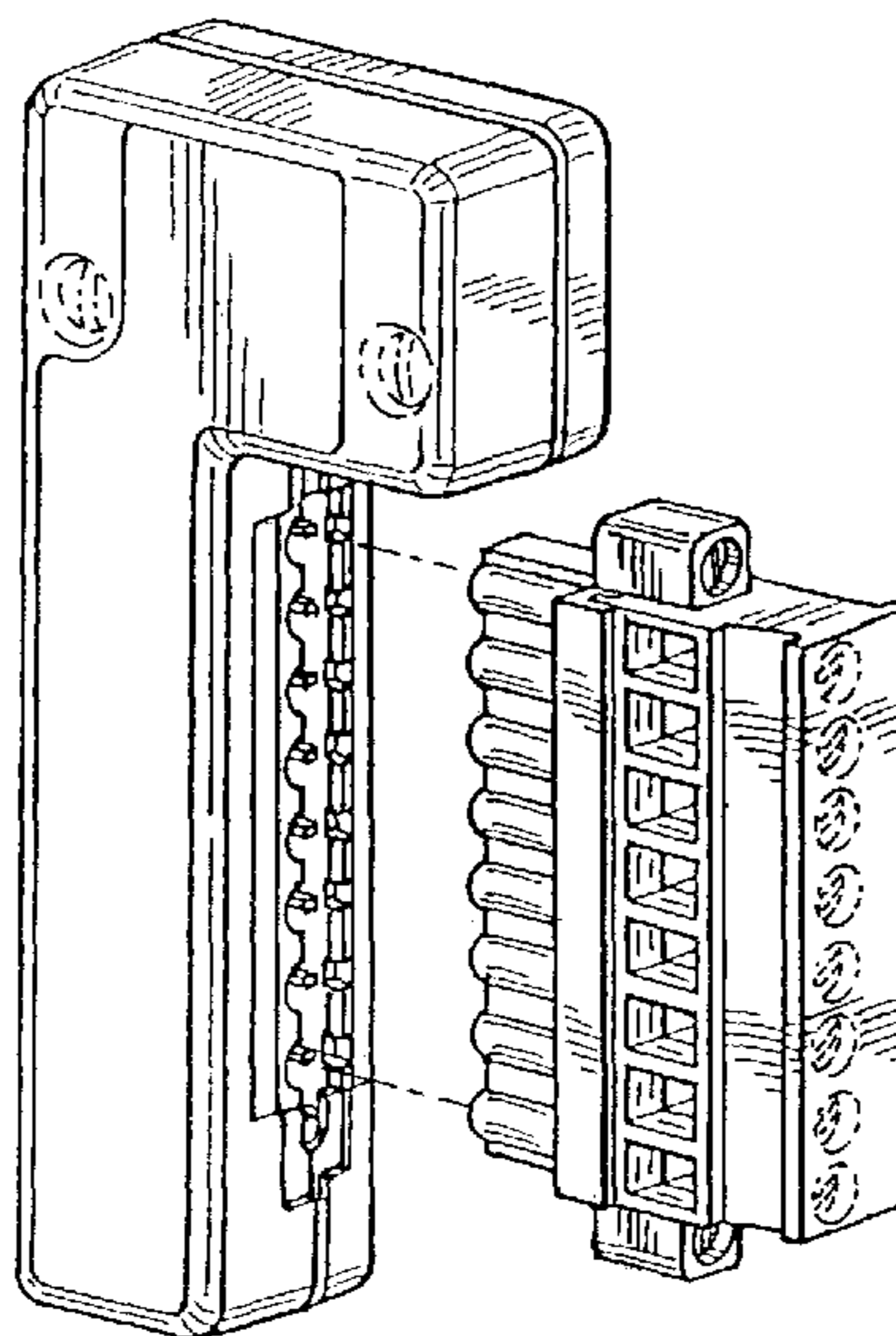

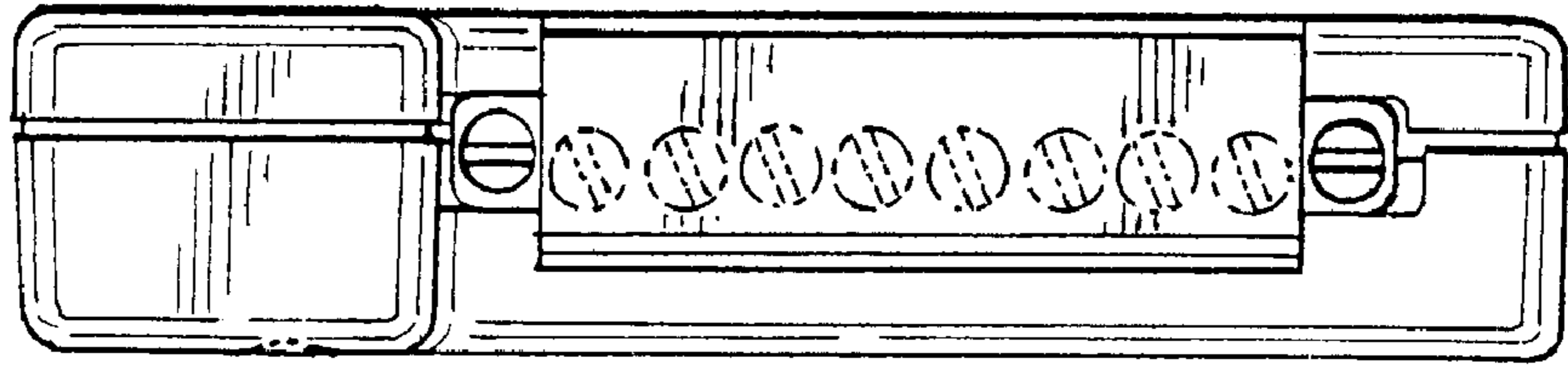

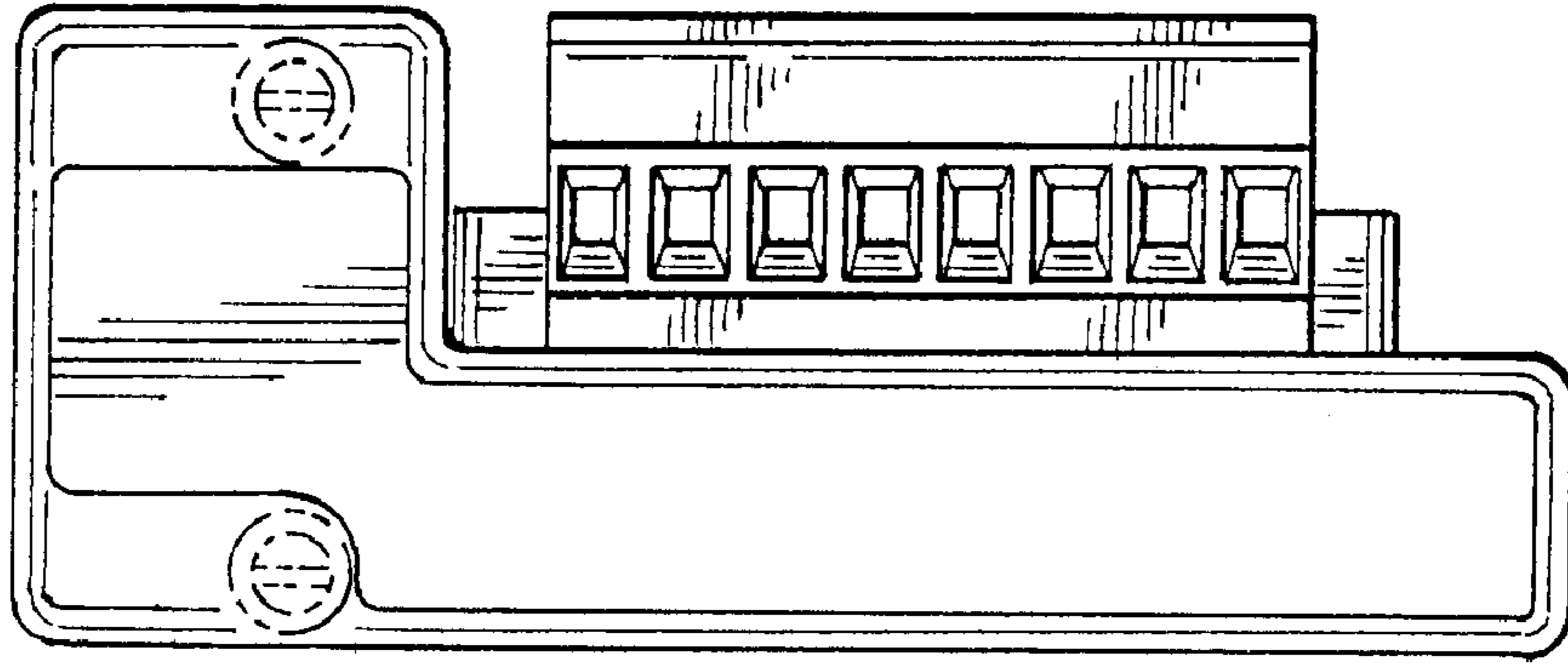

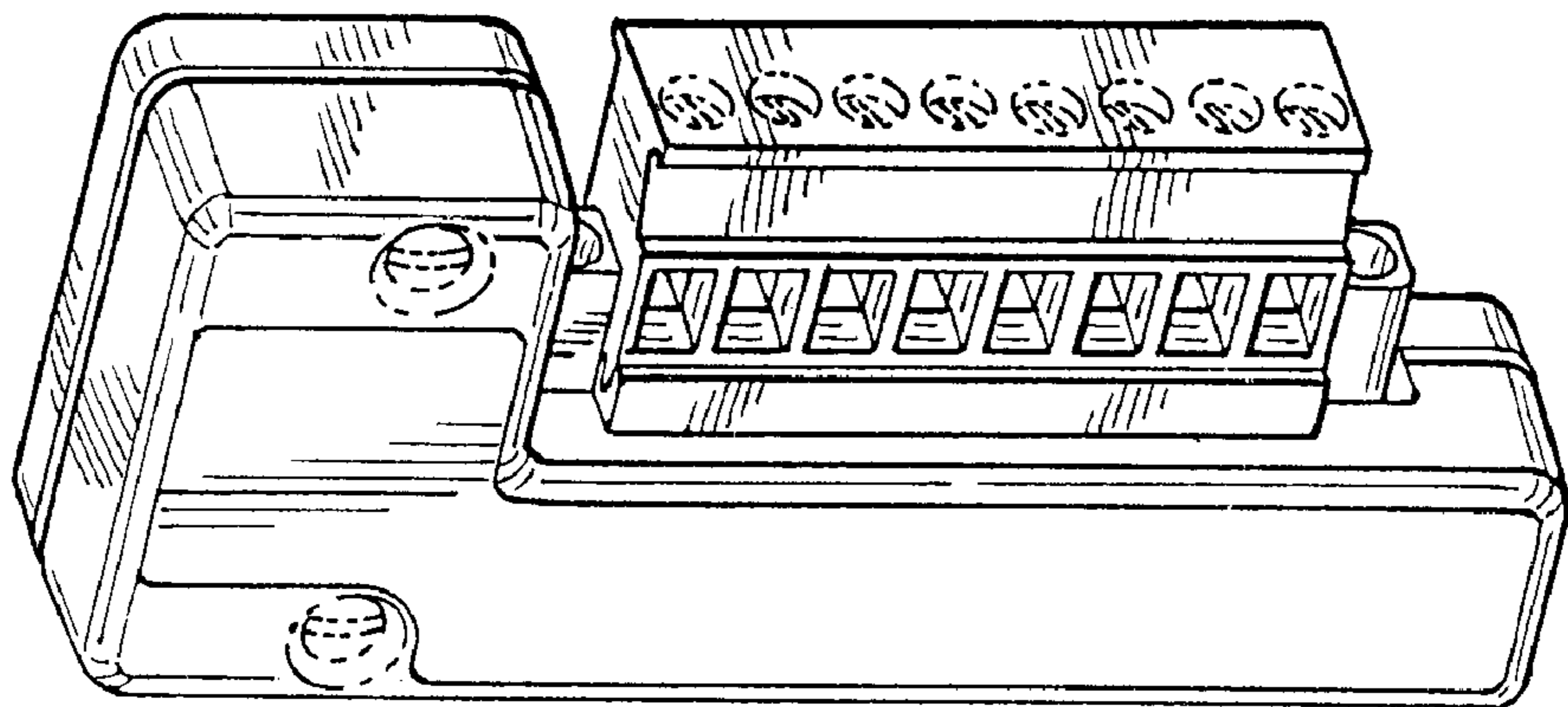

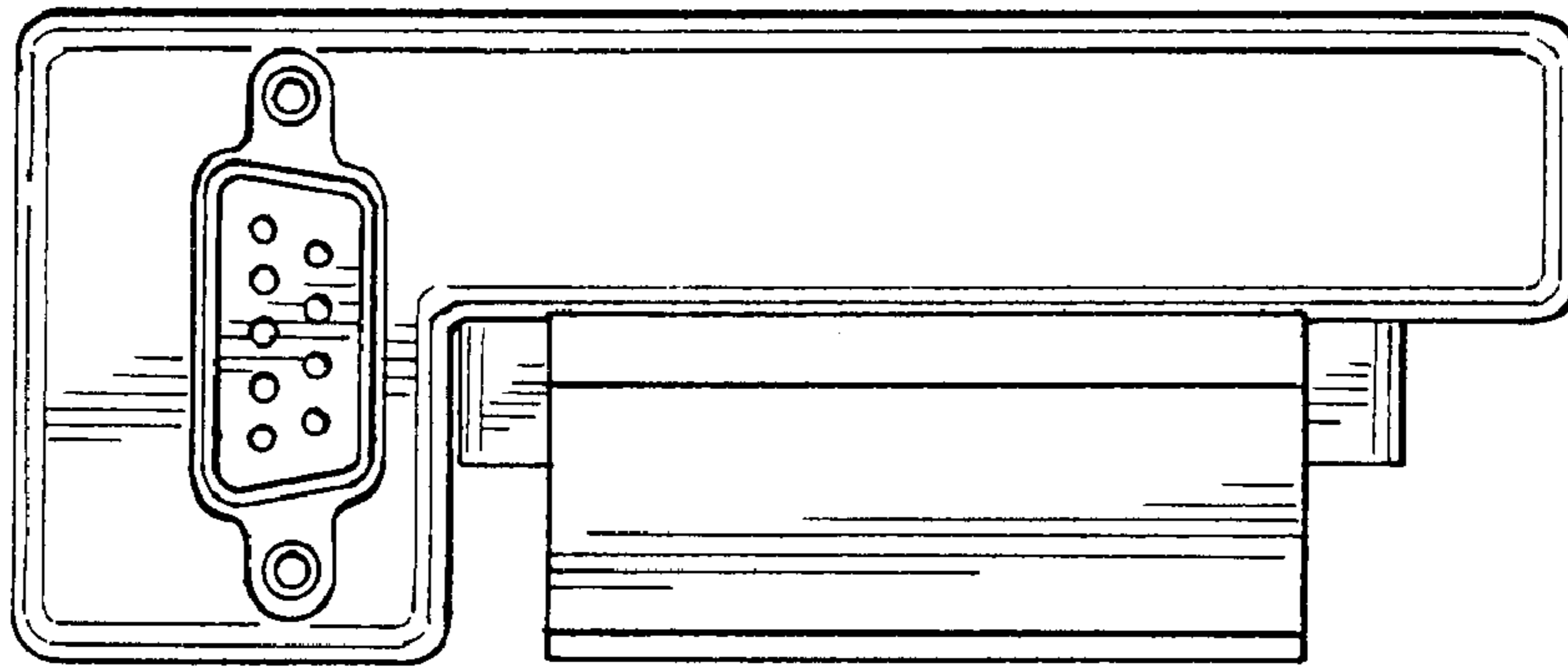

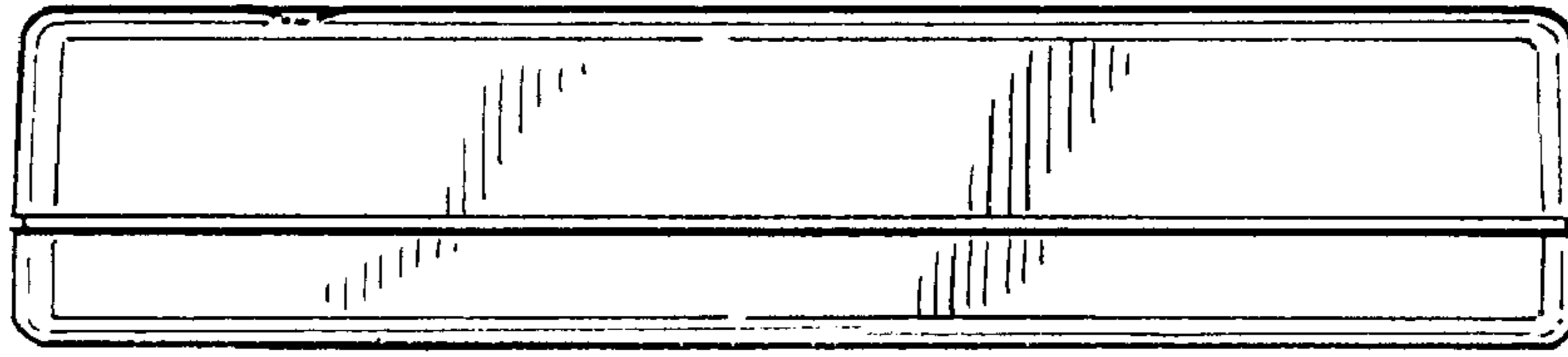

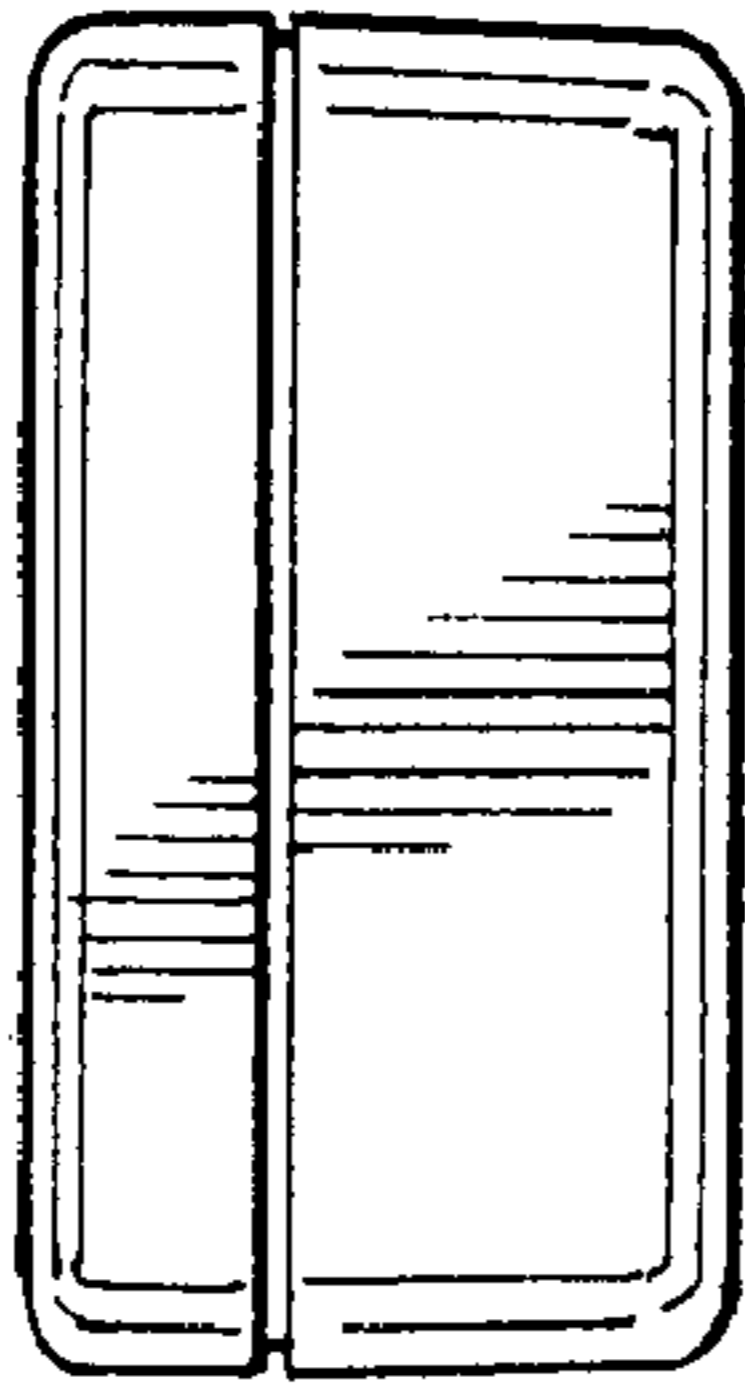

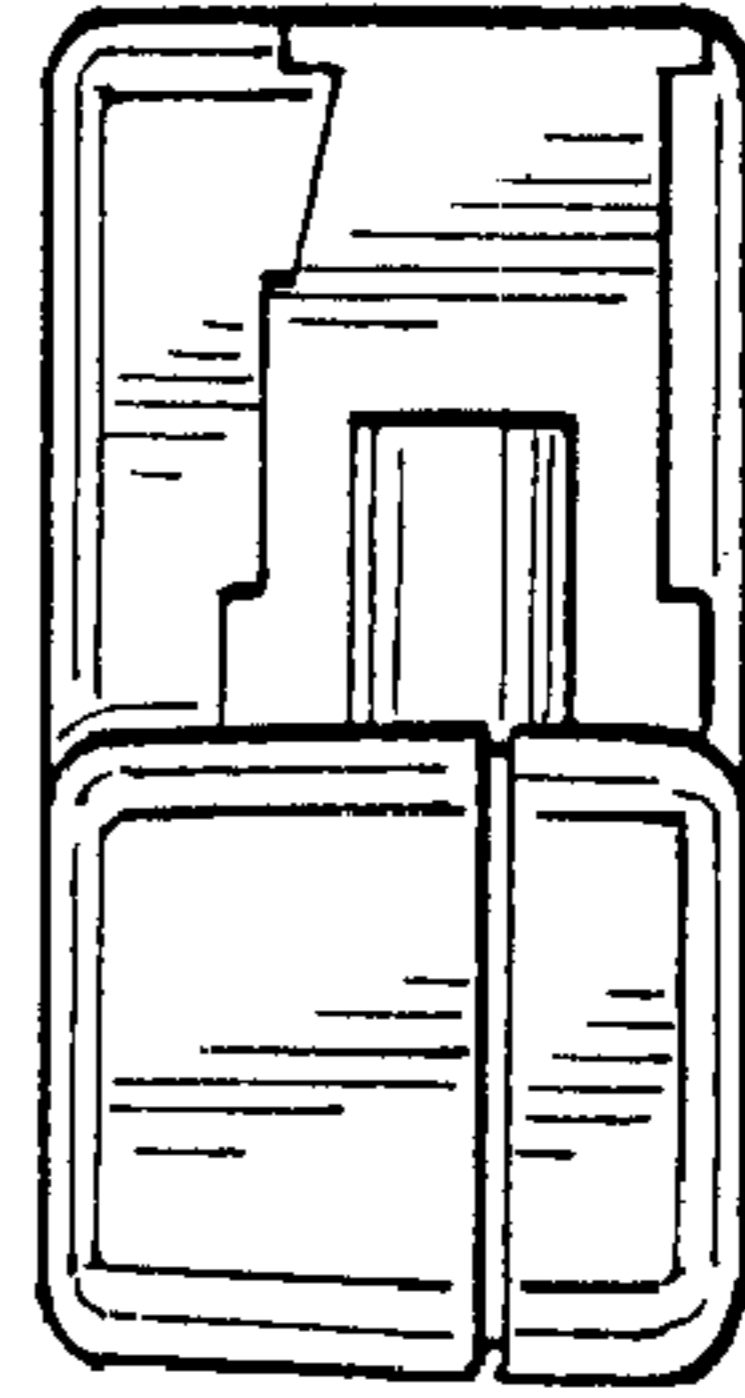

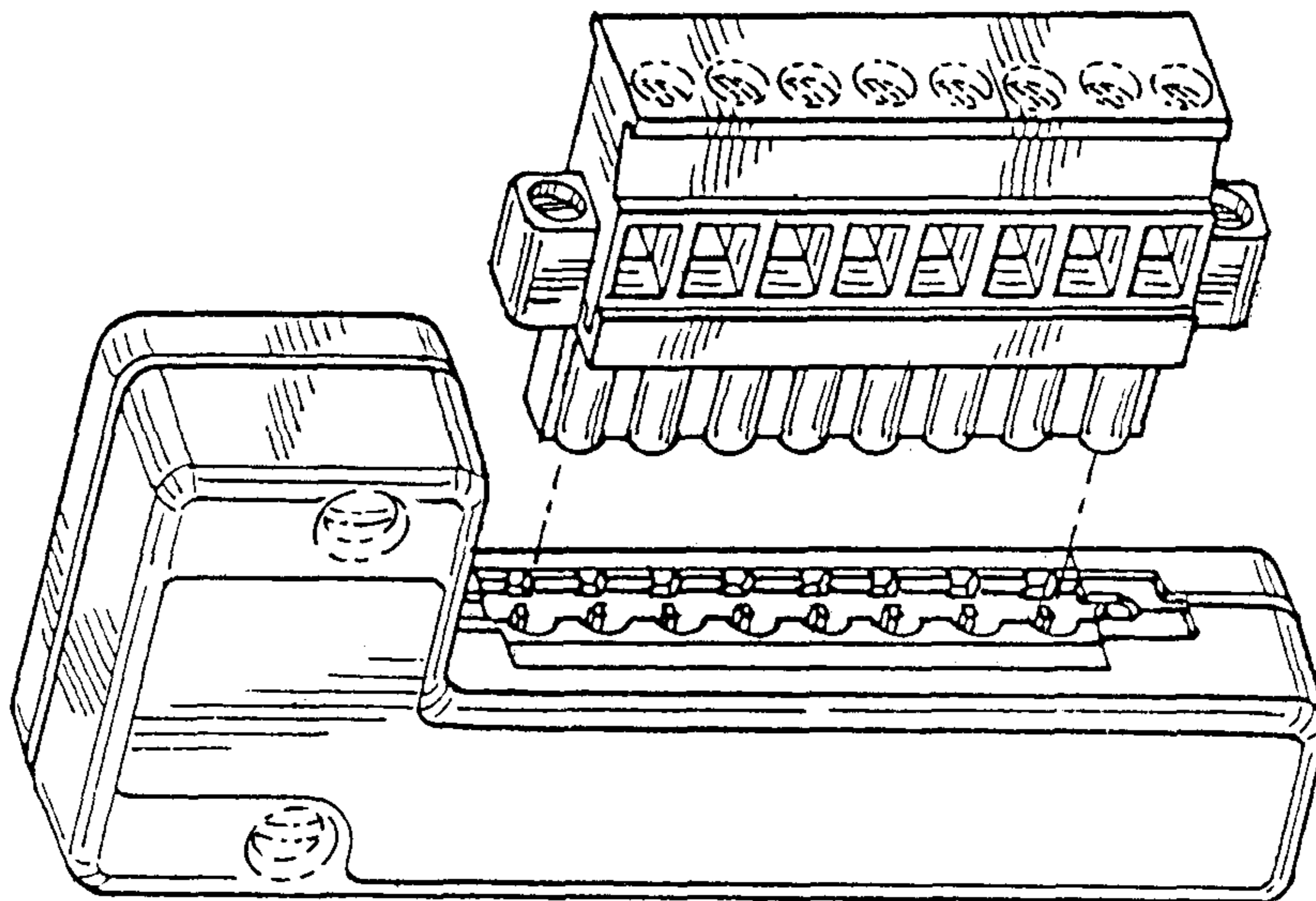

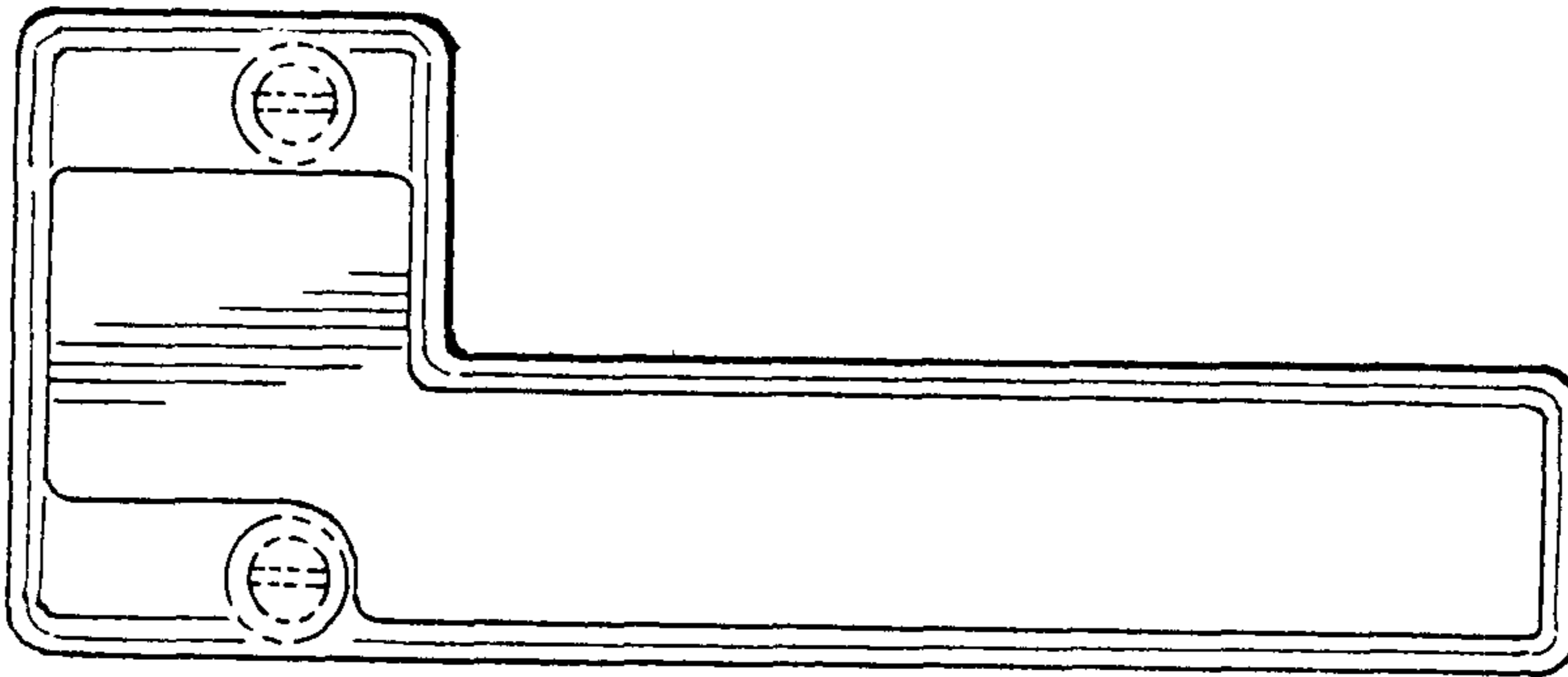

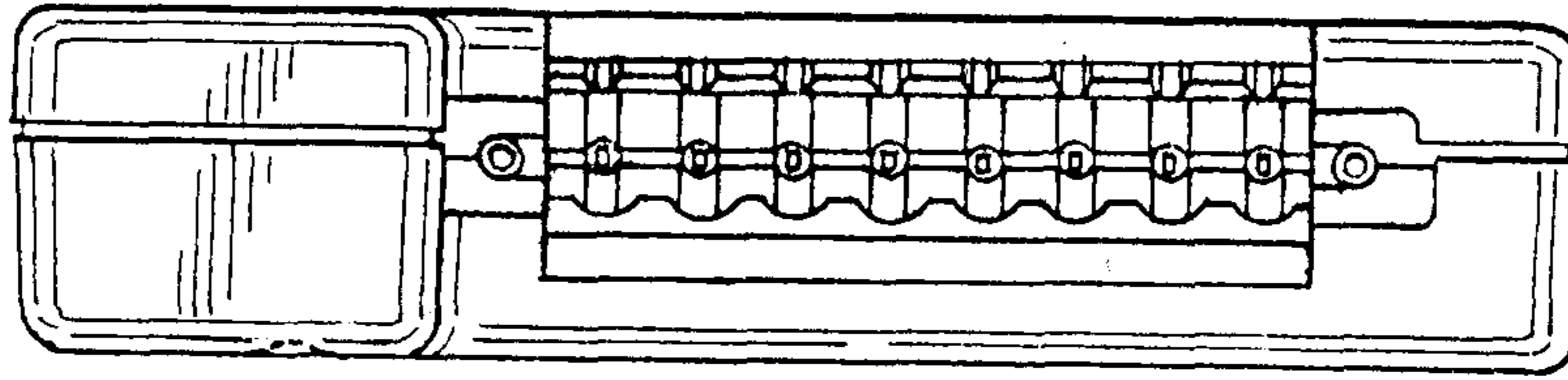

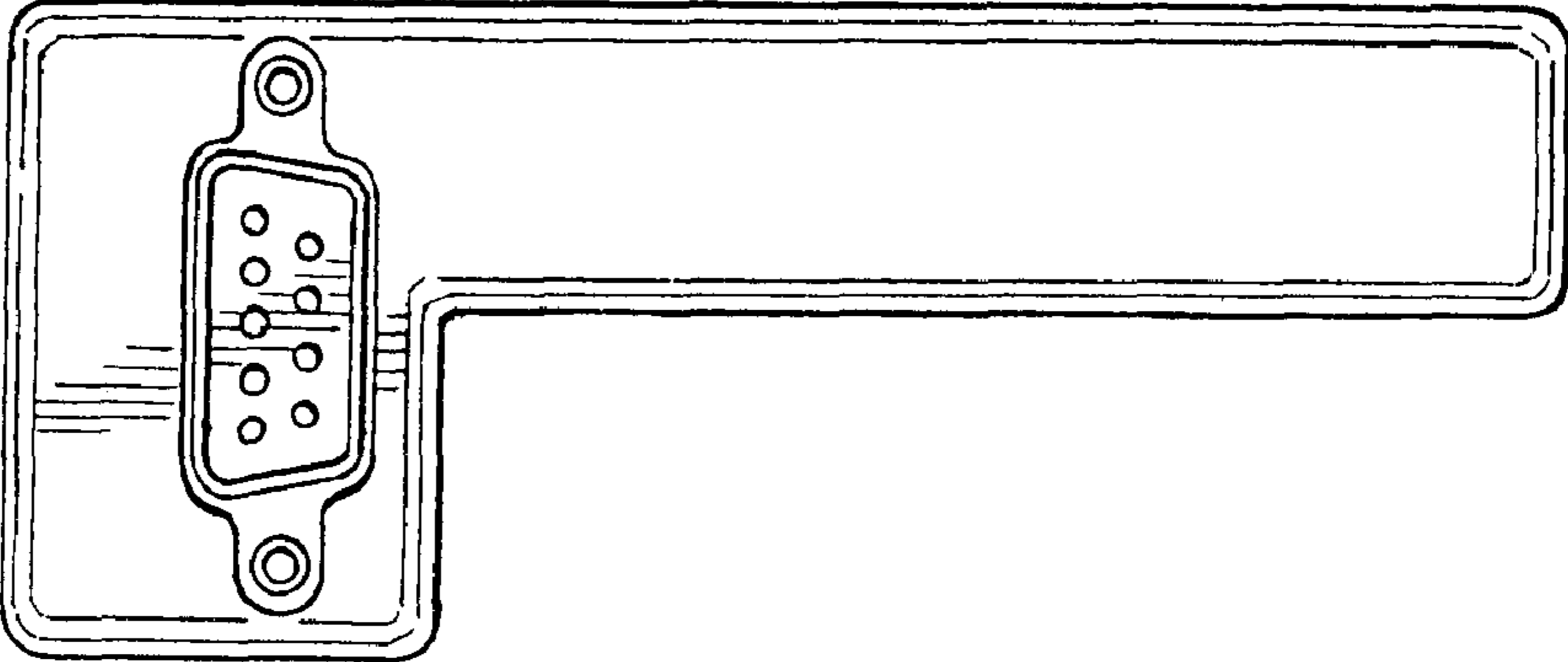

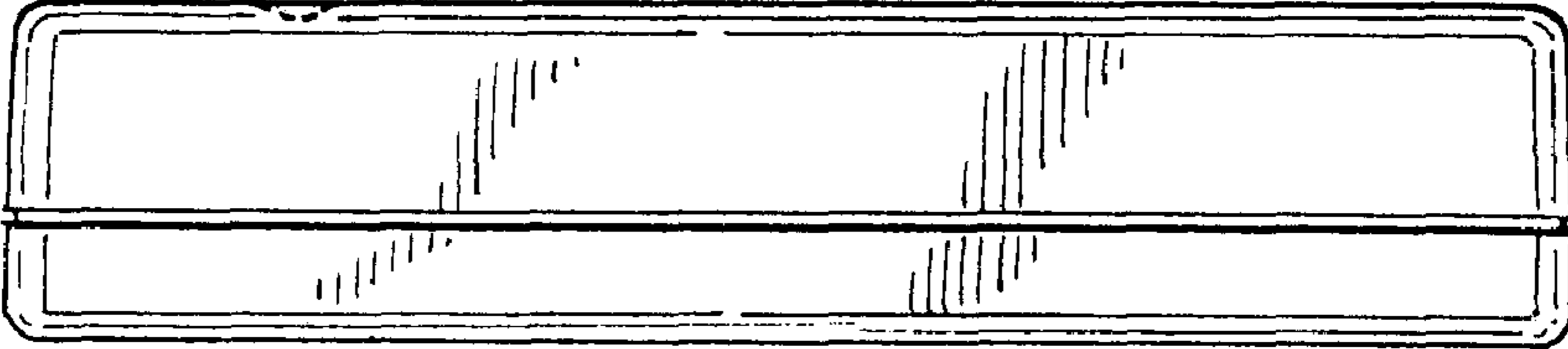

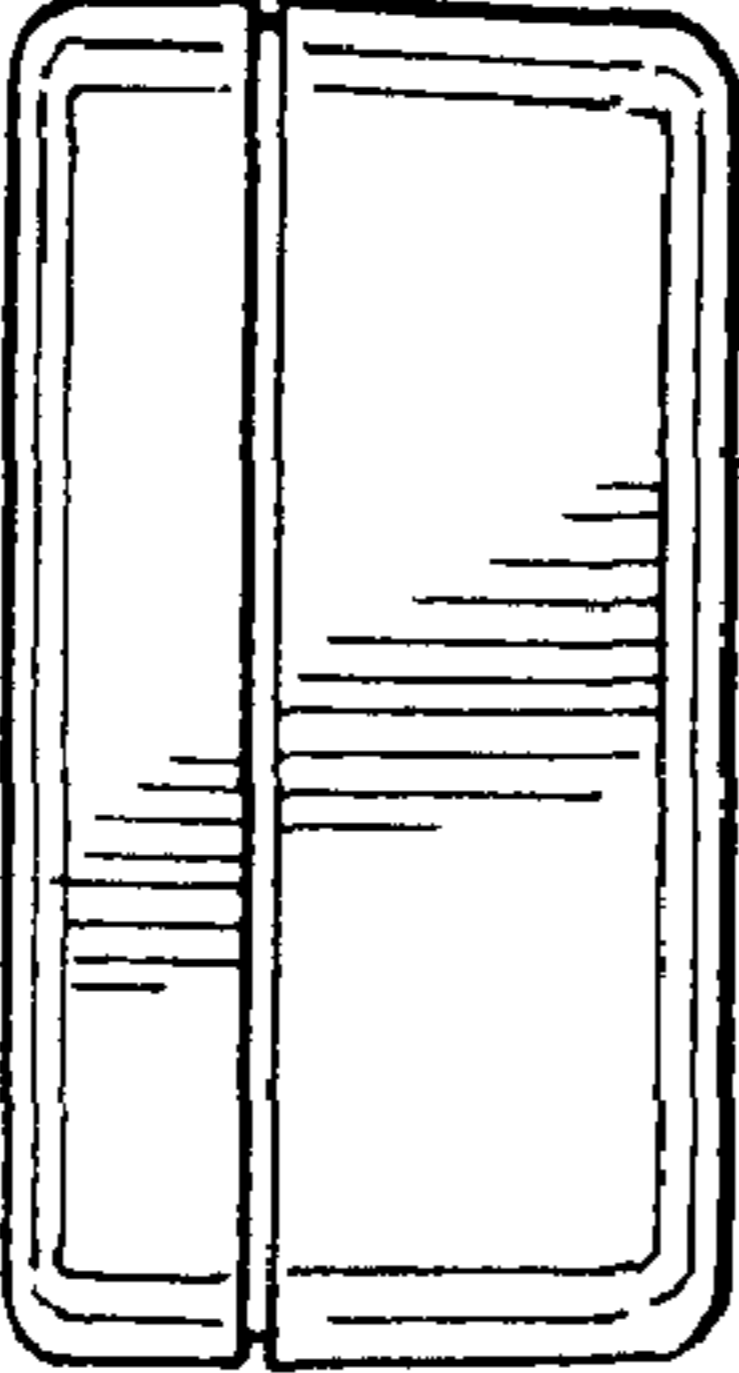

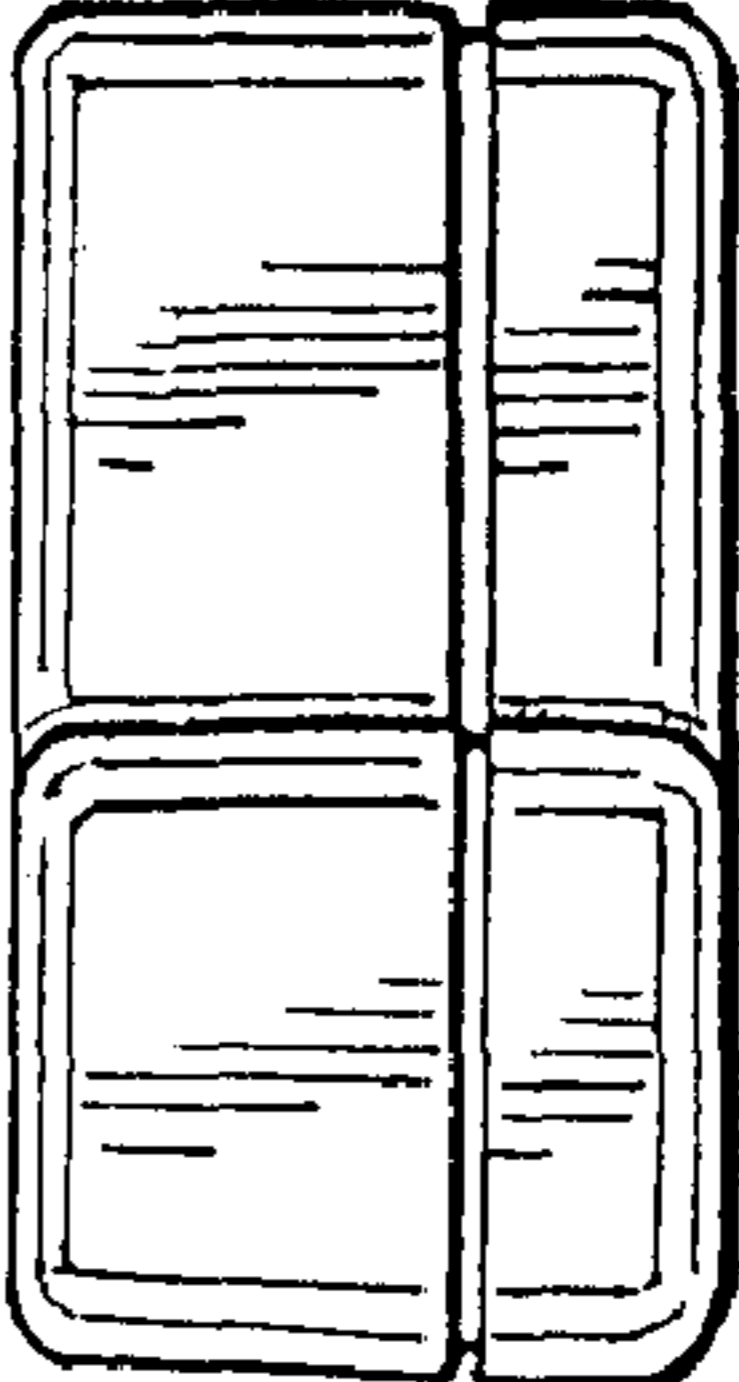

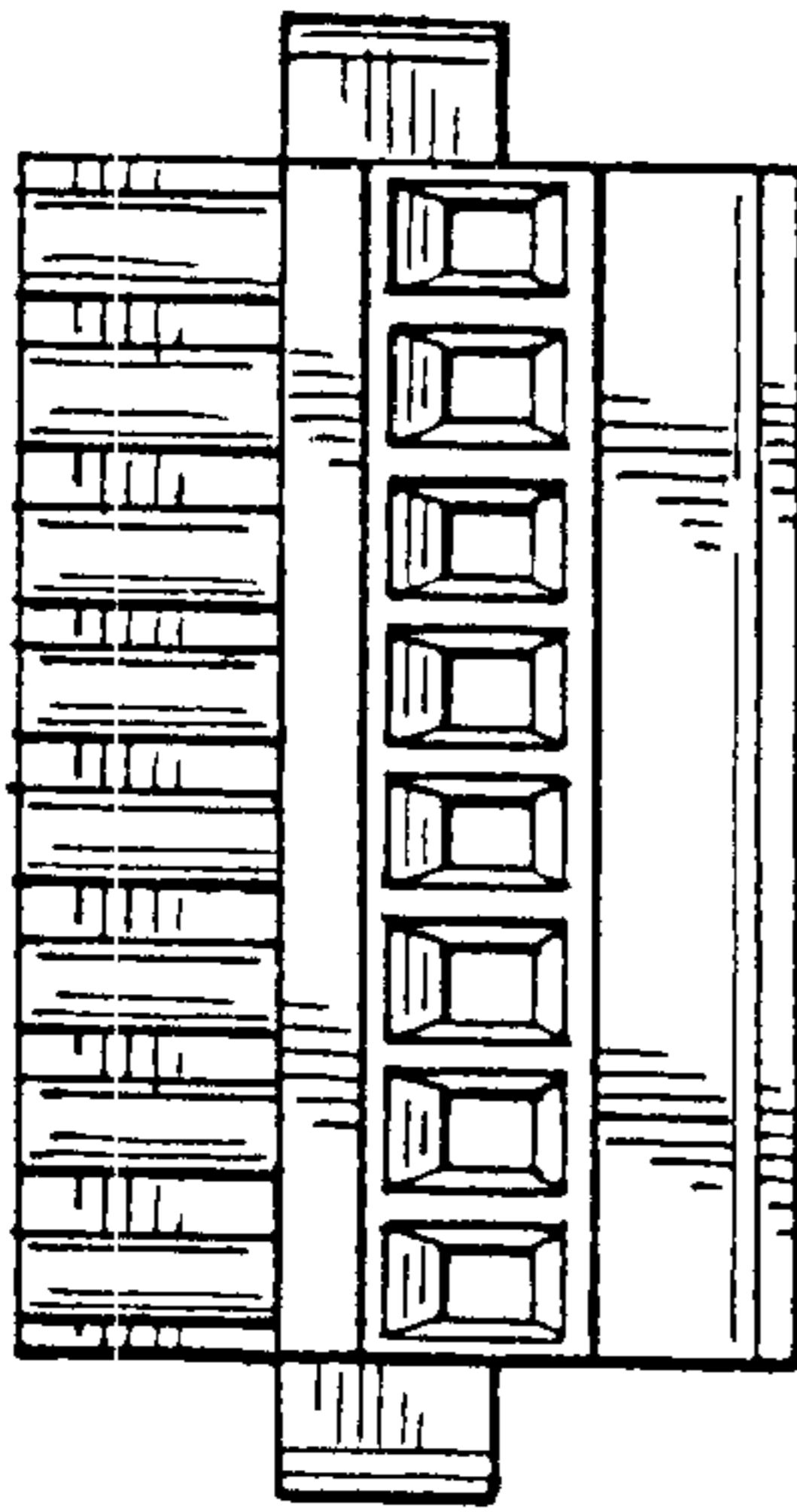

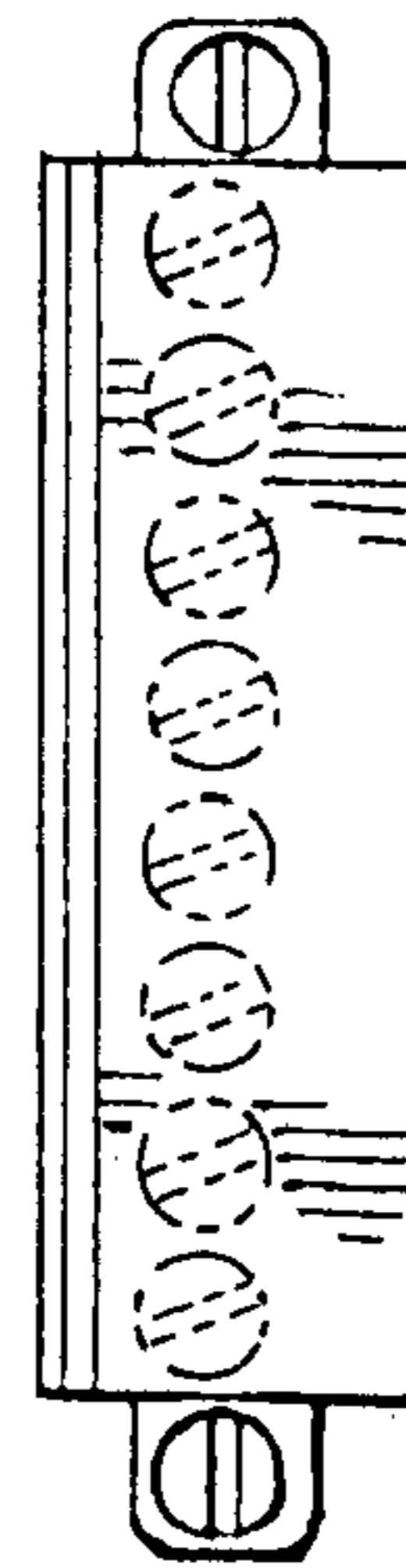

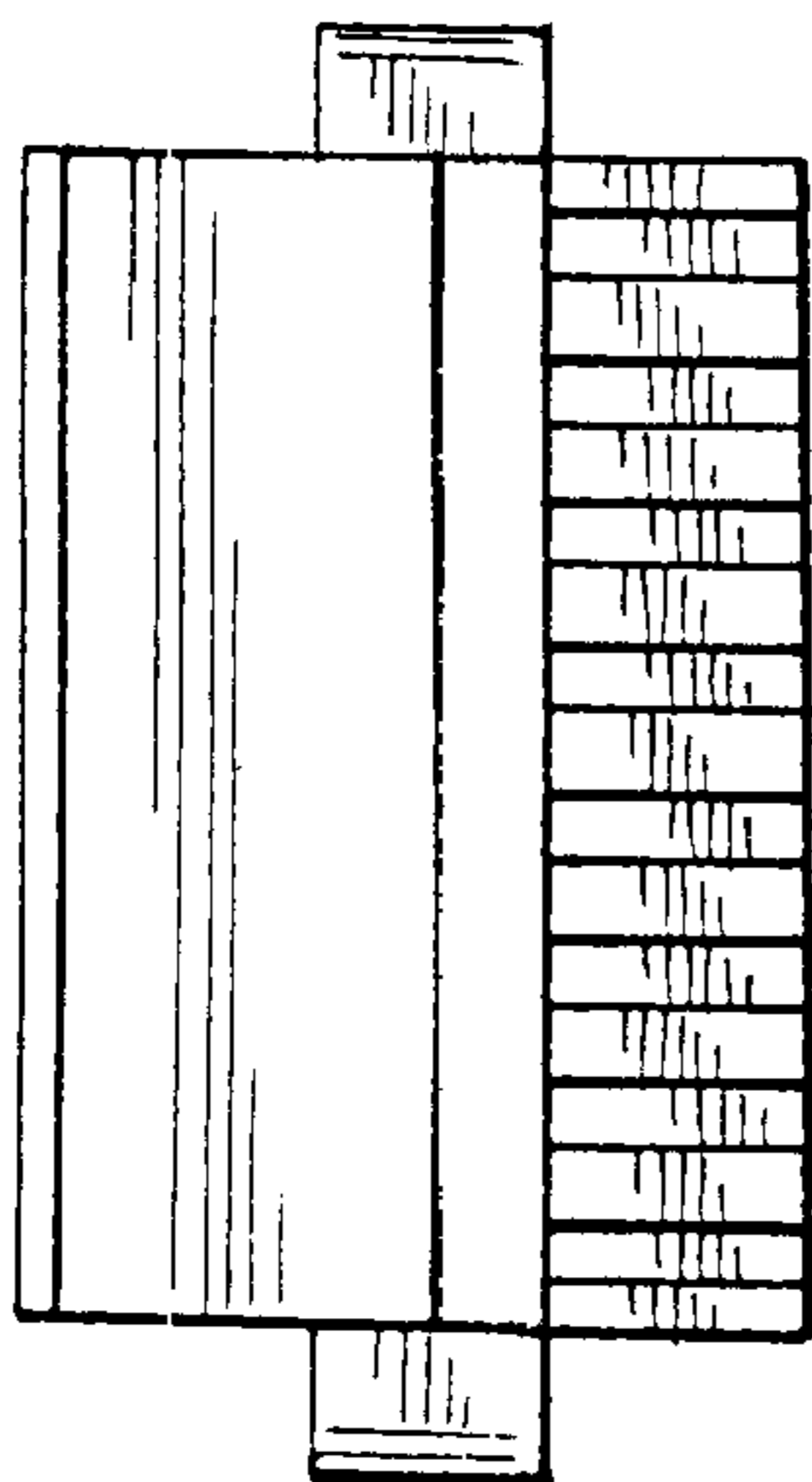

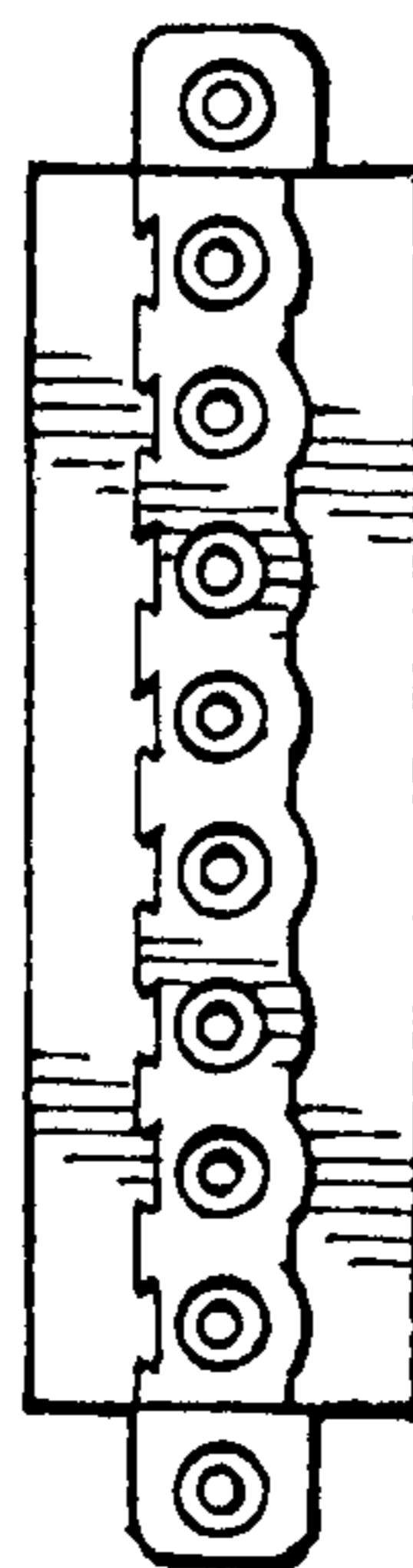

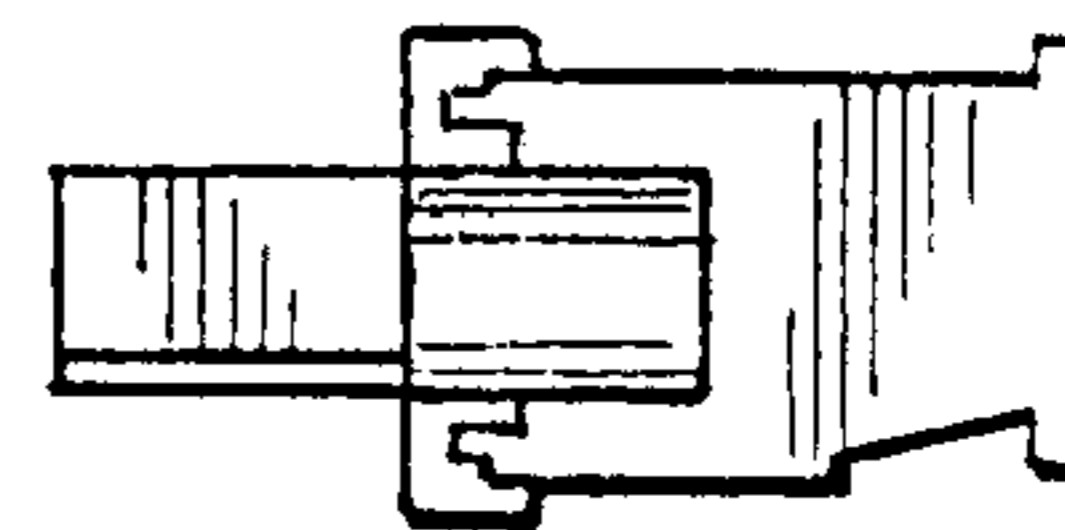
