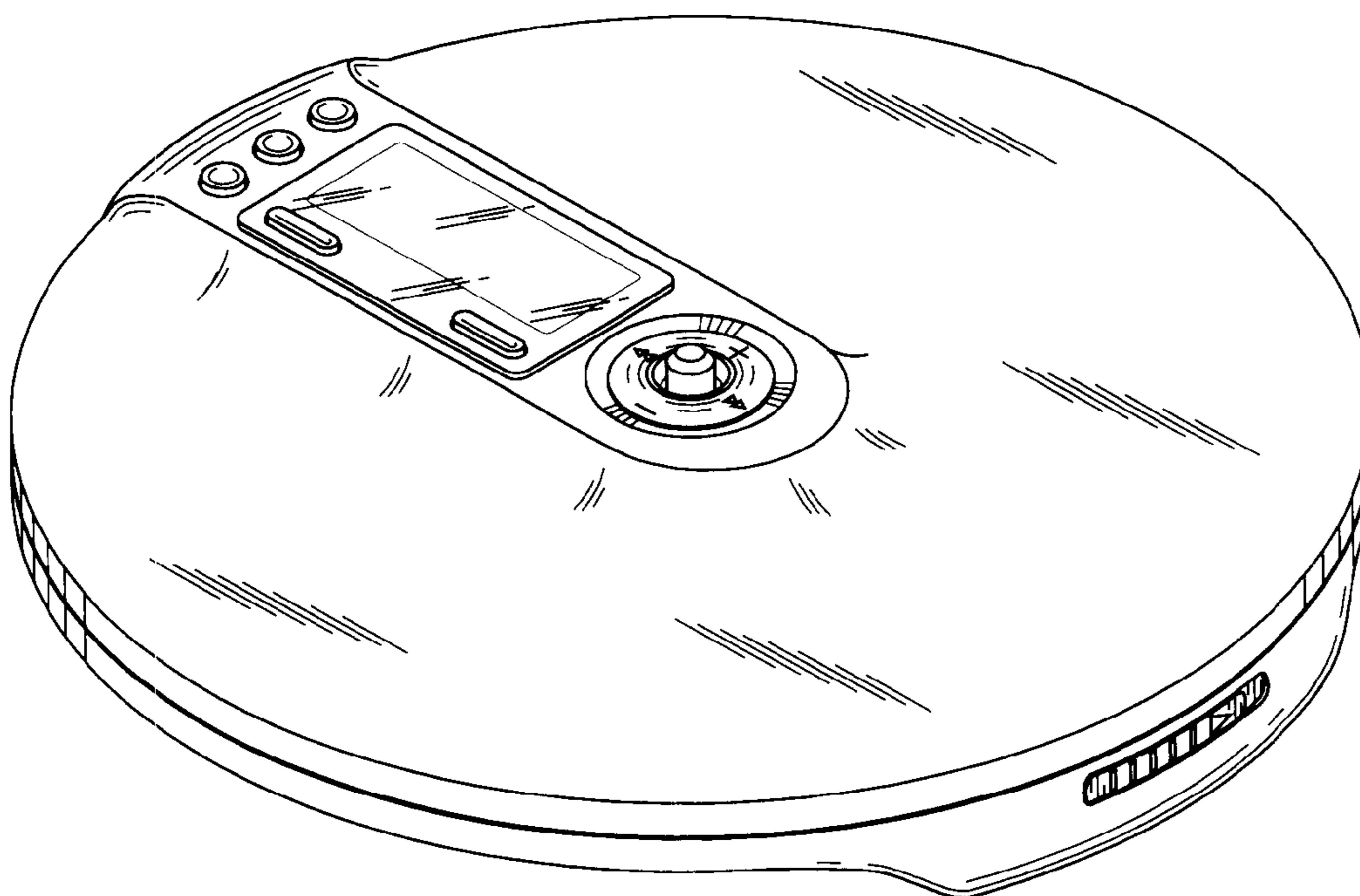
(57) **CLAIM**

The ornamental design for a portable CD/MP3 player, as shown and described.

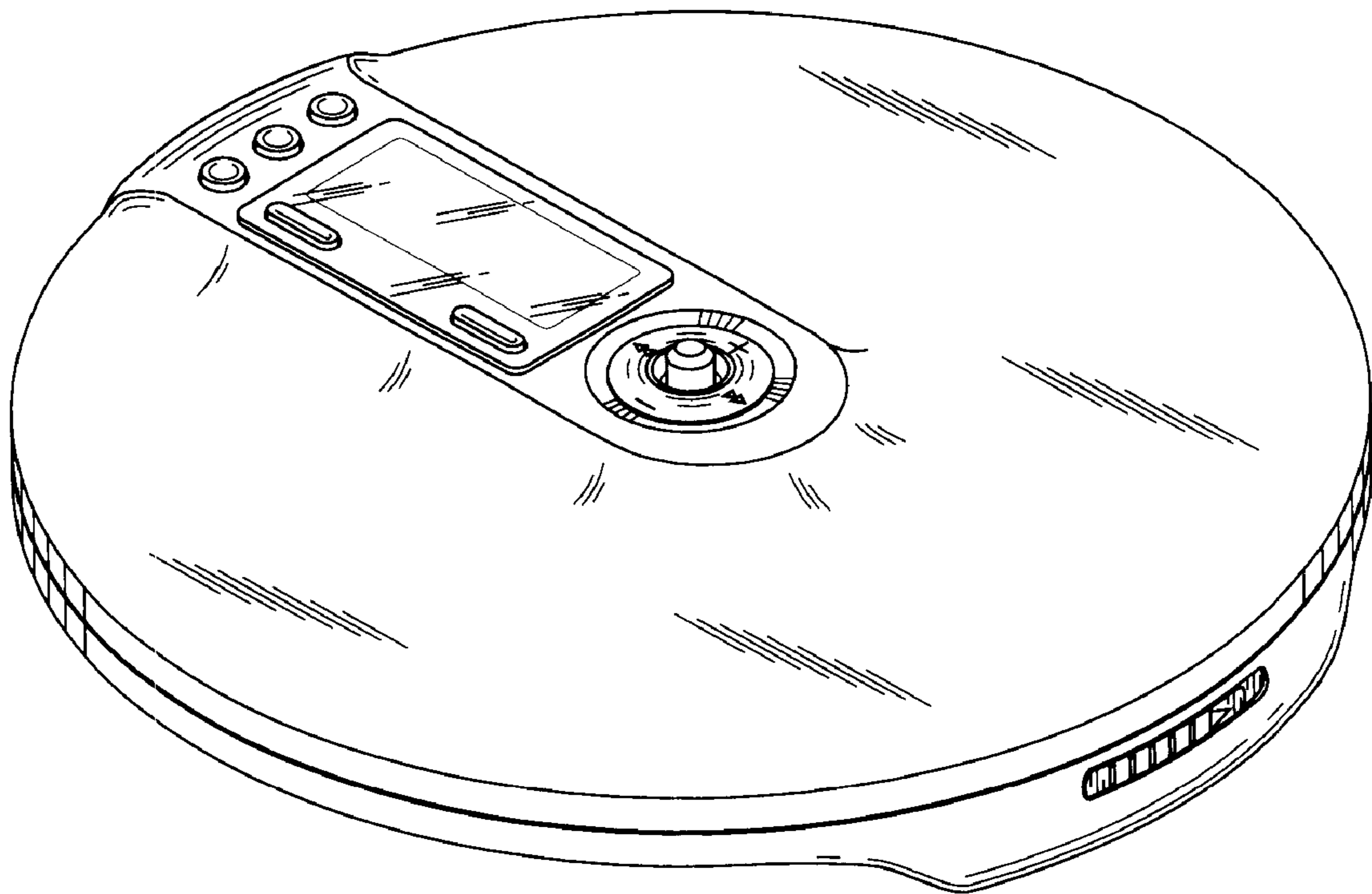
**DESCRIPTION**

FIG. 7 is a bottom plan view thereof.

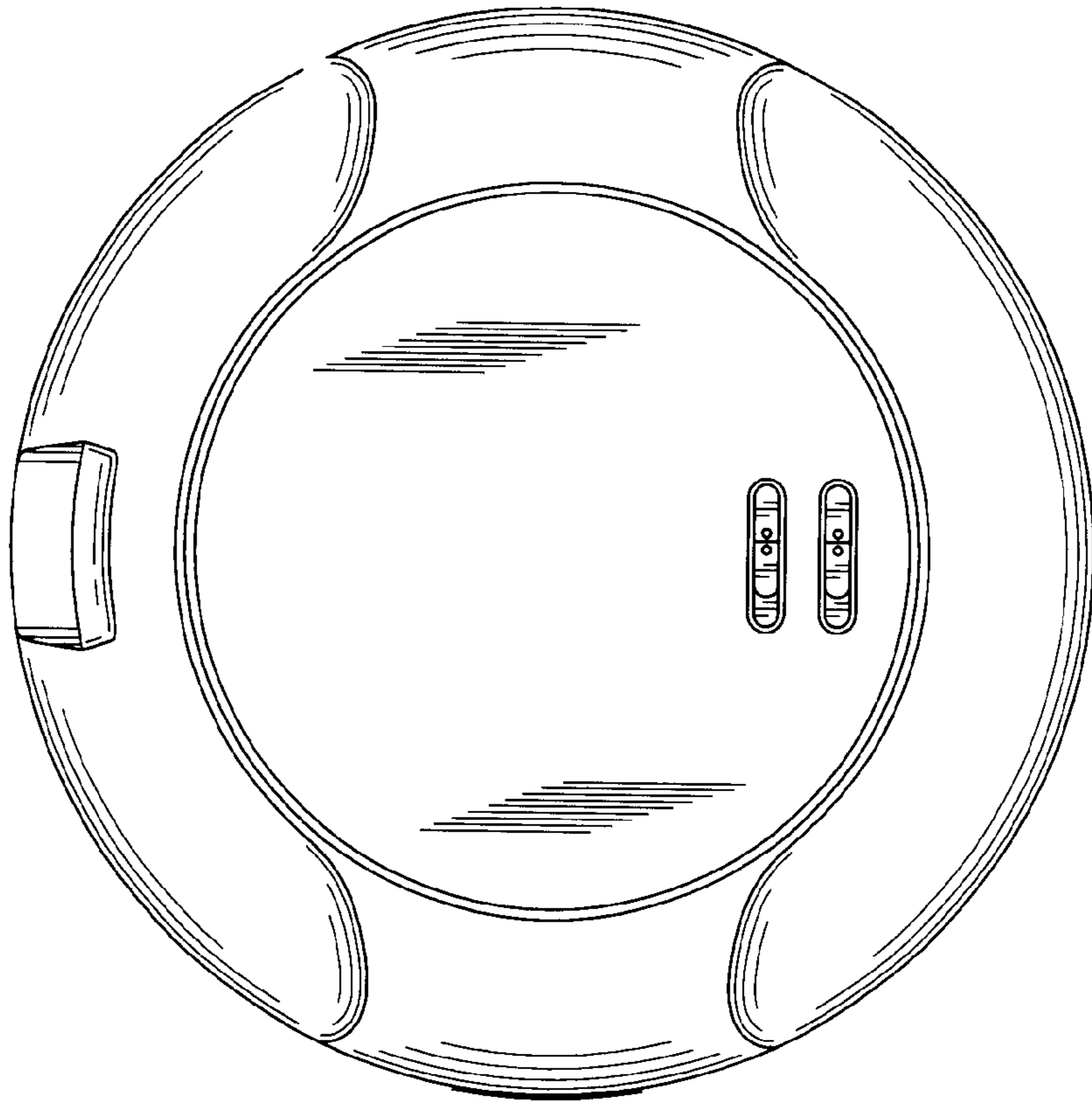

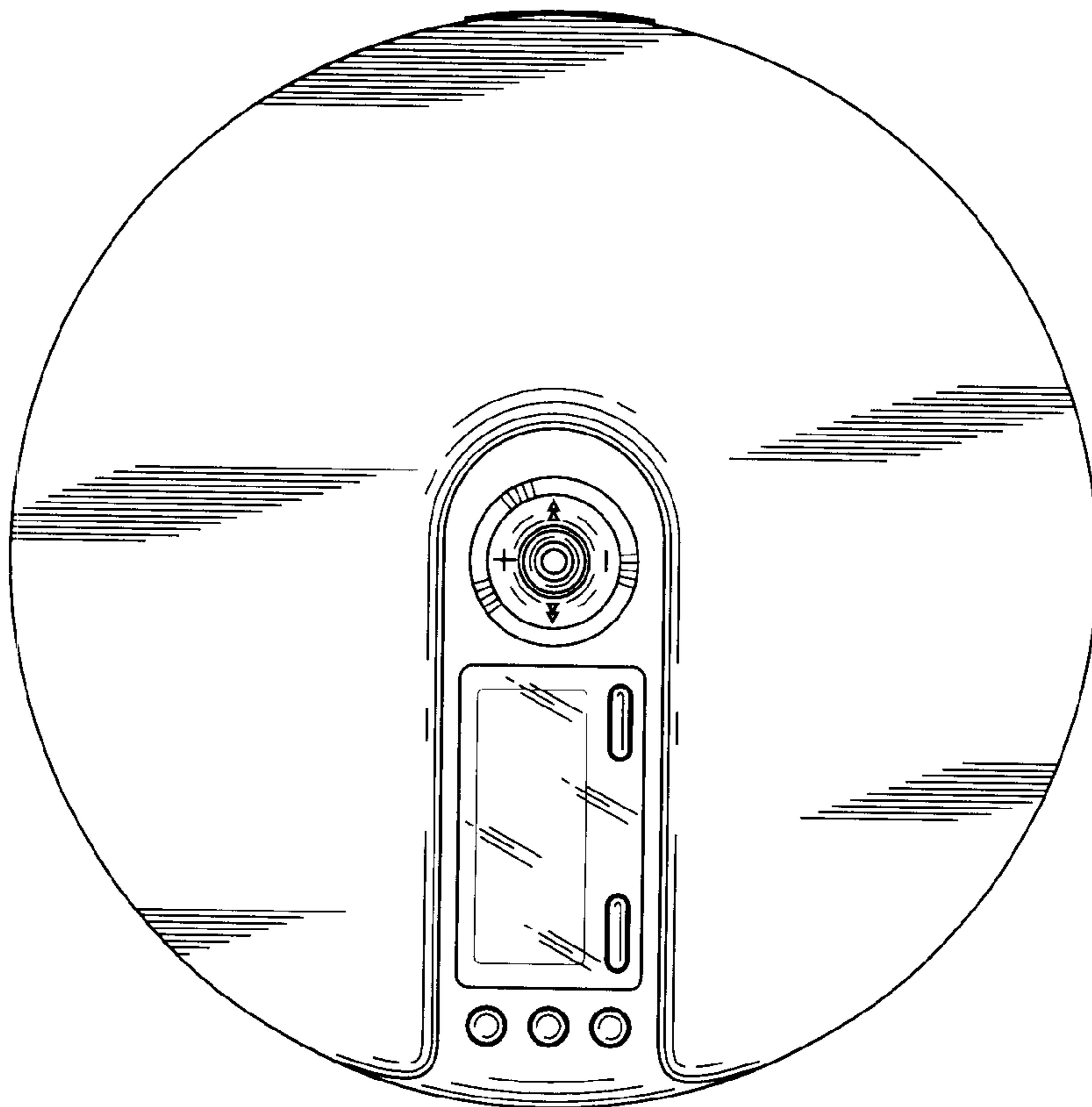

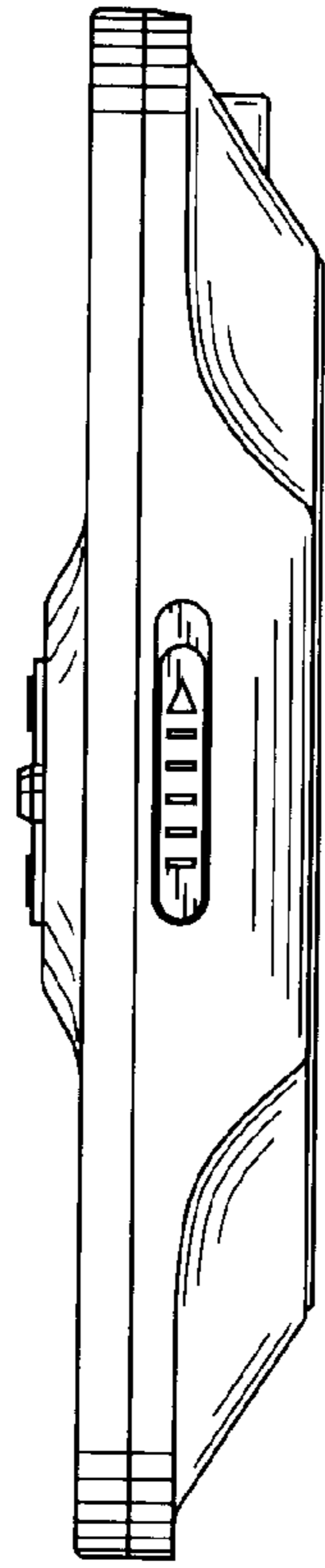

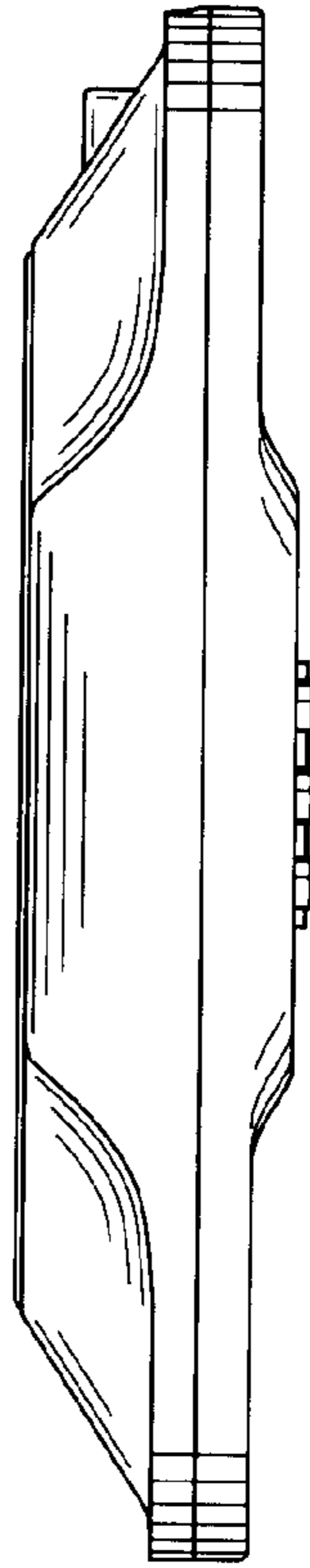

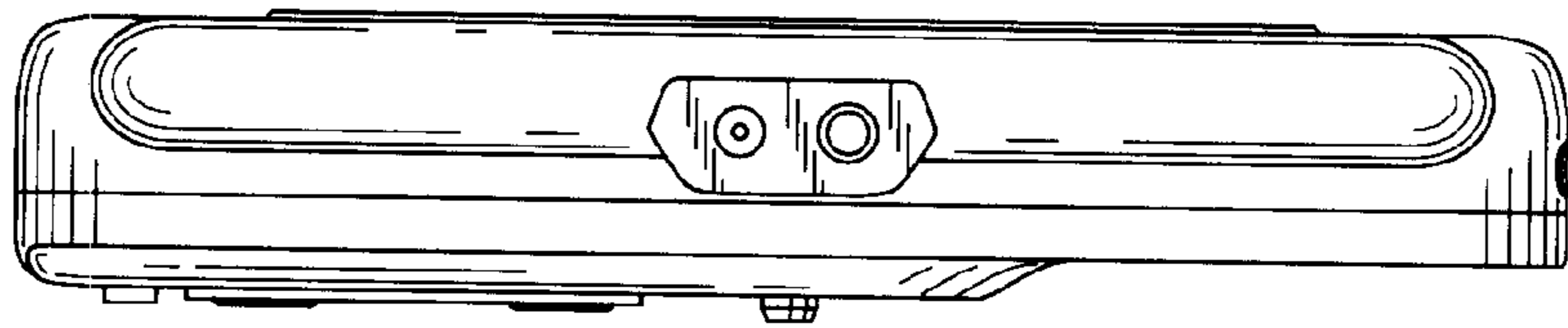
