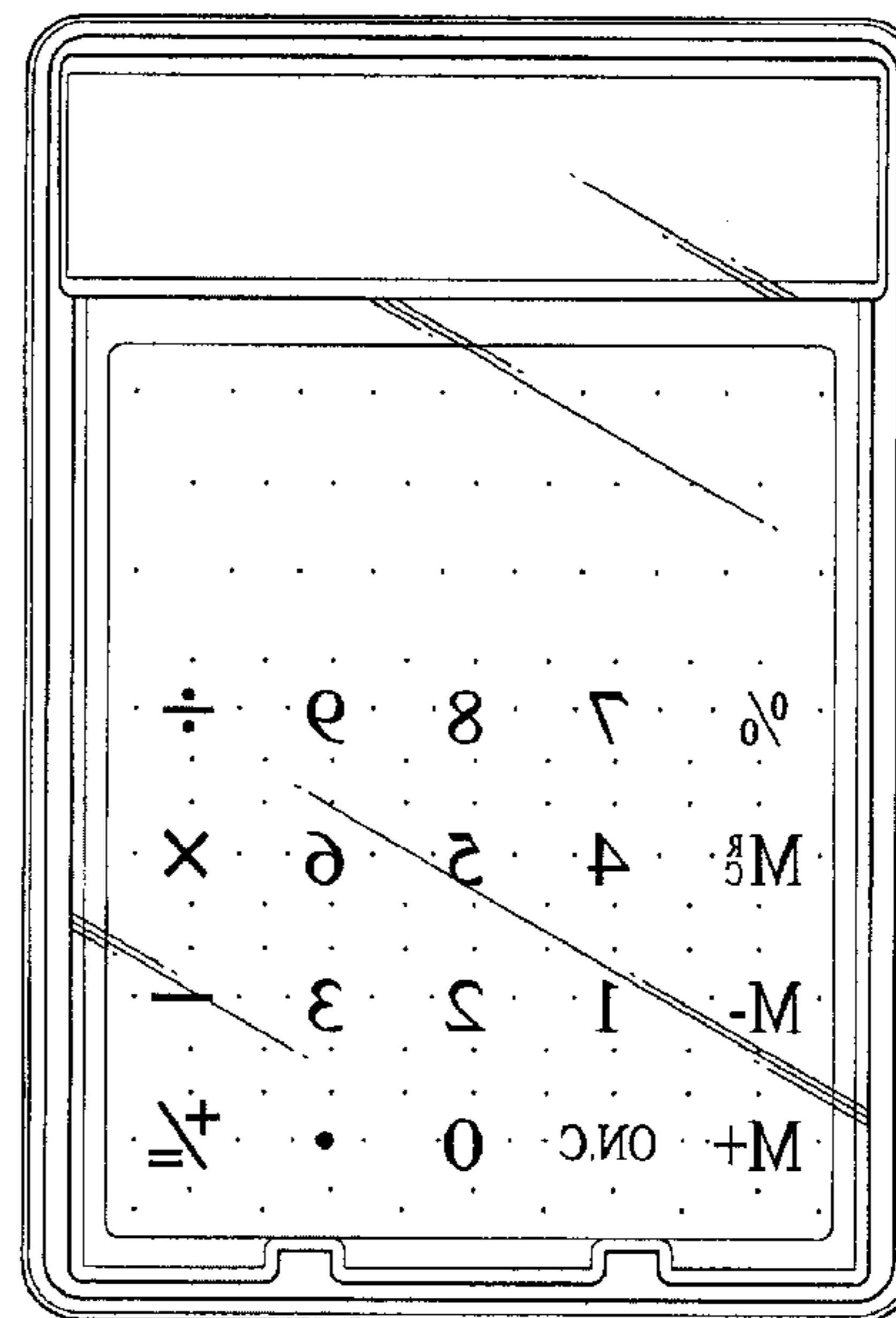
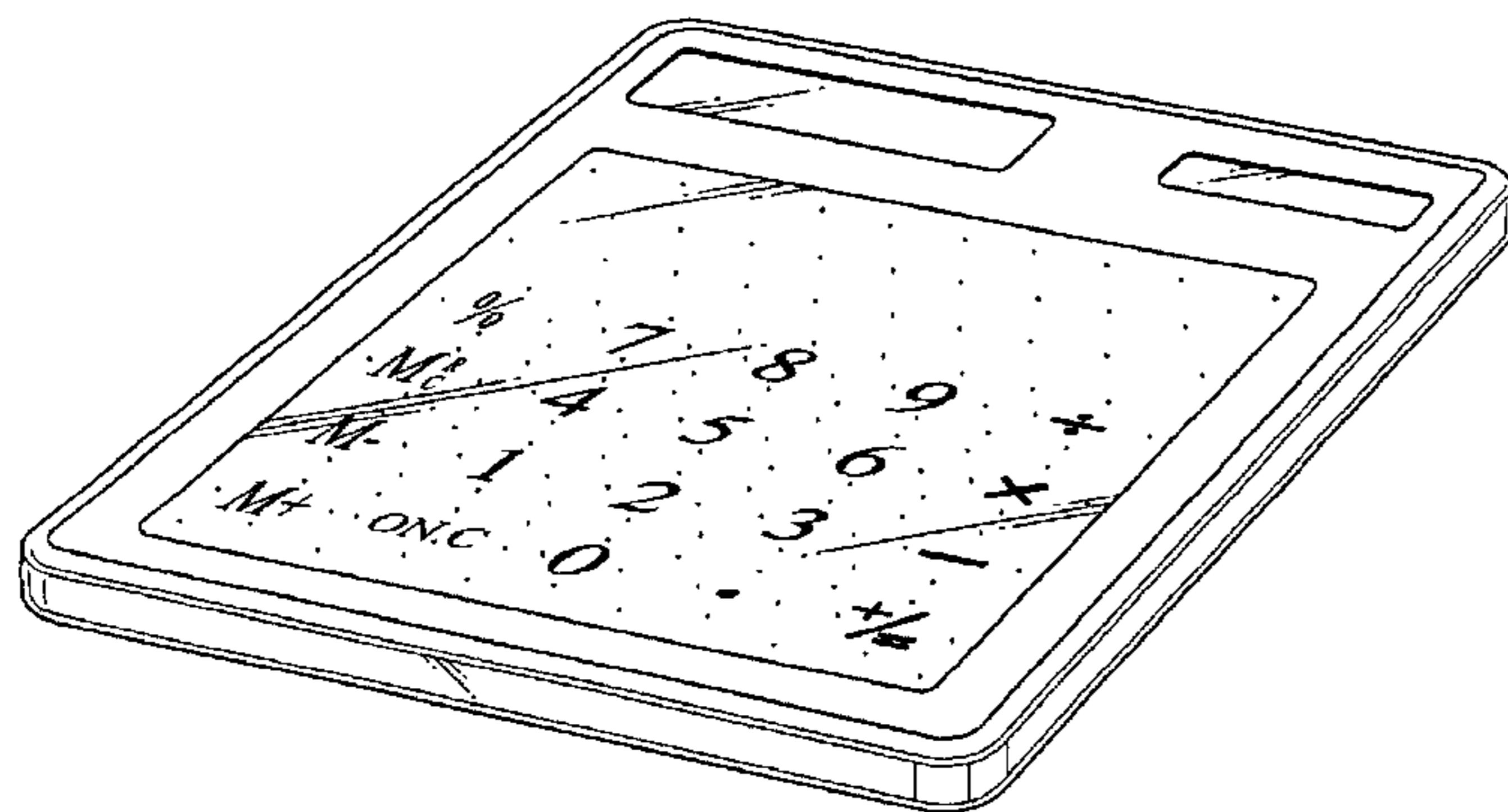

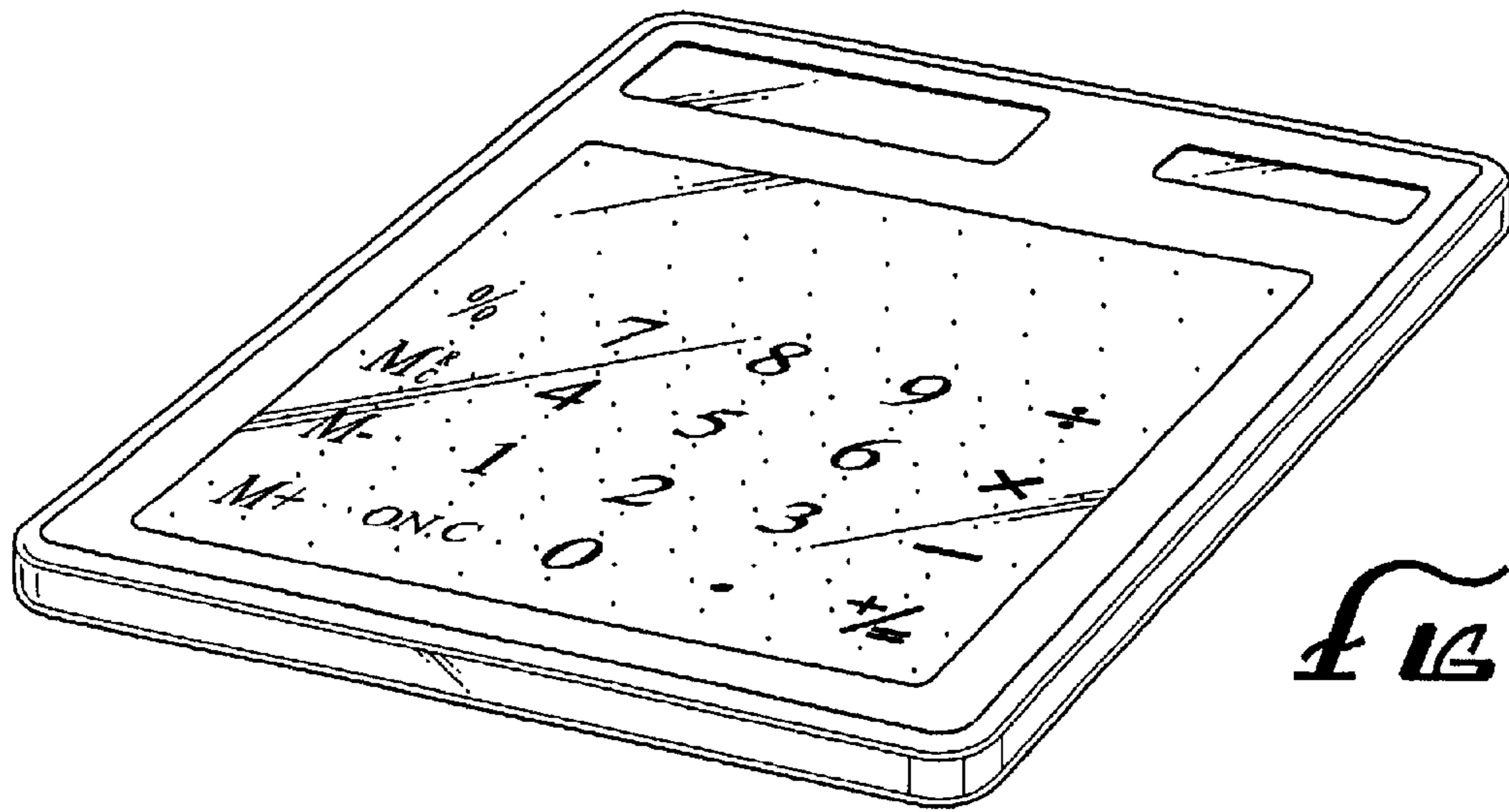
The ornamental design for a calculator, as shown and described.

**DESCRIPTION**

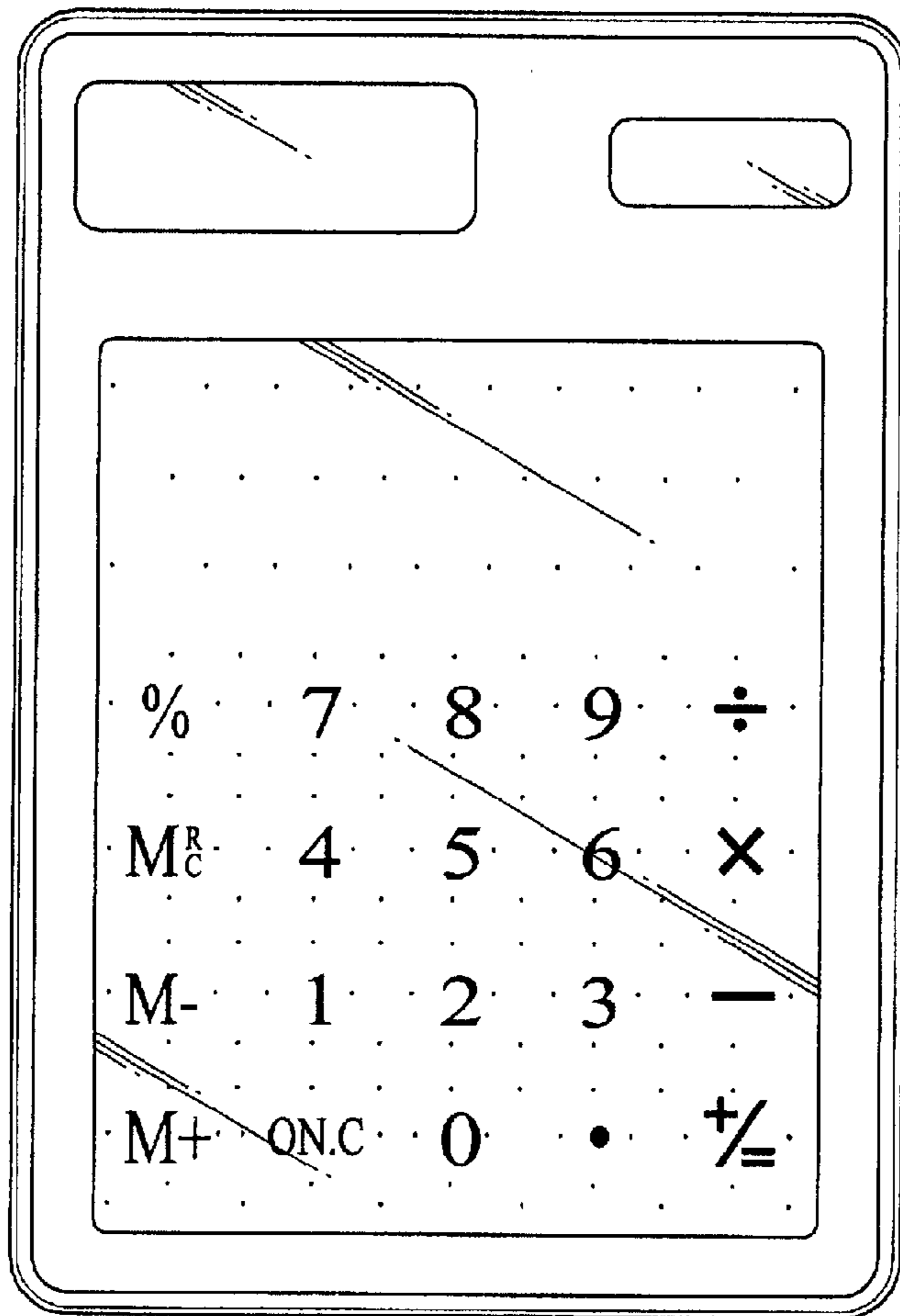
FIG. 1 is a front perspective view of a calculator;

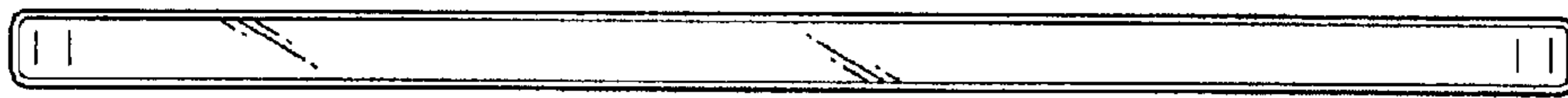

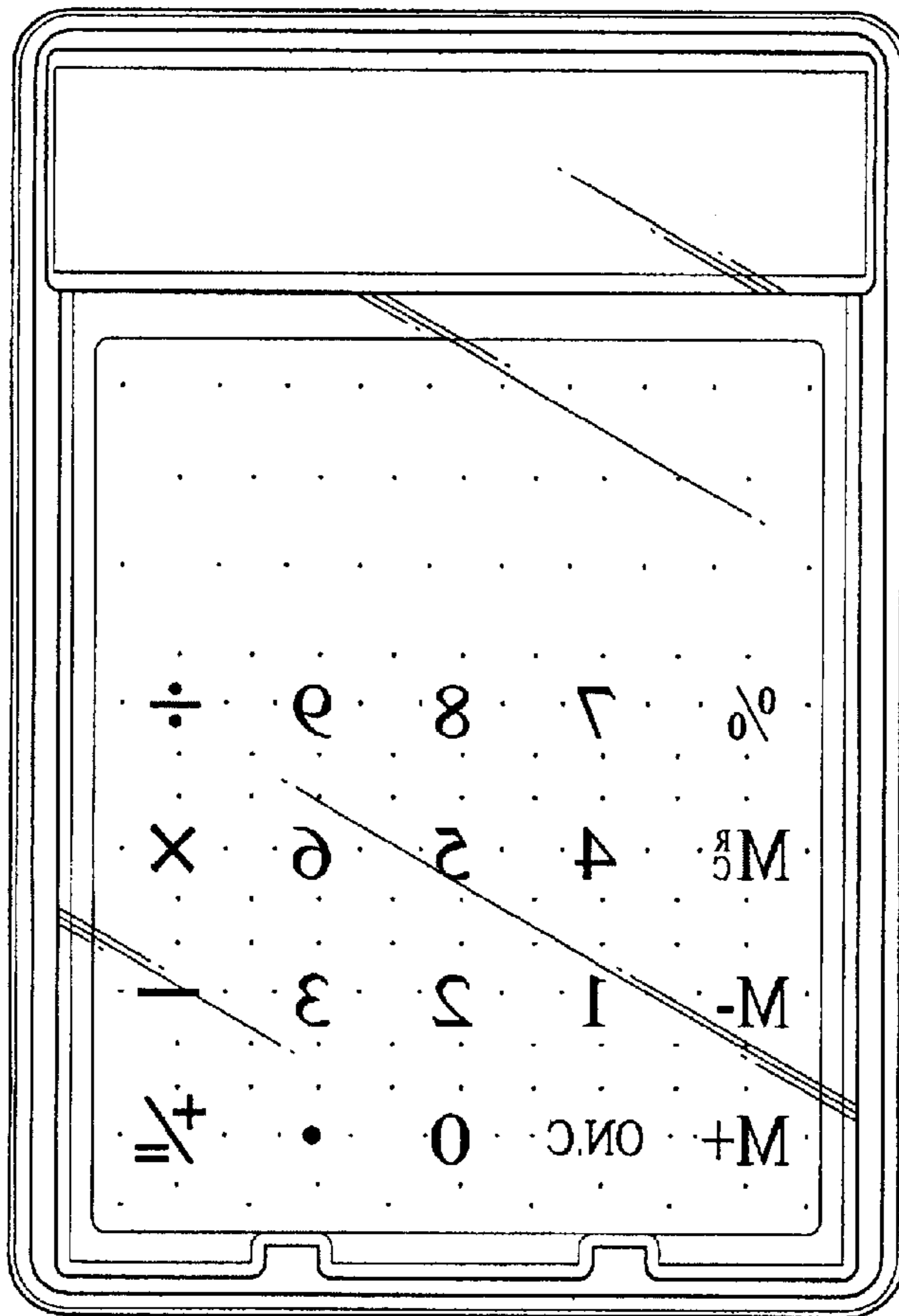
