(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is a handle for a plumbing fixture such as a faucet.

FIG. 1 is a left, top, front perspective view of a handle embodying my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view thereof of being a mirror image of the front view shown;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a left, top, front perspective view of a handle according to another embodiment of my new design;

FIG. 8 is a front elevational view thereof, the rear elevational view thereof of being a mirror image of the front view shown;

FIG. 9 is a left side elevational view thereof;

FIG. 10 is a right side elevational view thereof;

FIG. 11 is a top plan view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 illustrates the FIG. 7 embodiment with faucet environment; and,

FIG. 14 illustrates the FIG. 7 embodiment with tub/shower control environment.

The broken line representations of handle and/or handle escutcheon structure in the figures and of faucet and tub/shower control environment in respective FIGS. 13 and 14 are for the purpose of illustration only, and form no part of the claimed design.

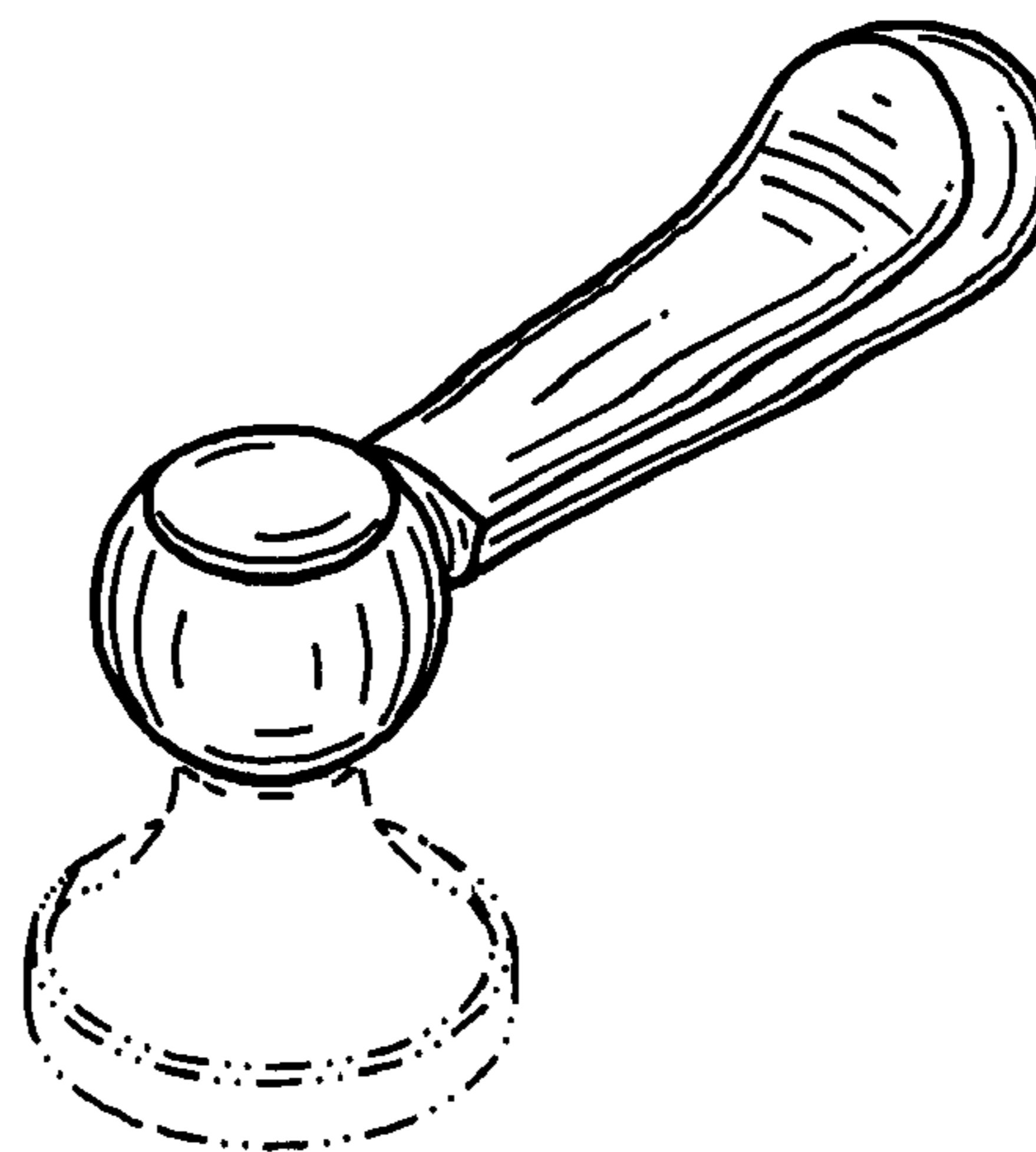
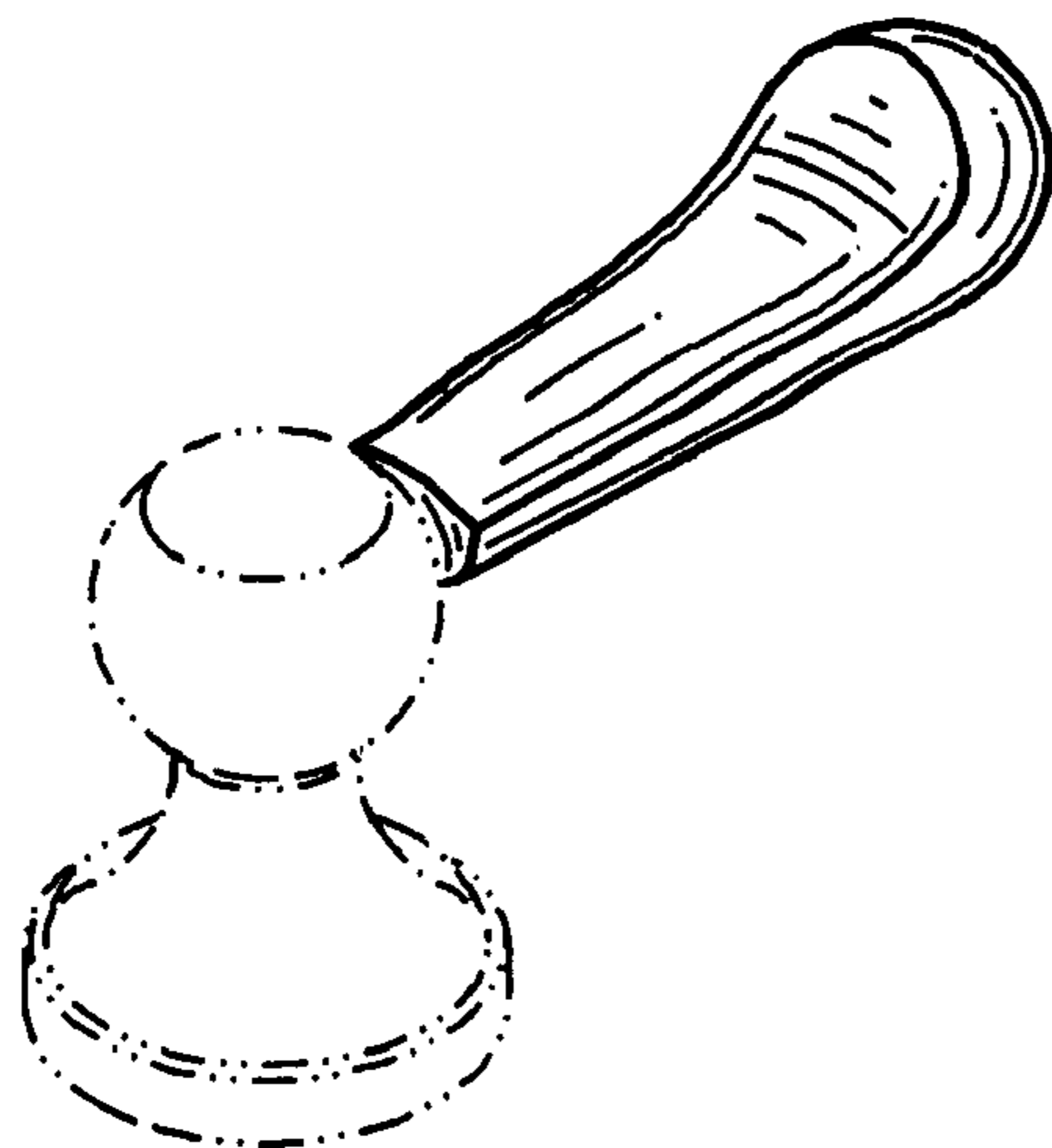

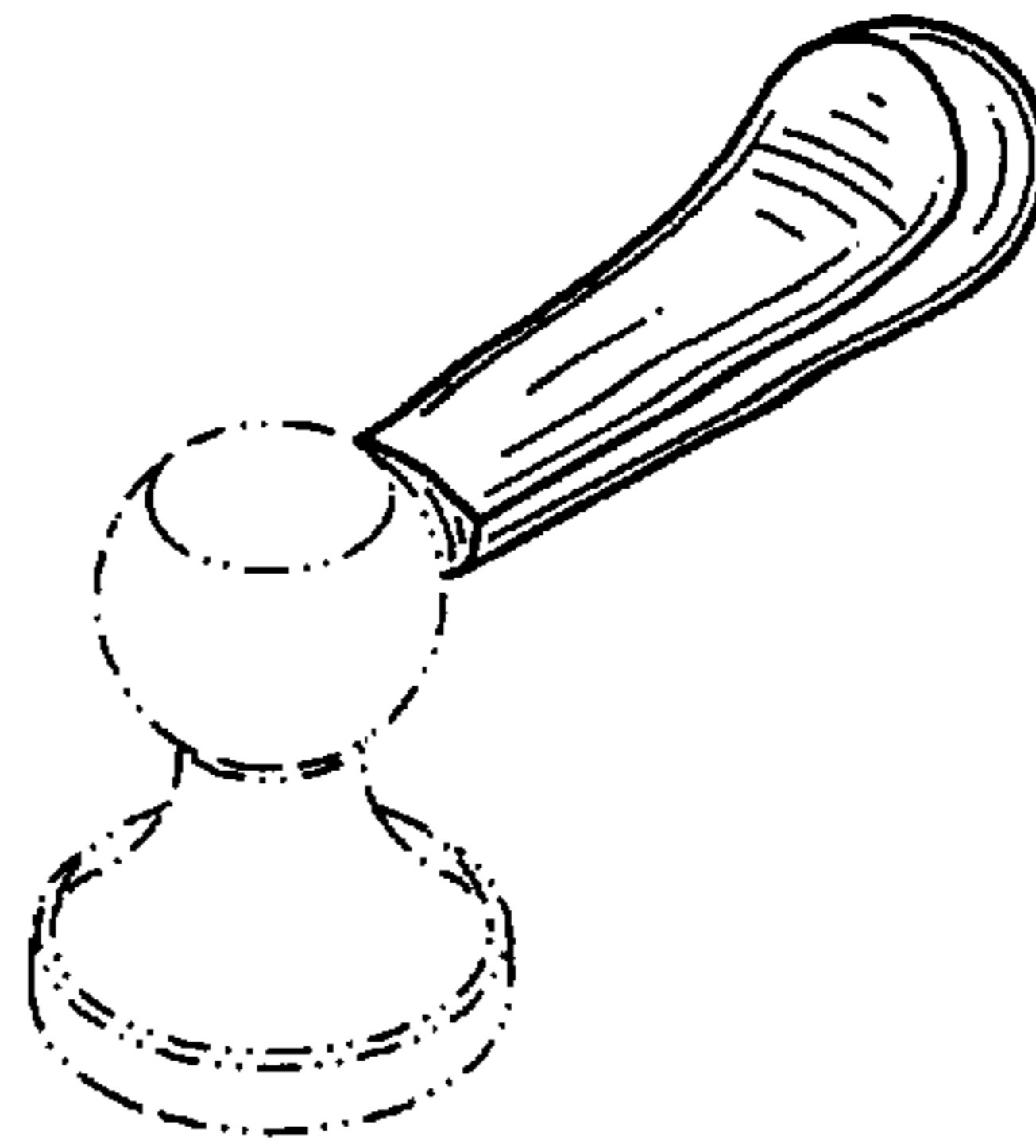

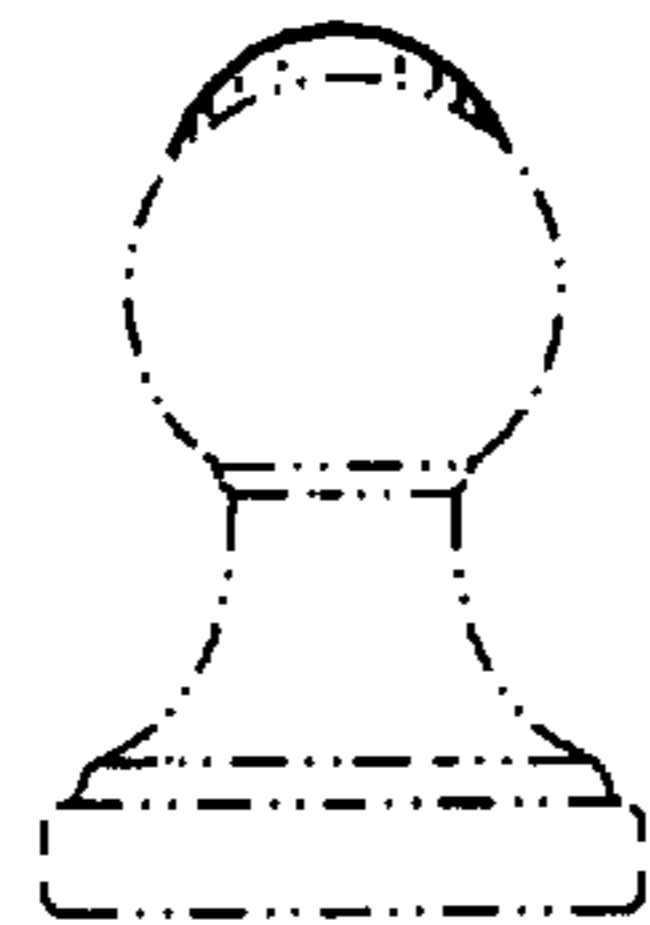
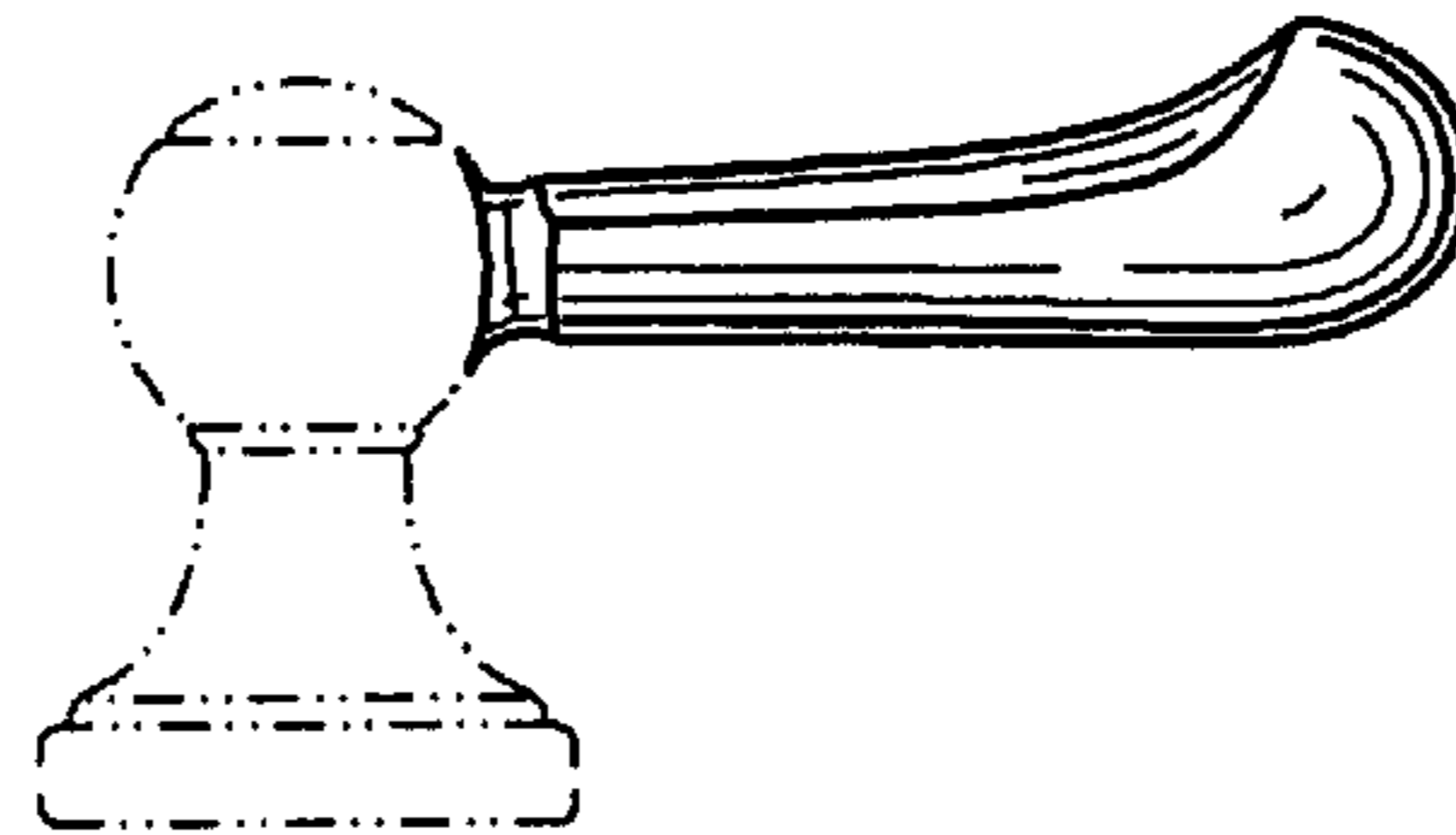

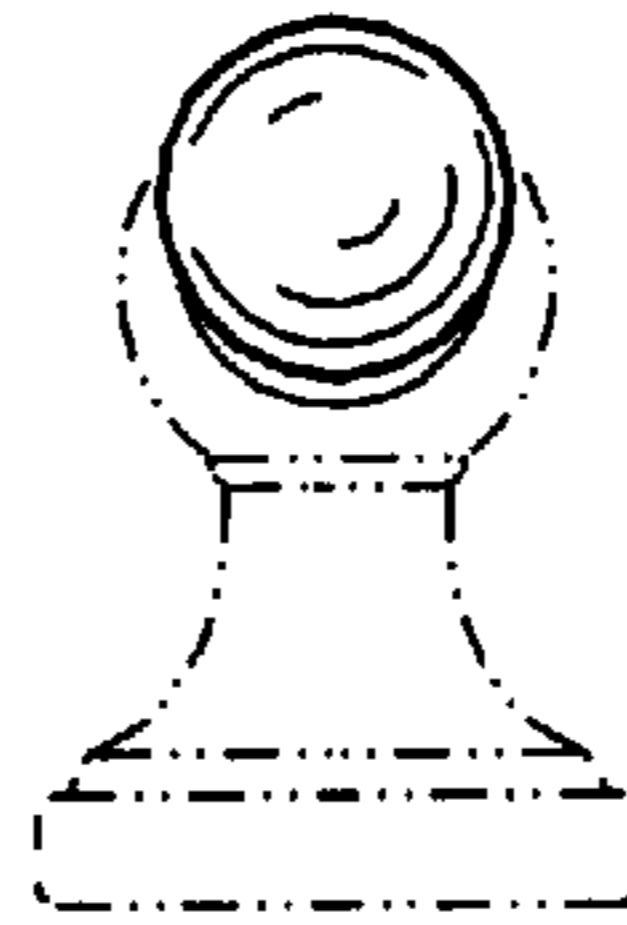

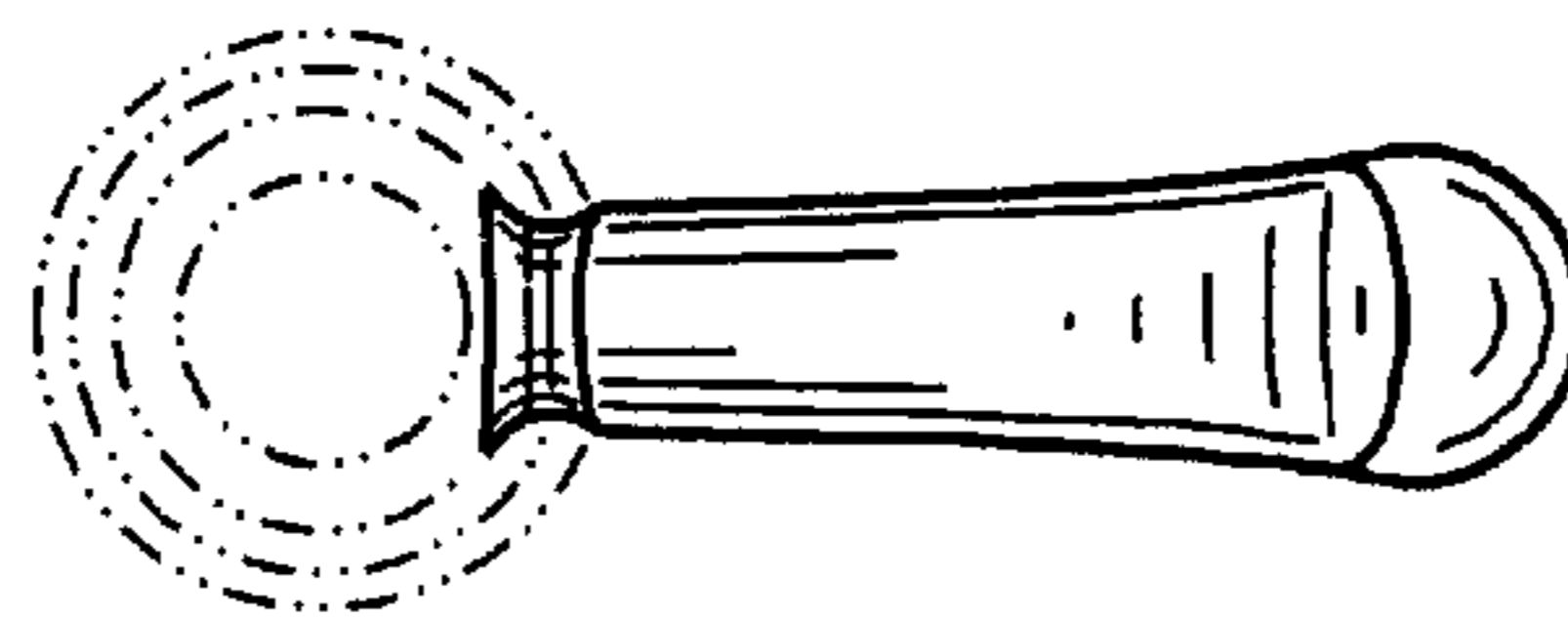

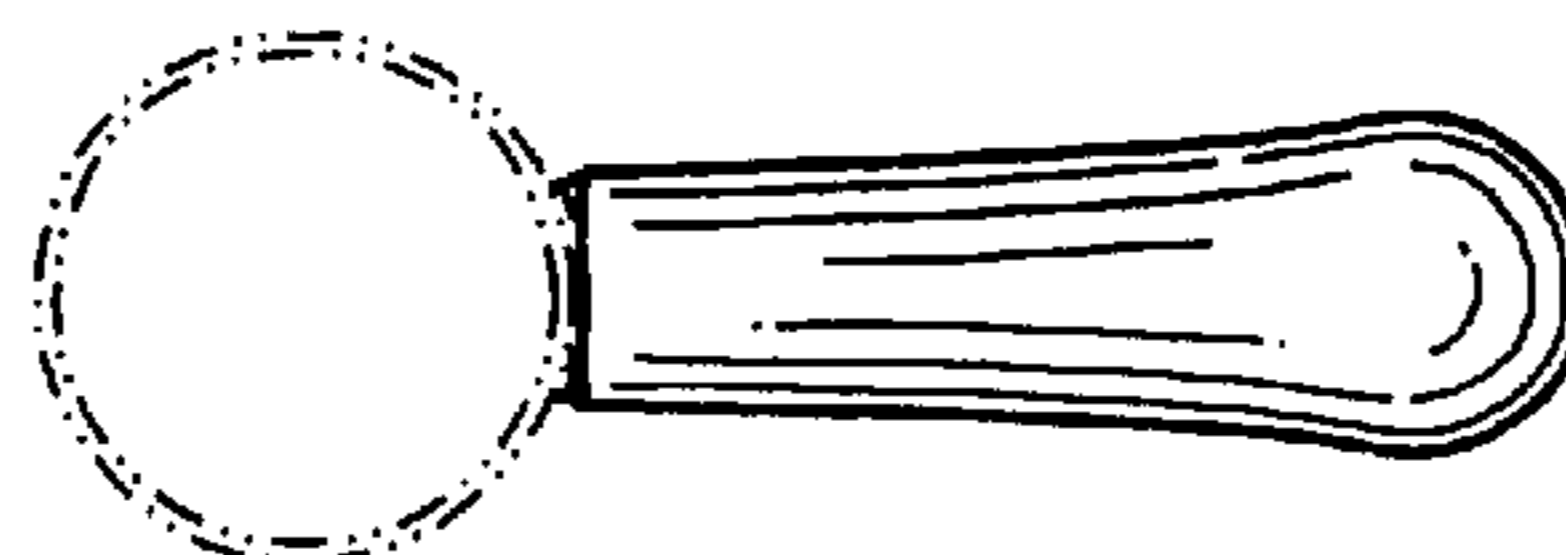

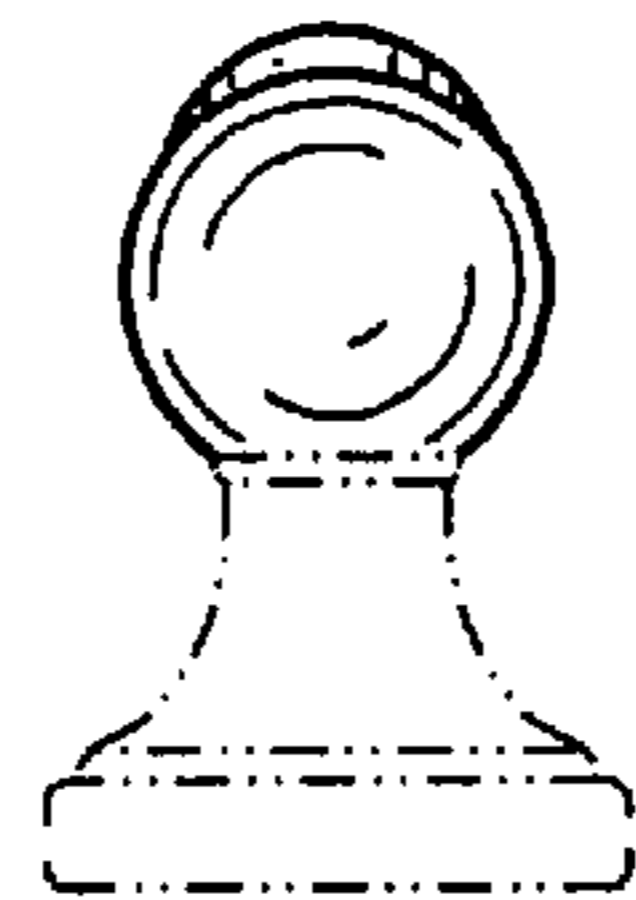
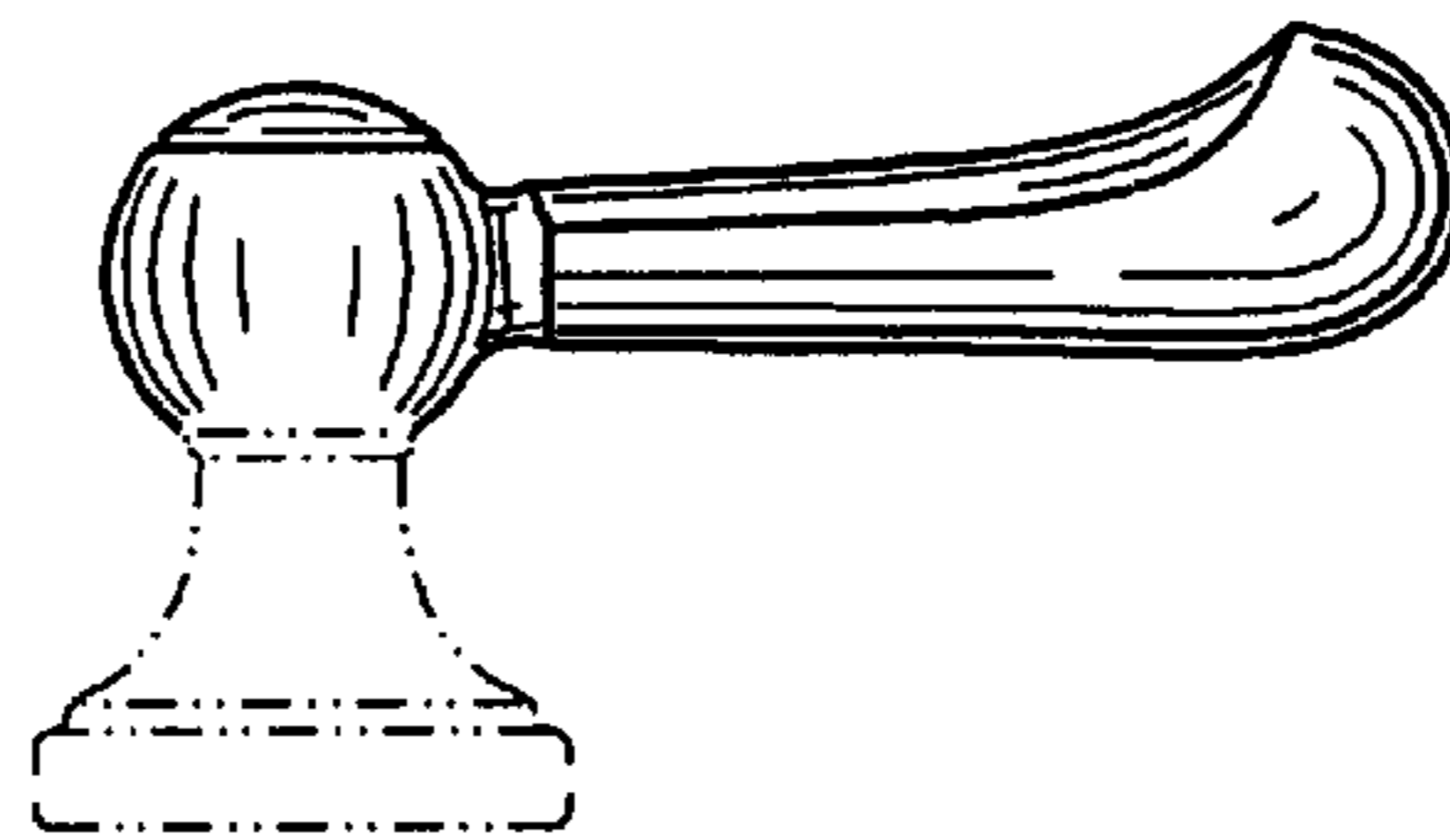

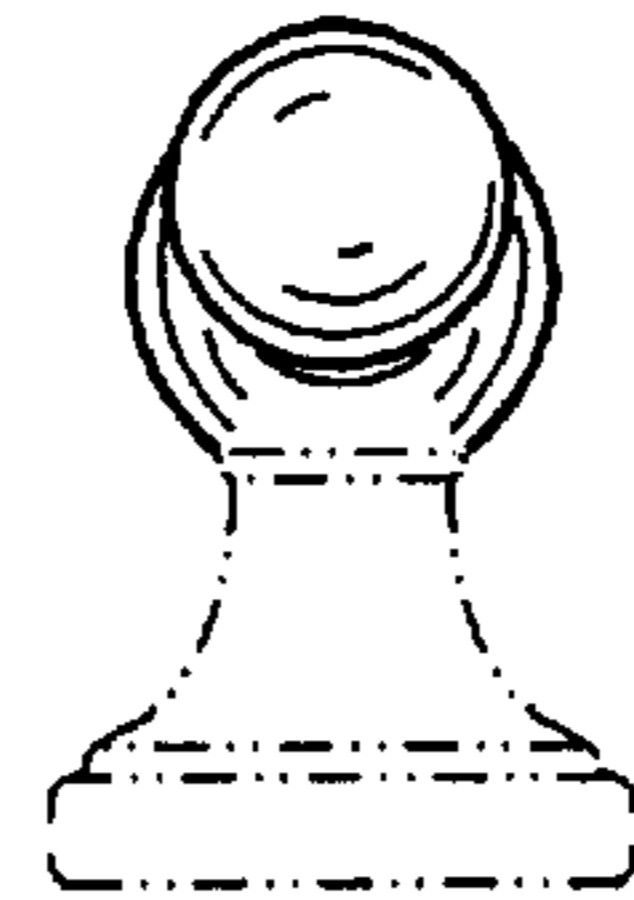

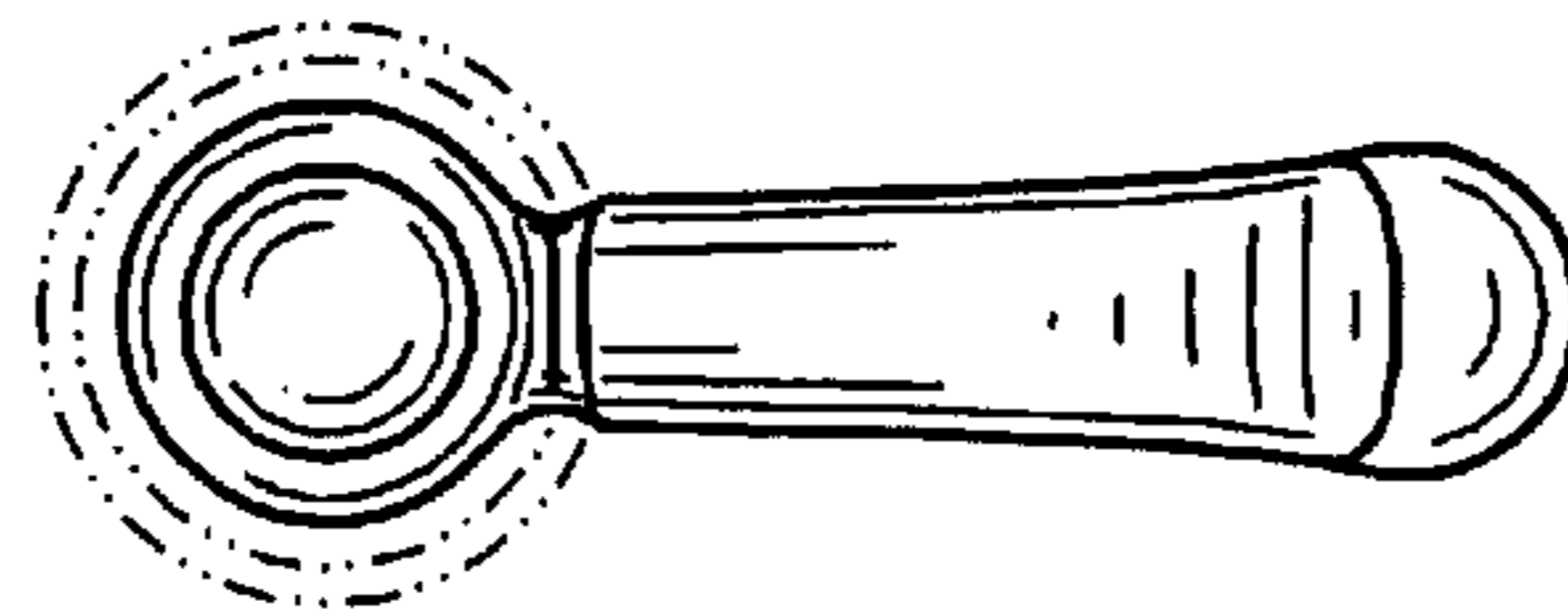
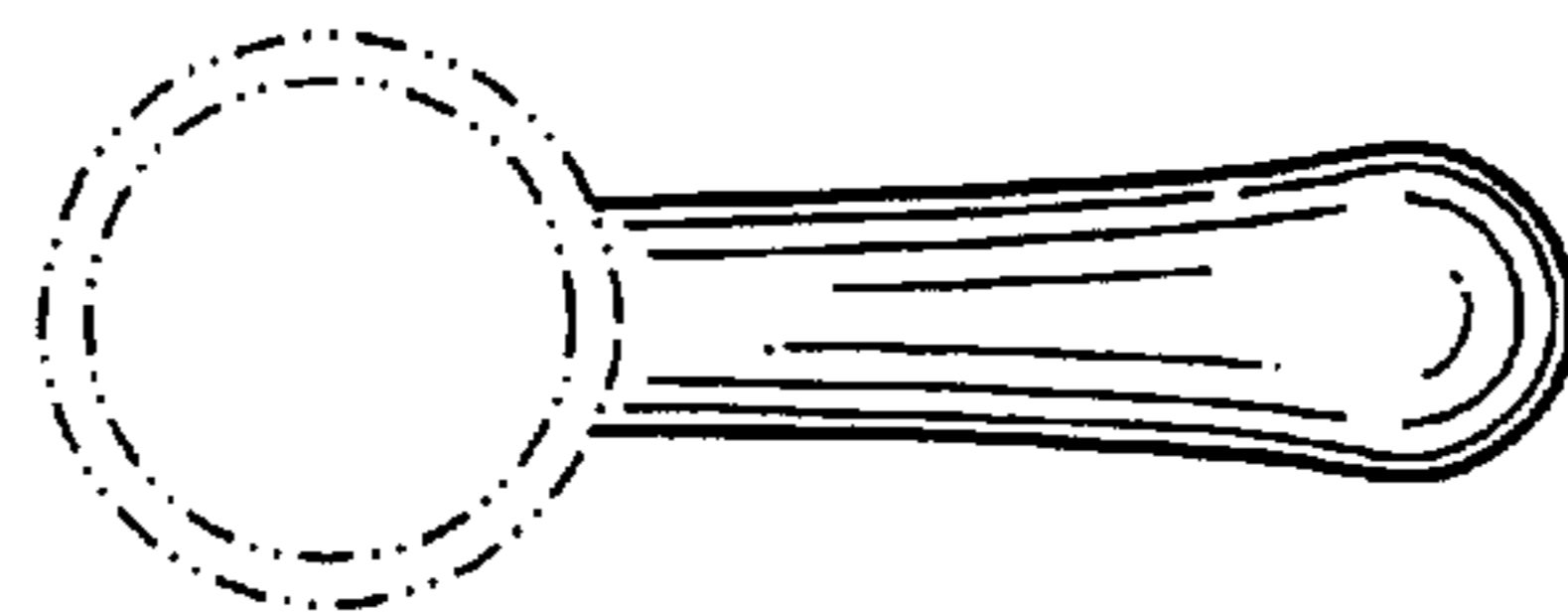

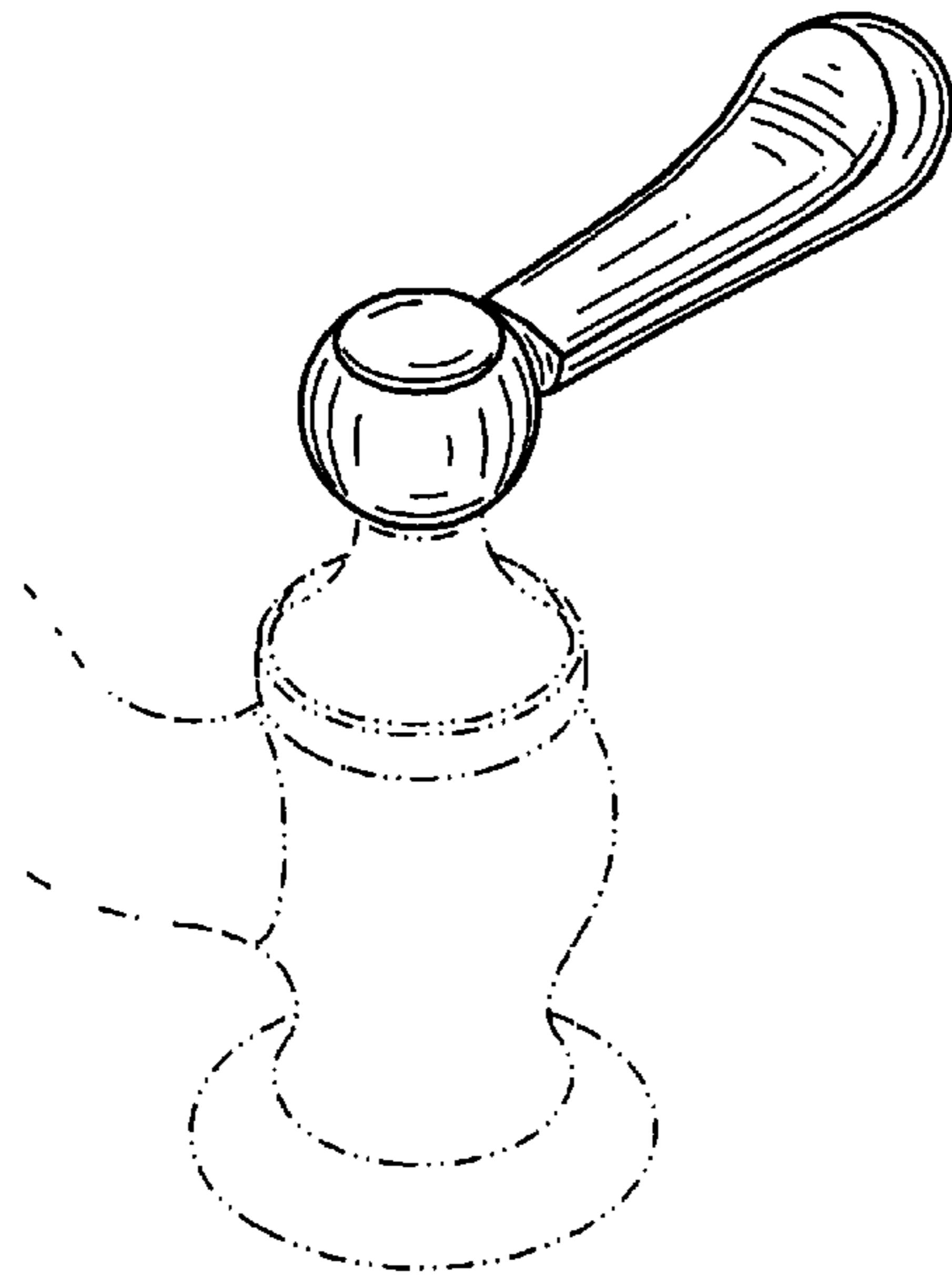

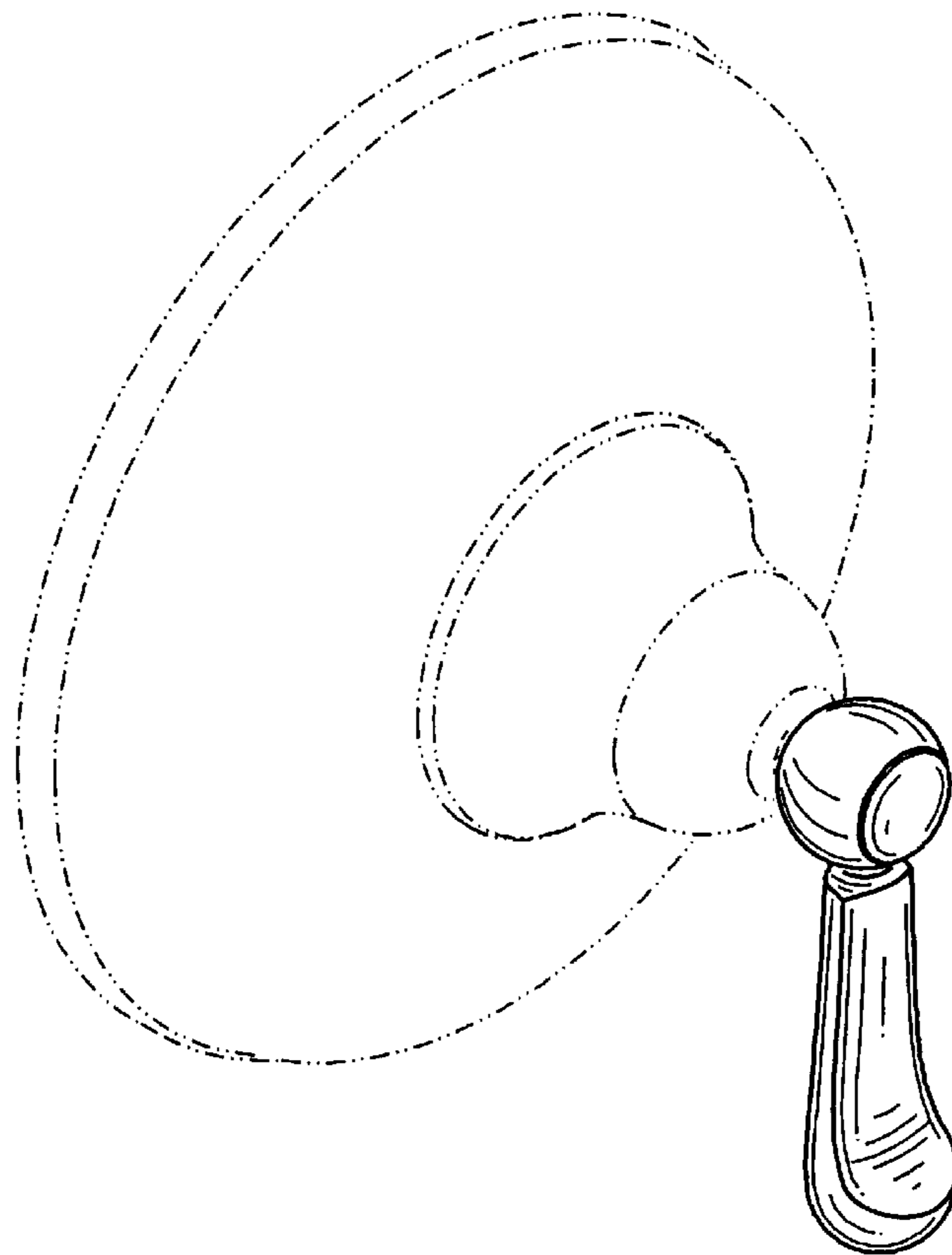
