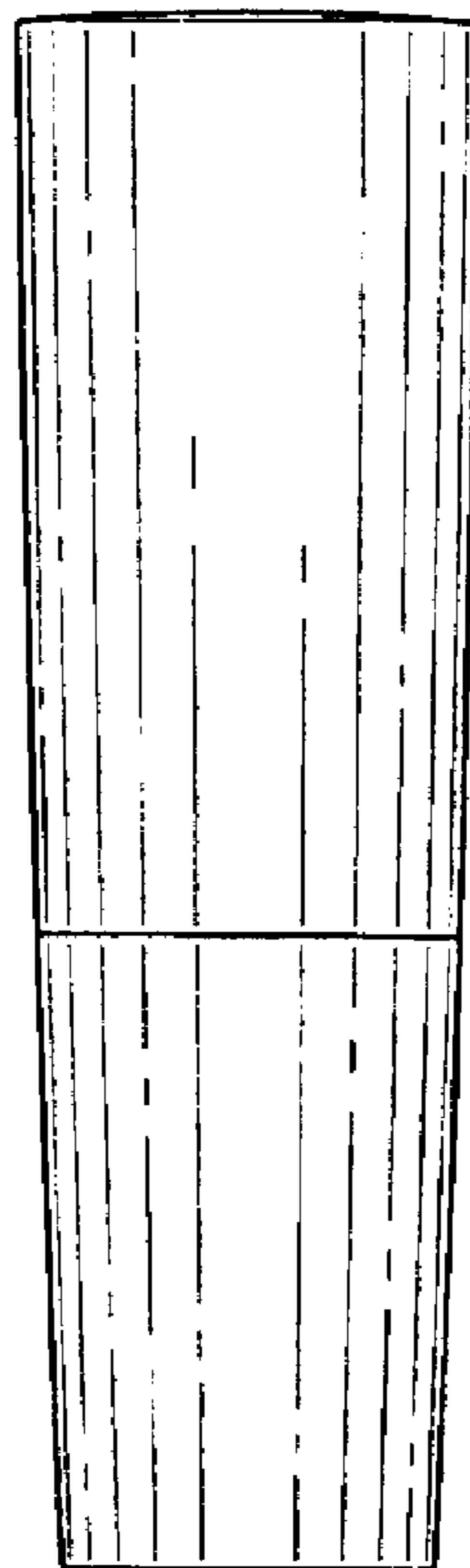
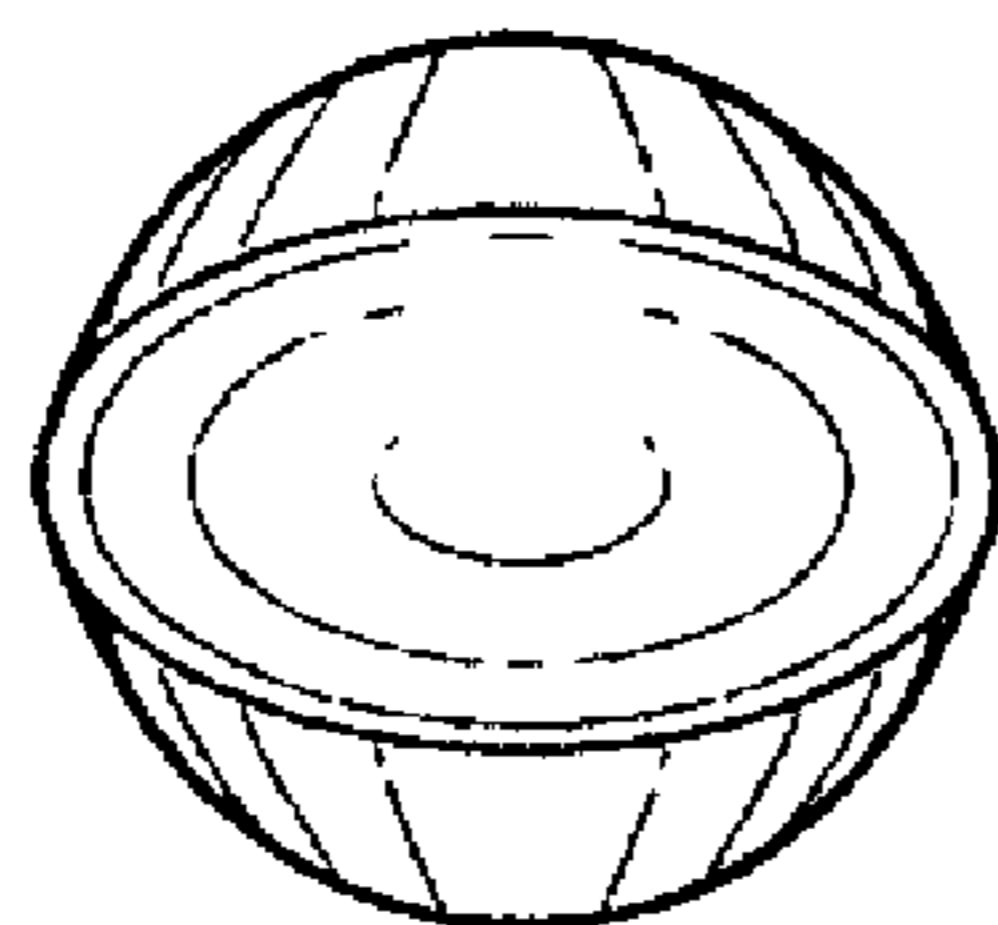
FIG. 2 is a top view of the cosmetic container of FIG. 1;

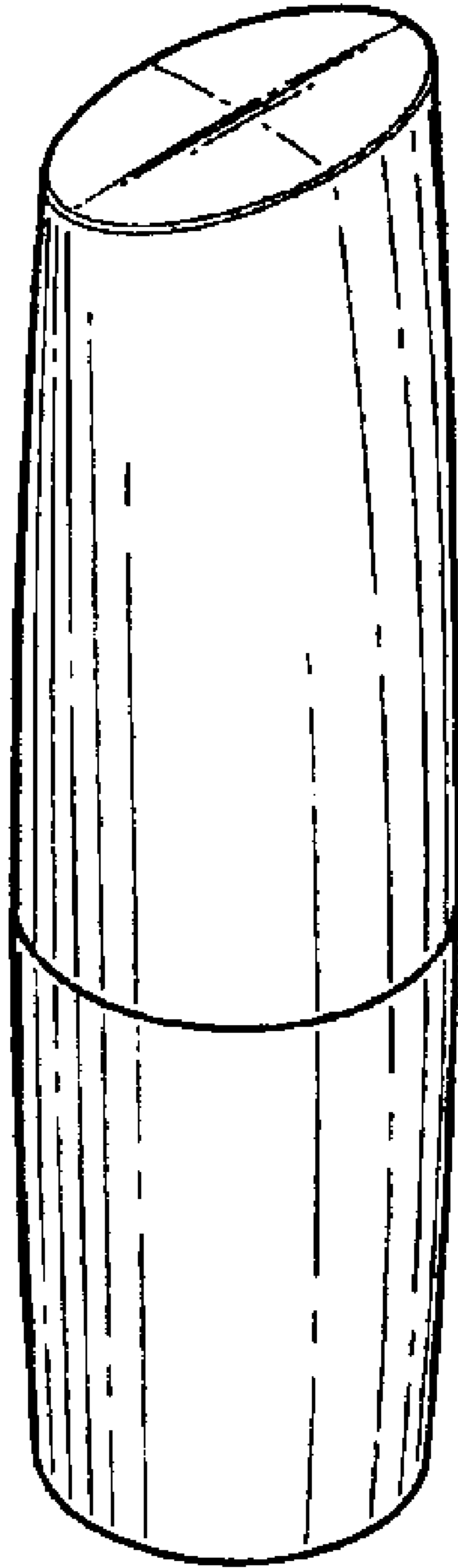

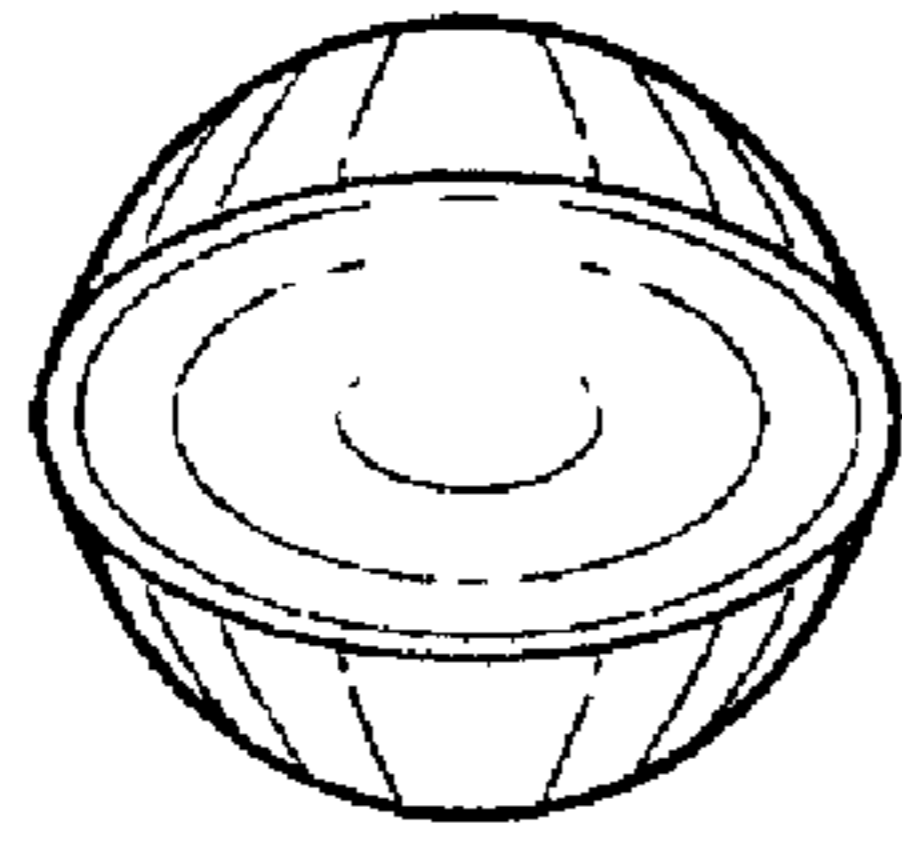

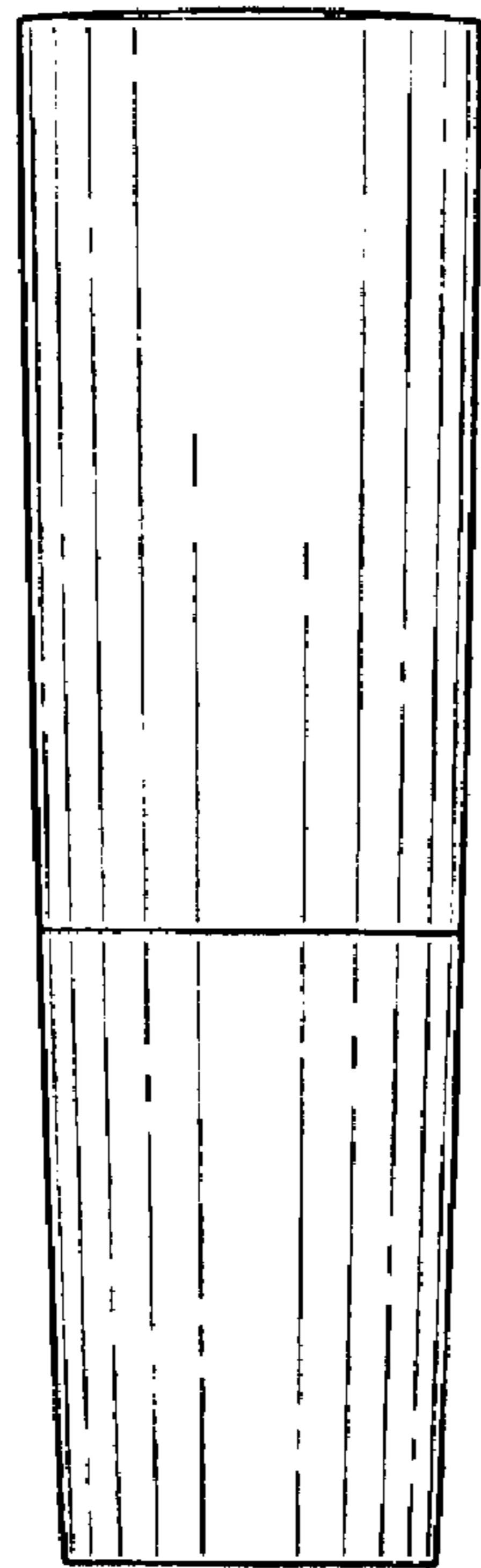

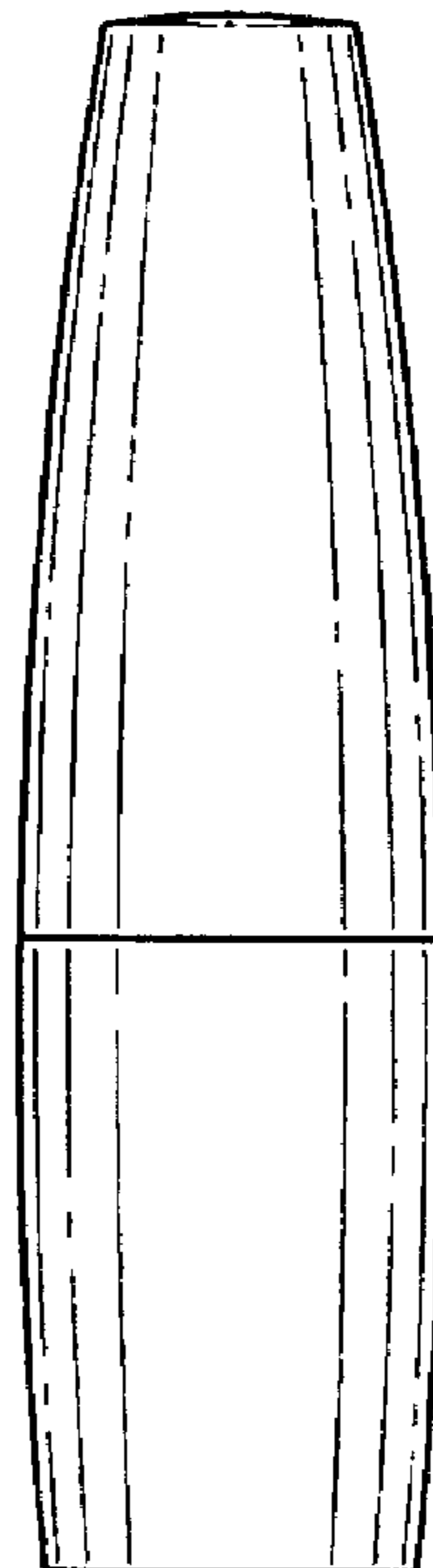

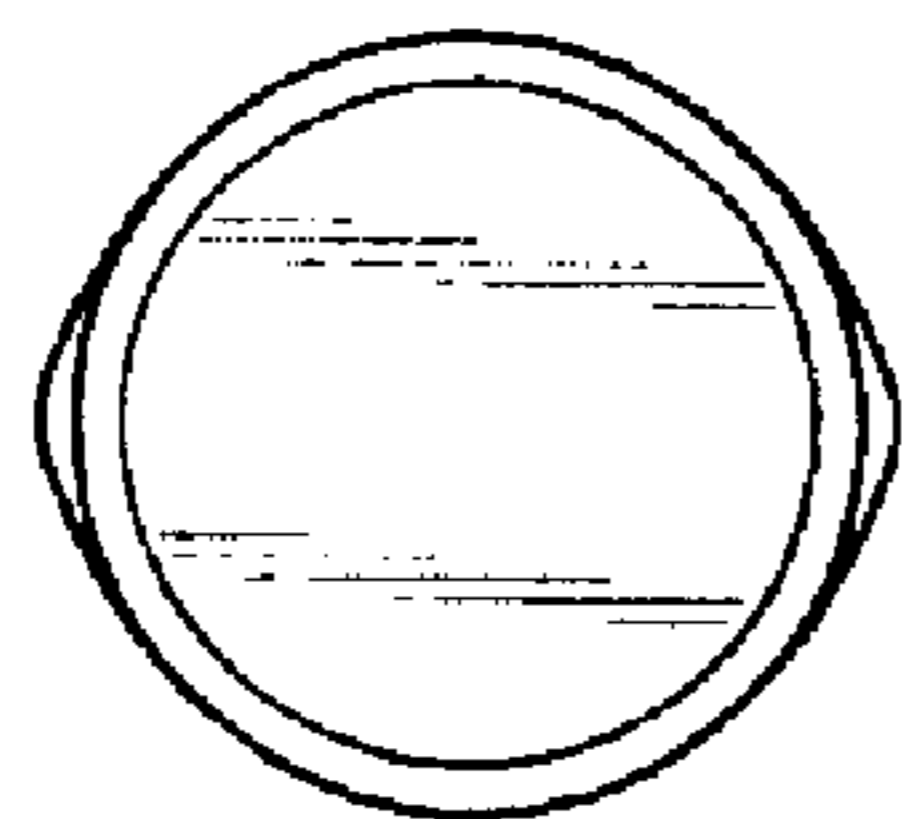
