(57) **CLAIM**

The ornamental design for a golf glove holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a golf glove holder showing my new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right side elevation view thereof; the left side elevation view being a mirror image thereof;

FIG. 4 is a top plan view thereof; the bottom plan view being a mirror image thereof; and,

FIG. 5 is an alternate front elevational view thereof.

The broken line showing of a golf bag and clubs is for illustrative purposes only and forms no part of the claimed design.

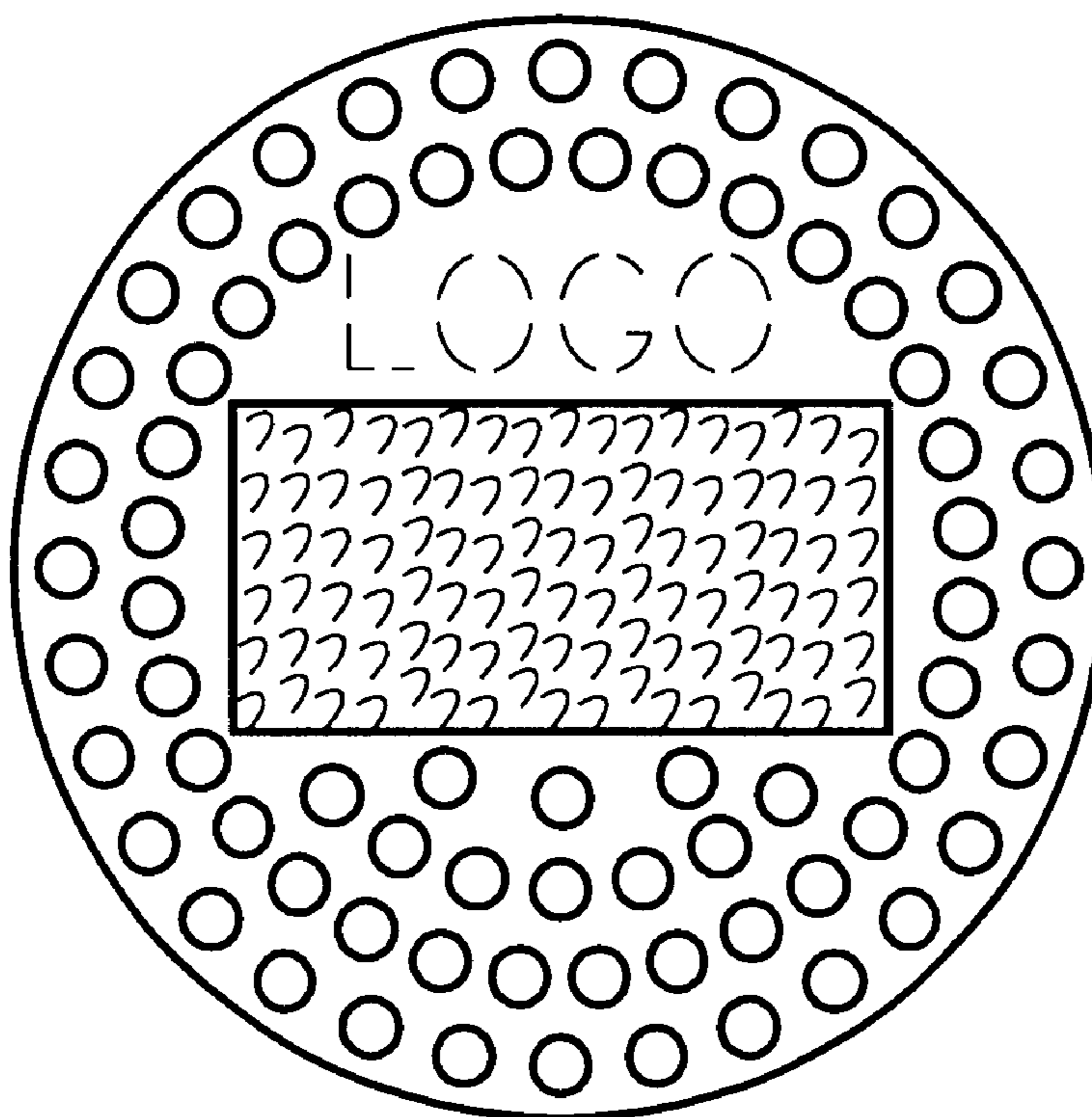

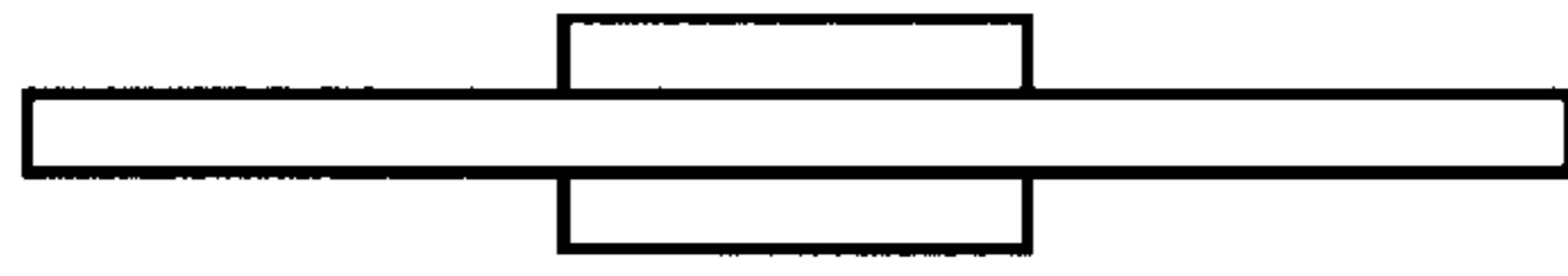

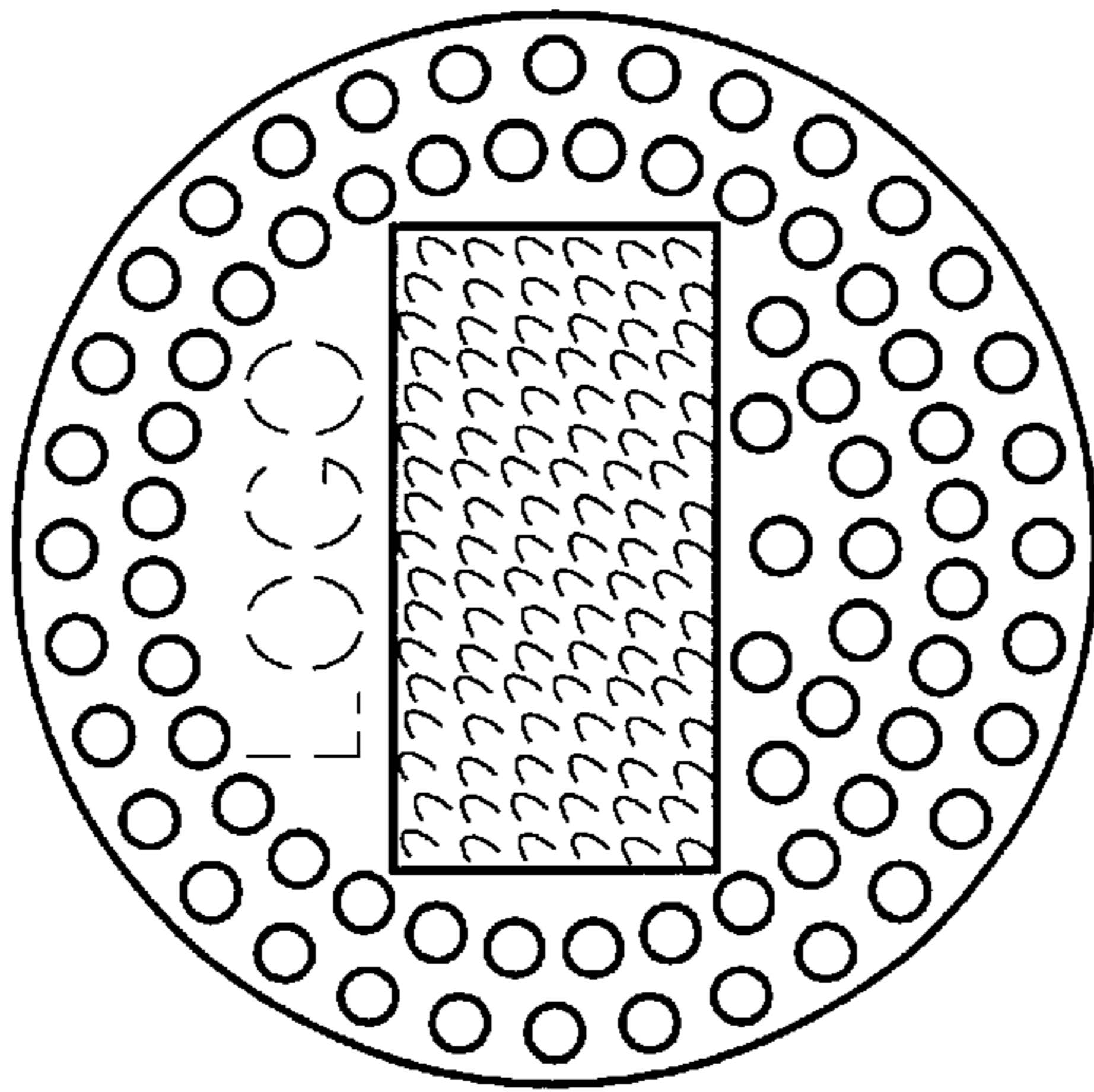

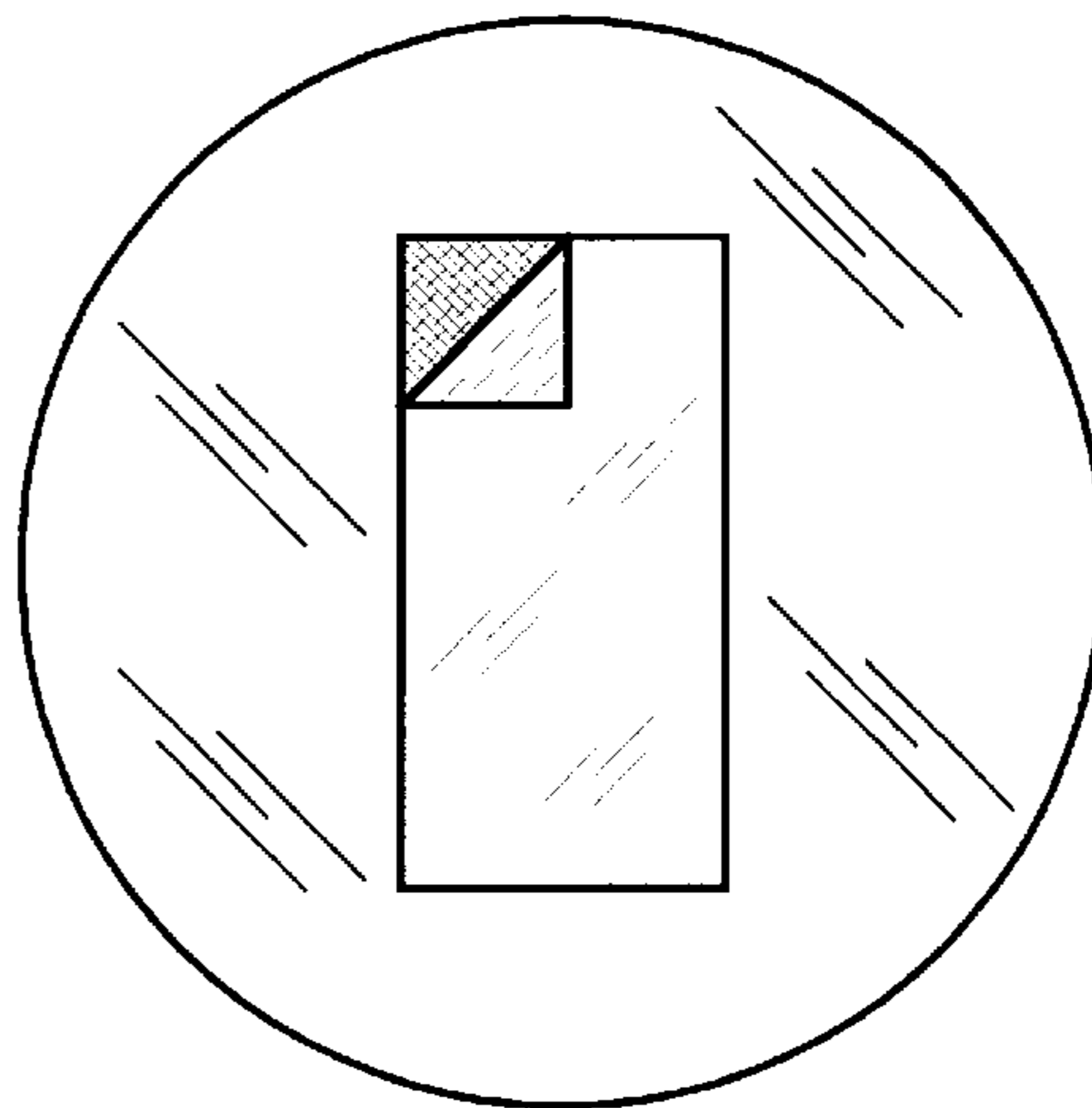

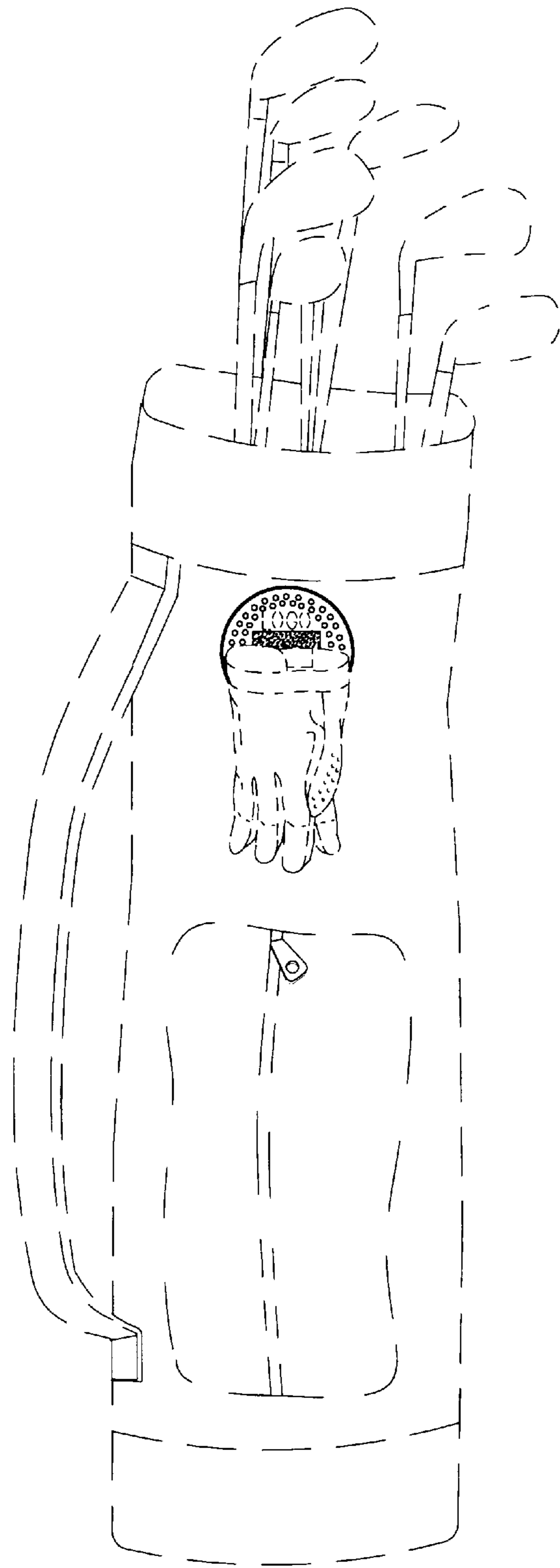
