FIG. 3 is a rear view of the present handle.

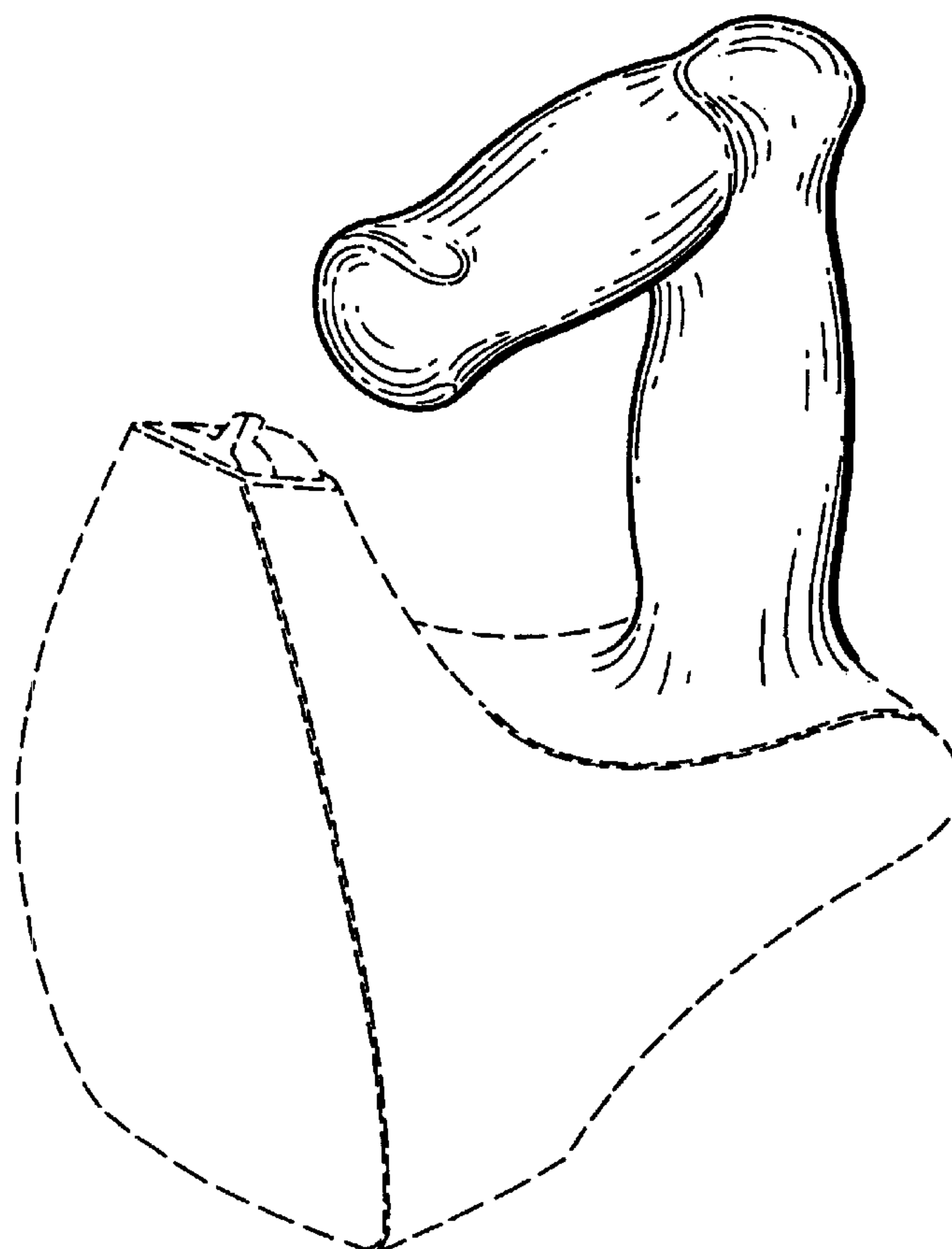
FIG. 4 is a side view of the present handle.

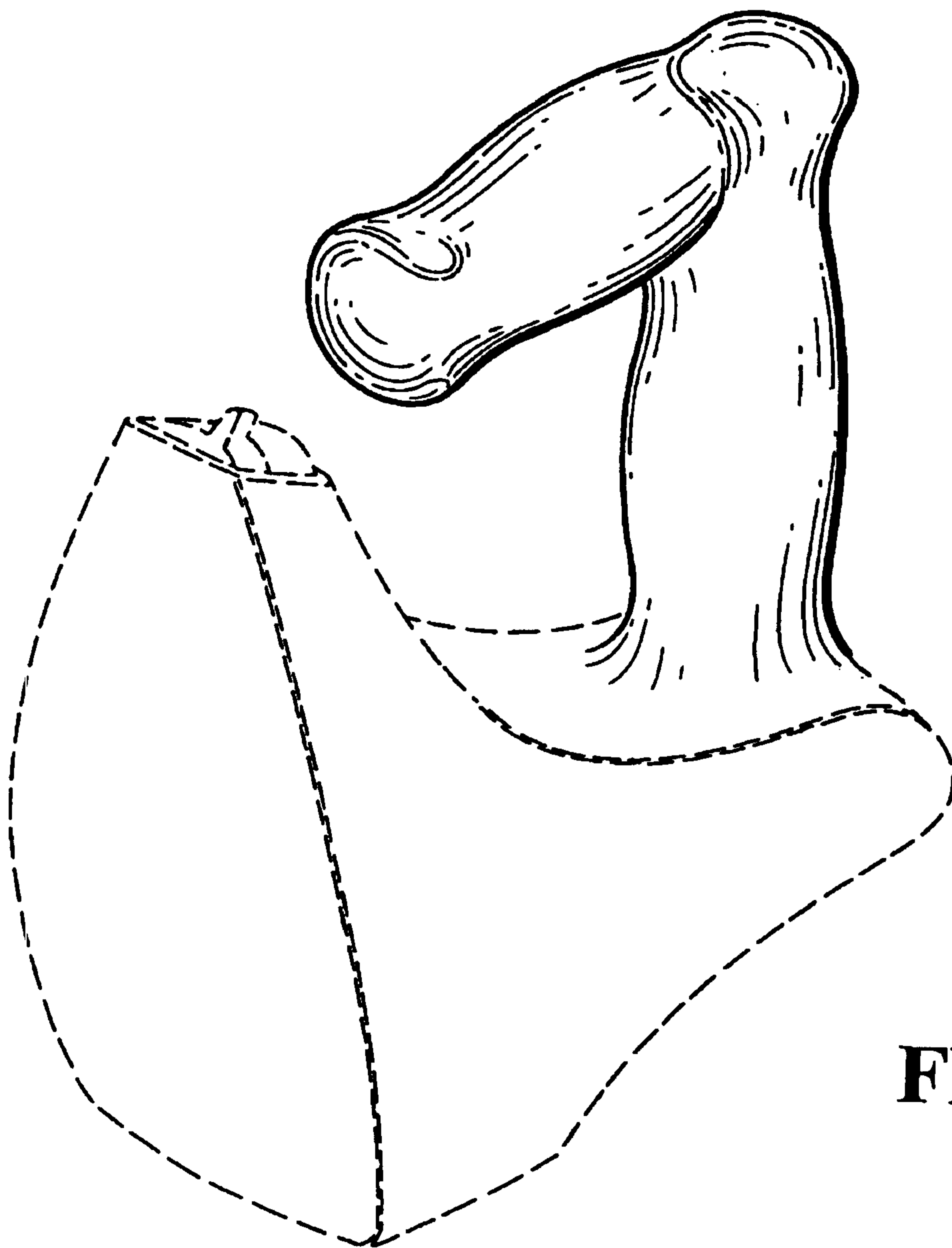
FIG. 5 is a side view (opposite that shown in FIG. 4) of the

FIG. 6 is a bottom perspective view of the present handle.

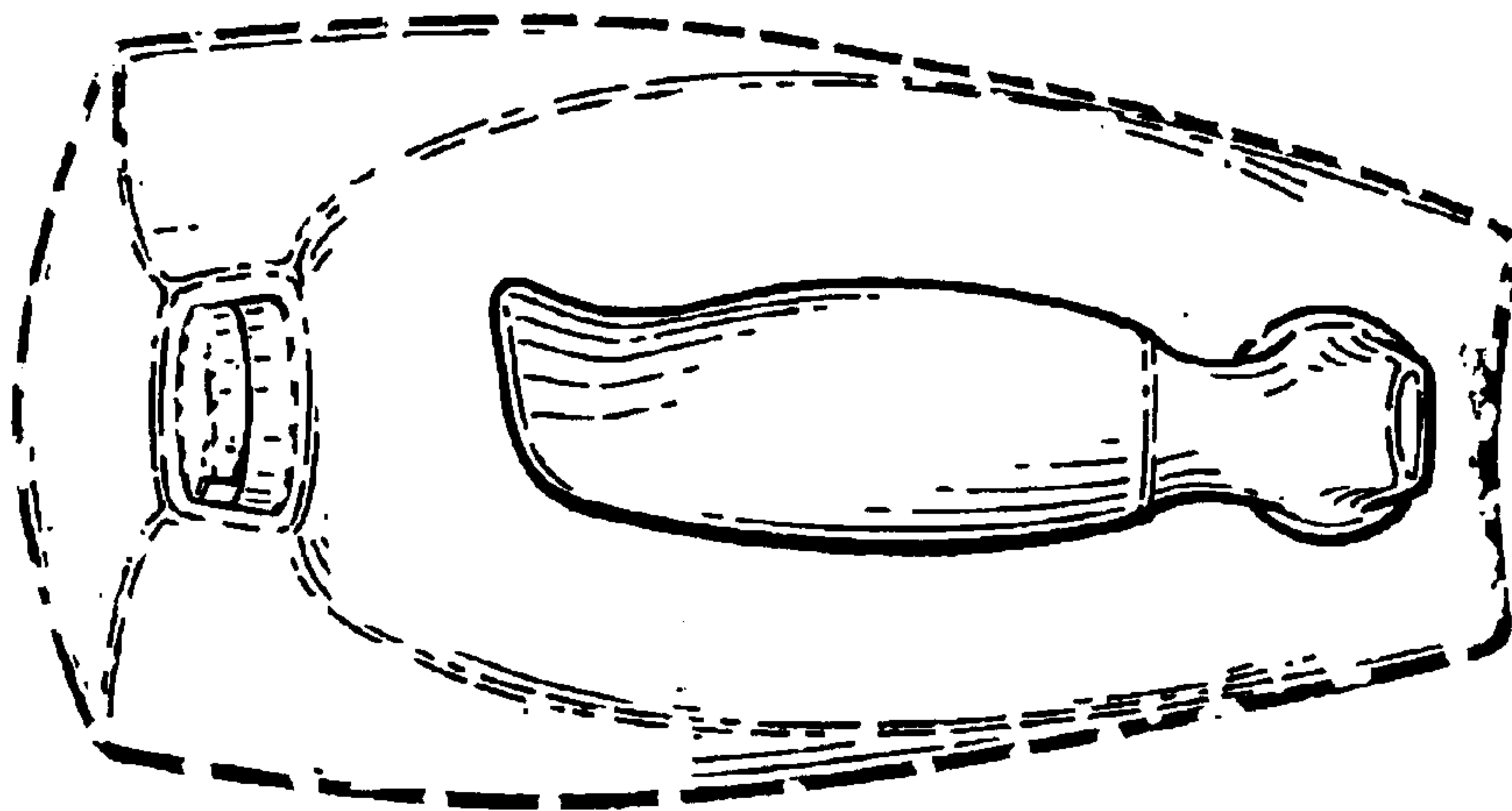
The broken lines immediately adjacent the shaded areas

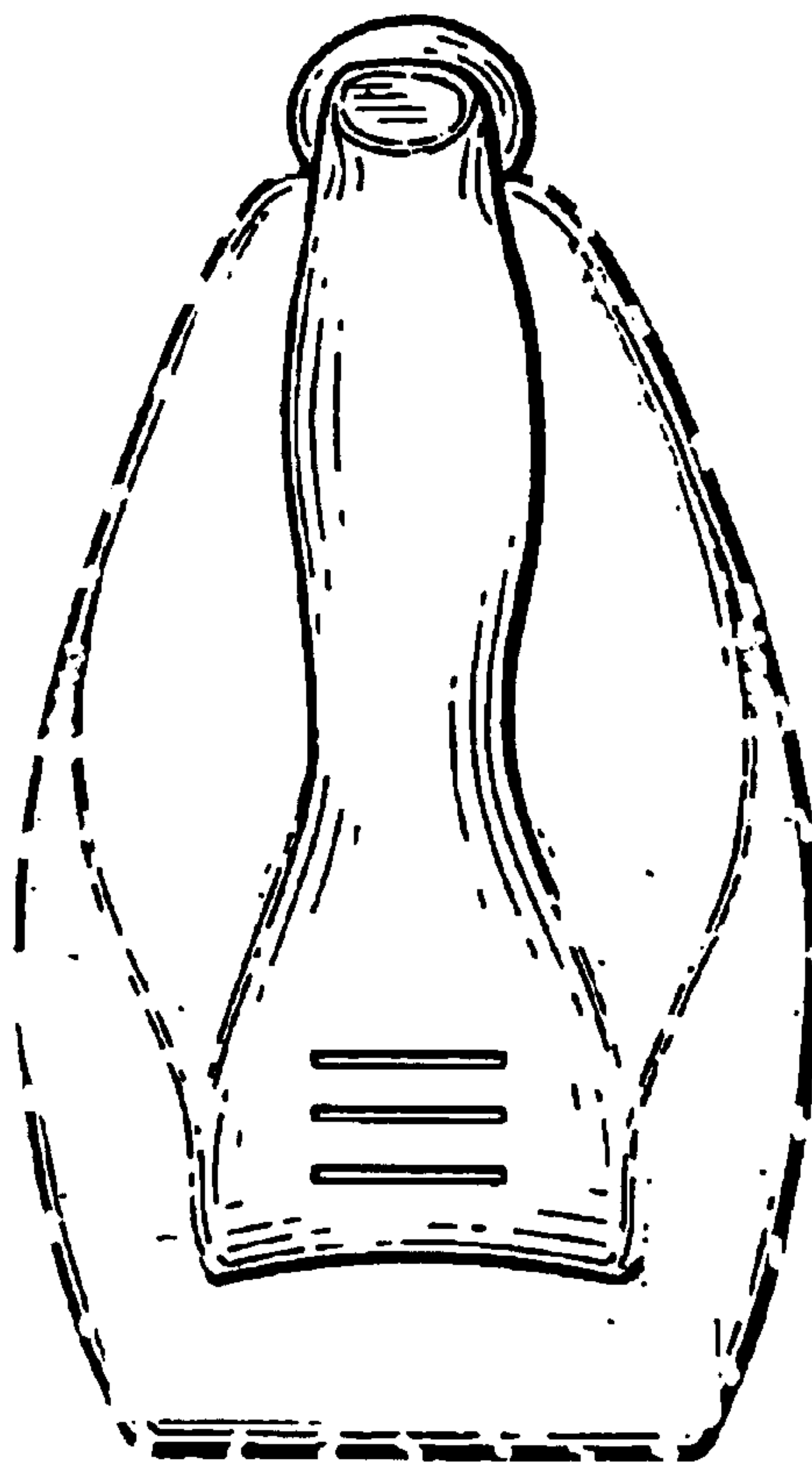




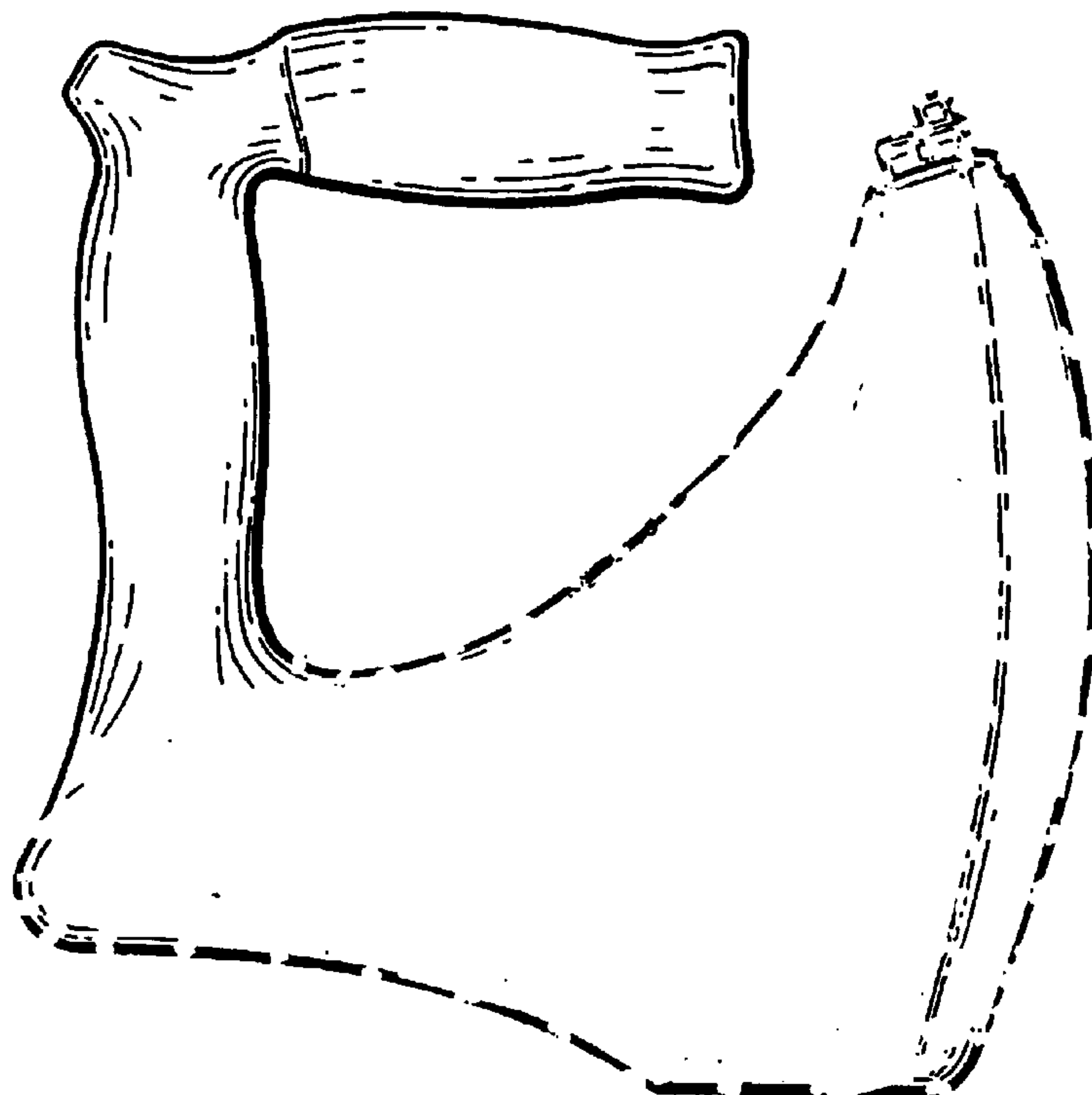

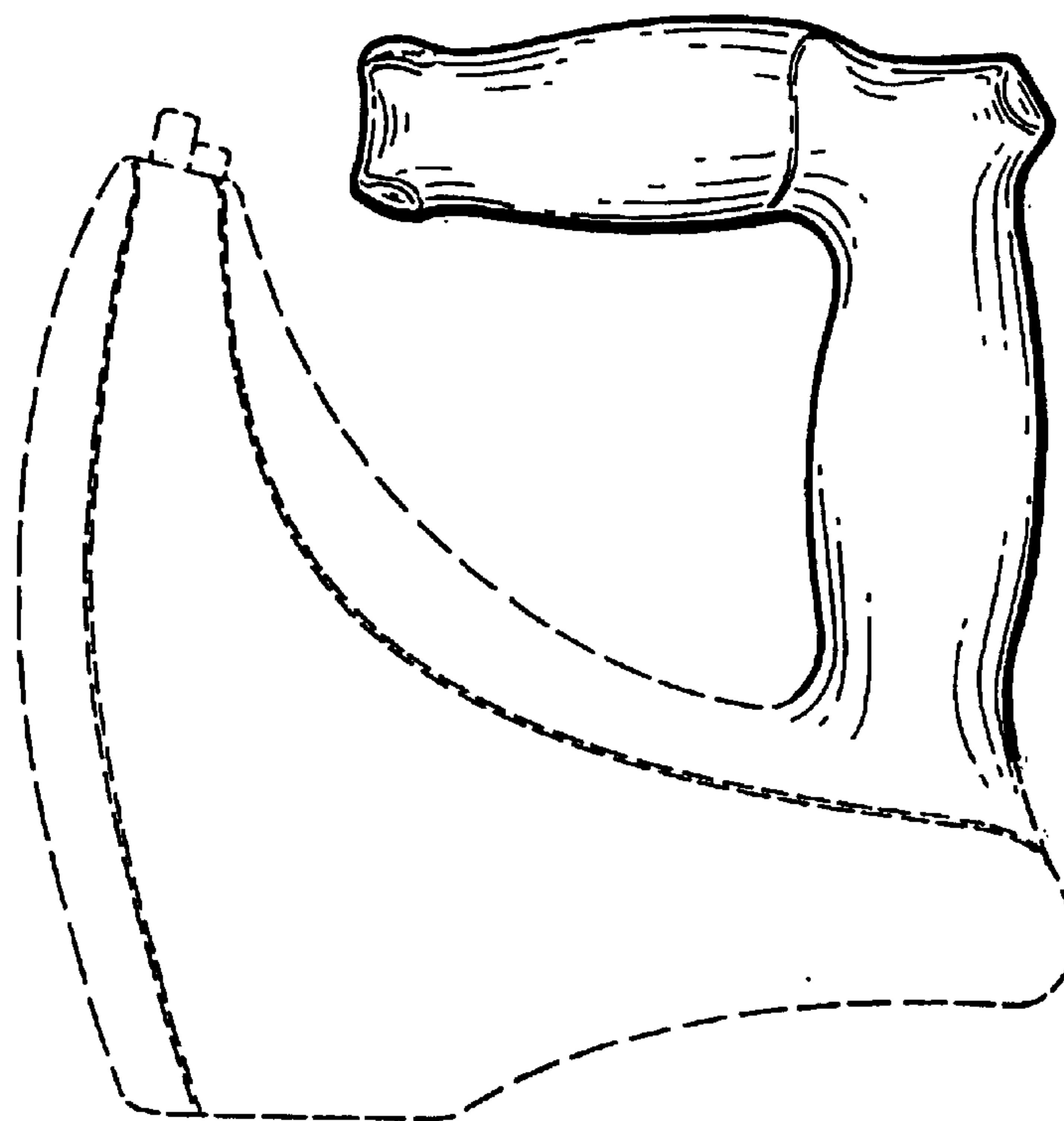

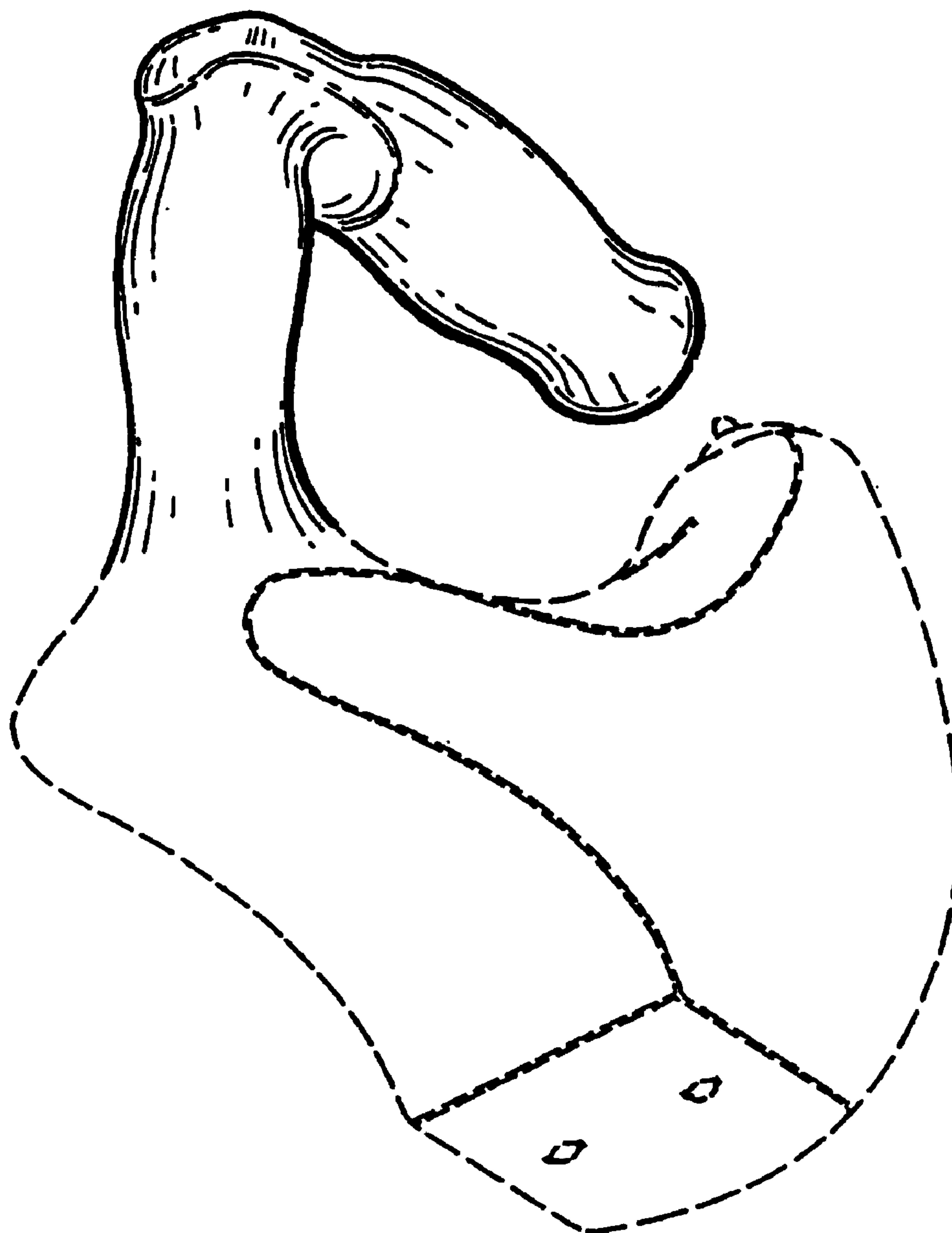
