(57) **CLAIM**

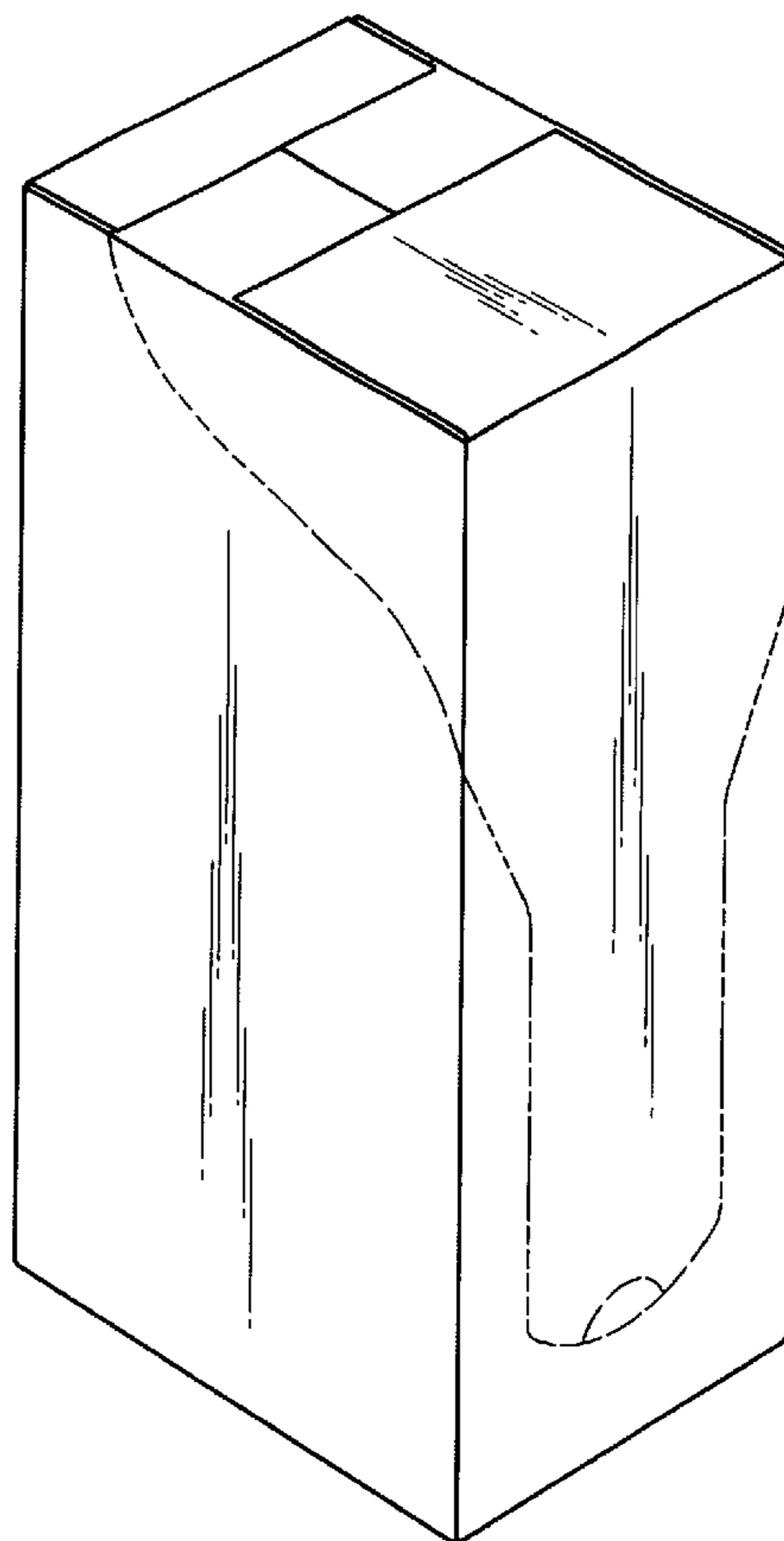
The ornamental design for a storage and display carton, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the storage and display carton, embodying our new design;
 FIG. 2 is an elevational front view thereof;
 FIG. 3 is an elevational back view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a perspective view thereof, with the tearing portion removed.

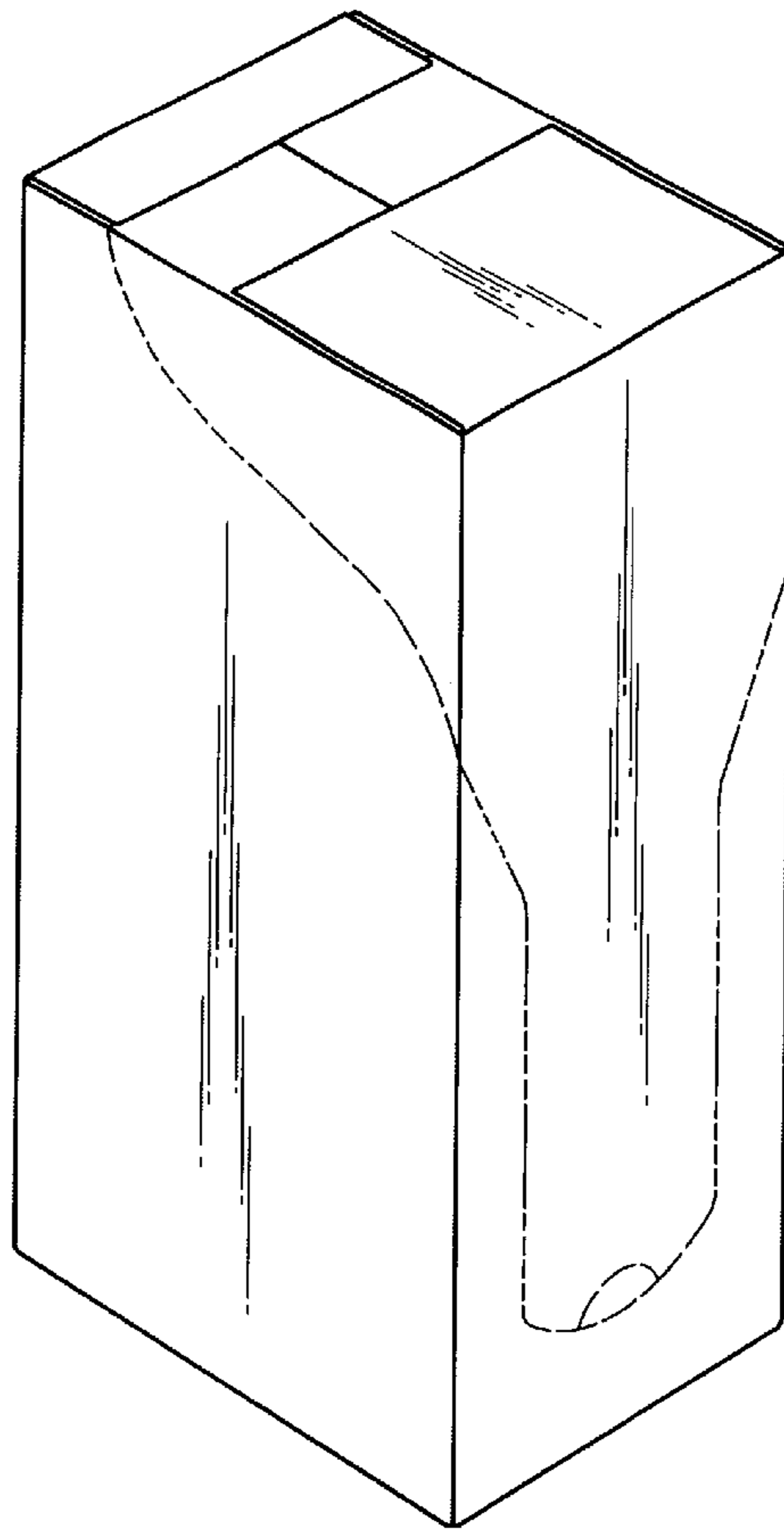

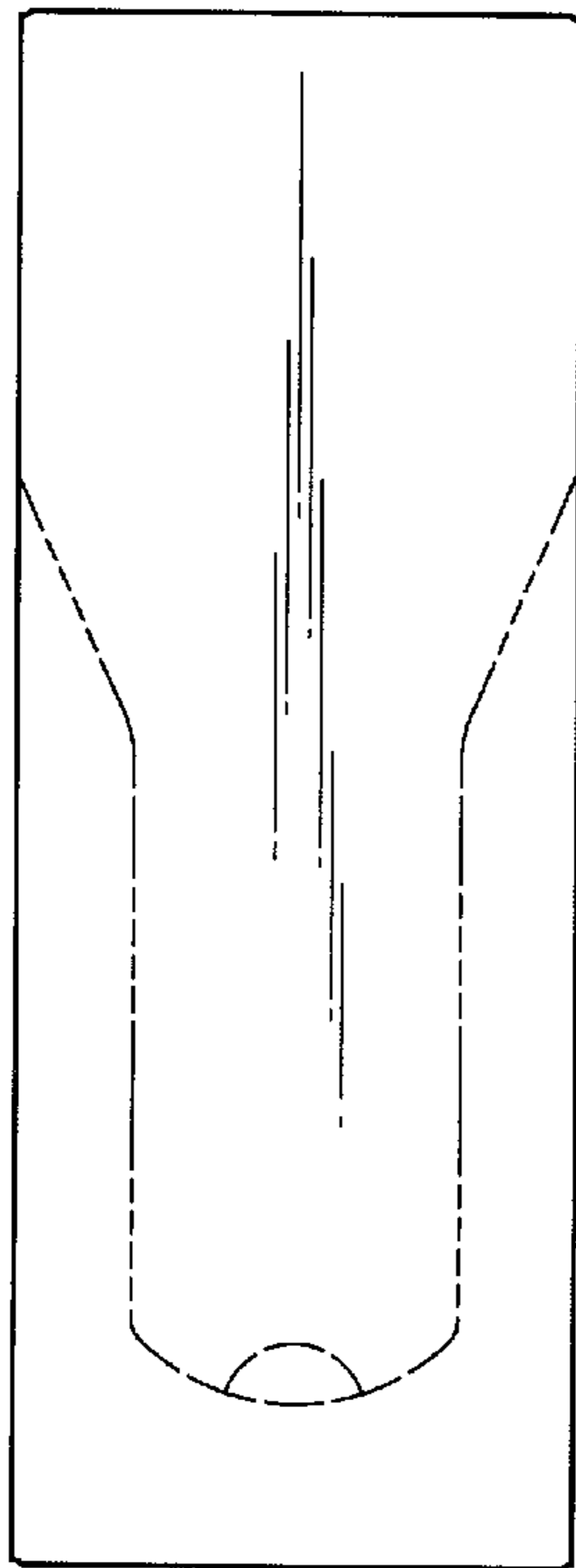

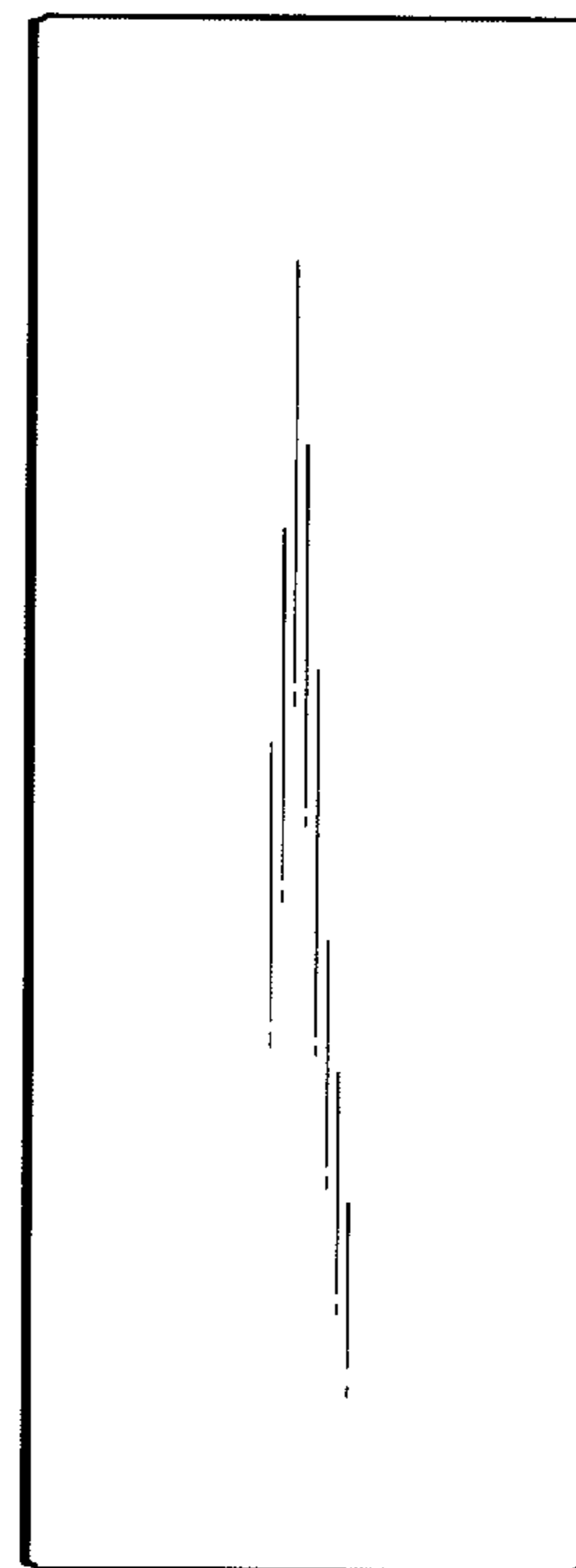

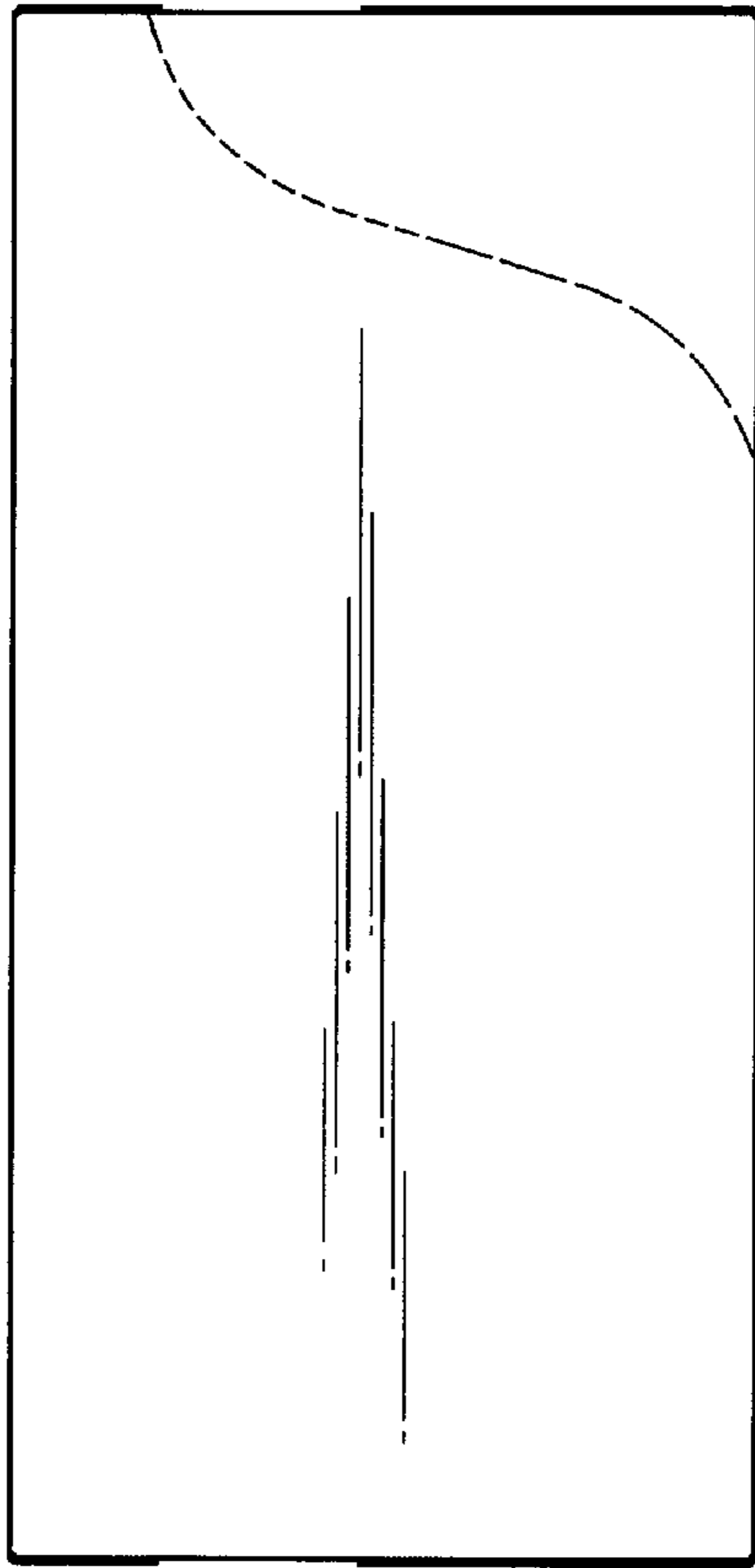

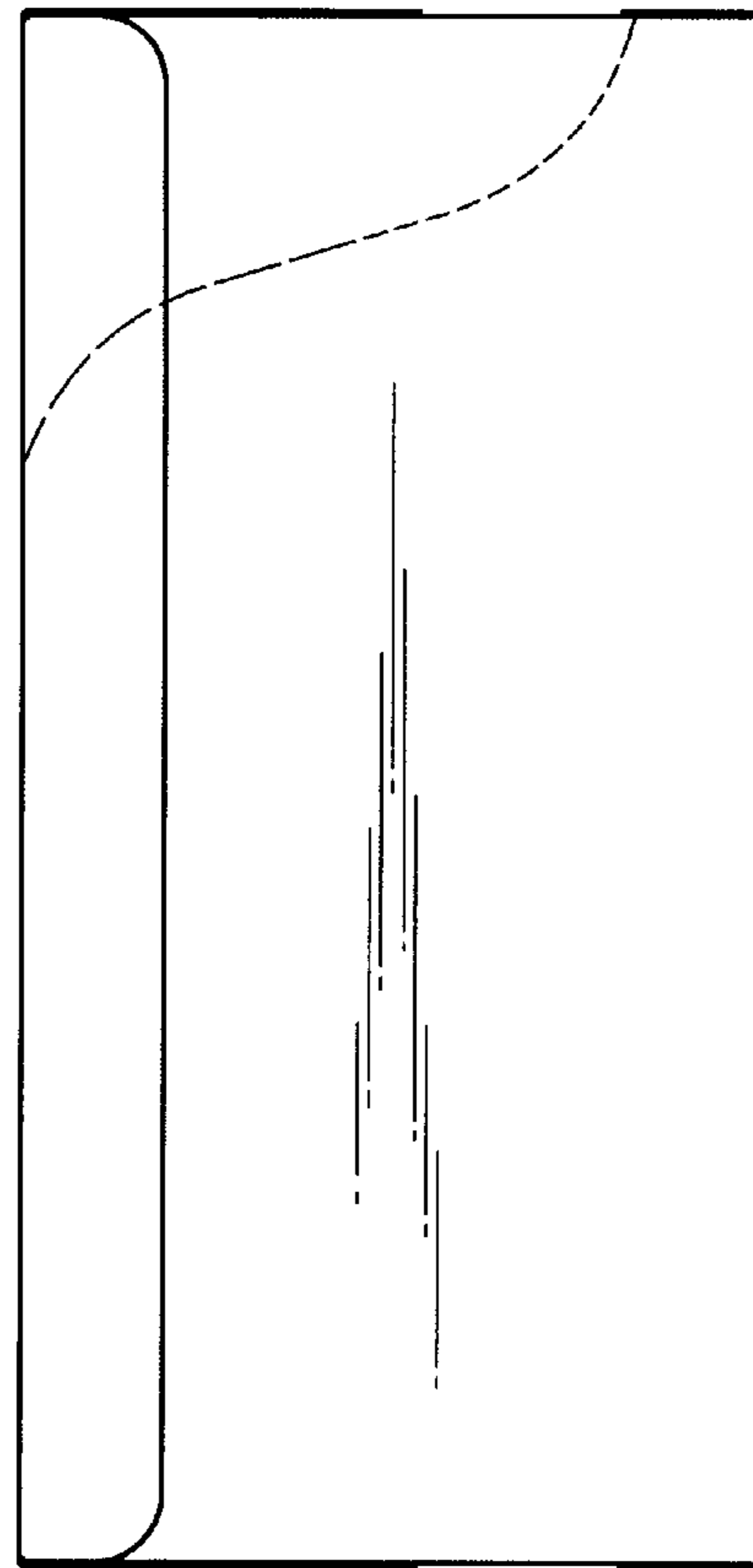

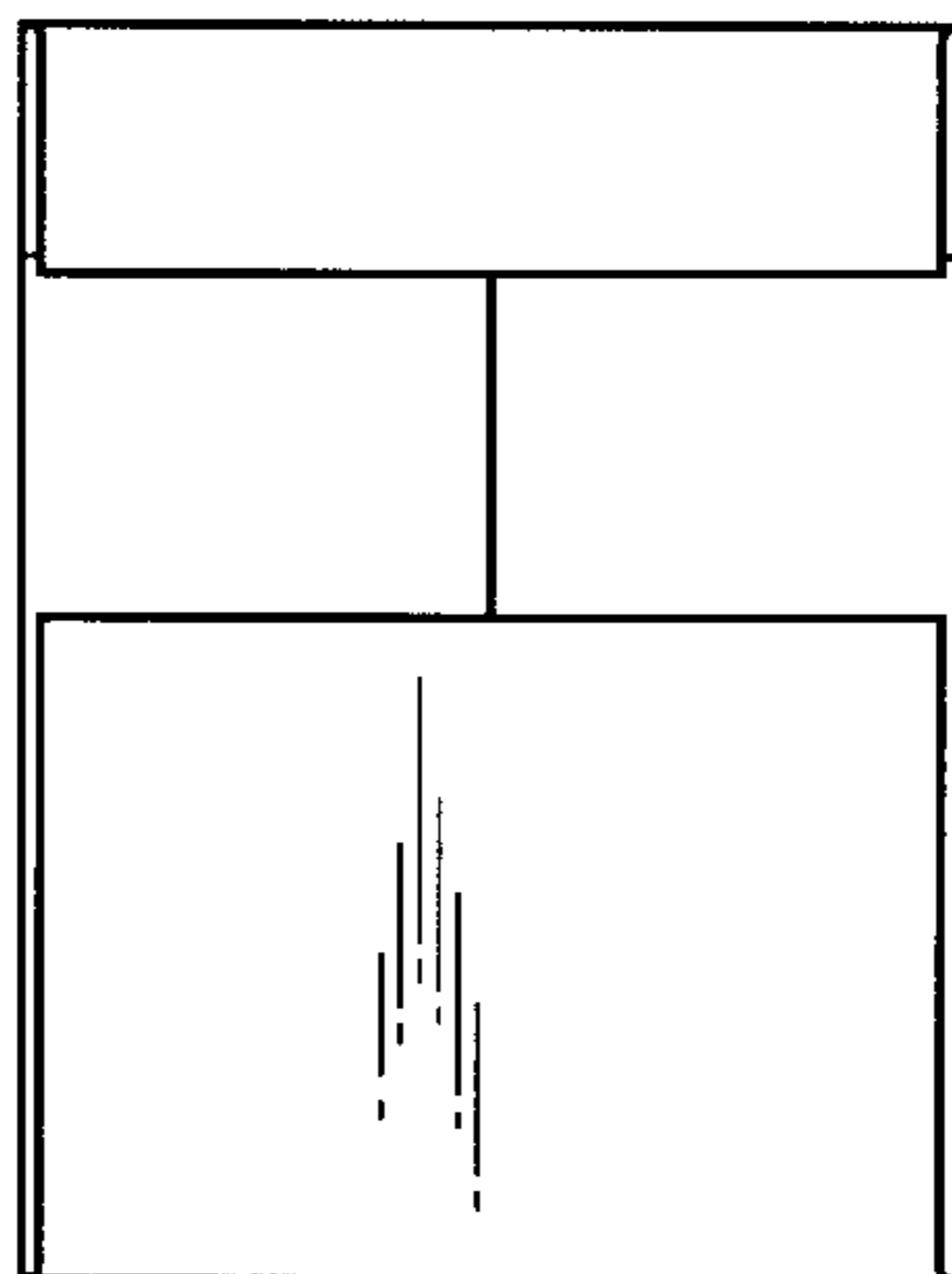

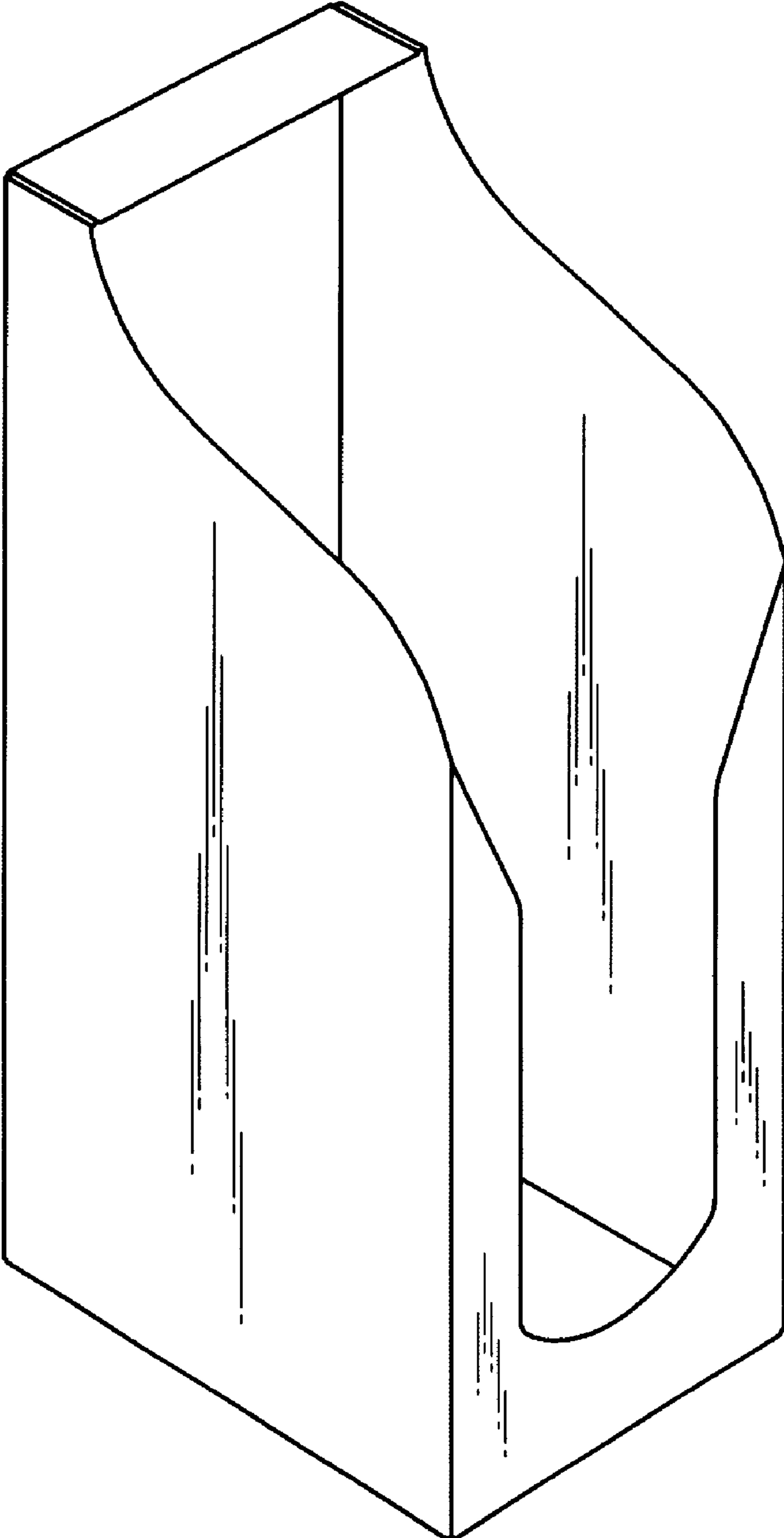
