(57) **CLAIM**

The ornamental design for an arithmetic and control unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right top perspective view of an arithmetic and control unit showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front right bottom perspective view thereof. Portions of FIGS. 1-8 that are shown as broken lines are for illustrative purposes only and form no part of the claimed design.

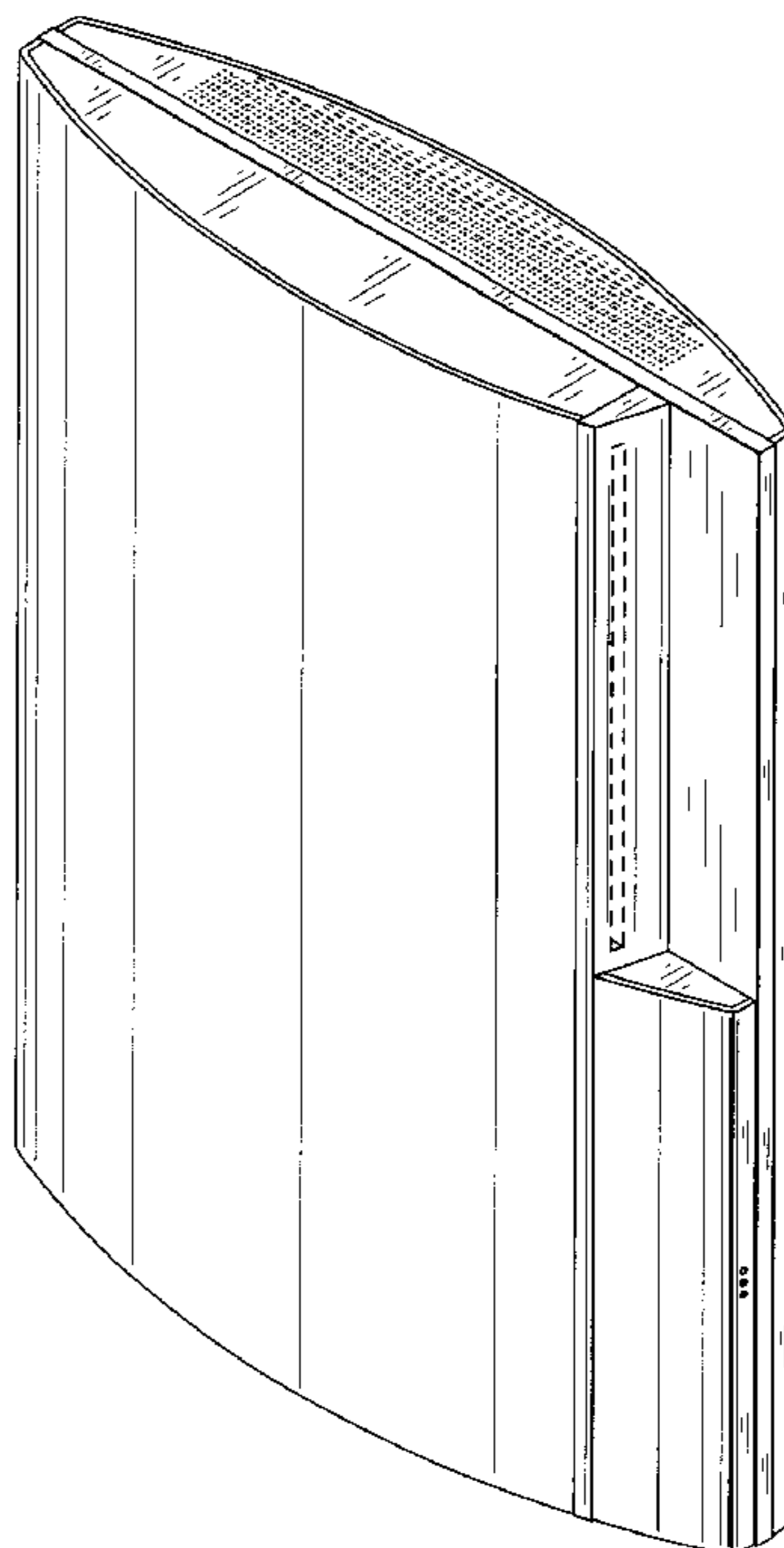

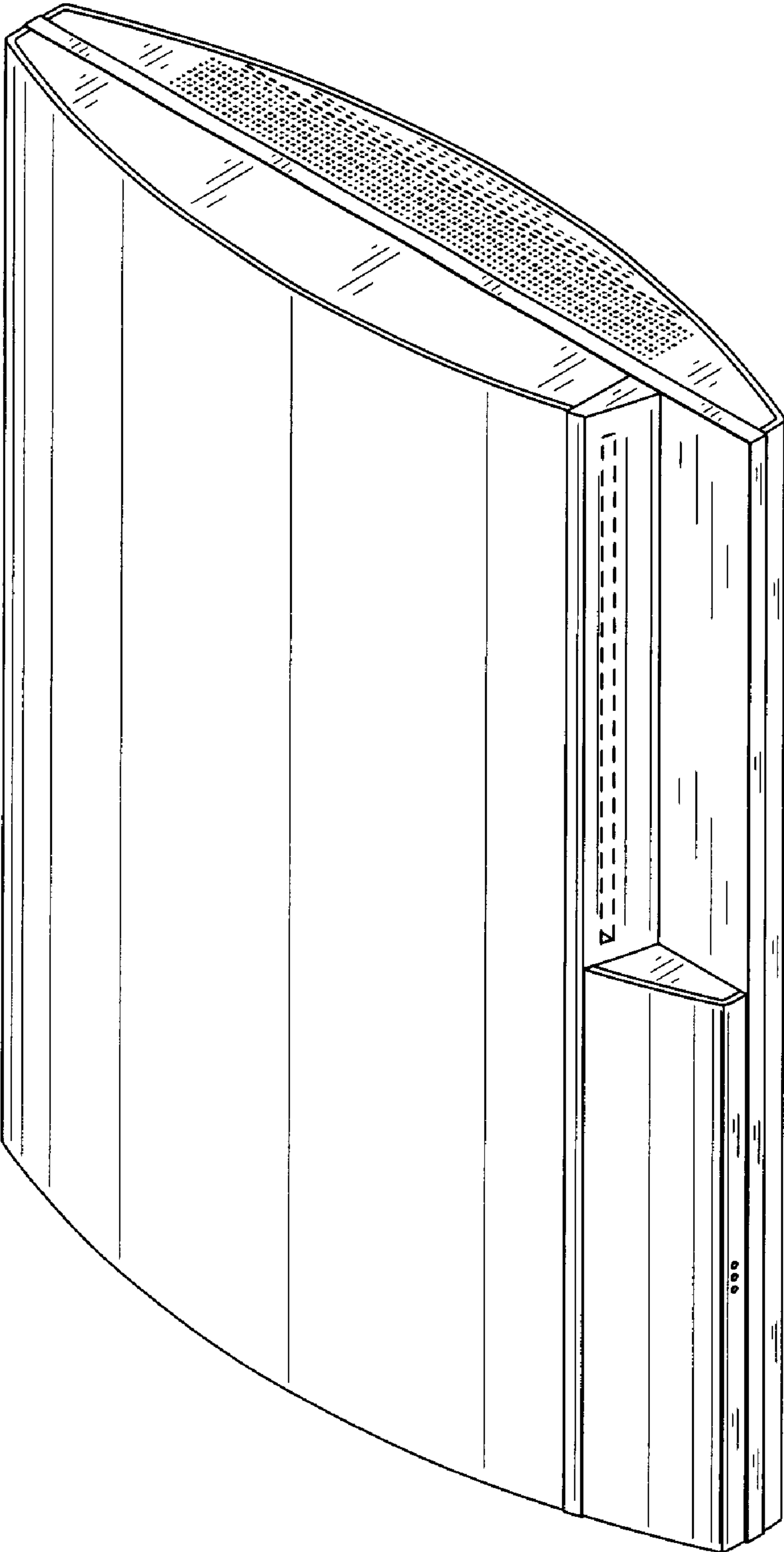

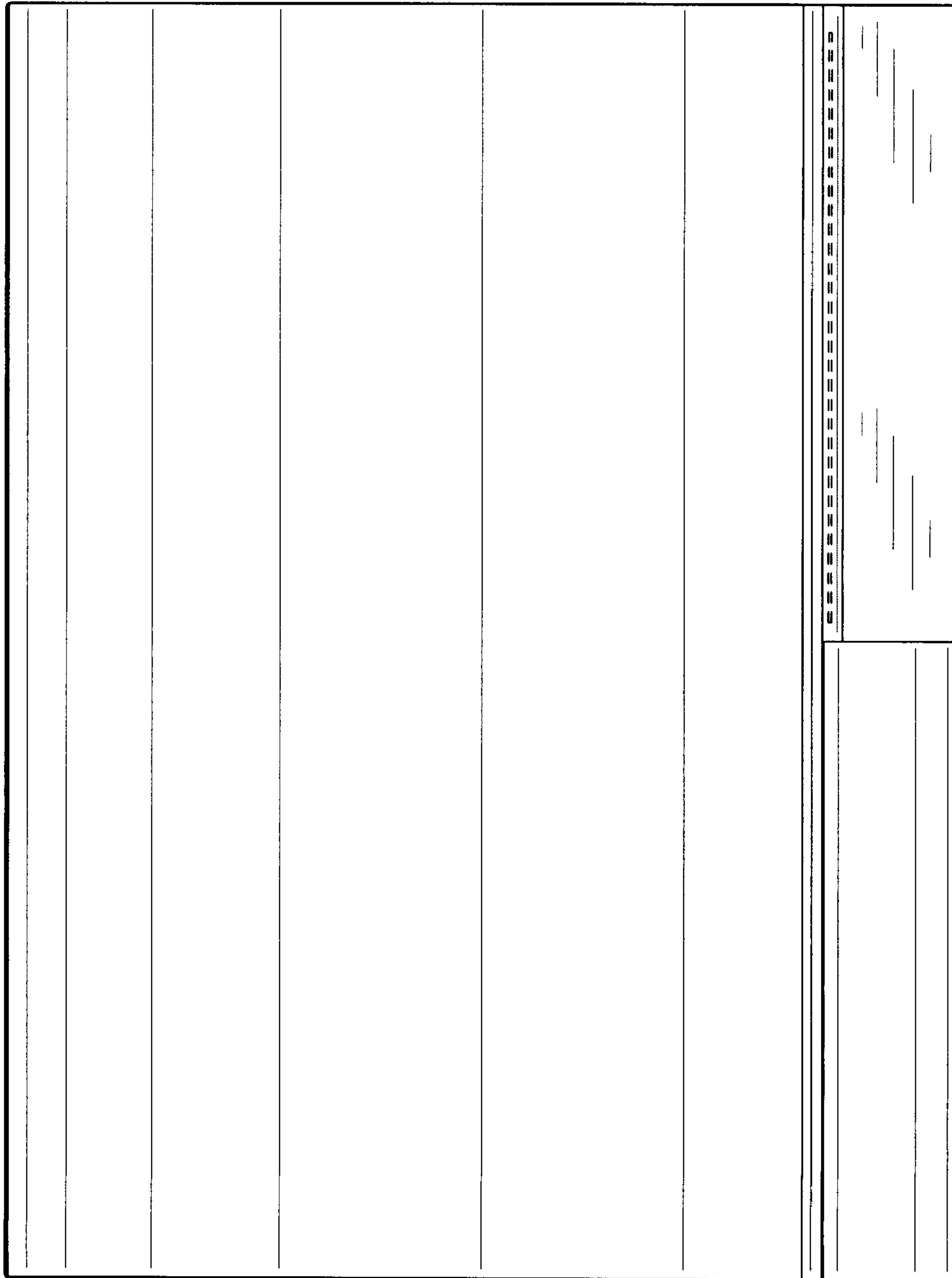

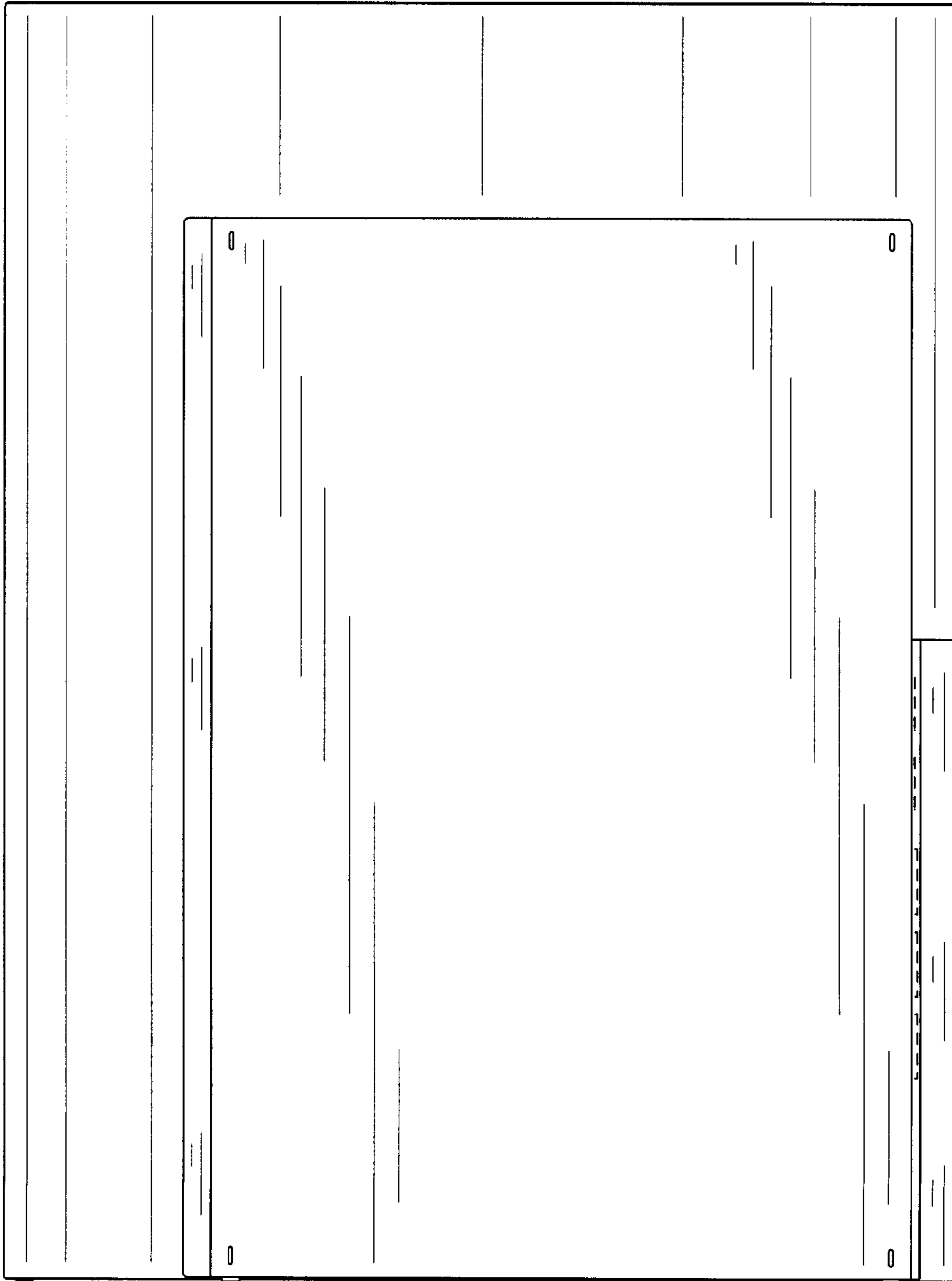

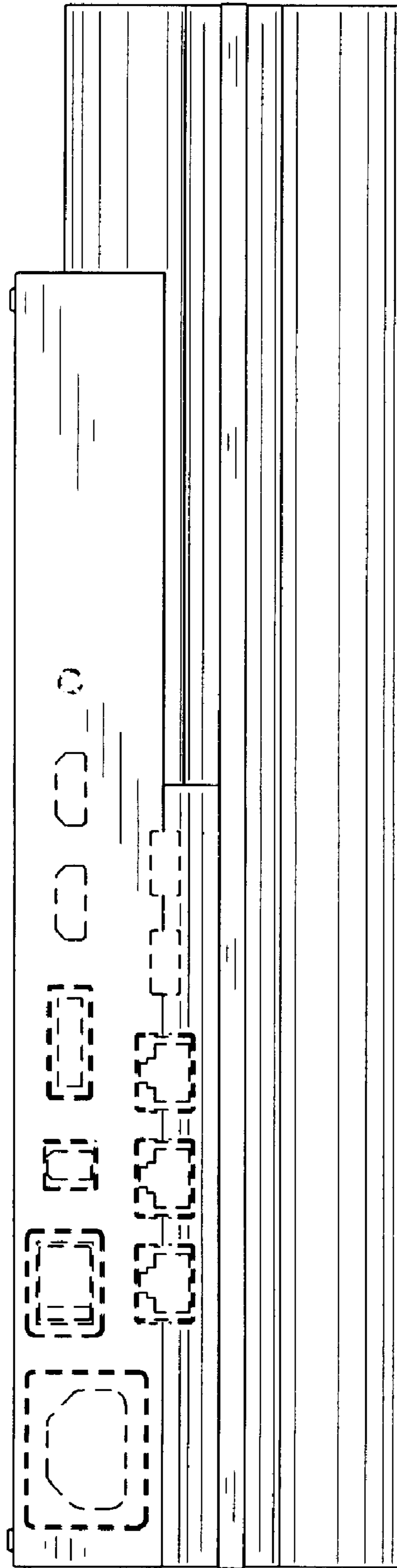

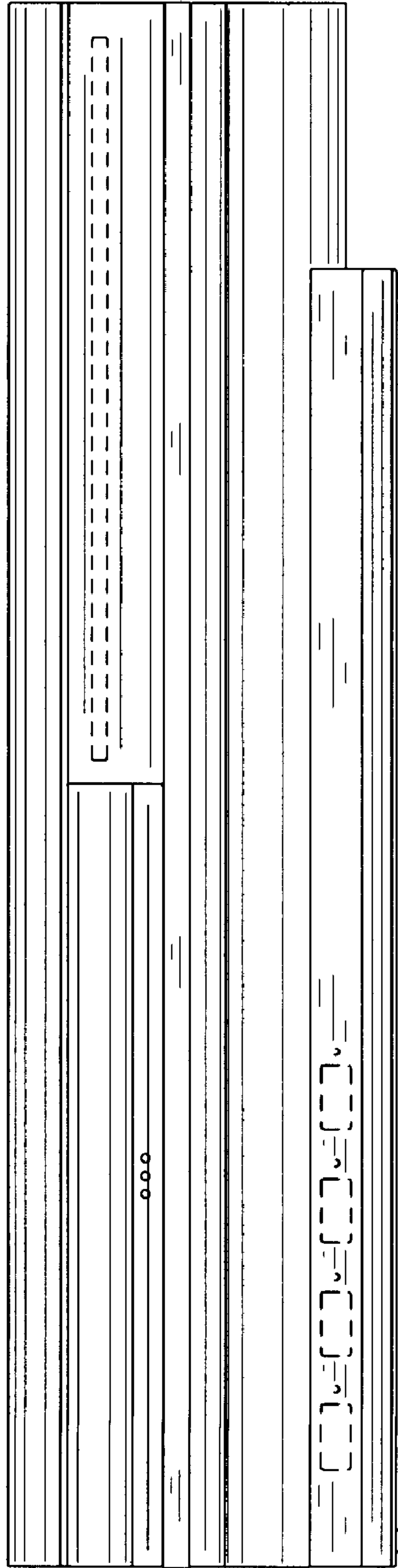

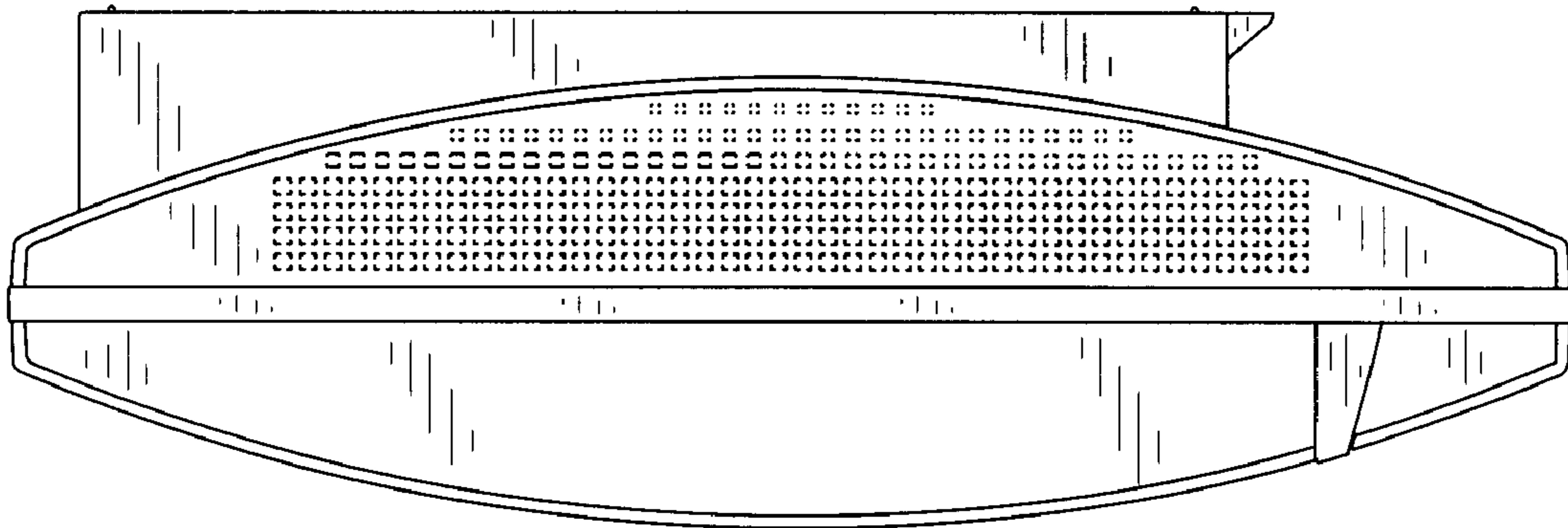

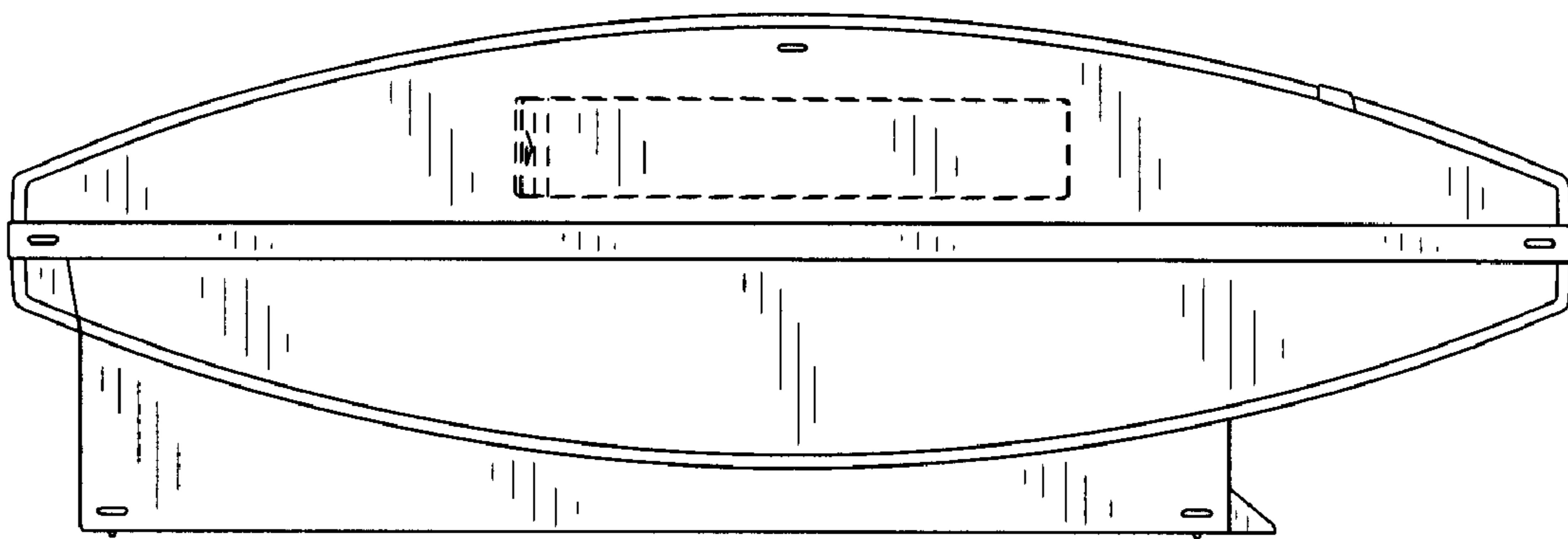
