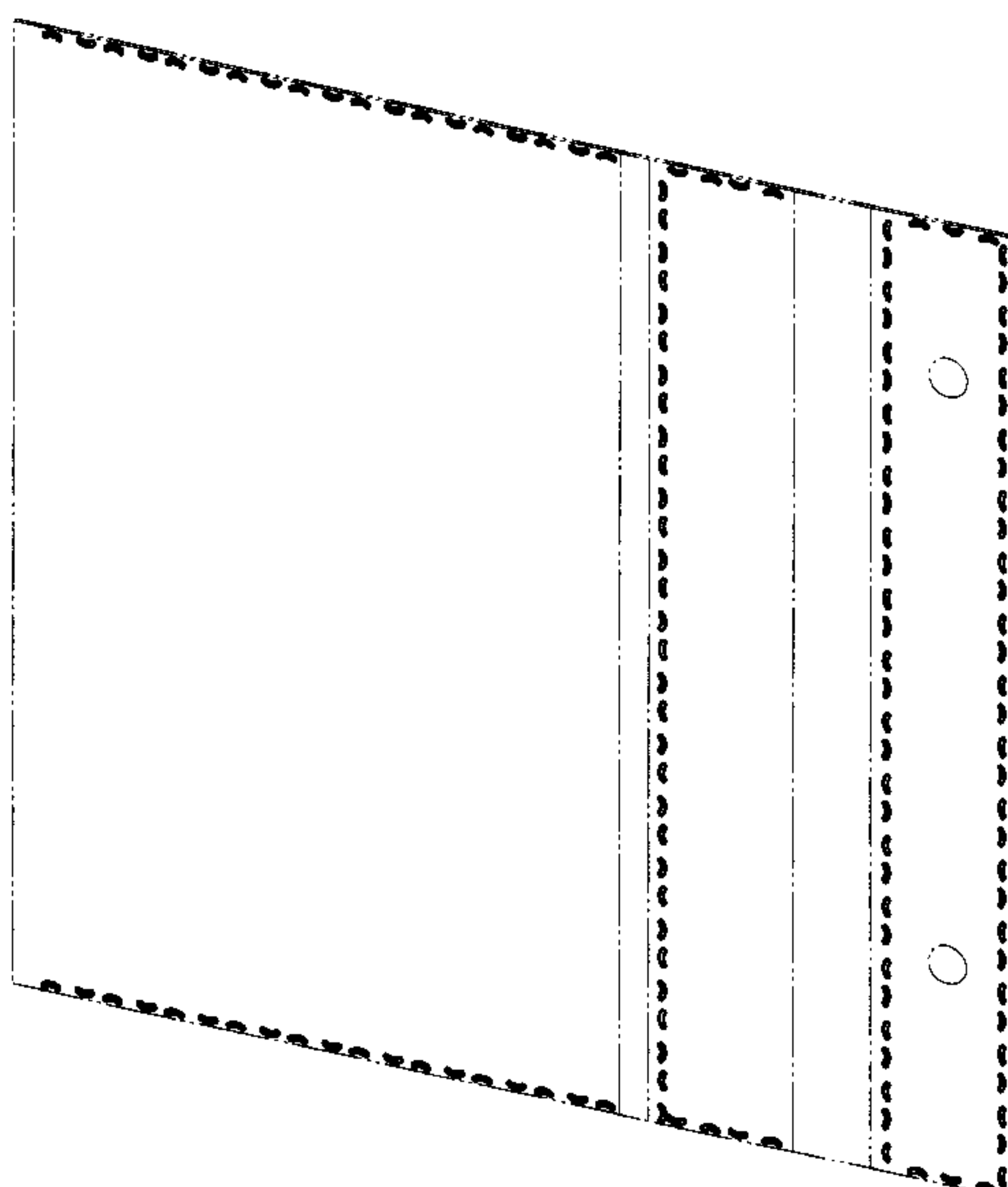

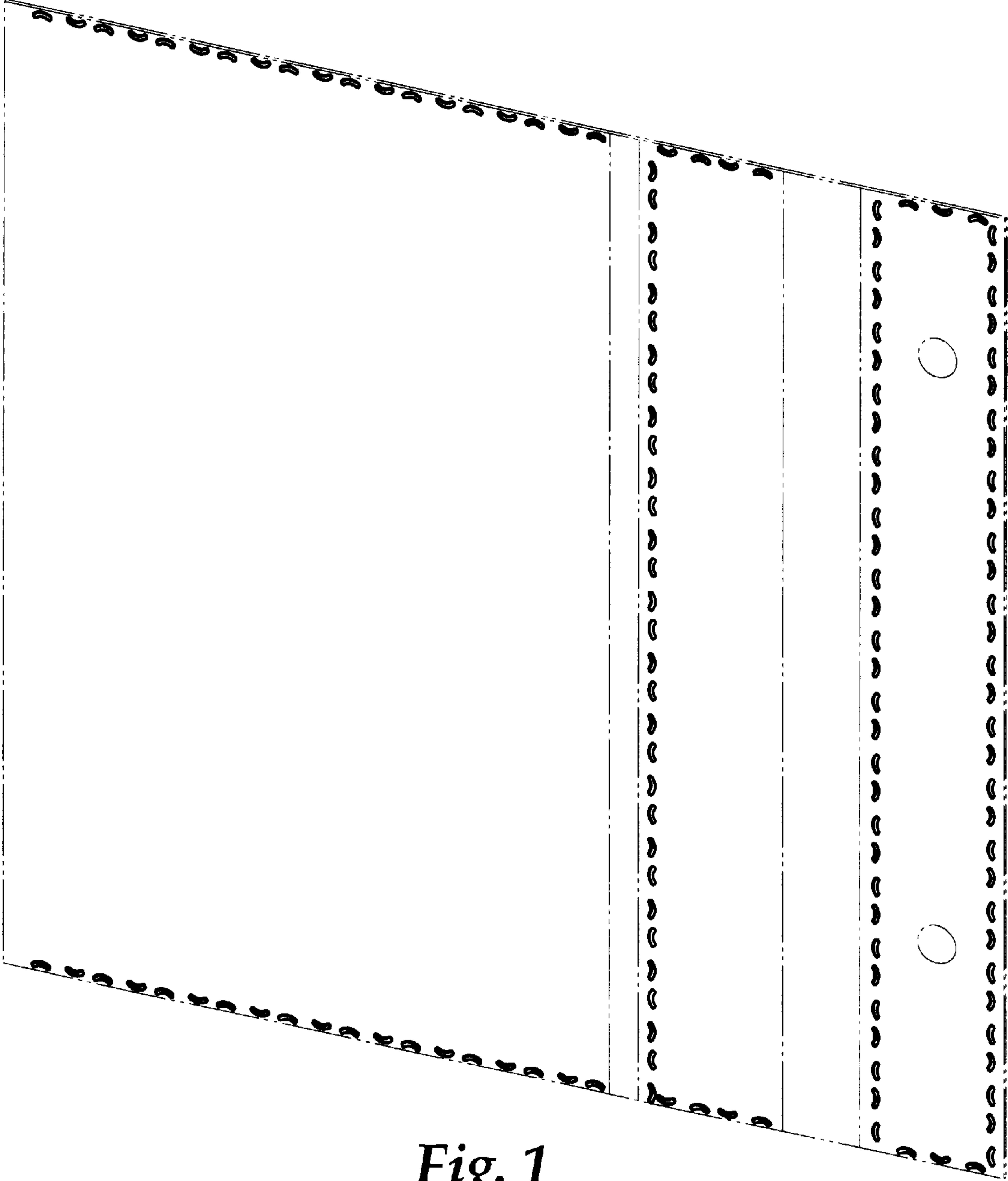
The ornamental design for a pocket photo album page, as shown and described.

**DESCRIPTION**

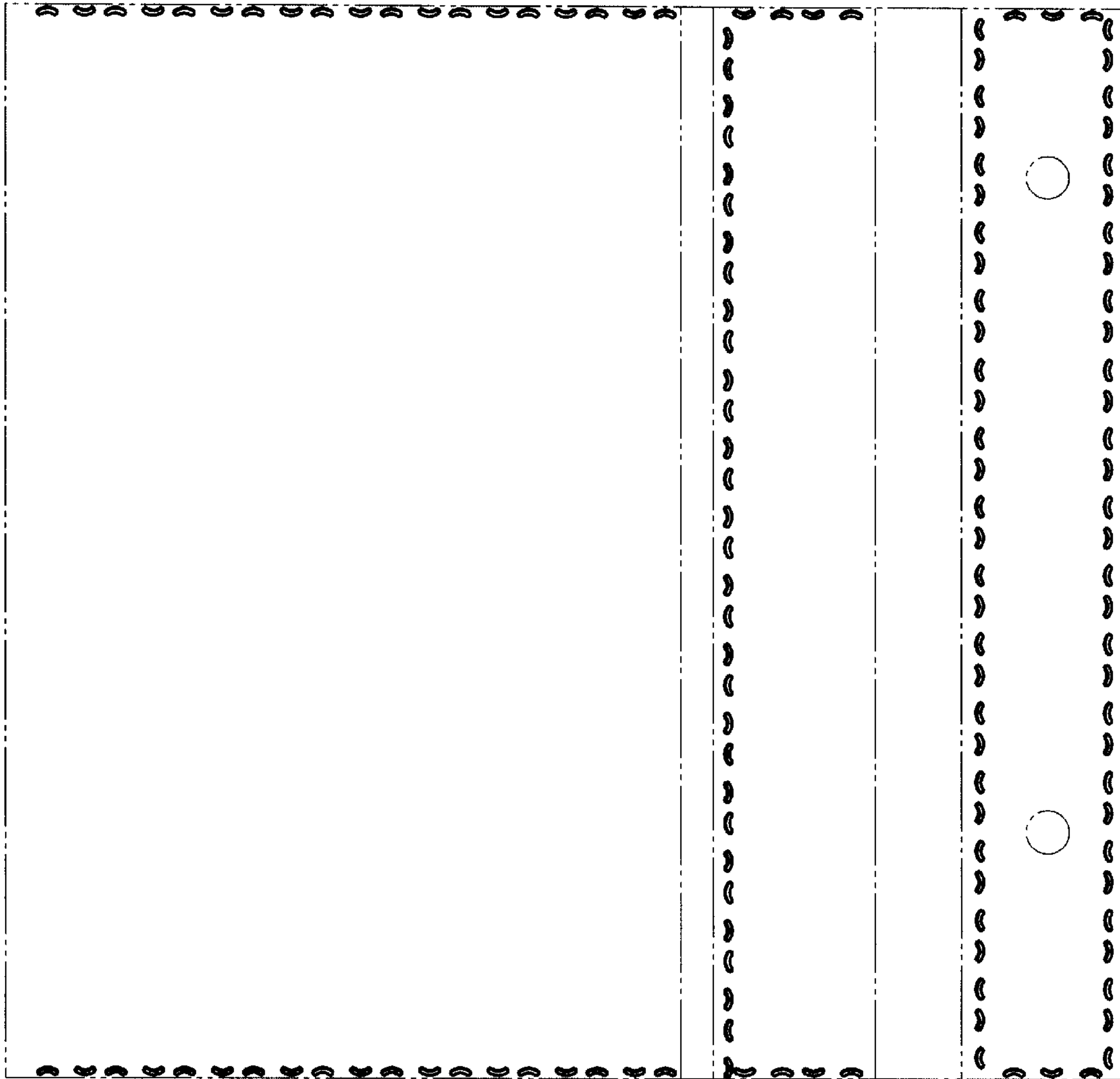
